The ornamental design for a glove for use in oral stimulation, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of a glove for use in oral stimulation showing my new design;

FIG. 8 is a cross sectional view taken in the direction of line 8—8 of FIG. 3;

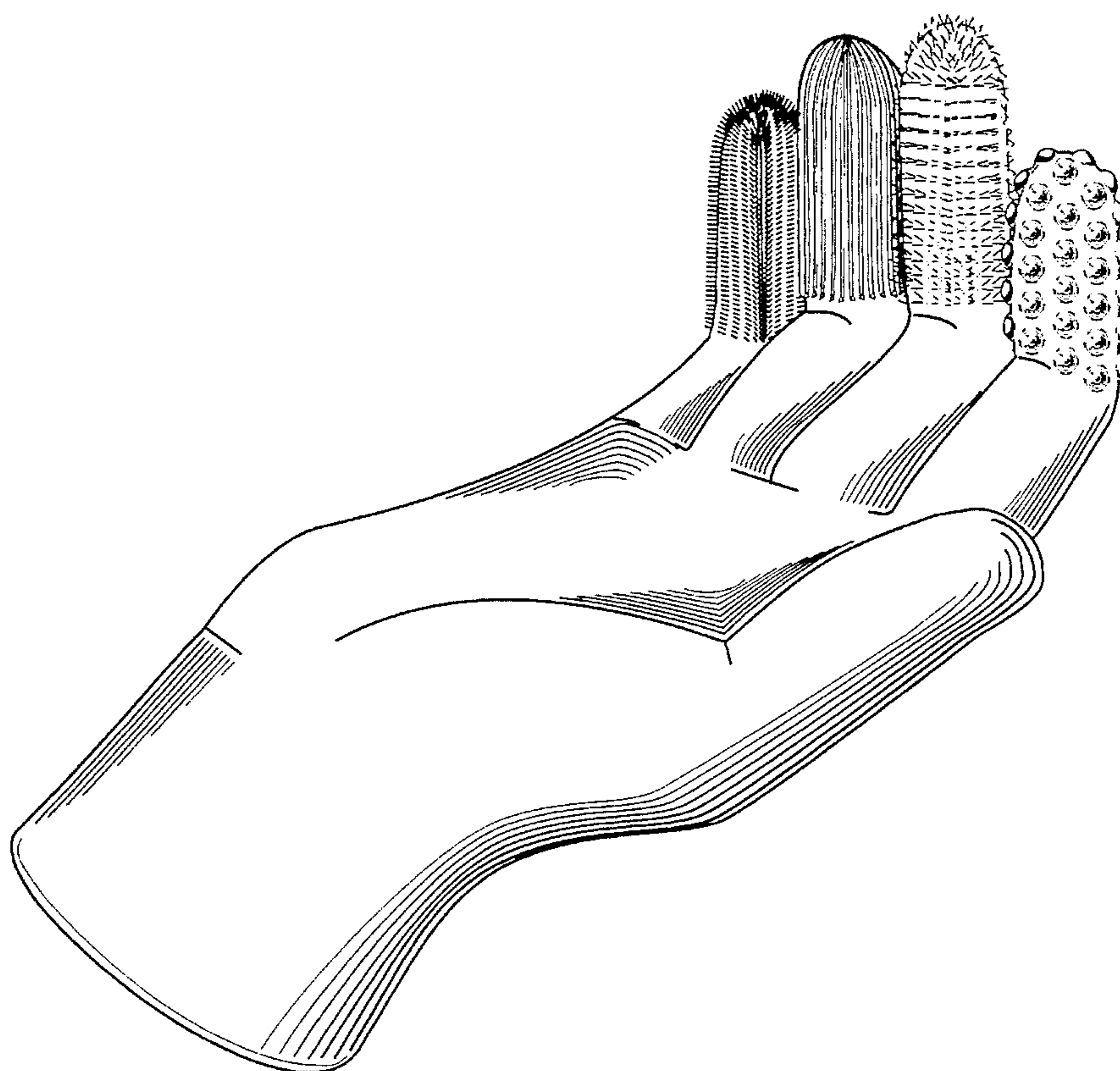
FIG. 9 is a rear elevational view thereof;

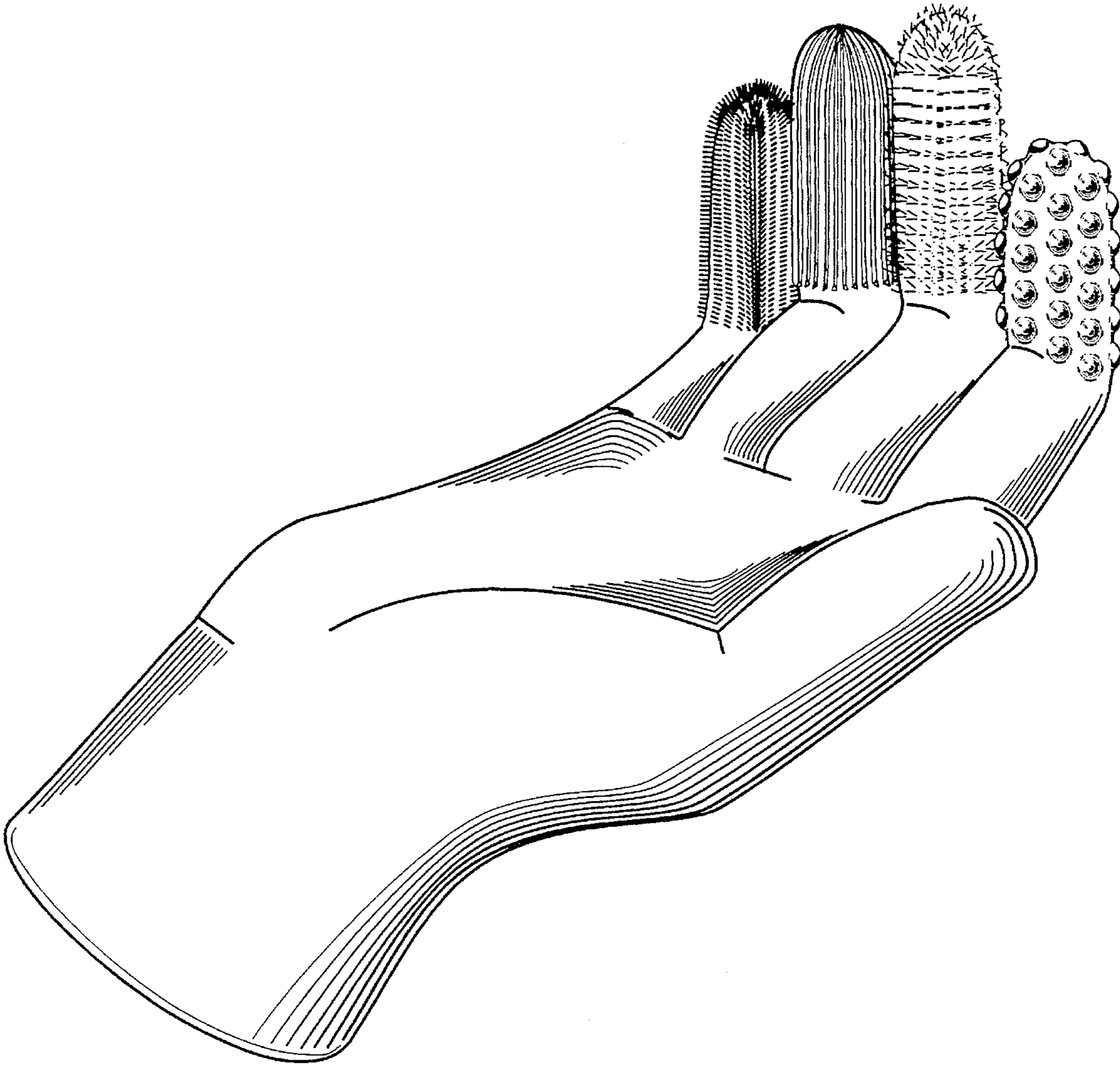
FIG. 10 is a bottom plan view thereof;

FIG. 11 is a left side elevational view thereof; and,

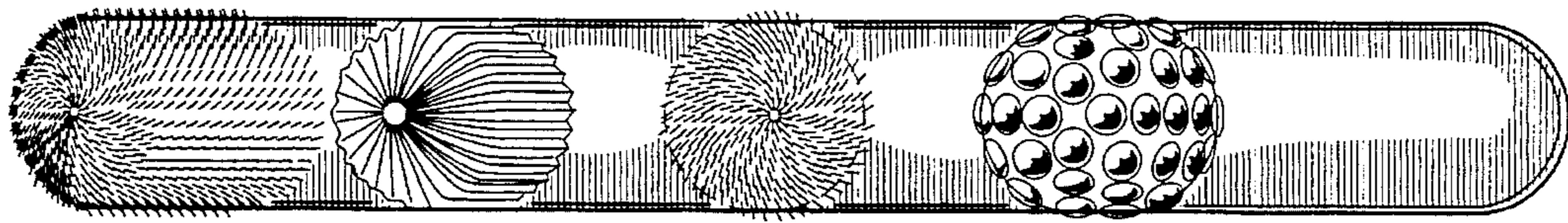
FIG. 12 is a right side elevational view thereof.

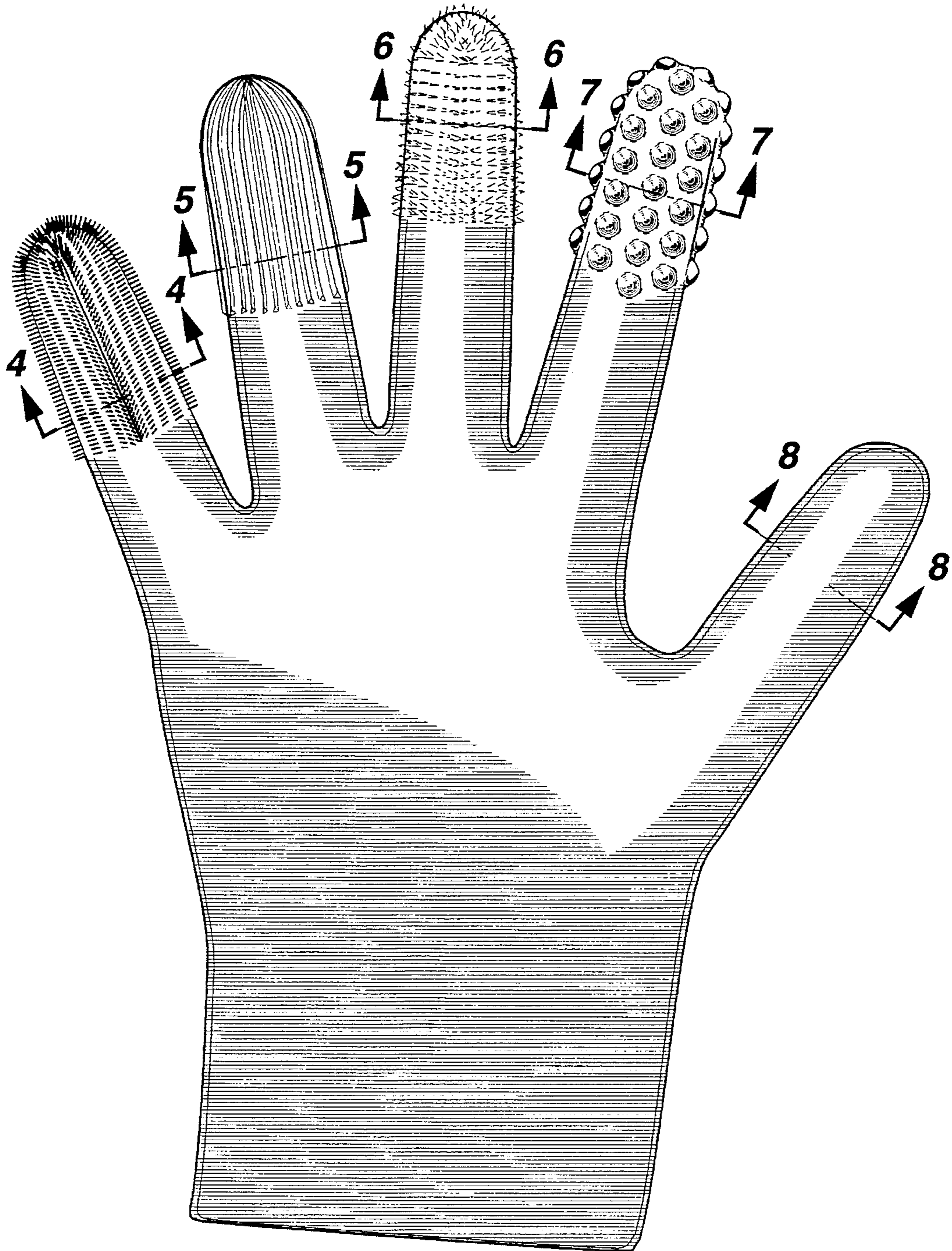




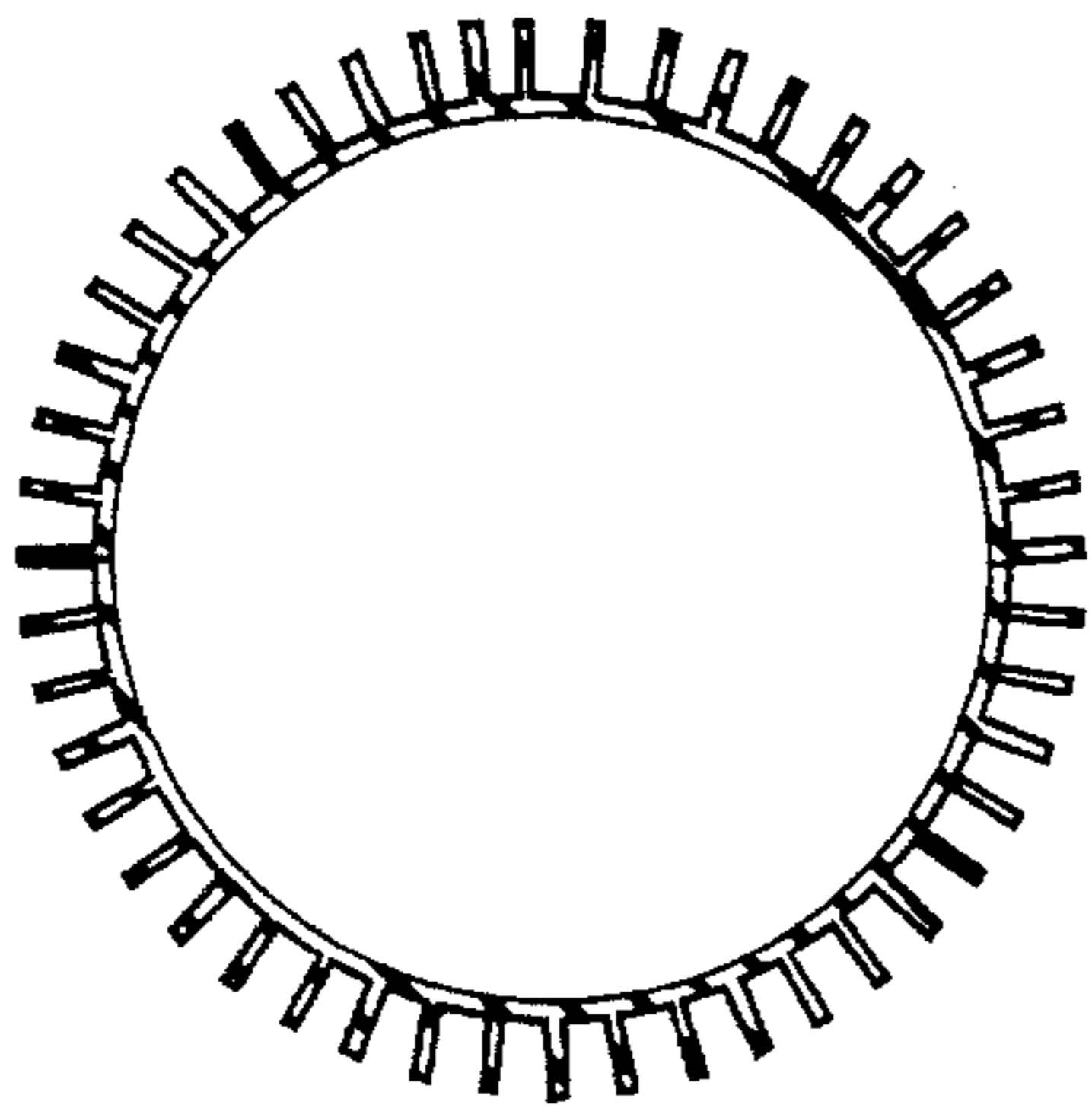

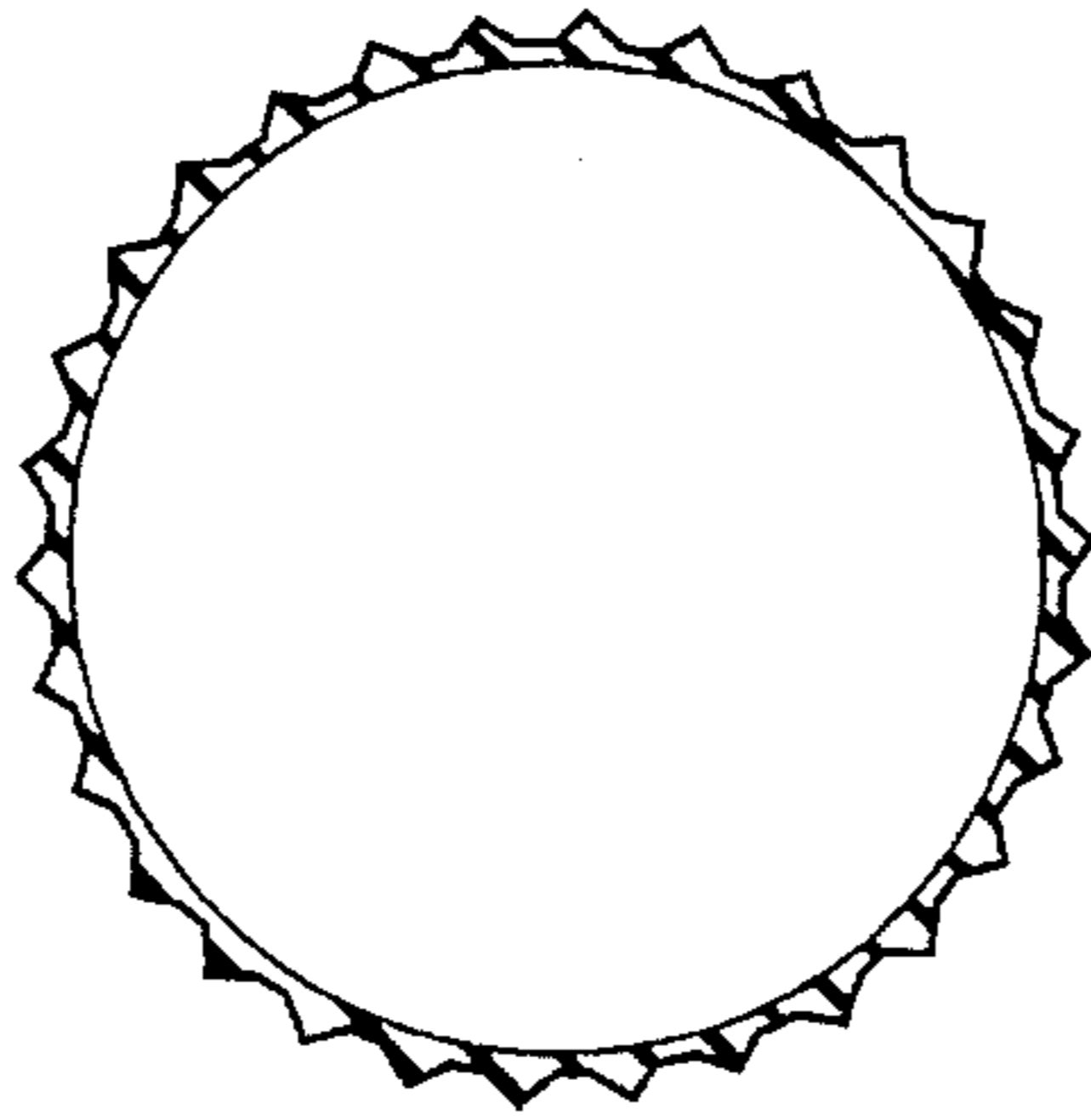

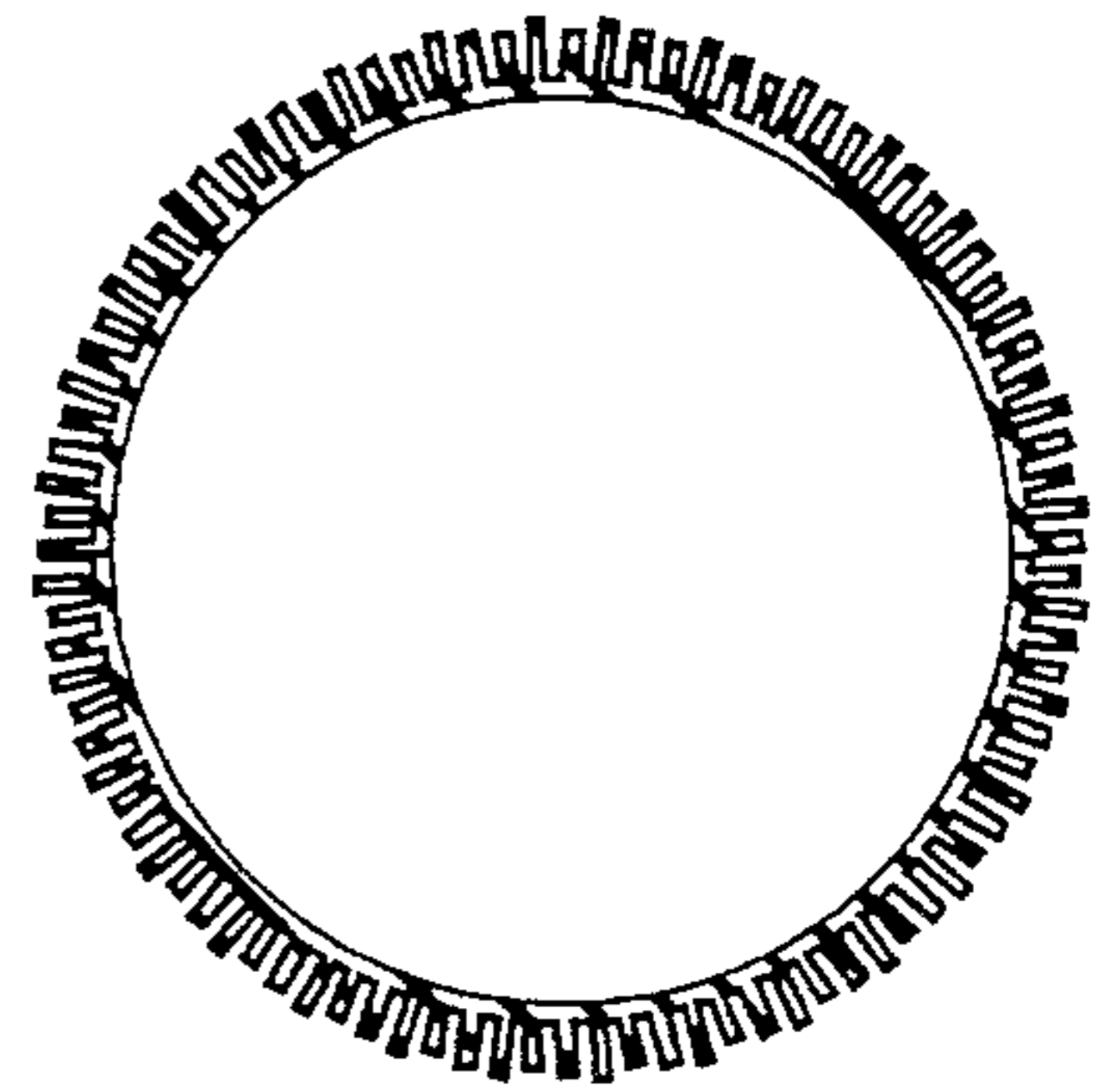

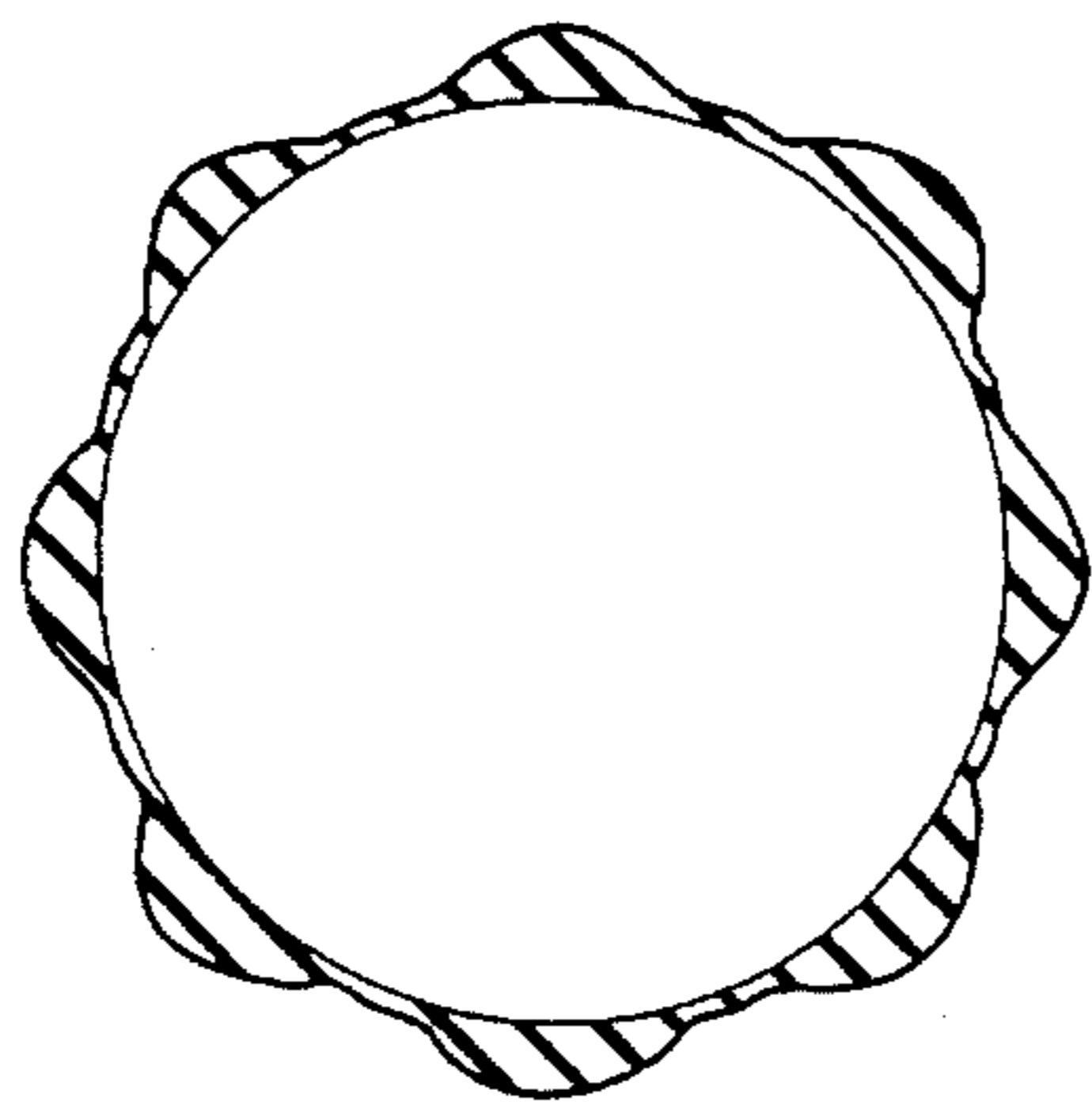

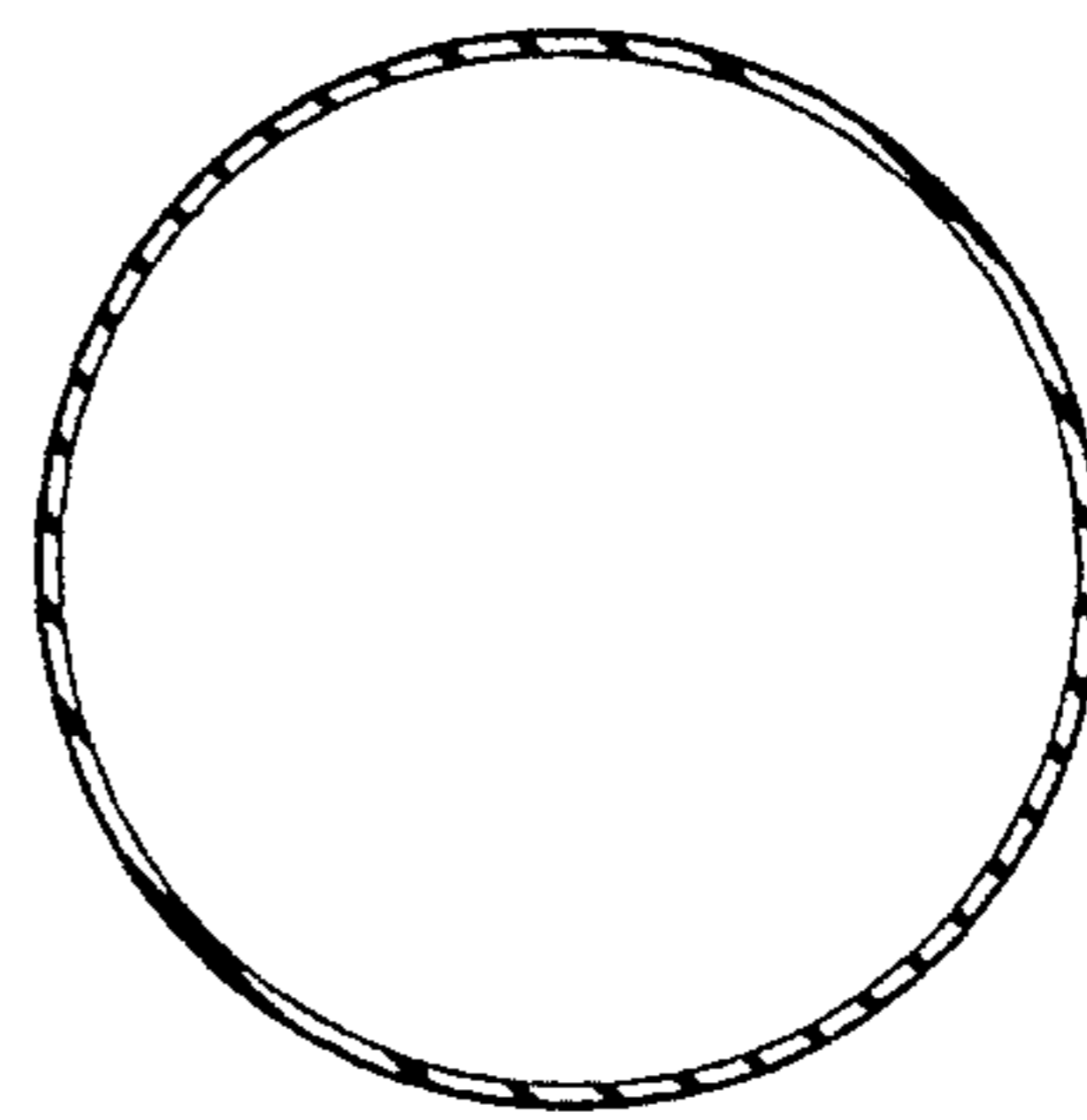

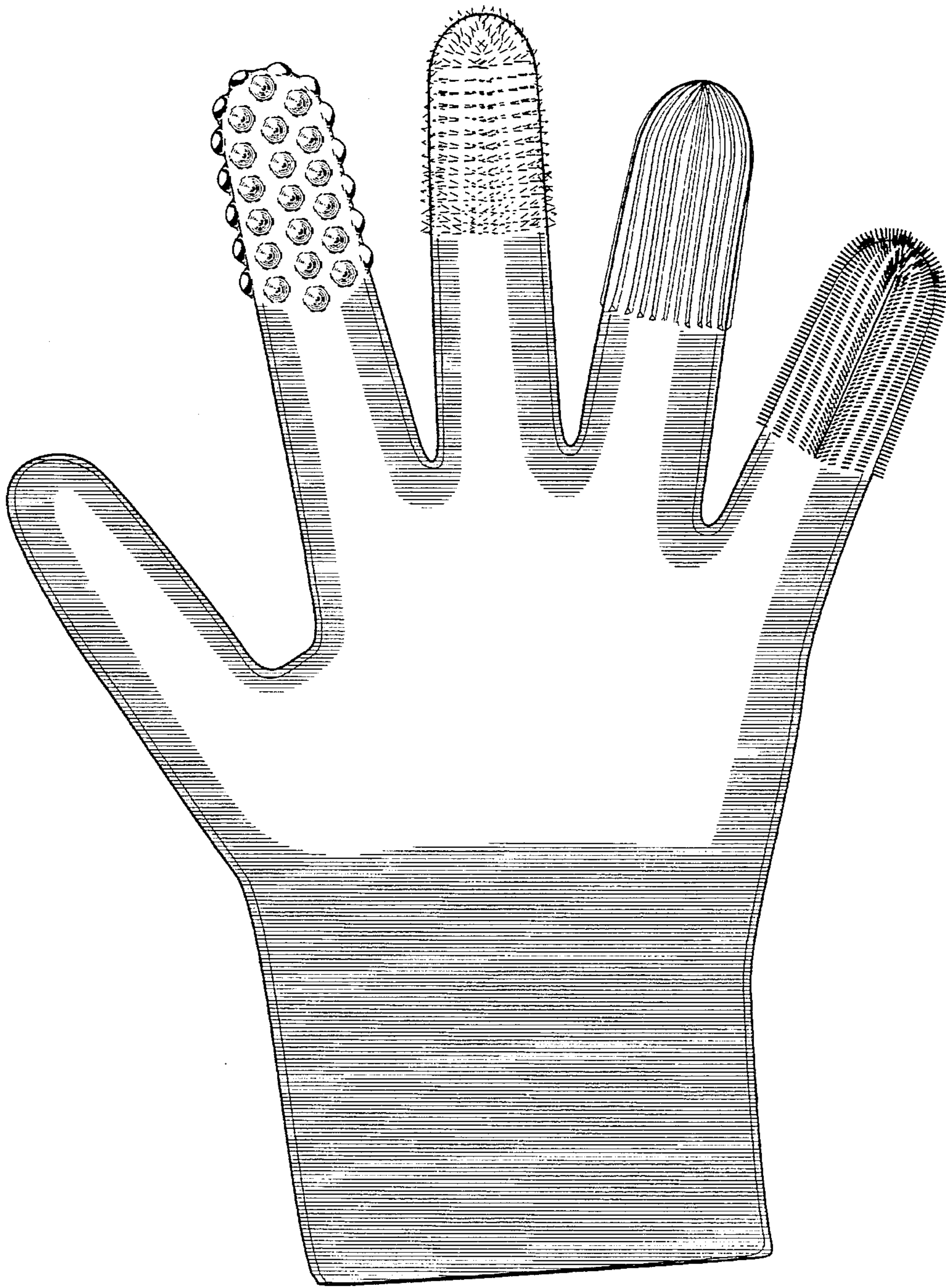

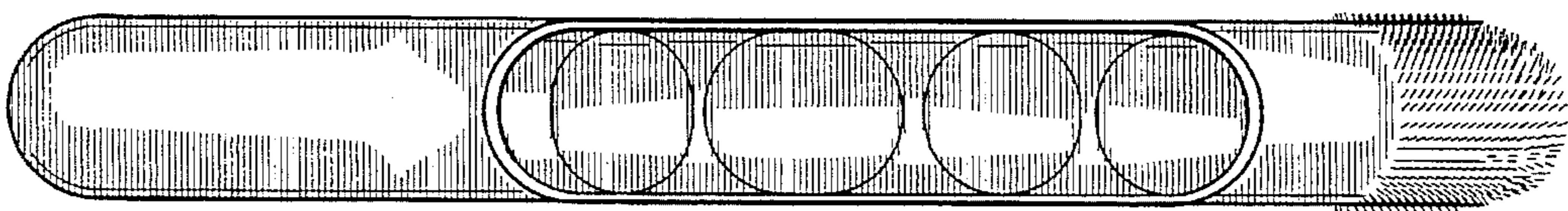

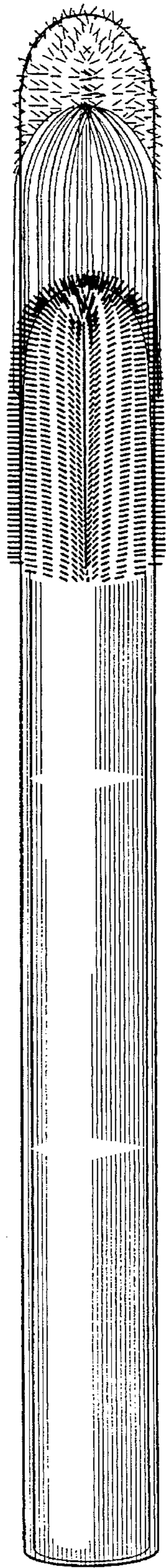

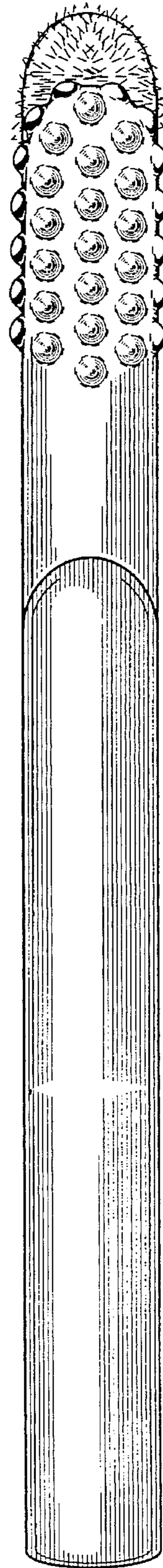
