FIG. 3 is a top plan view thereof assembled together;

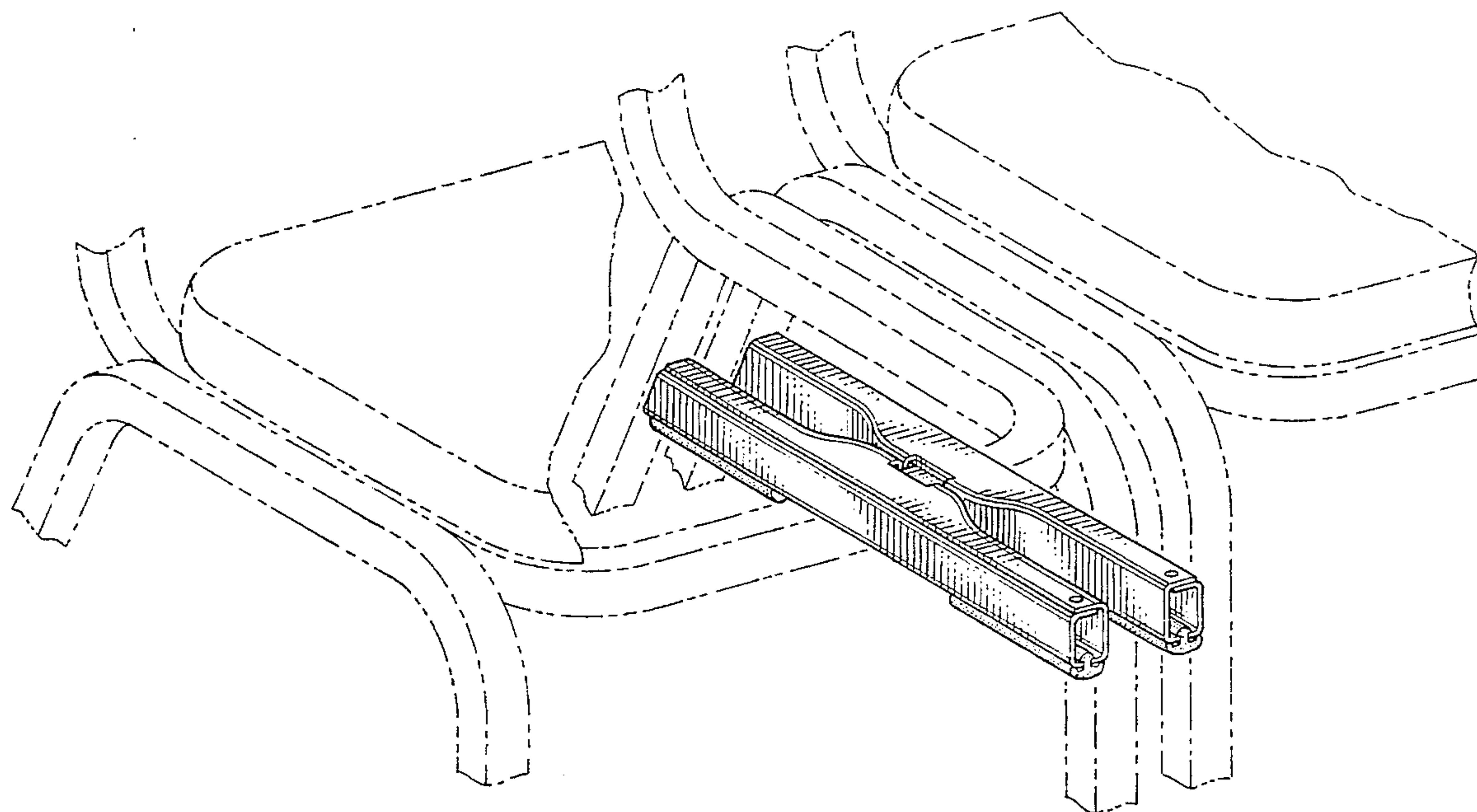
FIG. 4 is a right side elevational view thereof assembled

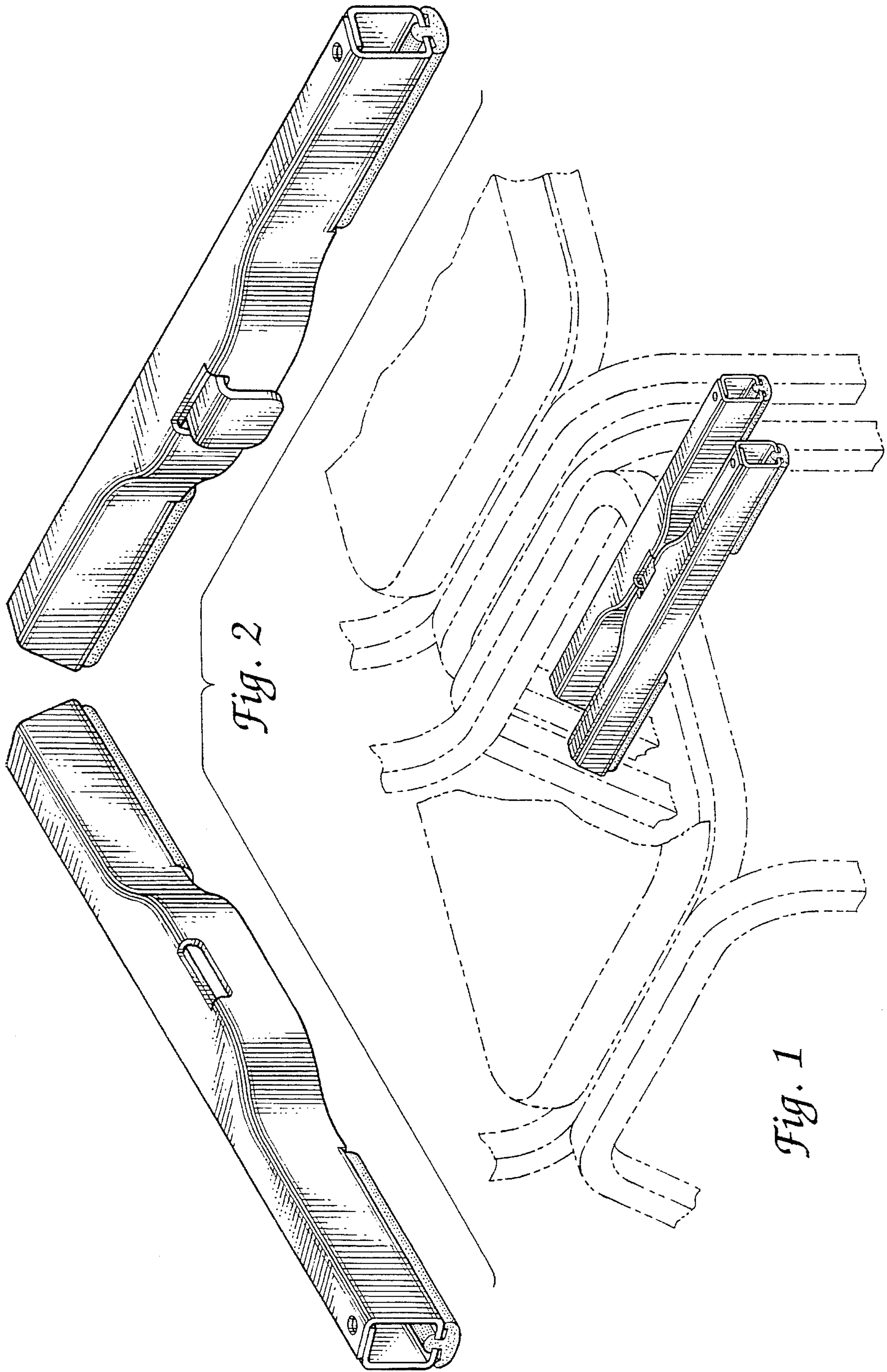

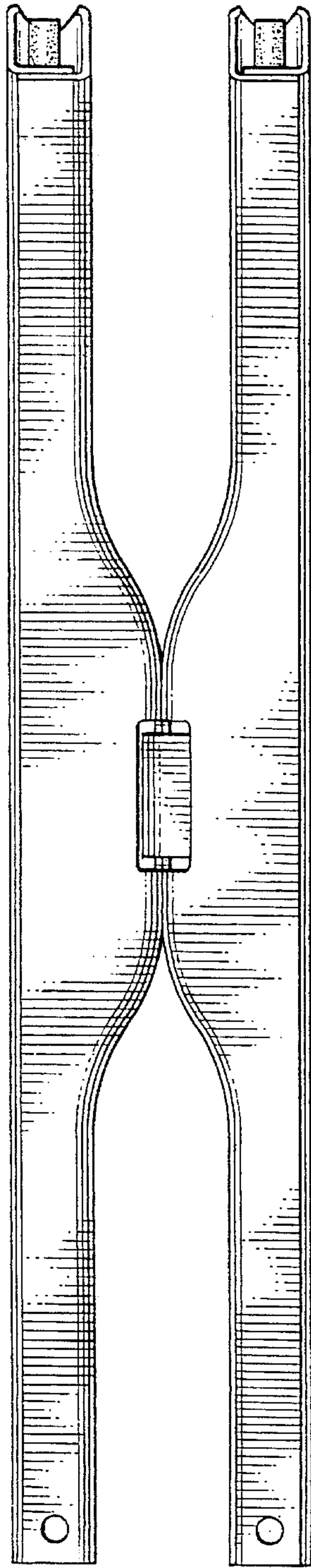

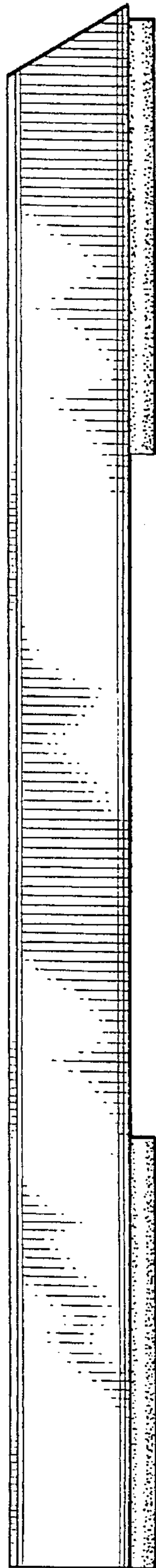

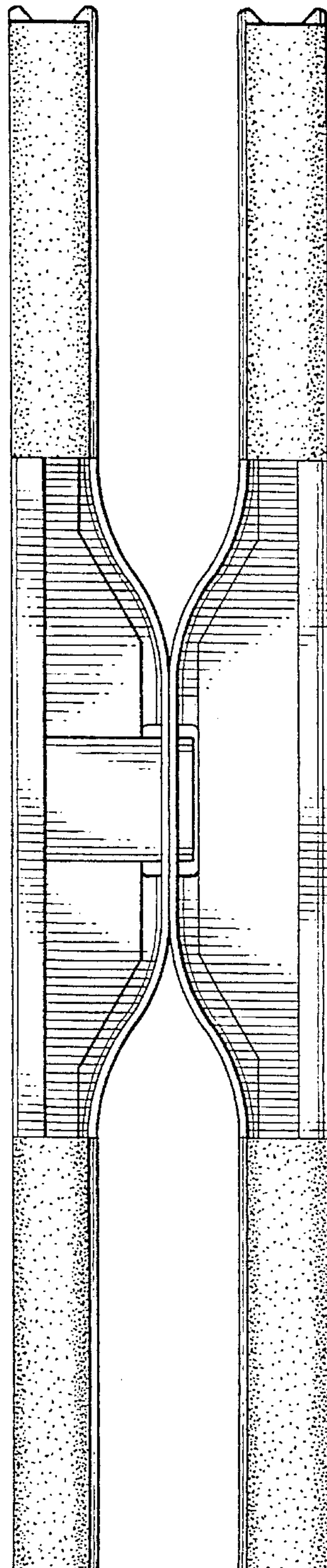

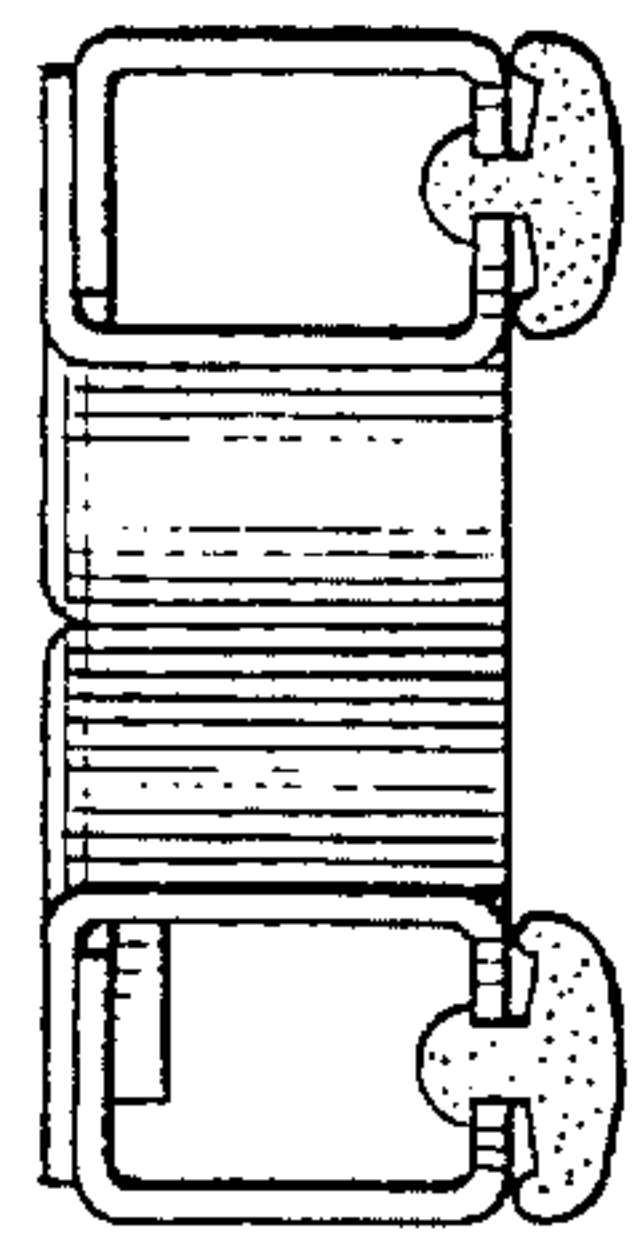
