The ornamental design for a printer for electronic computer, as shown and described.

## DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a printer for electronic computer showing my new design; FIG. 2 is a rear, bottom and left side perspective view thereof;

FIG. 5 is a top plan view thereof;

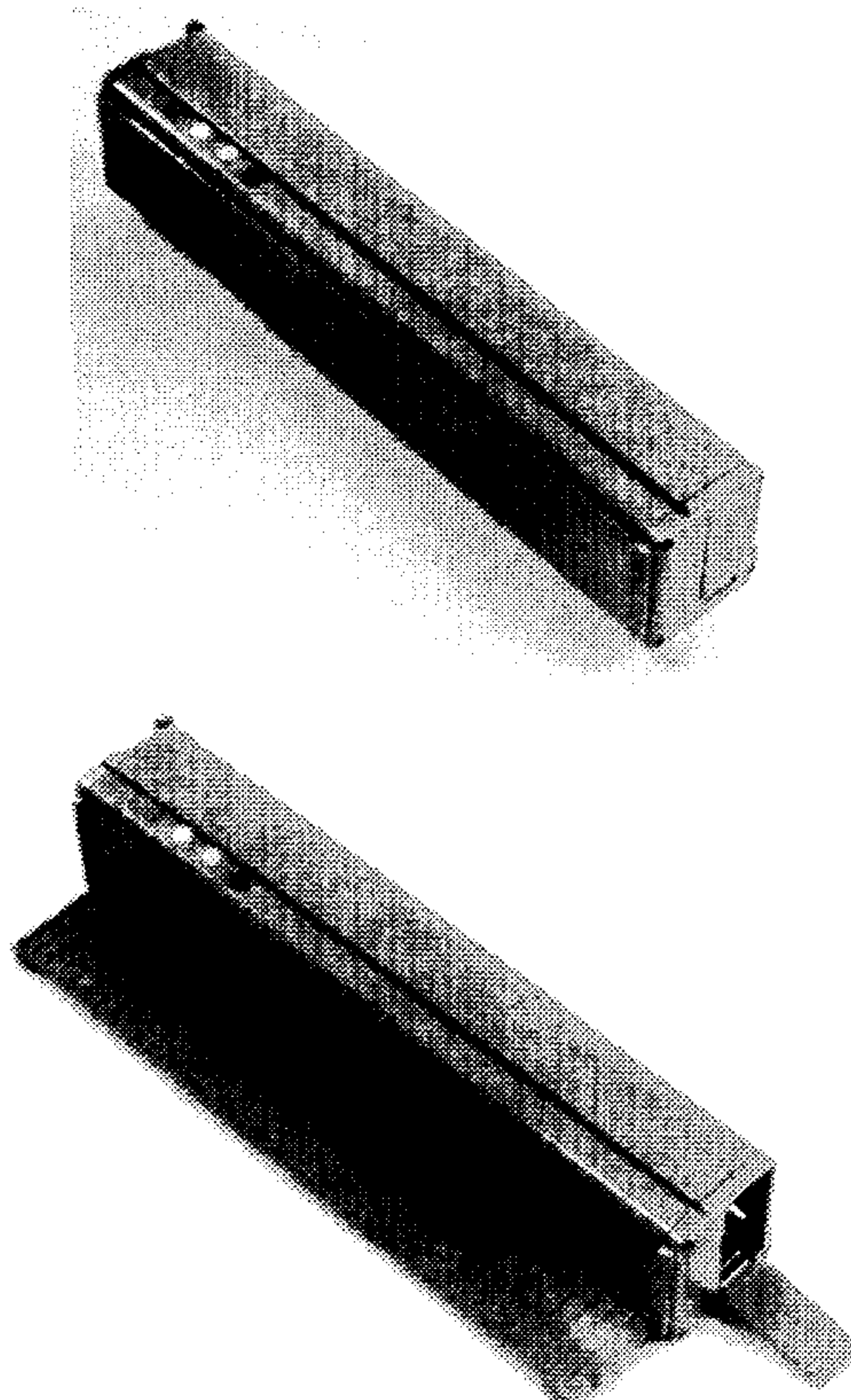
FIG. 6 is a right side elevational view thereof;

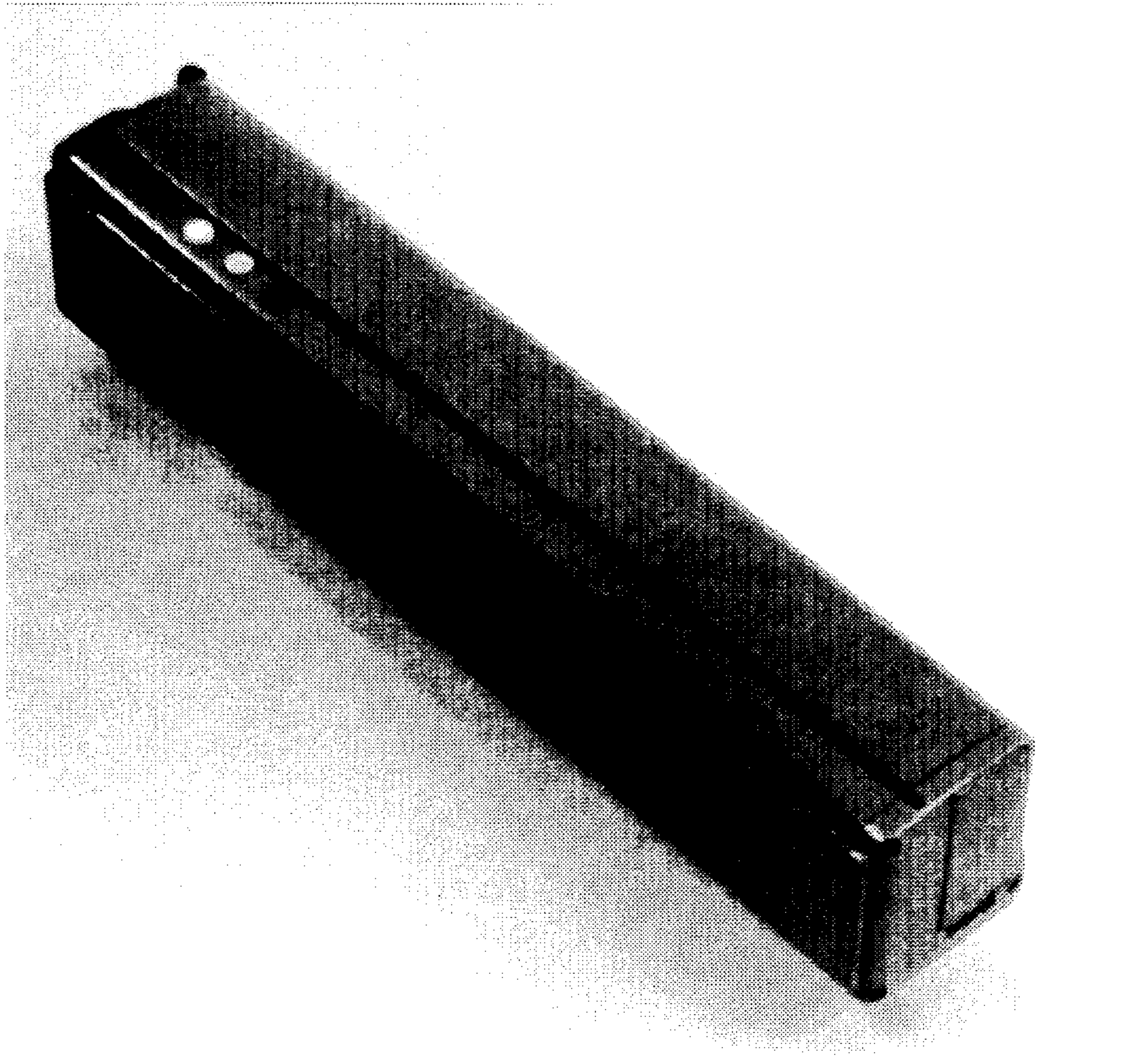

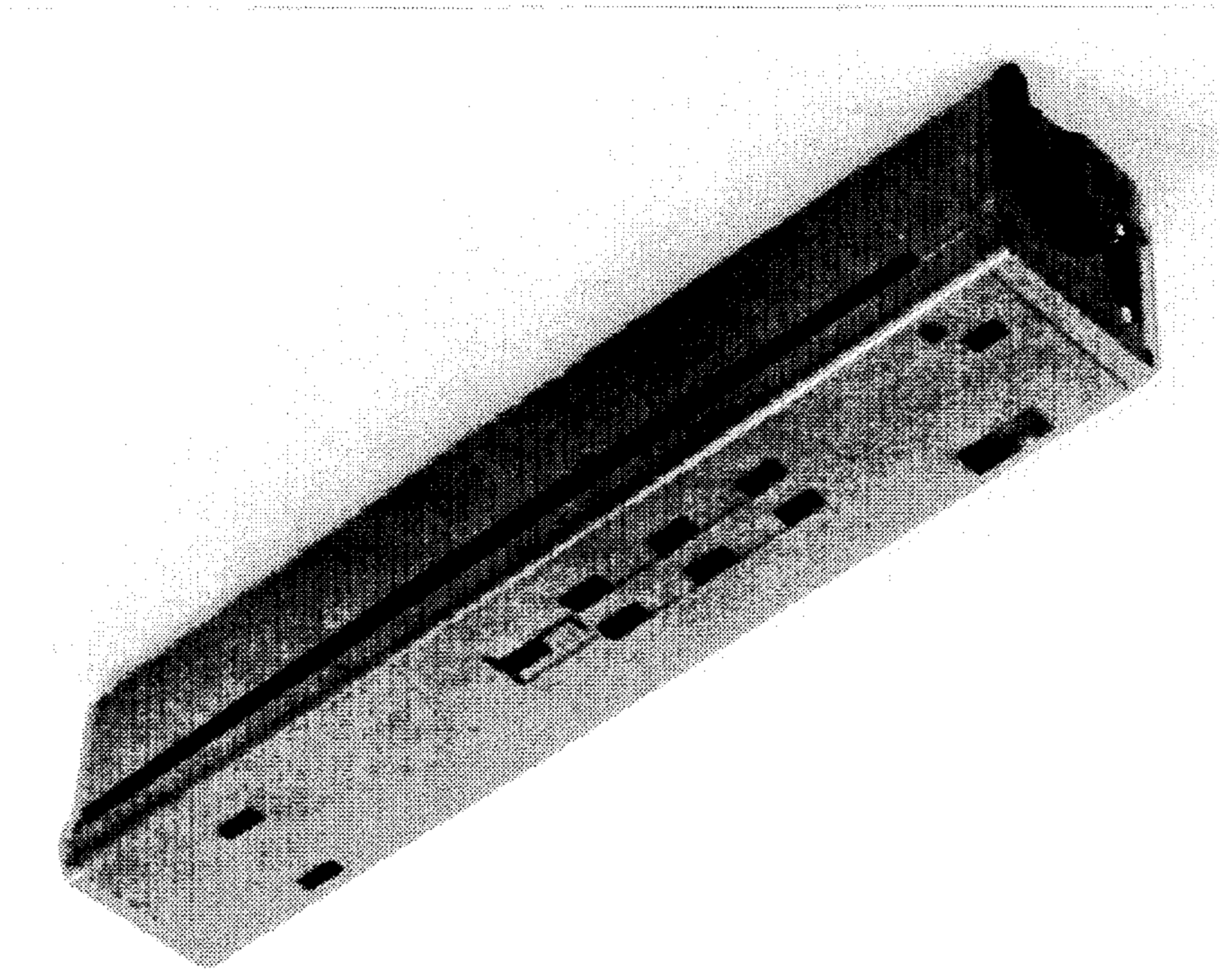

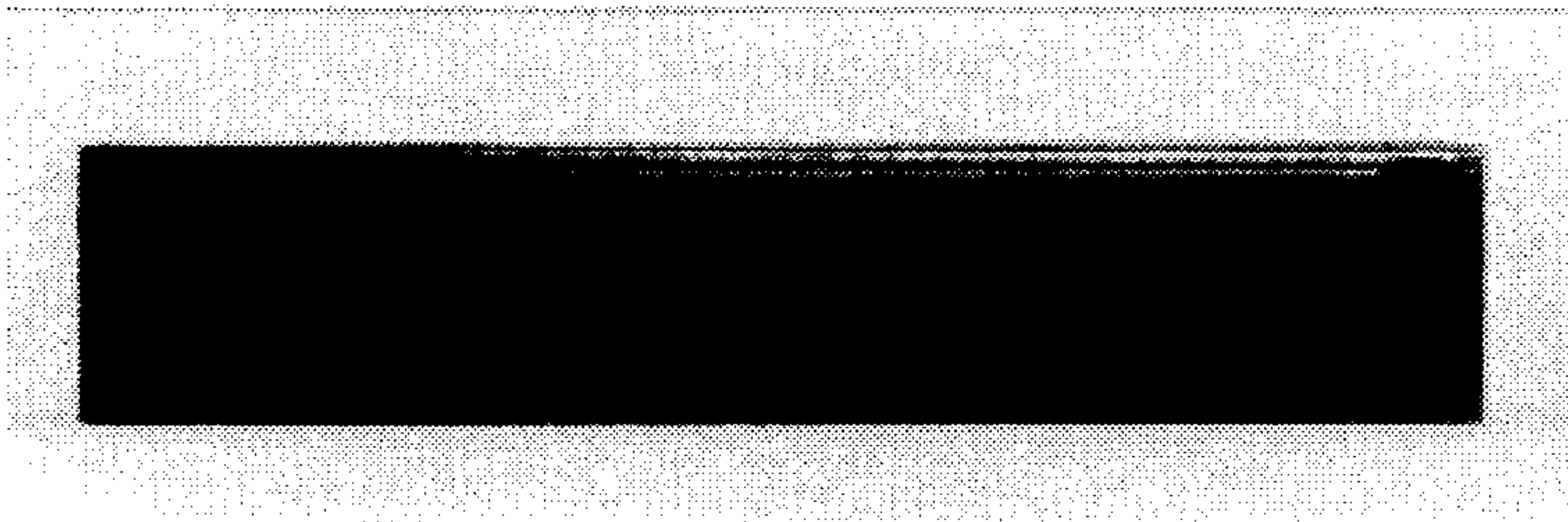

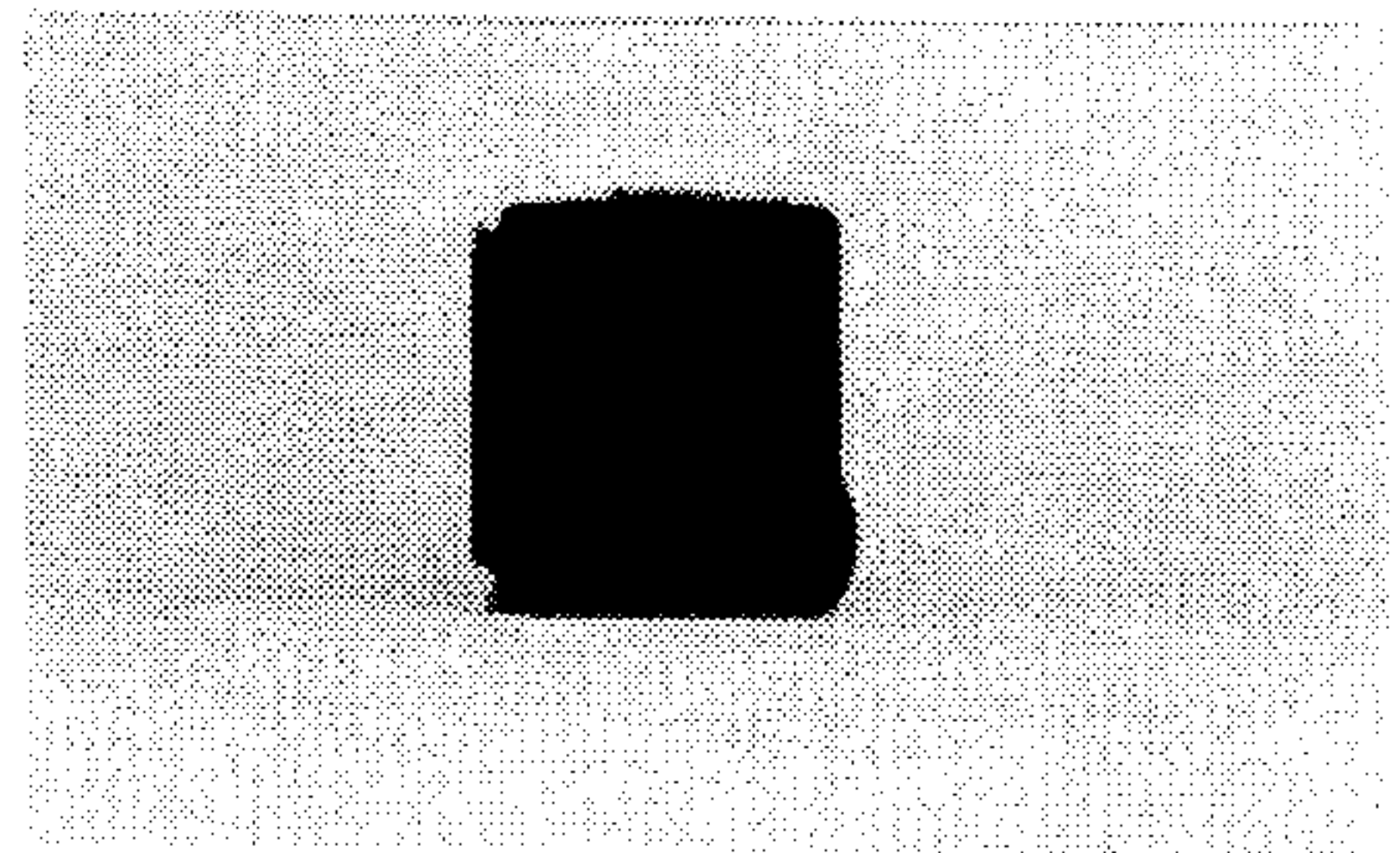

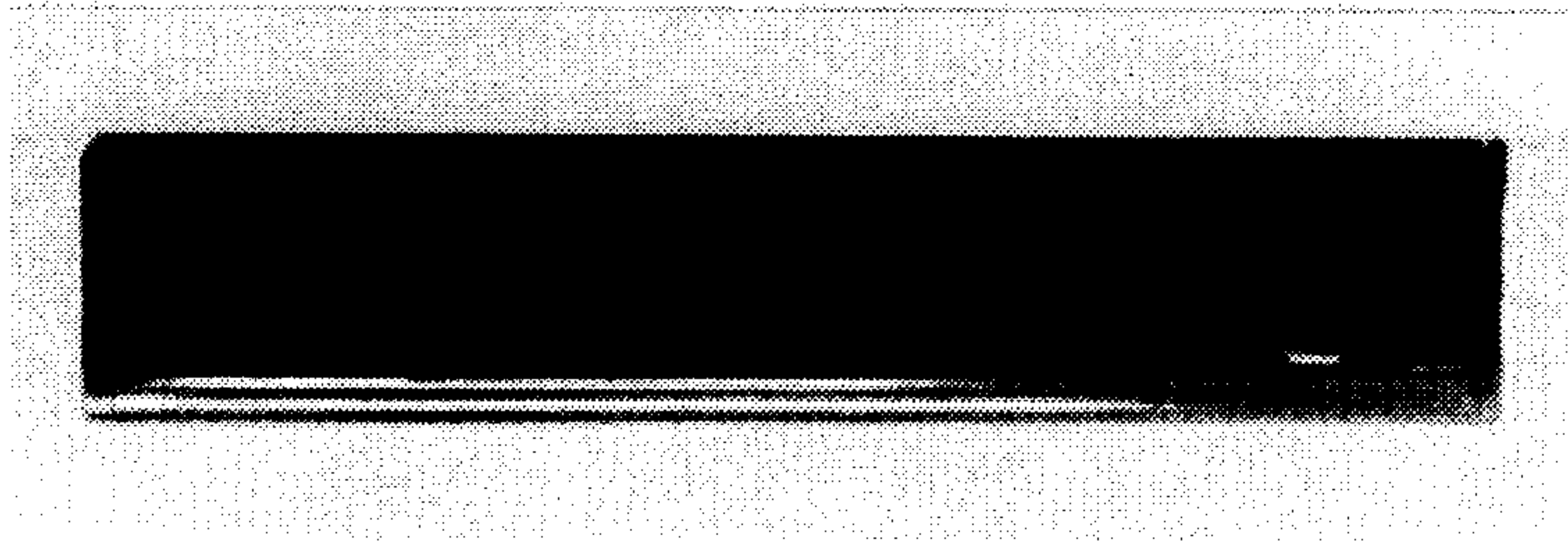

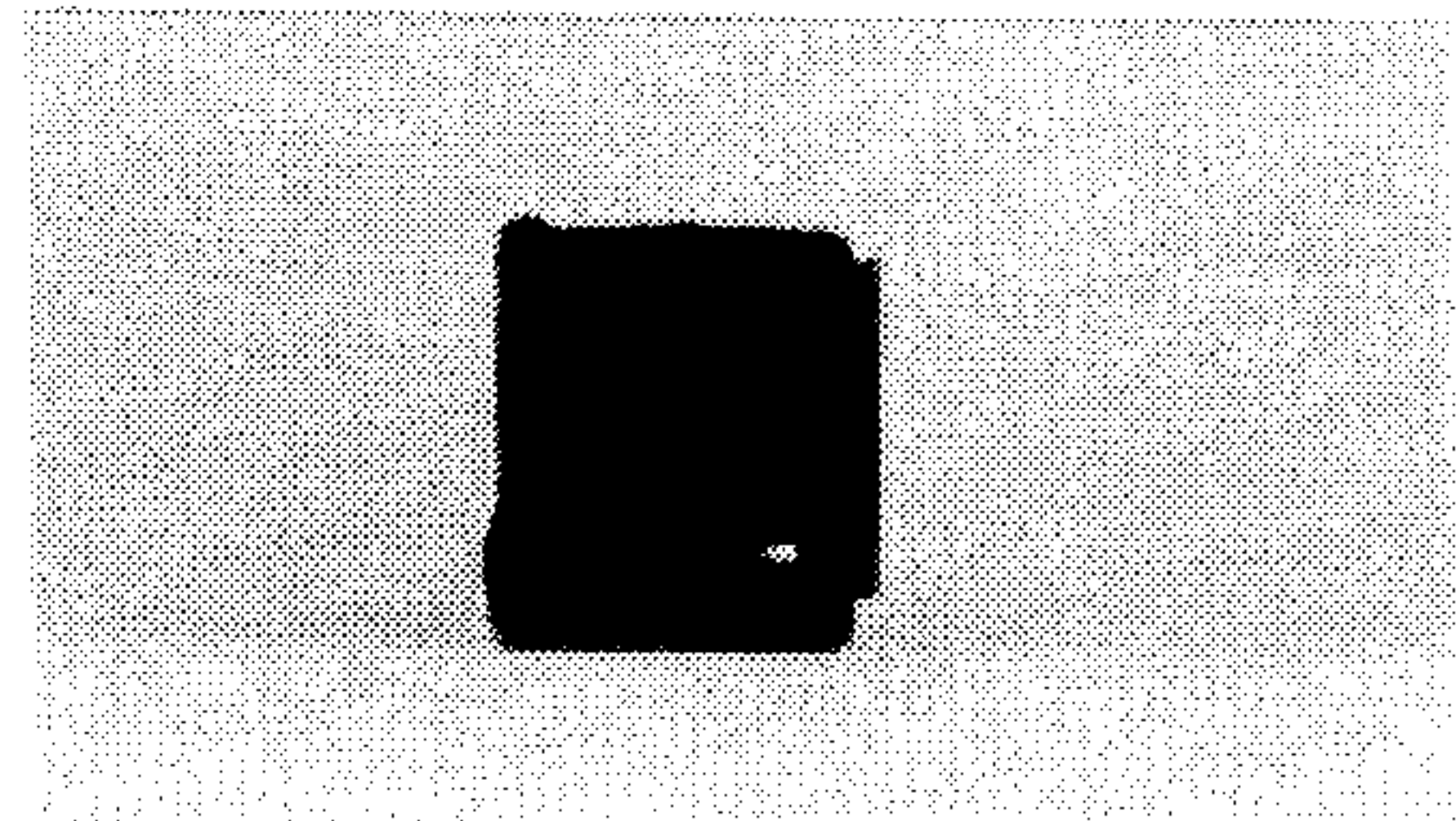

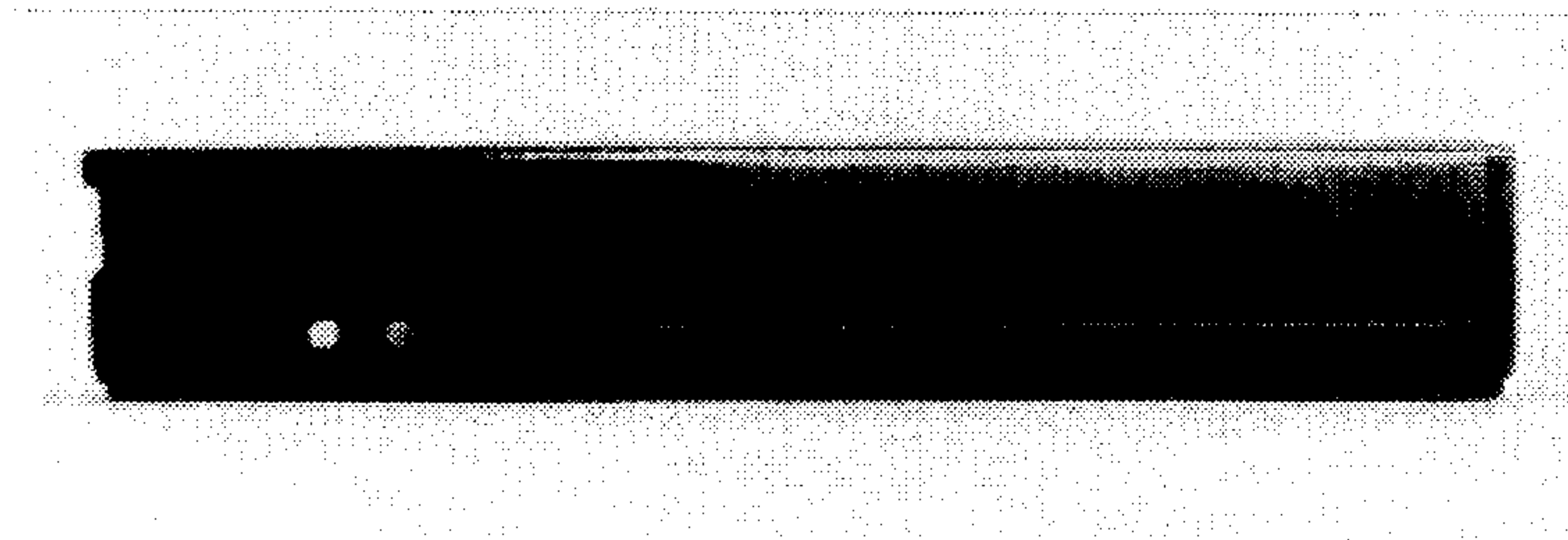

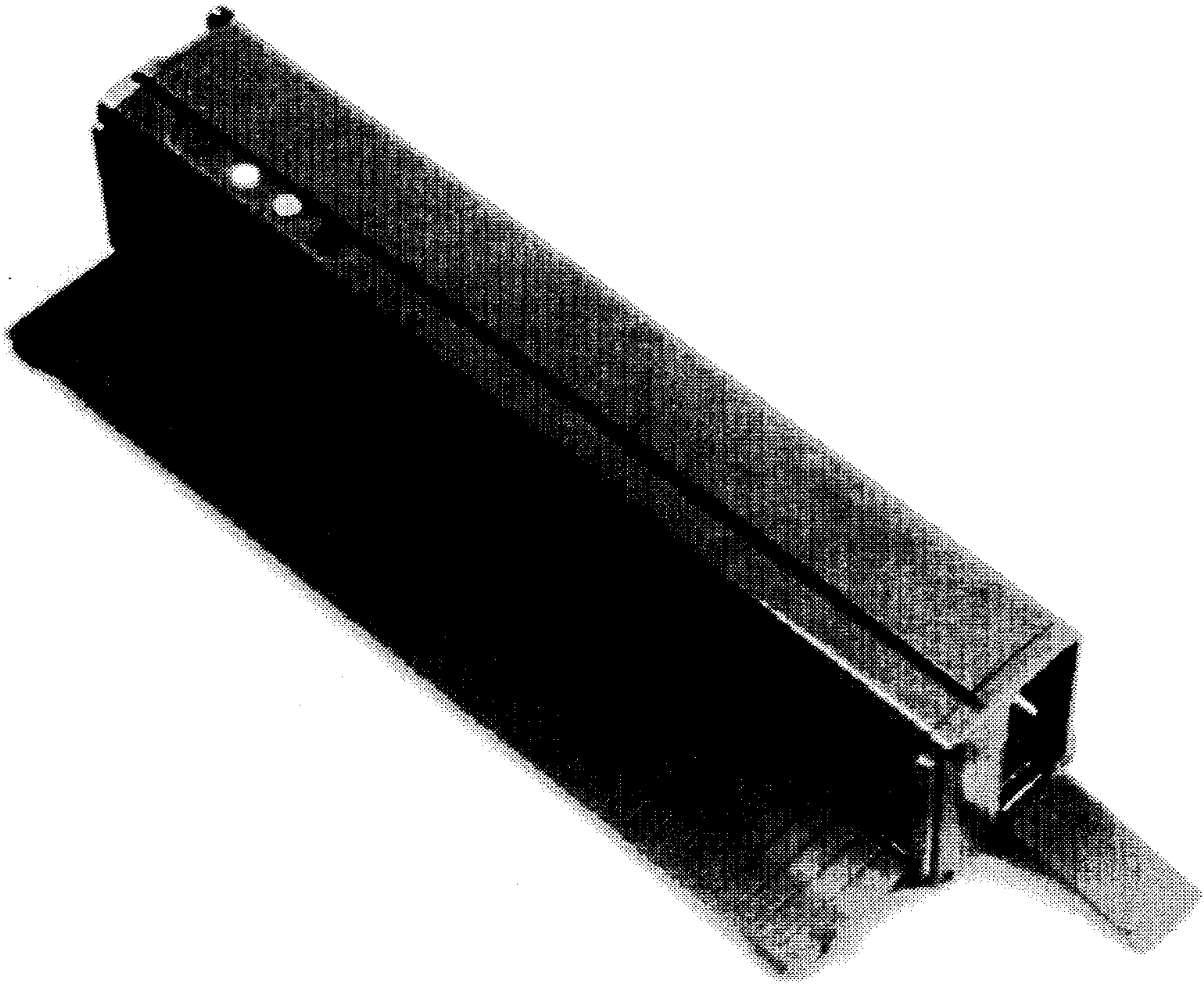
