FIG. 2 is a front elevational view of the sun visor shown separately for purposes of illustration;

FIG. 3 is a front elevational view of the neck guard shown separately for purposes of illustration;

FIG. 4 is a rear elevational view of the visor portion described by FIGS. 2;

FIG. 5 is a rear elevational view of the neck guard portion described by FIG. 3;

FIG. 6 is a top plan view of the visor portion described by FIG. 2;

FIG. 7 is a bottom plan view of the visor portion described by FIG. 2;

FIG. 8 is a top plan view of the neck guard portion described by FIG. 3; and,

FIG. 9 is a bottom plan view of the neck guard portion described by FIG. 3.

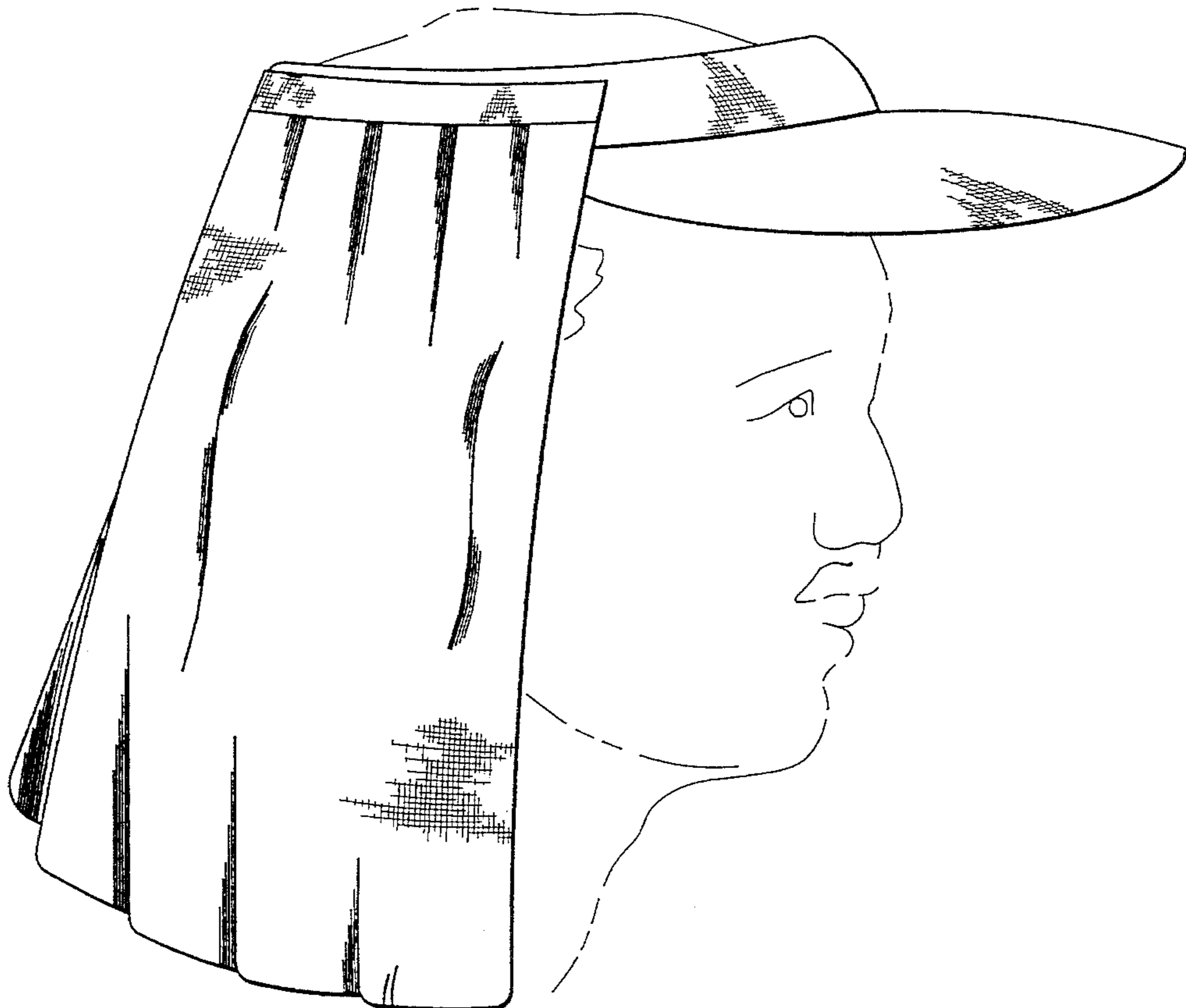

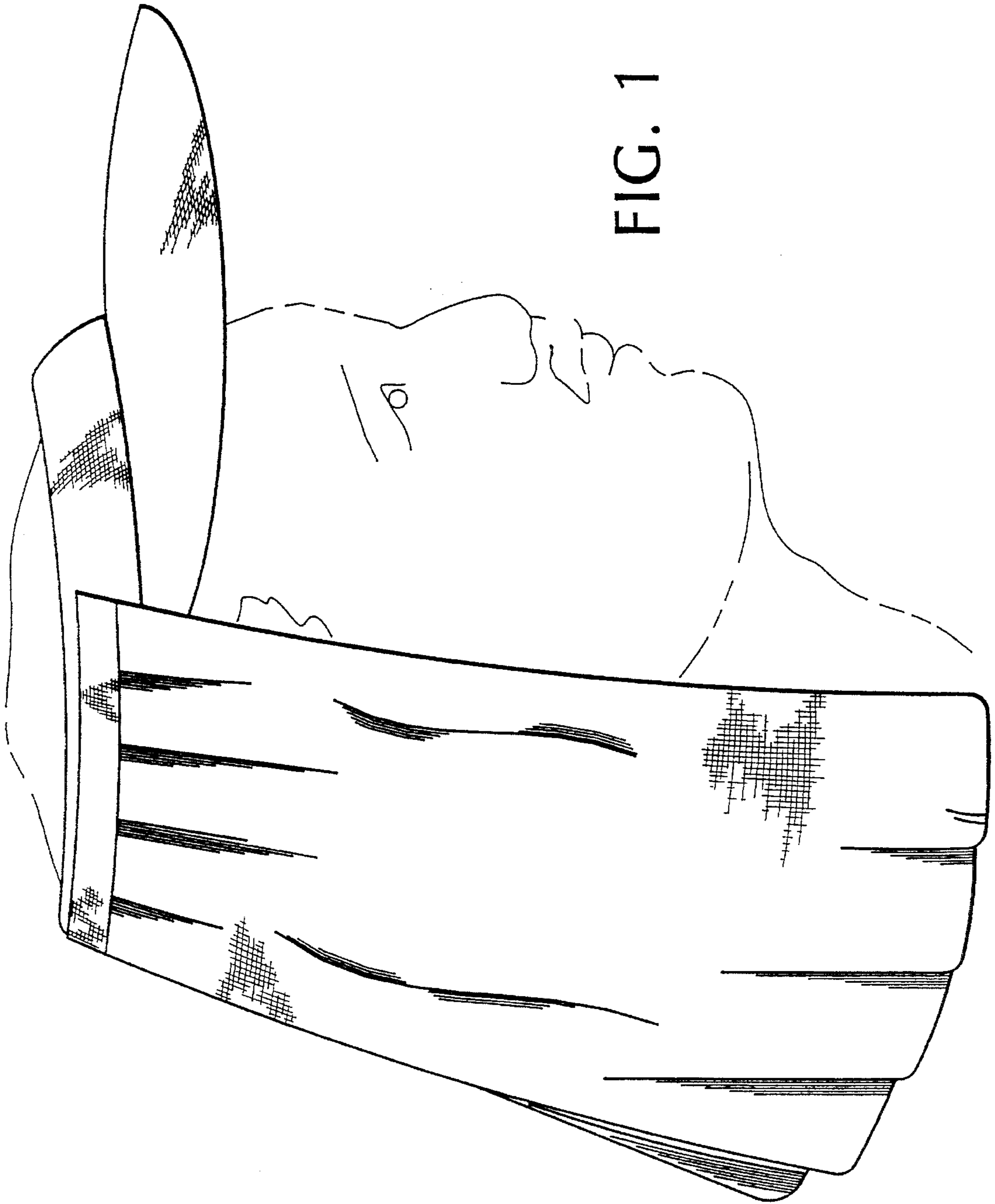

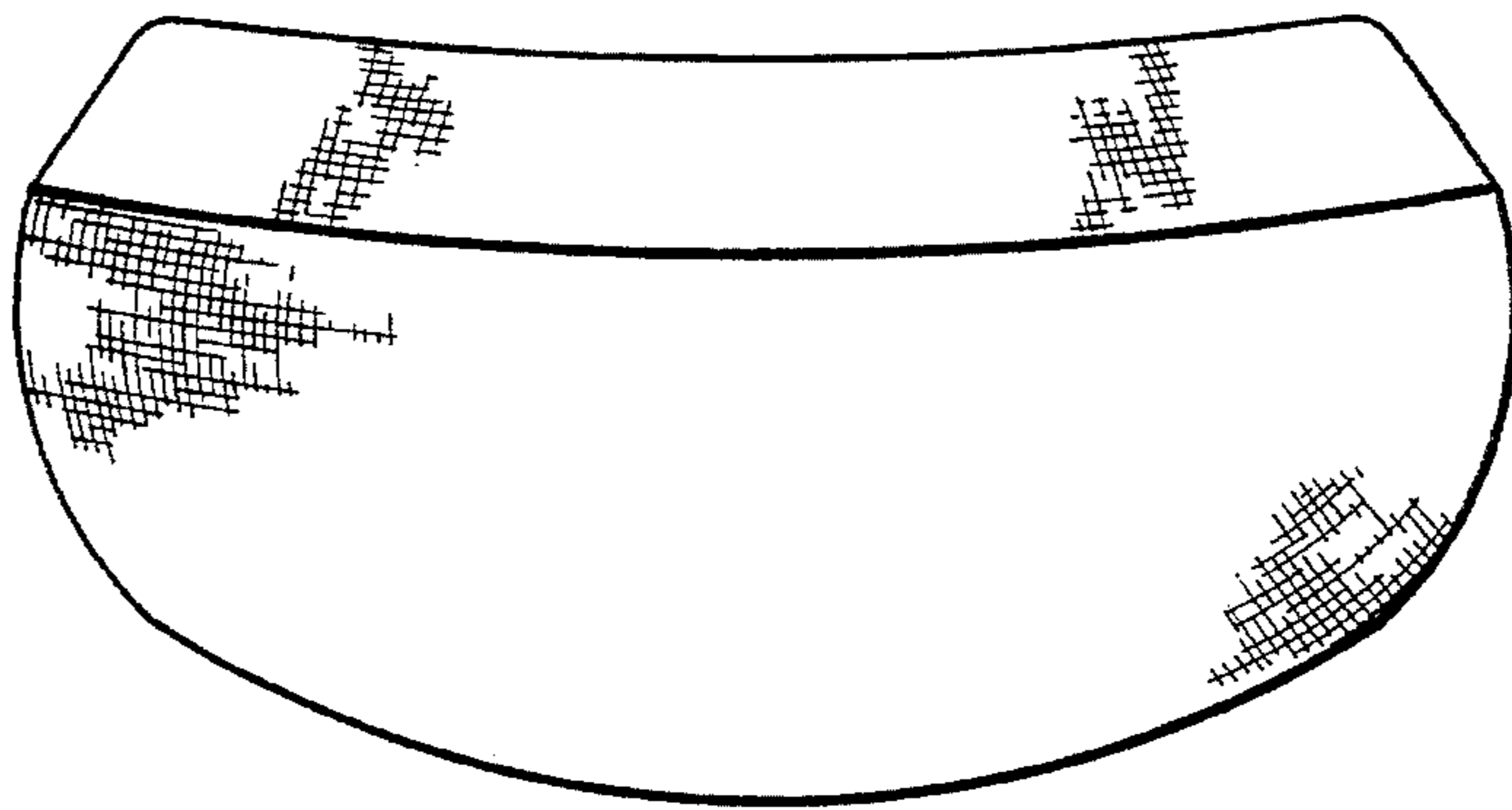

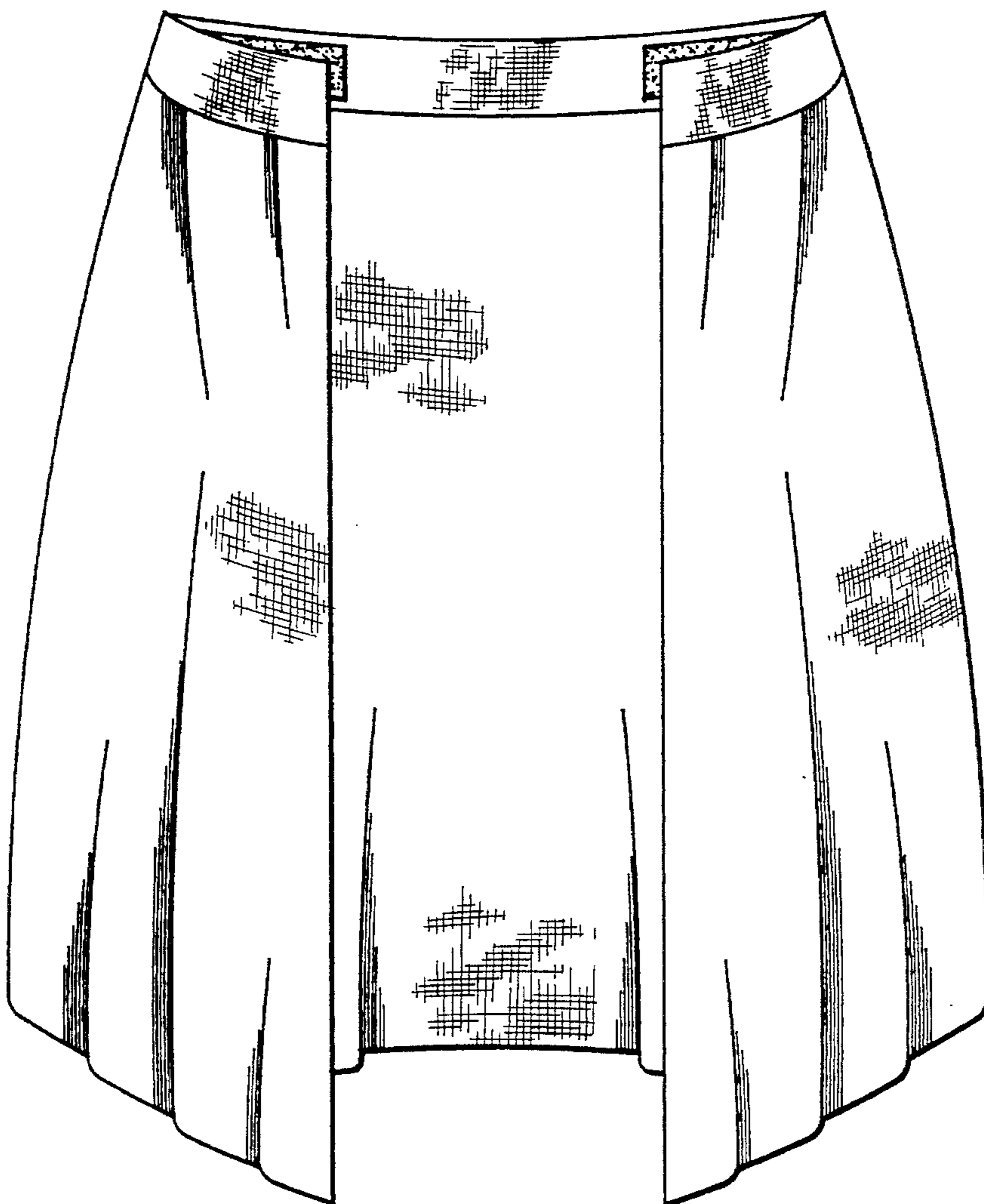

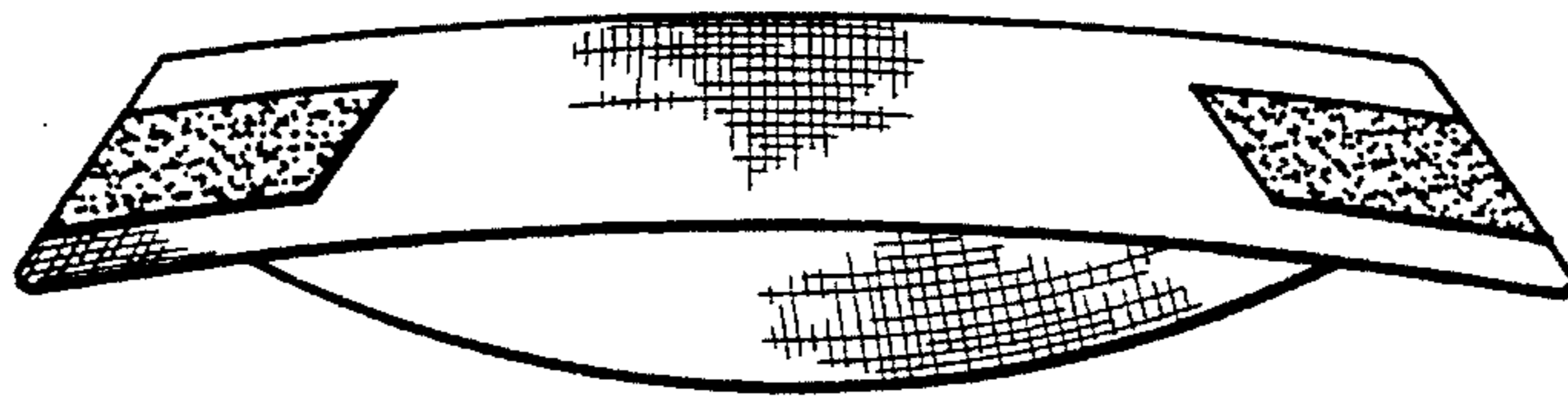

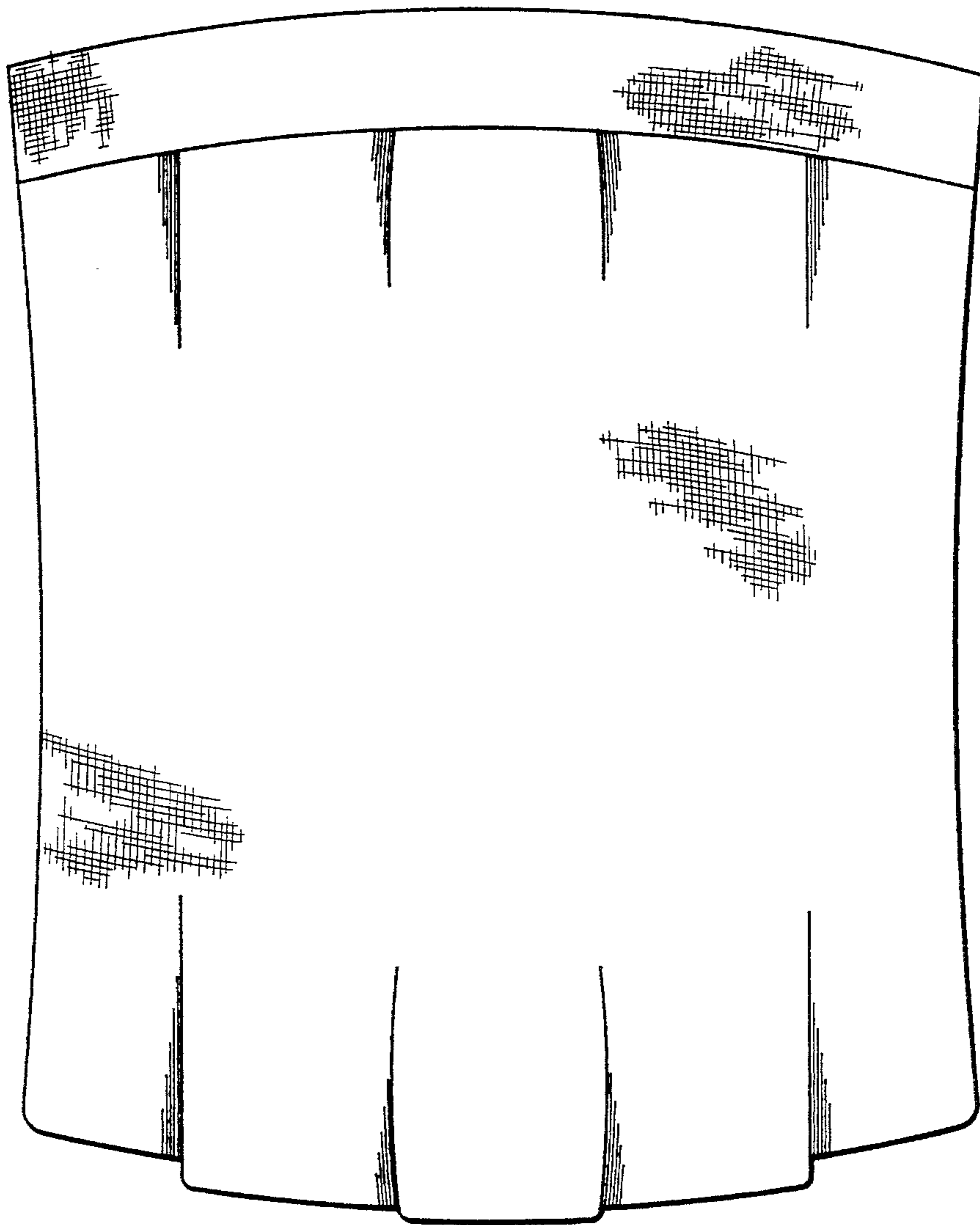

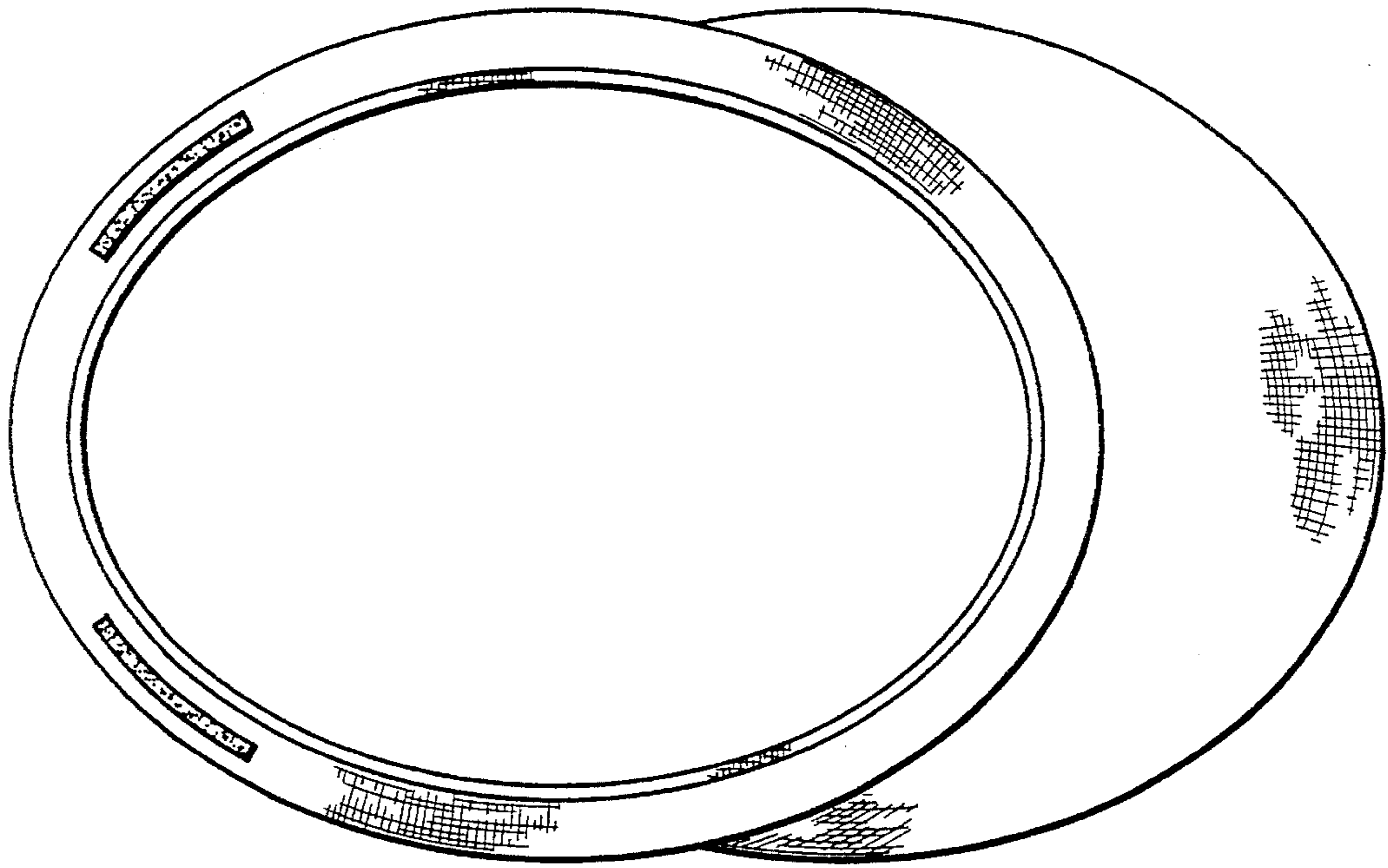

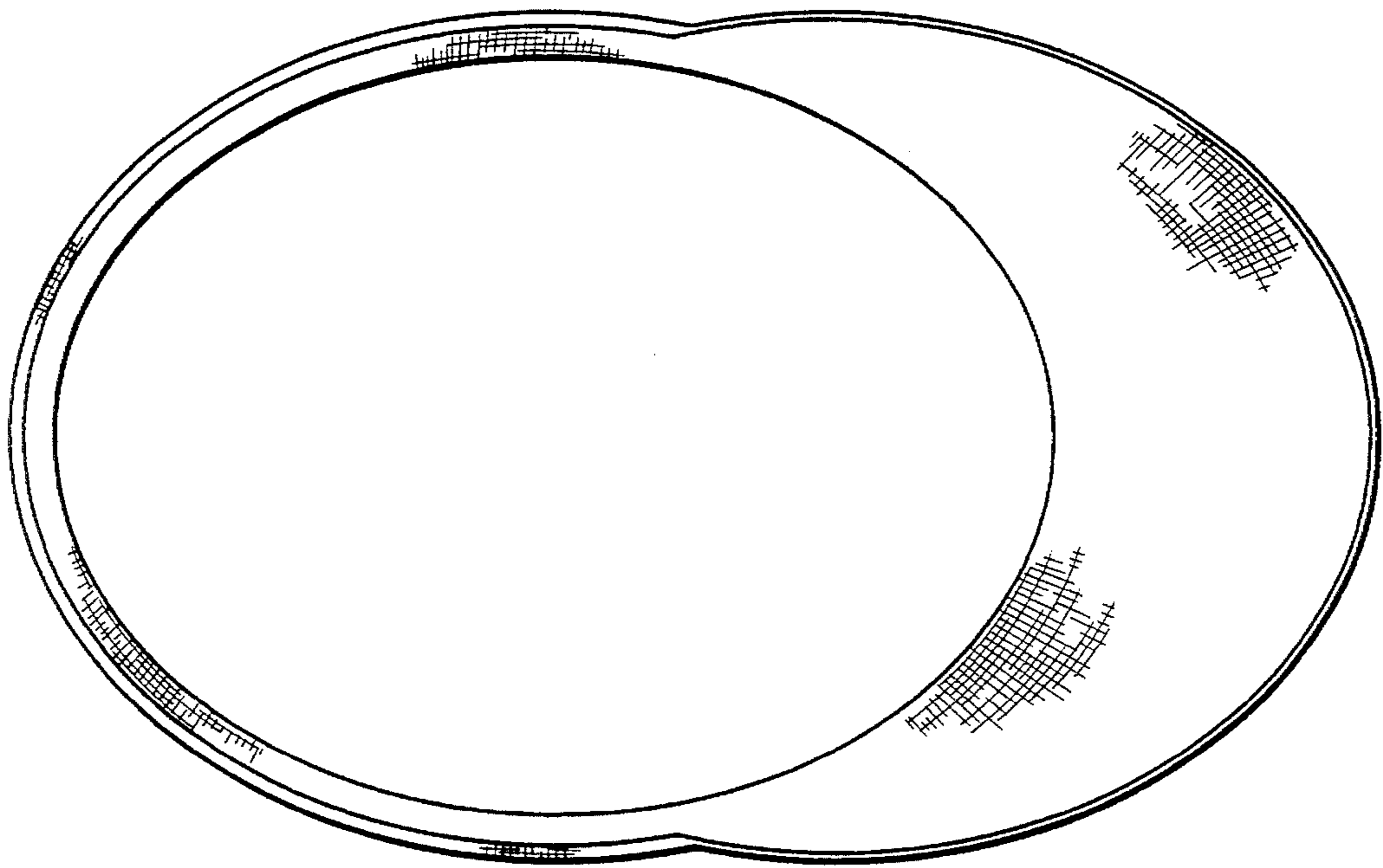
