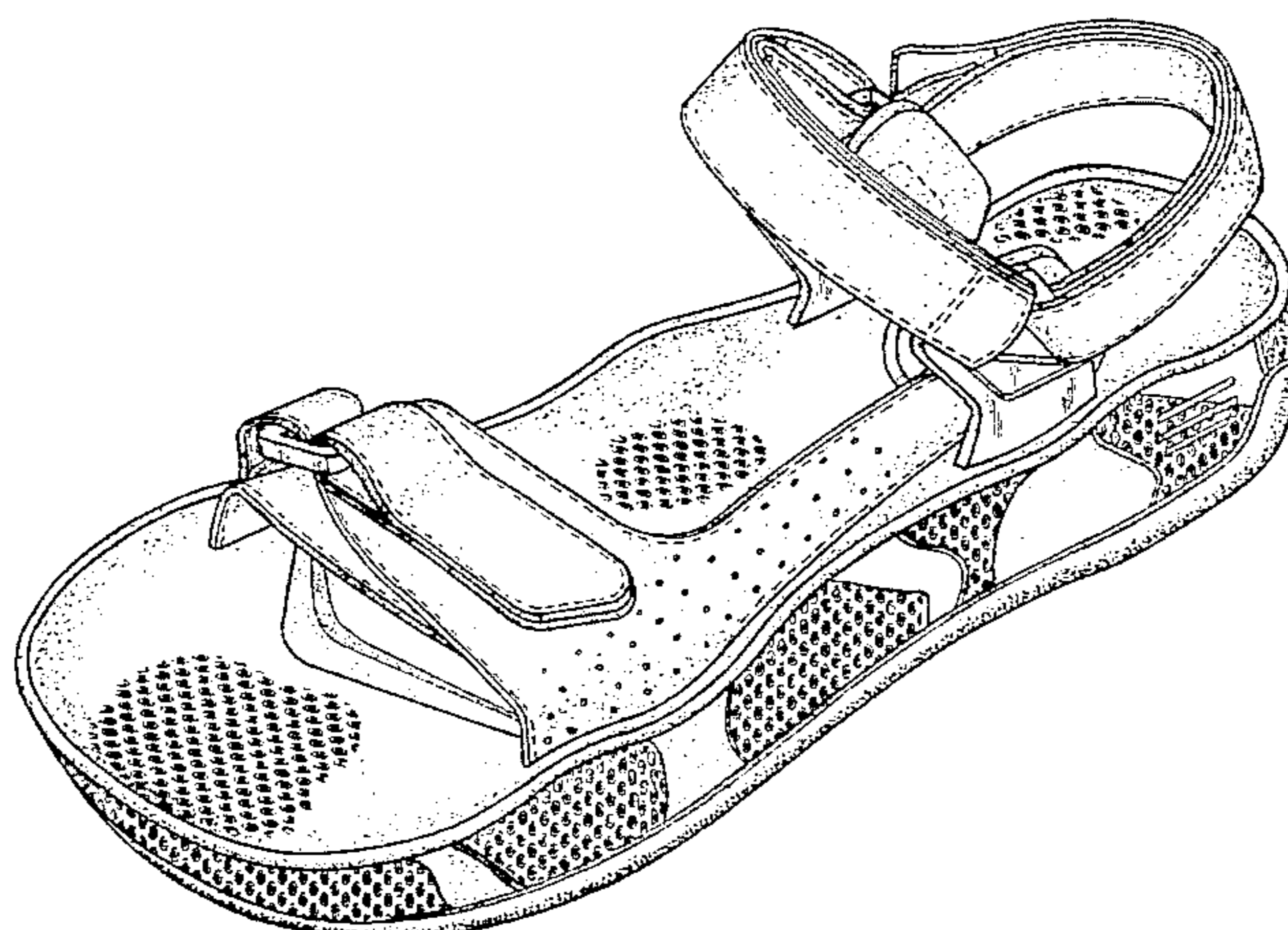
[57] **CLAIM**

The ornamental design for a sandal, as shown.

DESCRIPTION

FIG. 1 is a top perspective view of a sandal, showing my new design;
FIG. 2 is a front elevational view of the sandal shown in FIG. 1;
FIG. 3 is a rear elevational view of the sandal shown in FIG. 1;
FIG. 4 is a top plan view of the sandal shown in FIG. 1;
FIG. 5 is a bottom plan view of the sandal shown in FIG. 1;
FIG. 6 is a side elevational view of one side of the sandal shown in FIG. 1; and,
FIG. 7 is a side elevational view of the other side of the sandal shown in FIG. 1.

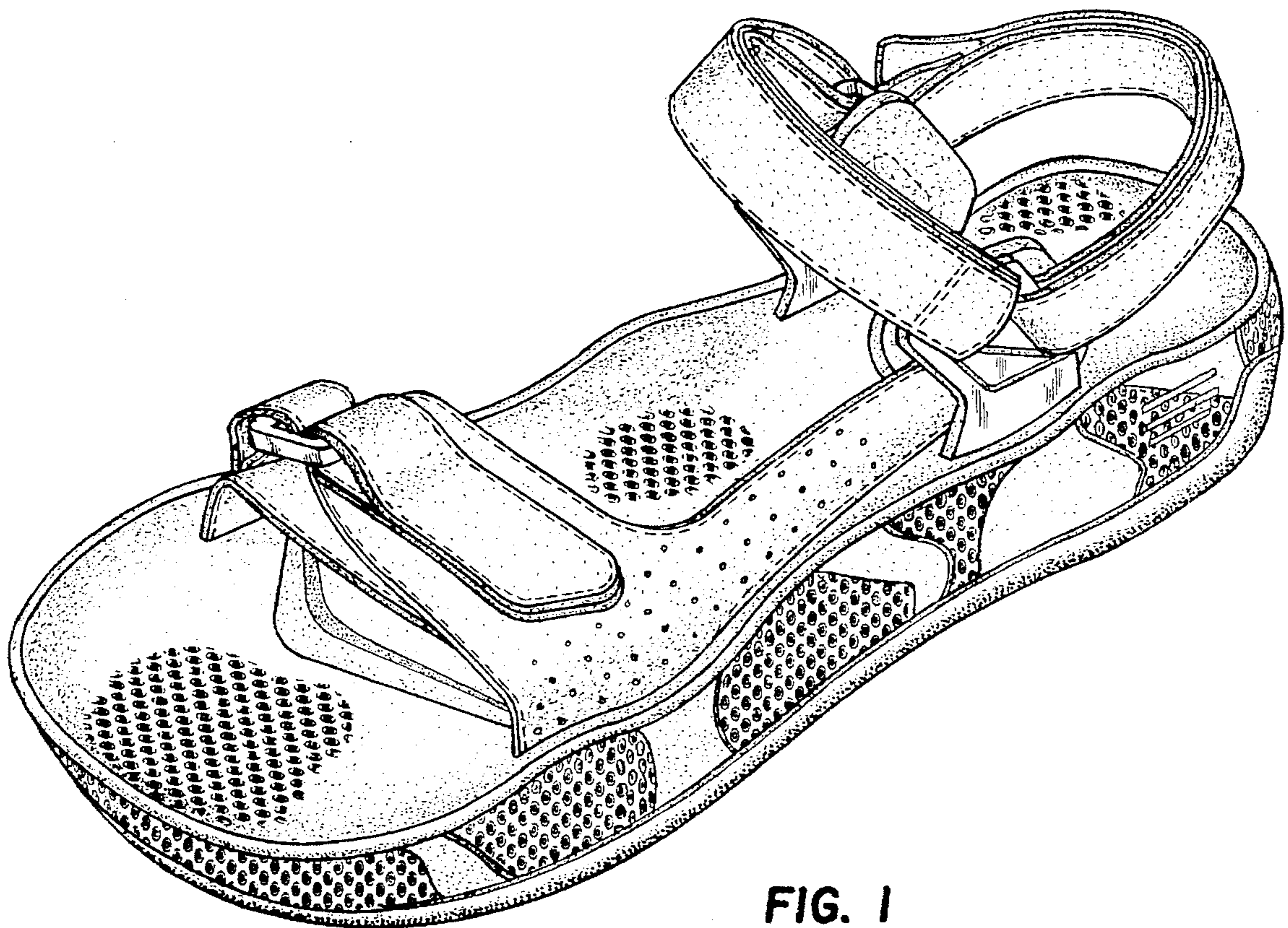

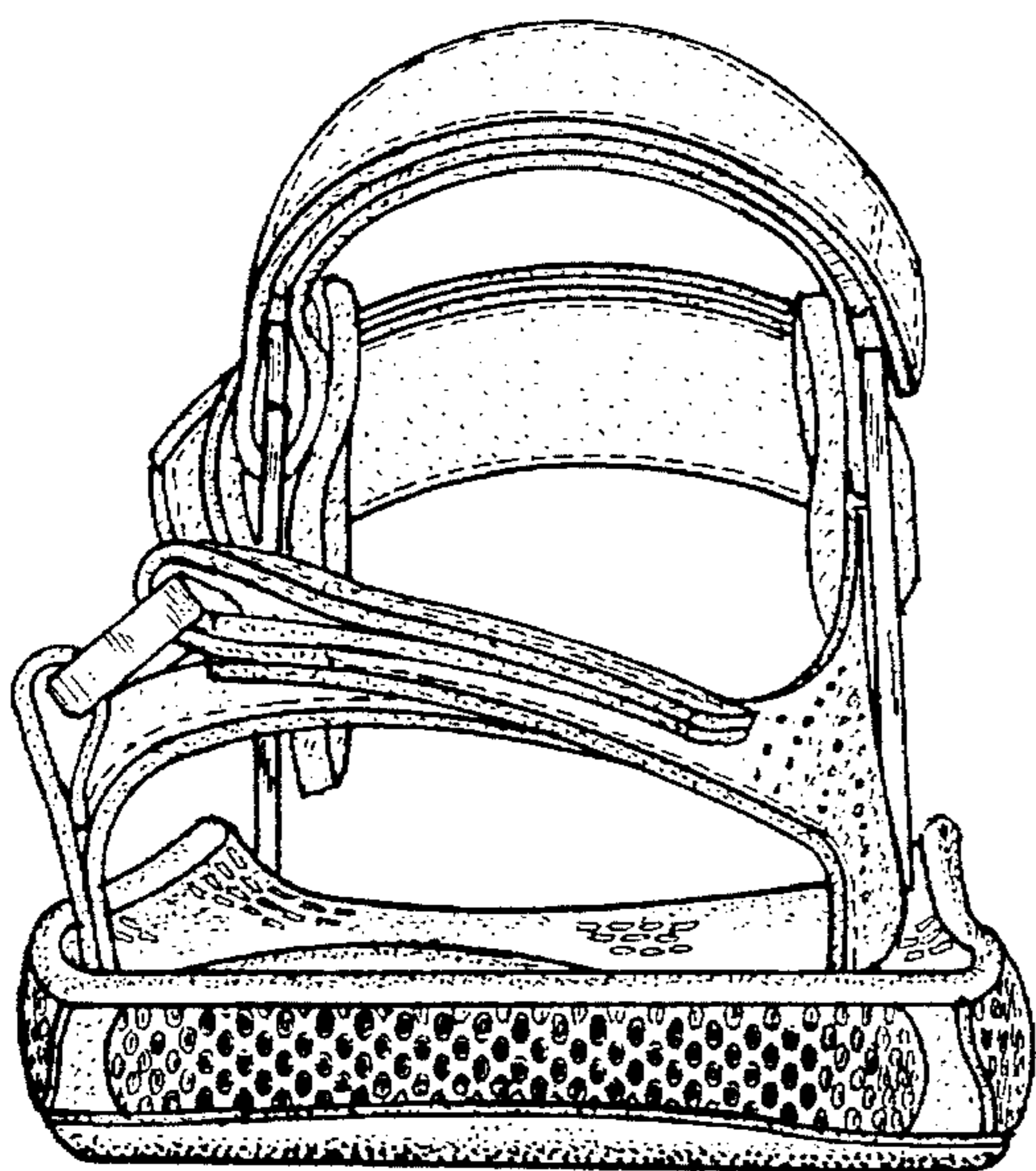

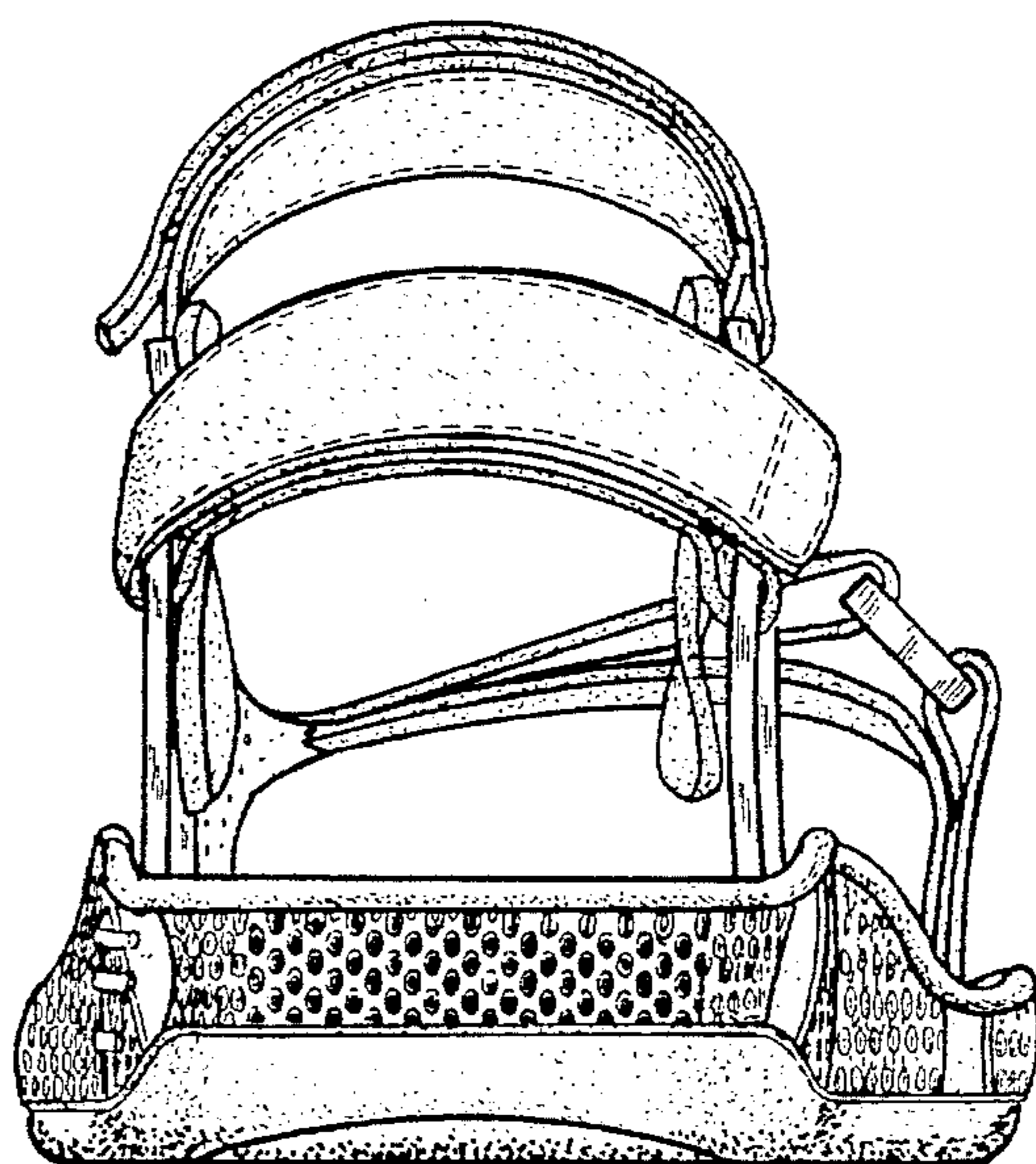

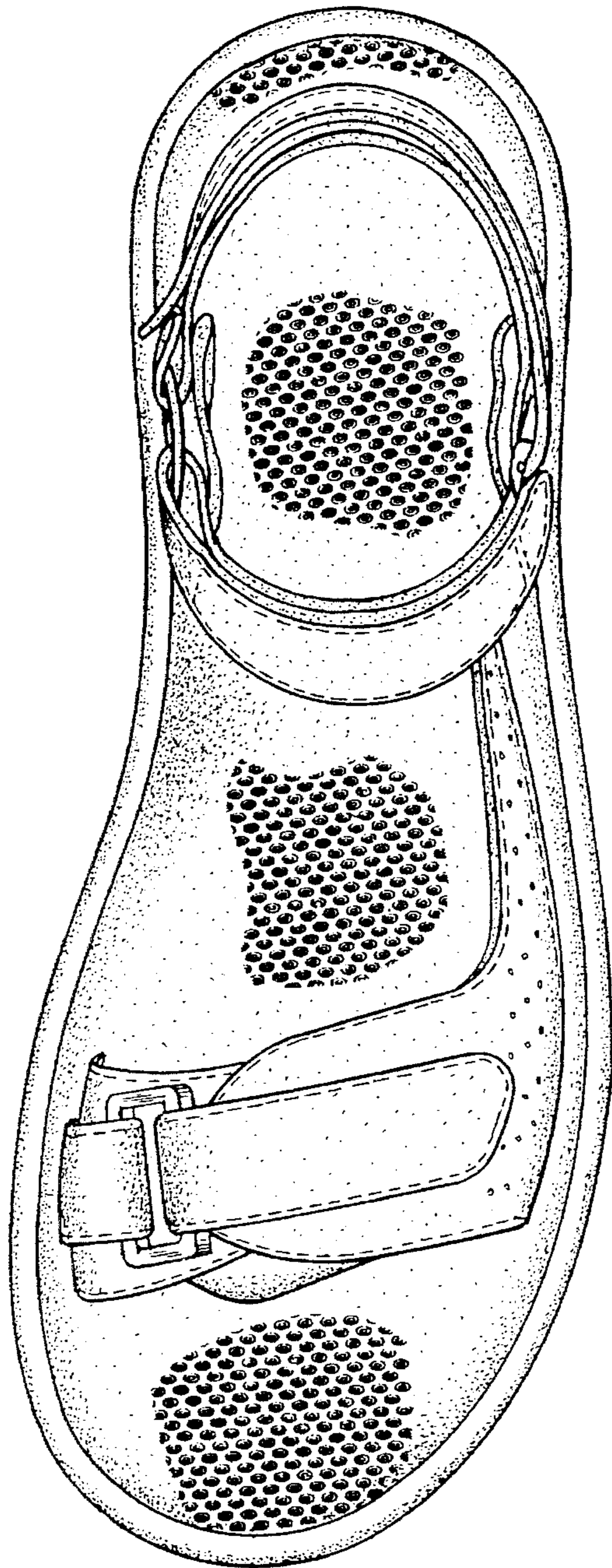

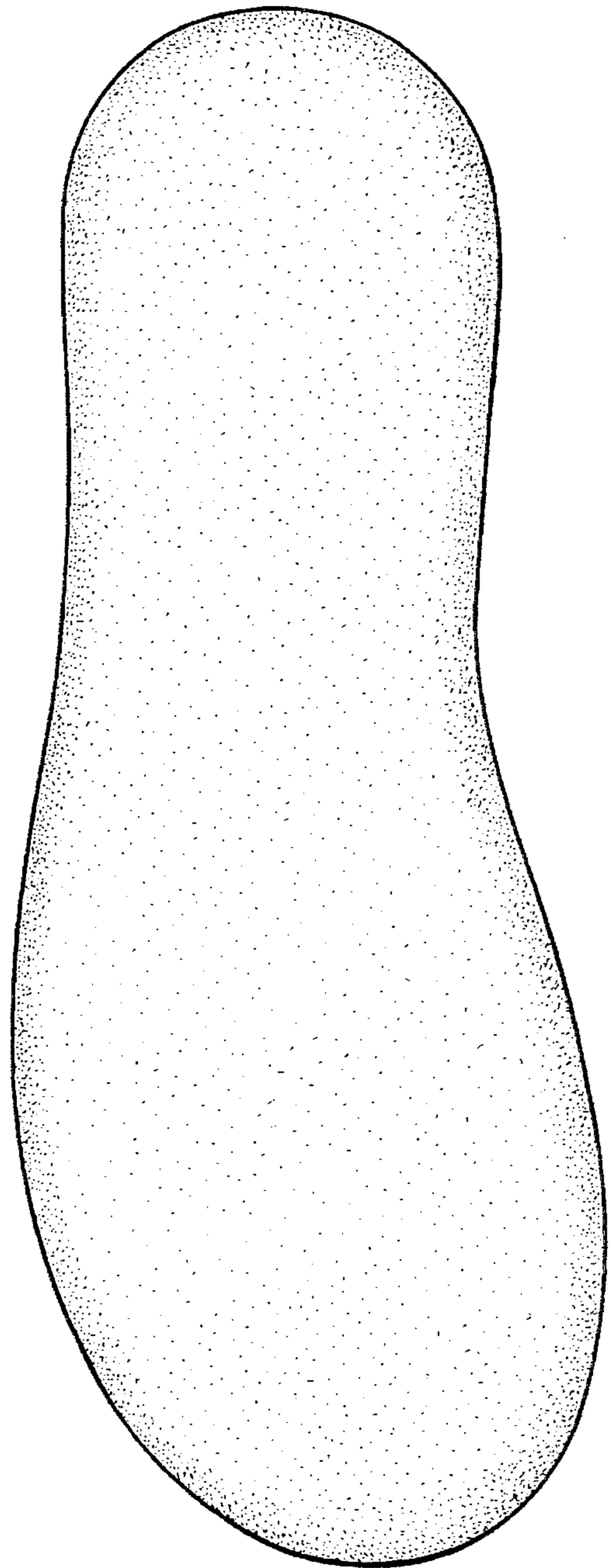

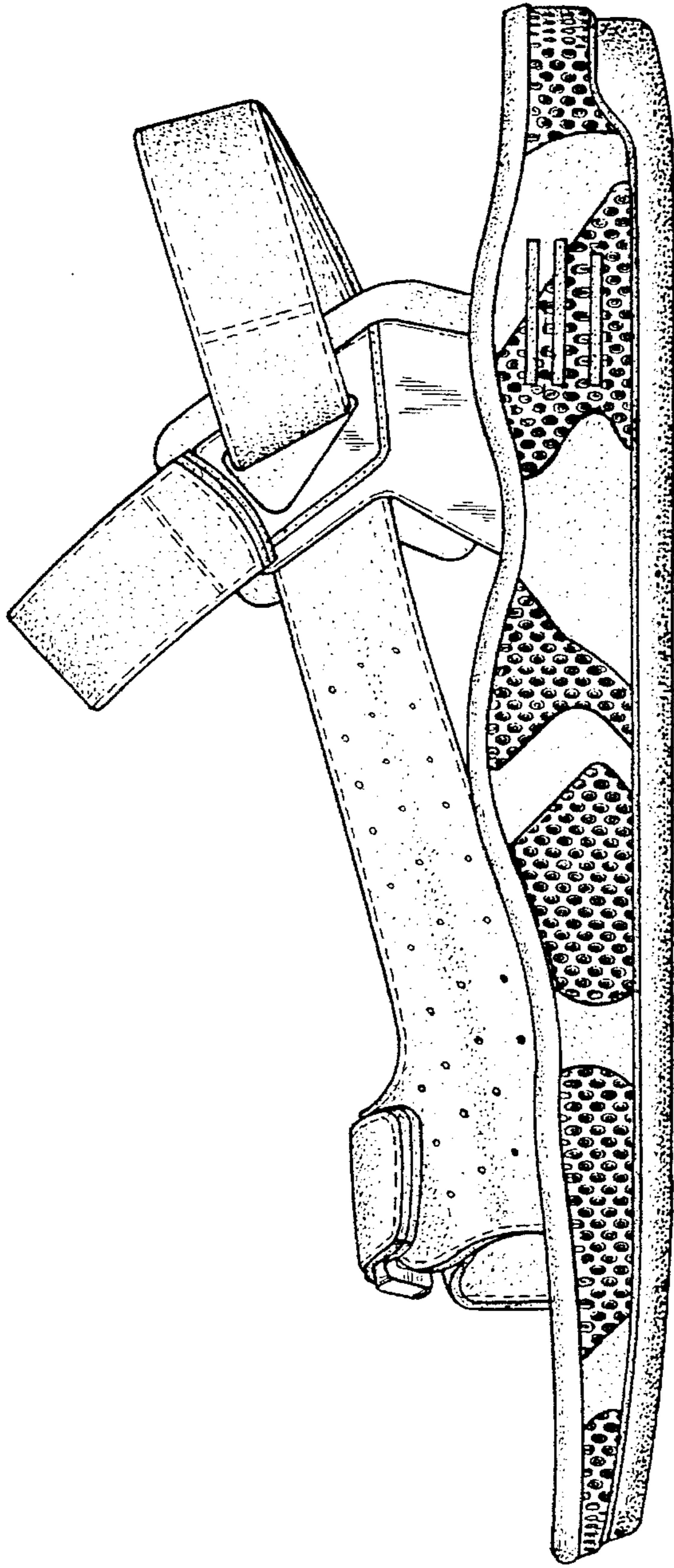

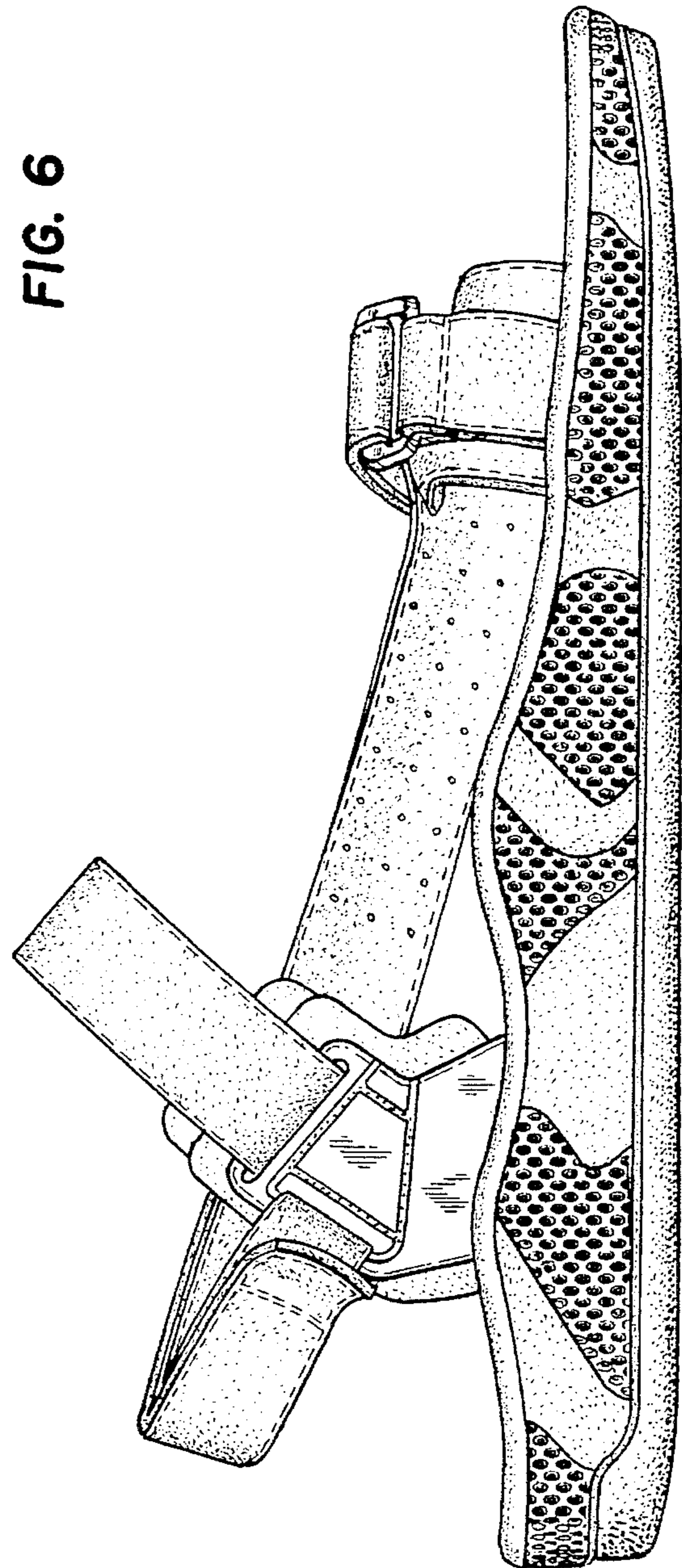
