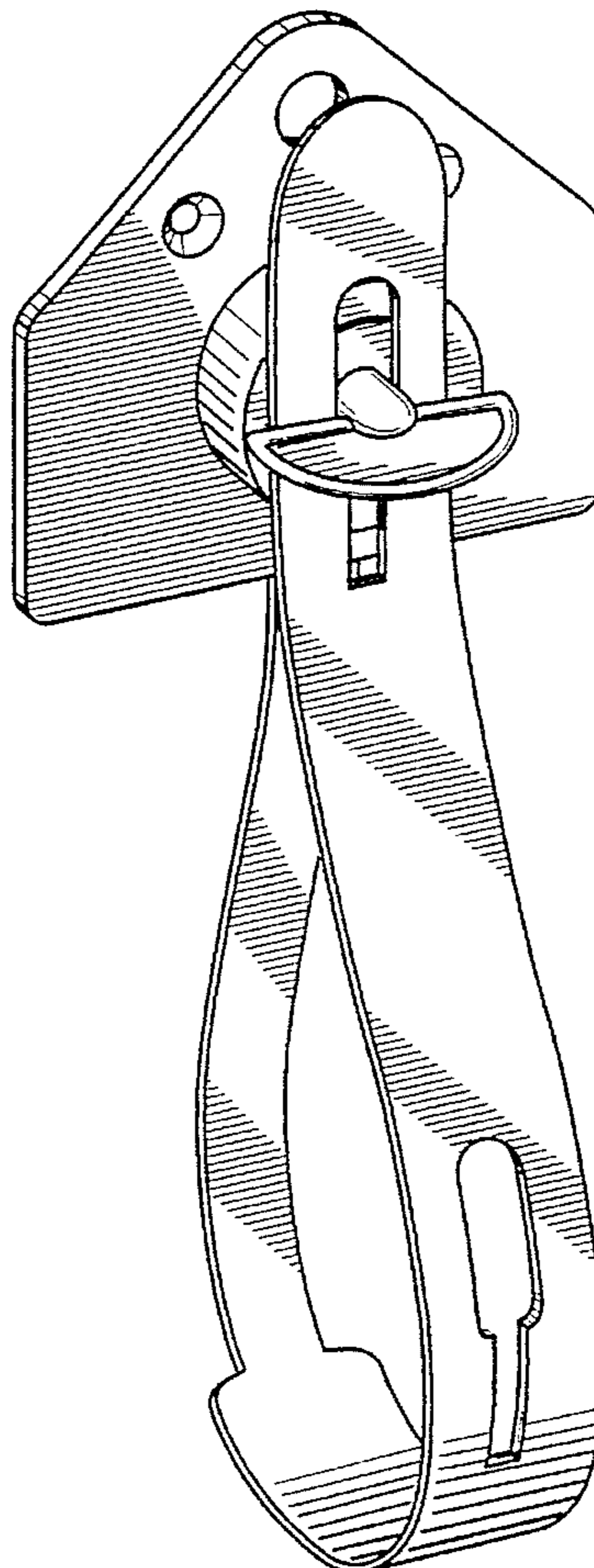

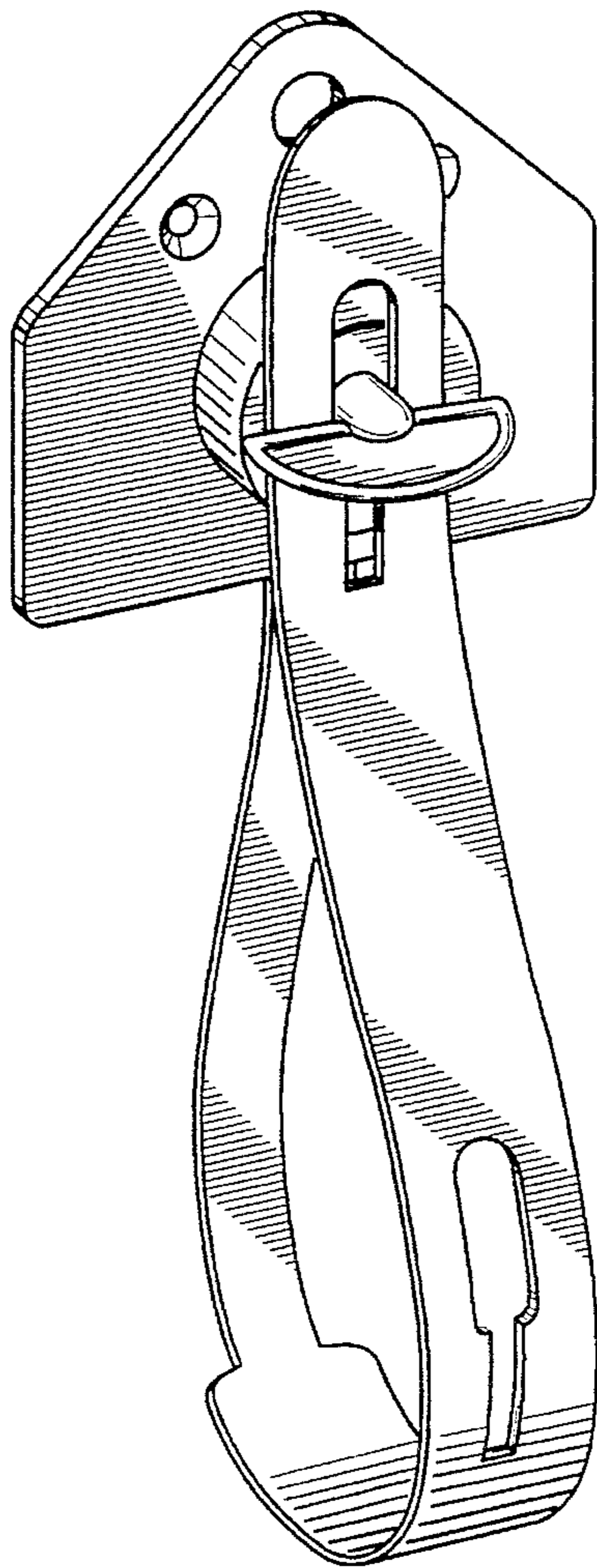

### DESCRIPTION

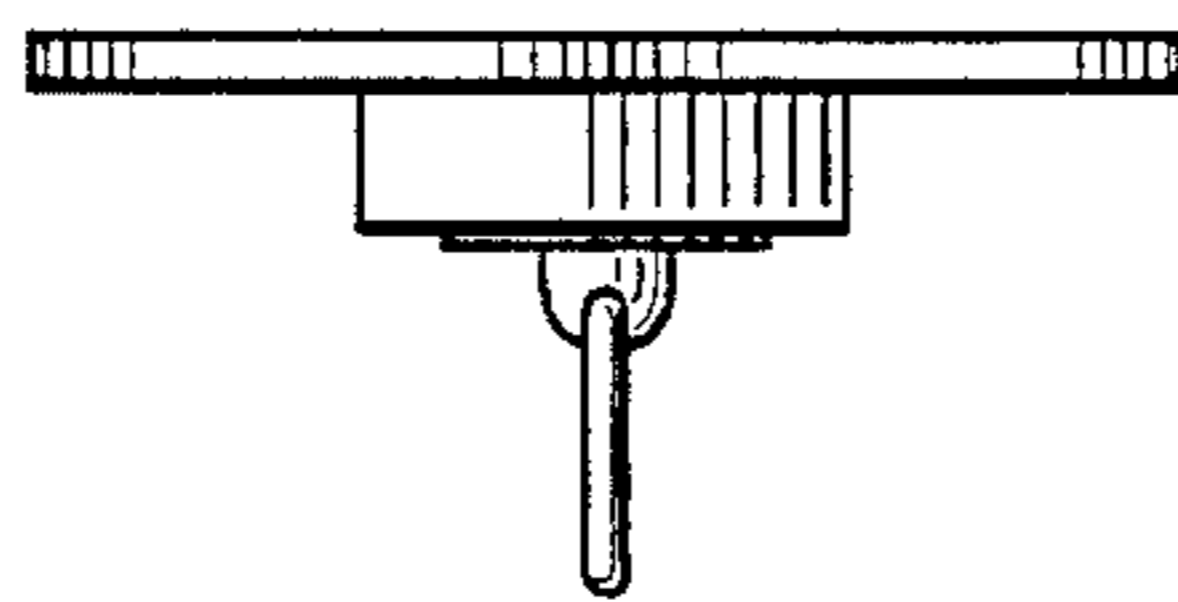
FIG. 1 is a perspective view of a strap holder showing my new design in a folded position;

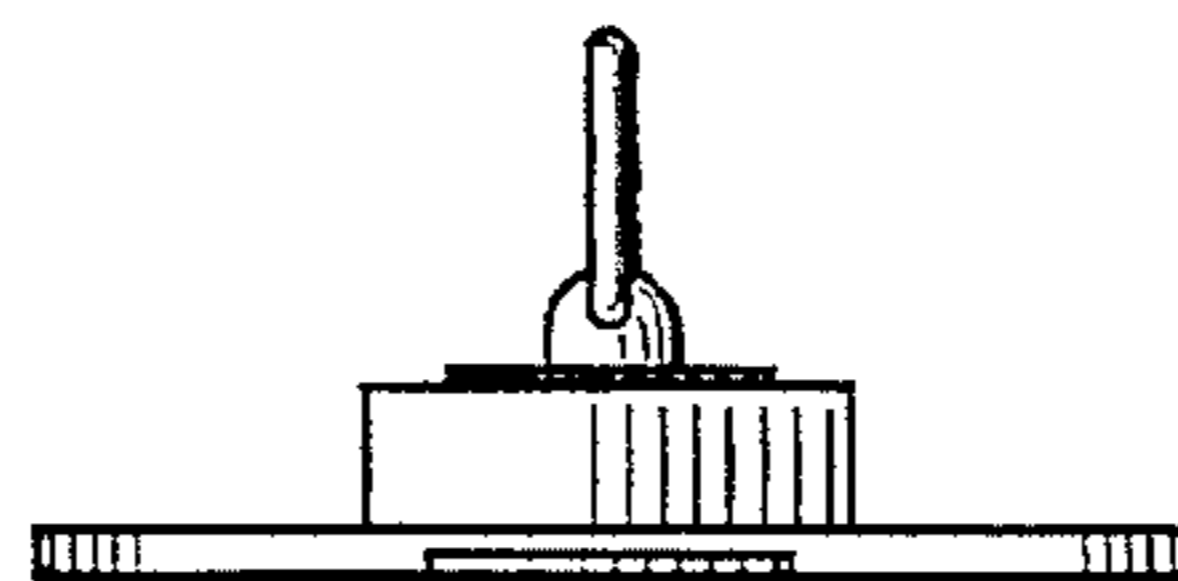




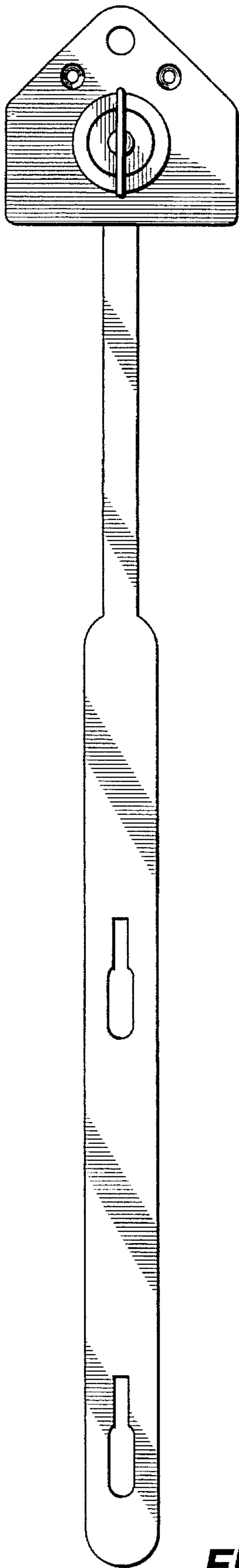

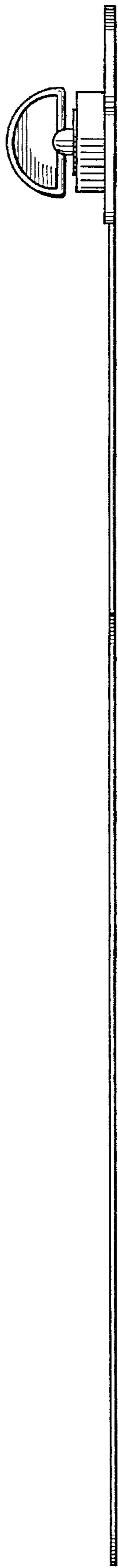

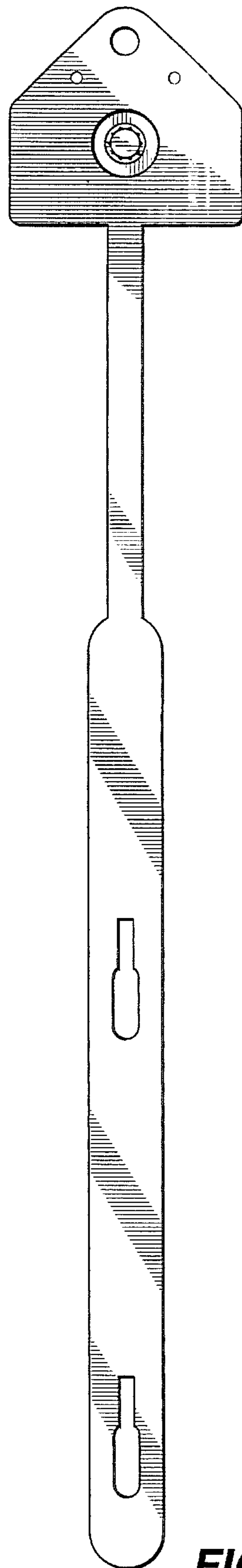
