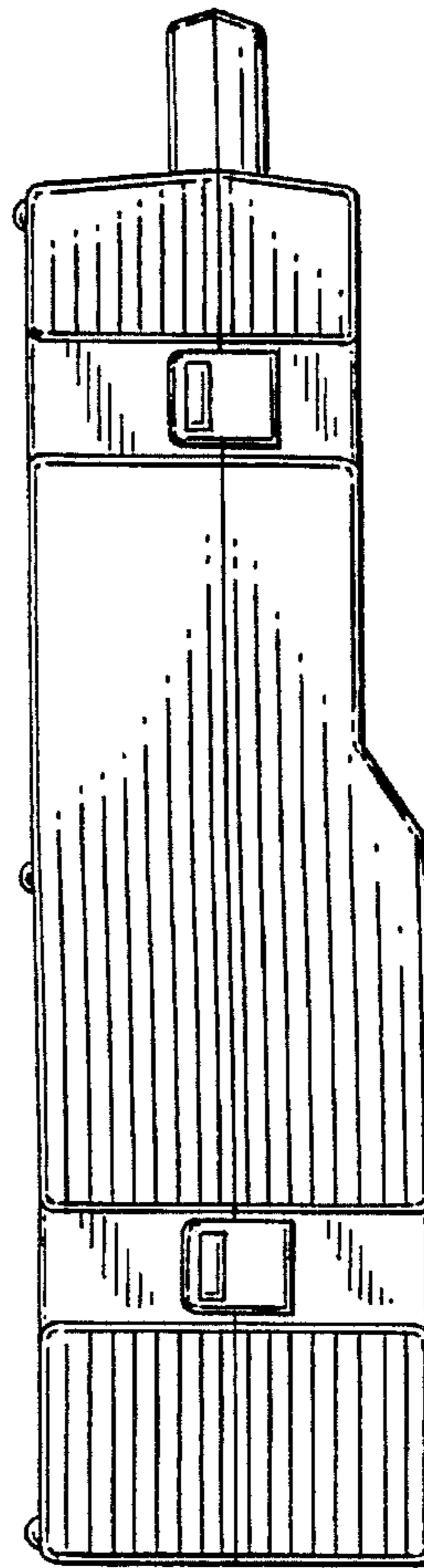
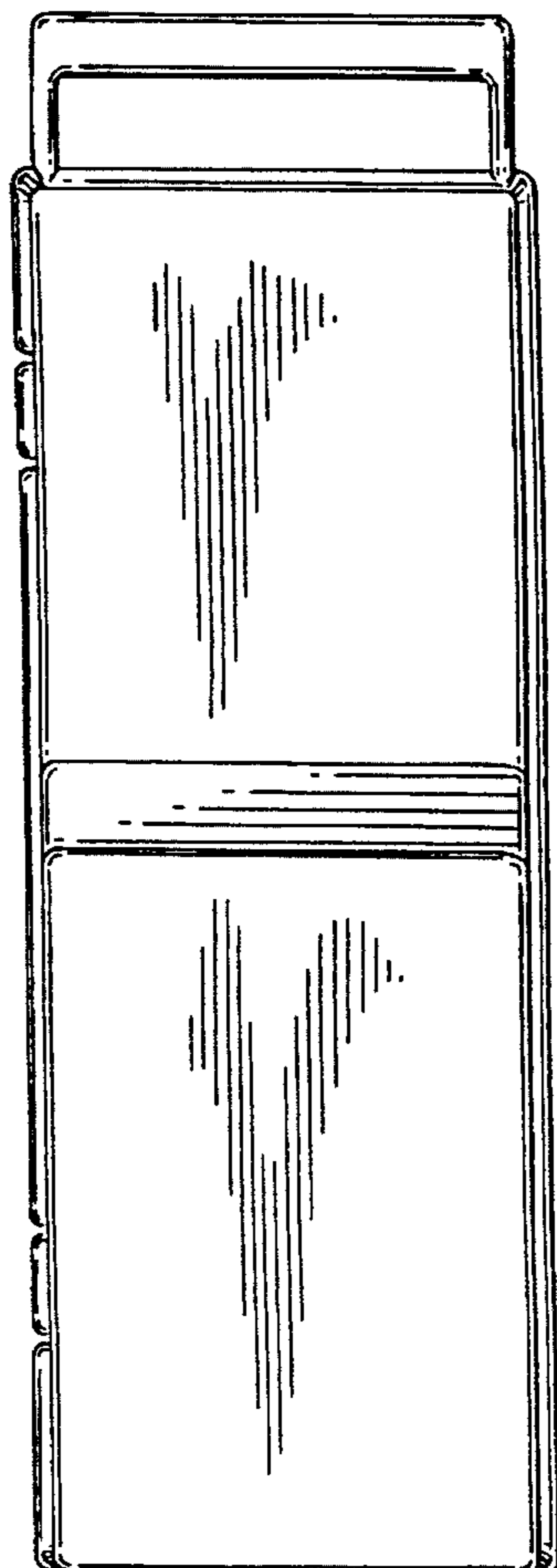
[57] **CLAIM**

DESCRIPTION

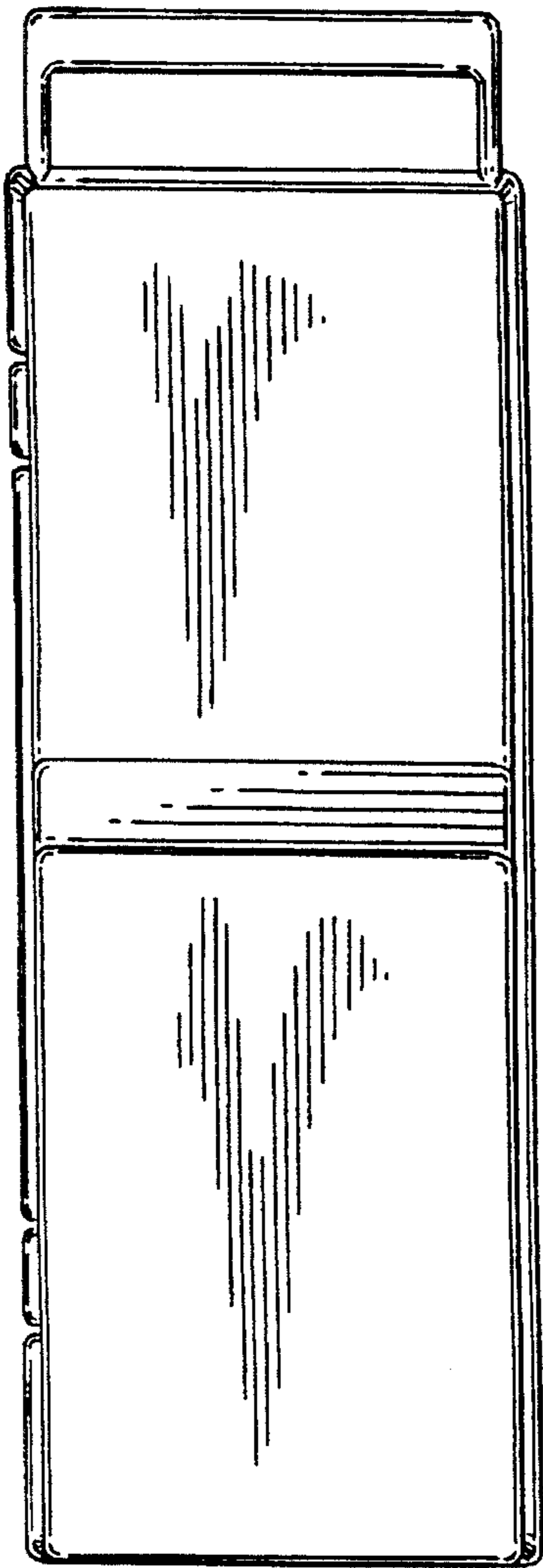

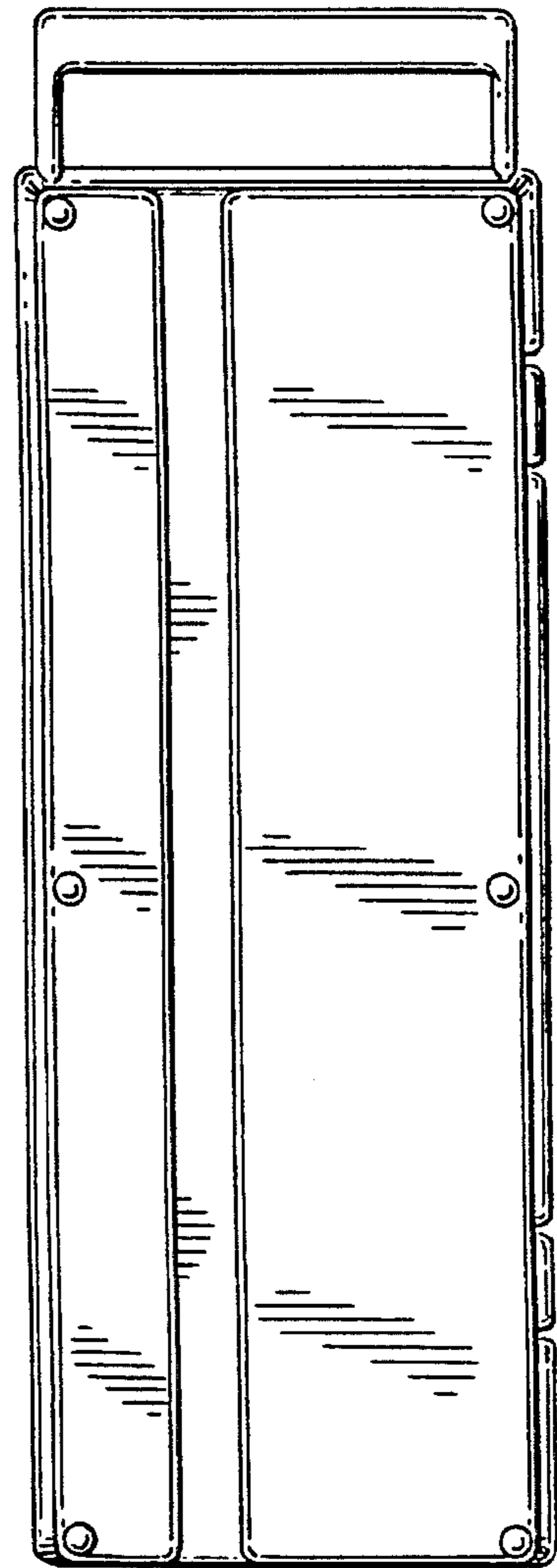

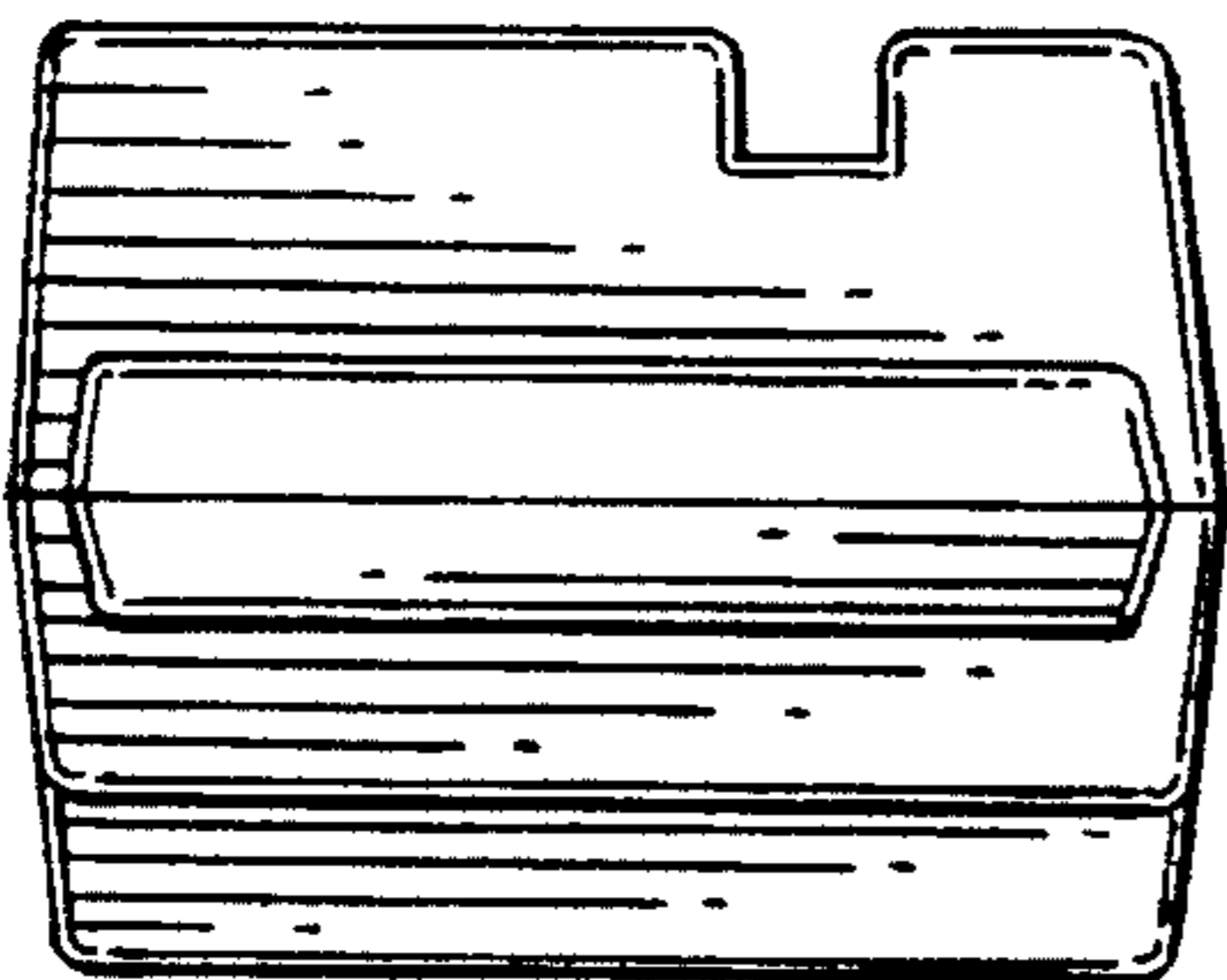

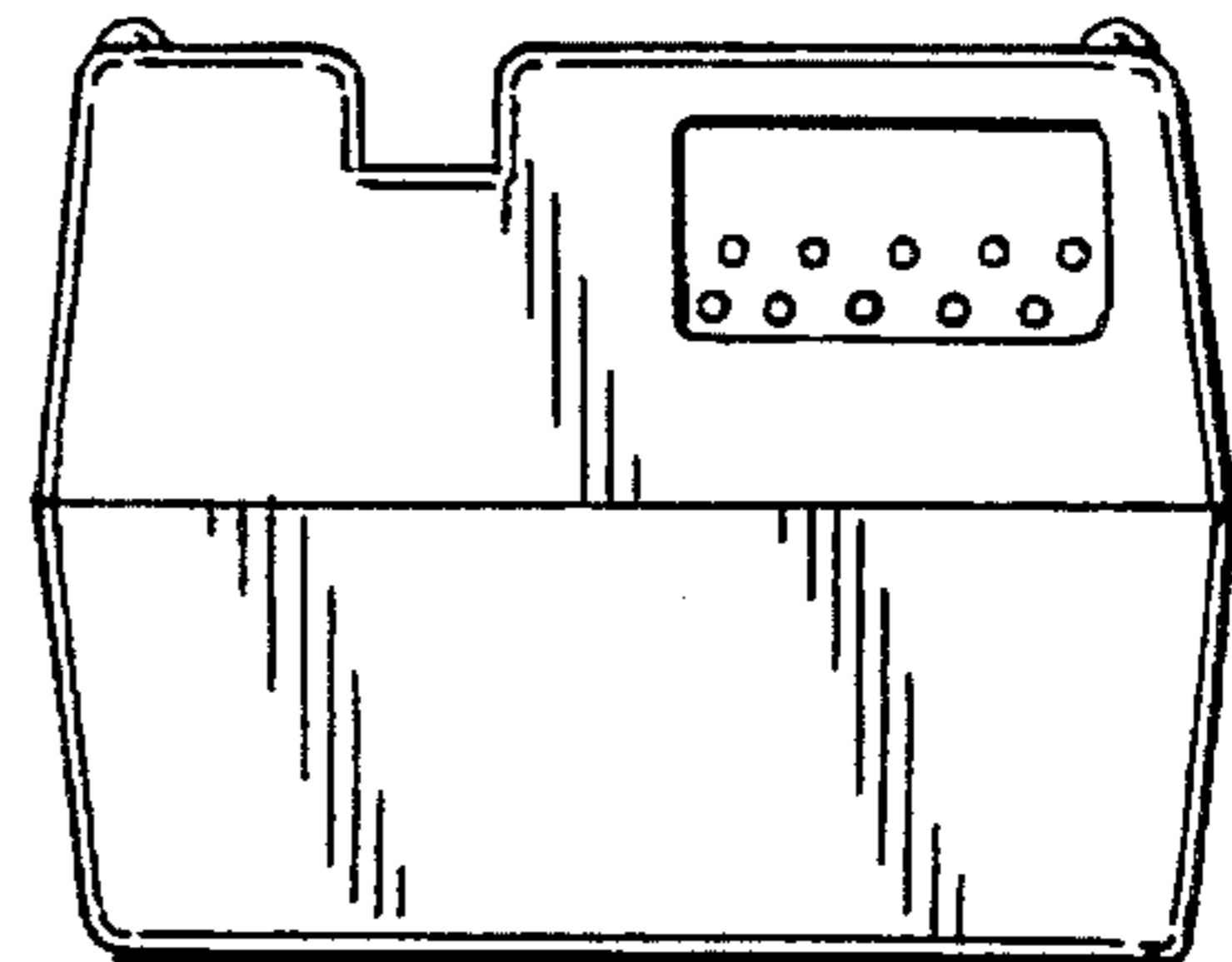

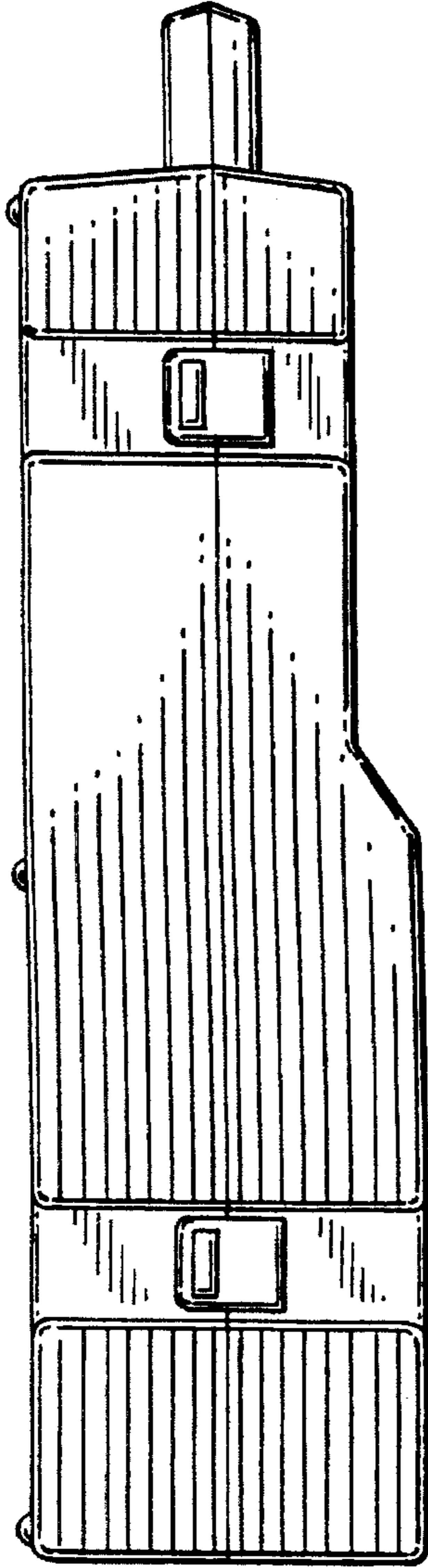

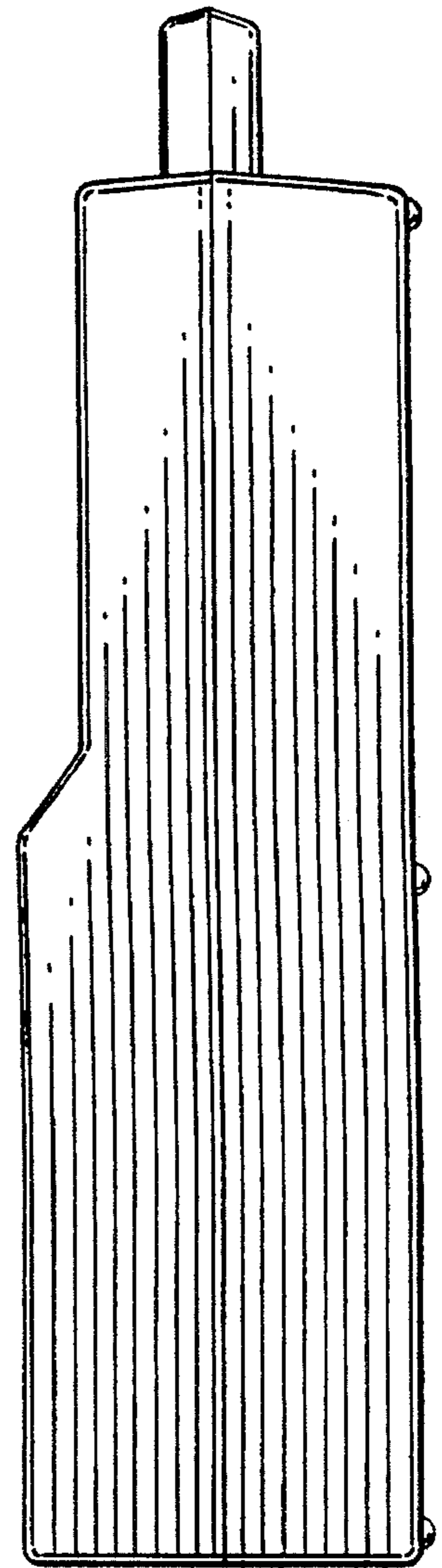
