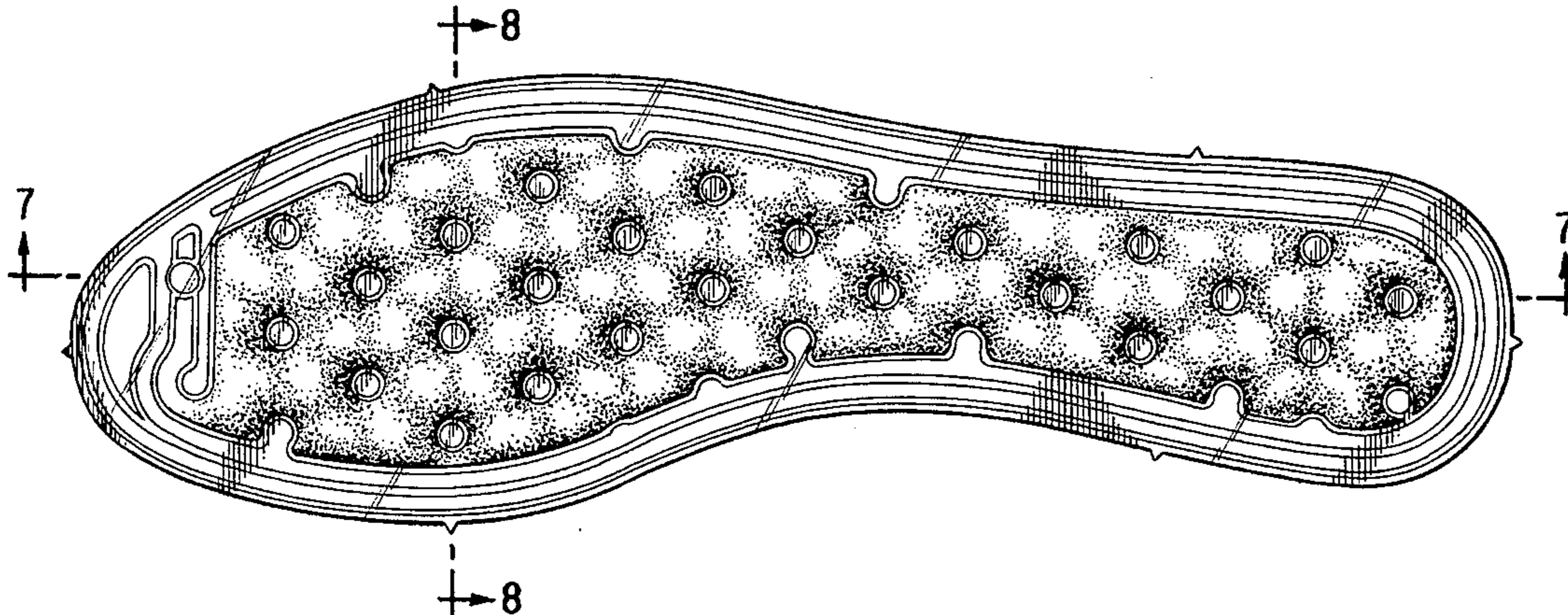
[57] **CLAIM**

The ornamental design for a bladder for a shoe sole, as shown and described.

DESCRIPTION

- FIG. 1 is a top plan view of a bladder for a shoe sole showing our new design;
- FIG. 2 is a front elevational view thereof;
- FIG. 3 is a rear elevational view thereof;
- FIG. 4 is a left side elevational view thereof;
- FIG. 5 is a right side elevational view thereof;
- FIG. 6 is a bottom perspective view thereof;
- FIG. 7 is a cross sectional view taken along the line 7—7 of FIG. 1; and,
- FIG. 8 is a cross sectional view taken along the line 8—8 of FIG. 1.

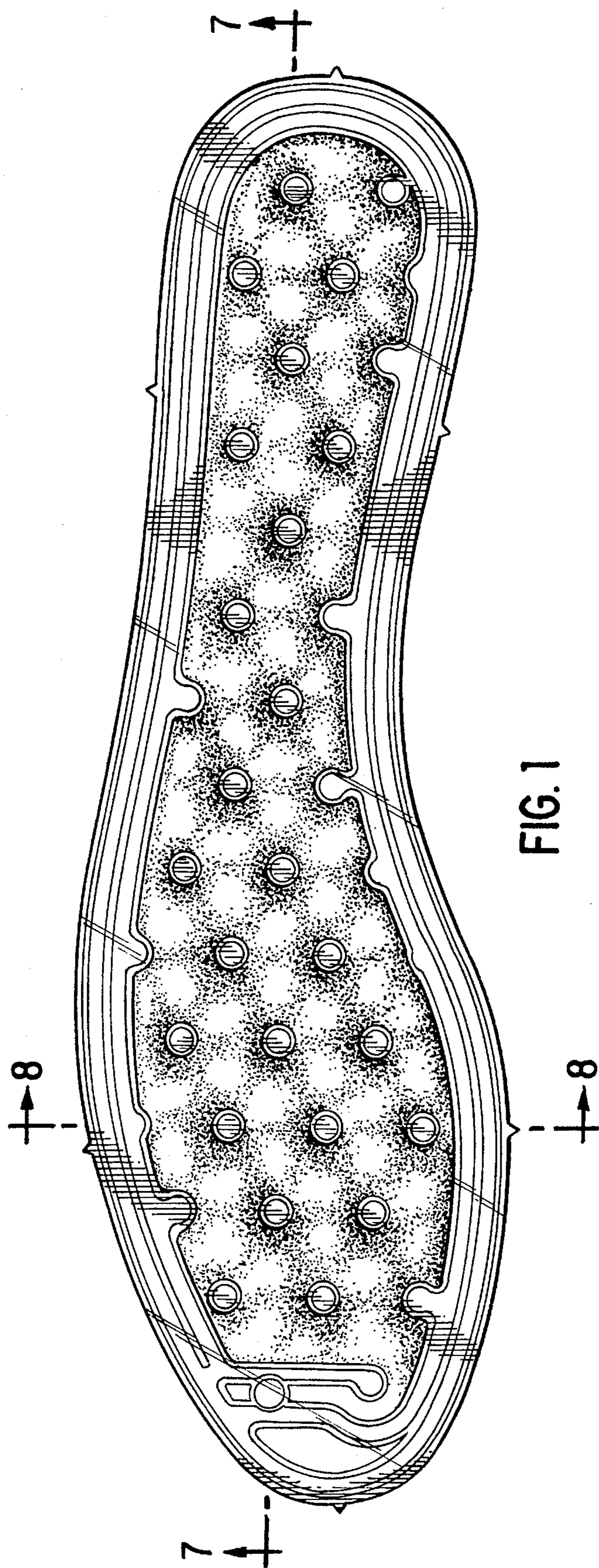

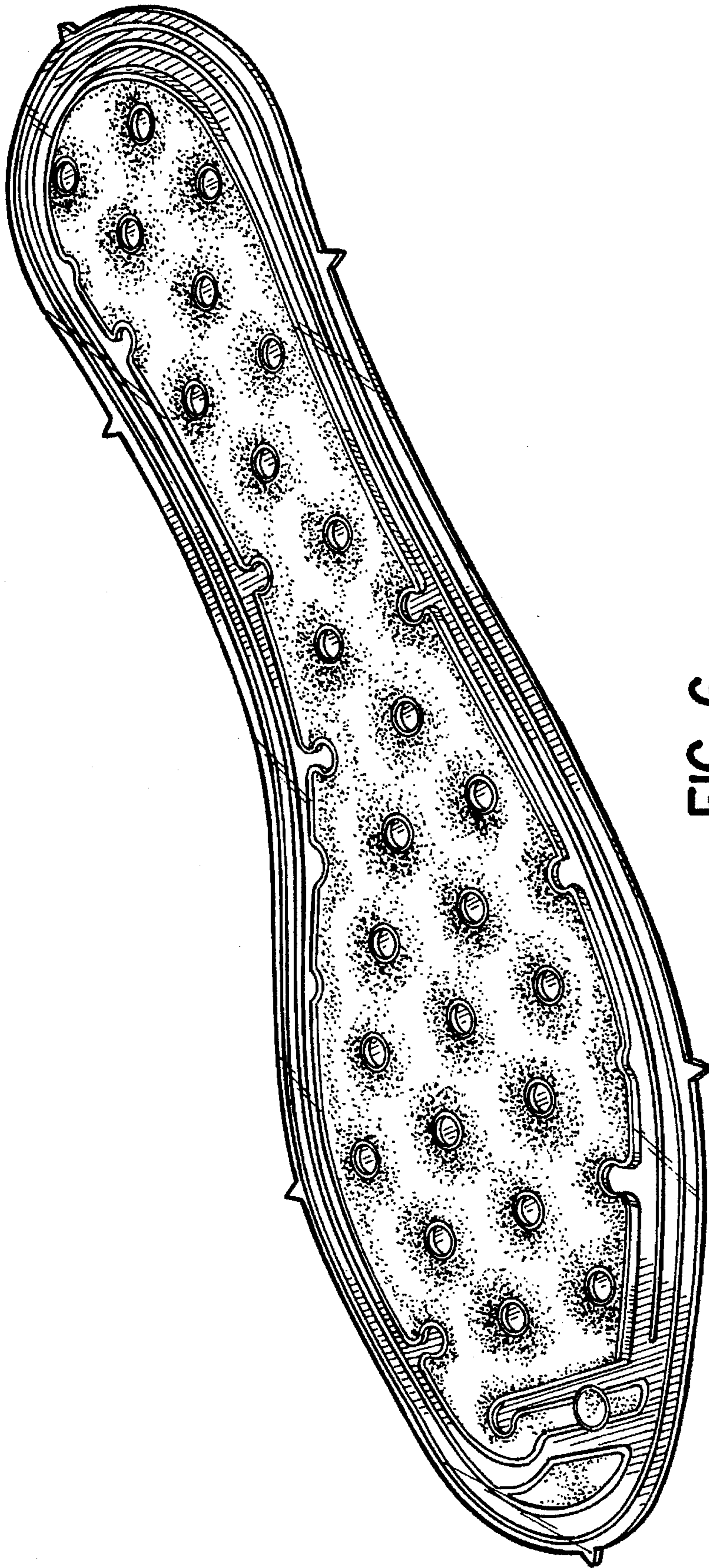
