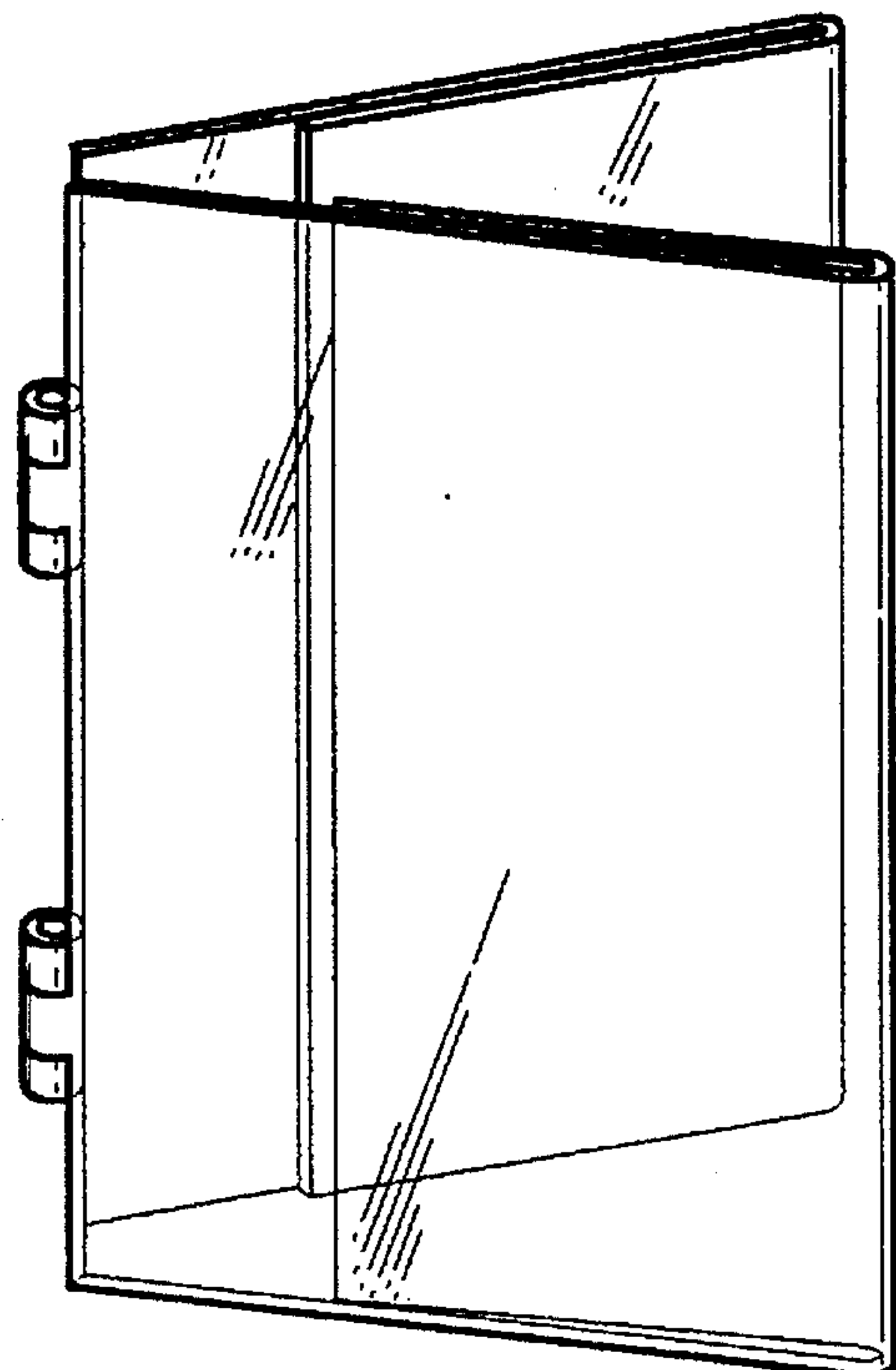
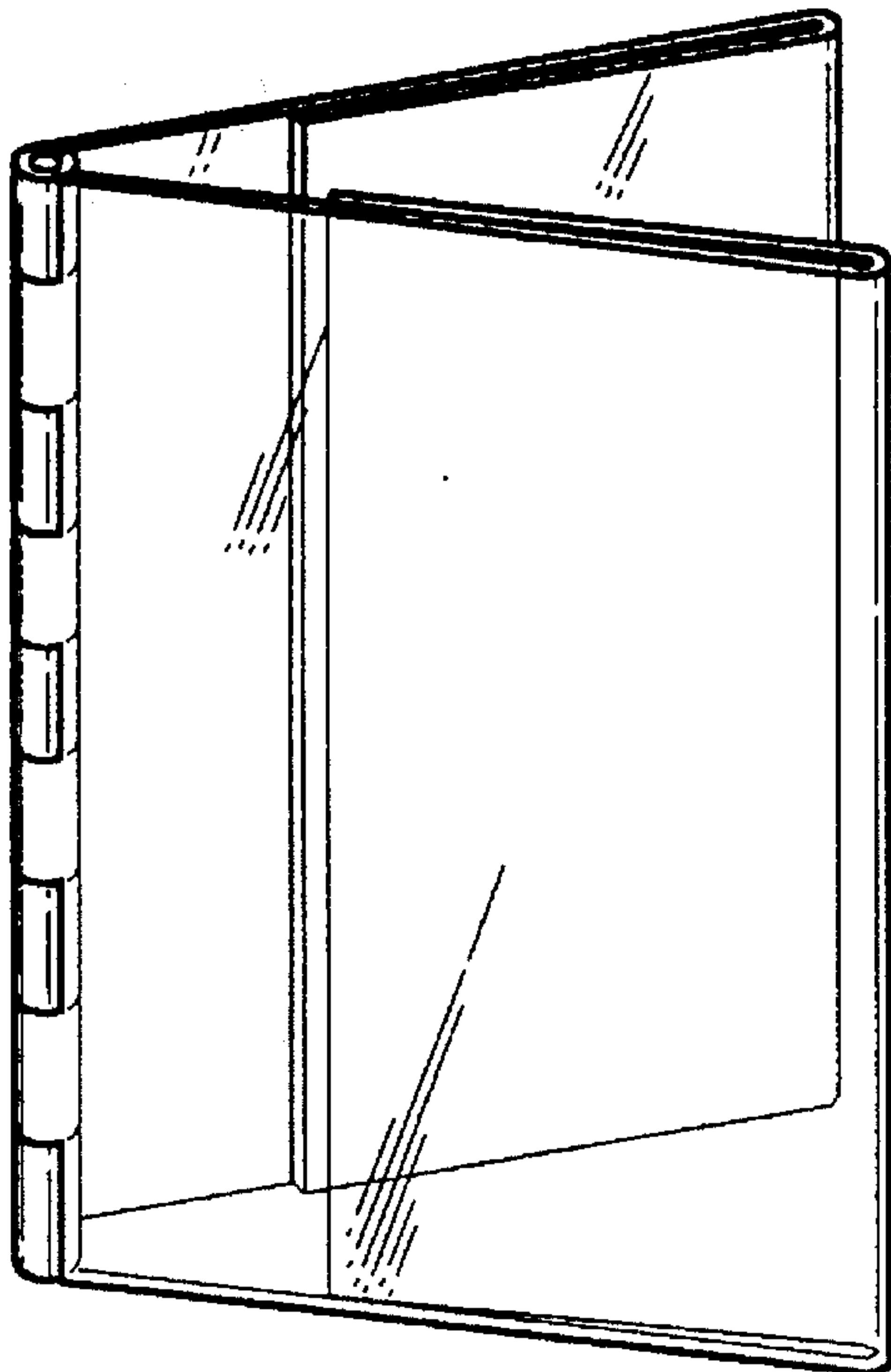
[57] CLAIM

DESCRIPTION

FIG. 1 is a side perspective view of a first embodiment of a greeting card support device in a partially open position showing my new design;
 FIG. 2 is a top and bottom plan view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a side view thereof;
 FIG. 5 is an open view of the inside portion thereof;
 FIG. 6 is a side perspective view of another embodiment of a greeting card support device in a partially open position showing my new design;

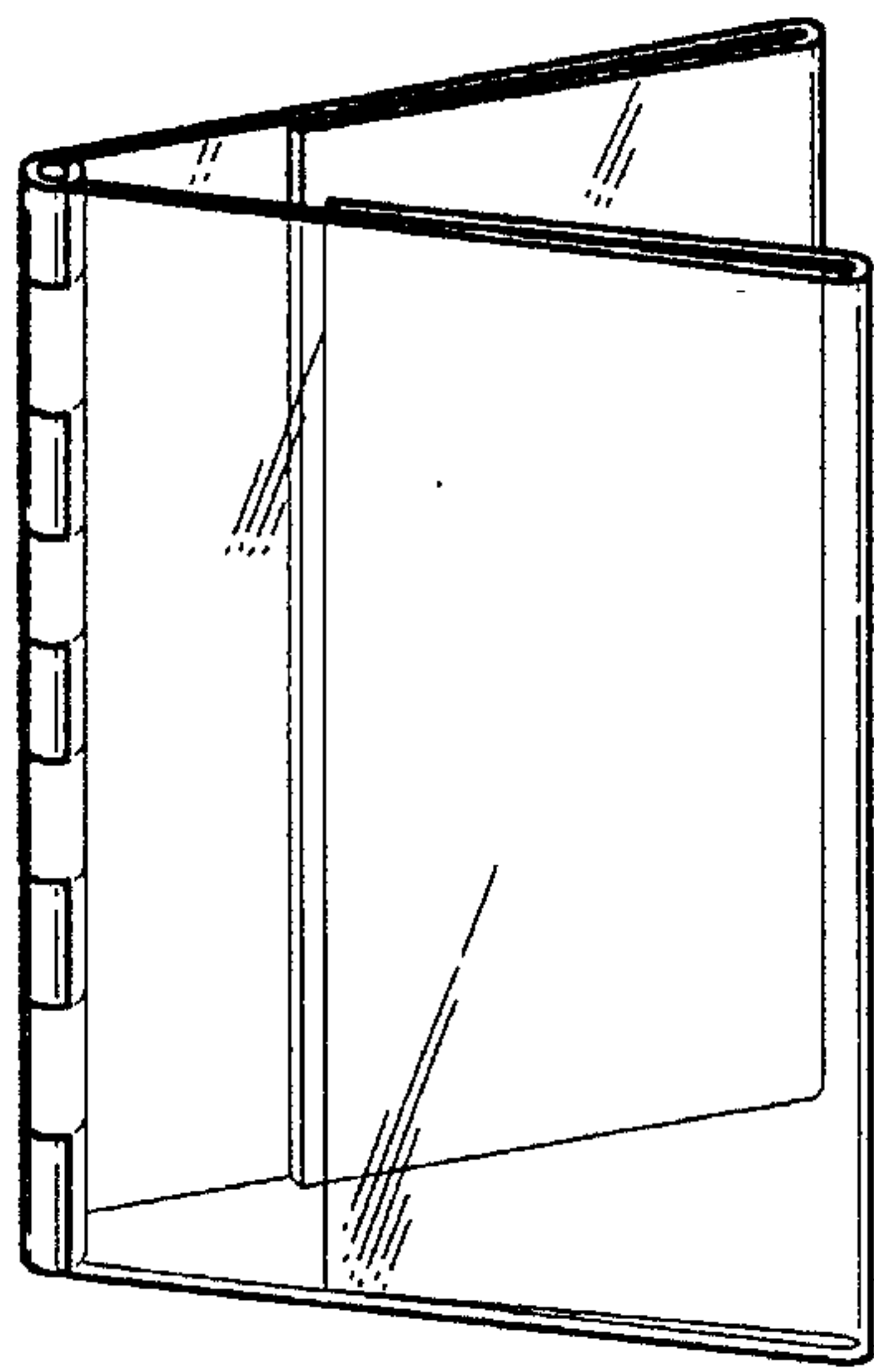

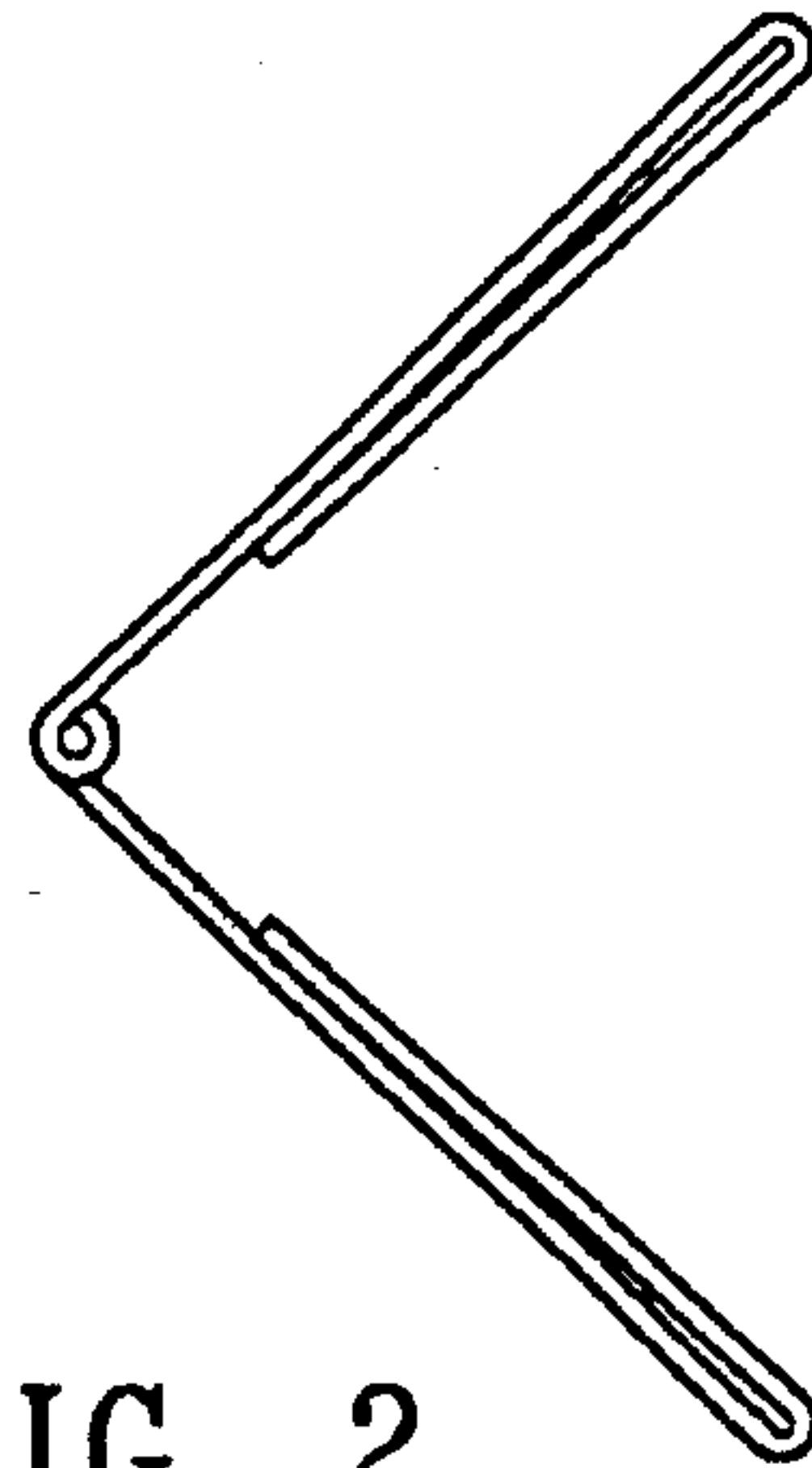

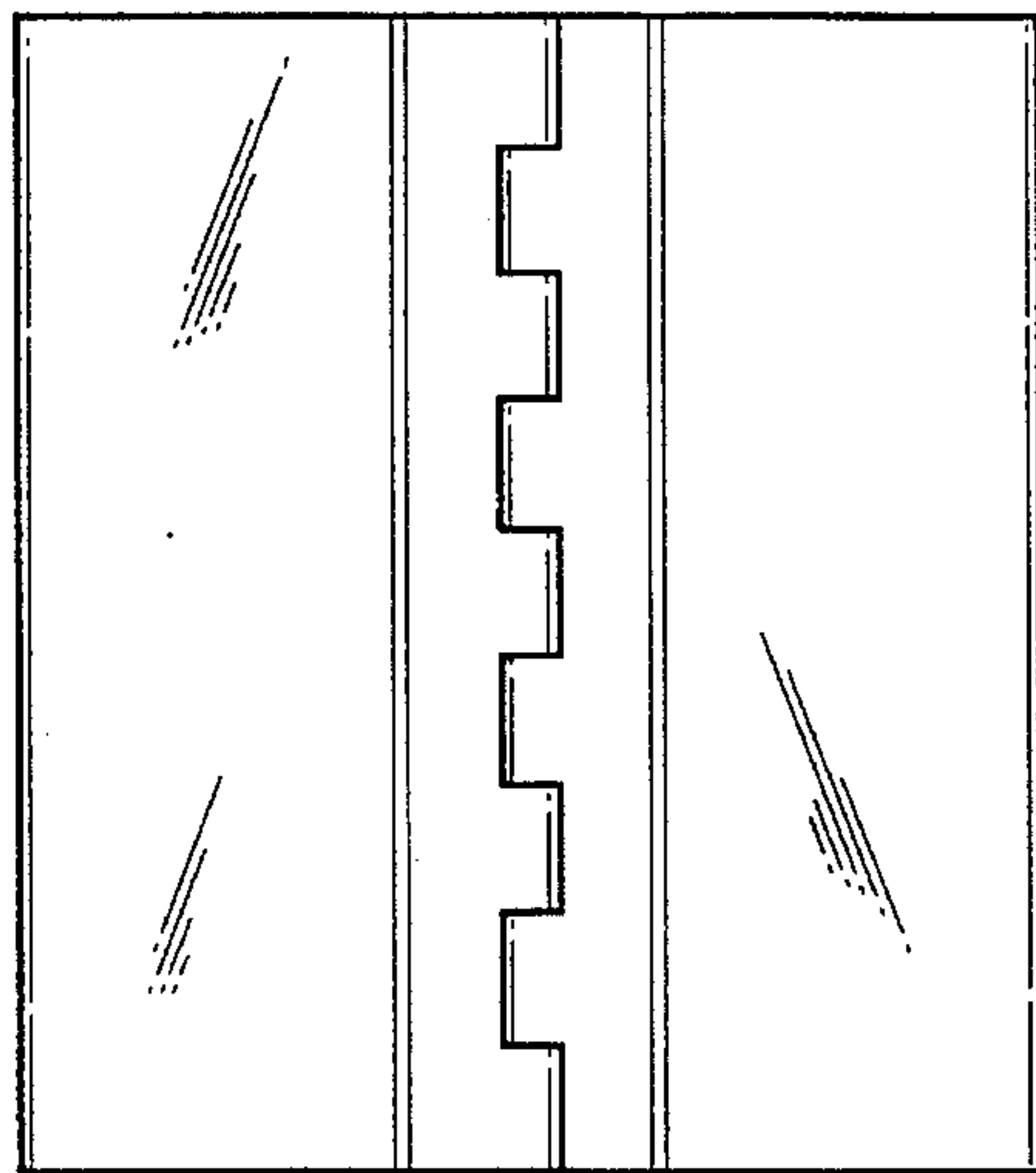

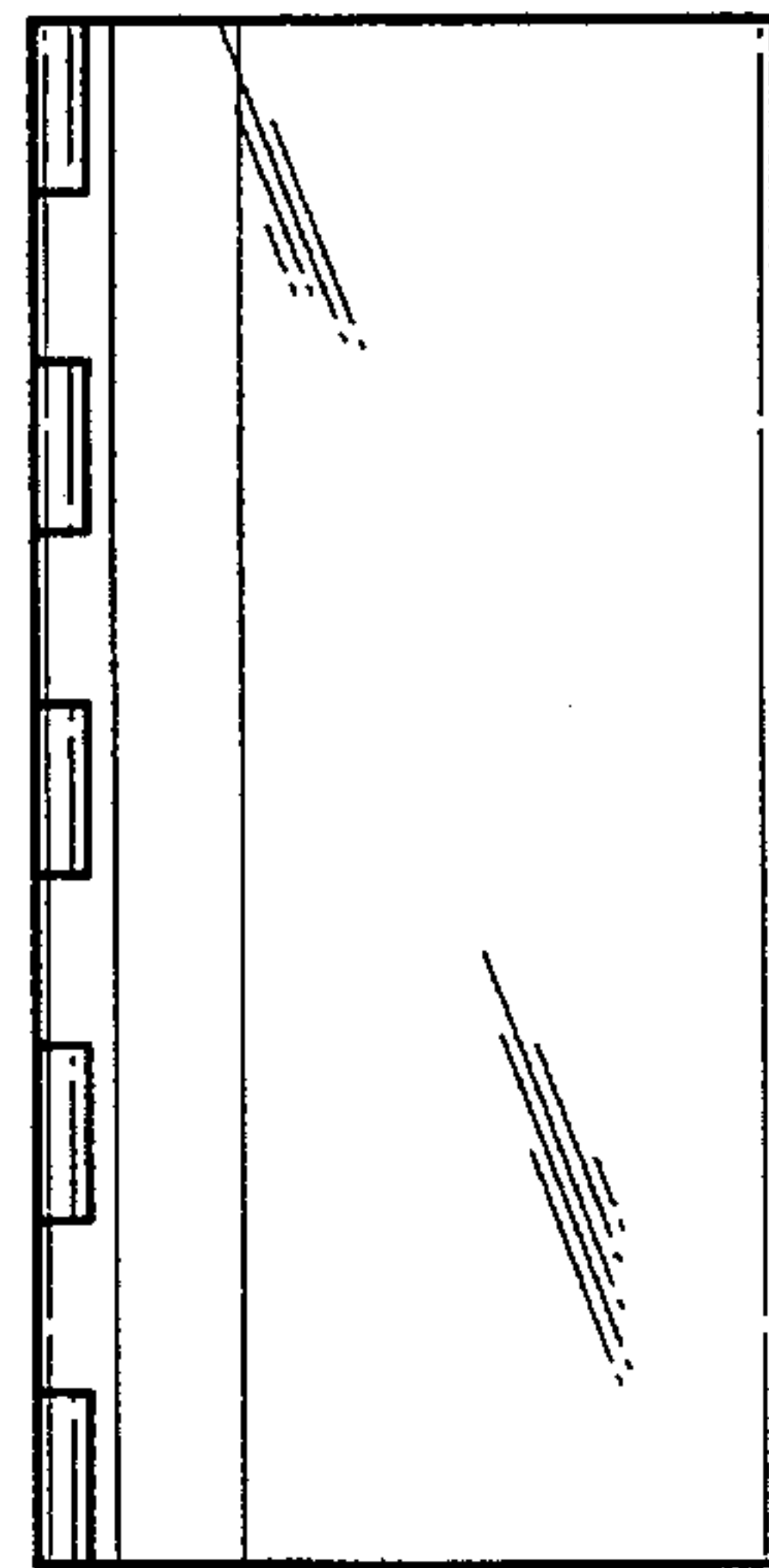

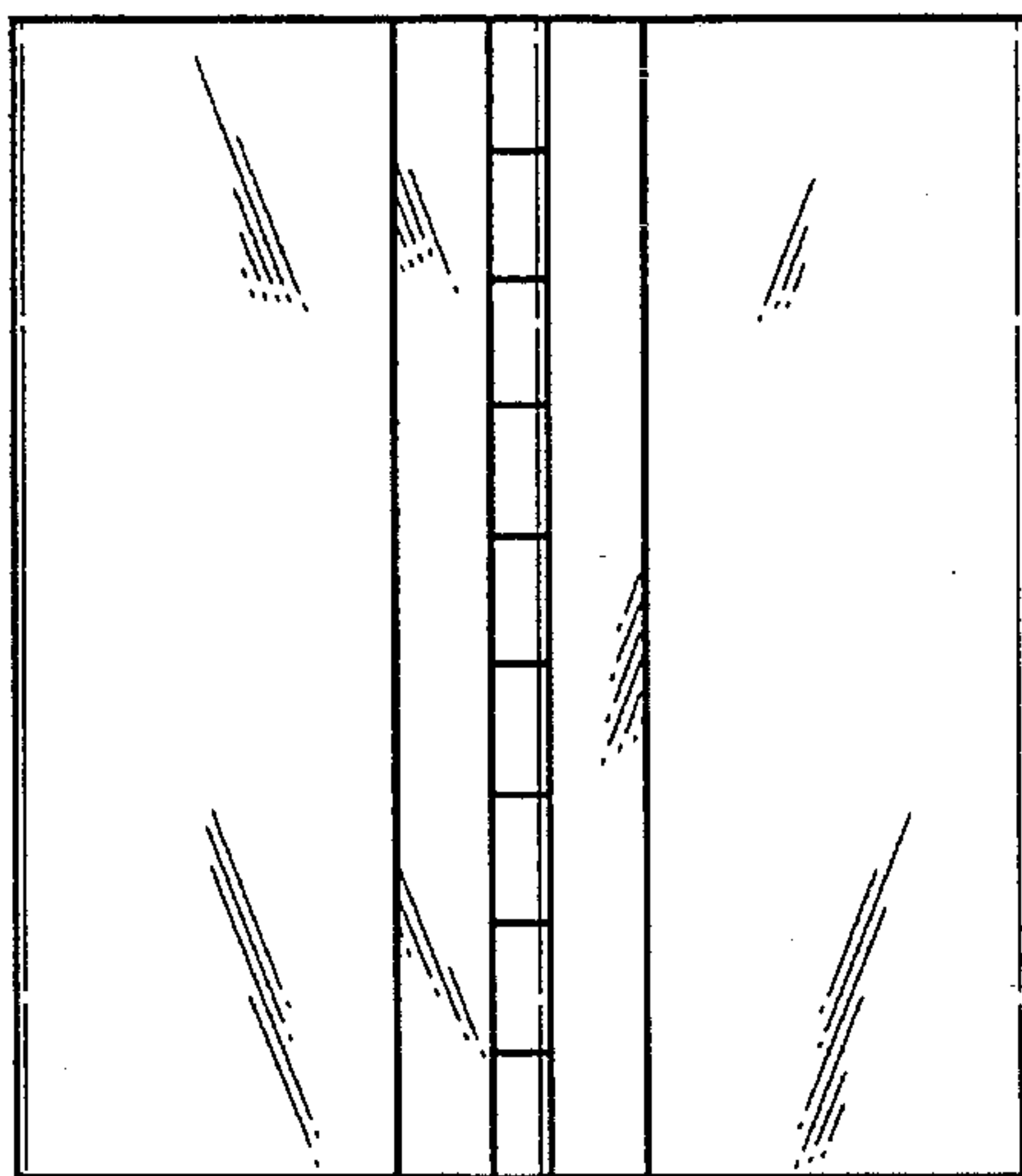

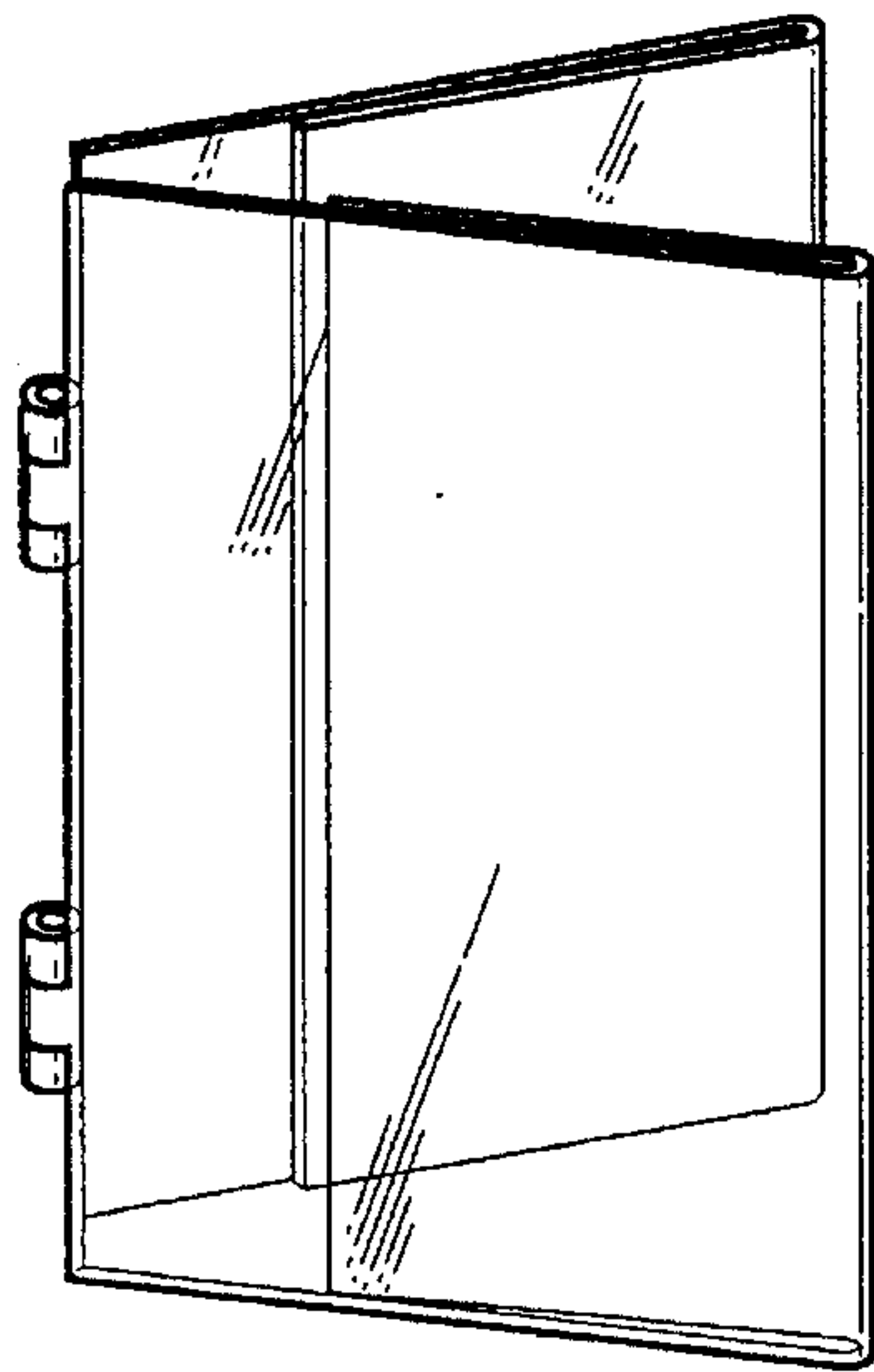

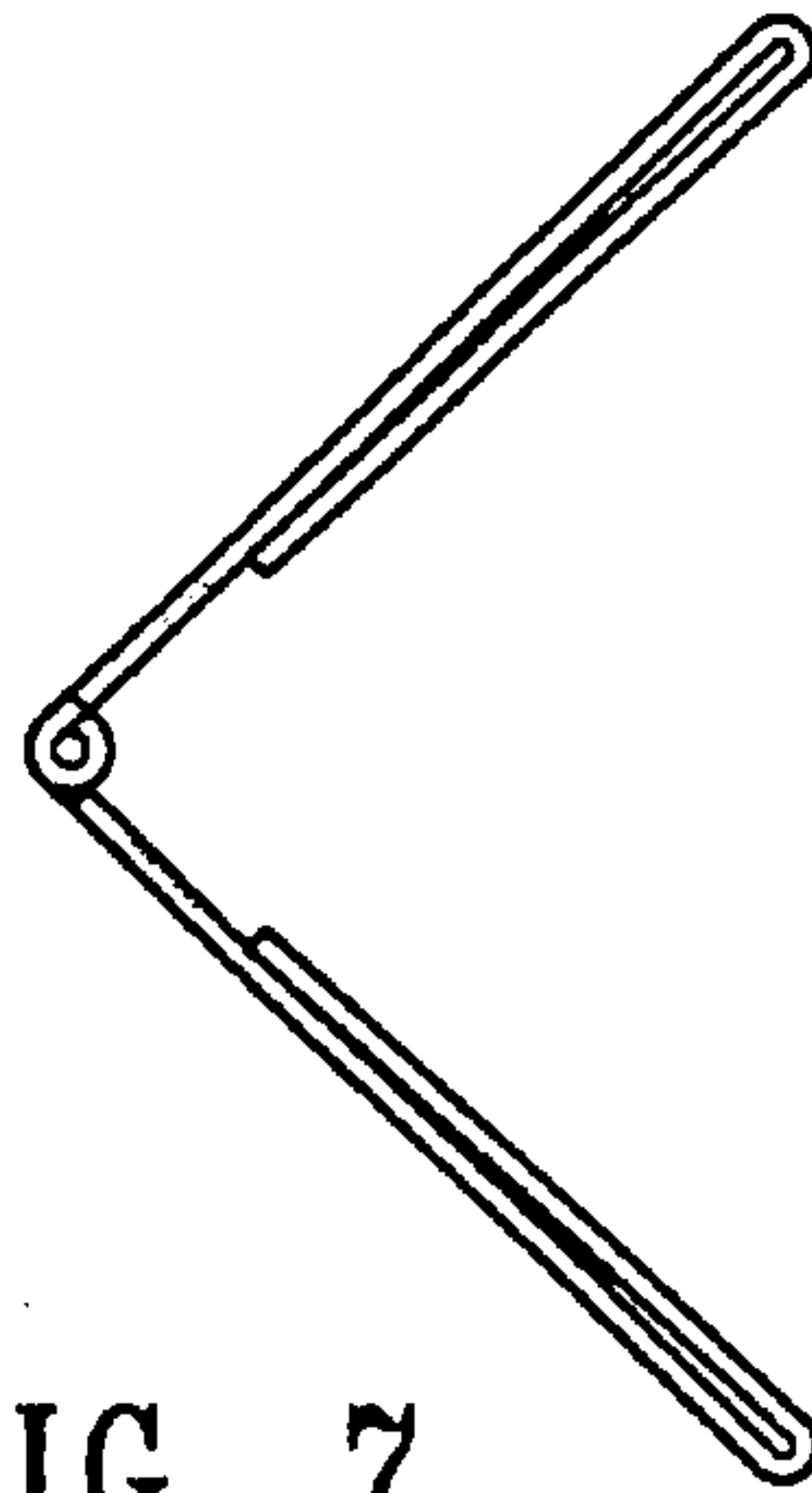

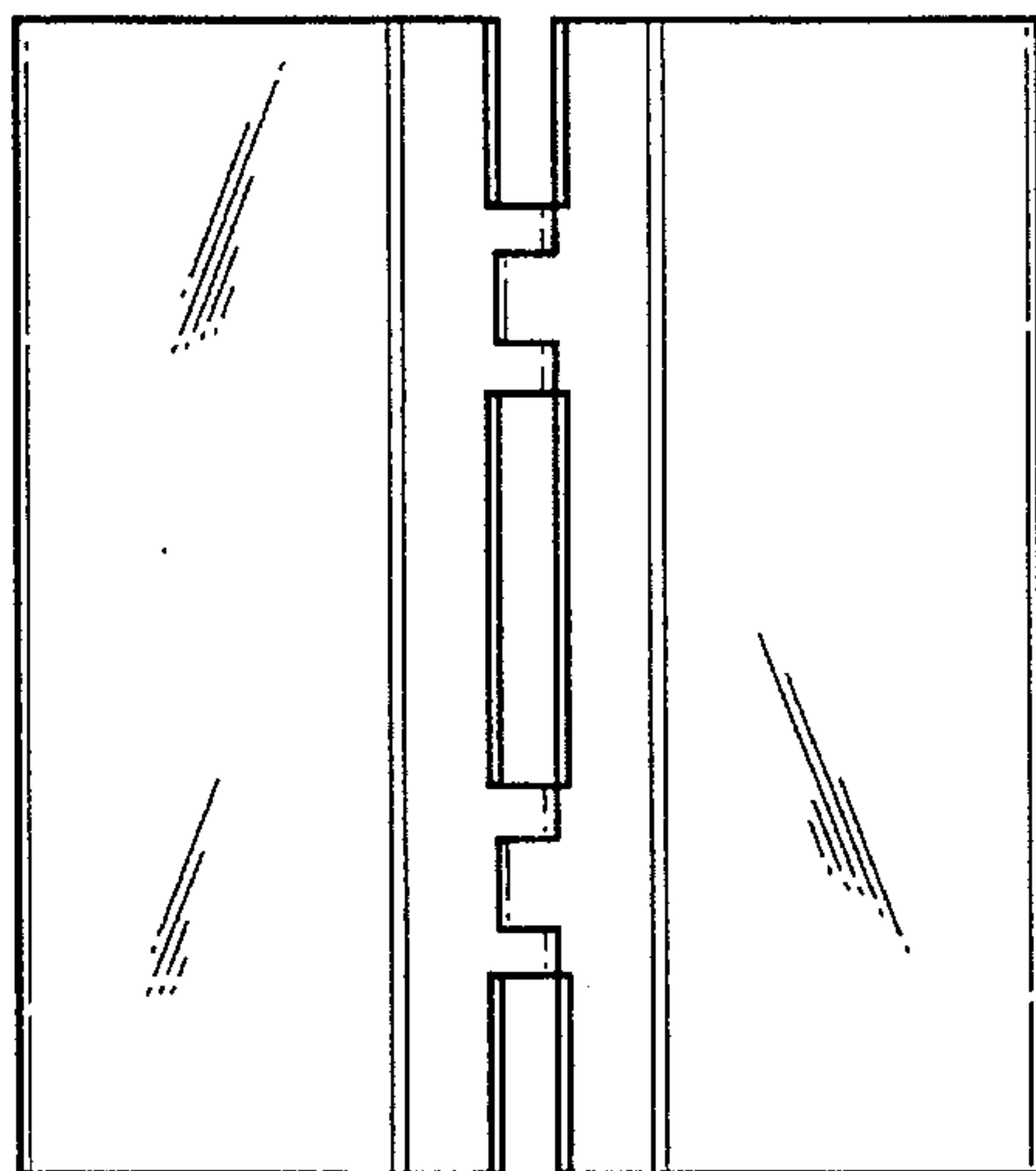

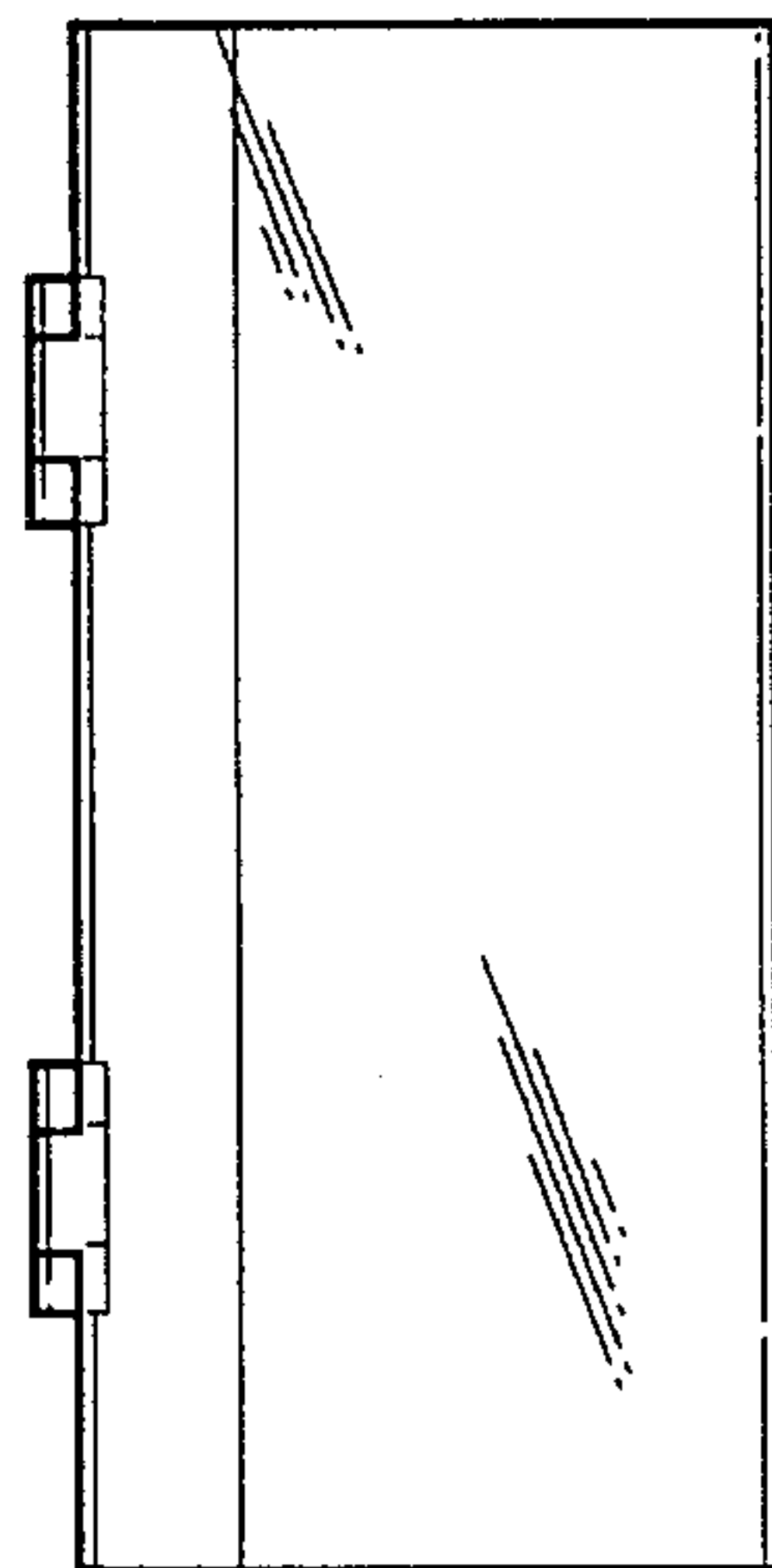
