[57] CLAIM

The ornamental design for a combined point of sale terminal, control unit and cash drawer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a

combined point of sale terminal, control unit and cash drawer showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevational view of the control unit shown separately for ease of illustration;

FIG. 9 is a rear elevational view of the control unit;

FIG. 10 is a right side elevational view of the control unit;

FIG. 11 is a left side elevational view of the control unit;

FIG. 12 is a top plan view of the control unit;

FIG. 13 is a bottom plan view of the control unit;

FIG. 14 is a top, front and right side perspective view of the control unit shown separately for ease of illustration with the door shown in the open position;

FIG. 15 is a front elevational view of FIG. 14;

FIG. 16 is a right side elevational view of FIG. 14;

FIG. 17 is a left side elevational view of FIG. 14;

FIG. 18 is a front elevational view of a cash drawer shown separately for ease of illustration;

FIG. 19 is a rear elevational view of a cash drawer;

FIG. 20 is a right elevational view of a cash drawer;

FIG. 21 is a left elevational view of a cash drawer;

FIG. 22 is a top plan elevational view of a cash drawer; and,

FIG. 23 is a bottom plan view of a cash drawer.

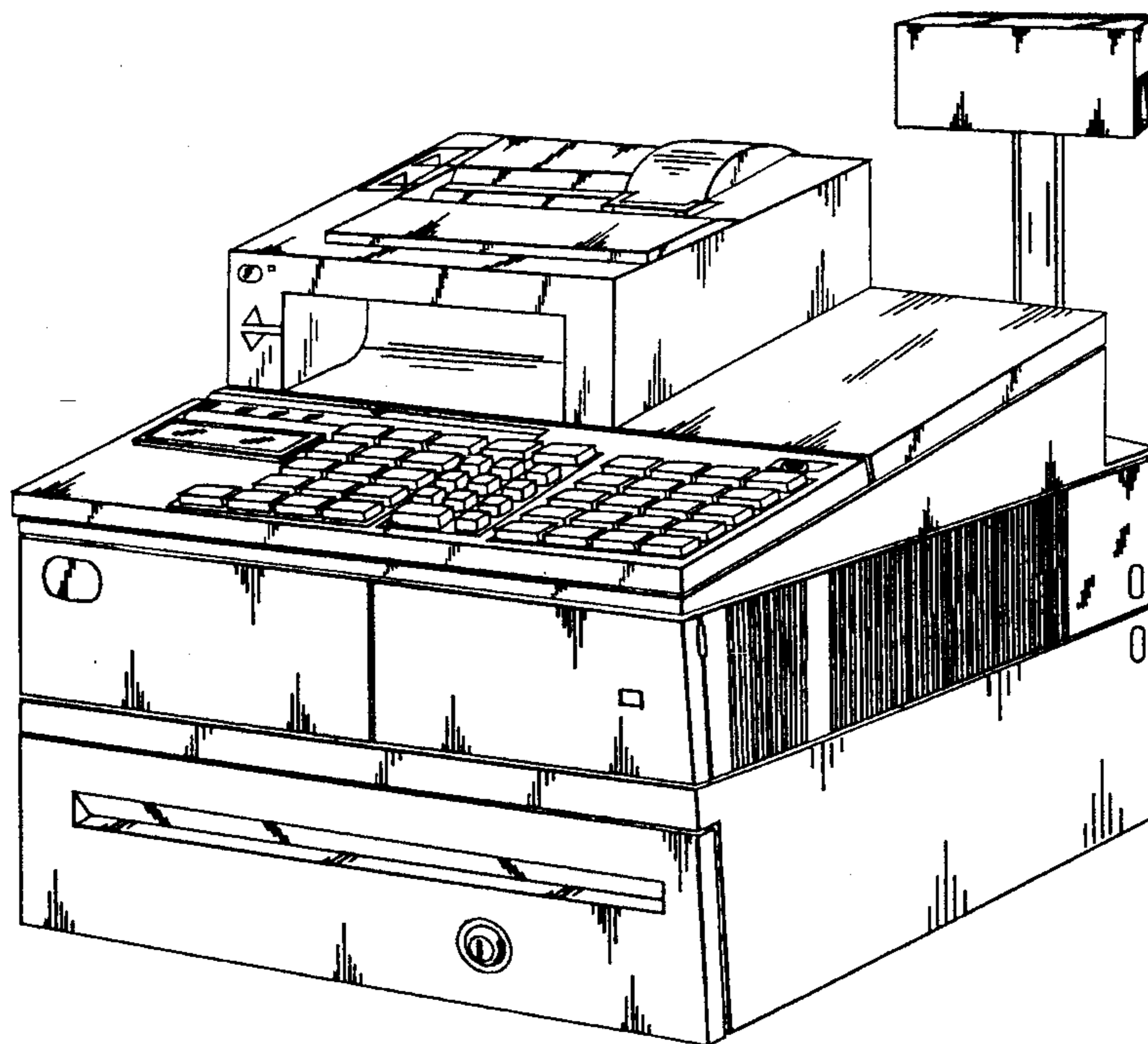

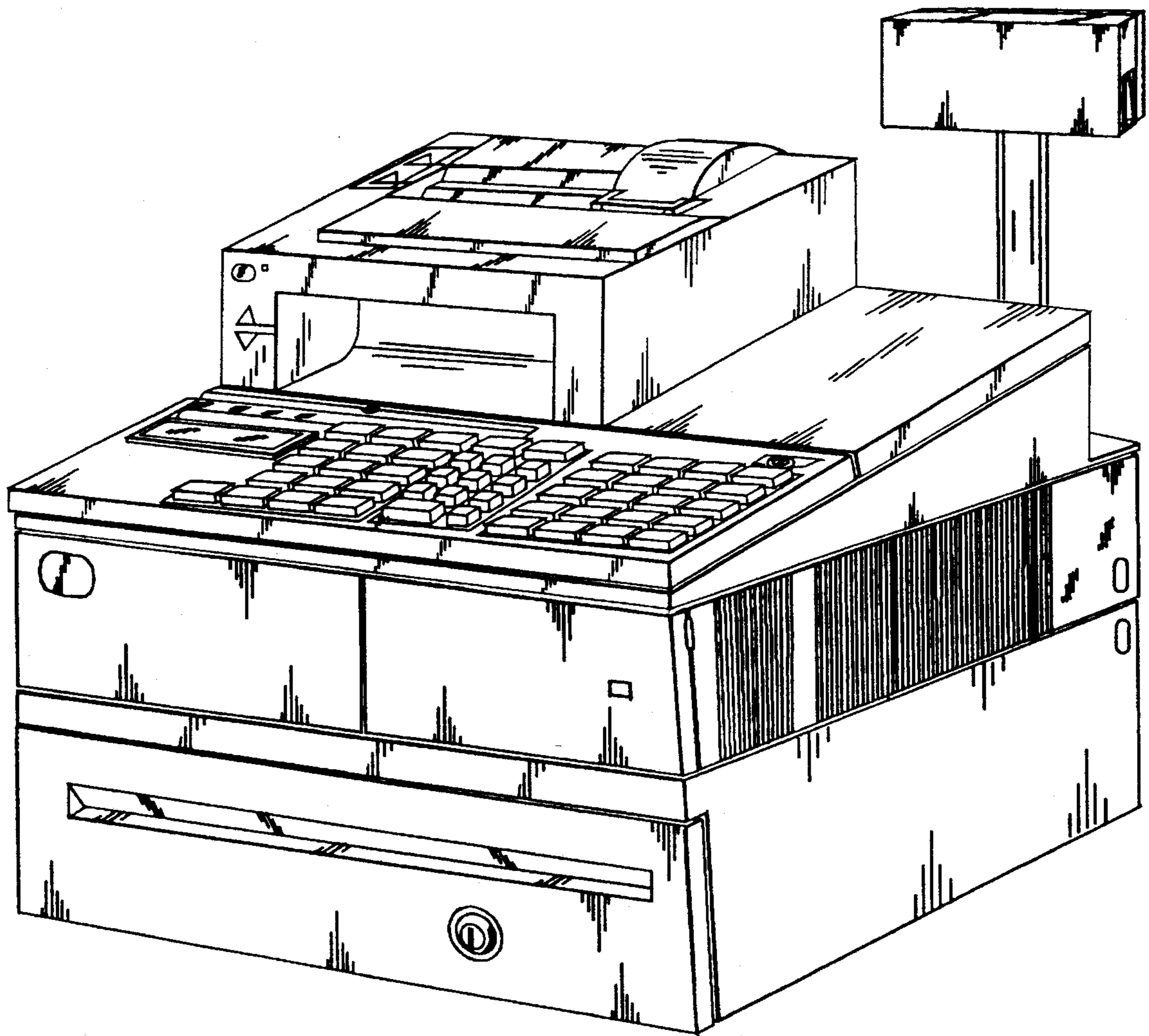

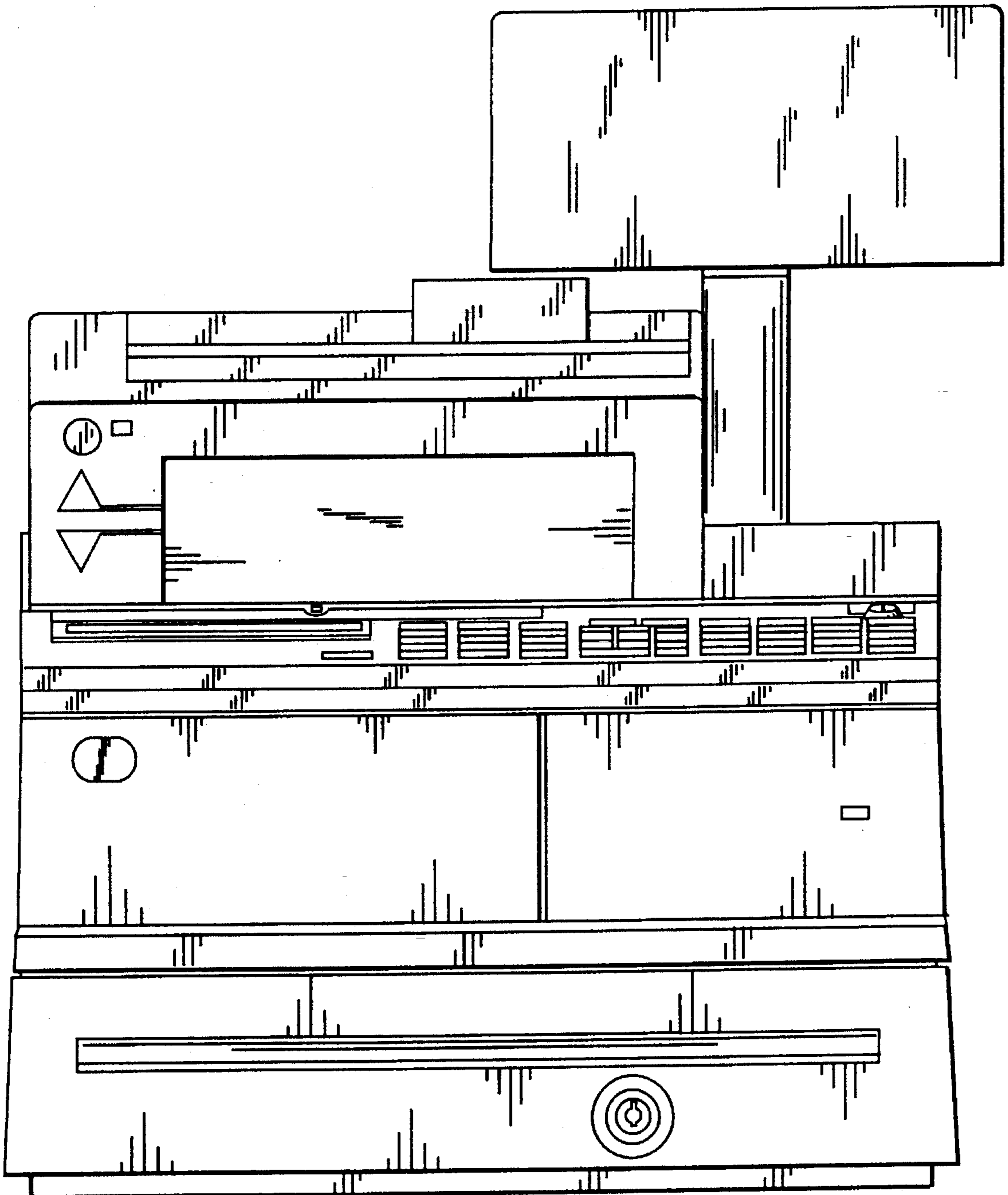

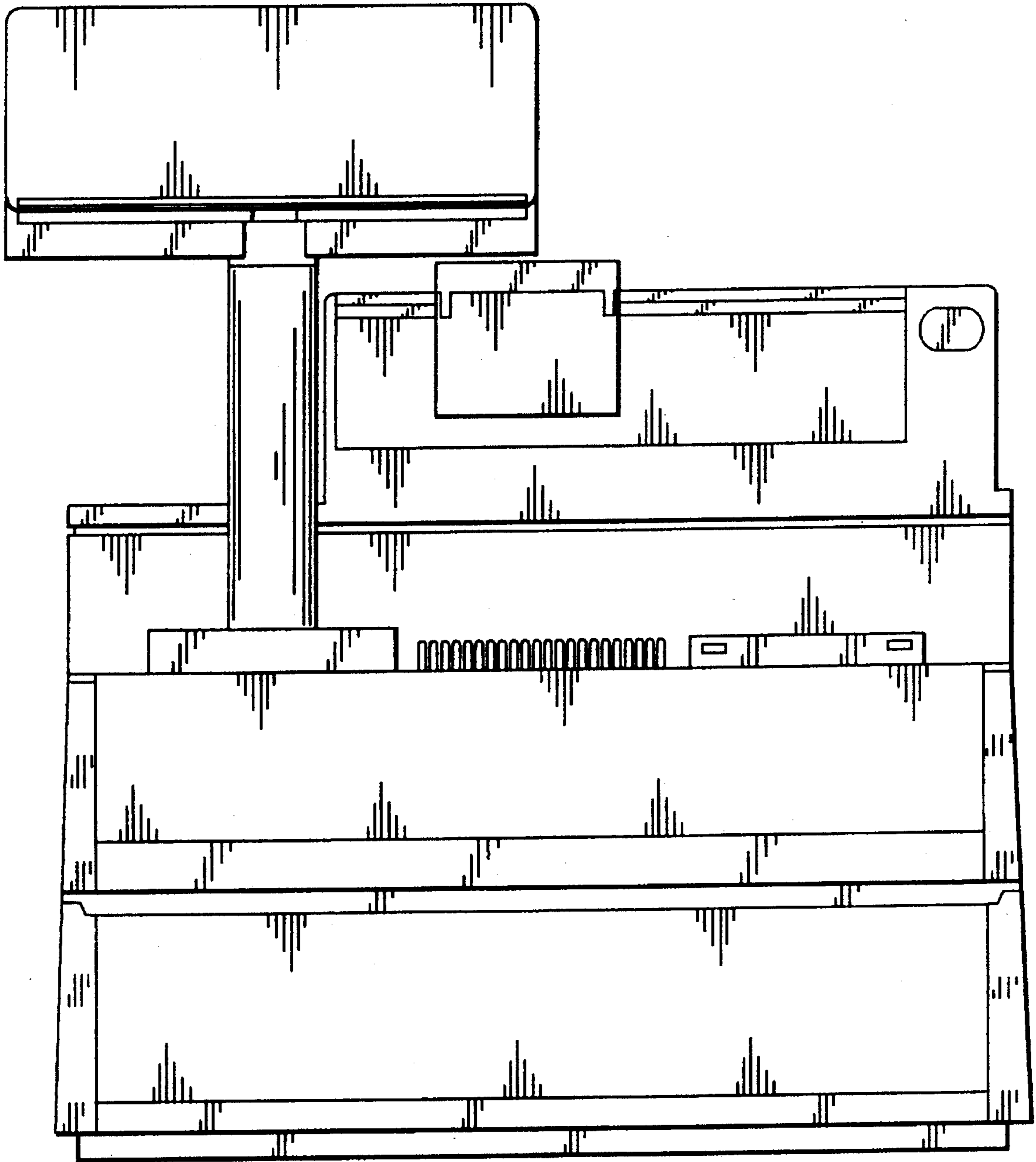

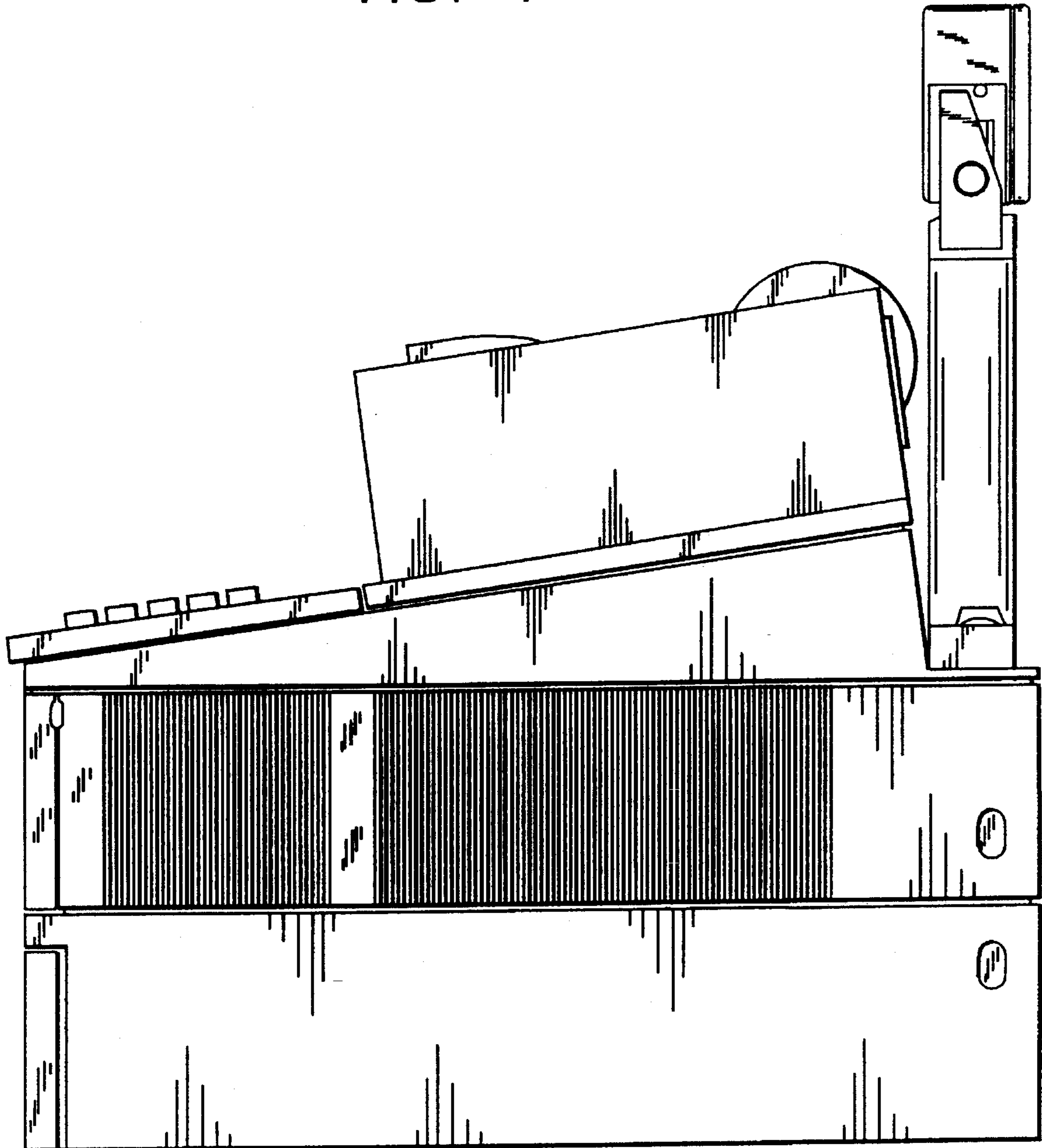

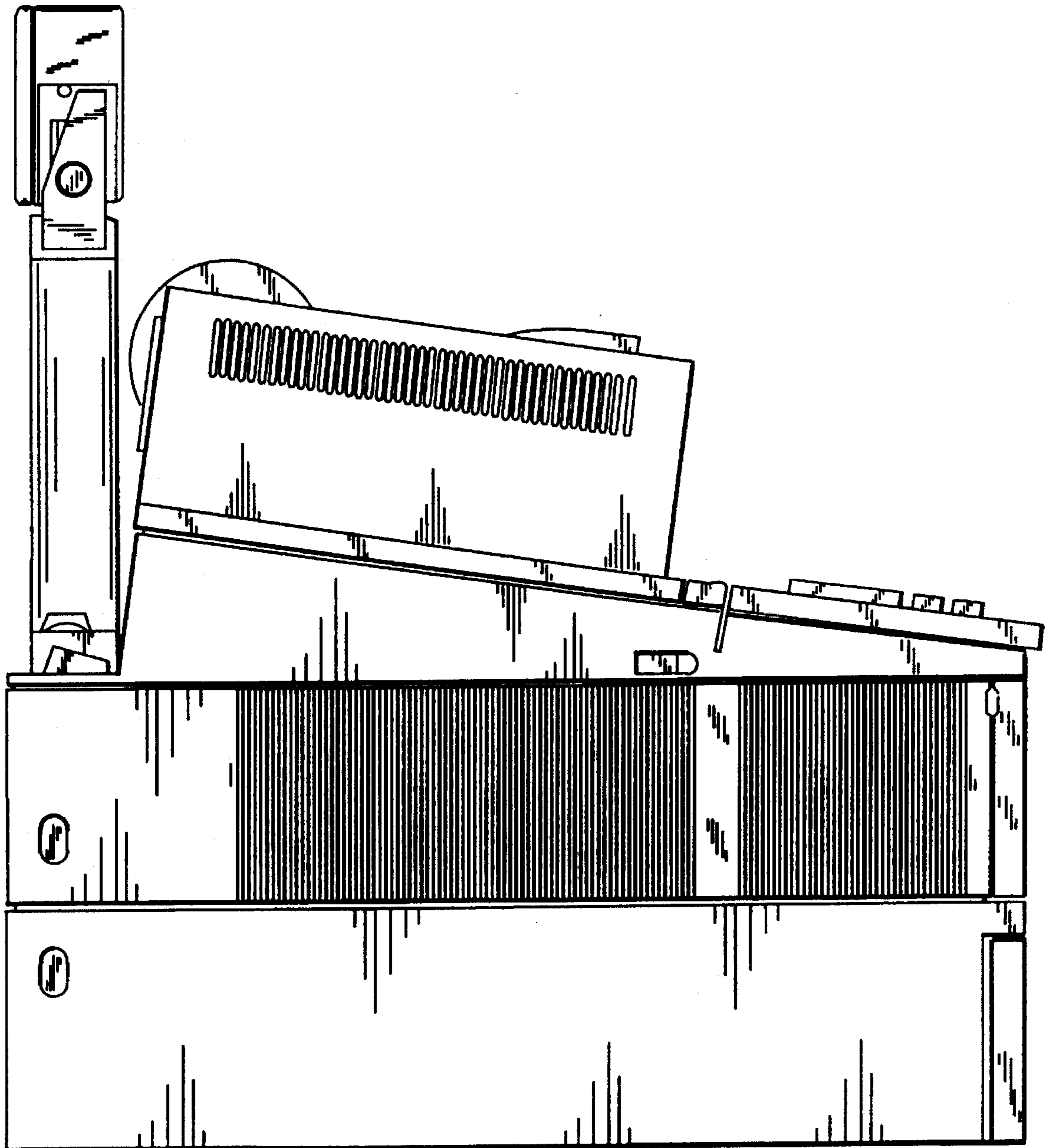

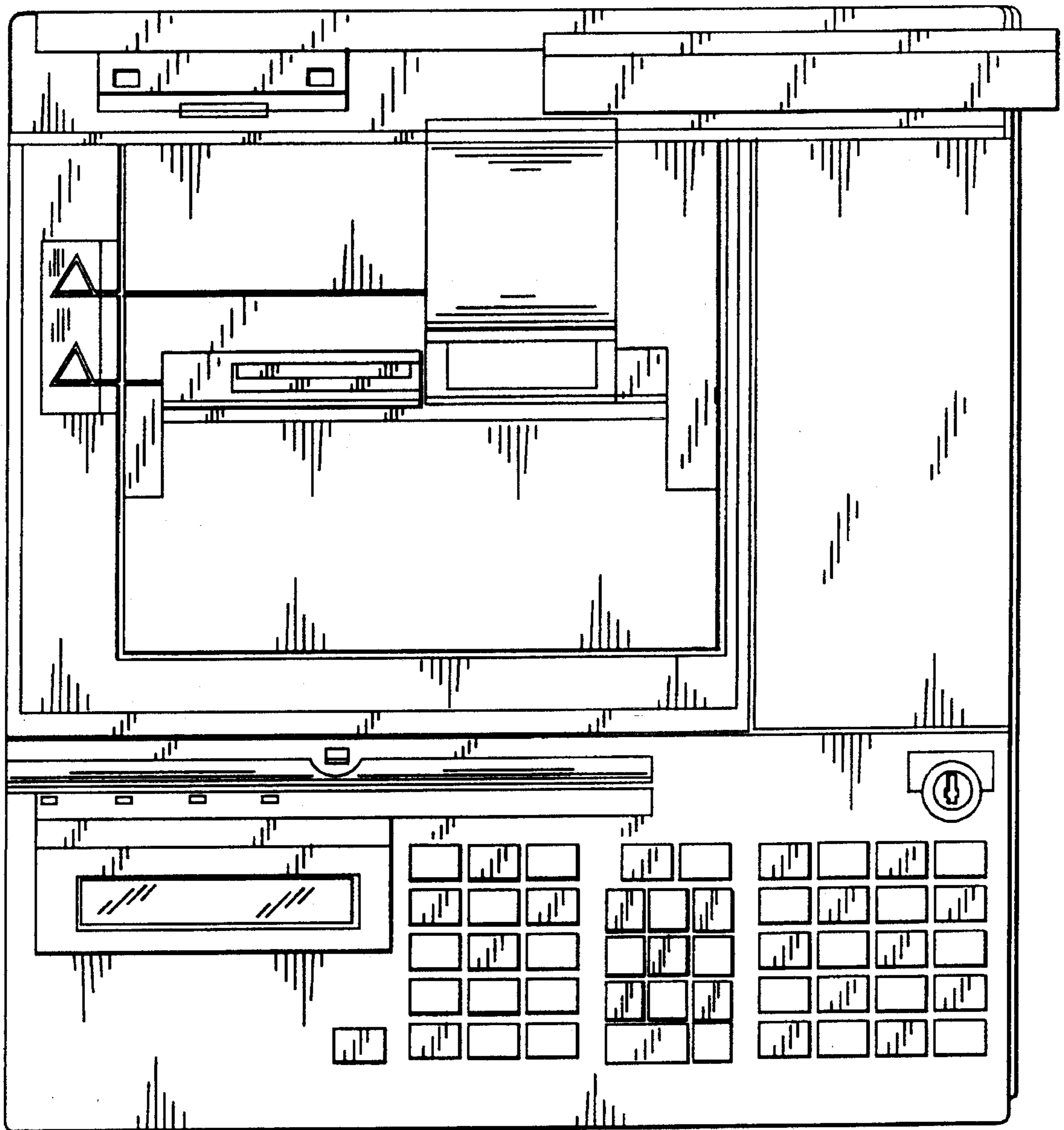

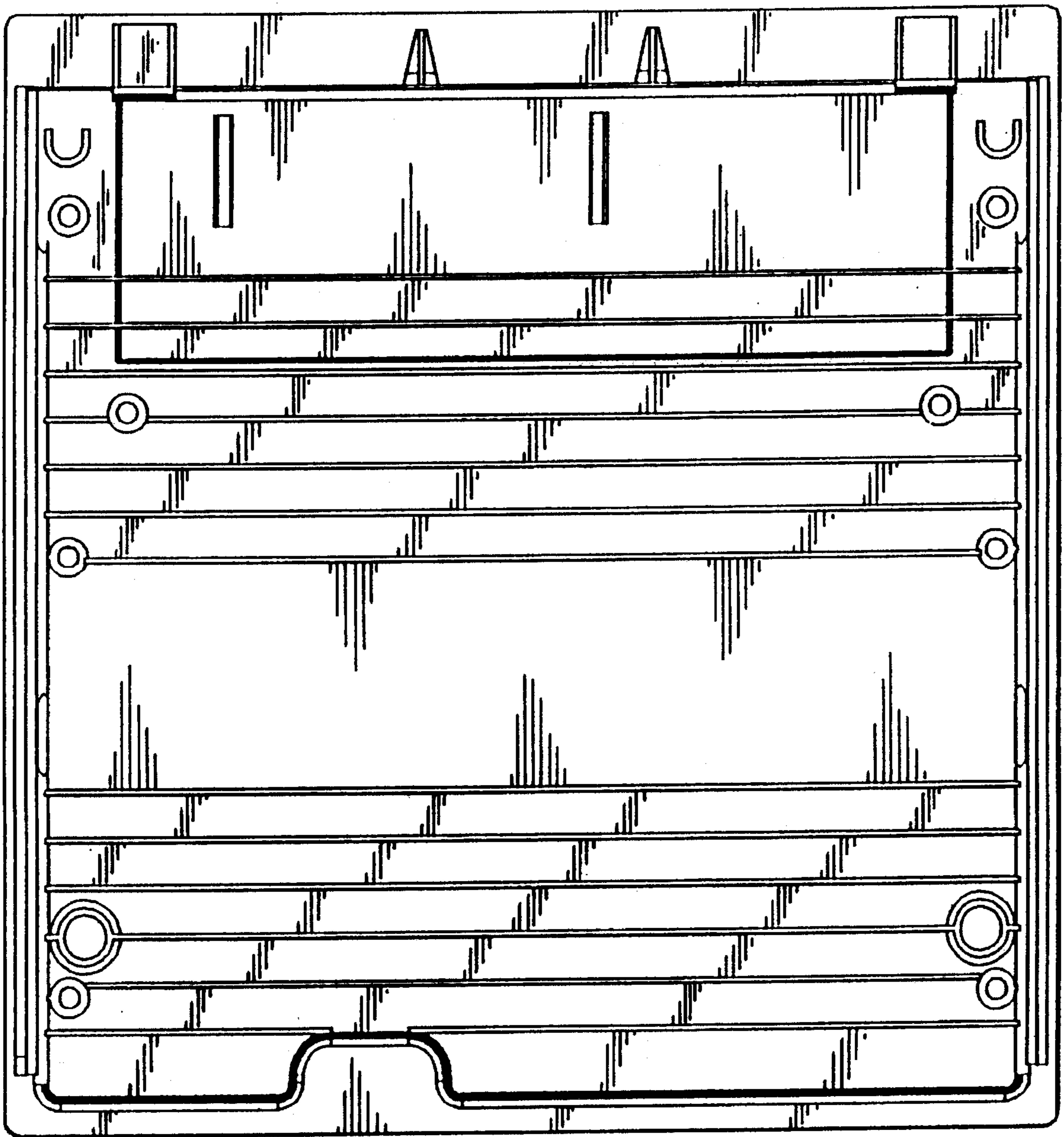

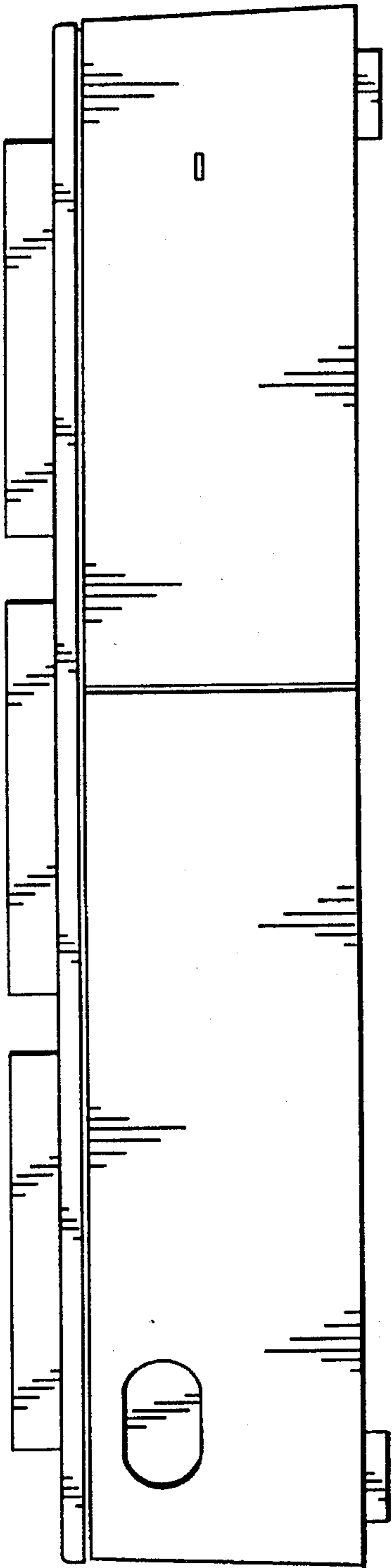

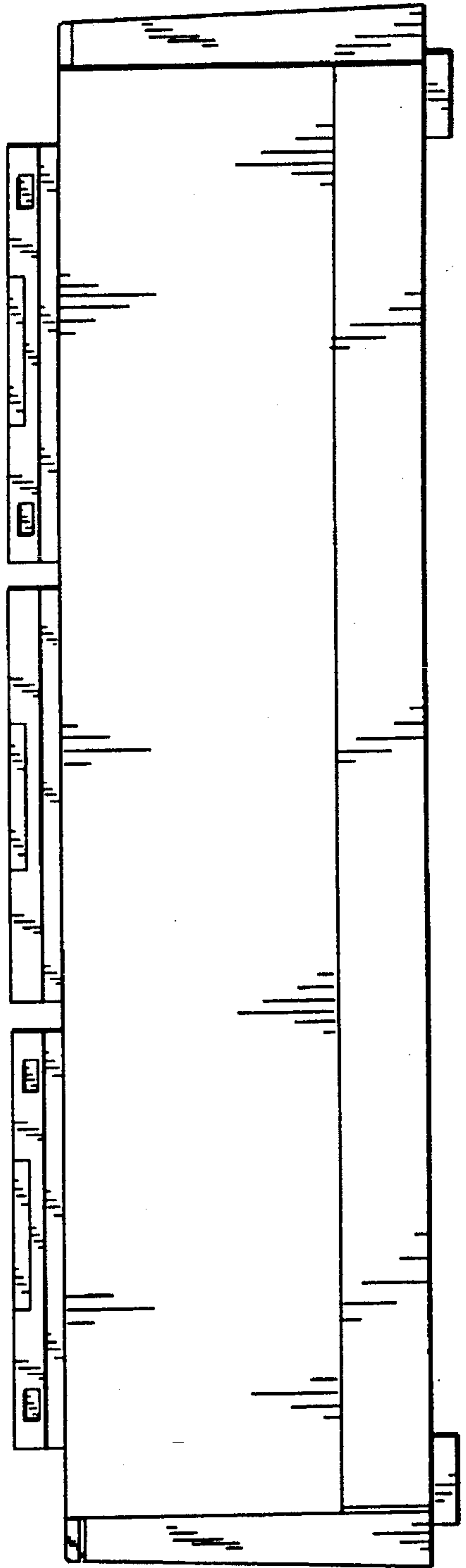

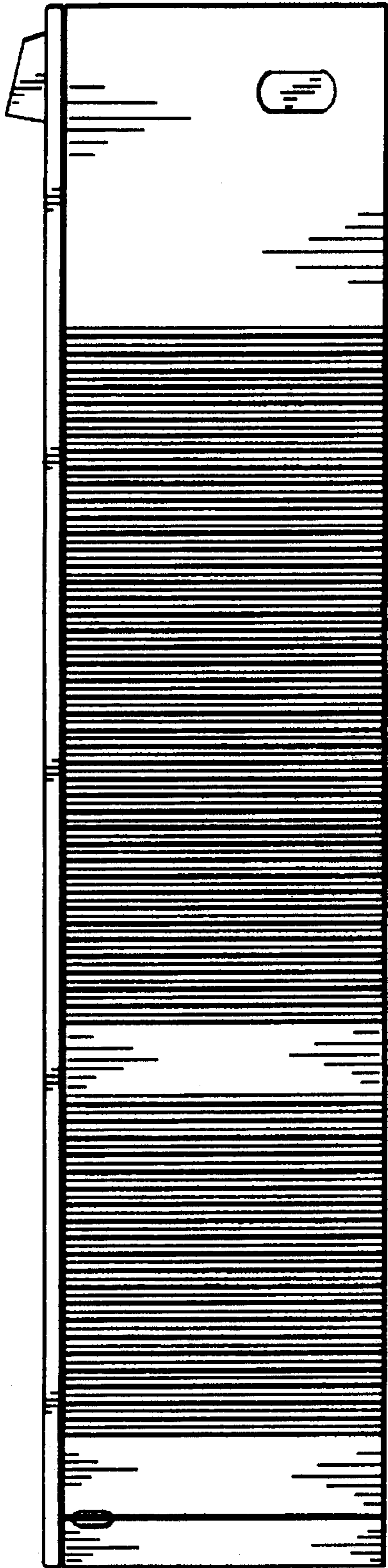

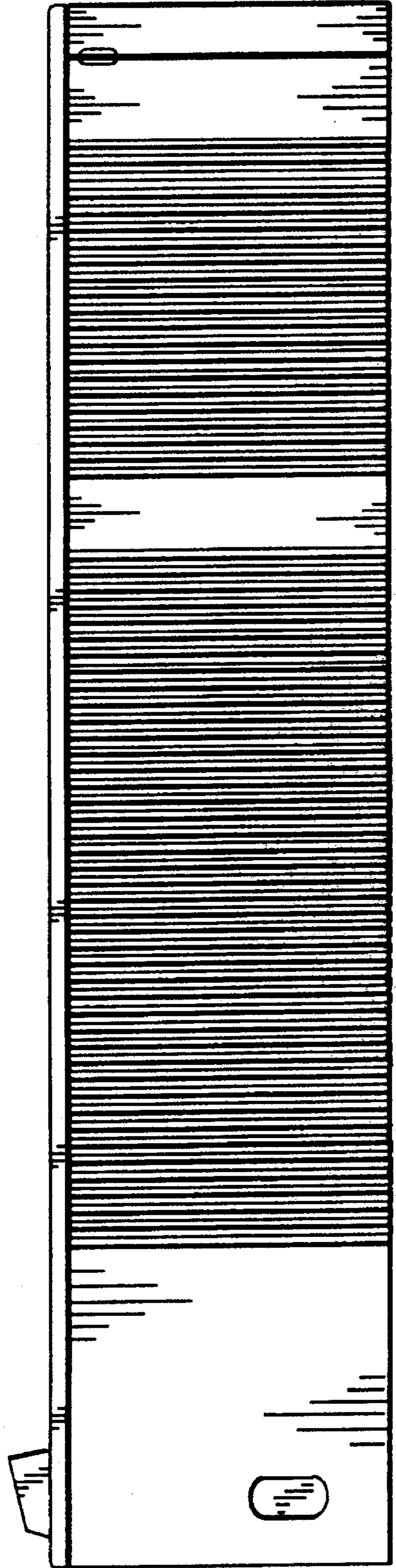

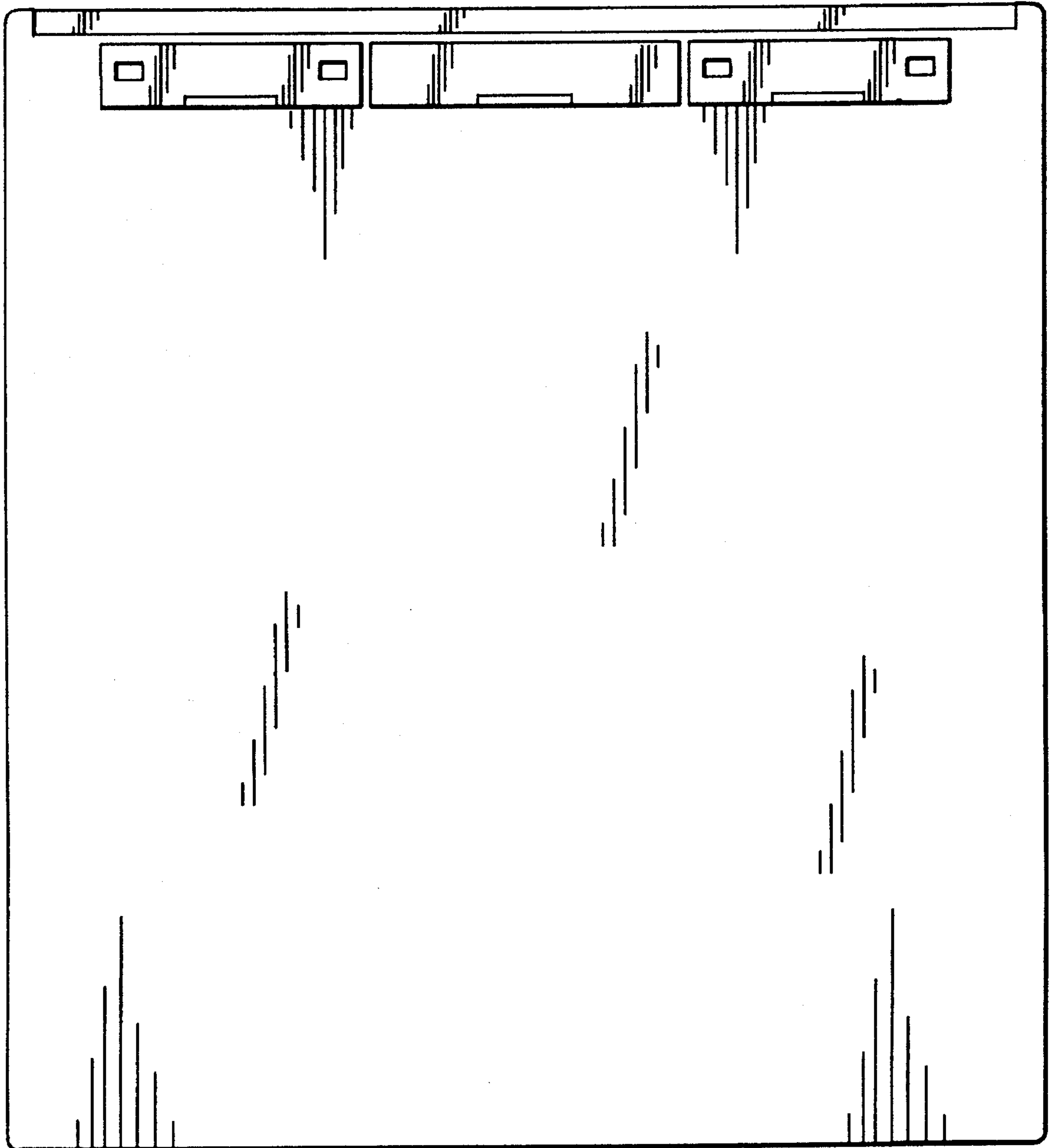

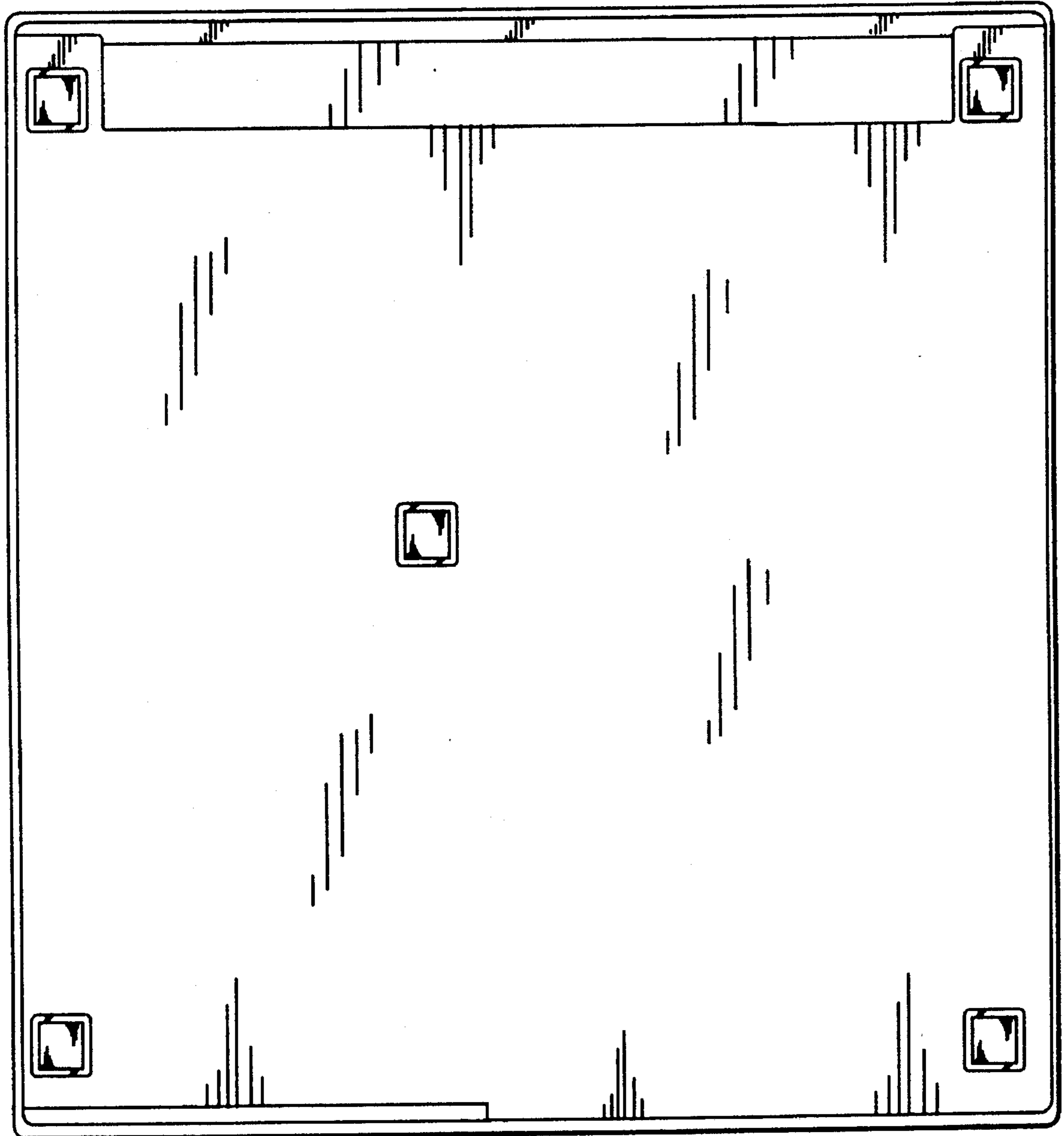

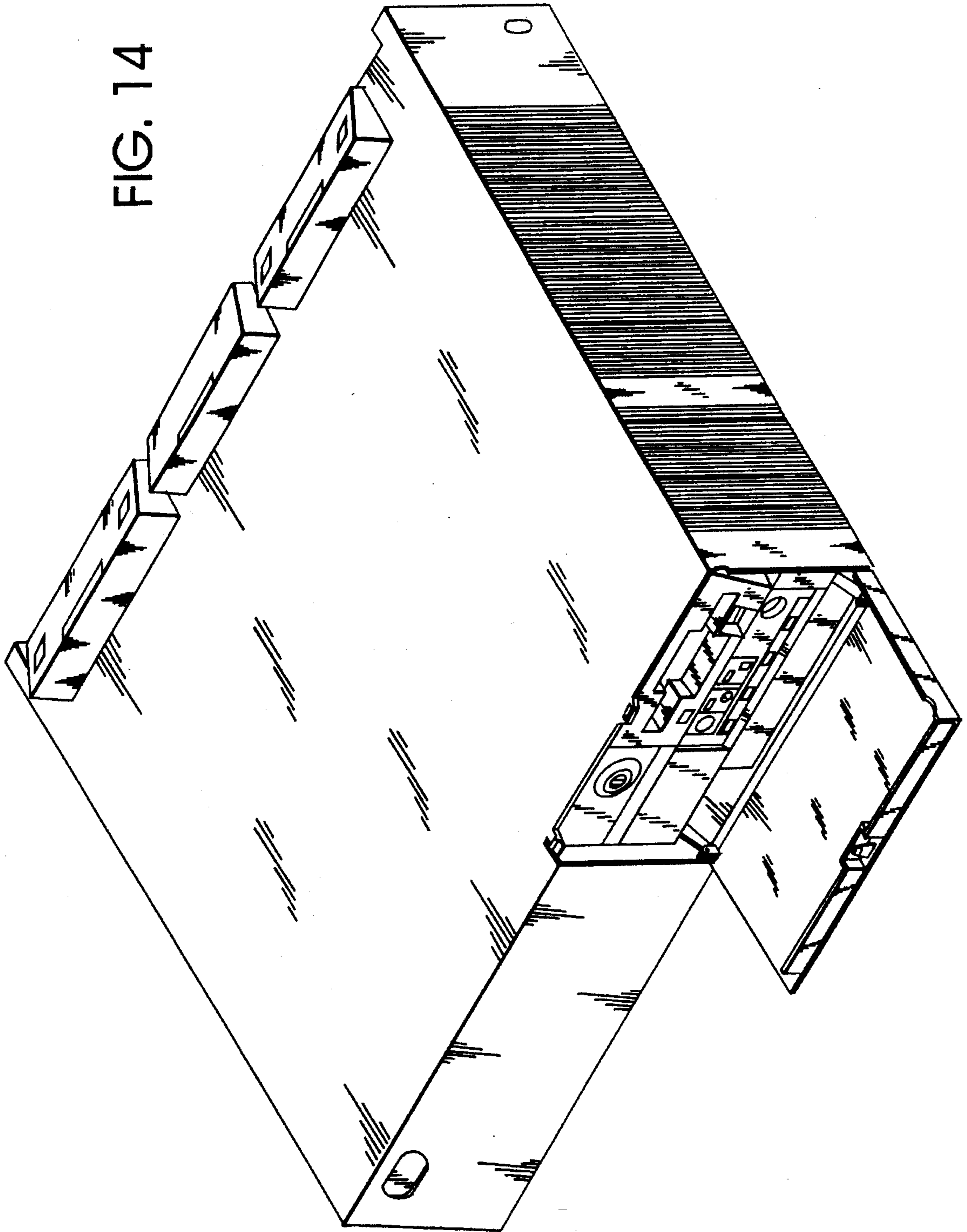
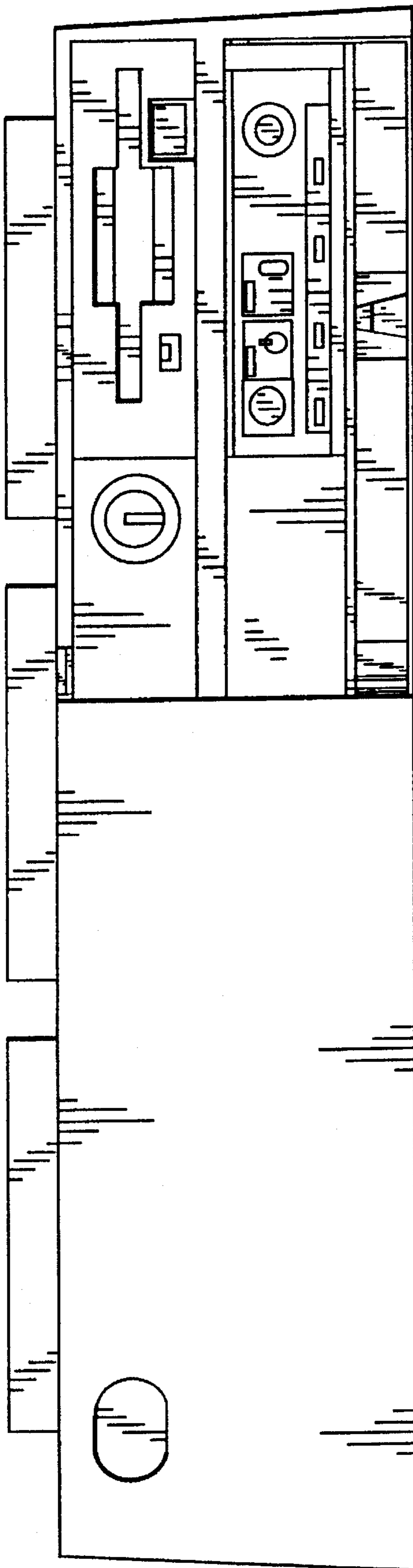

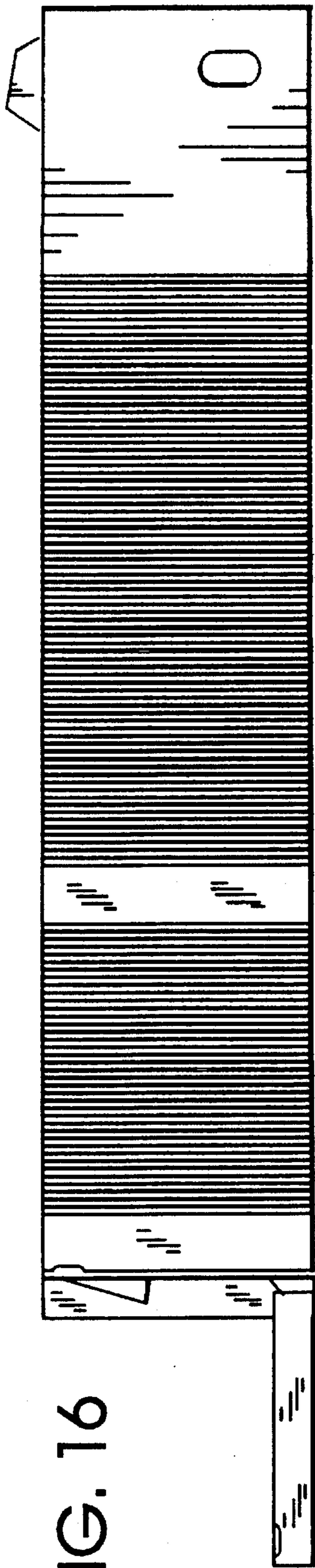

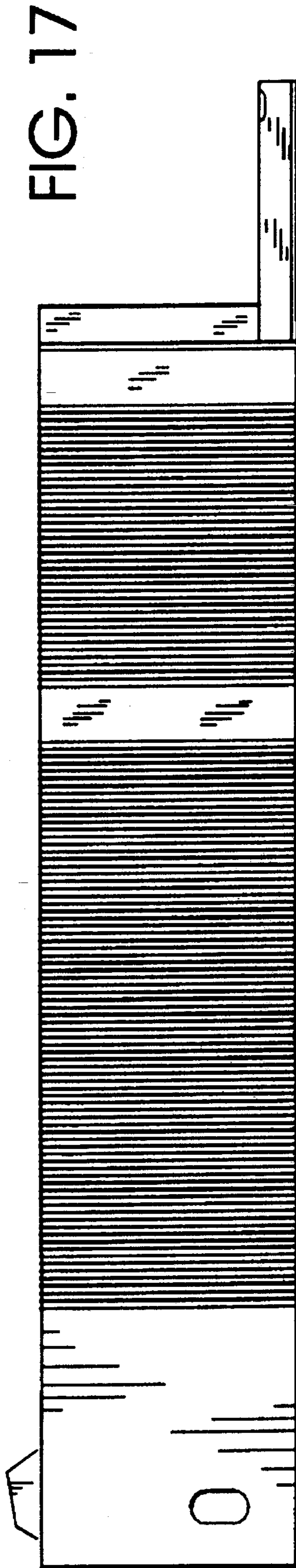

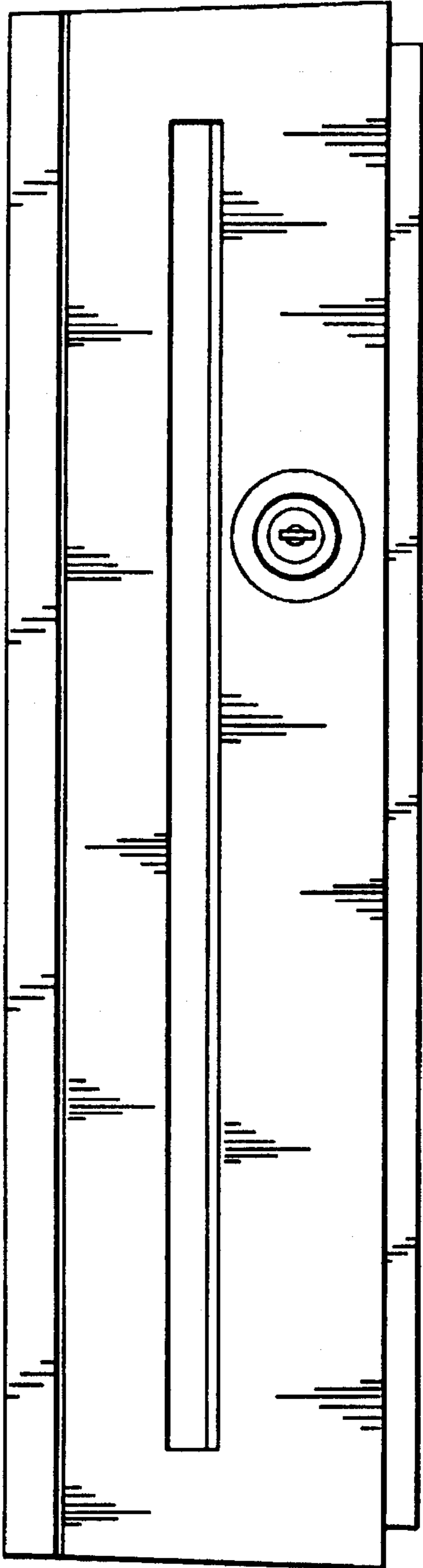

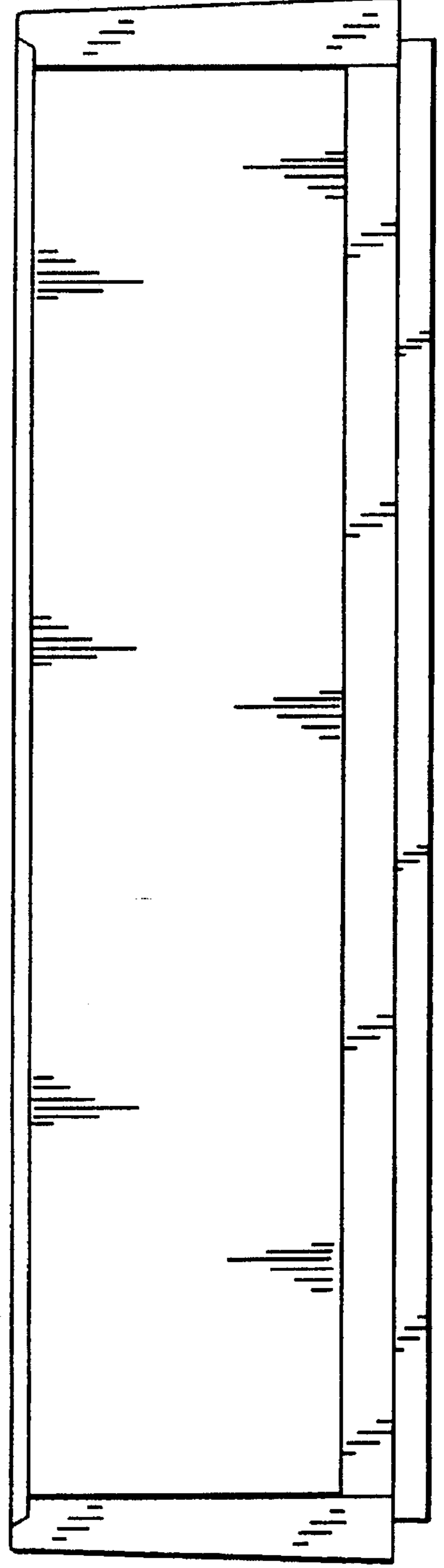

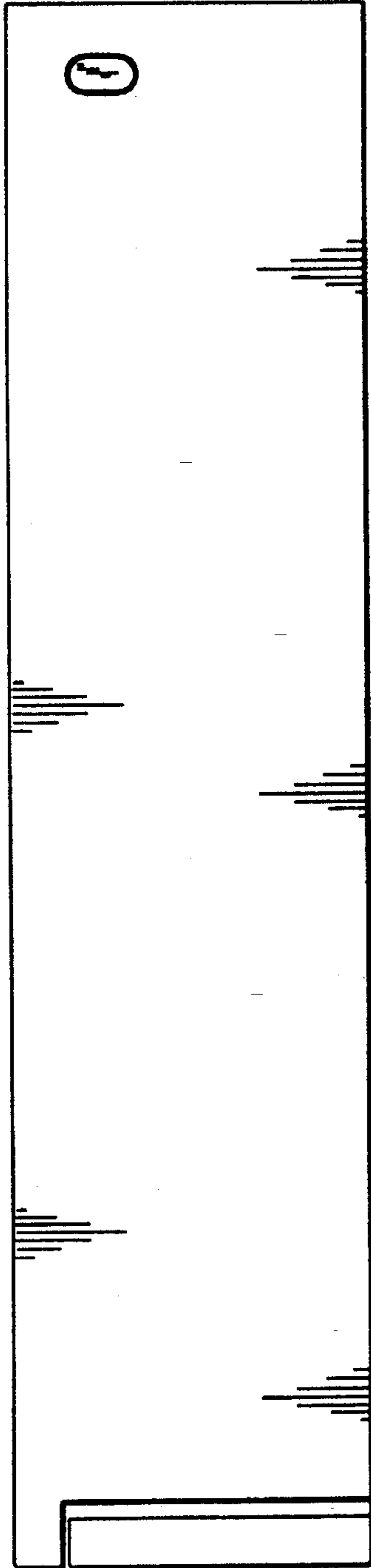

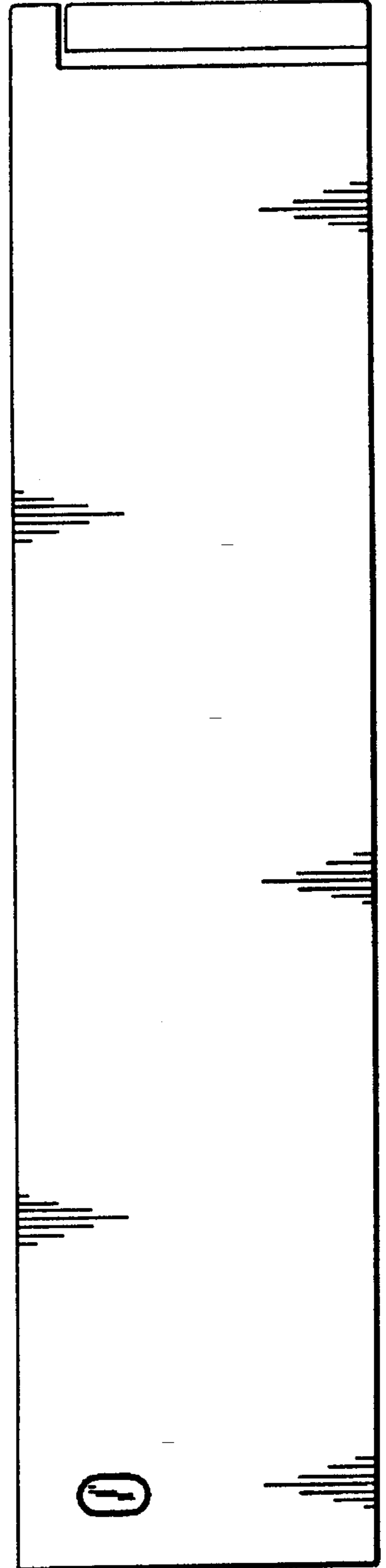

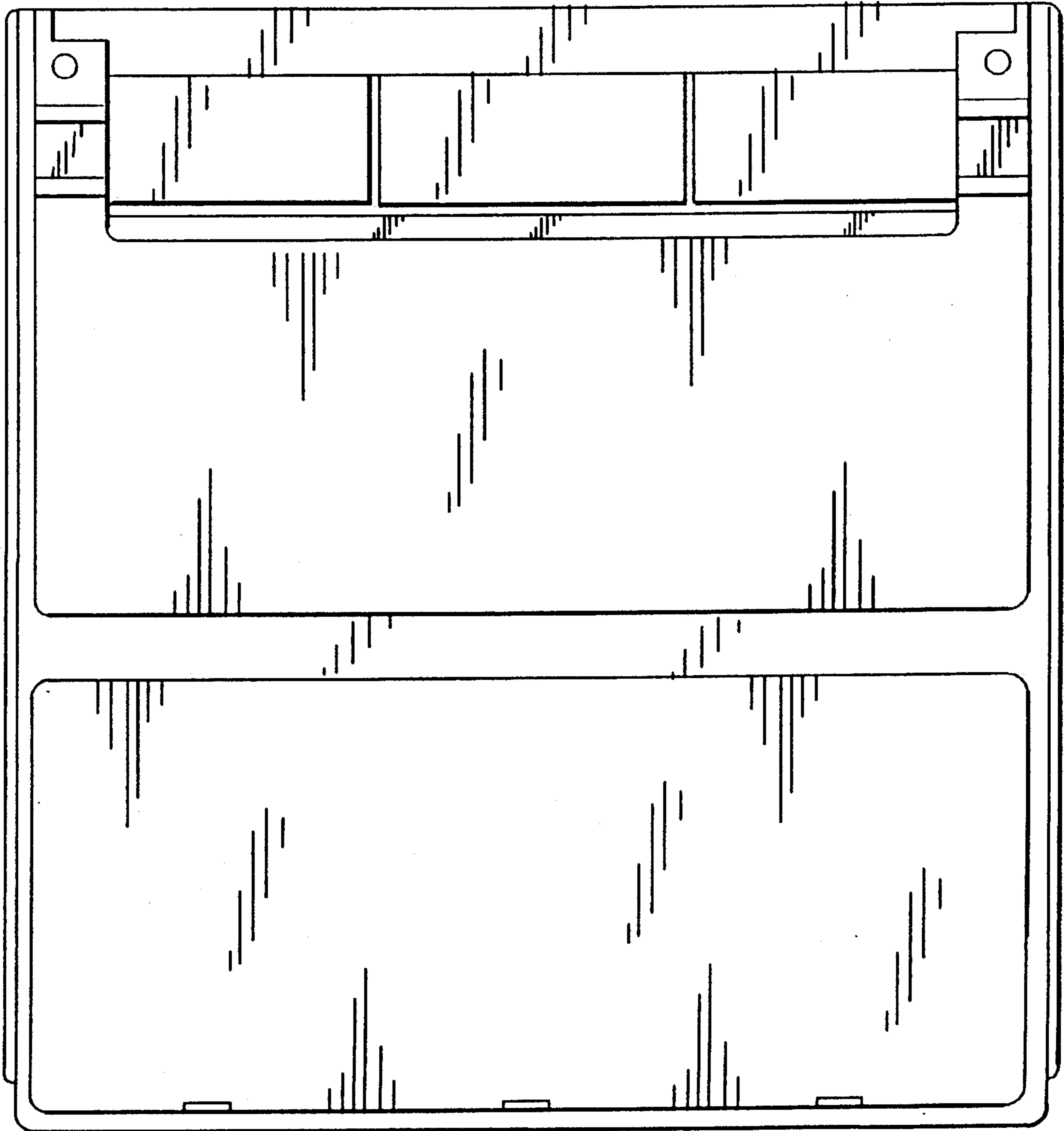
