**DESCRIPTION**

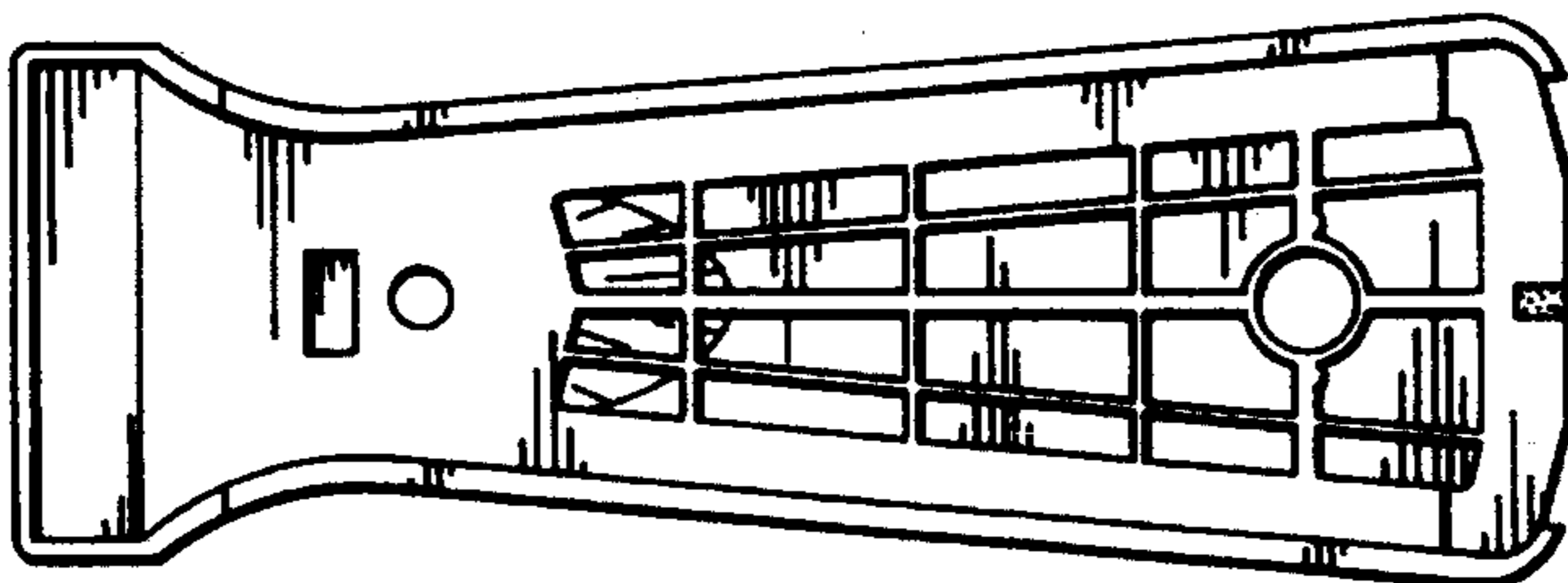
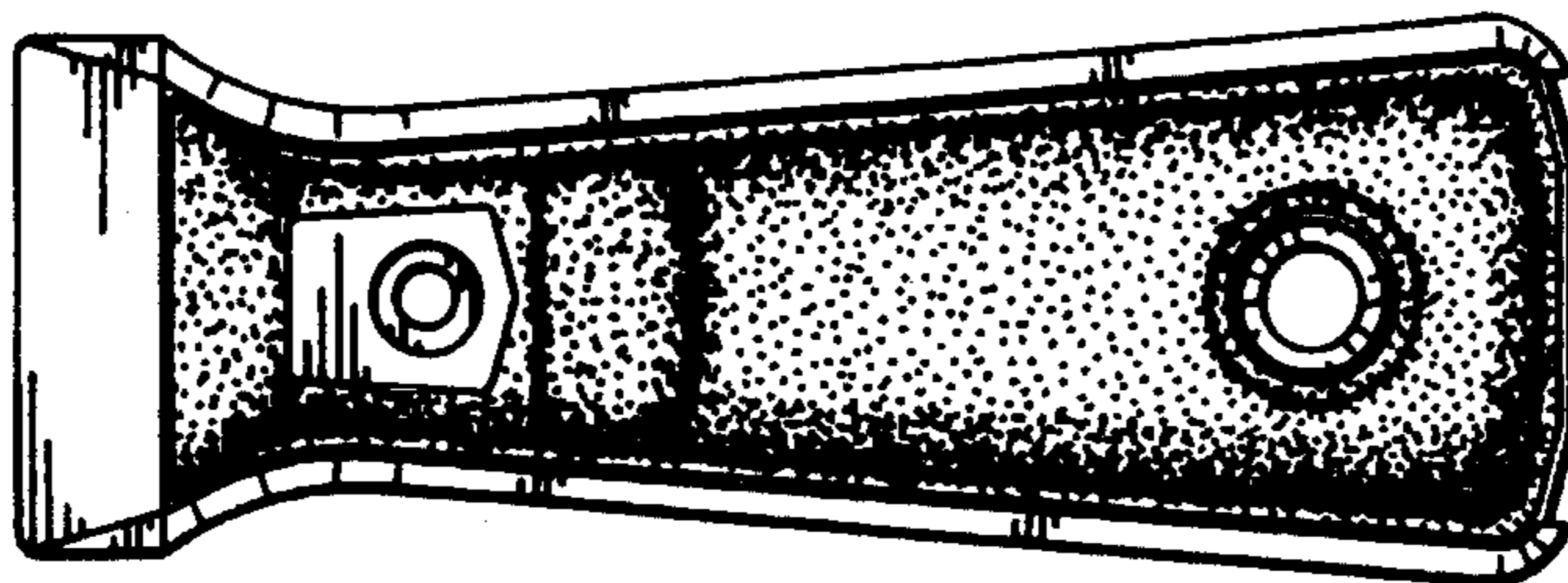
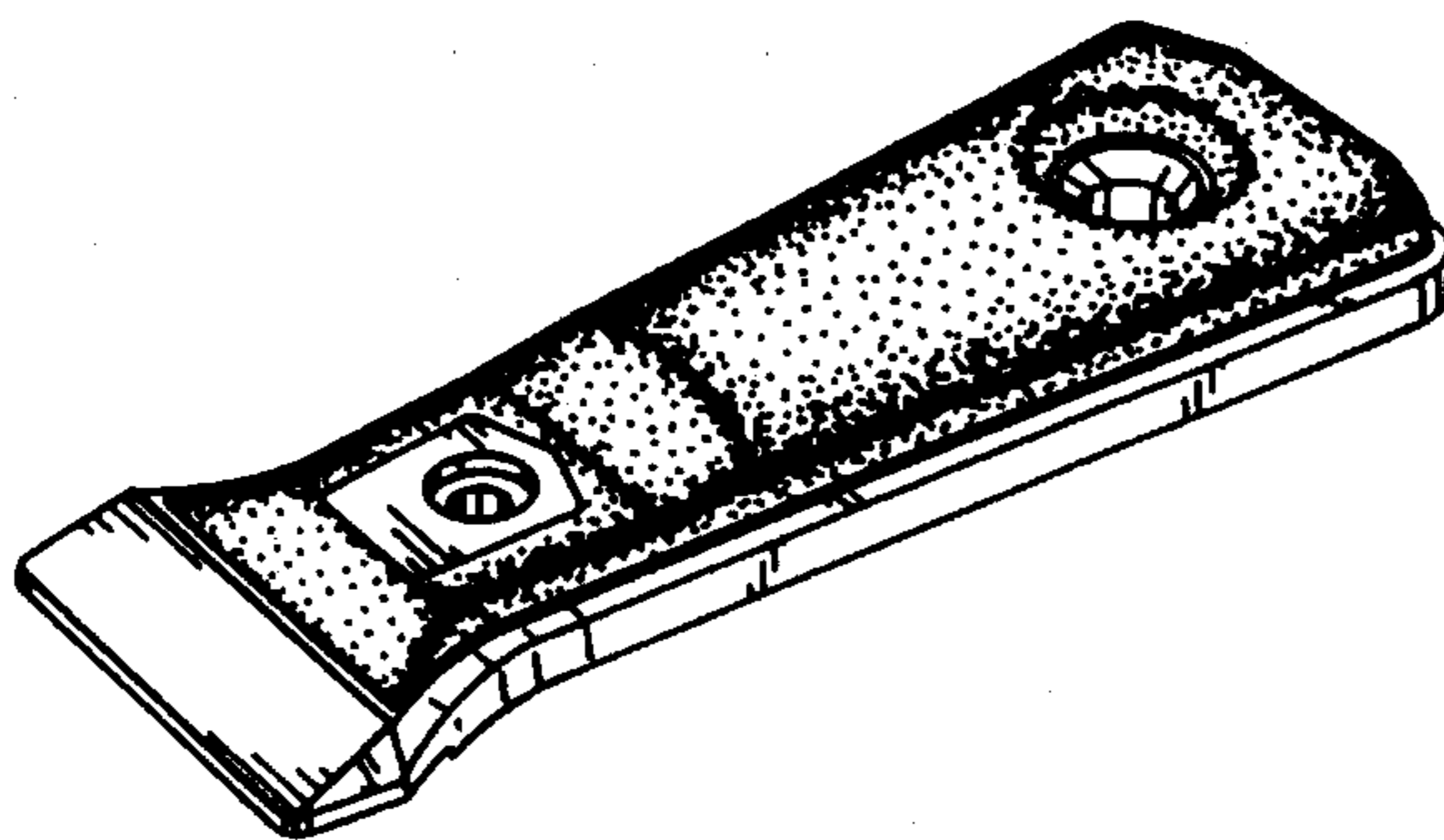

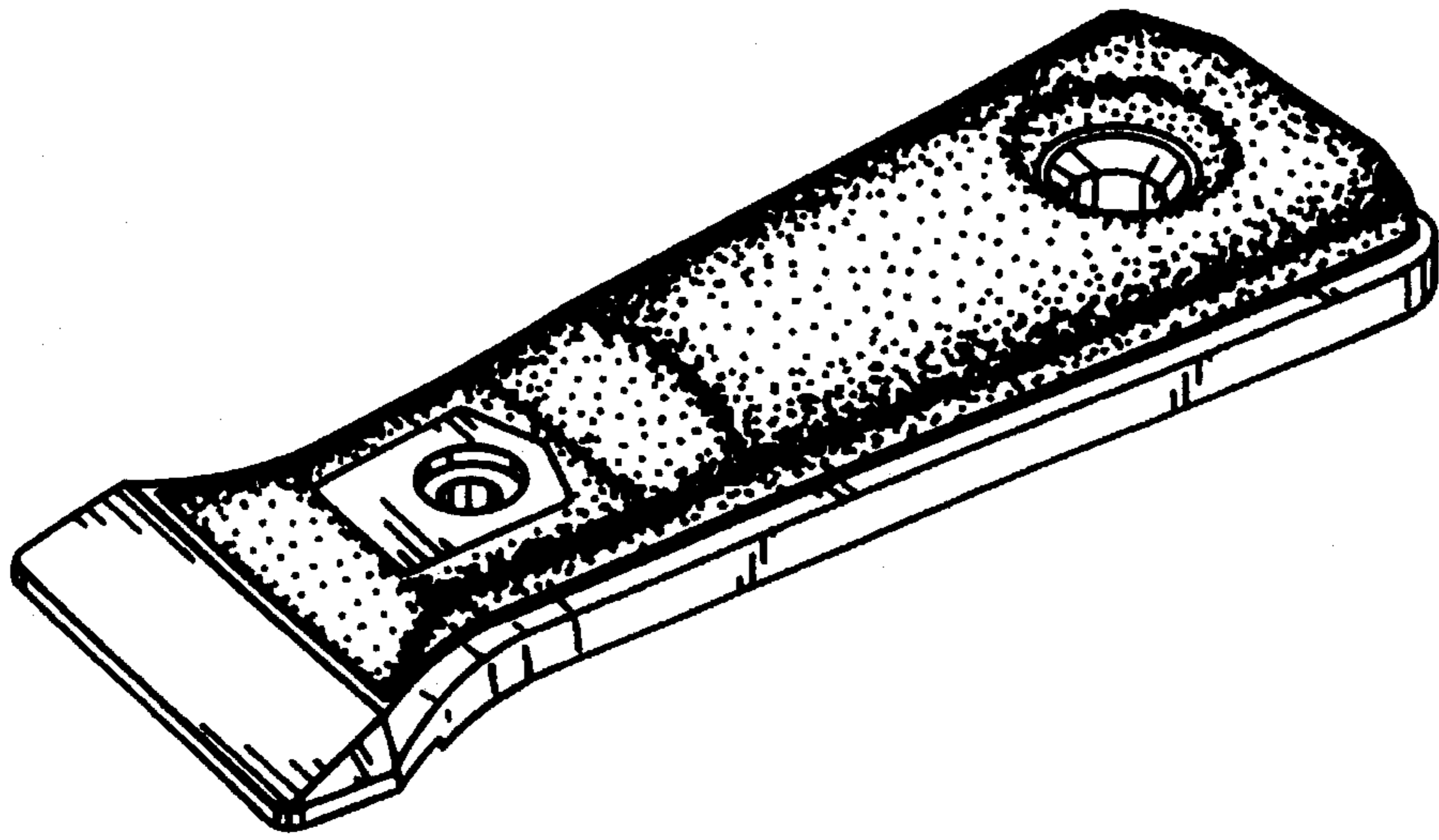

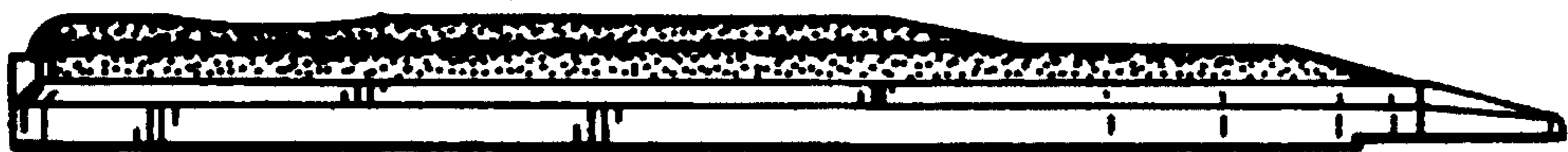

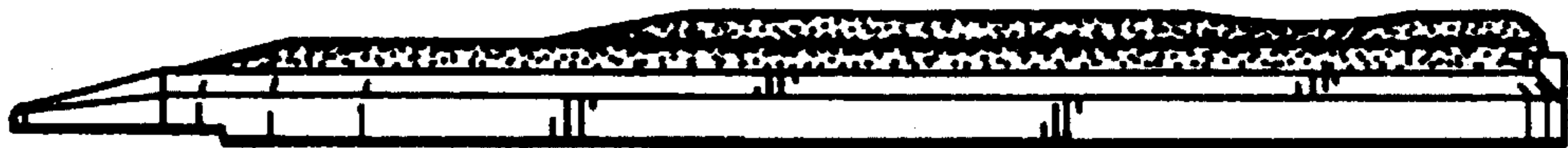

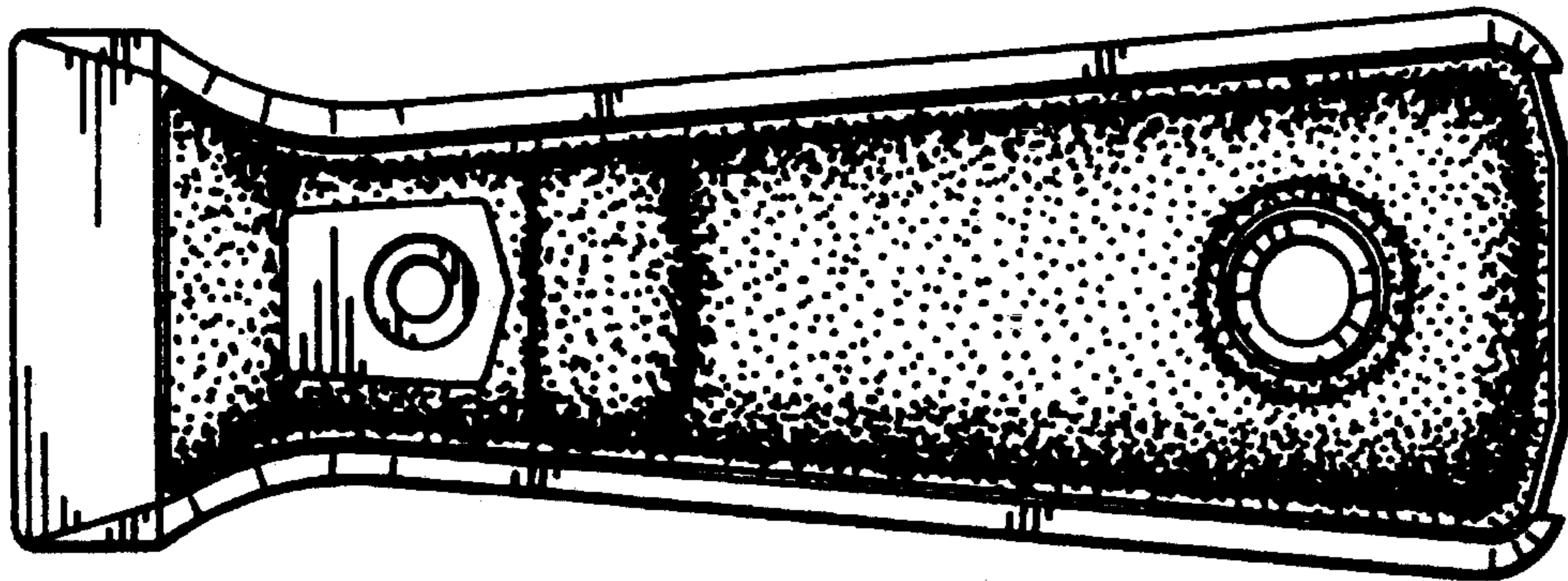

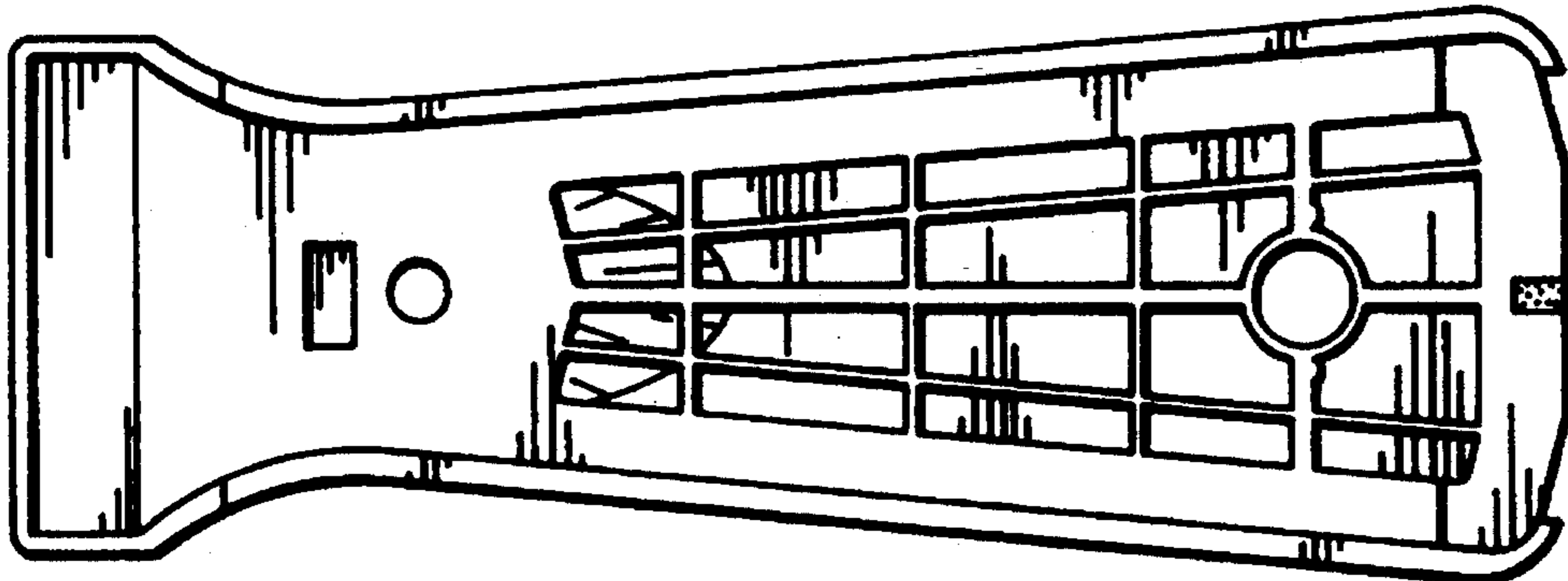

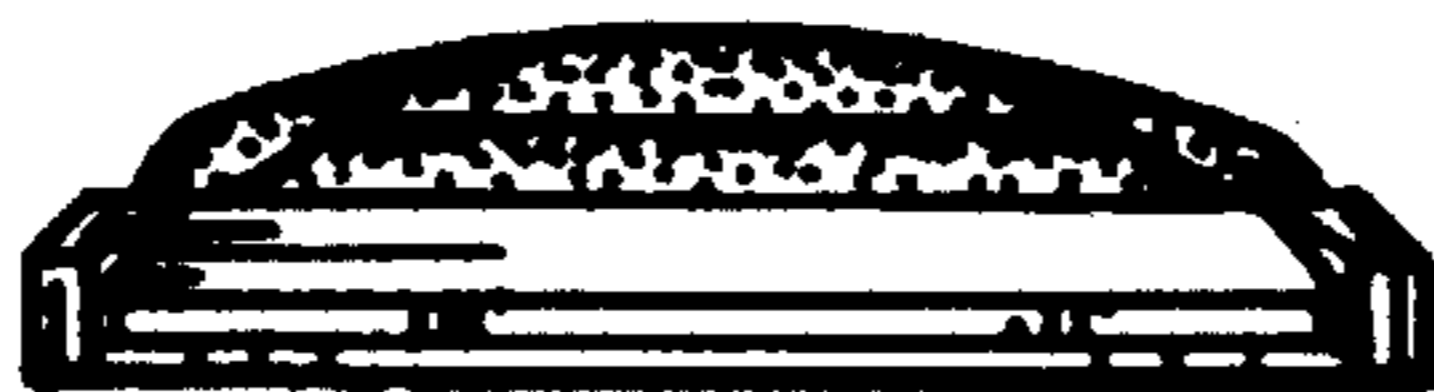
