The ornamental design for a combined rim and handle portion for a trash container, as shown and described.

## DESCRIPTION

FIG. 1 is a top right front perspective view of a combined rim and handle portion for a trash container showing our new design;

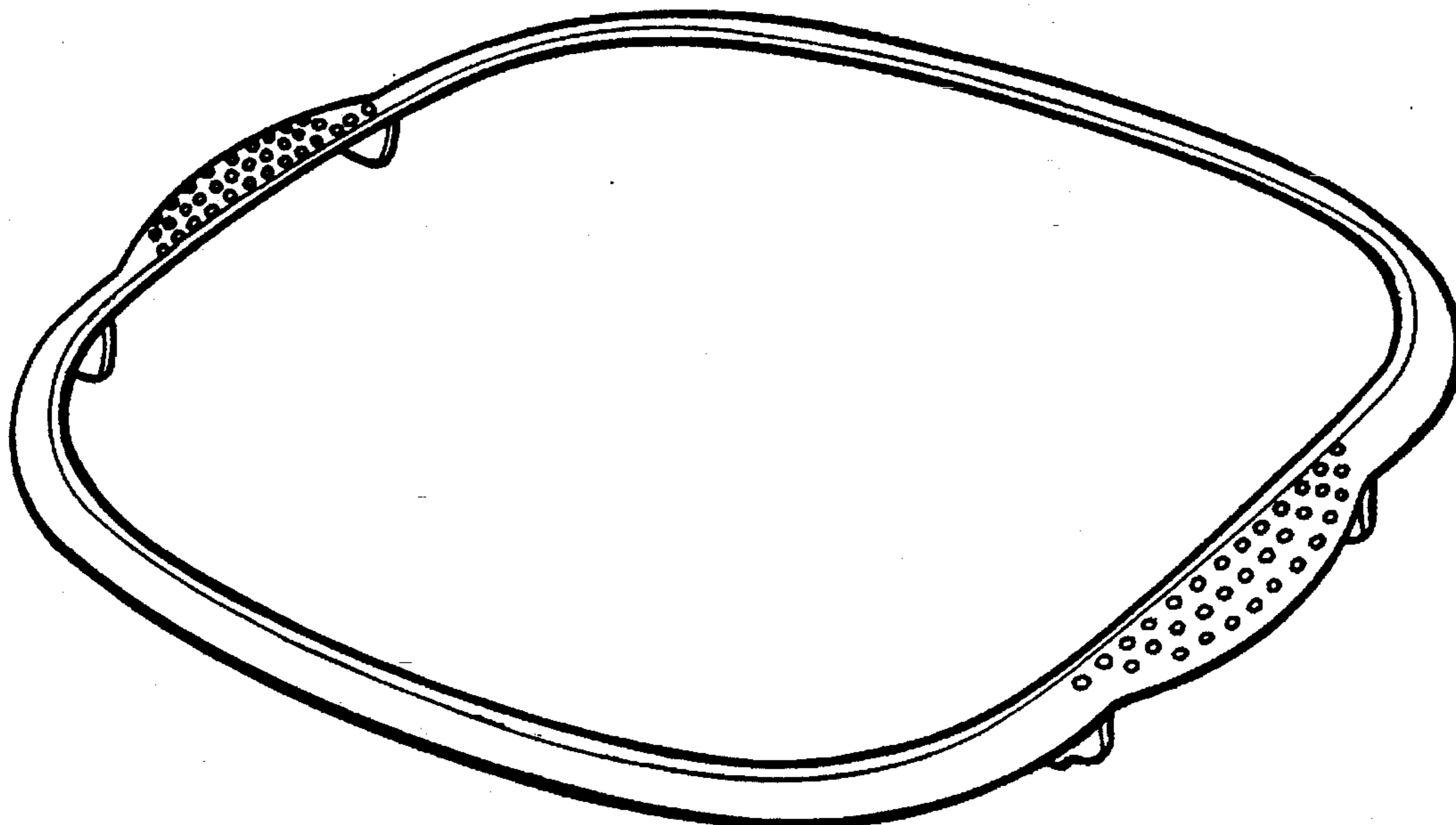
FIG. 2 is a front elevational view thereof; the rear elevational view being a mirror image;

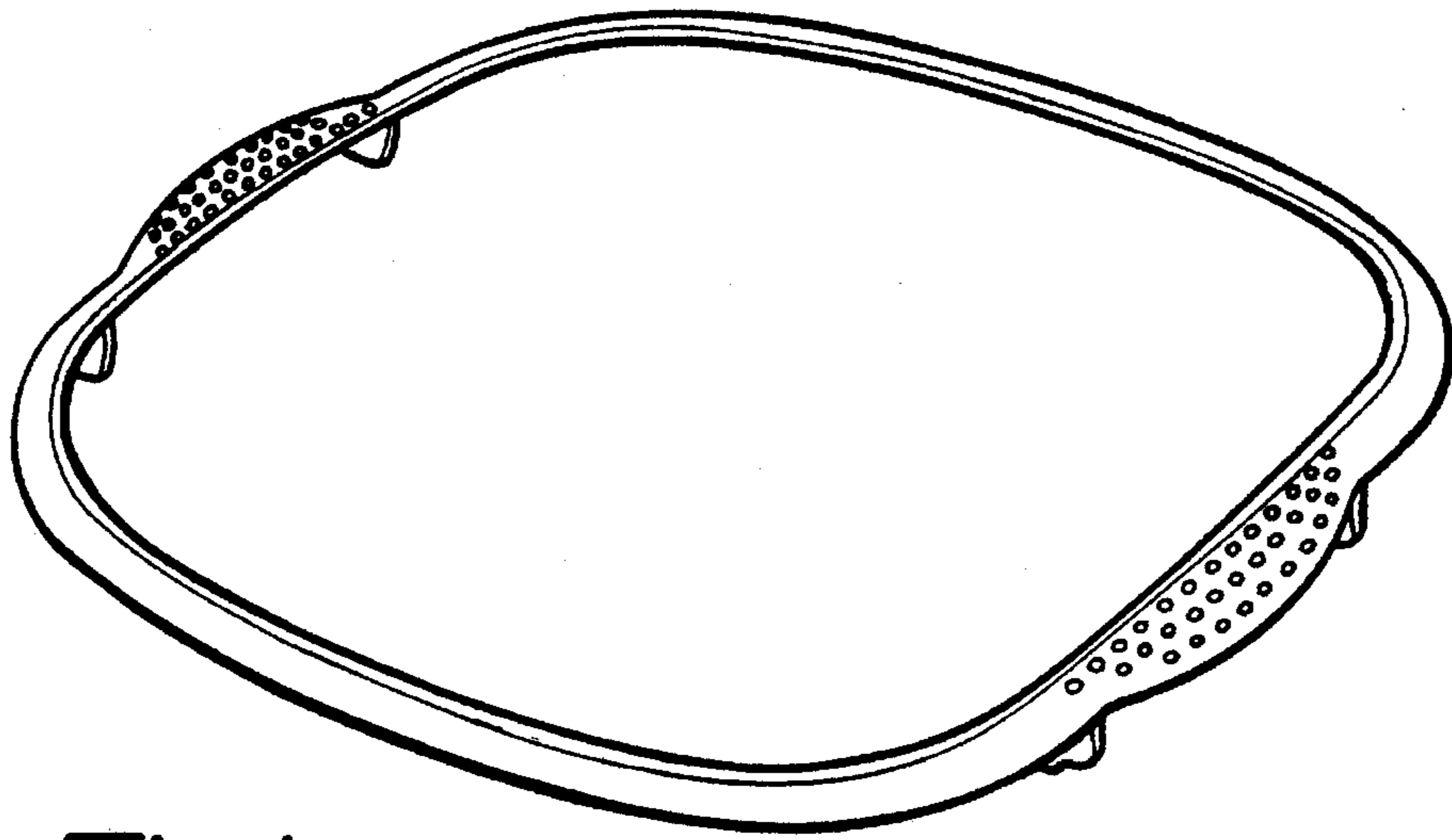

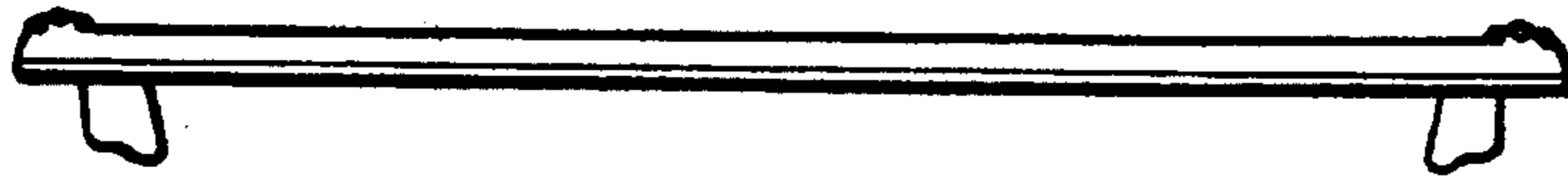

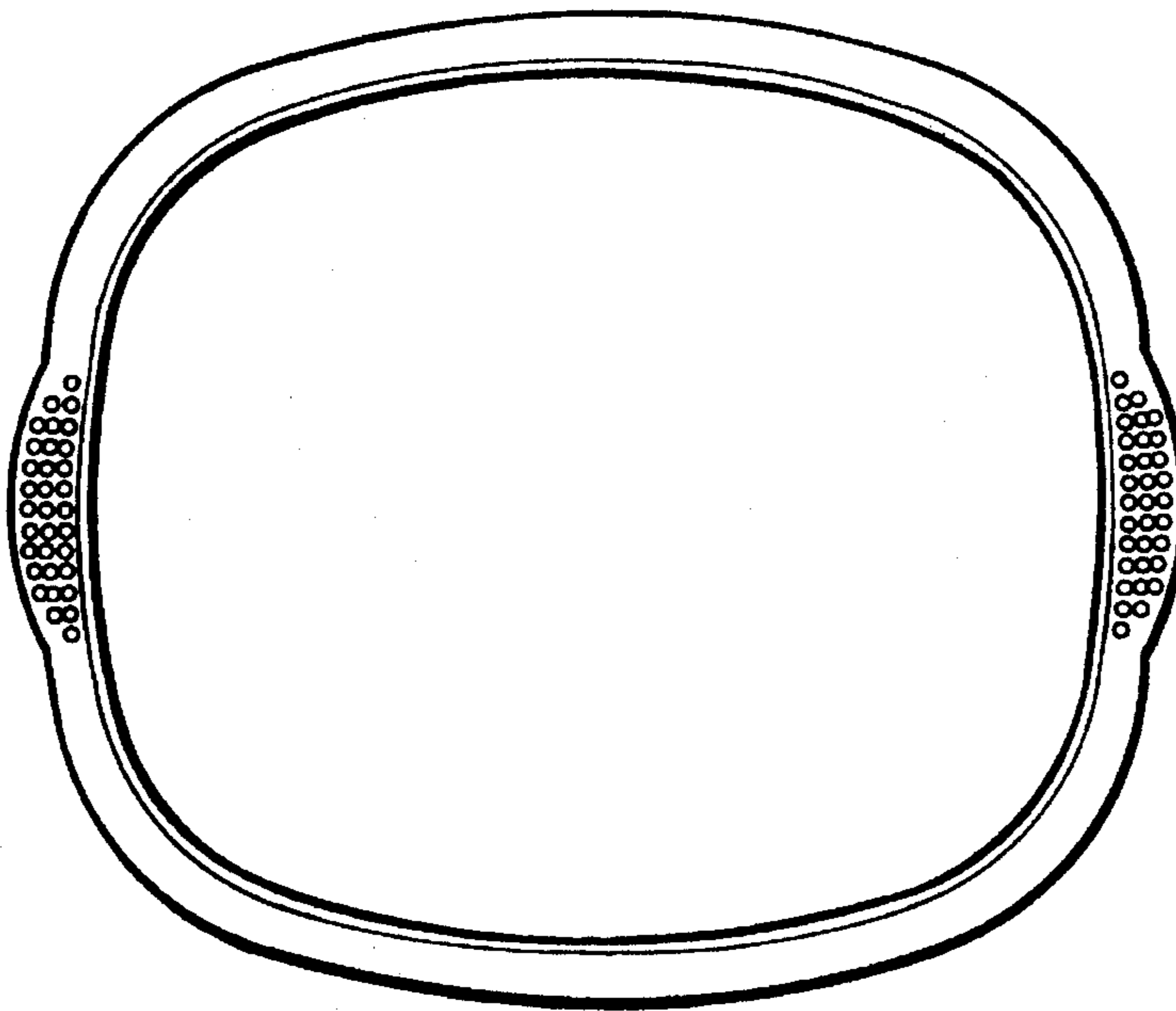

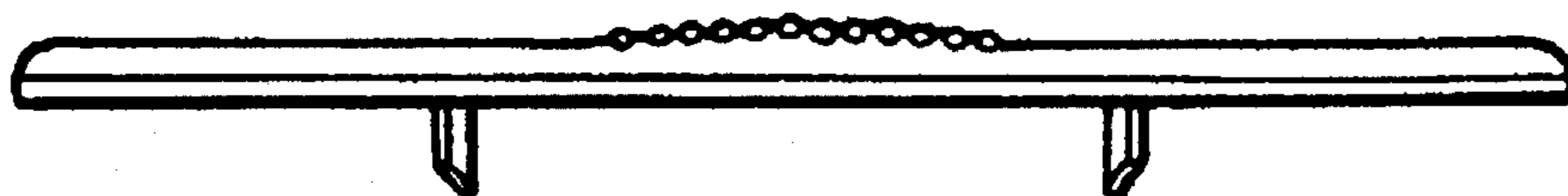

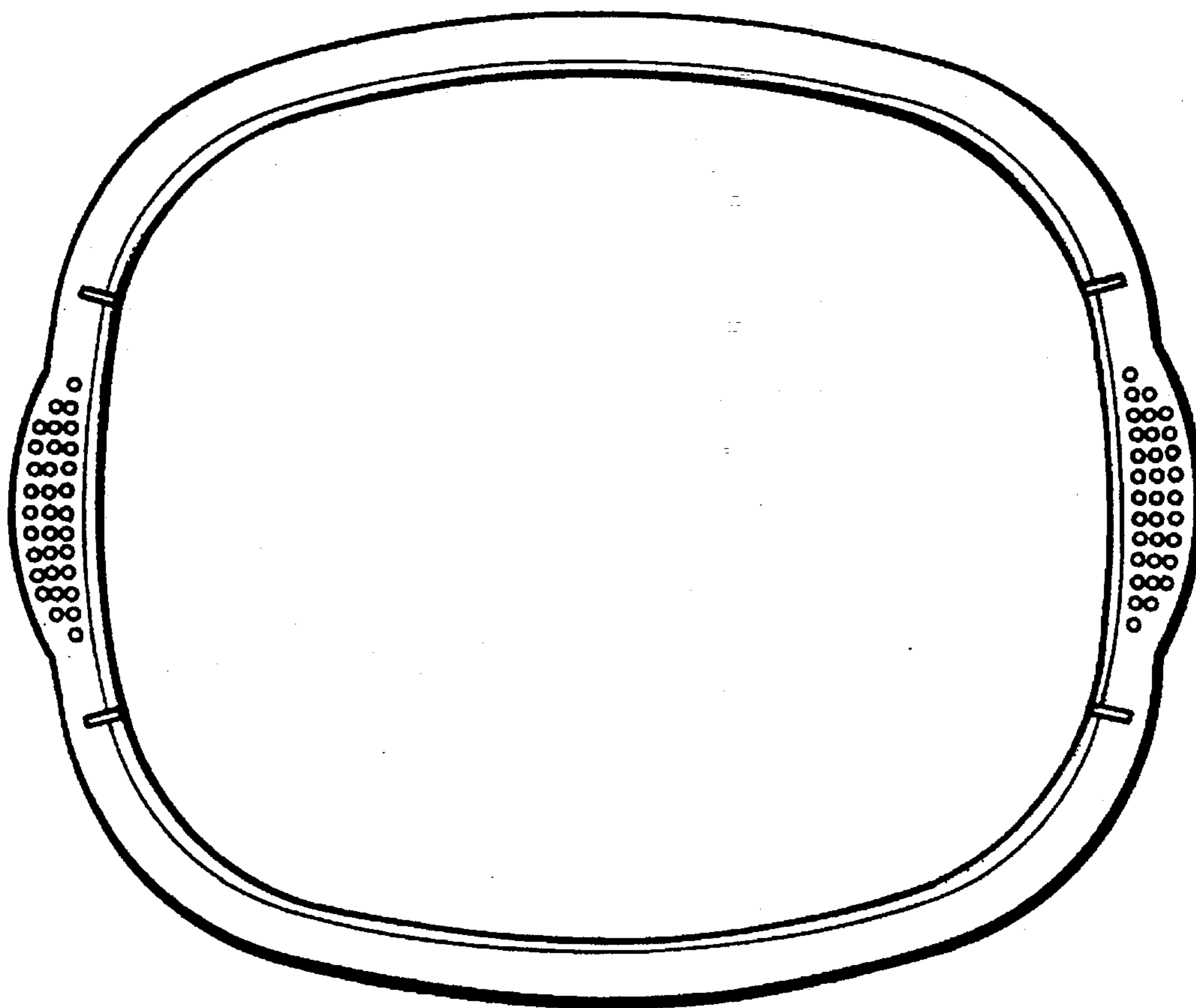
