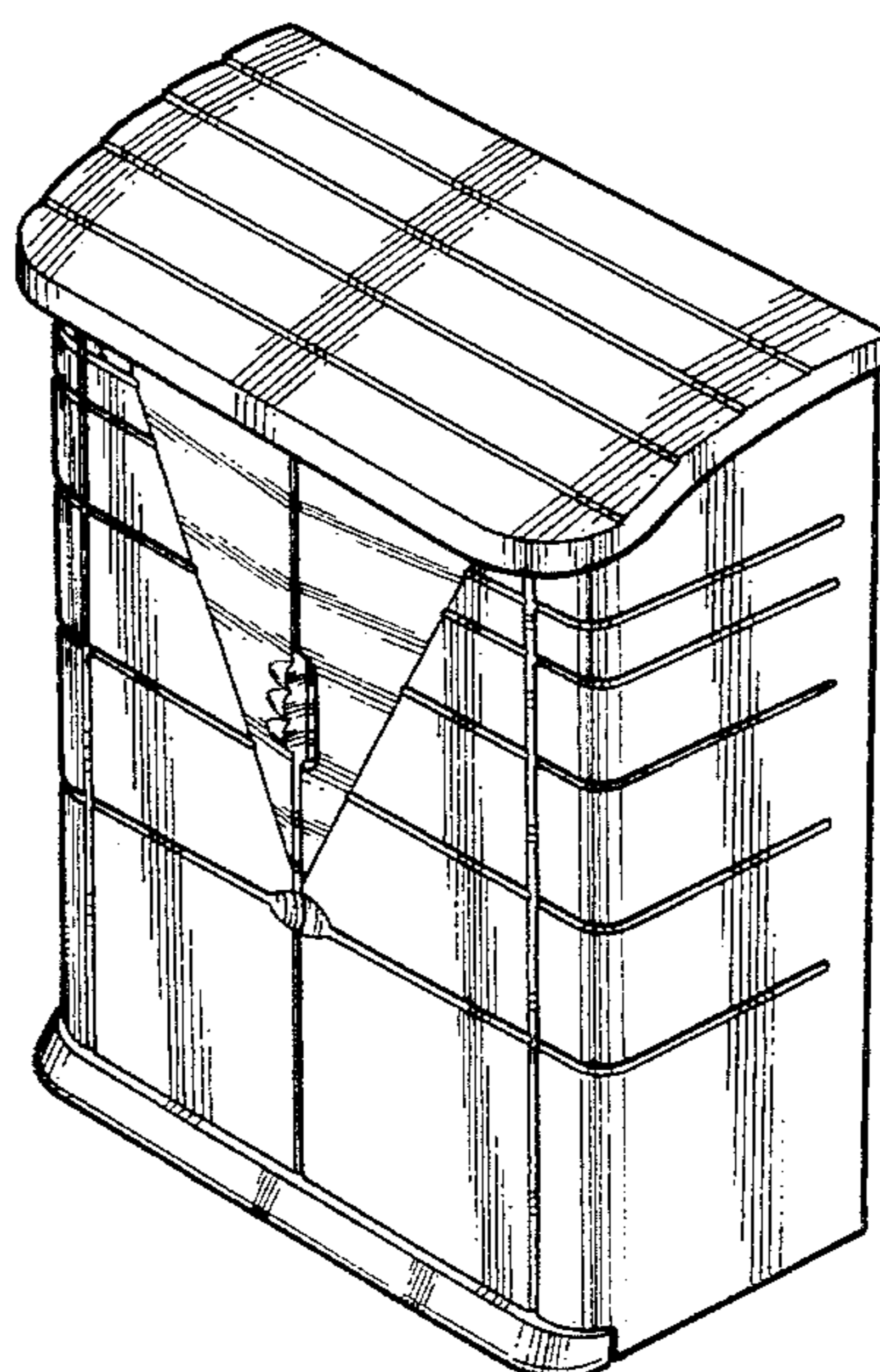
## [57] CLAIM

The ornamental design for an utility shed, as shown and described.

## DESCRIPTION

FIG. 1 is a top right front perspective view of an utility shed showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image;  
 FIG. 5 is a rear elevational view thereof; and,  
 FIG. 6 is a bottom plan view thereof.  
 The broken line showing of environment in FIG. 6 is for illustrative purposes only and forms no part of the claimed design.

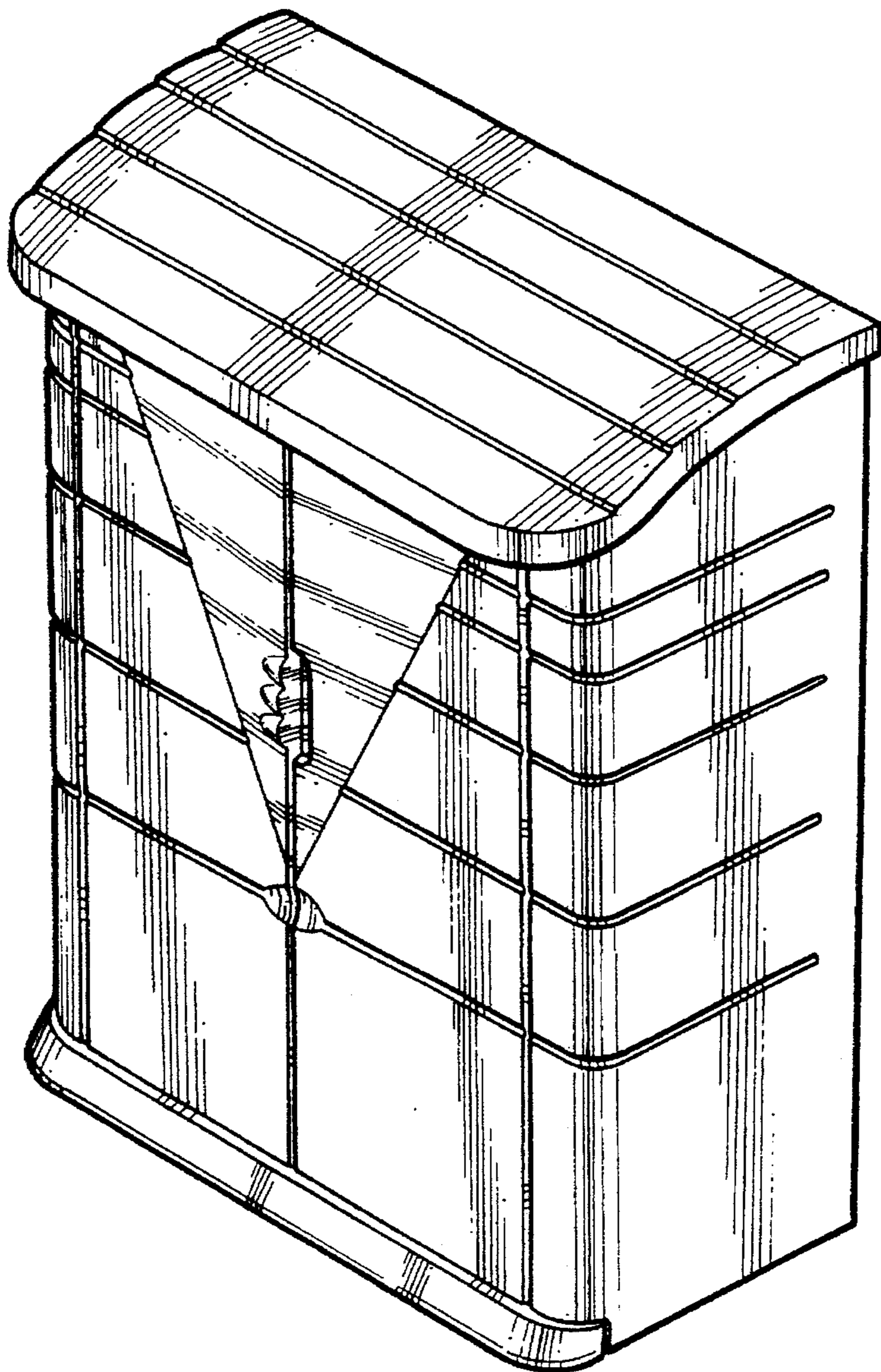

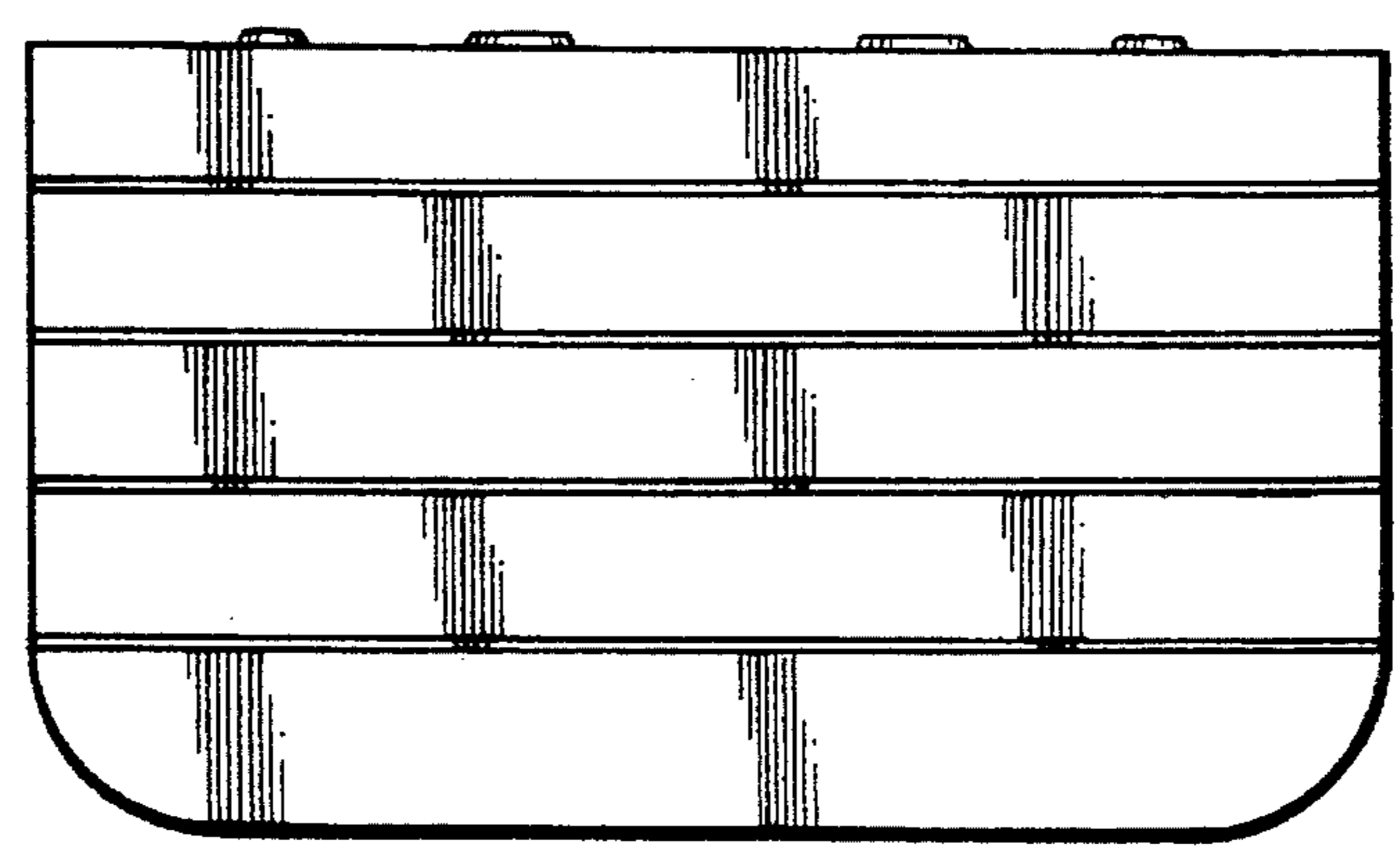

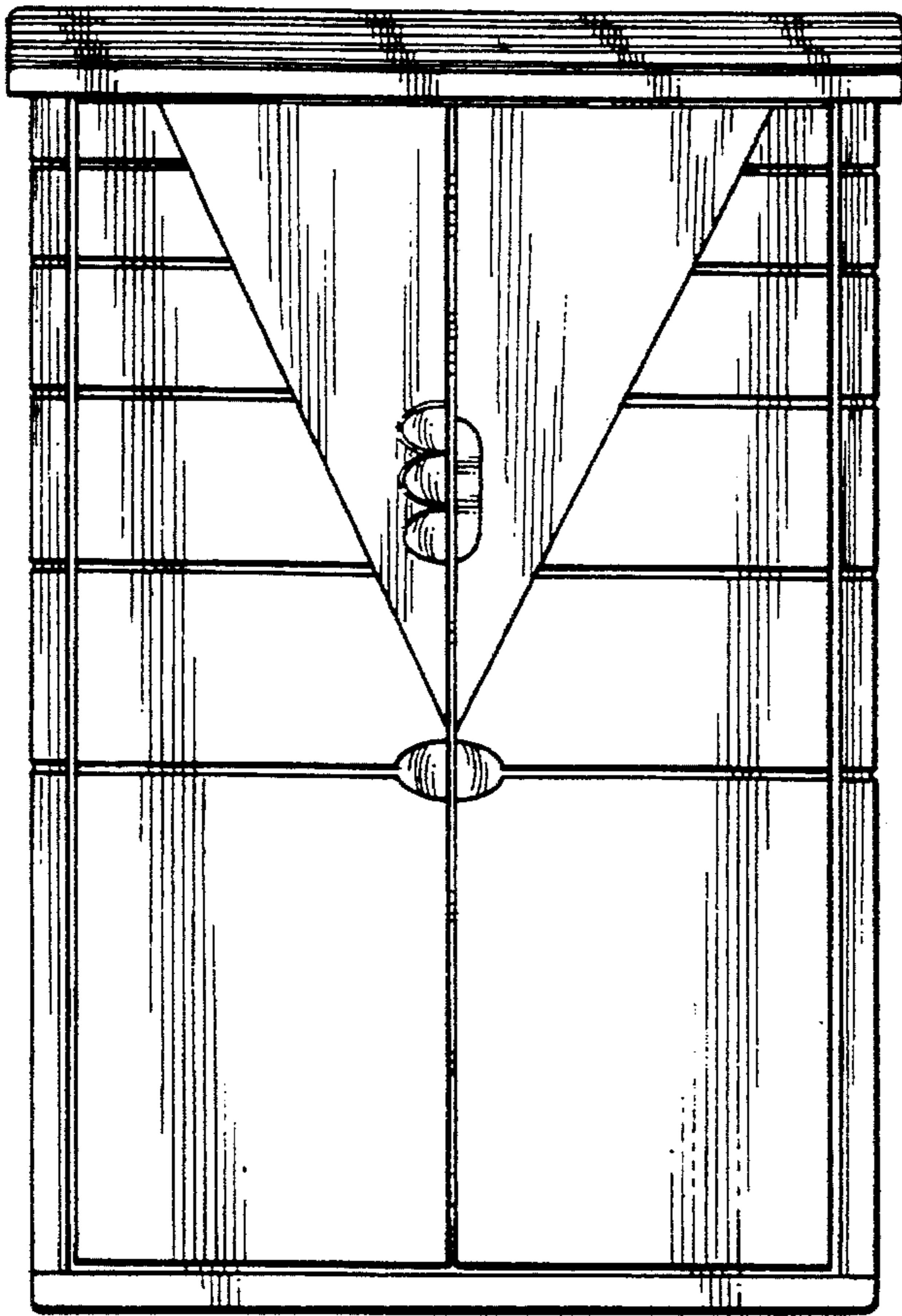

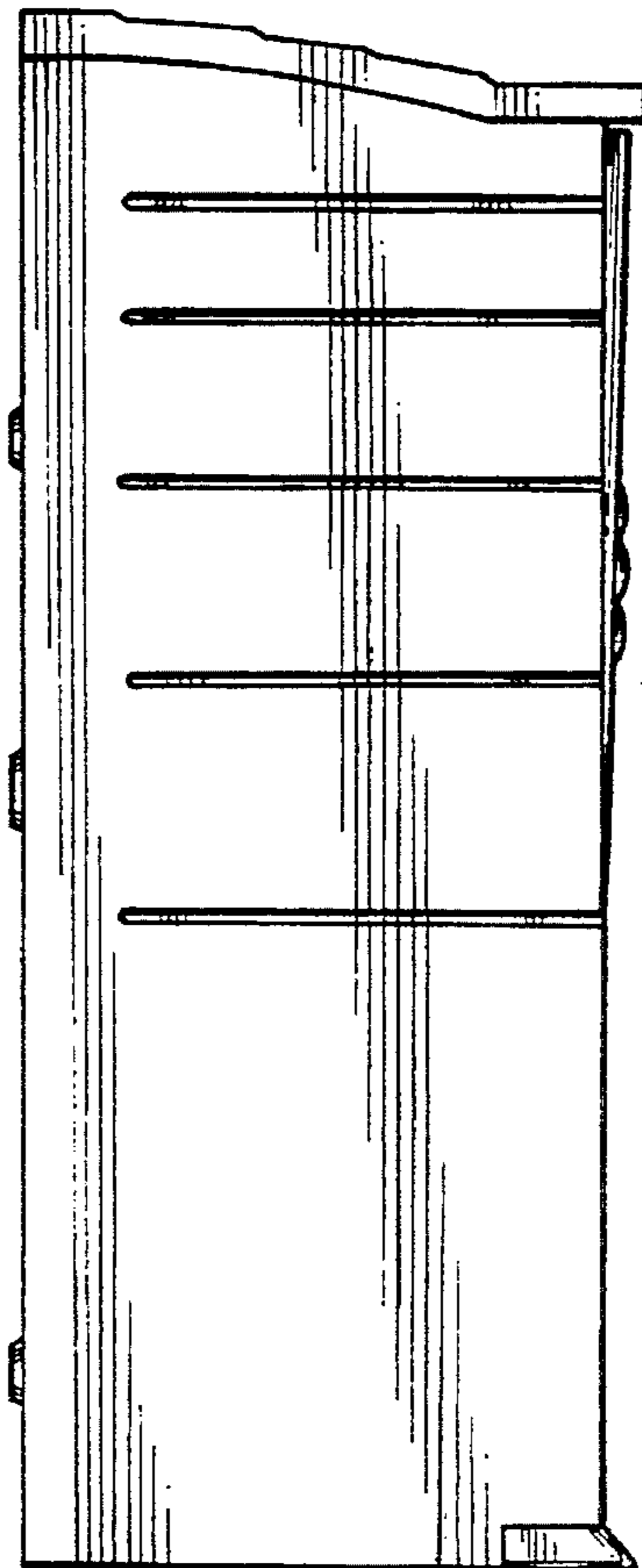

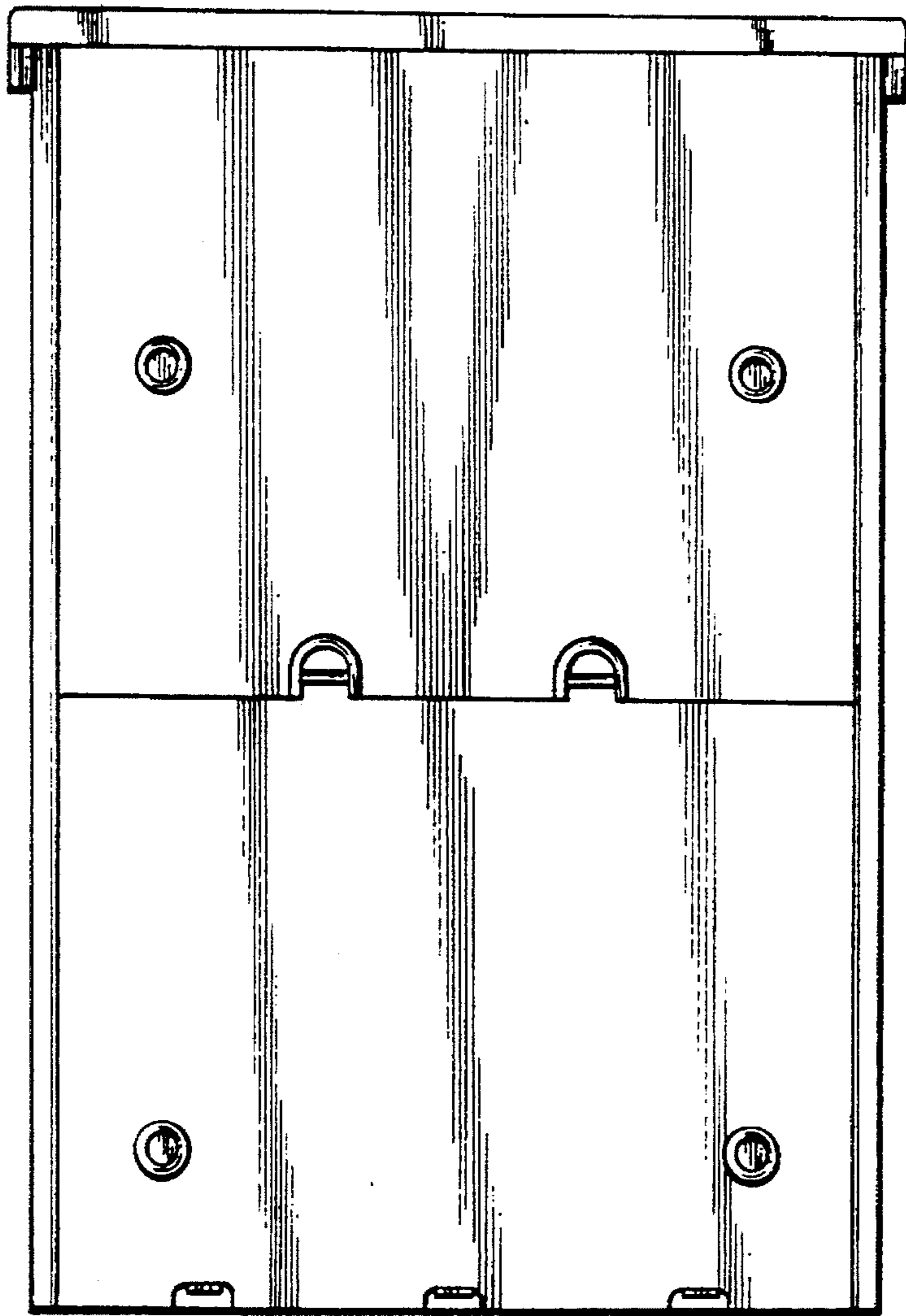

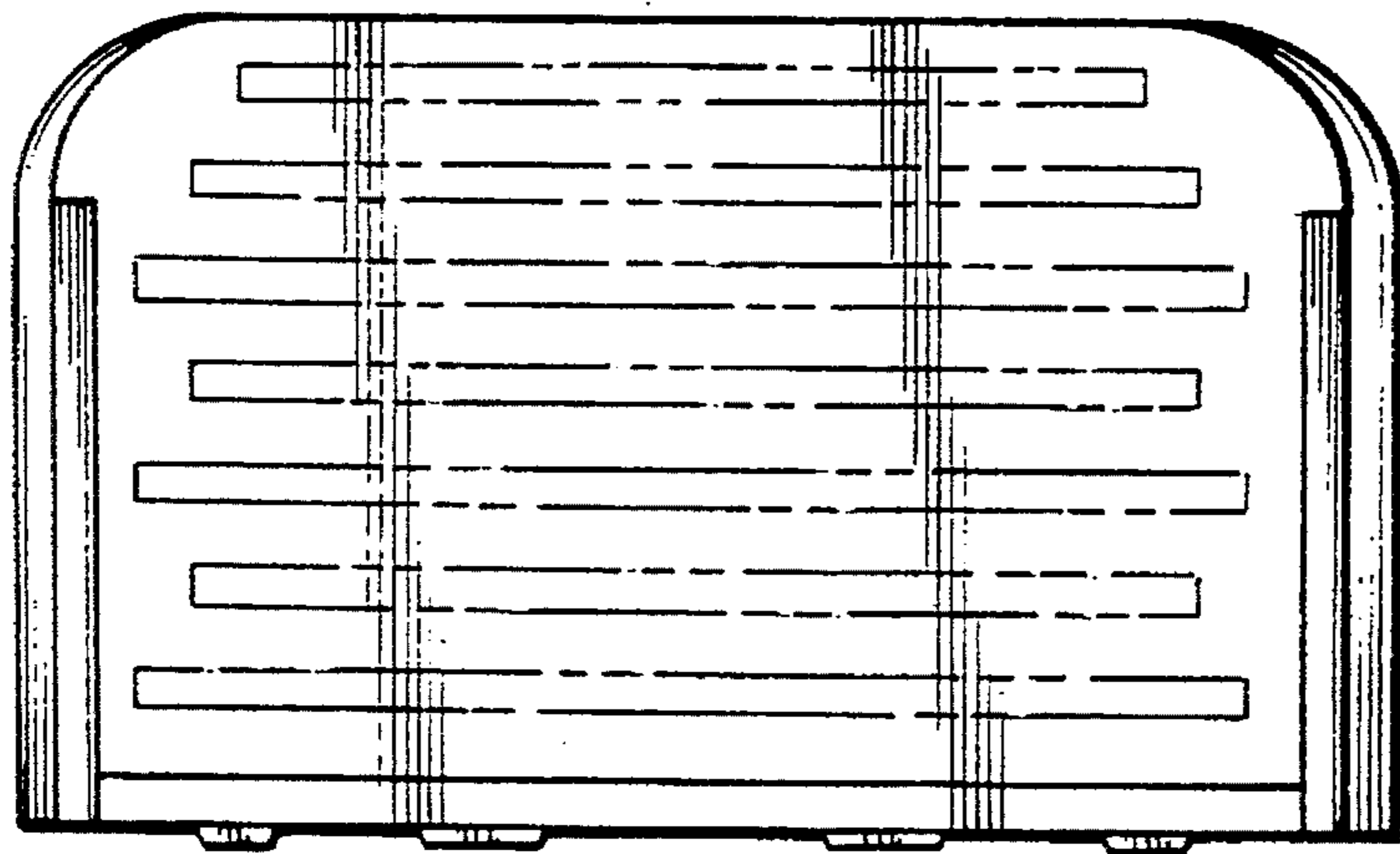
