The ornamental design for a CD storage tower, as shown and described.

## DESCRIPTION

FIG. 1 is a front, left, top perspective view of a CD storage

tower showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a front, left, top perspective view of a modified embodiment thereof;  
 FIG. 8 is a front elevational view thereof;  
 FIG. 9 is a top plan view thereof;  
 FIG. 10 is a right side elevational view thereof, the left side elevational view being a mirror image;  
 FIG. 11 is a rear elevational view thereof;  
 FIG. 12 is a bottom plan view thereof;  
 FIG. 13 is a sectional view thereof taken along the line 13—13 in FIG. 8;  
 FIG. 14 is a front, left, top perspective view of a further modified embodiment thereof;  
 FIG. 15 is a front elevational view thereof, the rear elevational view being identical;  
 FIG. 16 is a top plan view thereof;  
 FIG. 17 is a right side elevational view thereof, the left side elevational view being identical;  
 FIG. 18 is a bottom plan view thereof;  
 FIG. 19 is a sectional view thereof taken along the line 19—19 in FIG. 15;  
 FIG. 20 is a front, left, top perspective view of another modified embodiment thereof;  
 FIG. 21 is a front elevational view thereof;  
 FIG. 22 is a top plan view thereof;  
 FIG. 23 is a right side elevational view thereof, the left side elevational view being a mirror image;  
 FIG. 24 is a rear elevational view thereof; and,  
 FIG. 25 is a bottom plan view thereof.

The broken line showing of compact discs in FIGS. 1, 7, 14 and 20 is for illustrative purposes only and forms no part of the claimed design.

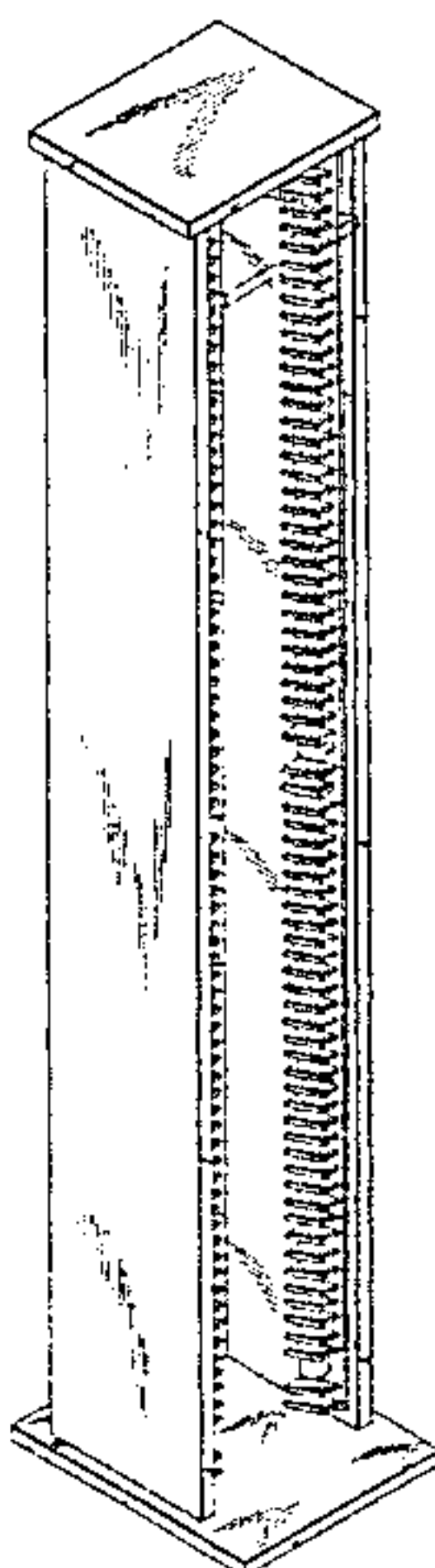

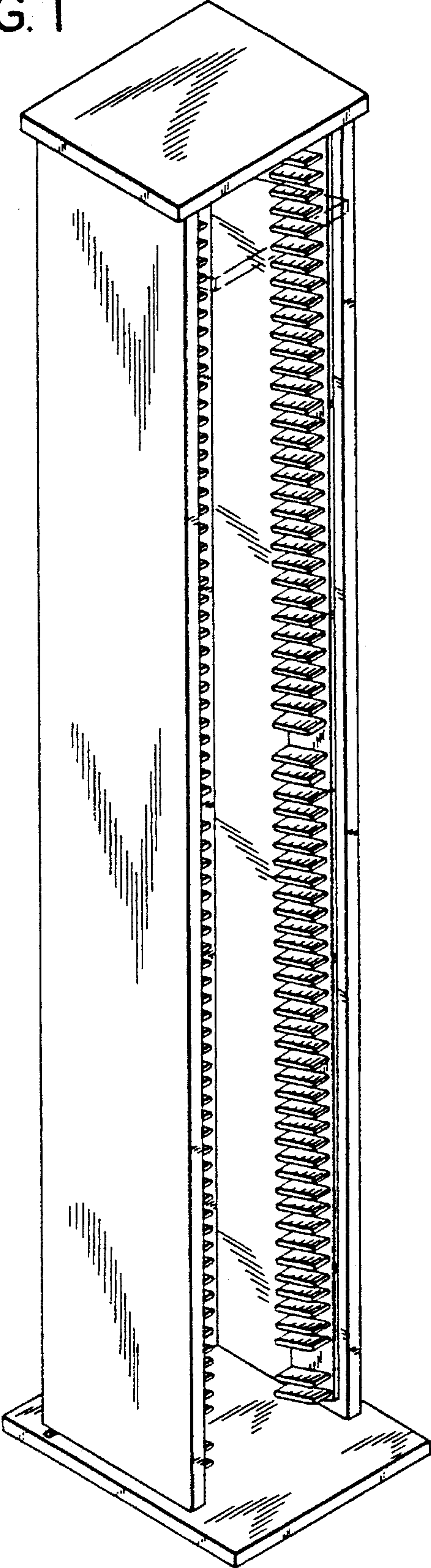

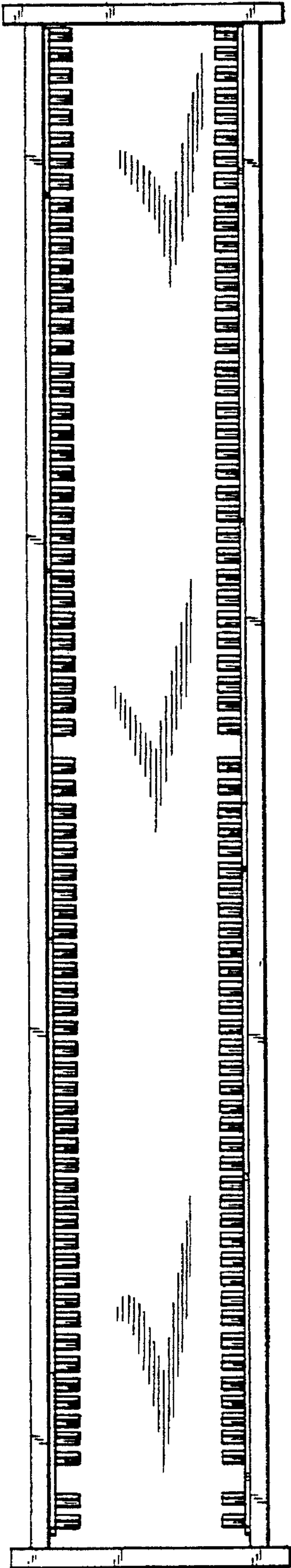

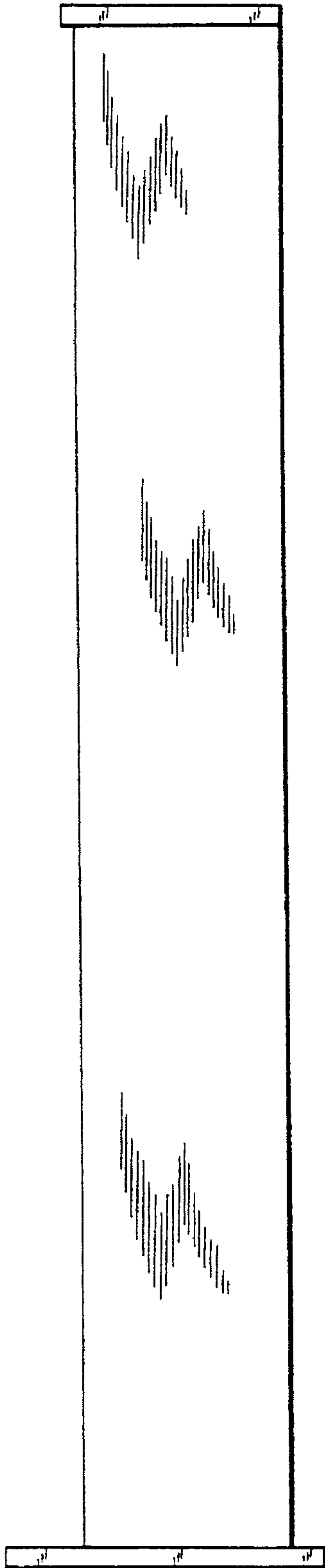

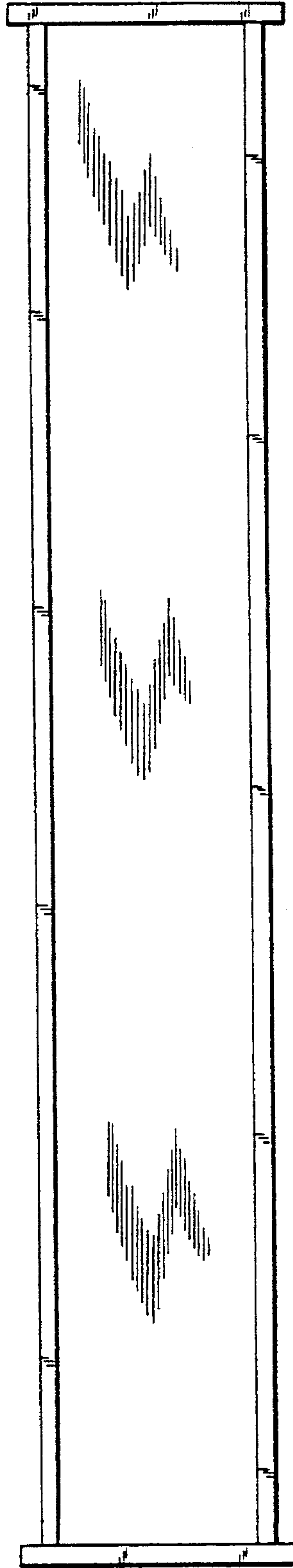

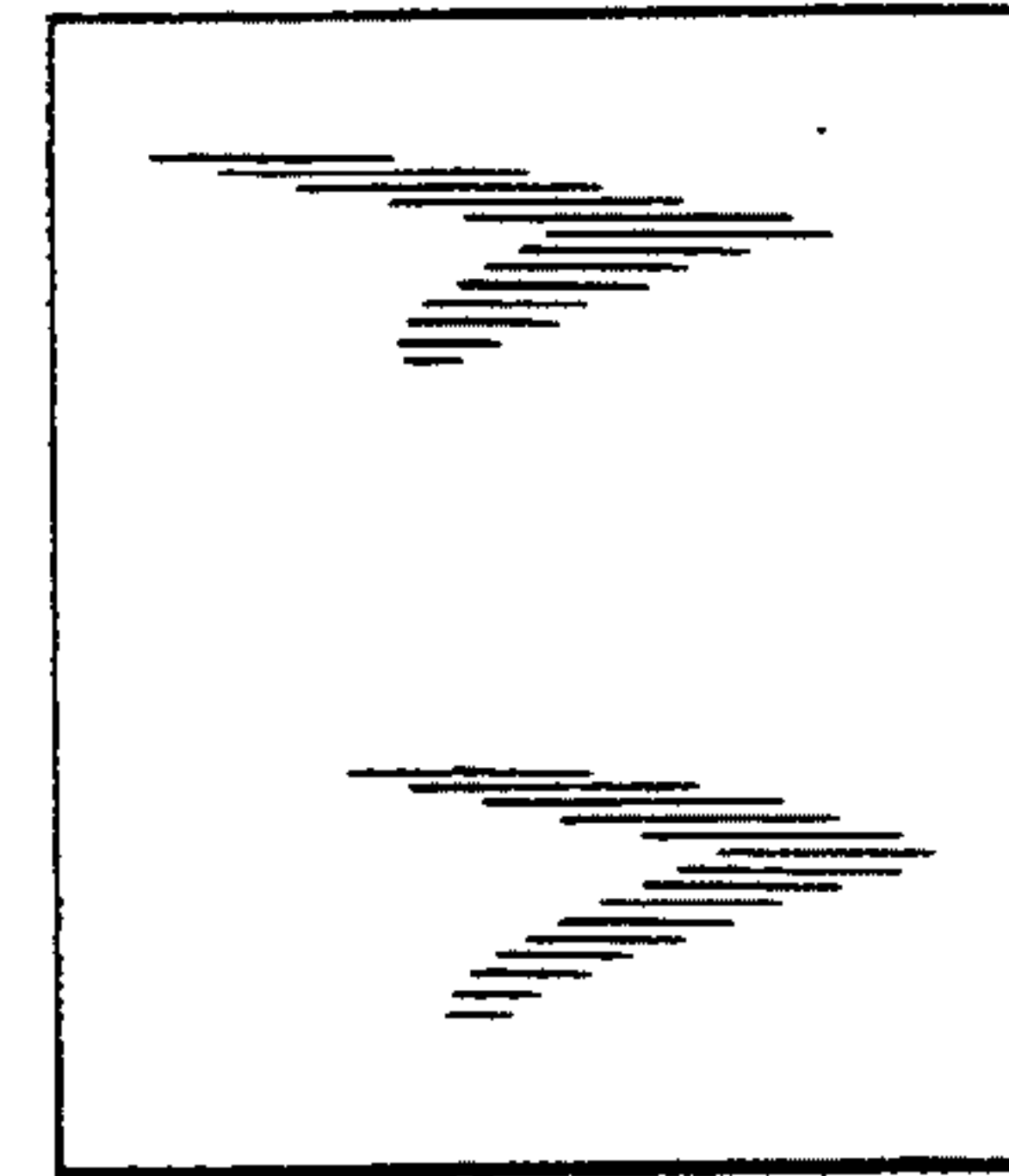
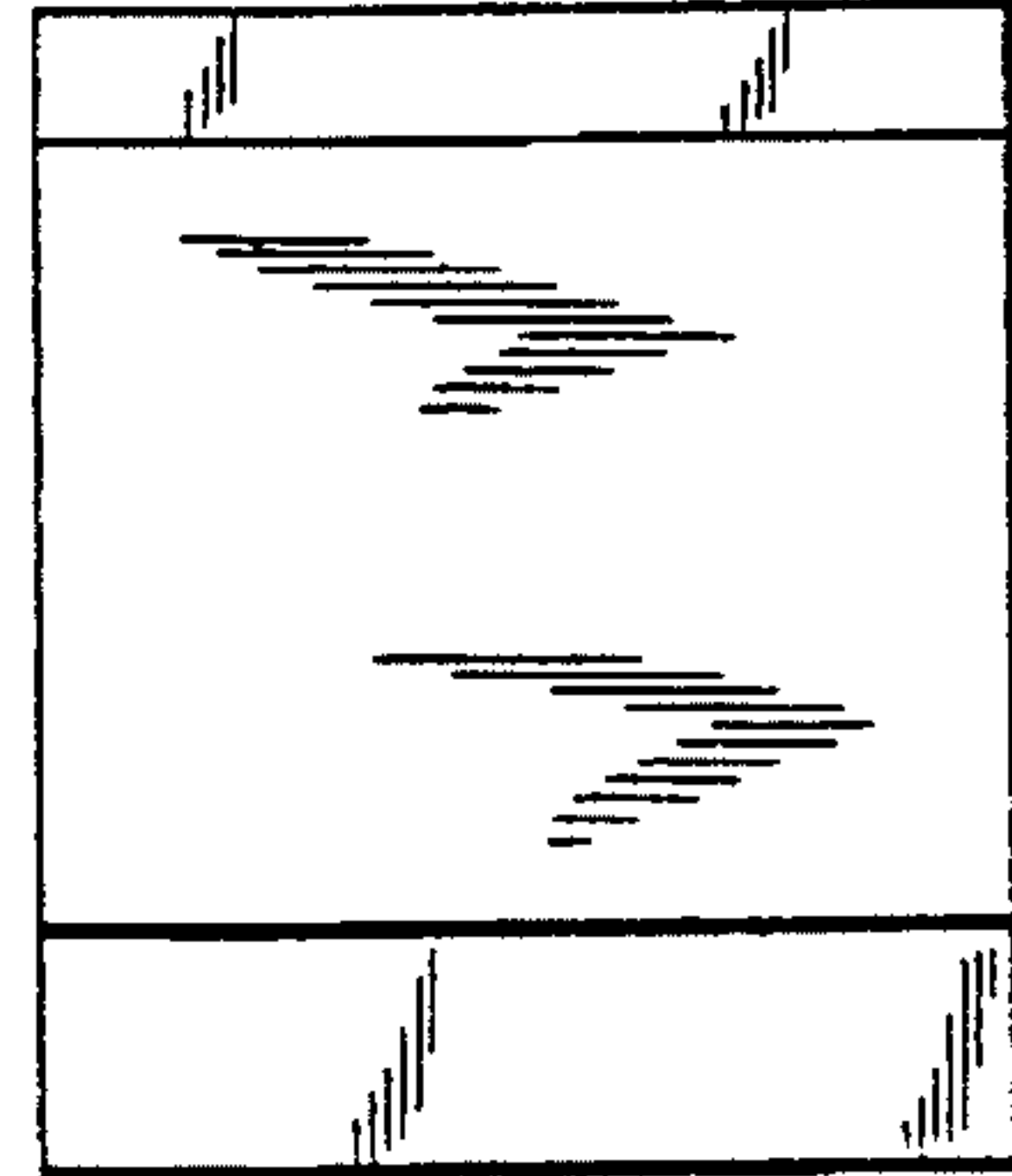

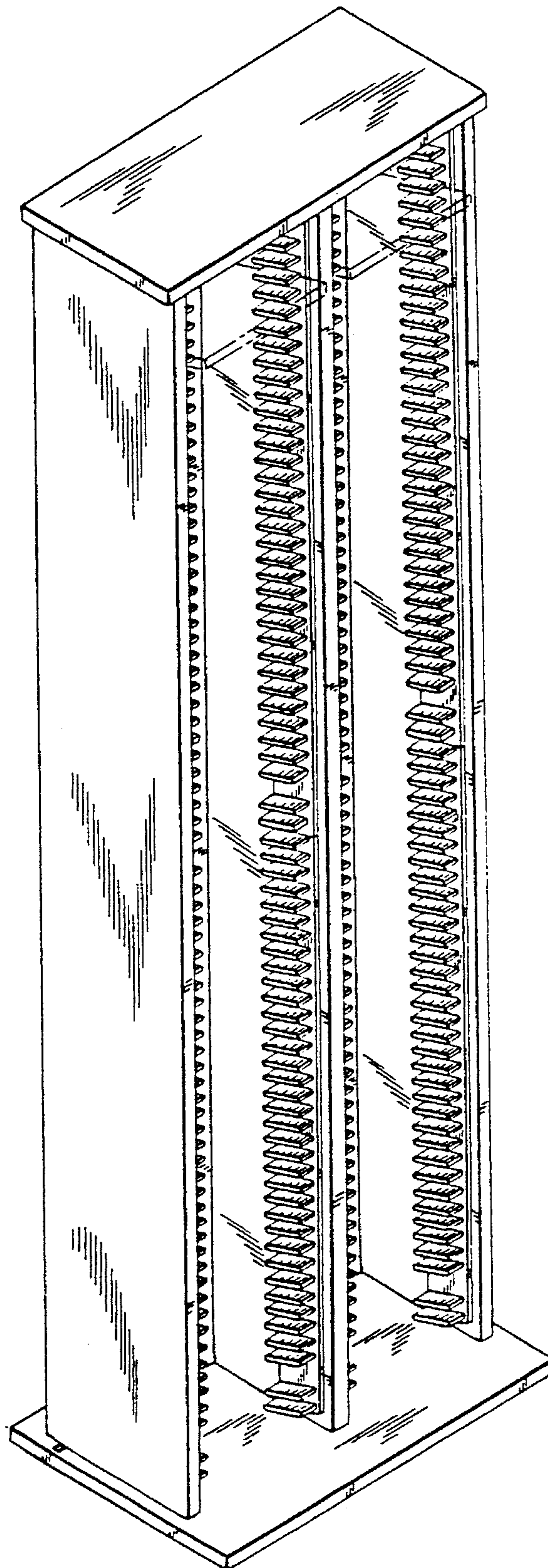

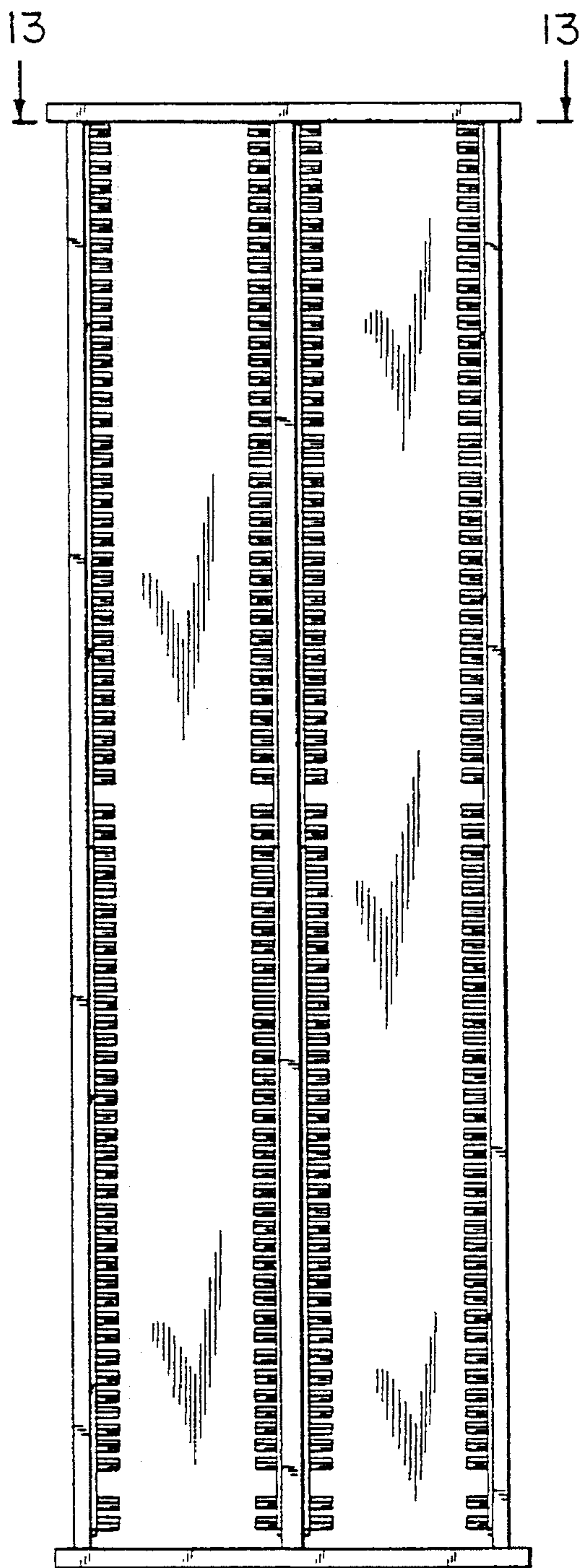

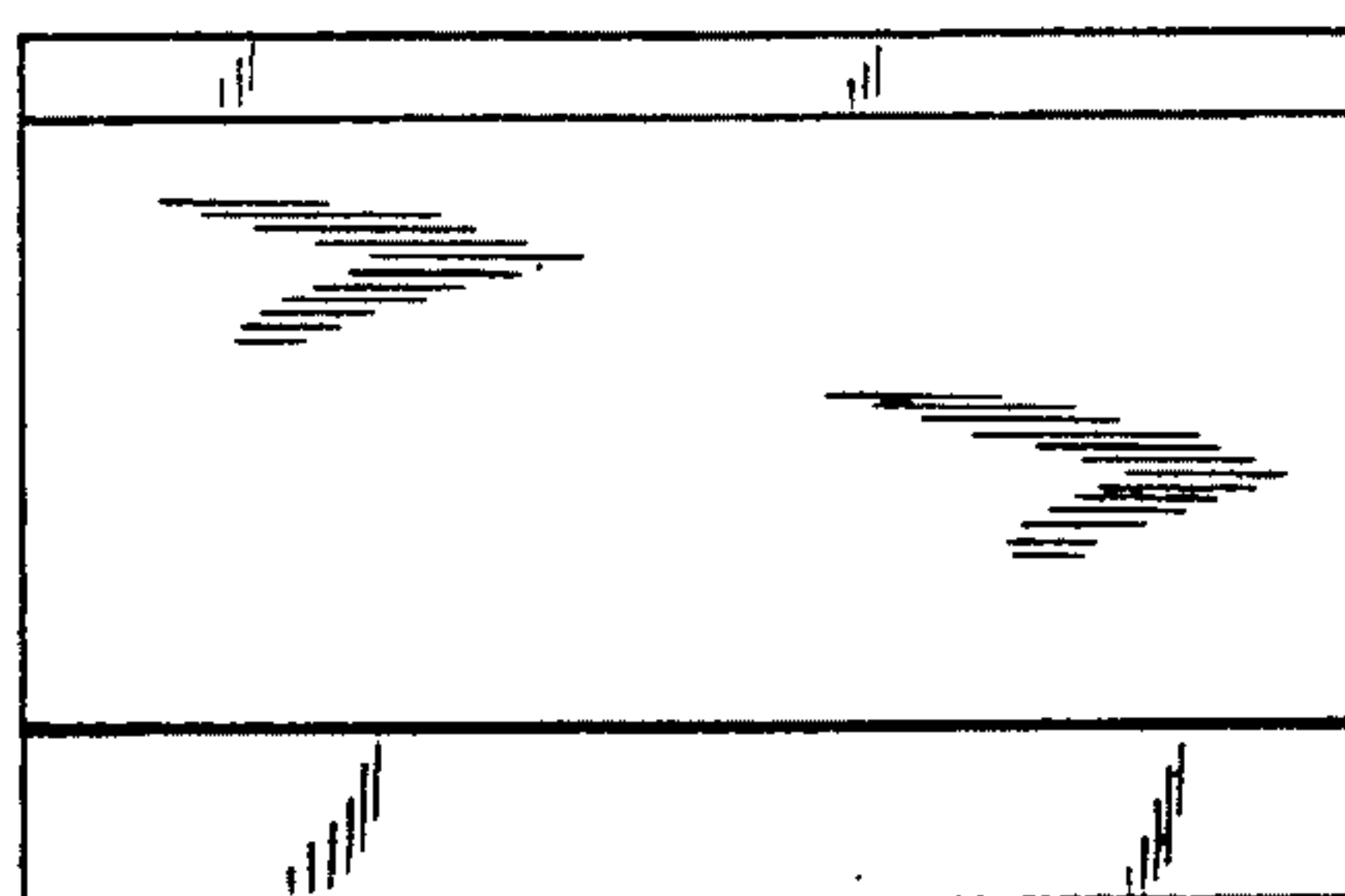

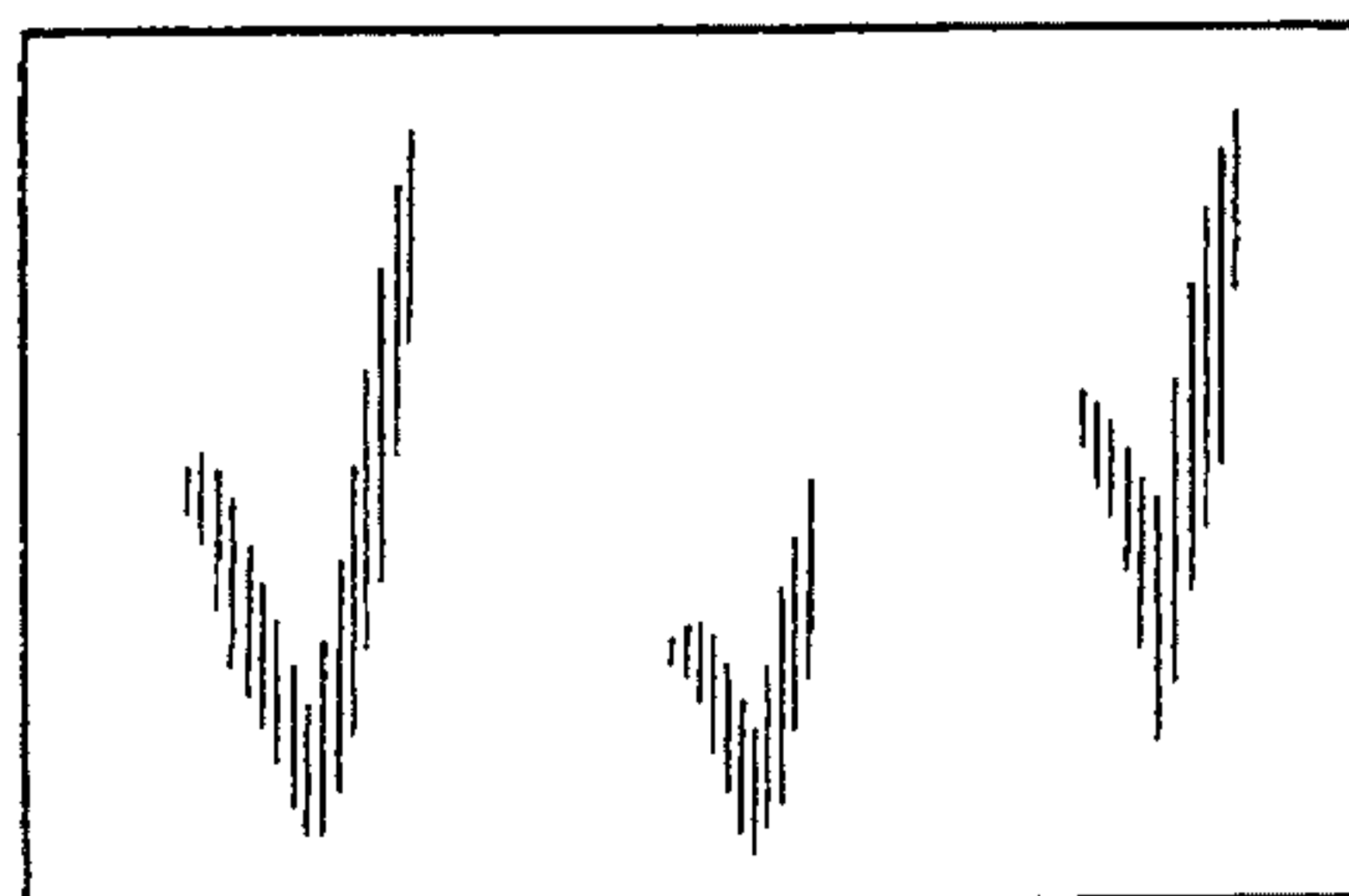

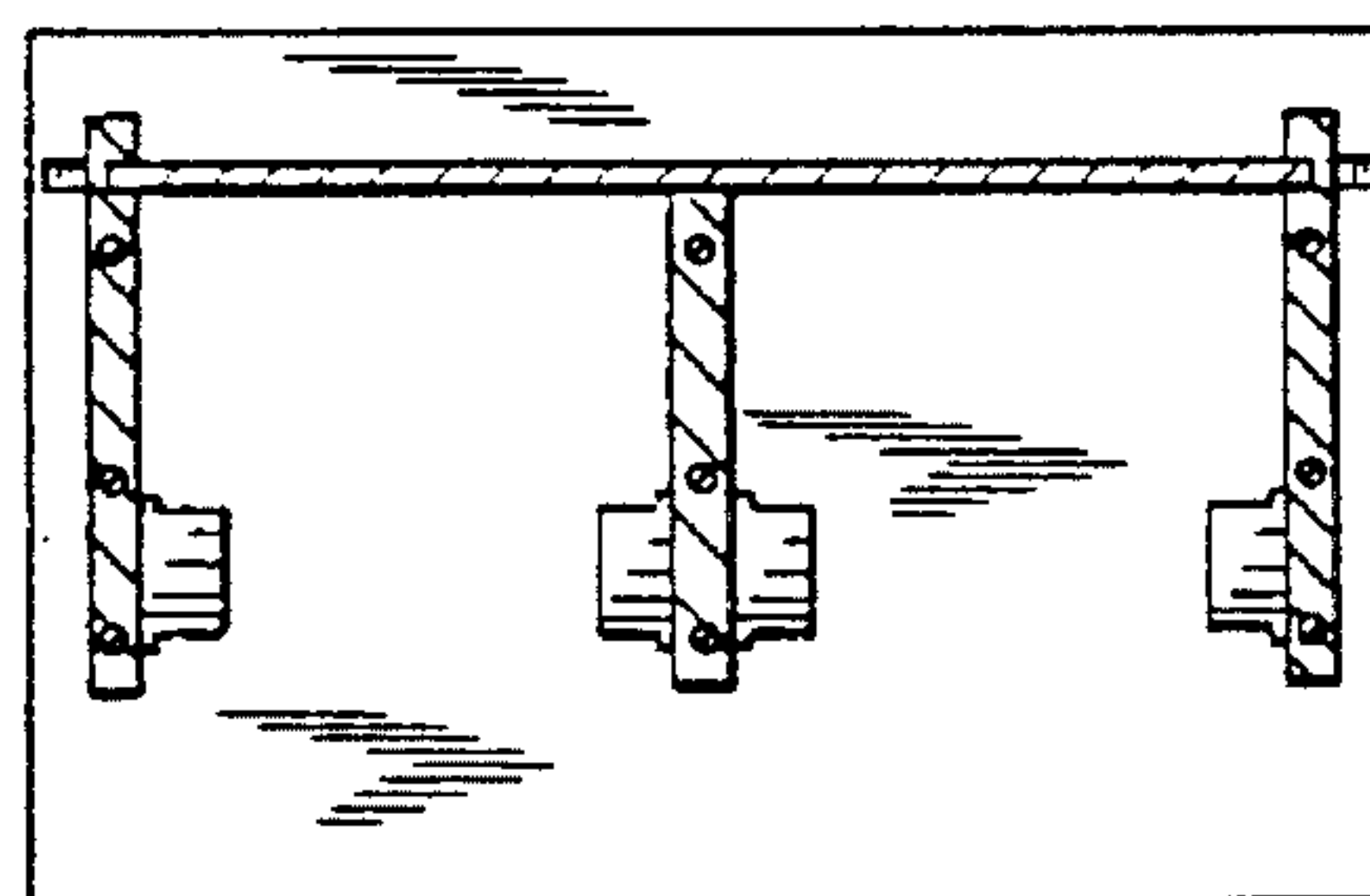

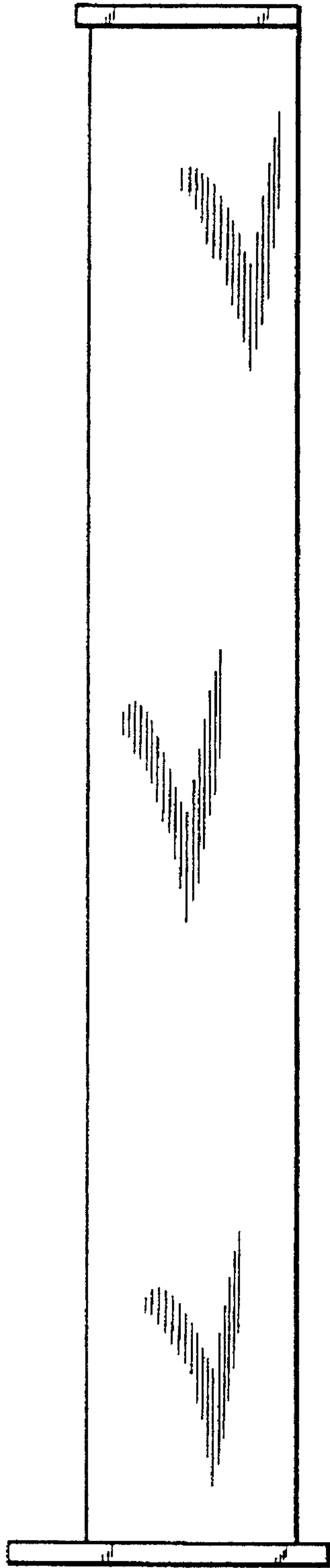
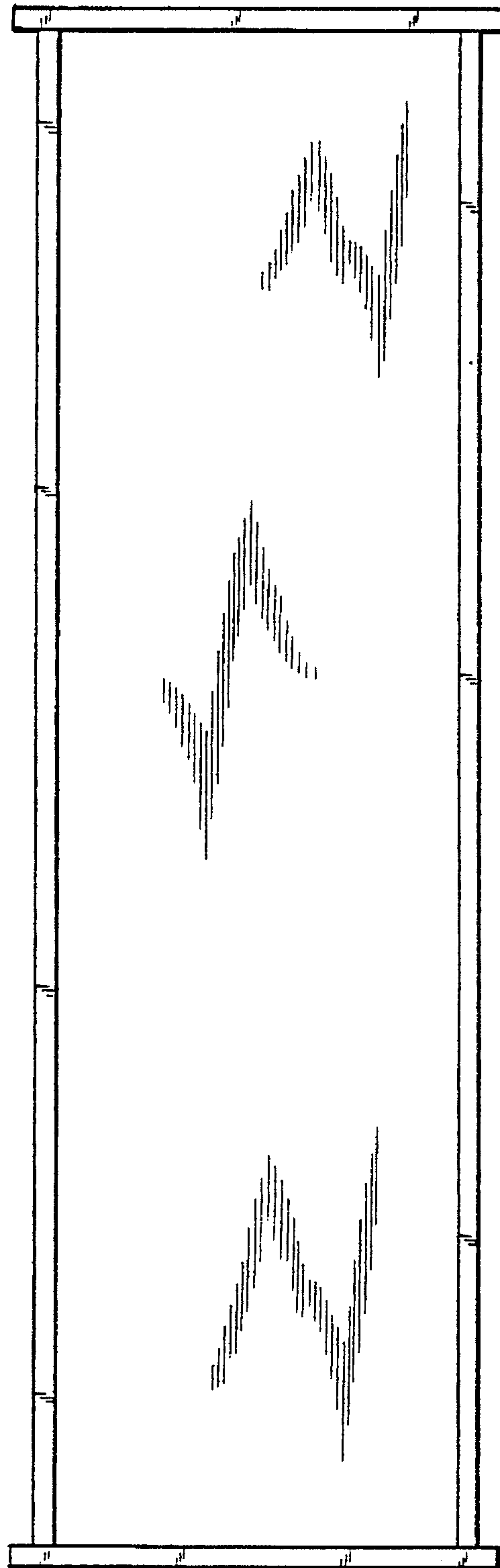

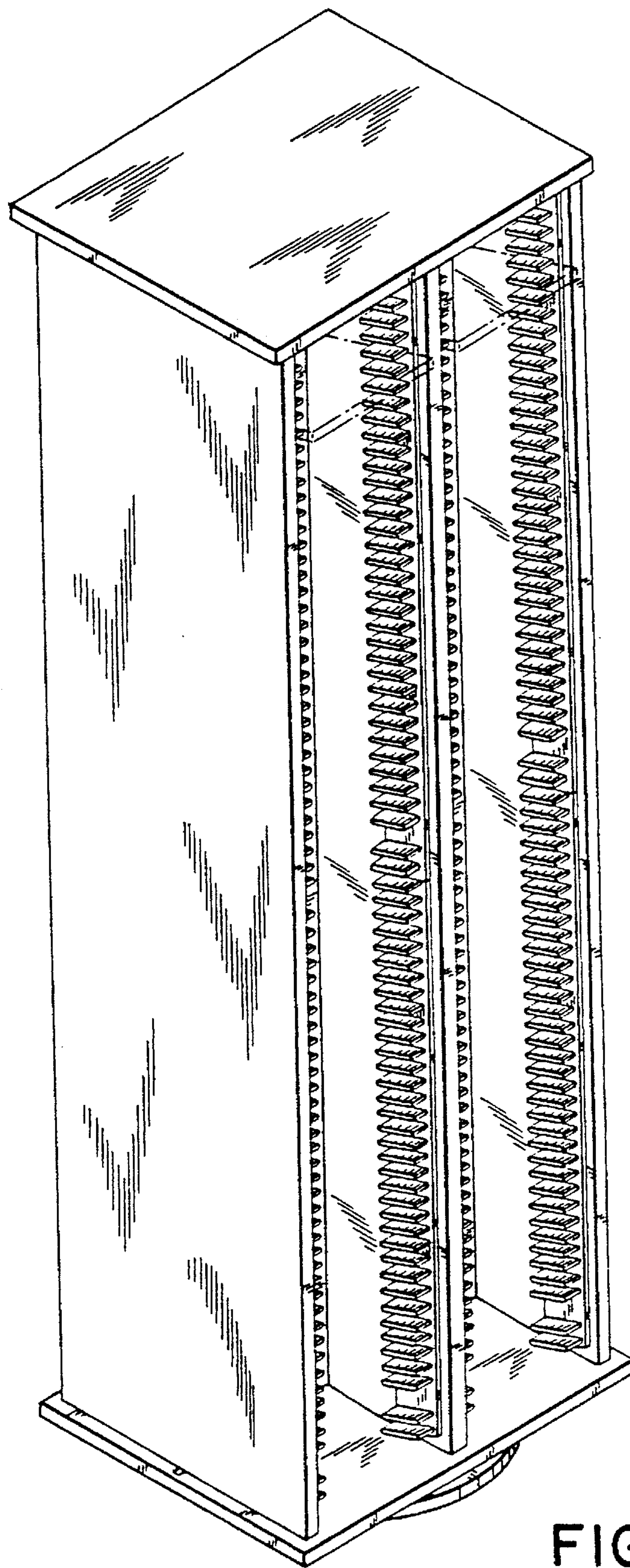

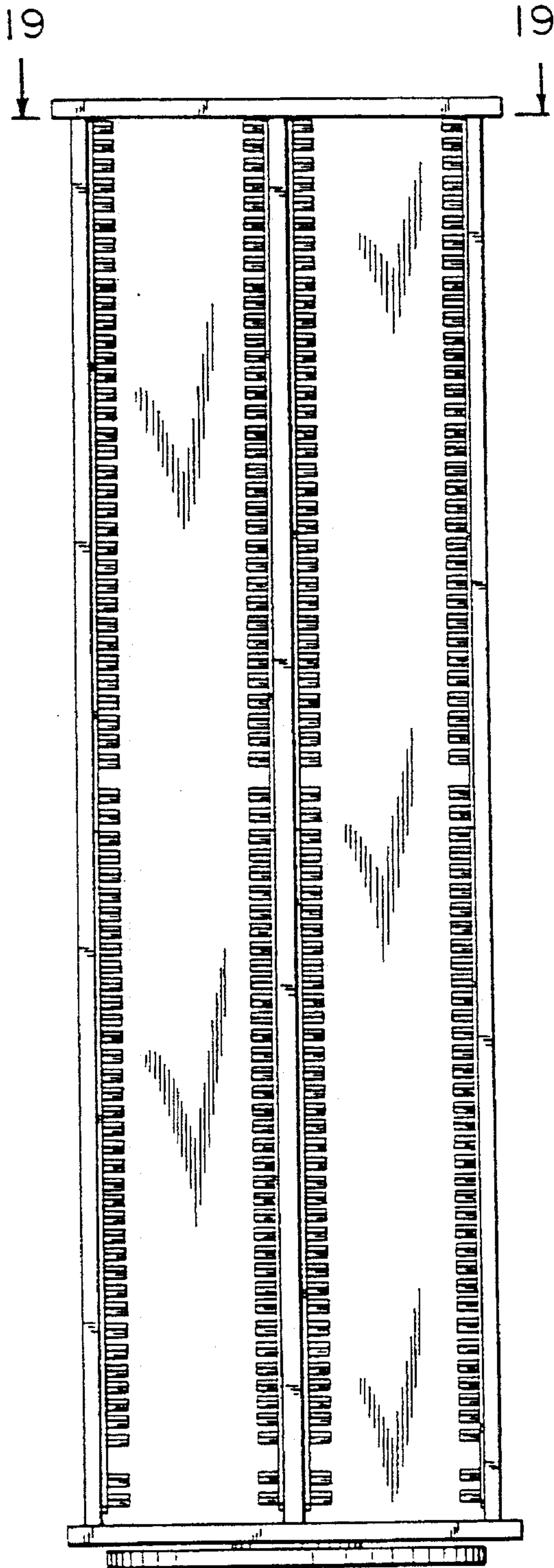

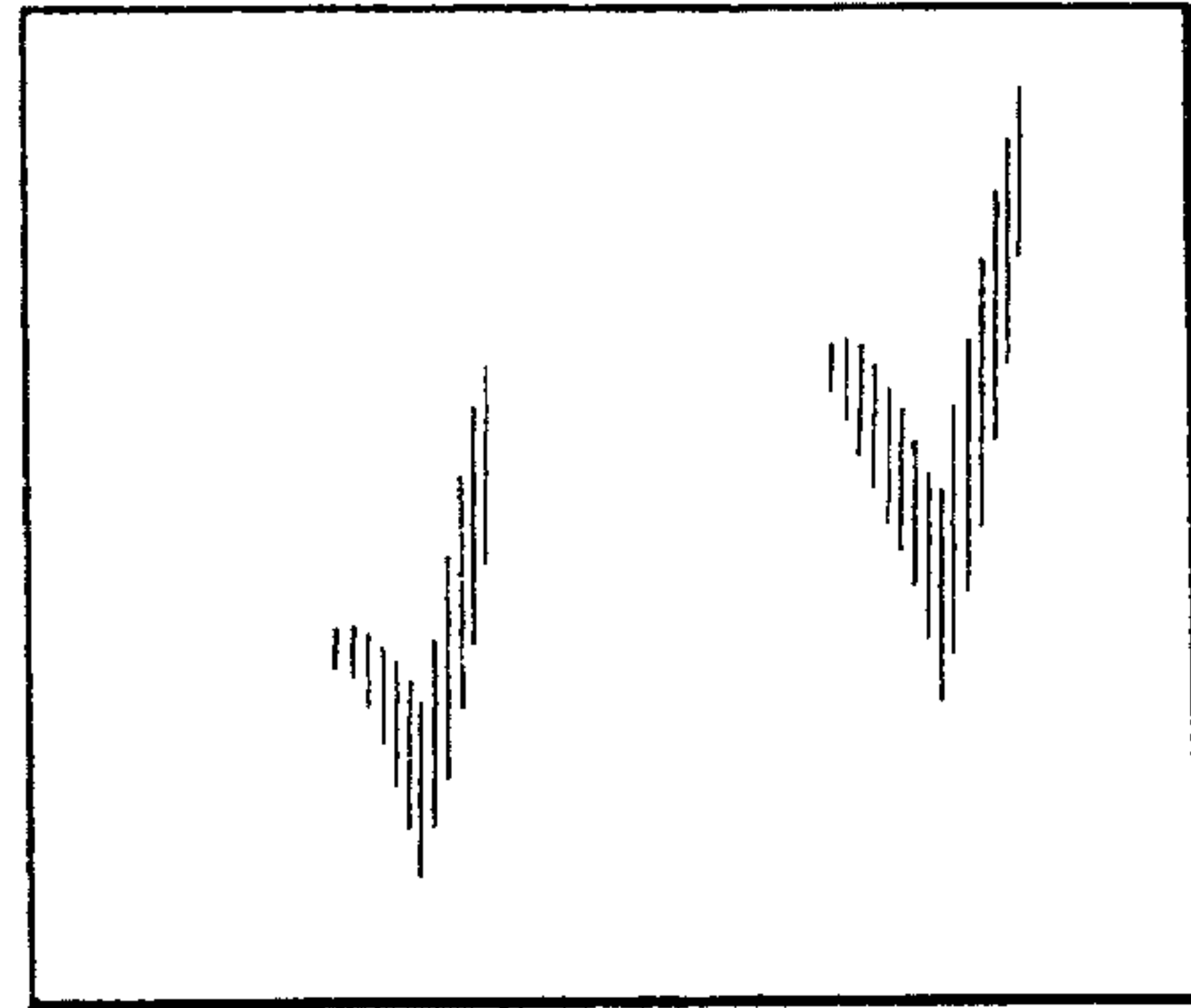

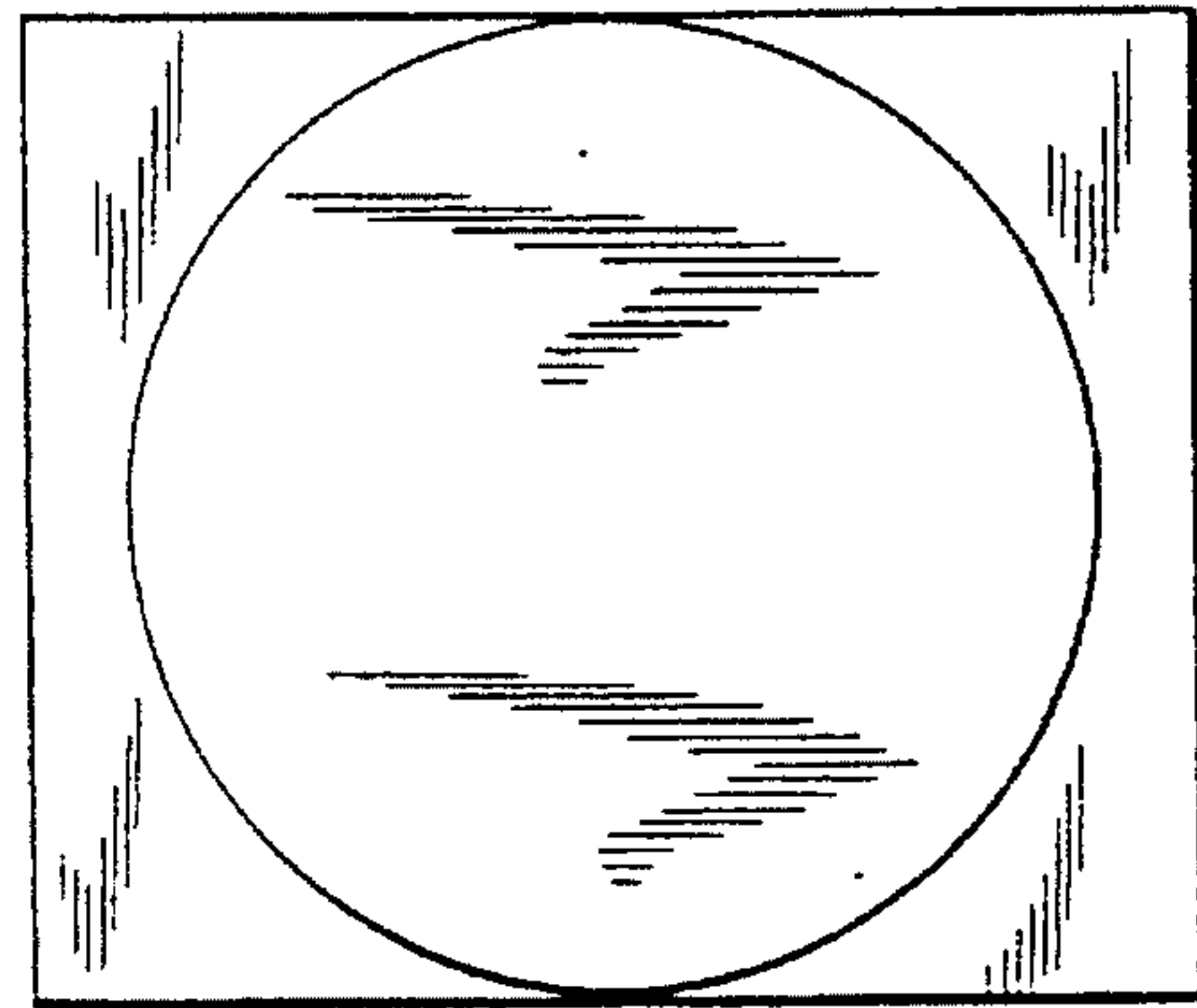

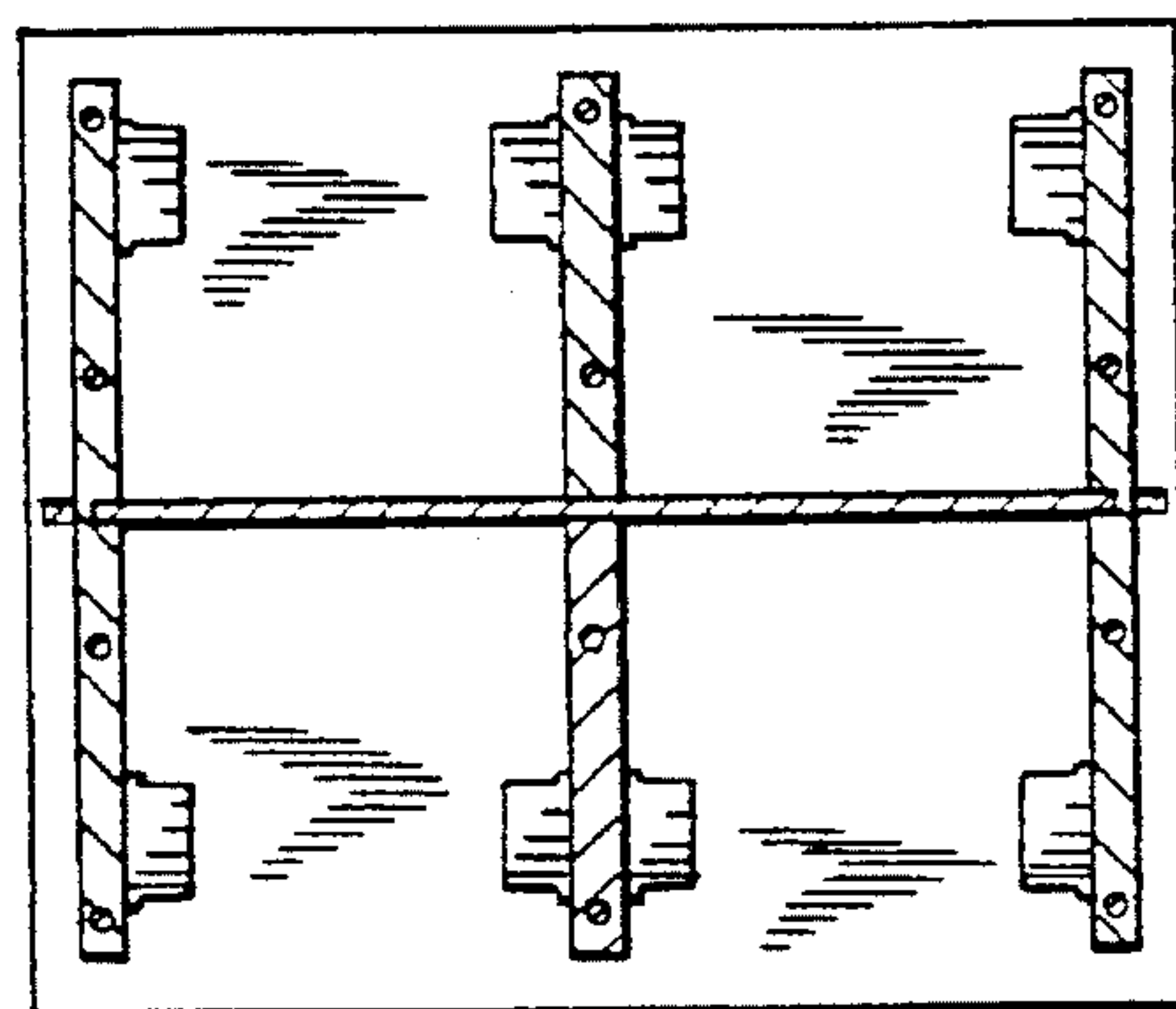

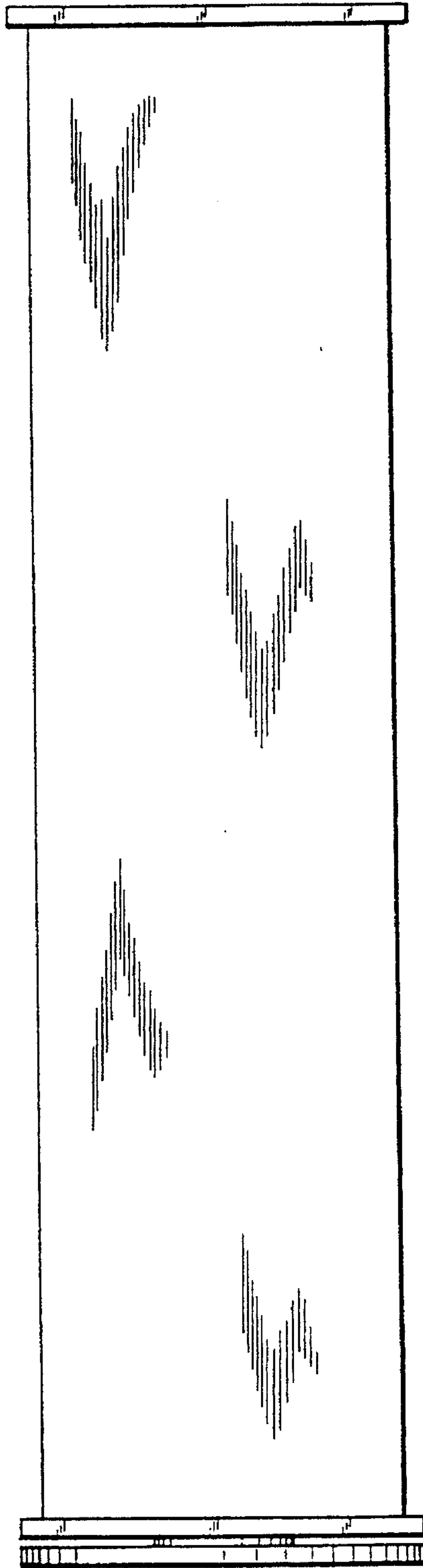

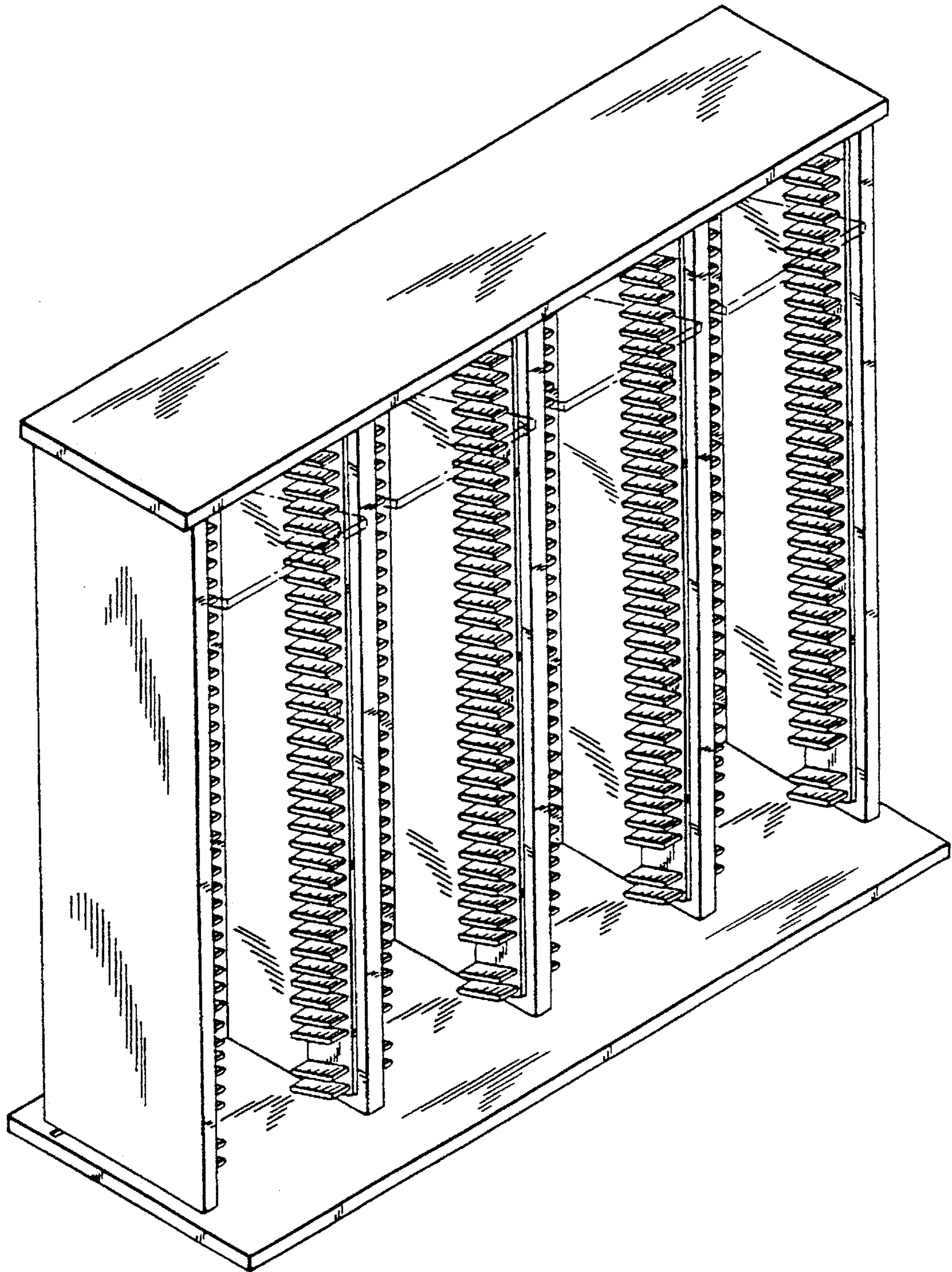

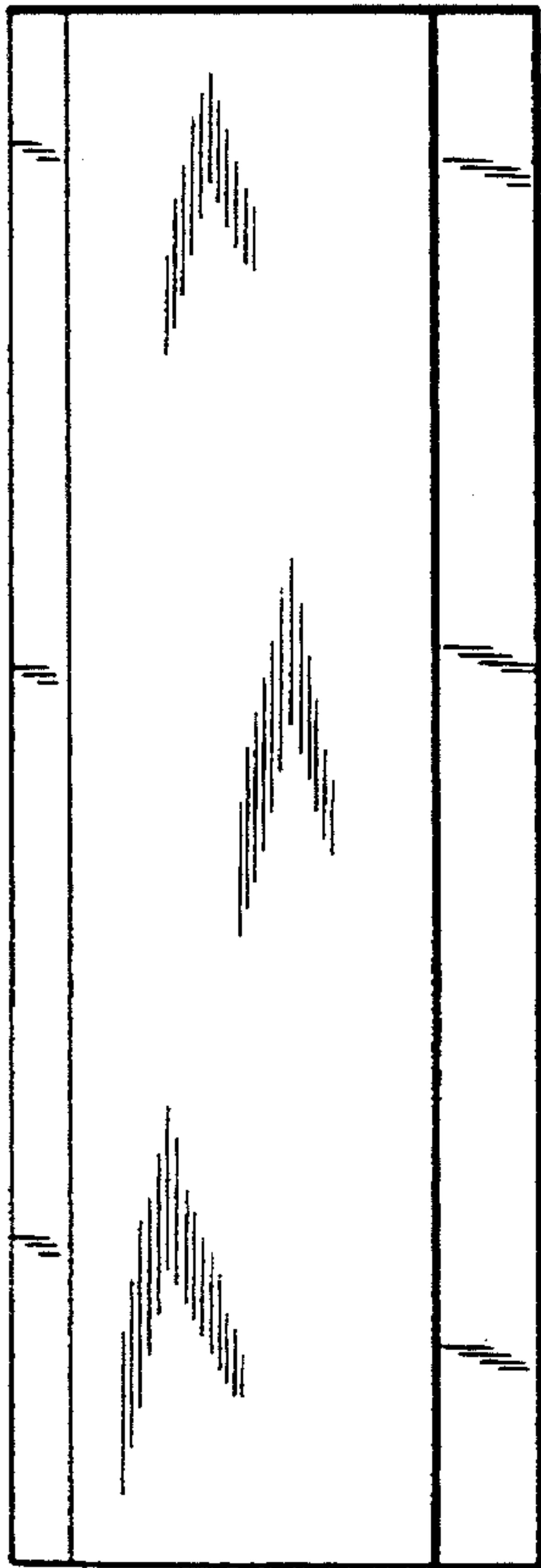
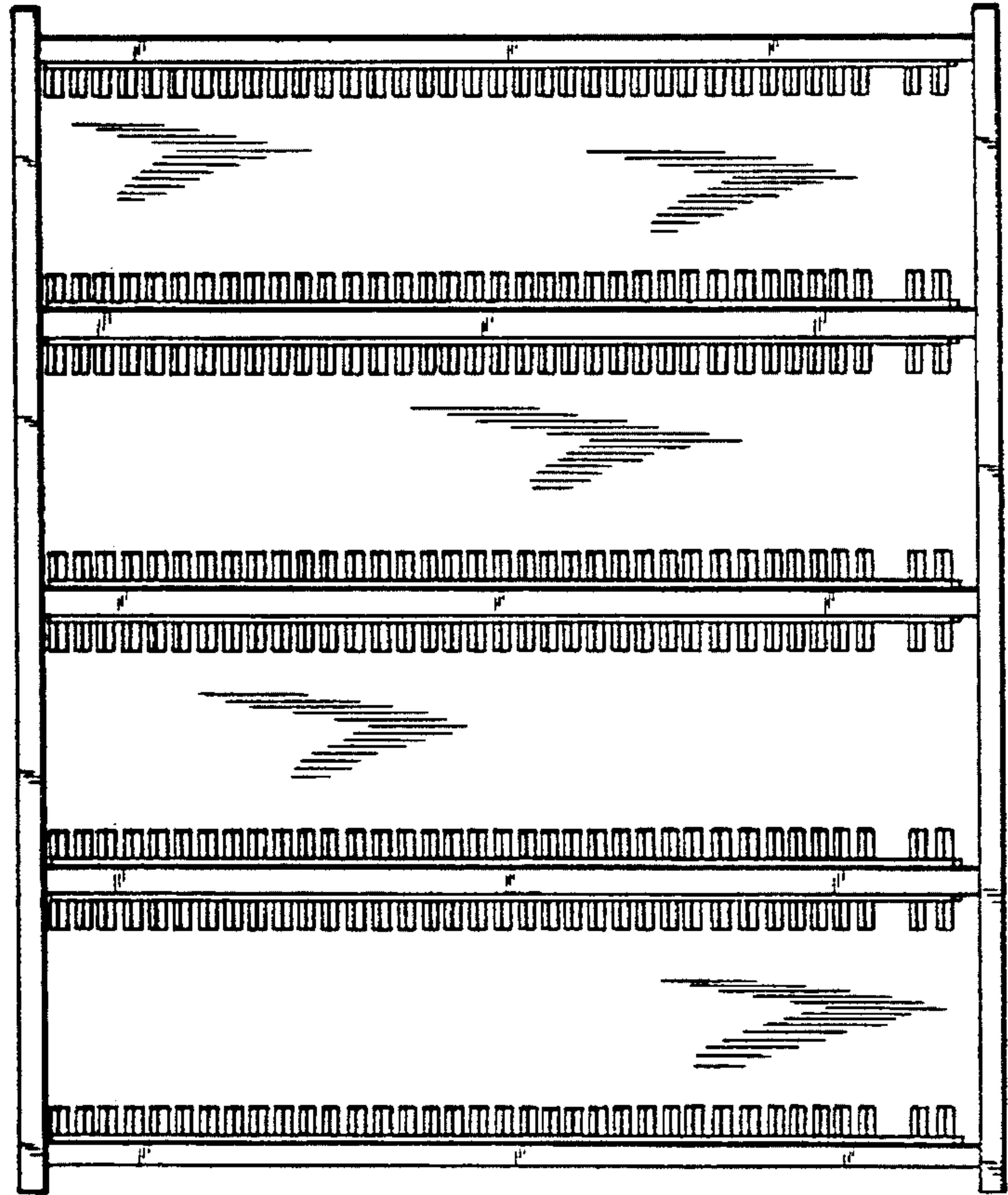

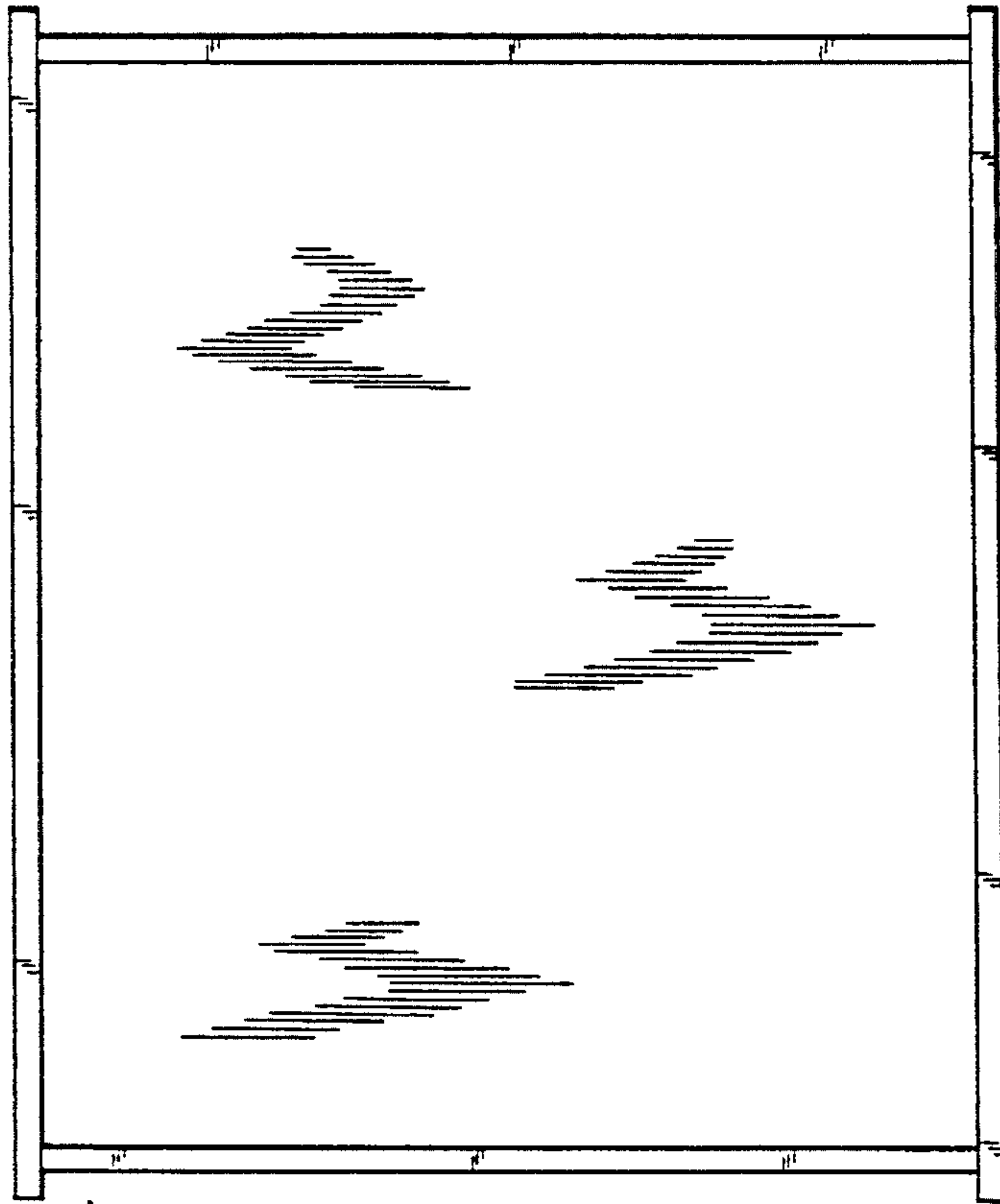

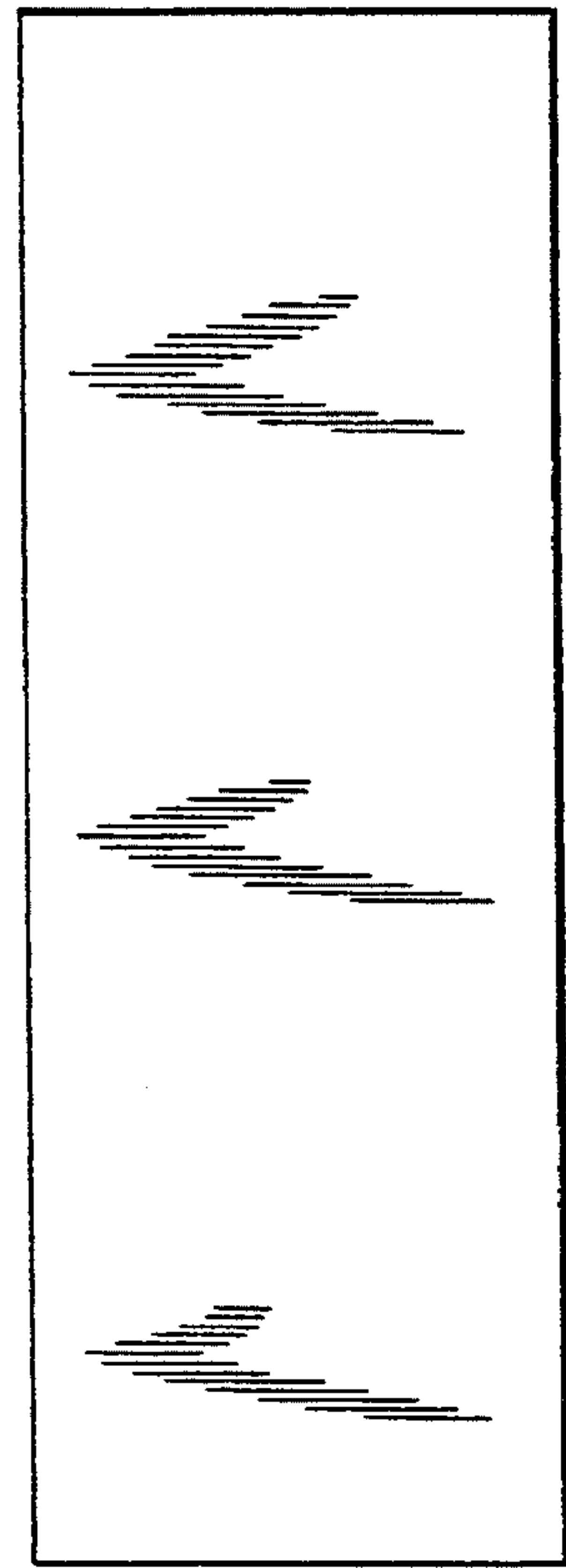

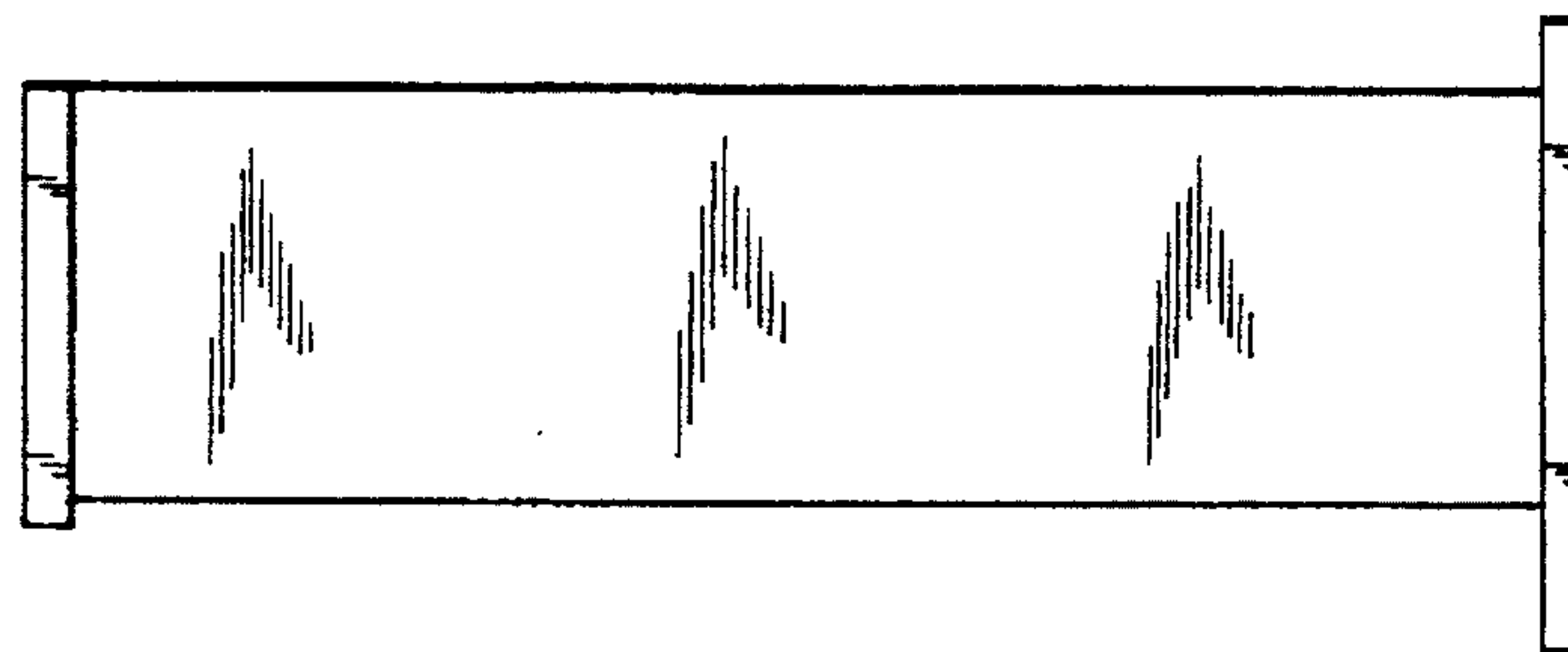
