DESCRIPTION

FIG. 1 is a front elevational view of a jewelry organizer, showing the new design;

FIG. 2 is a right side elevational view of the jewelry organizer of FIG. 1, with the left side elevational view being a mirror image thereof;

FIG. 3 is a rear elevation of the jewelry organizer of FIG. 1;

FIG. 4 is a top plan view of the jewelry organizer of FIG. 1; and,

FIG. 5 is a bottom plan view of the jewelry organizer of FIG. 1.

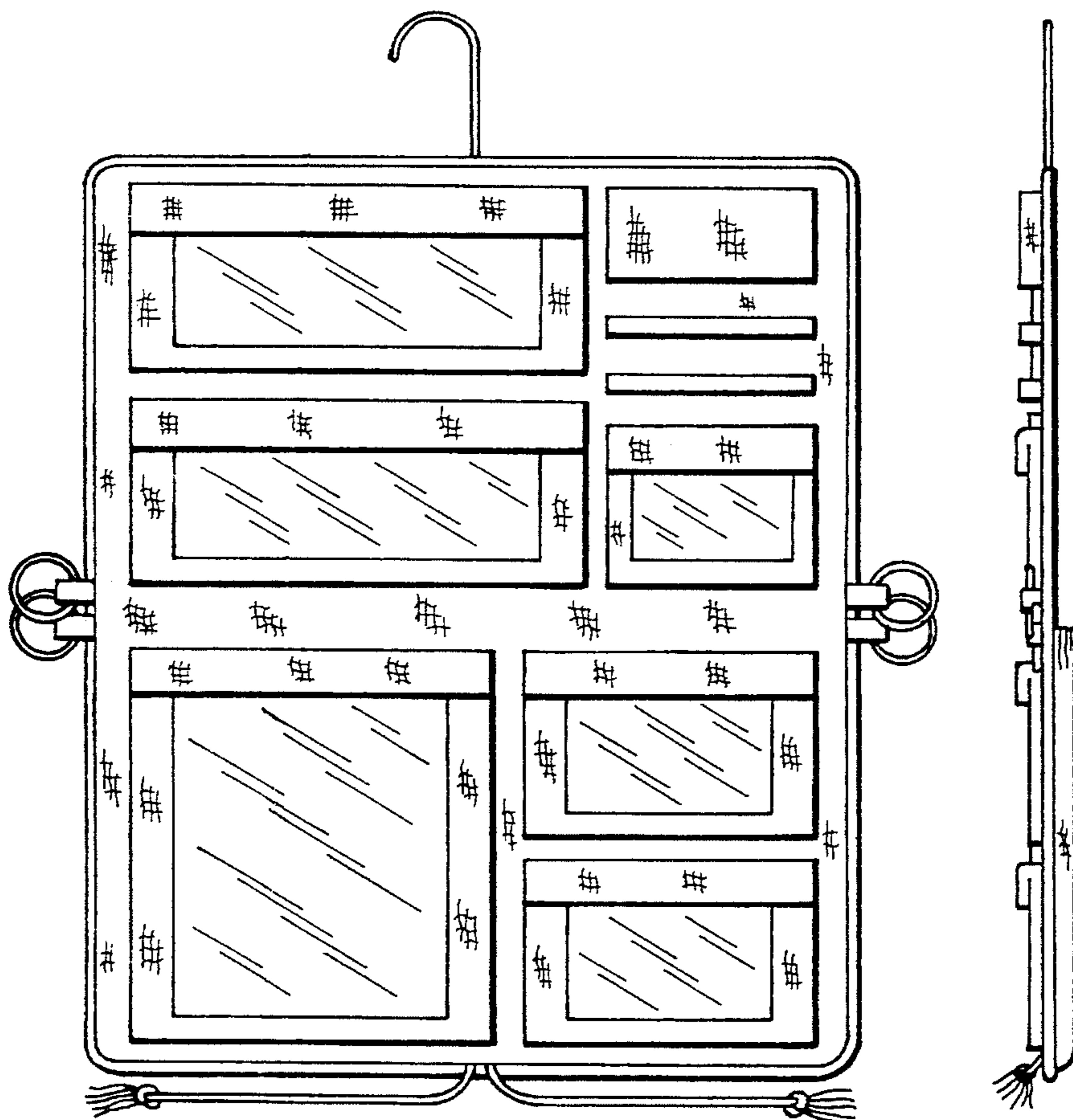

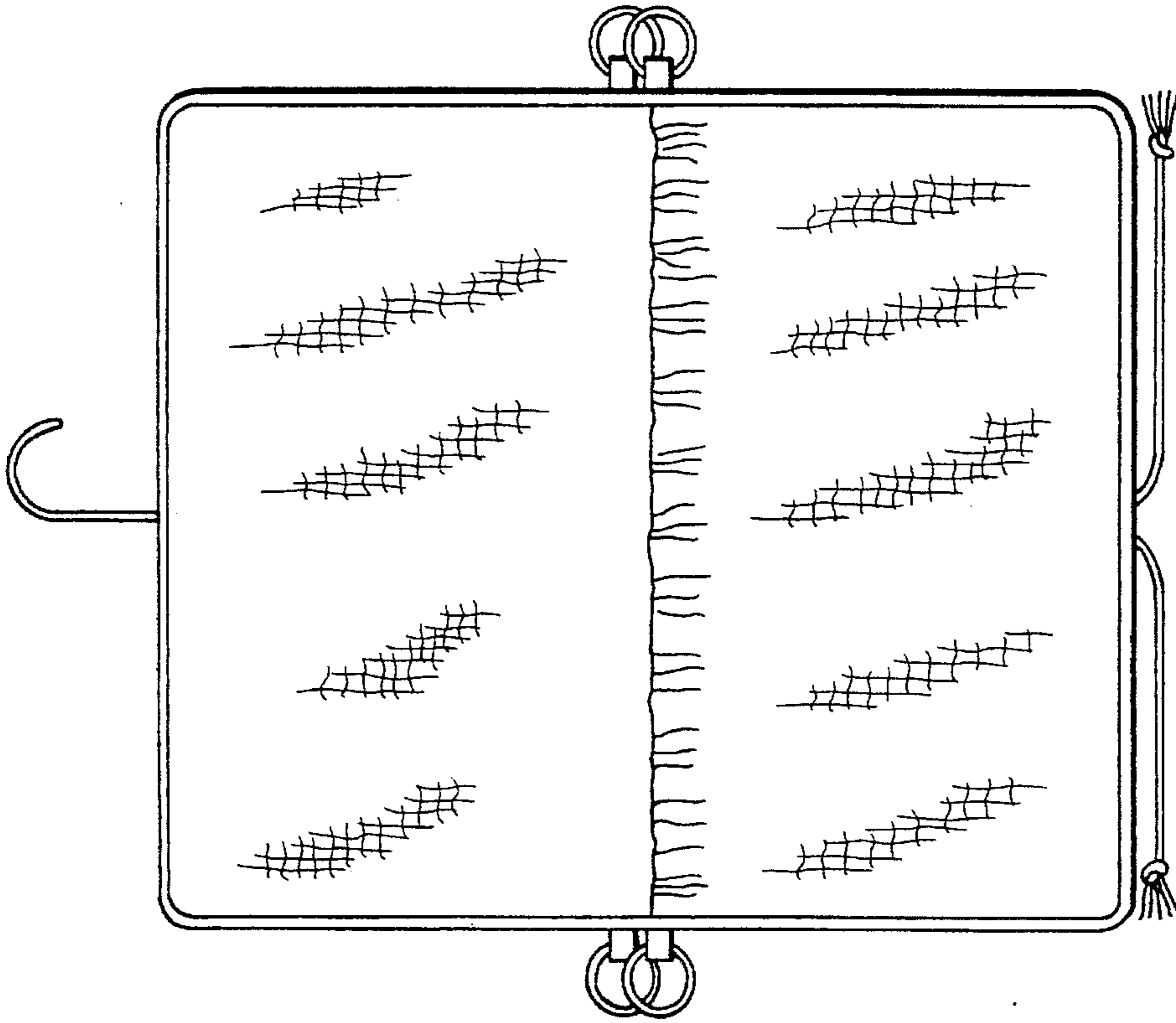

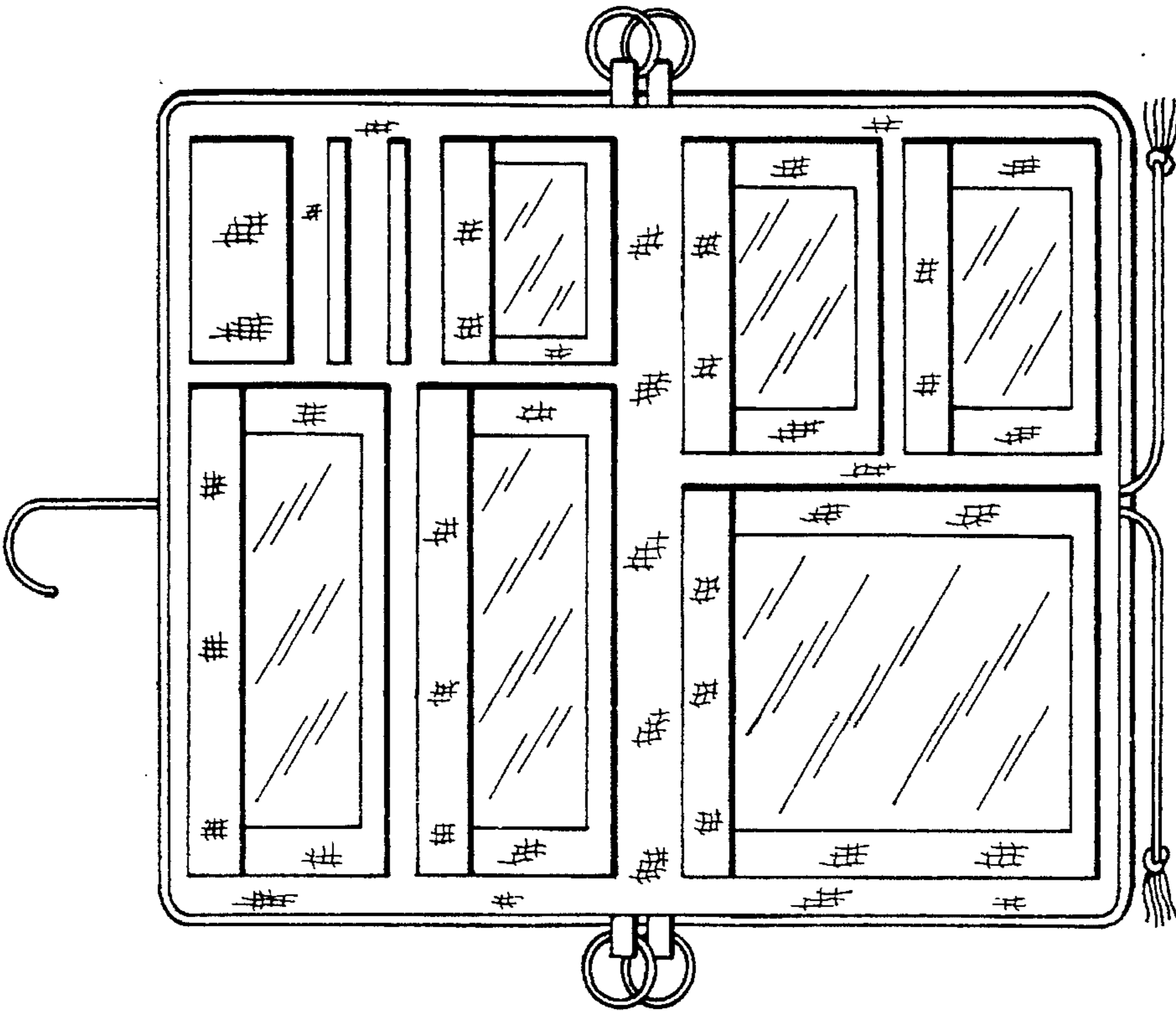
