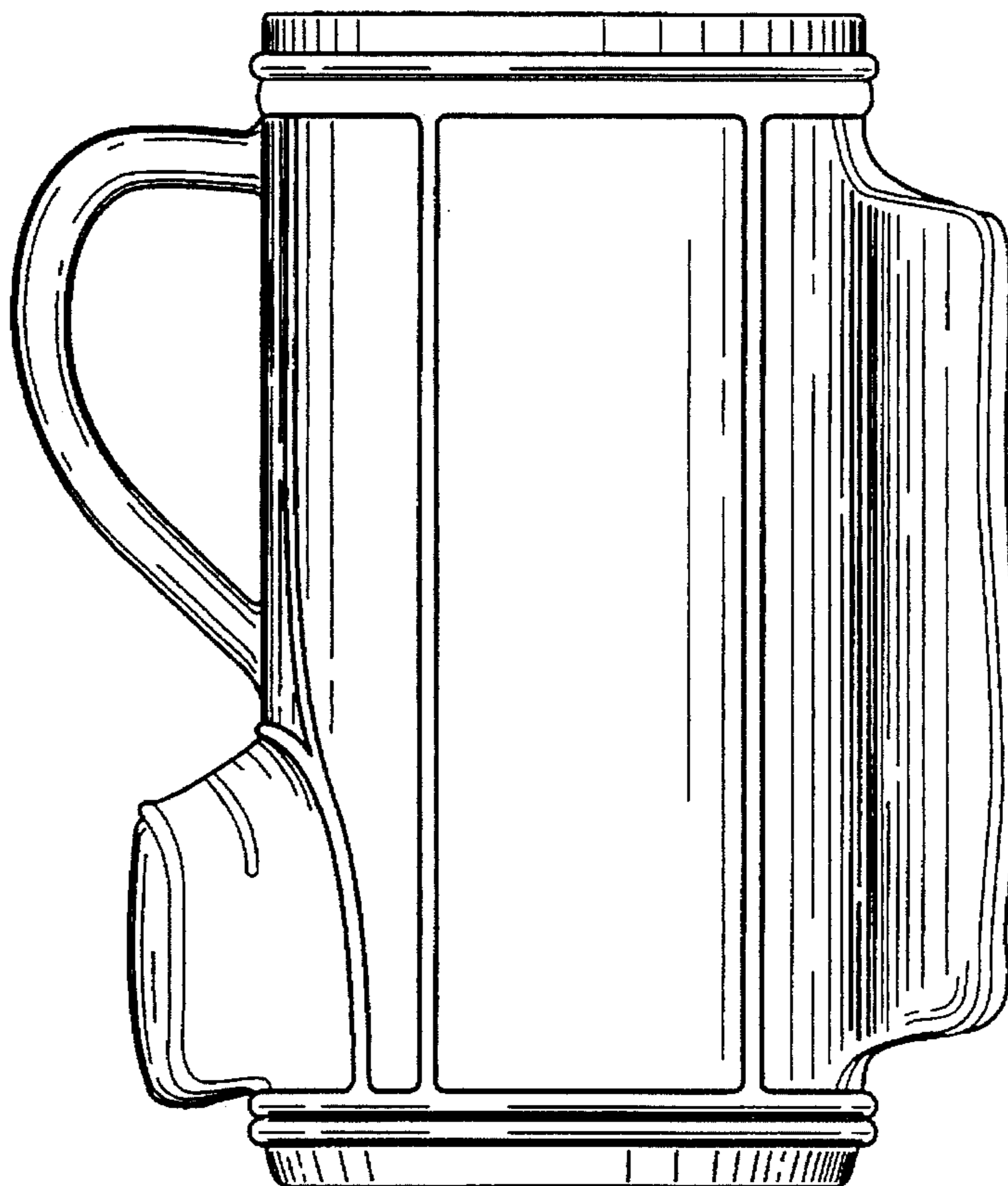

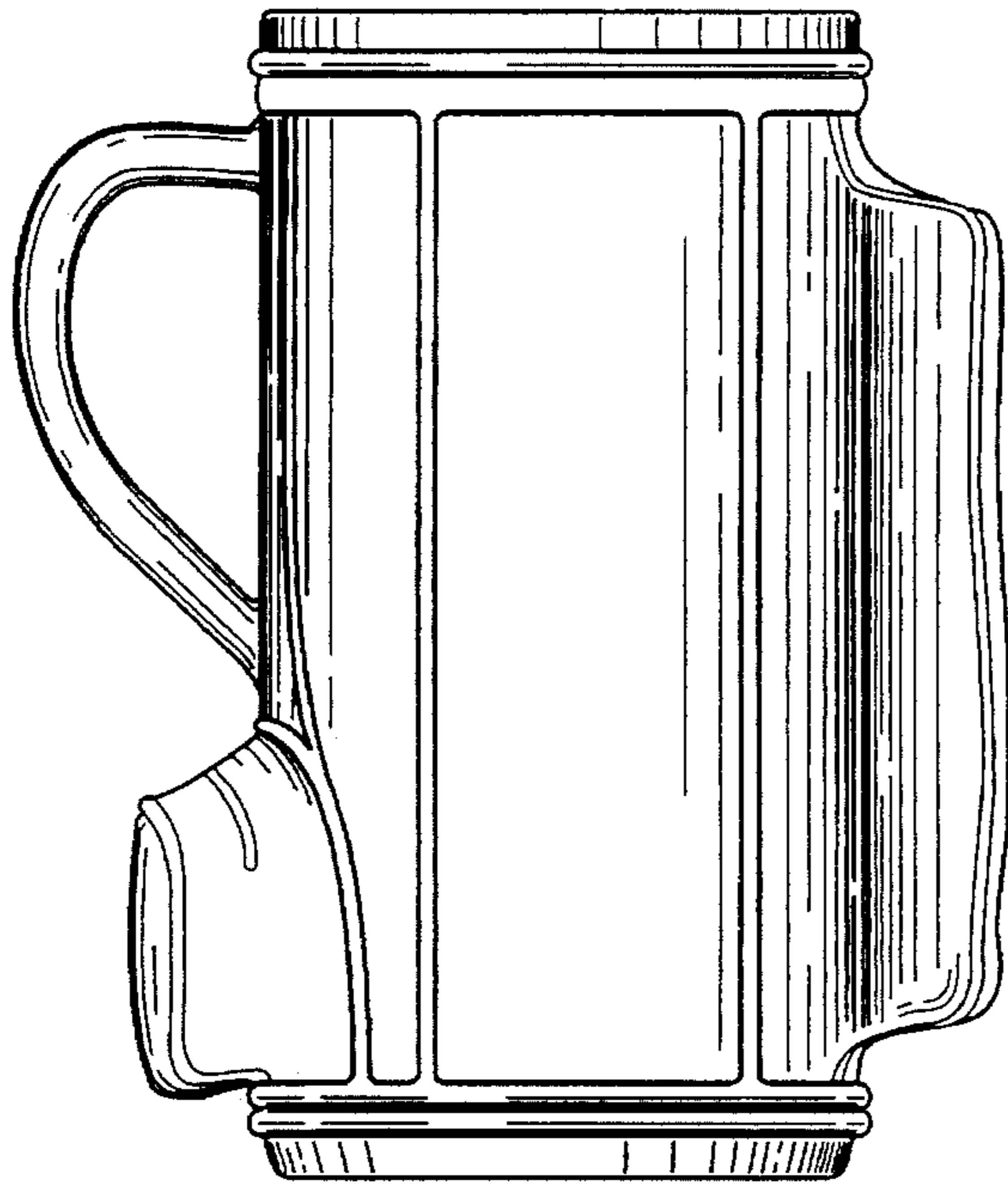
The ornamental design for a beverage mug and holder, as shown and described.

**DESCRIPTION**

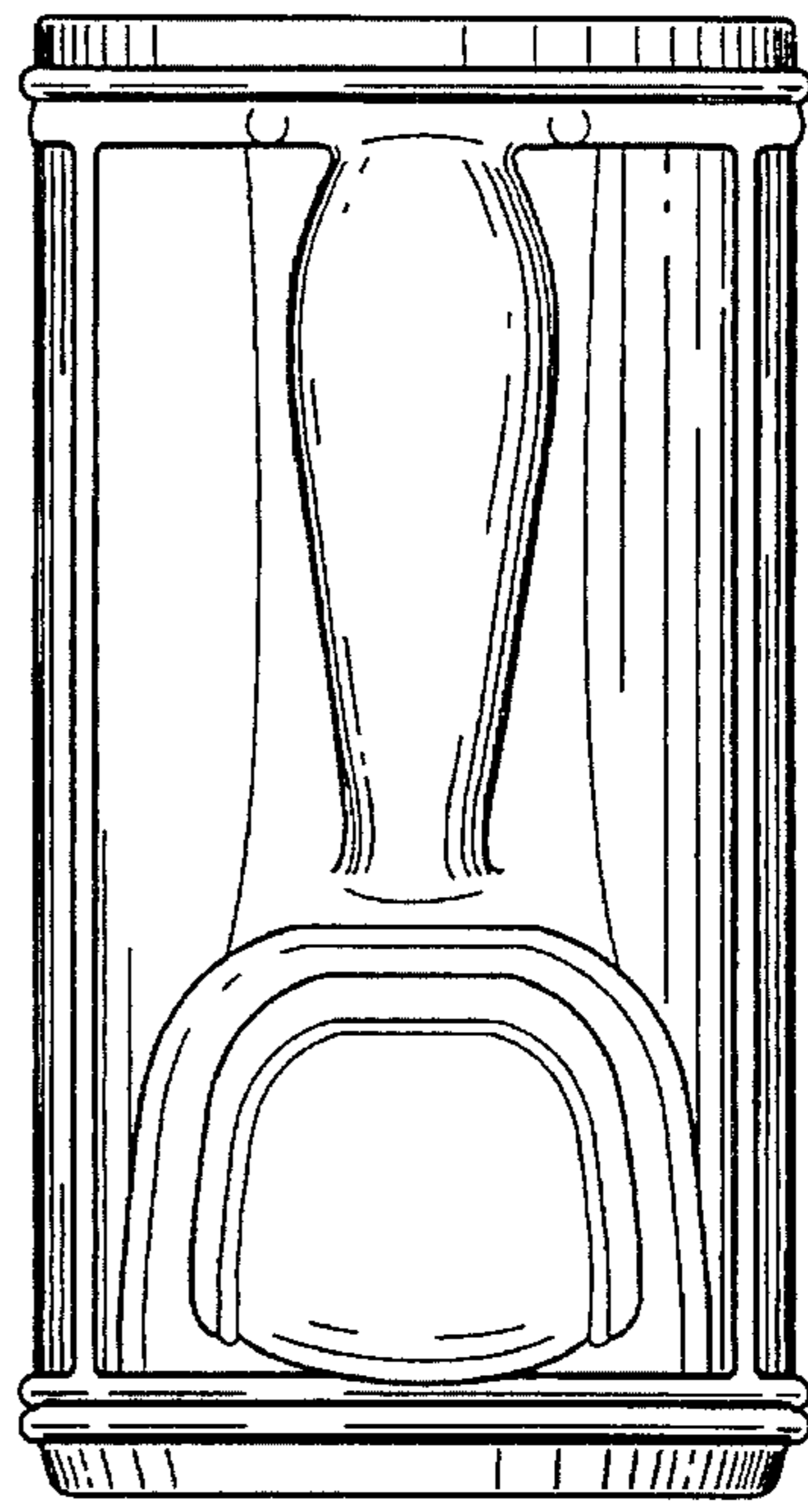

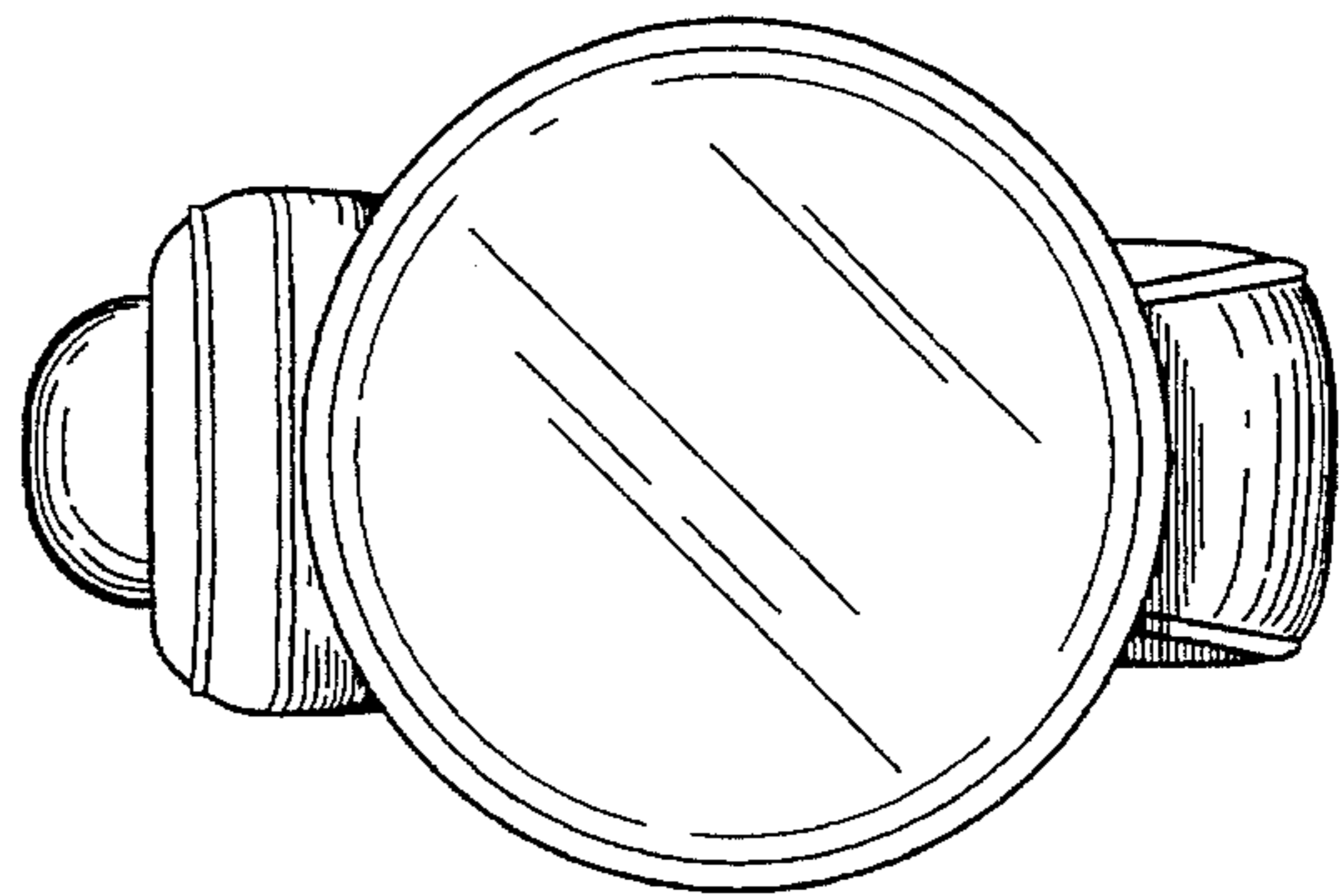




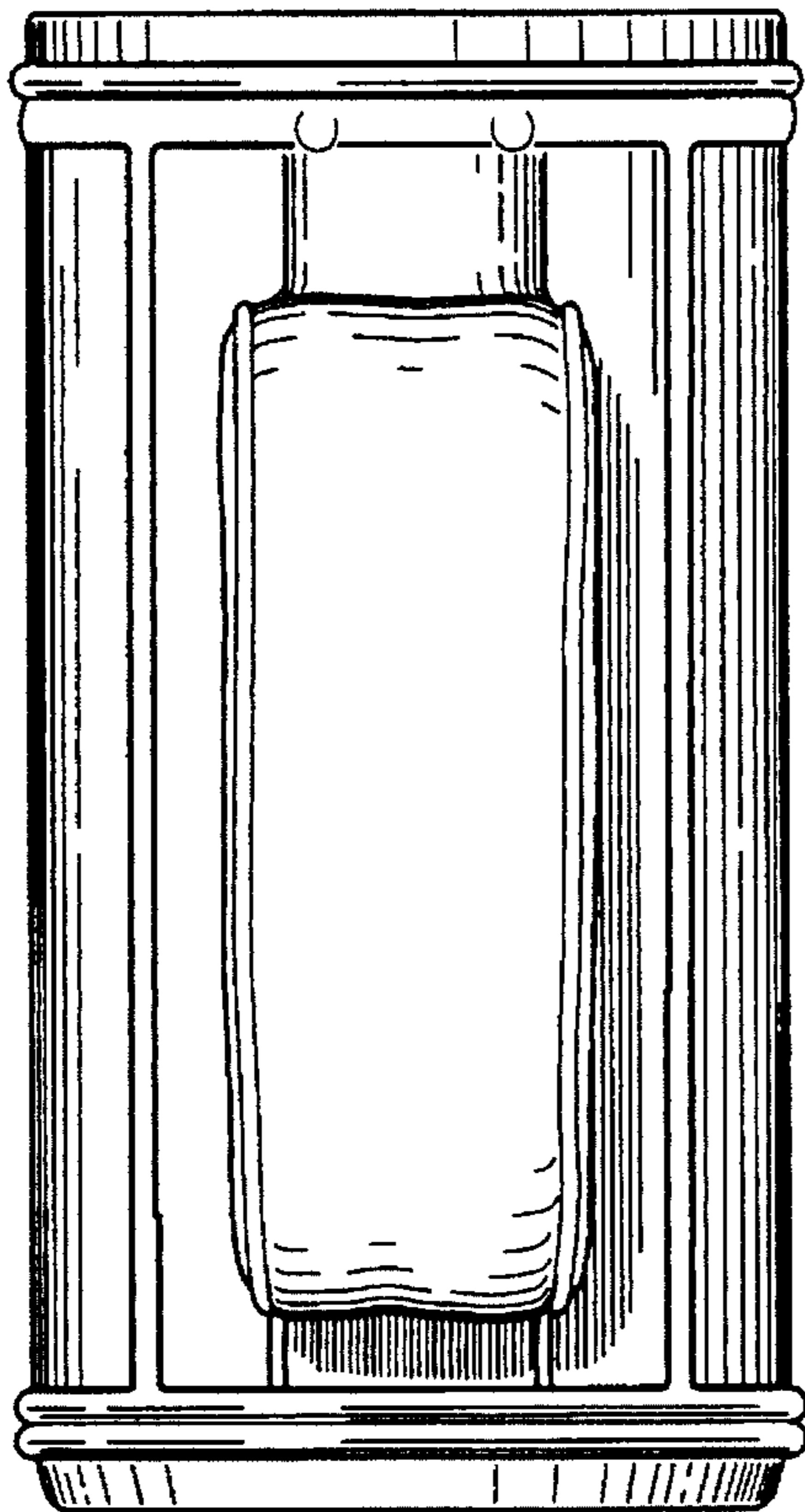

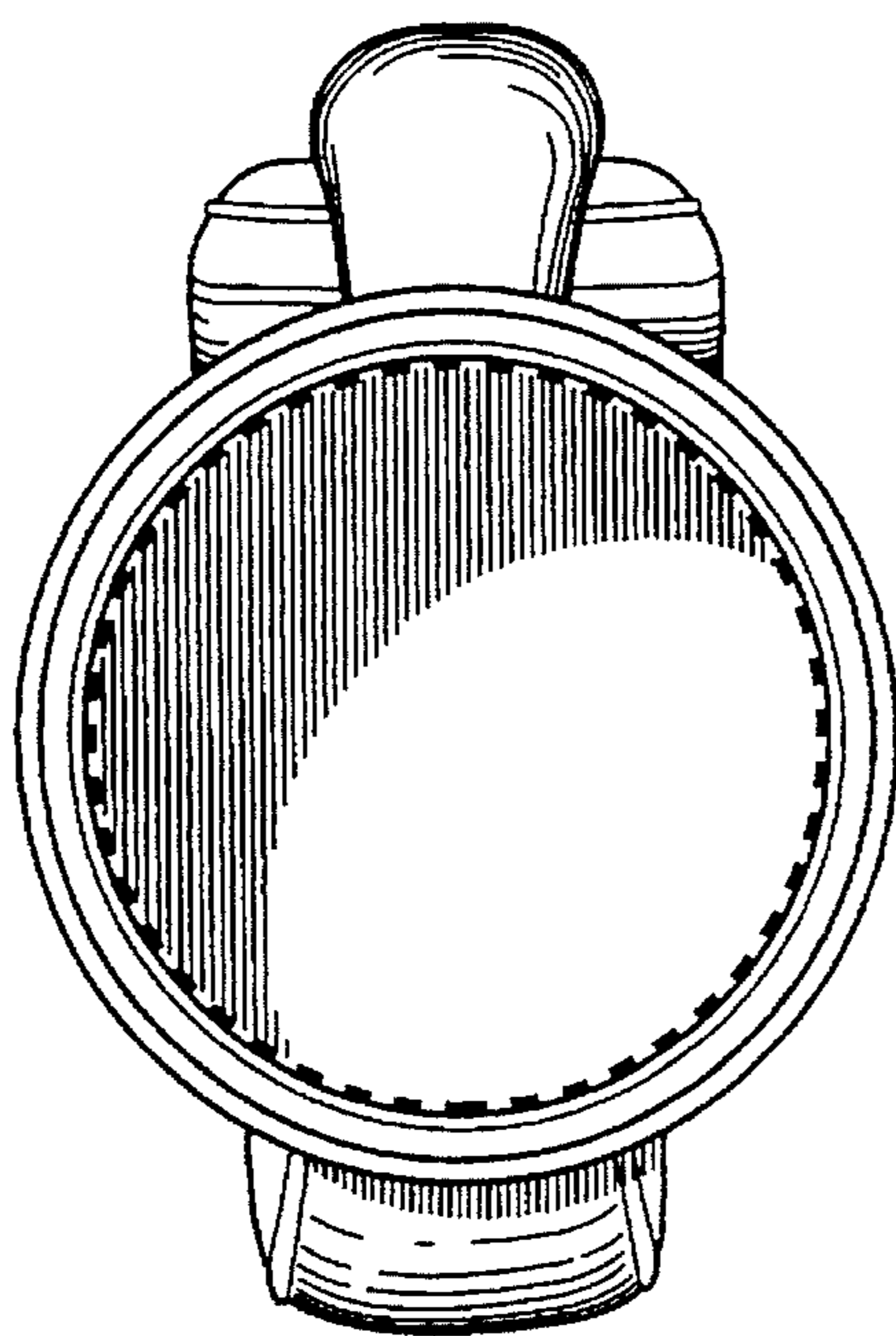
