[57] **CLAIM**

The ornamental design for a housing of a hand-held type portable telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hand-held type portable telephone showing our new design from the front, left side and top;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a bottom plan view thereof; and,

FIG. 4 is a rear elevational view thereof.

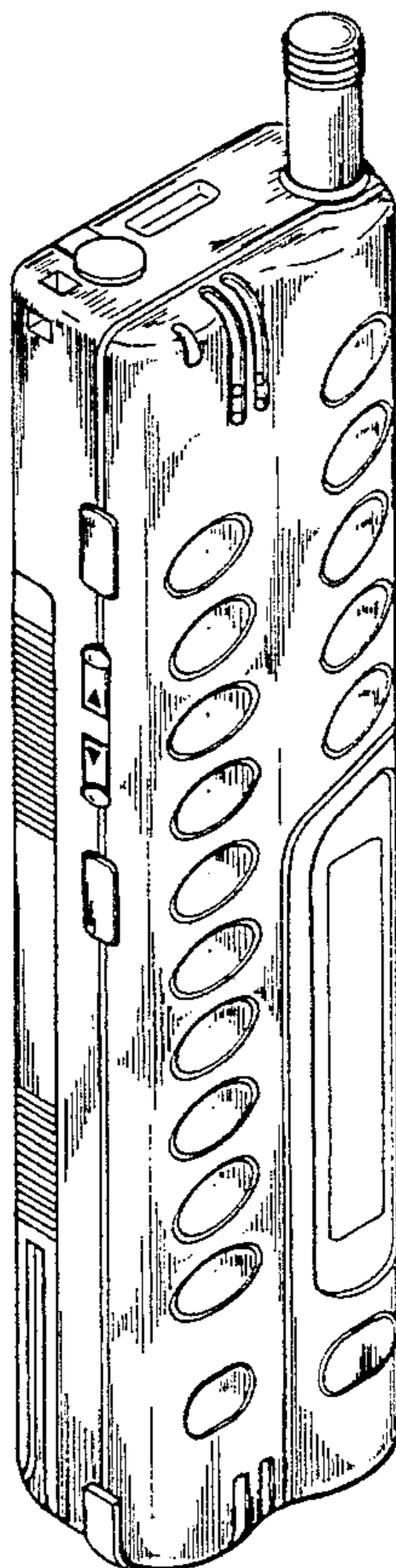

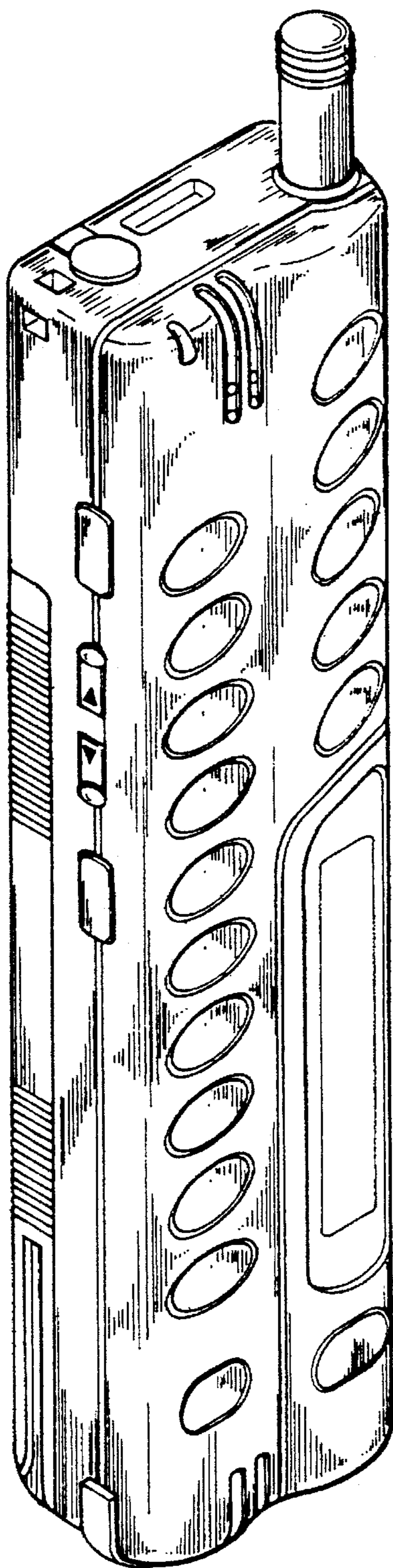

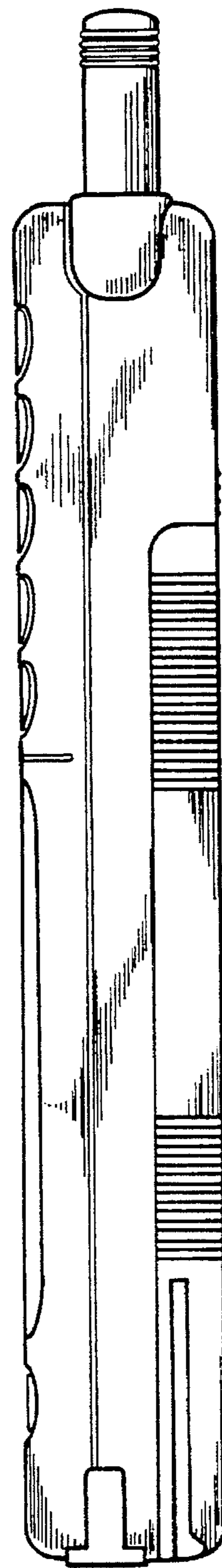

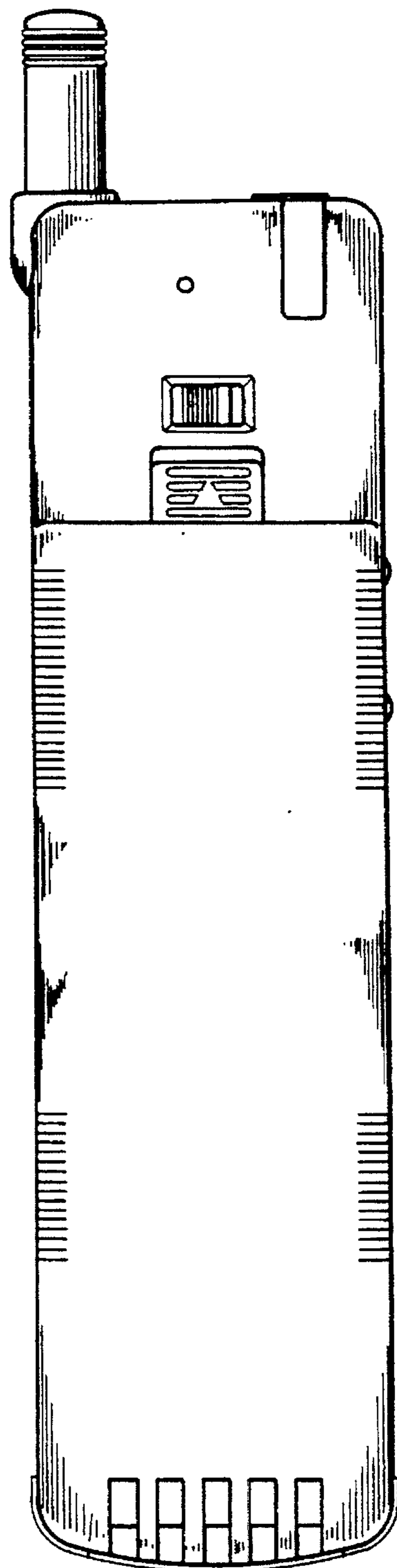
