[57] **CLAIM**

The ornamental design for a cordless telephone headset, as shown and described.

DESCRIPTION

FIG. 1 is a right side and front perspective view of a cordless telephone headset showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a left side and front perspective view thereof.

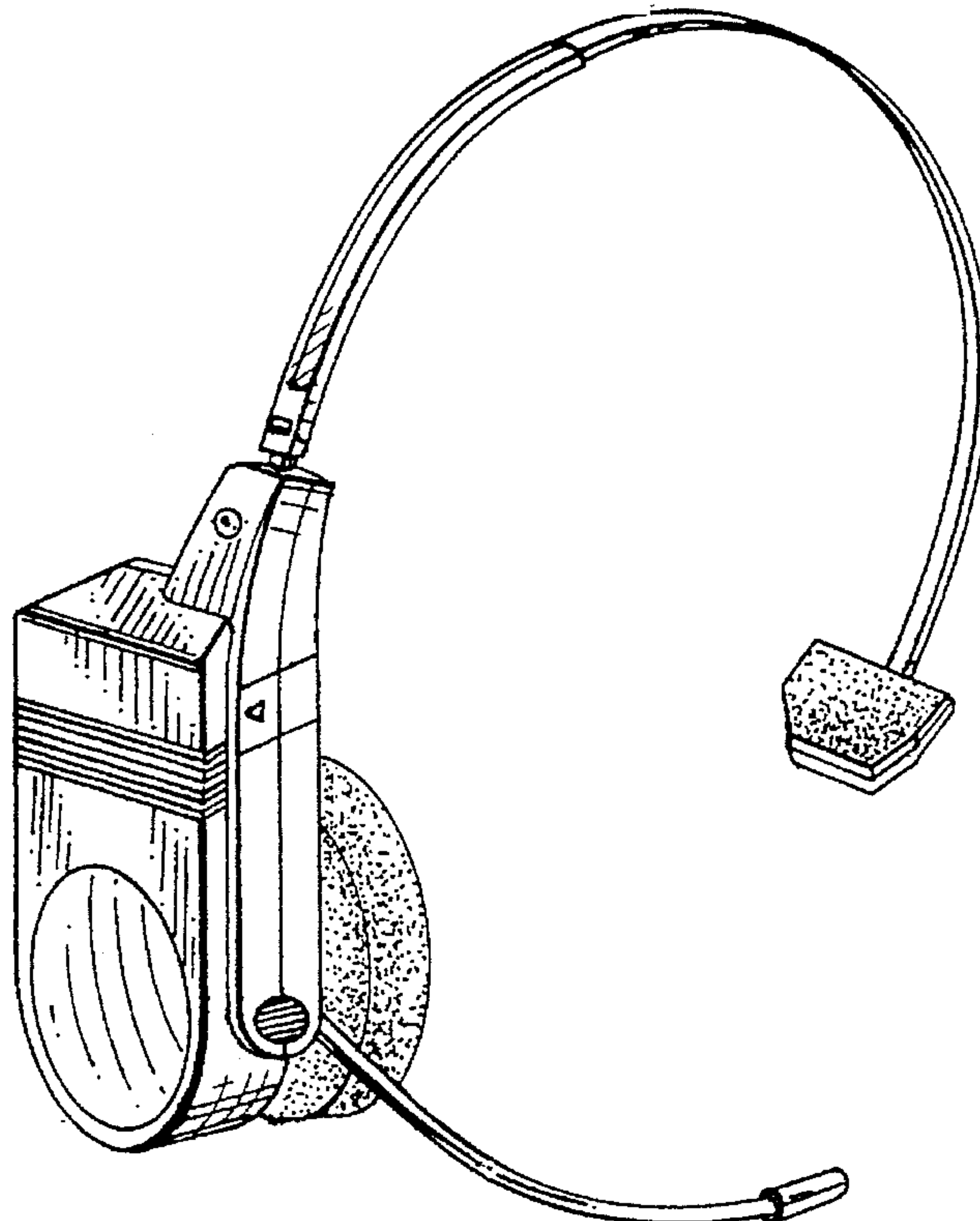

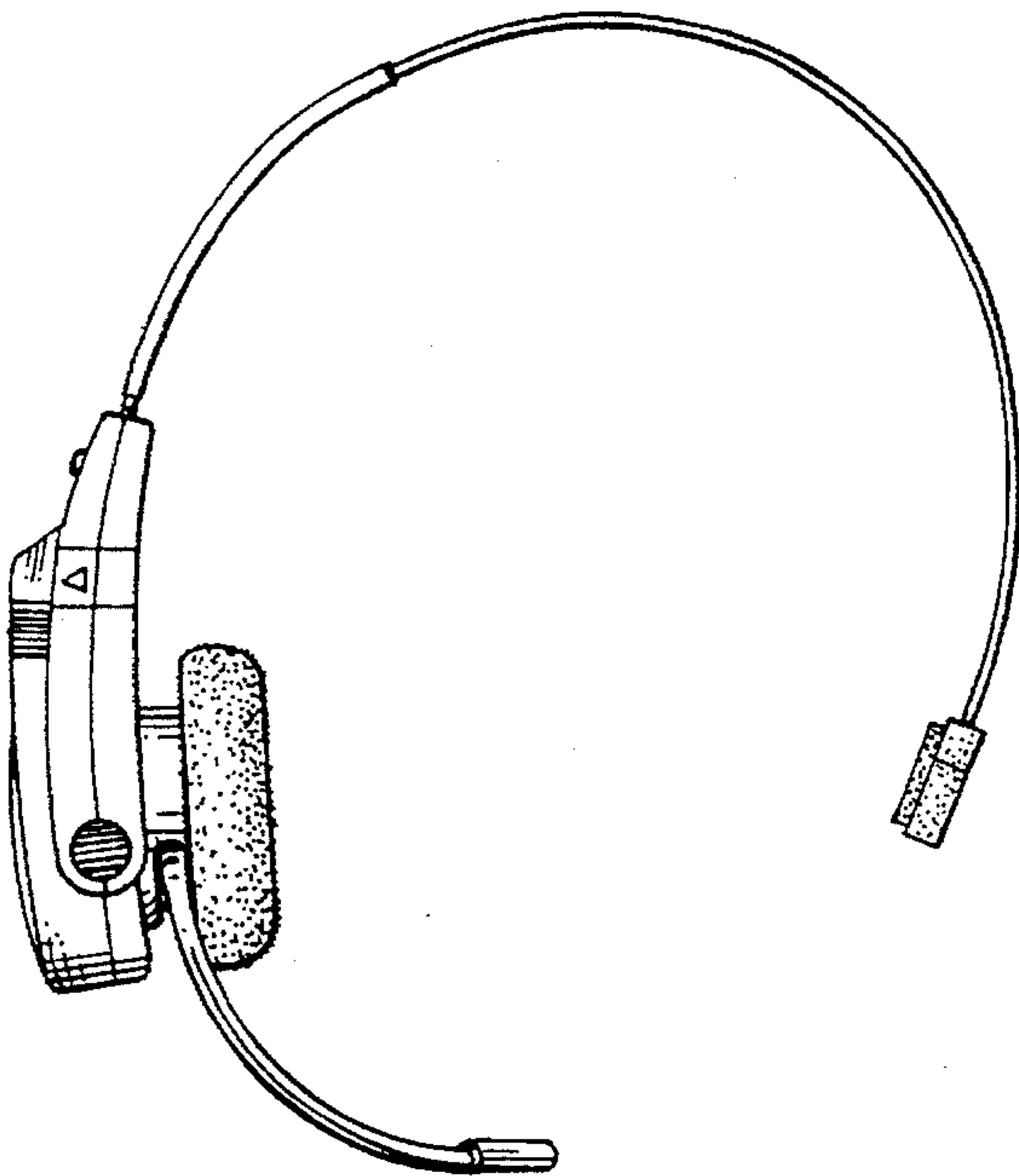
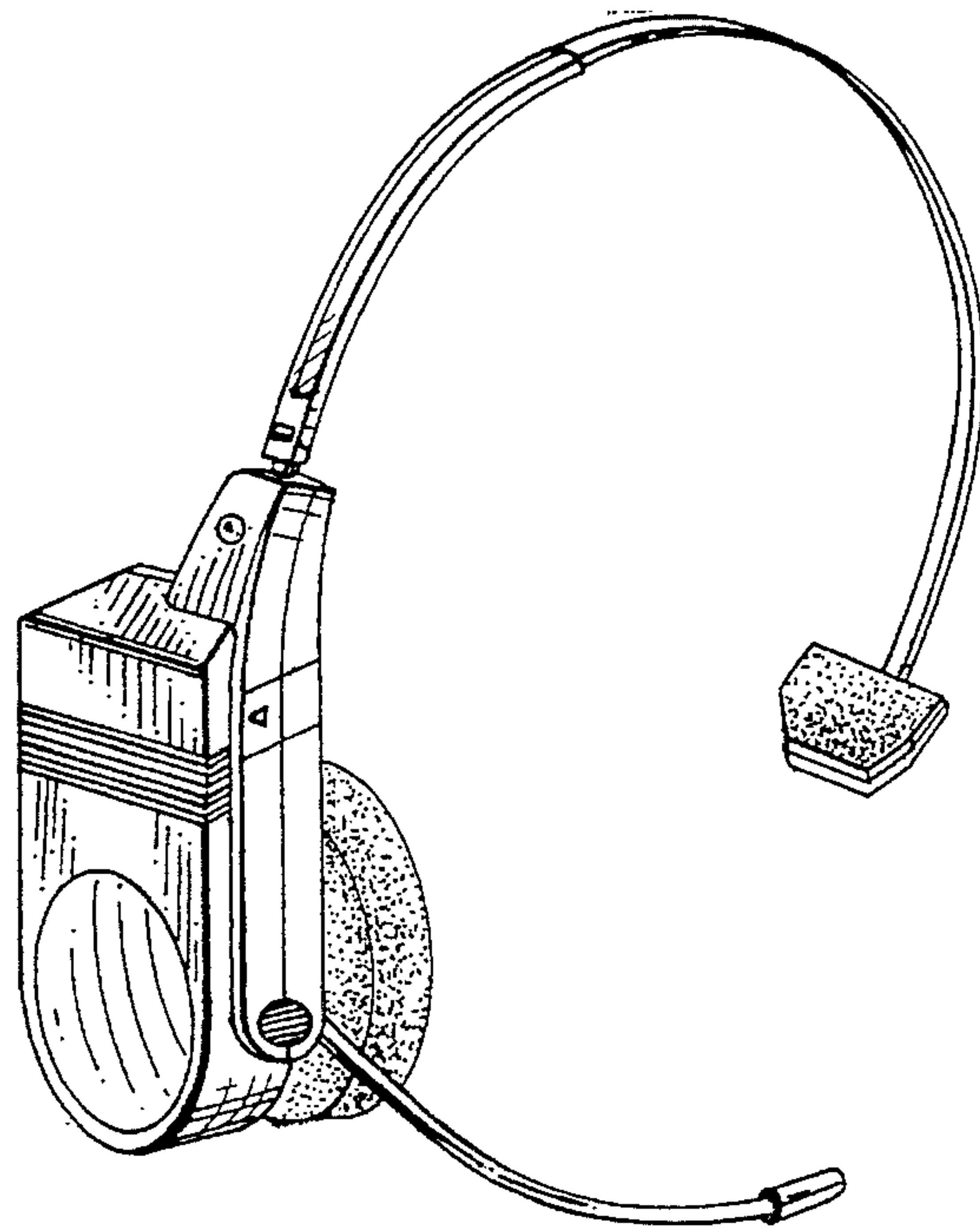

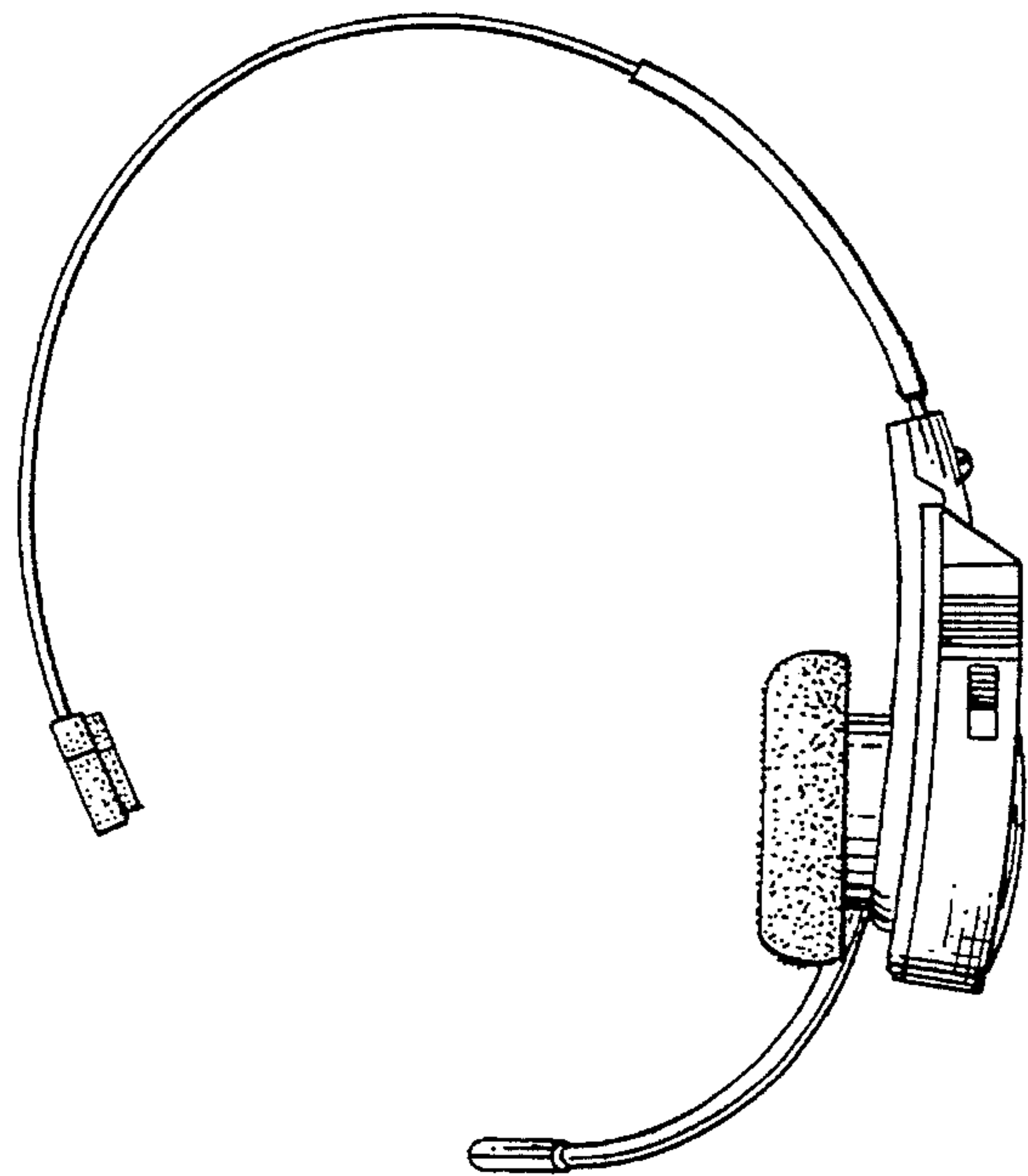

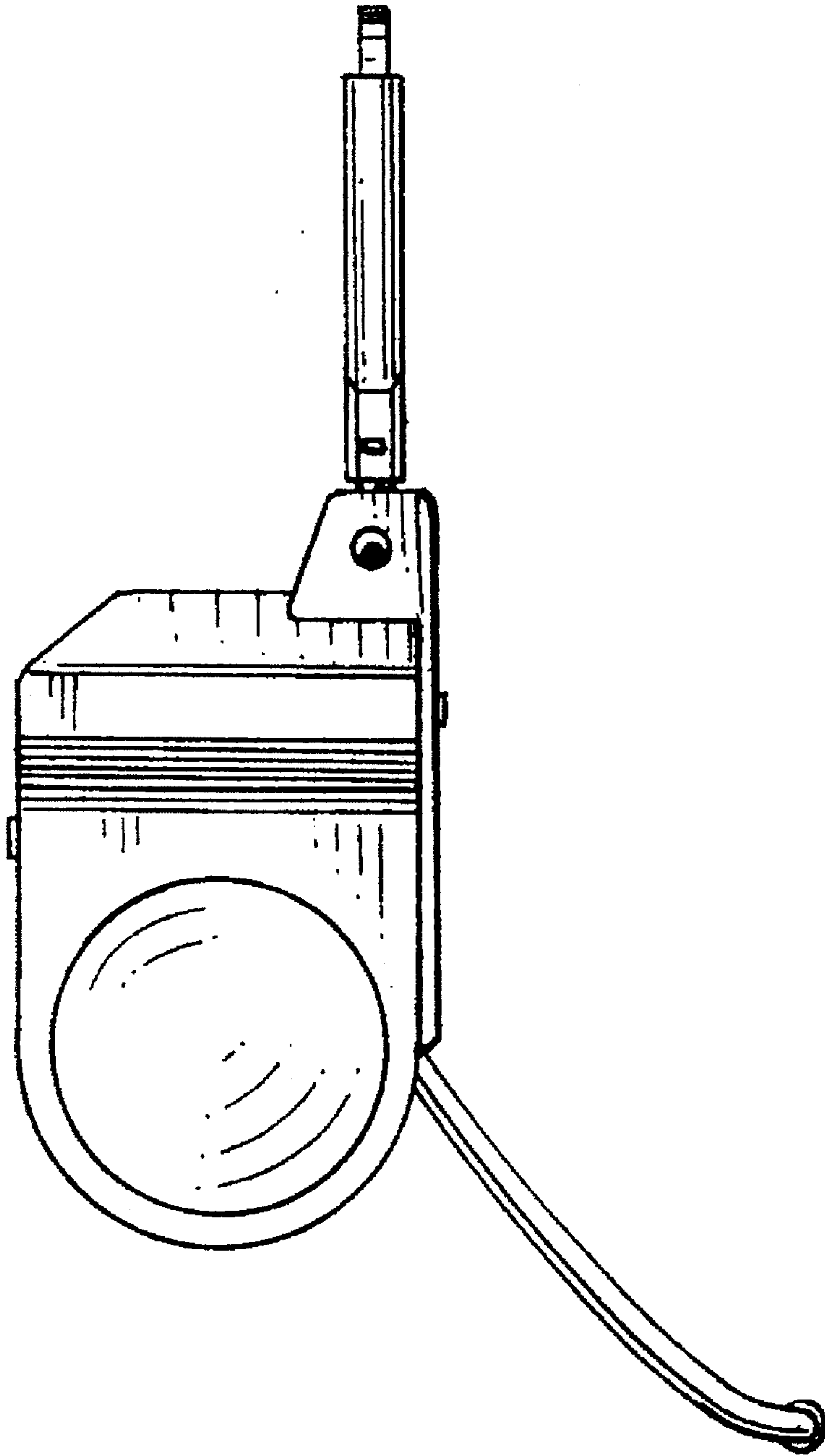

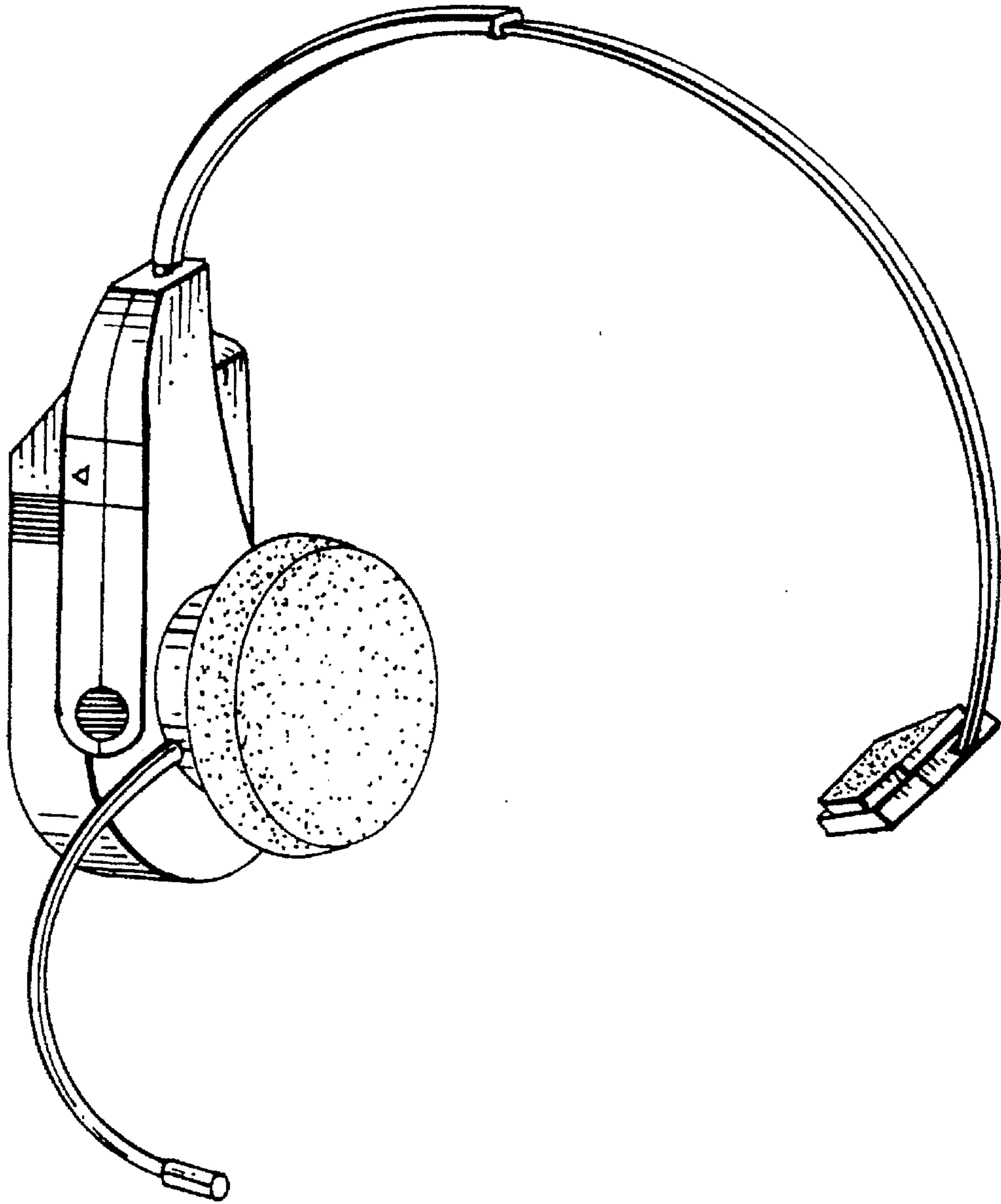
