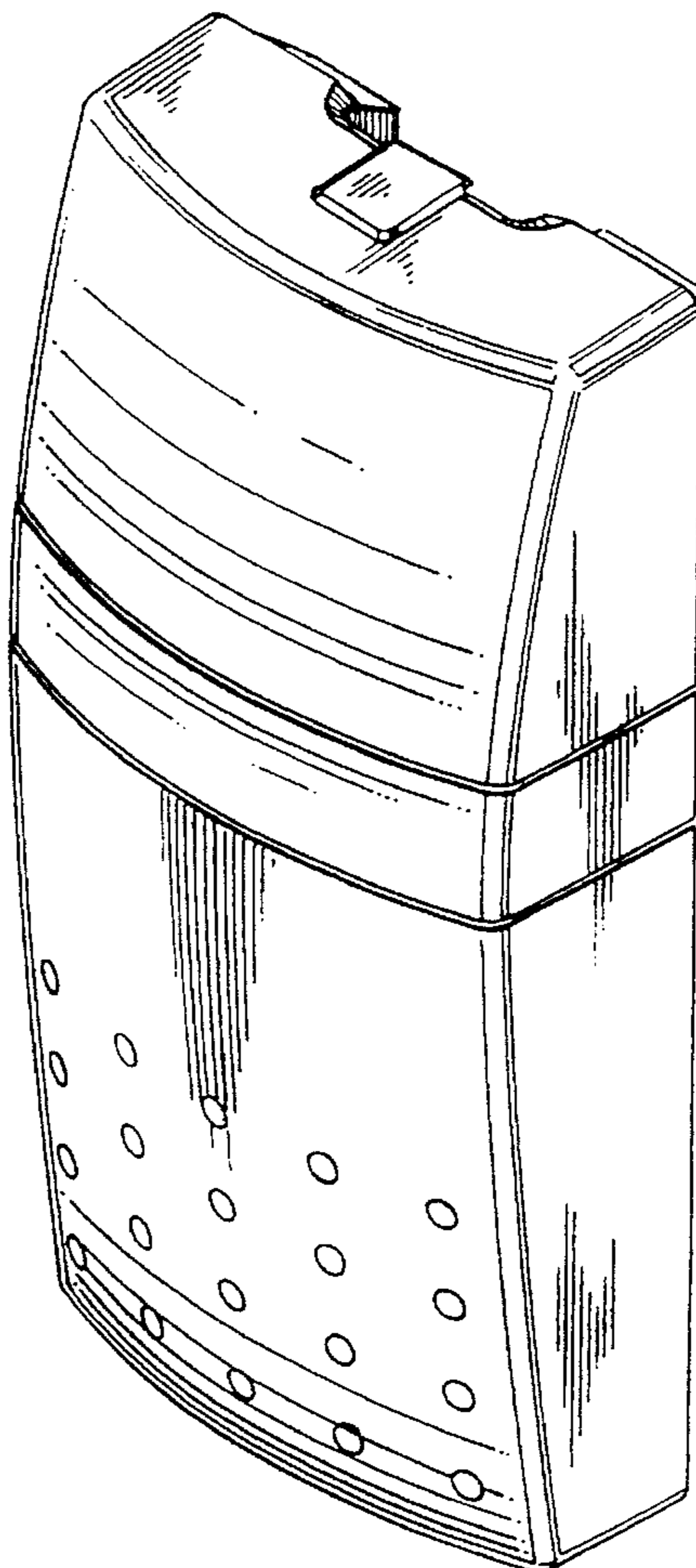
[57] **CLAIM**

The ornamental design for a telephone basestation, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of the telephone basestation showing my new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a front elevational view thereof;  
 FIG. 6 is a right hand side view thereof; and,

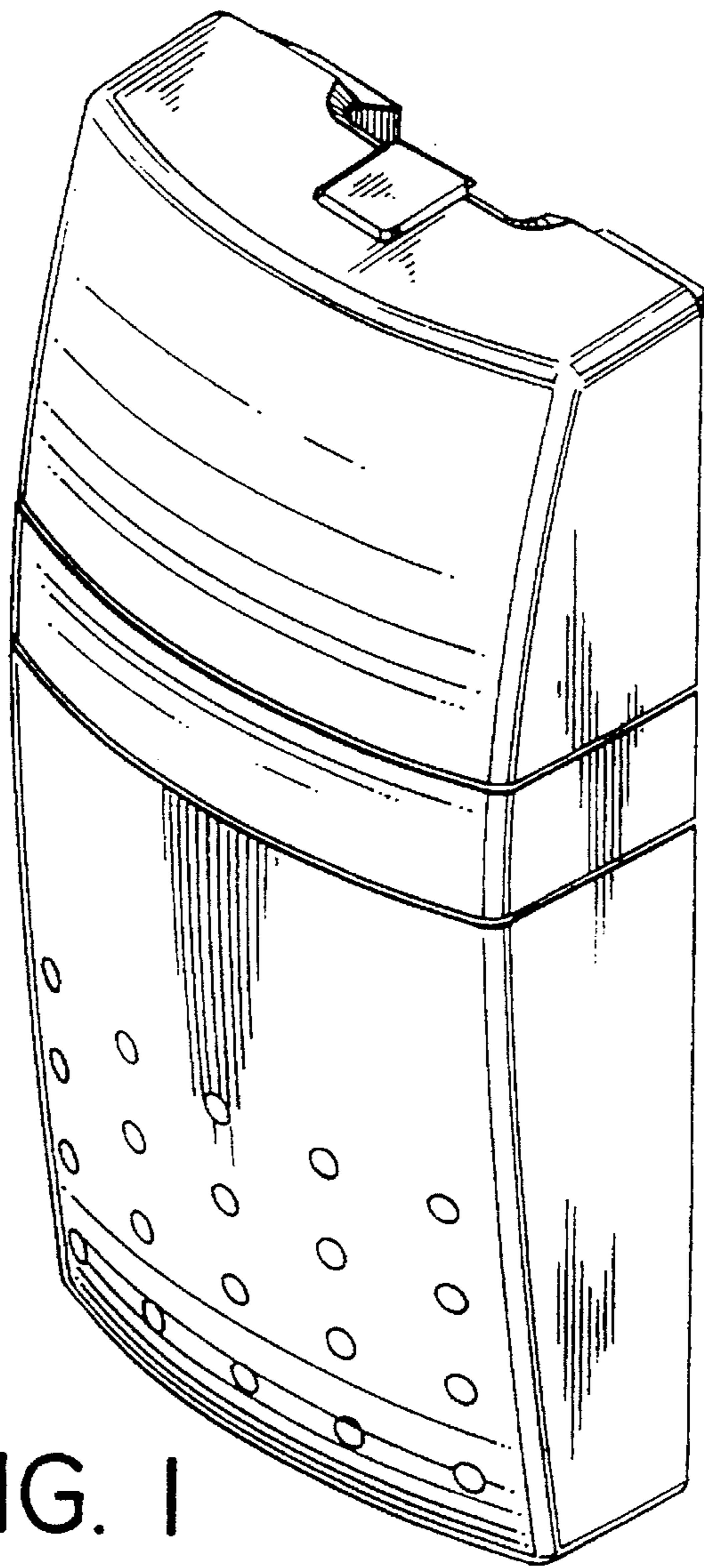

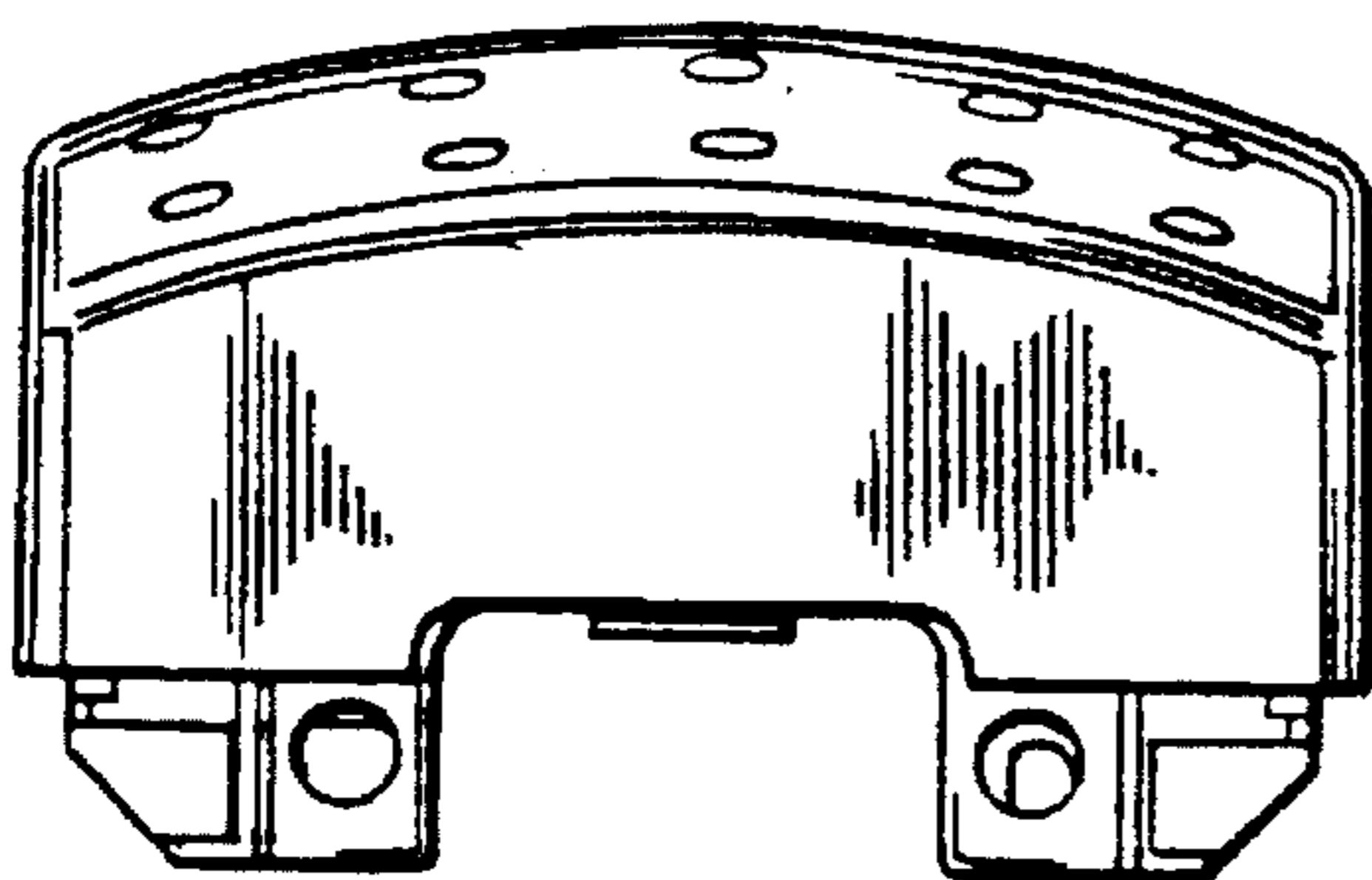

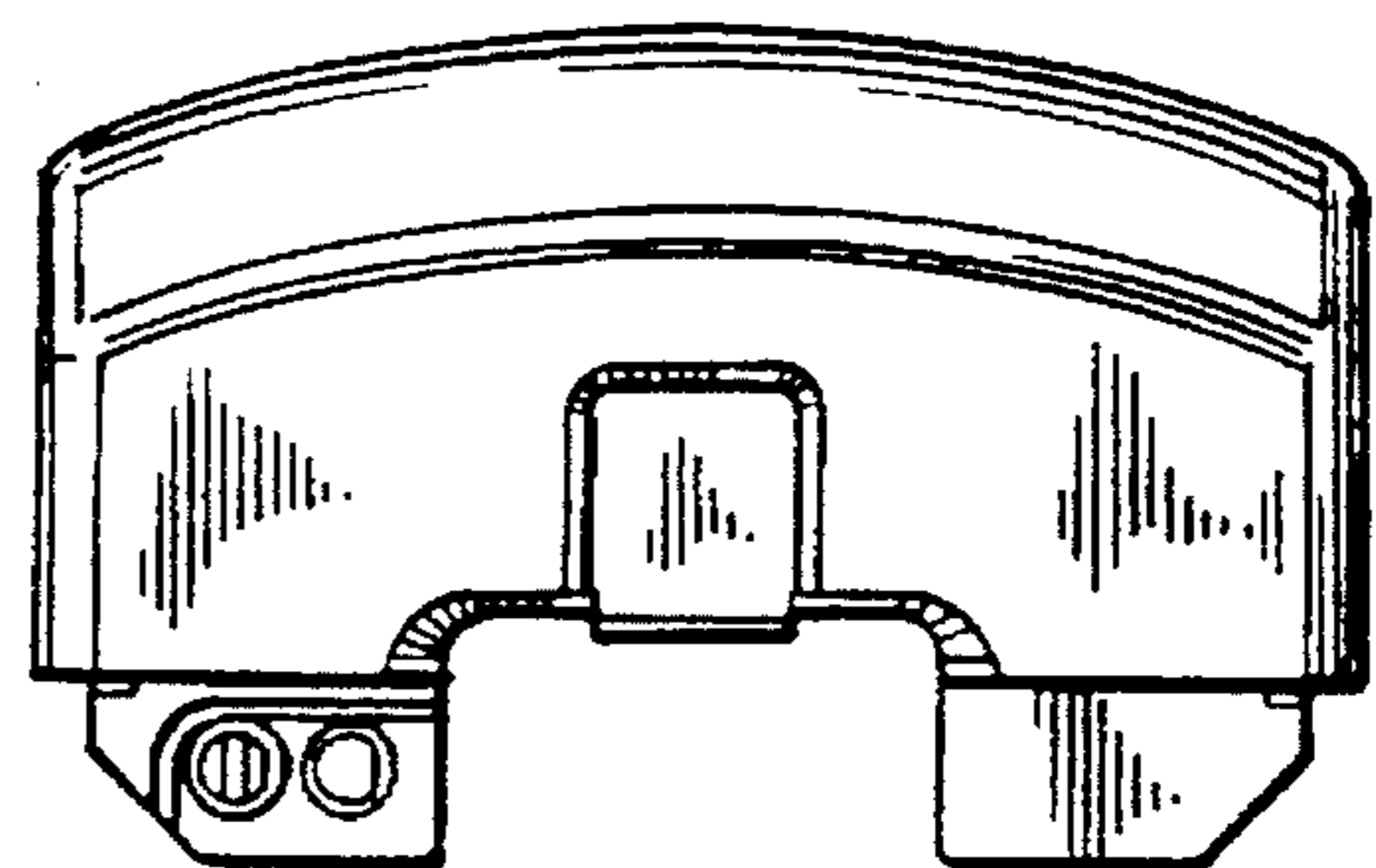

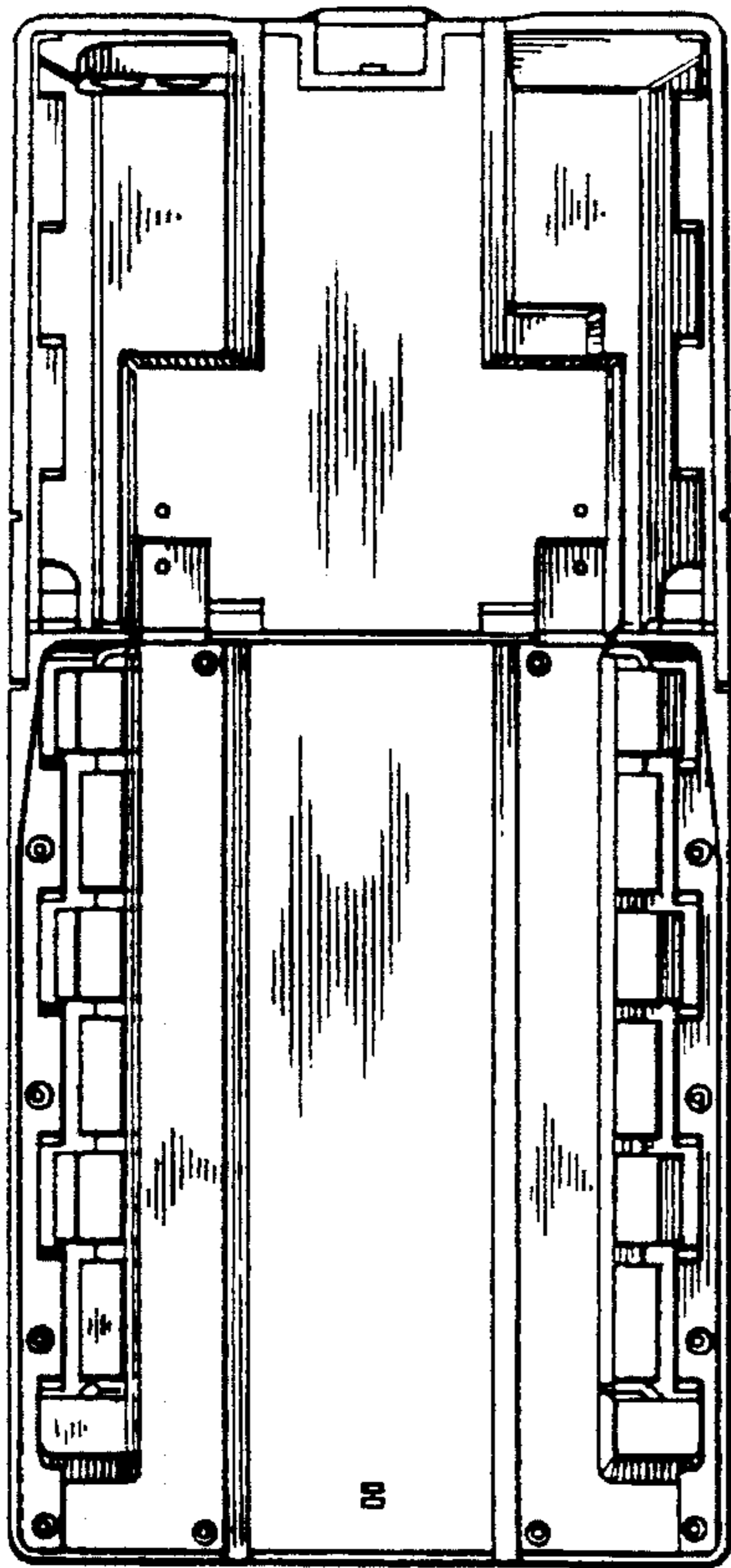

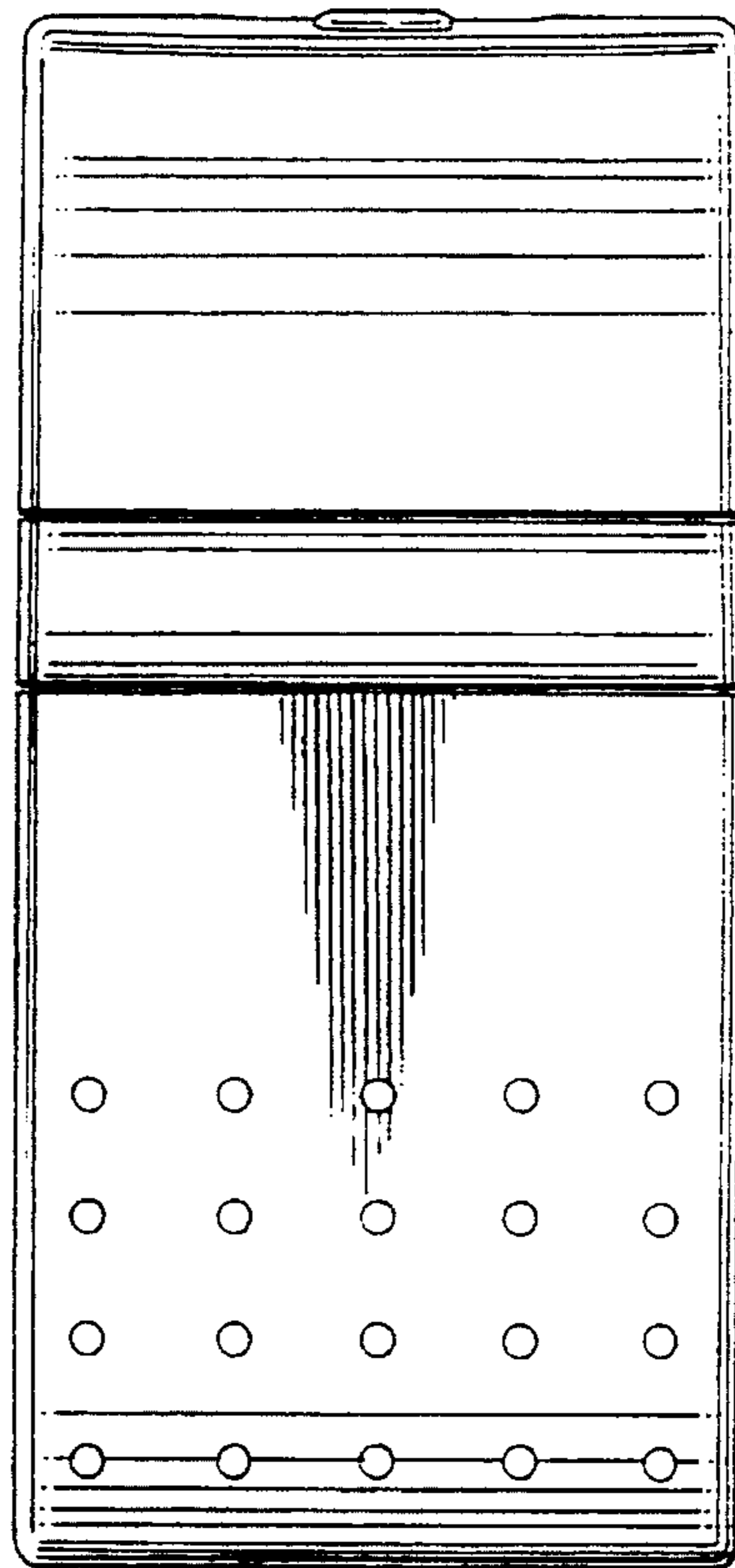

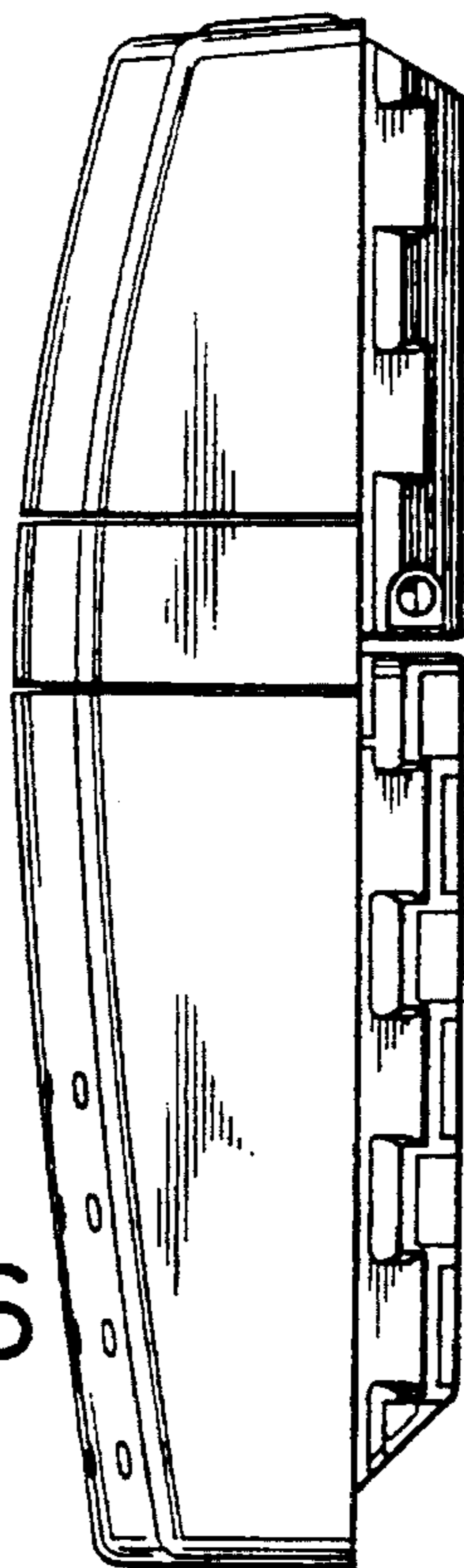

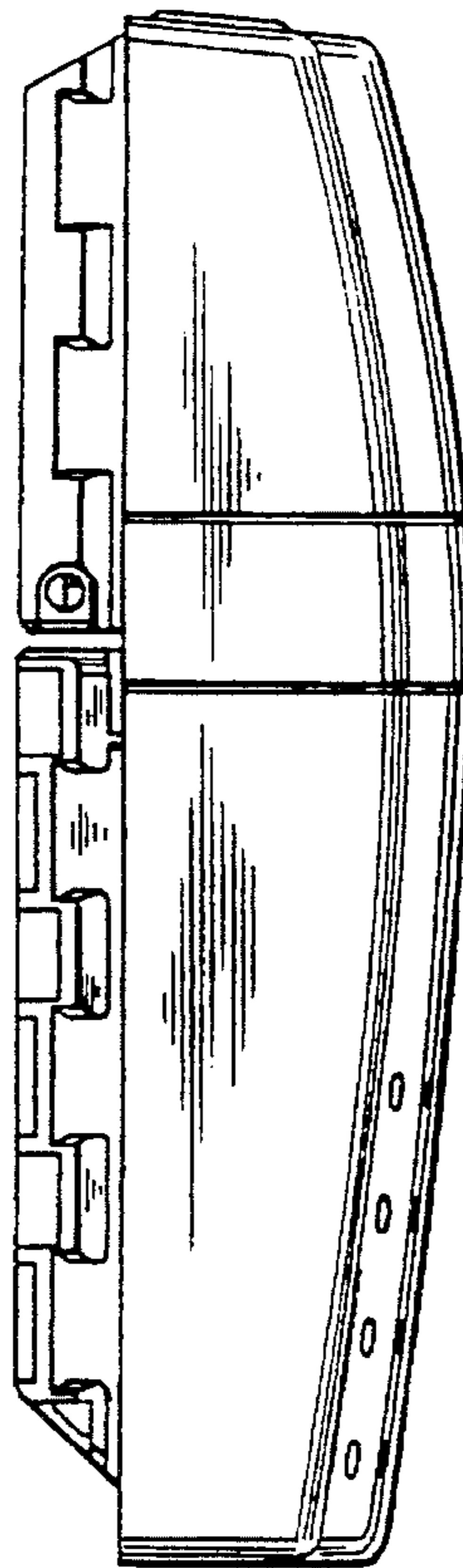
