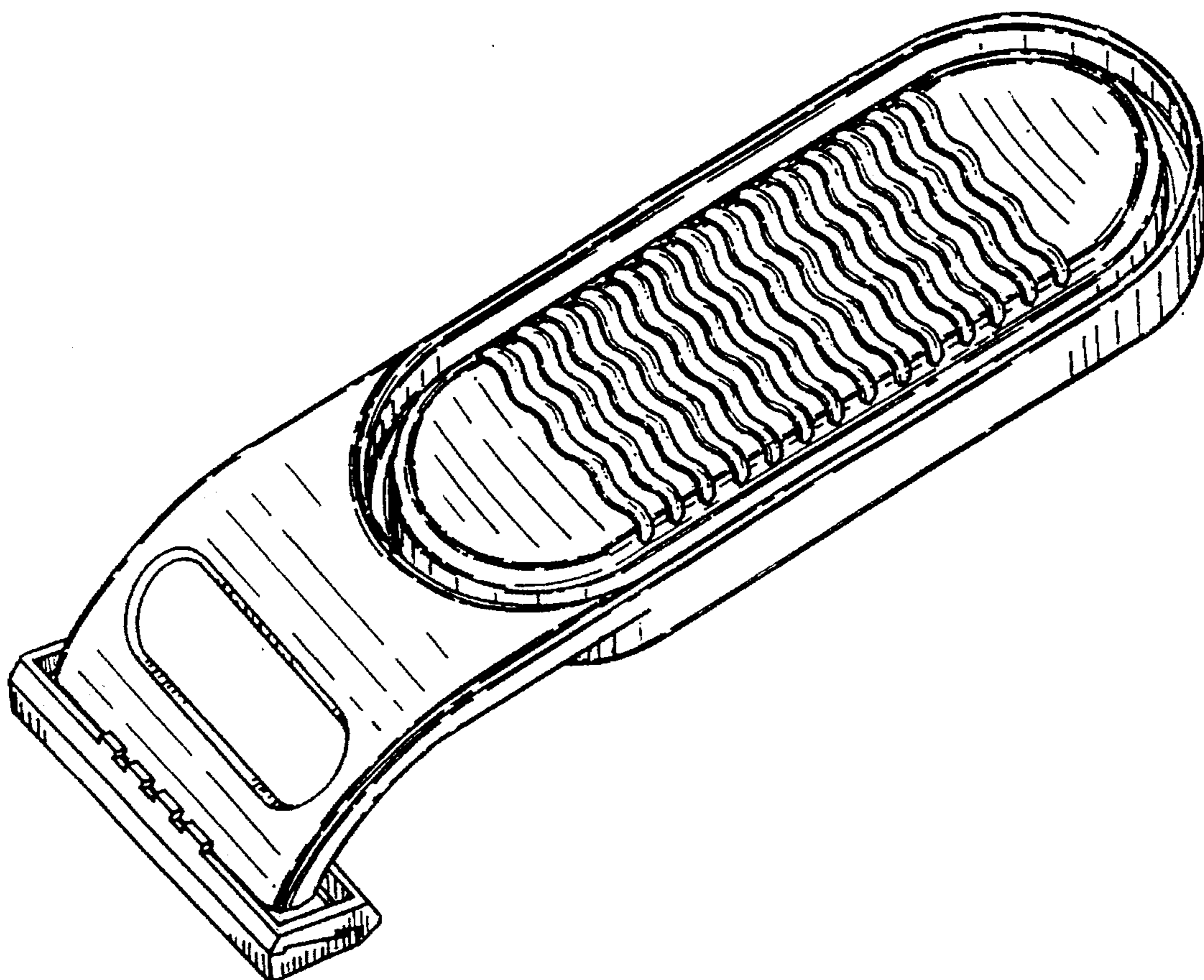

FIG. 1 is a perspective top view of a razor showing my new design;  
FIG. 2 is a perspective bottom view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;  
FIG. 6 is a cross-sectional view taken along the line 6—6 of FIG. 3.  
FIG. 7 is a front elevational view thereof; and,  
FIG. 8 is a rear elevational view thereof.

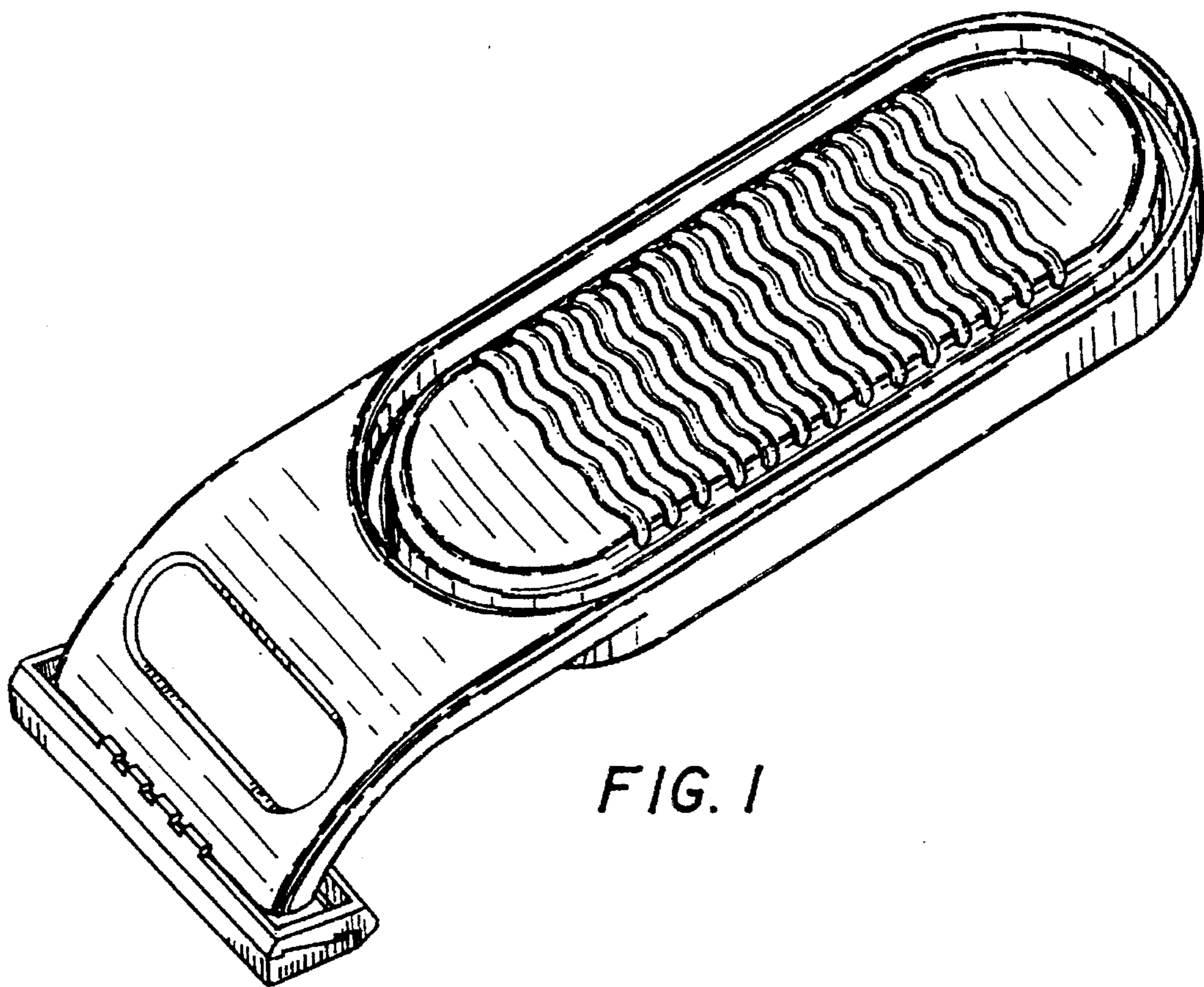

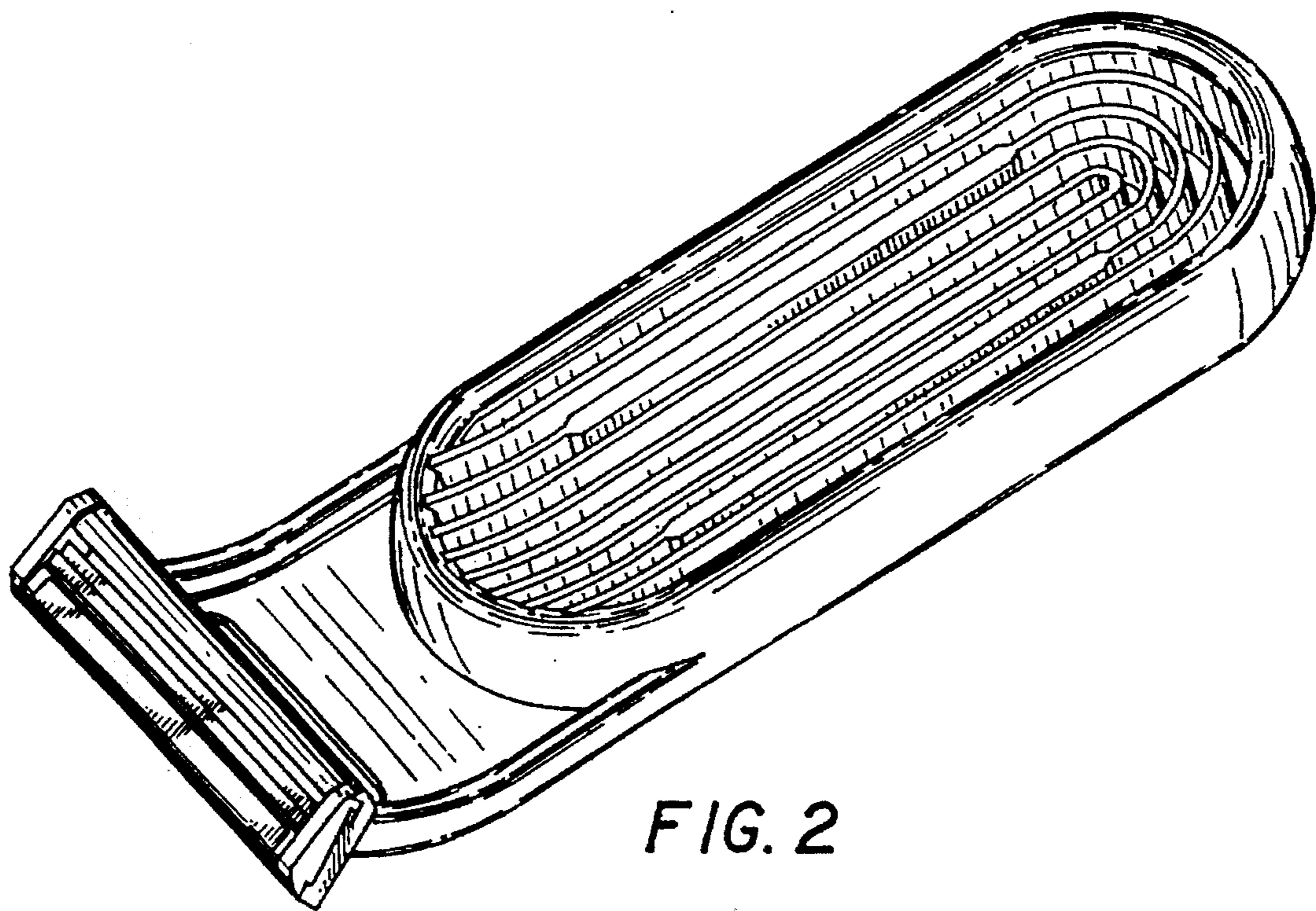

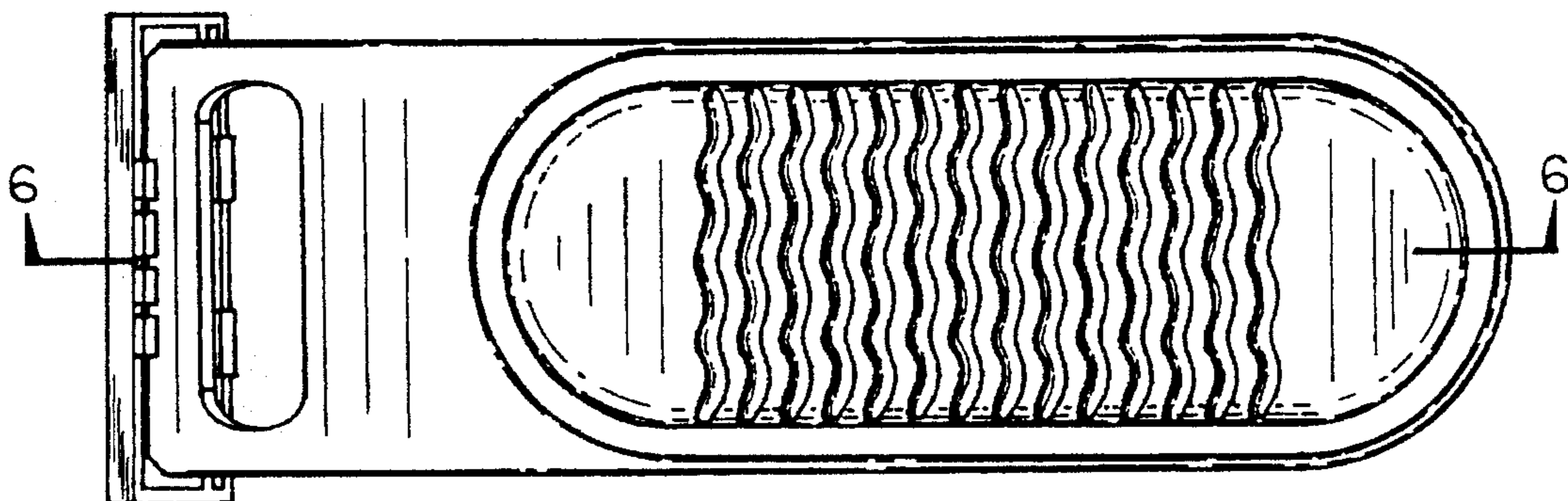

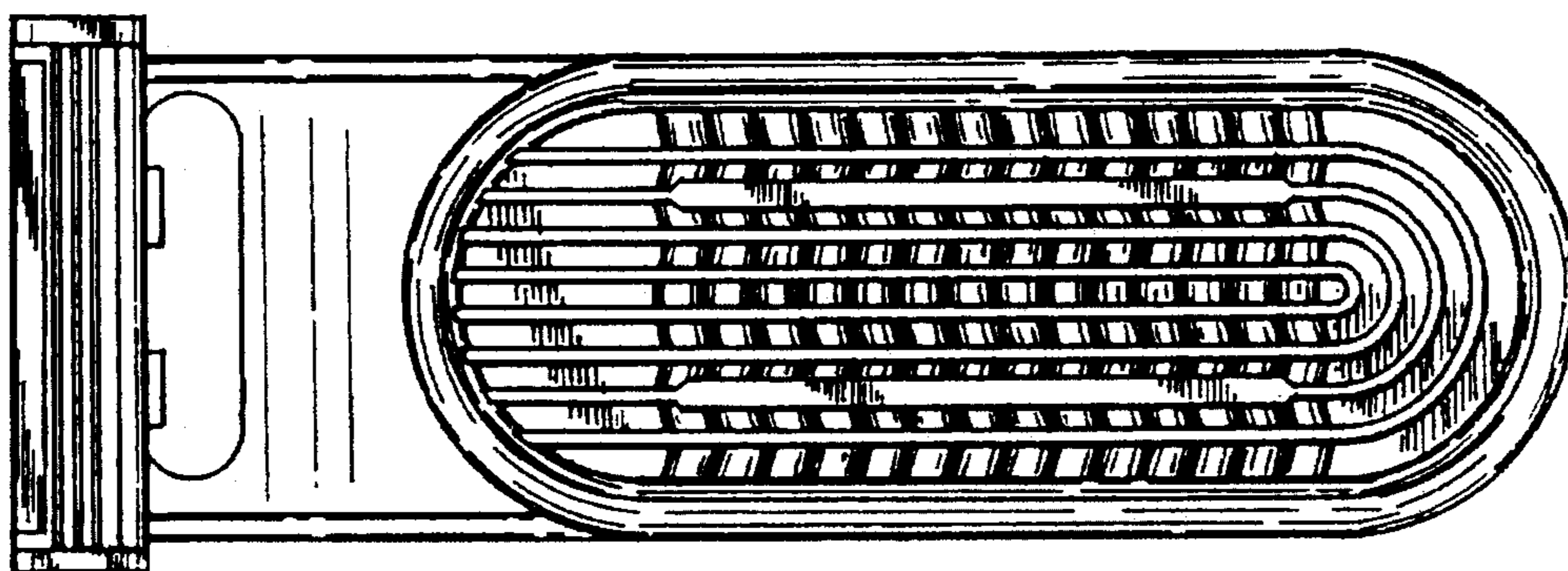

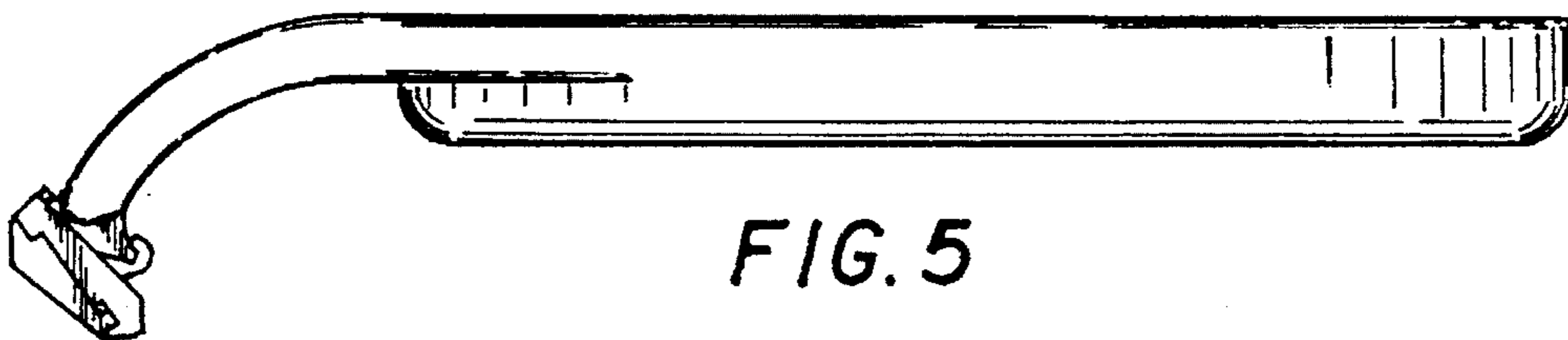

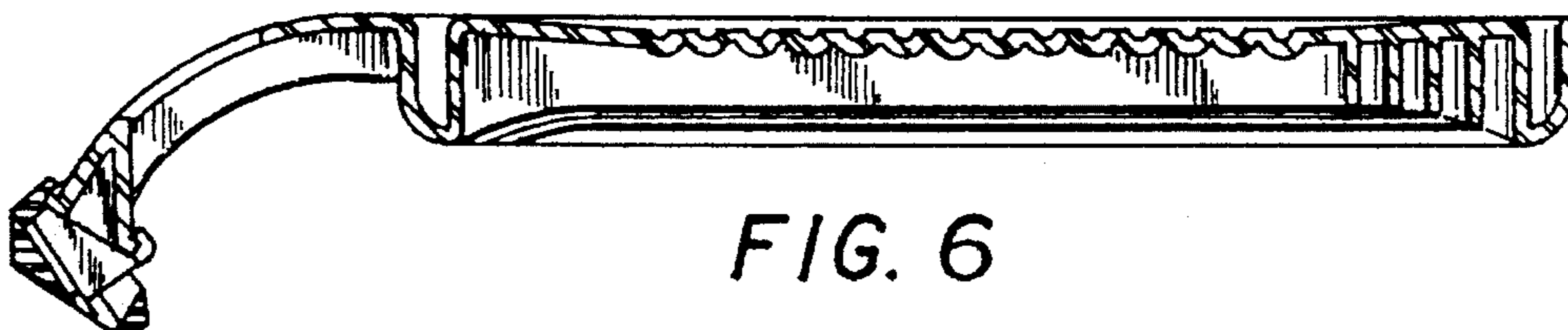
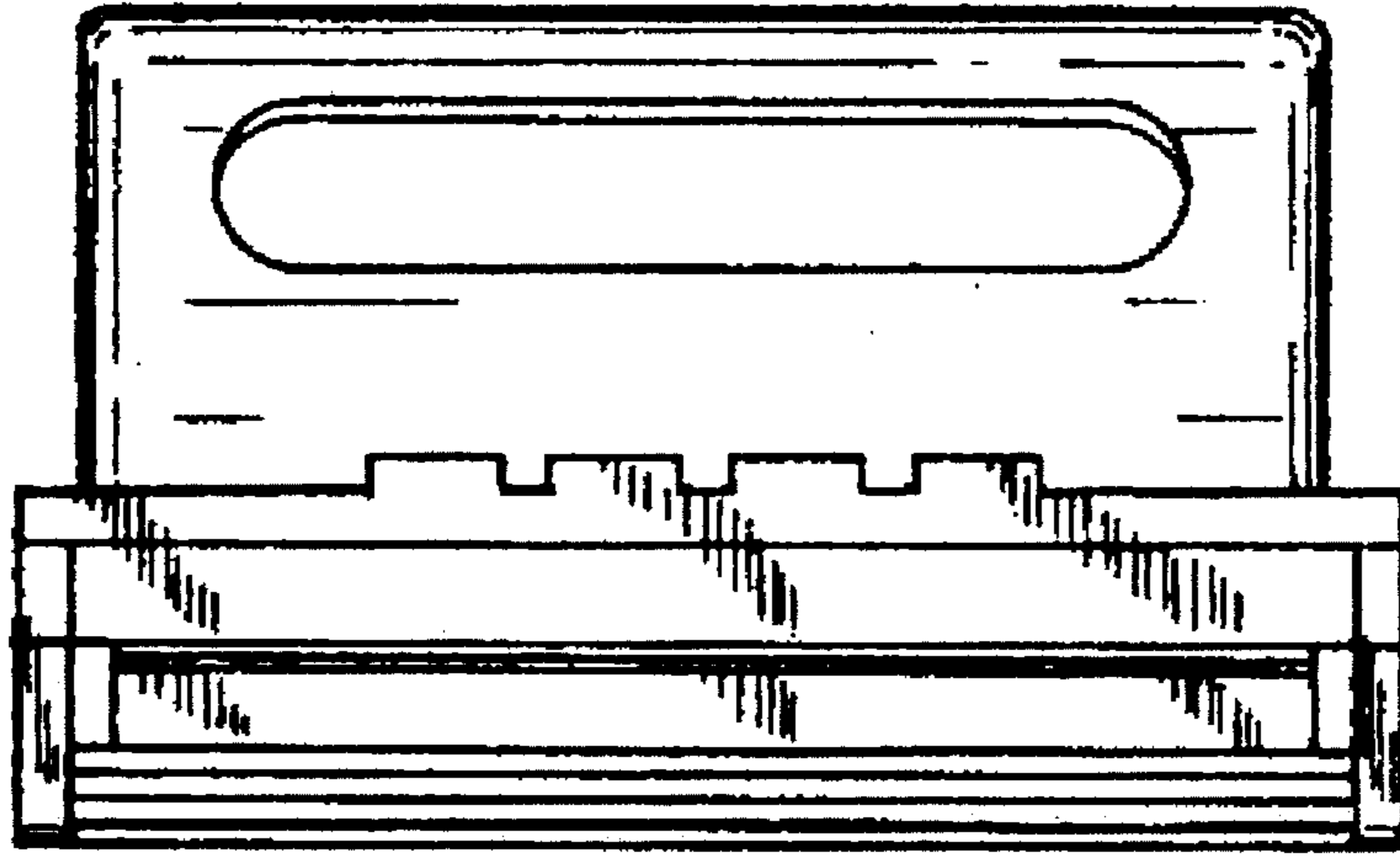
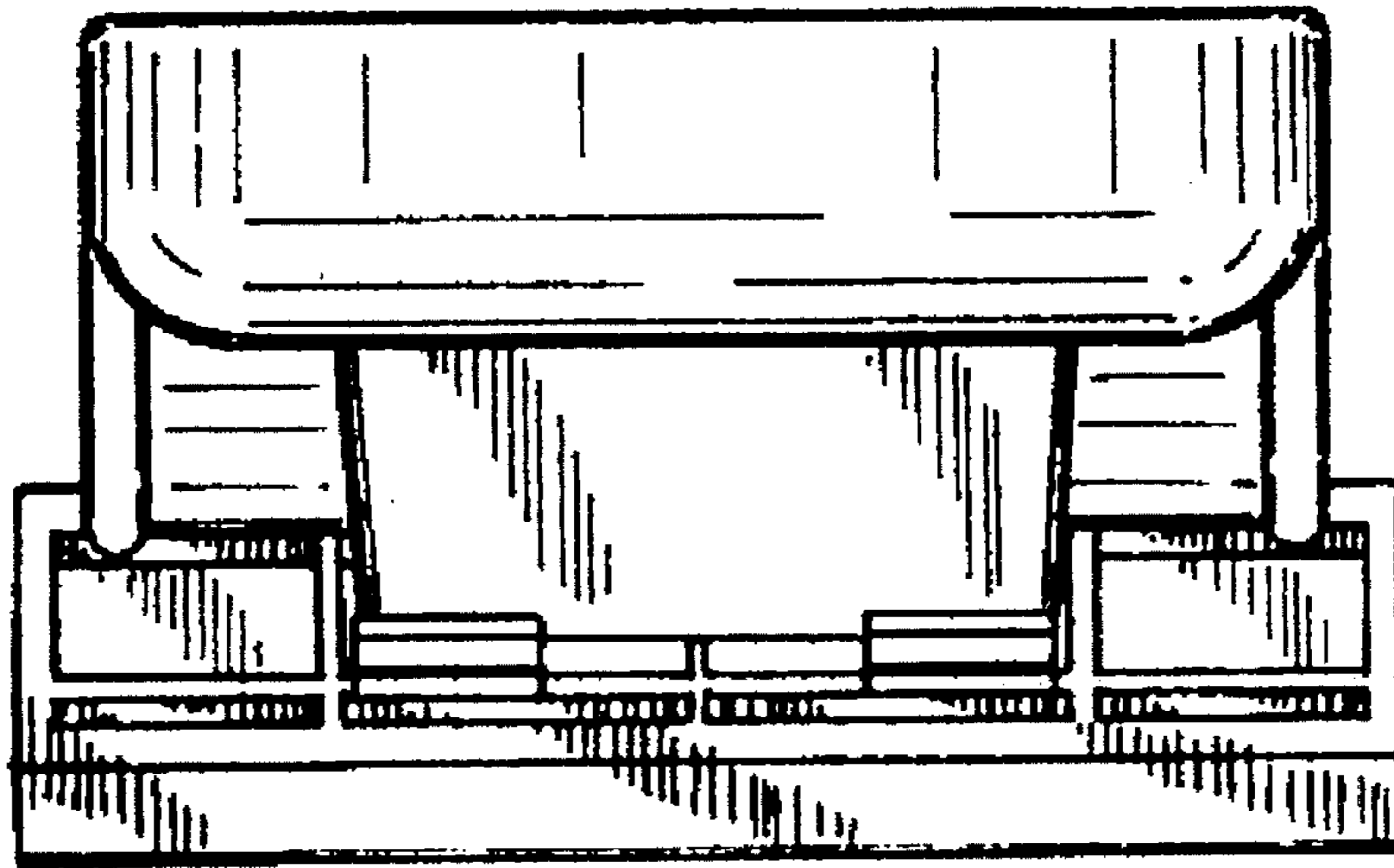
