The ornamental design for seating furniture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of seating furniture

according to my new design and specifically illustrating as a first embodiment a fauteuil;

FIG. 17 is a perspective view of the seating furniture of the present invention and illustrating as a fifth embodiment a side chair;

FIG. 20 is a side elevational view thereof, the opposite side being a mirror image.

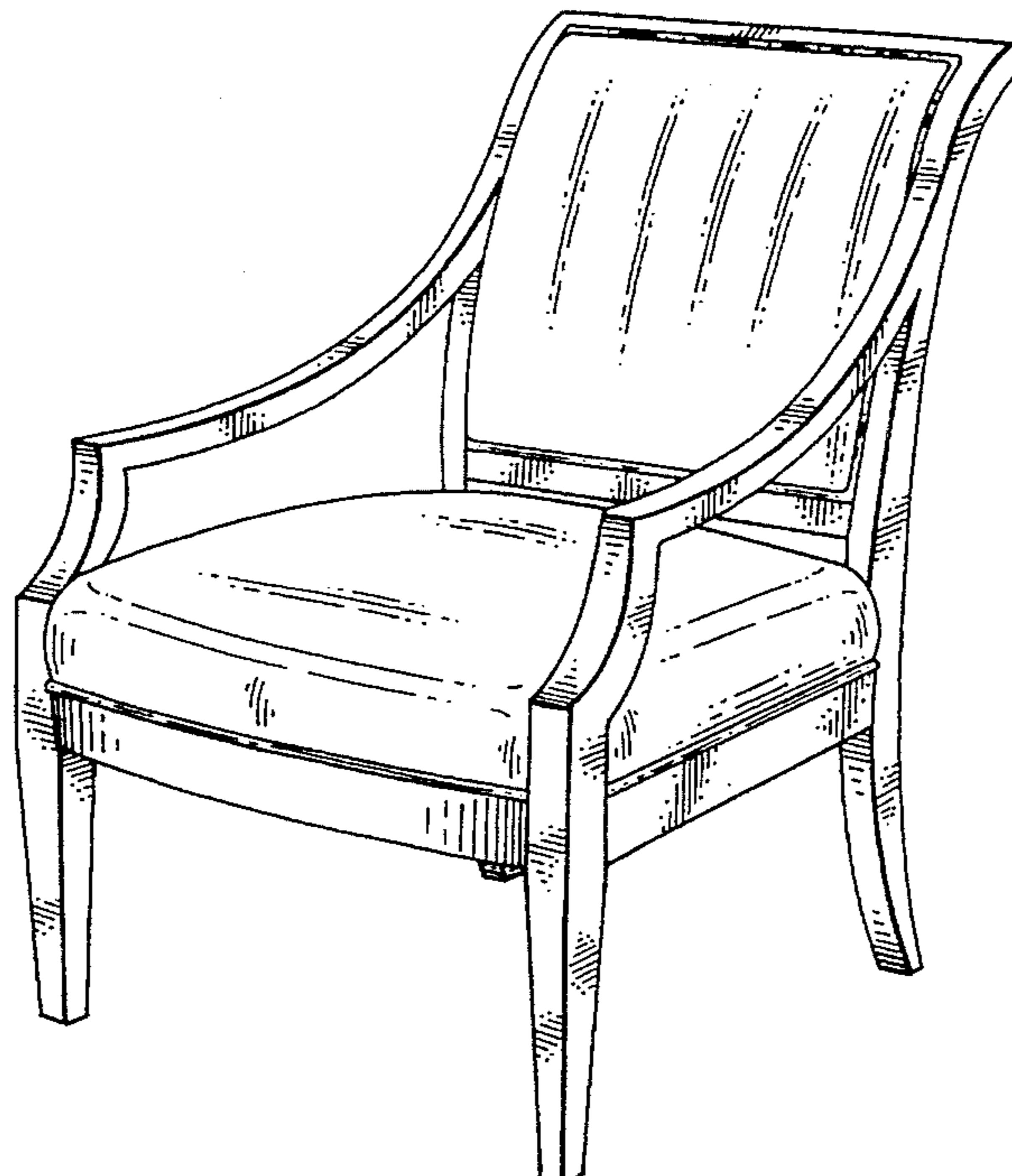

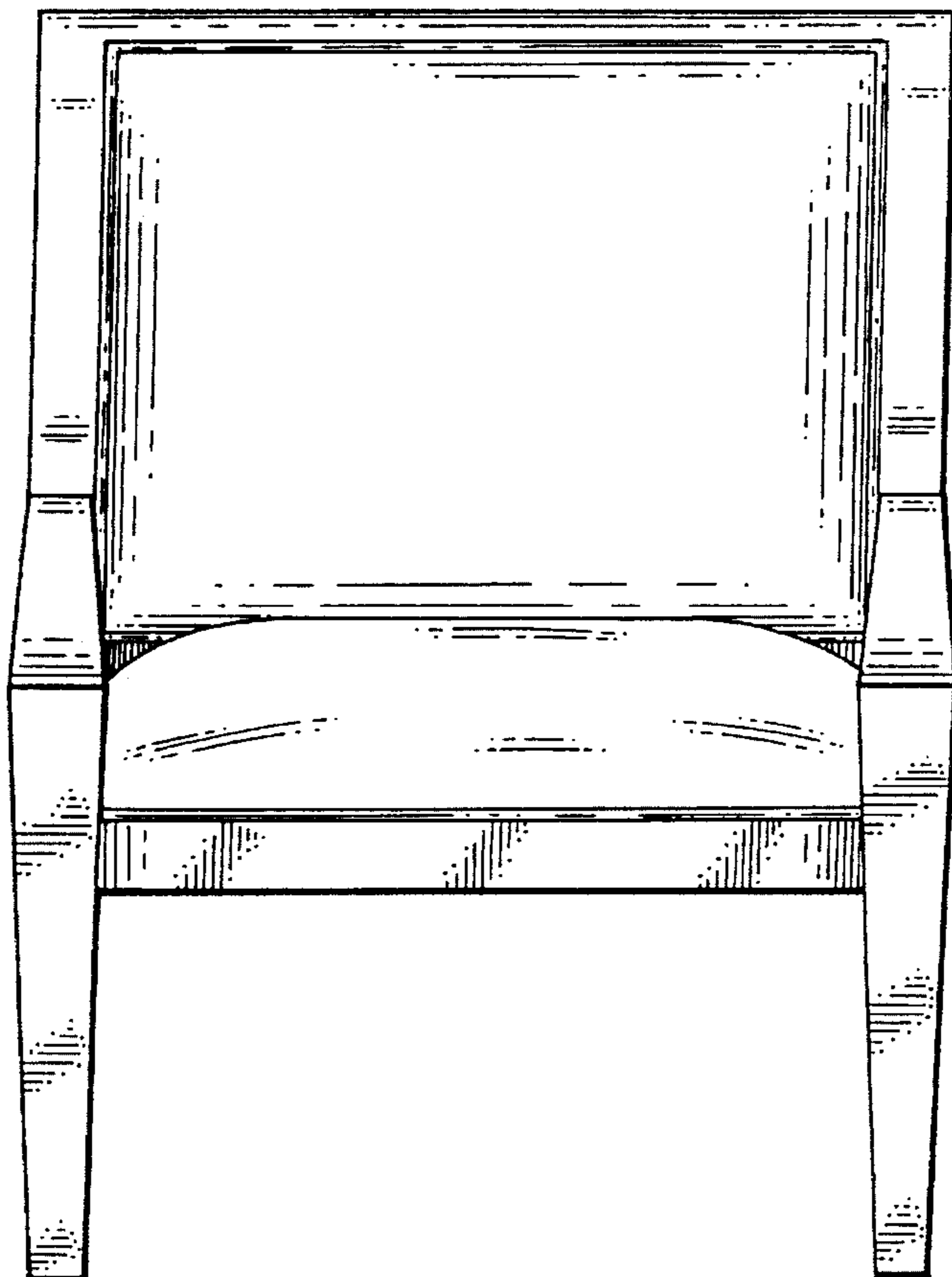
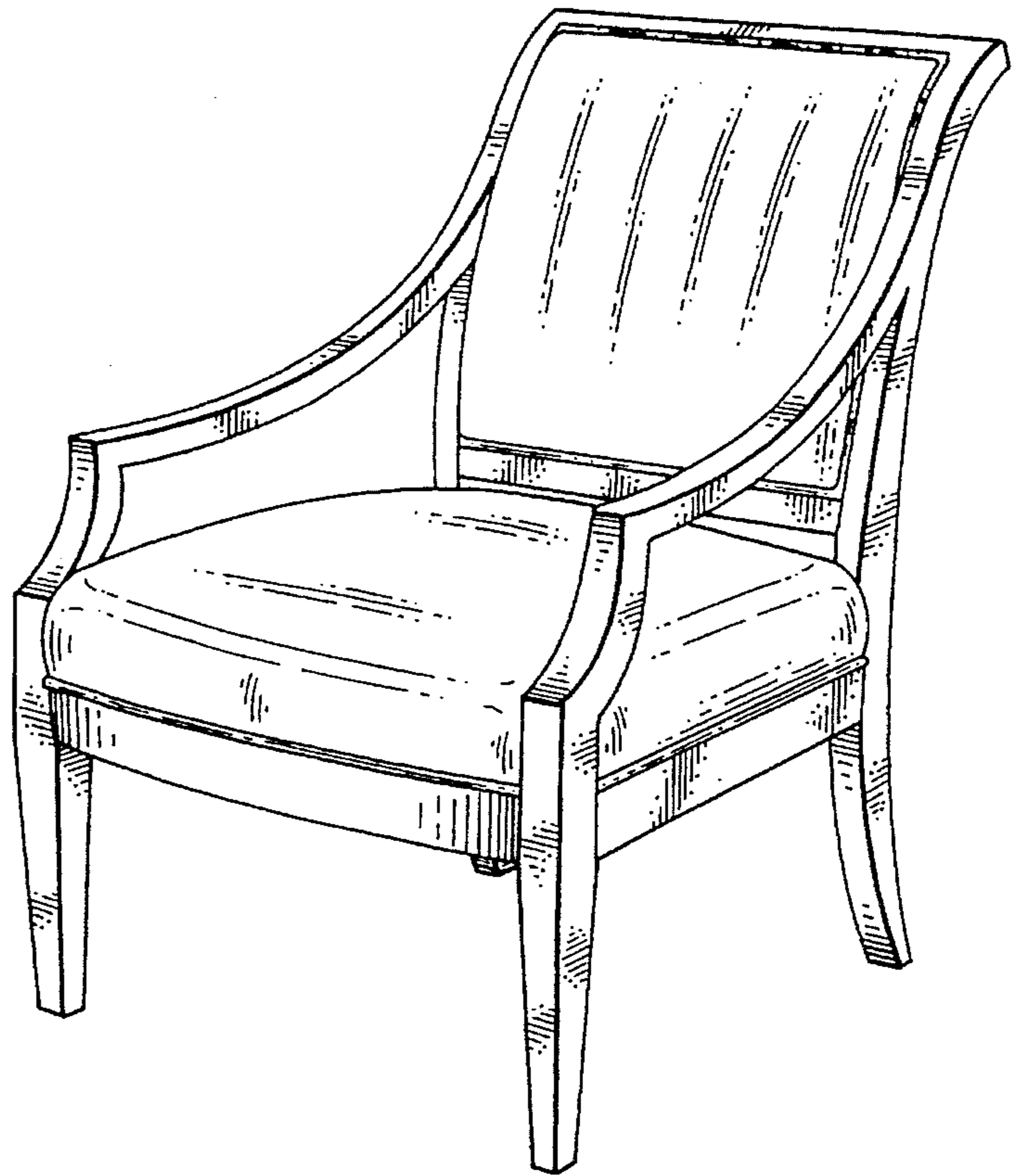

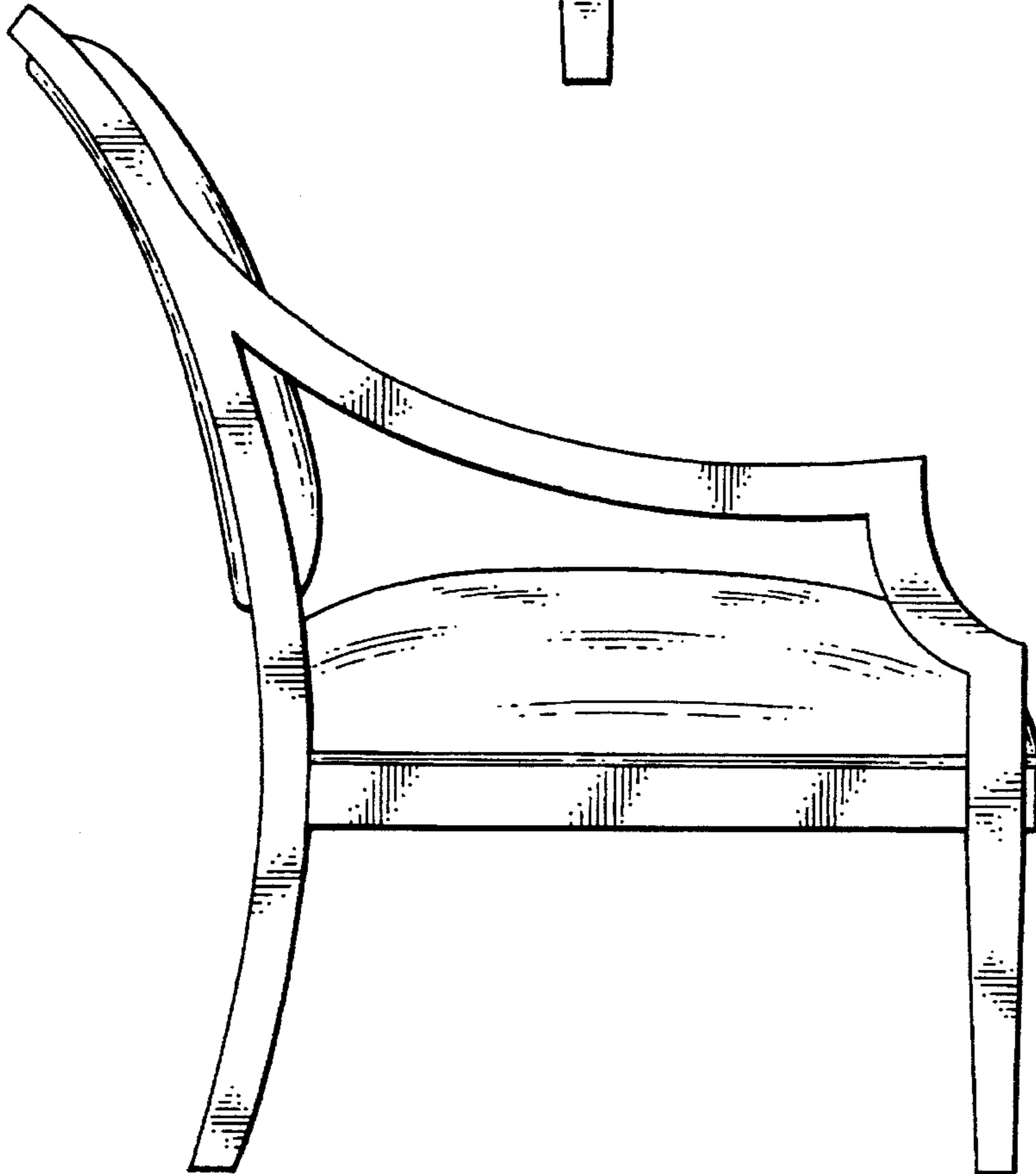
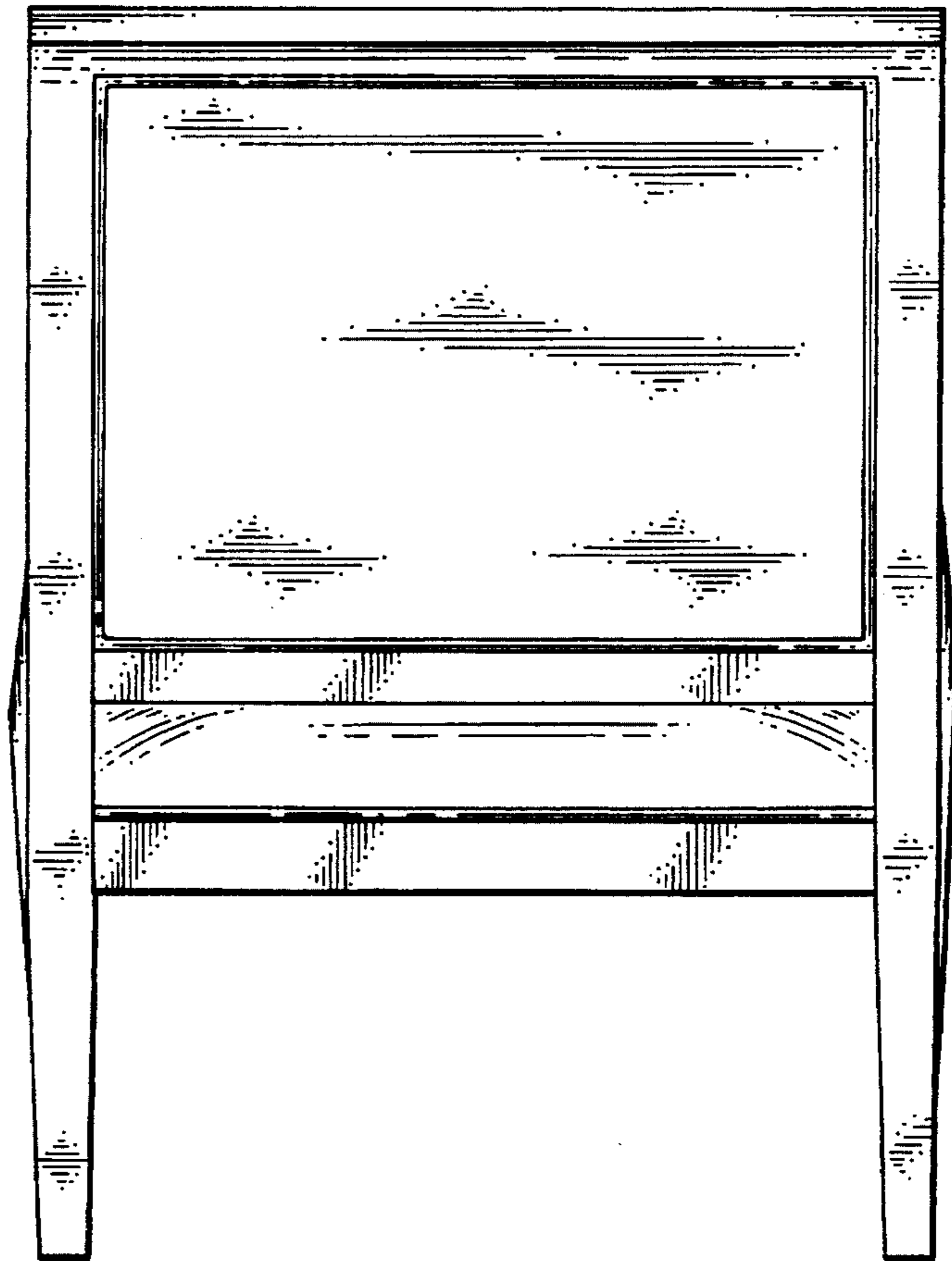

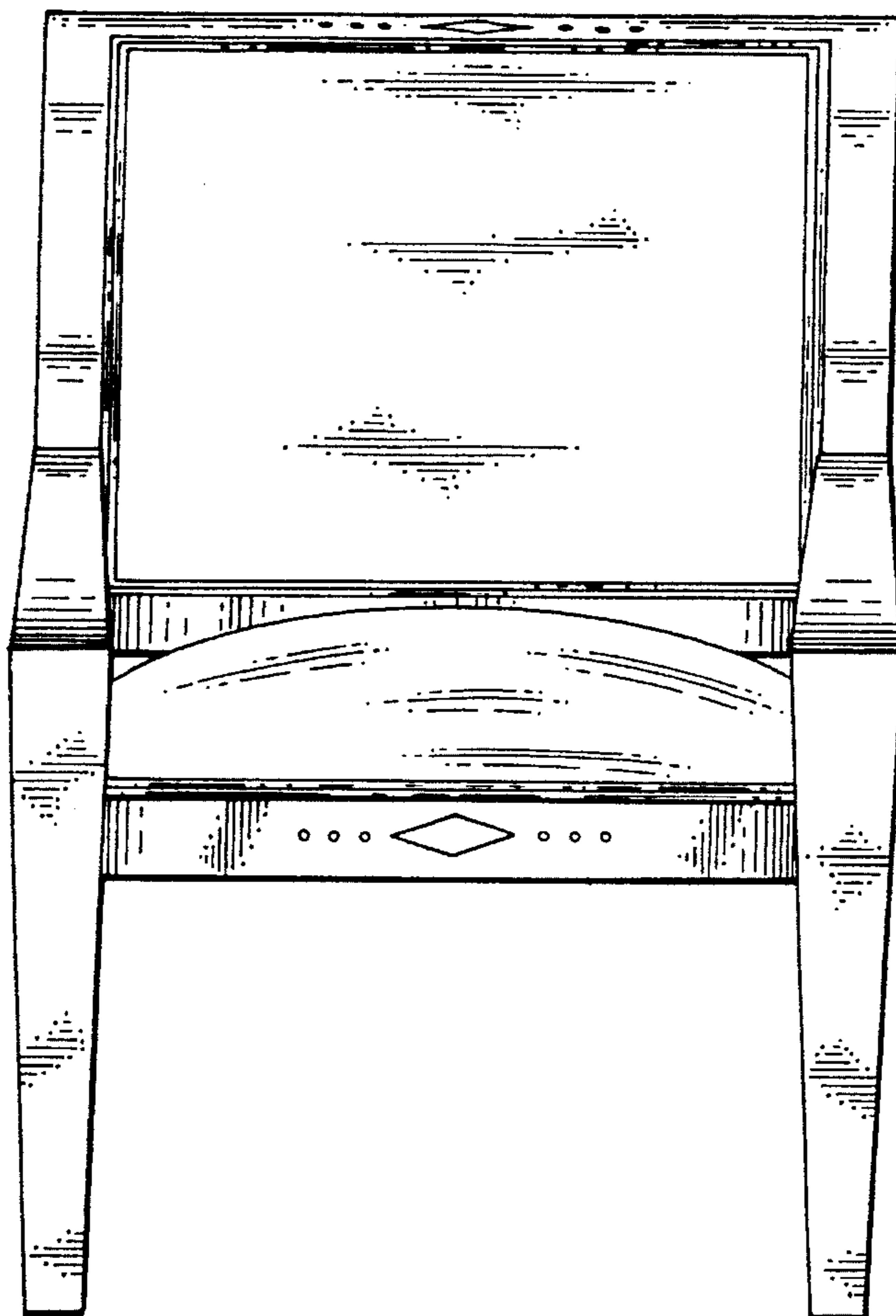
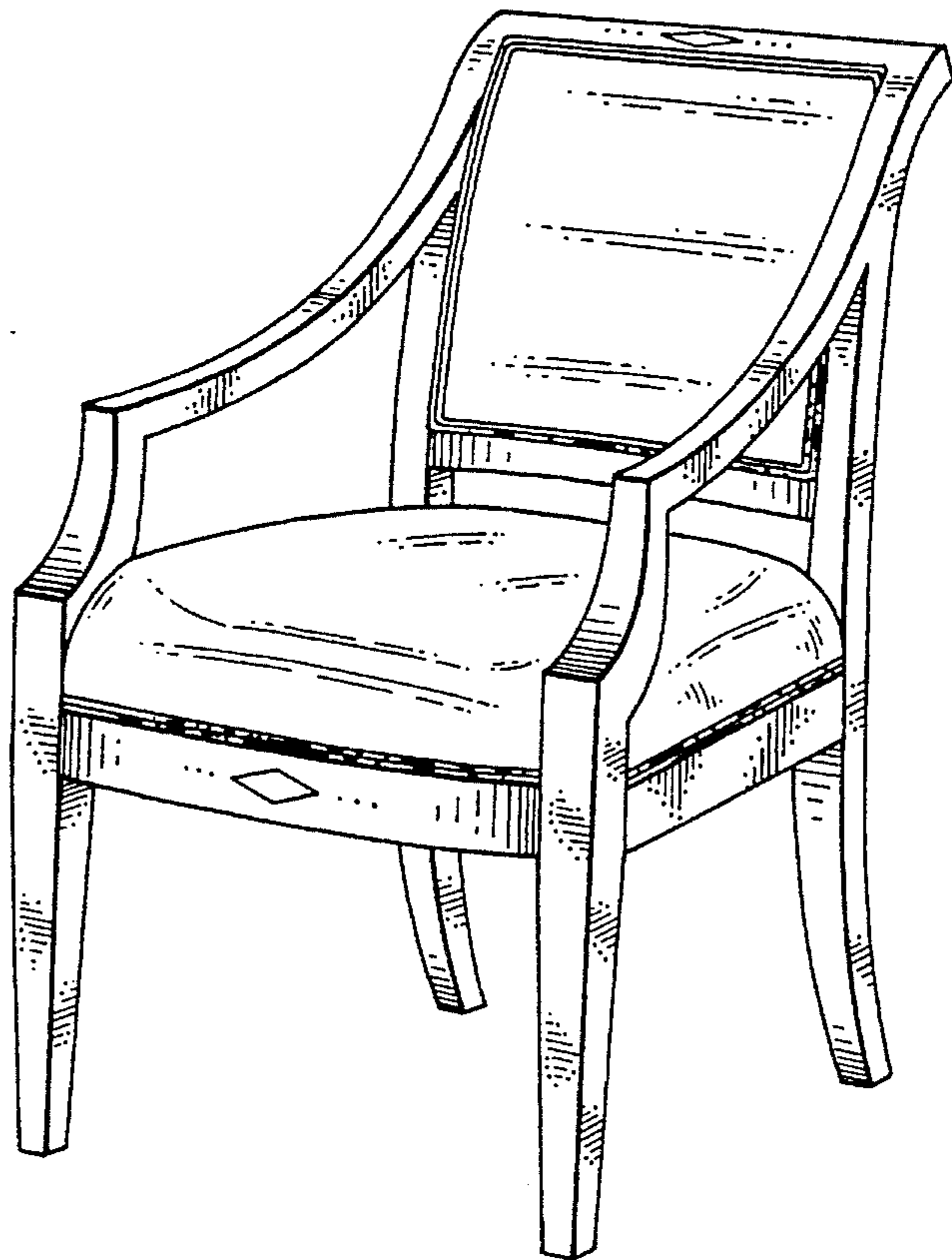

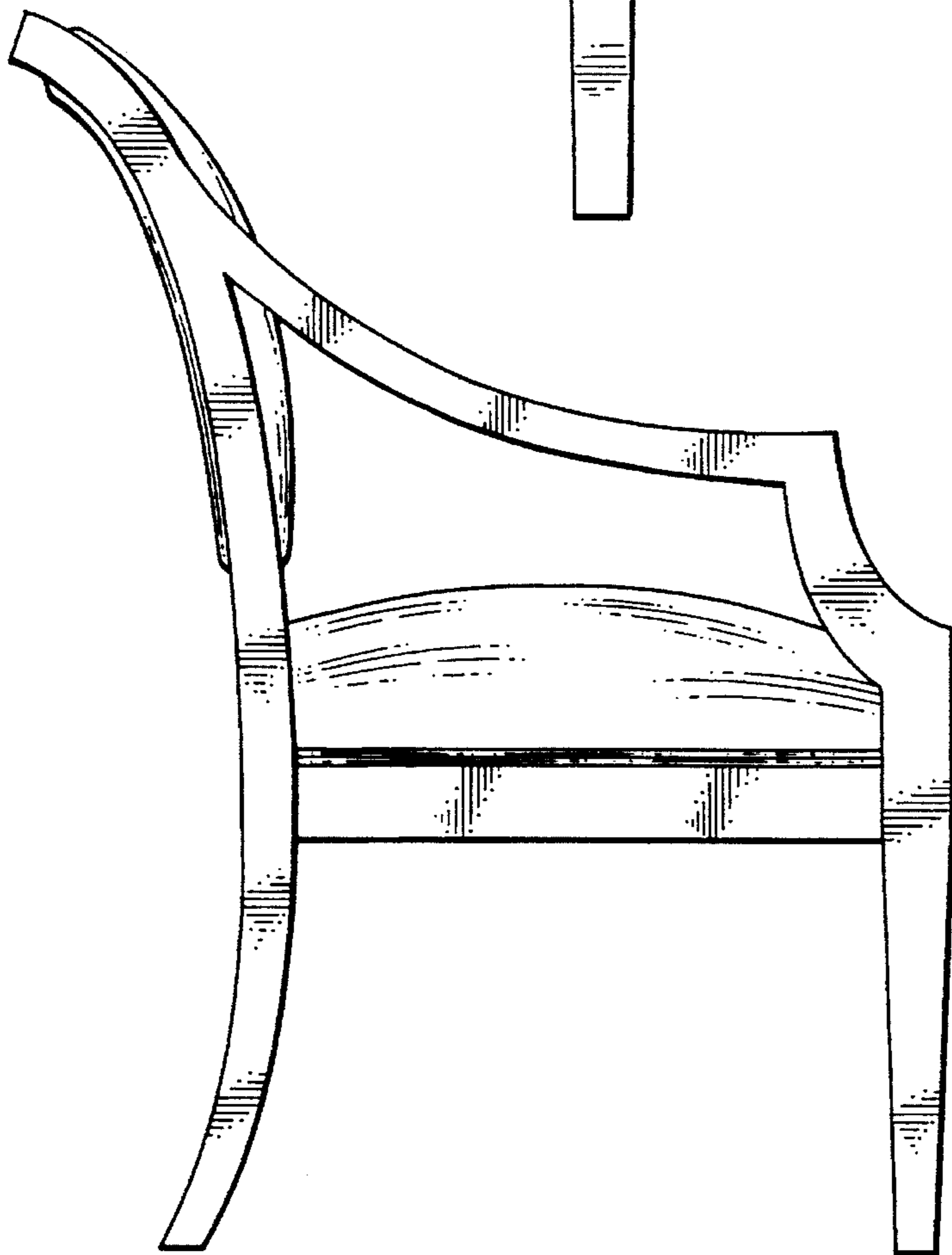
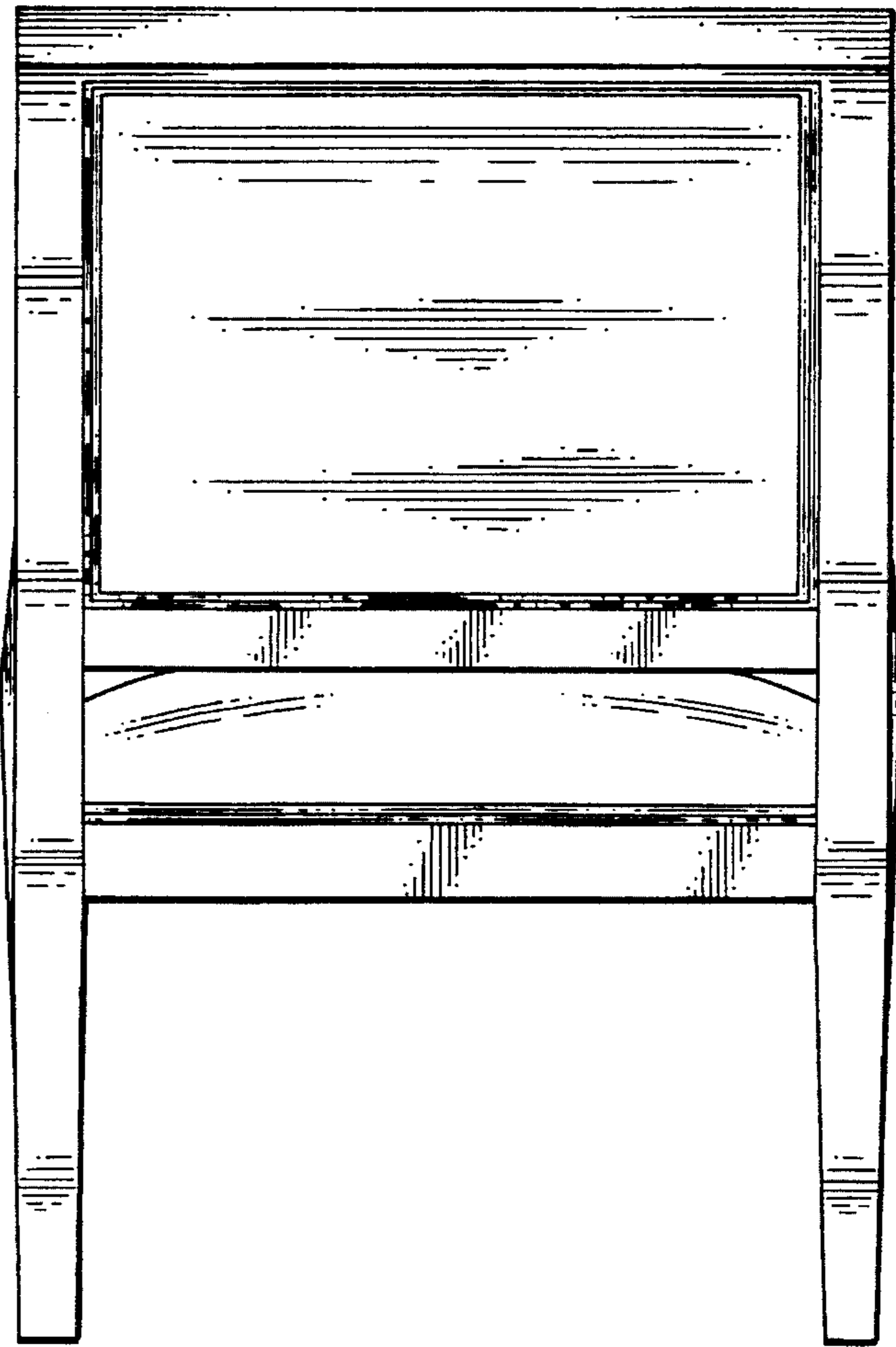

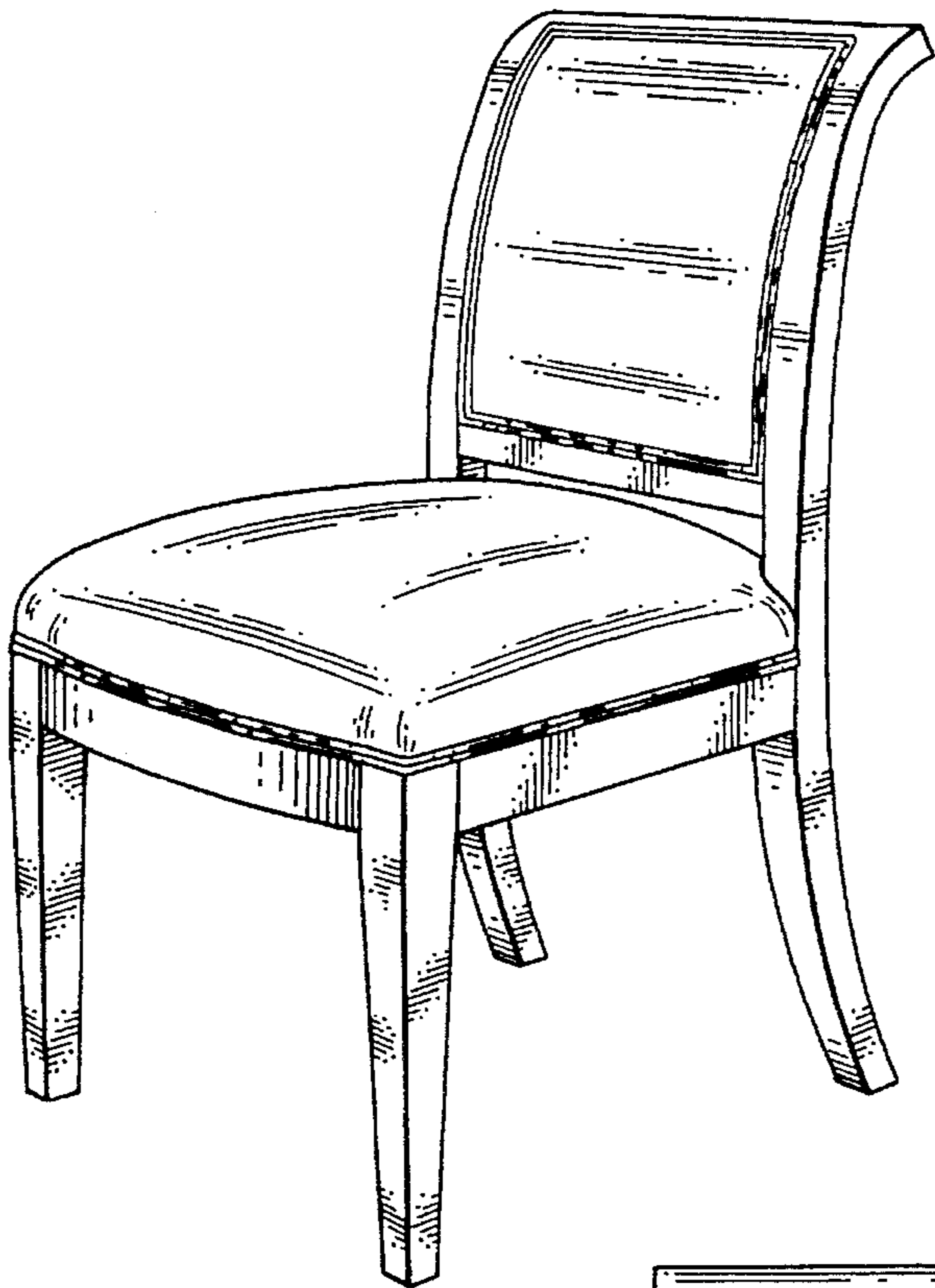

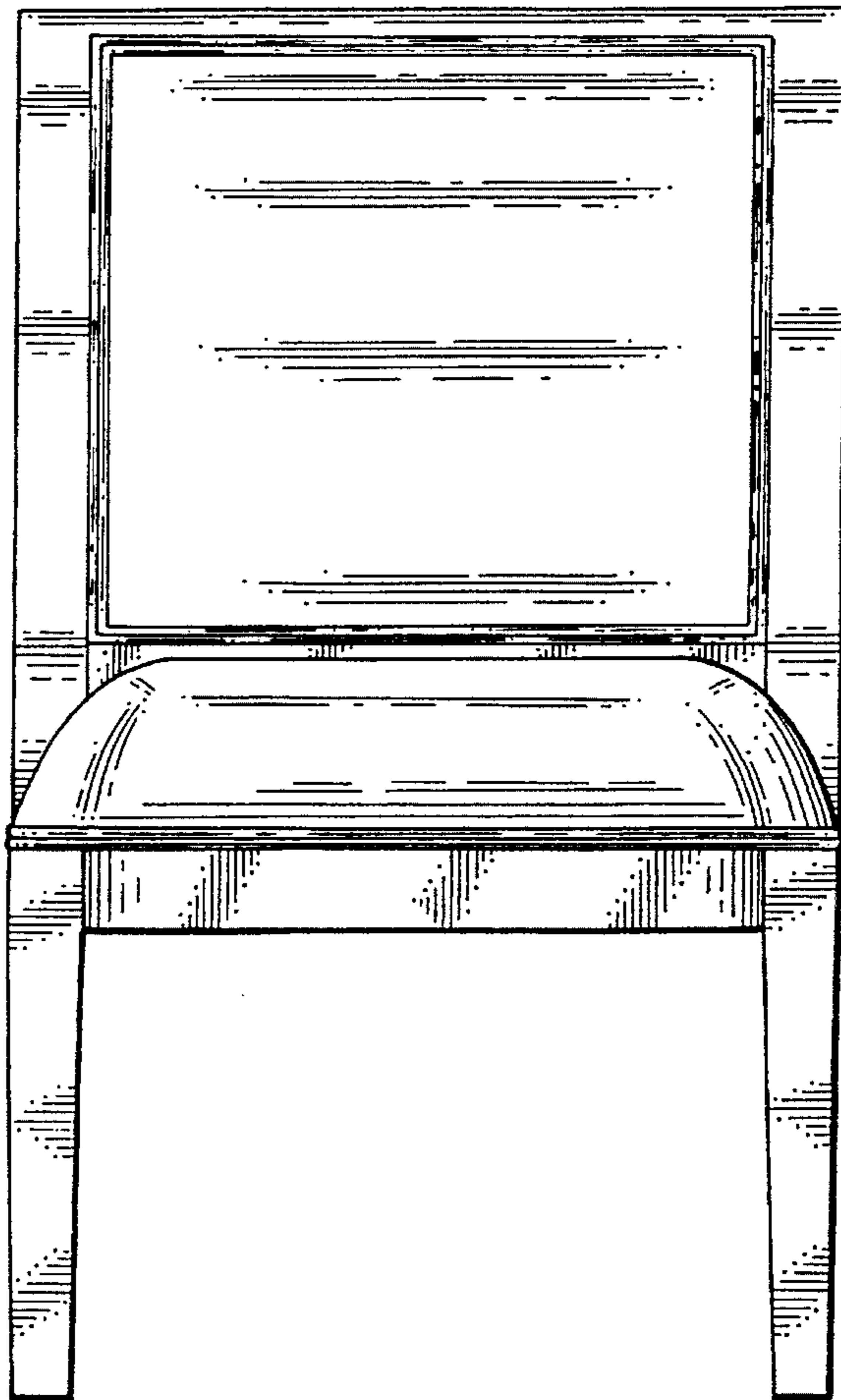

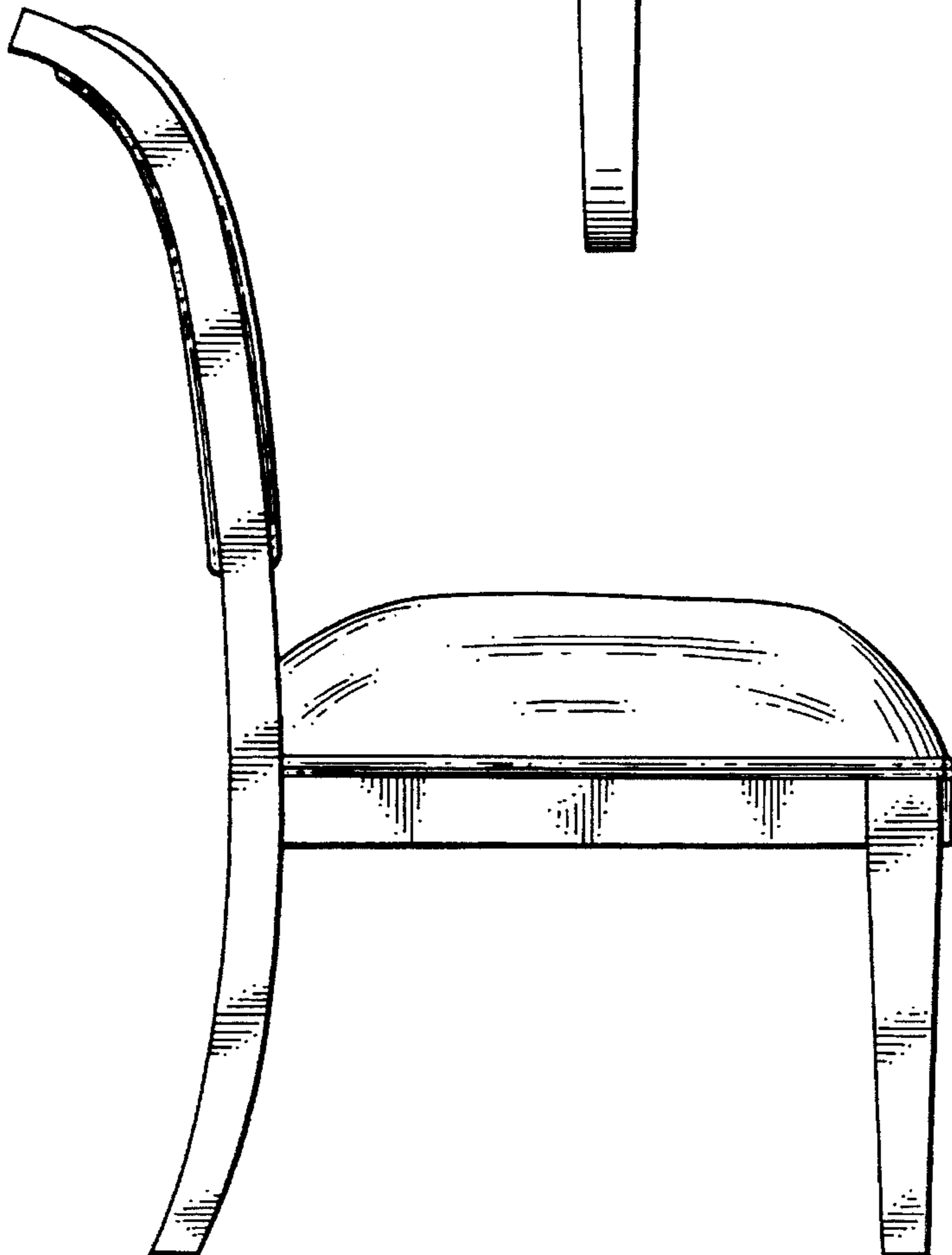
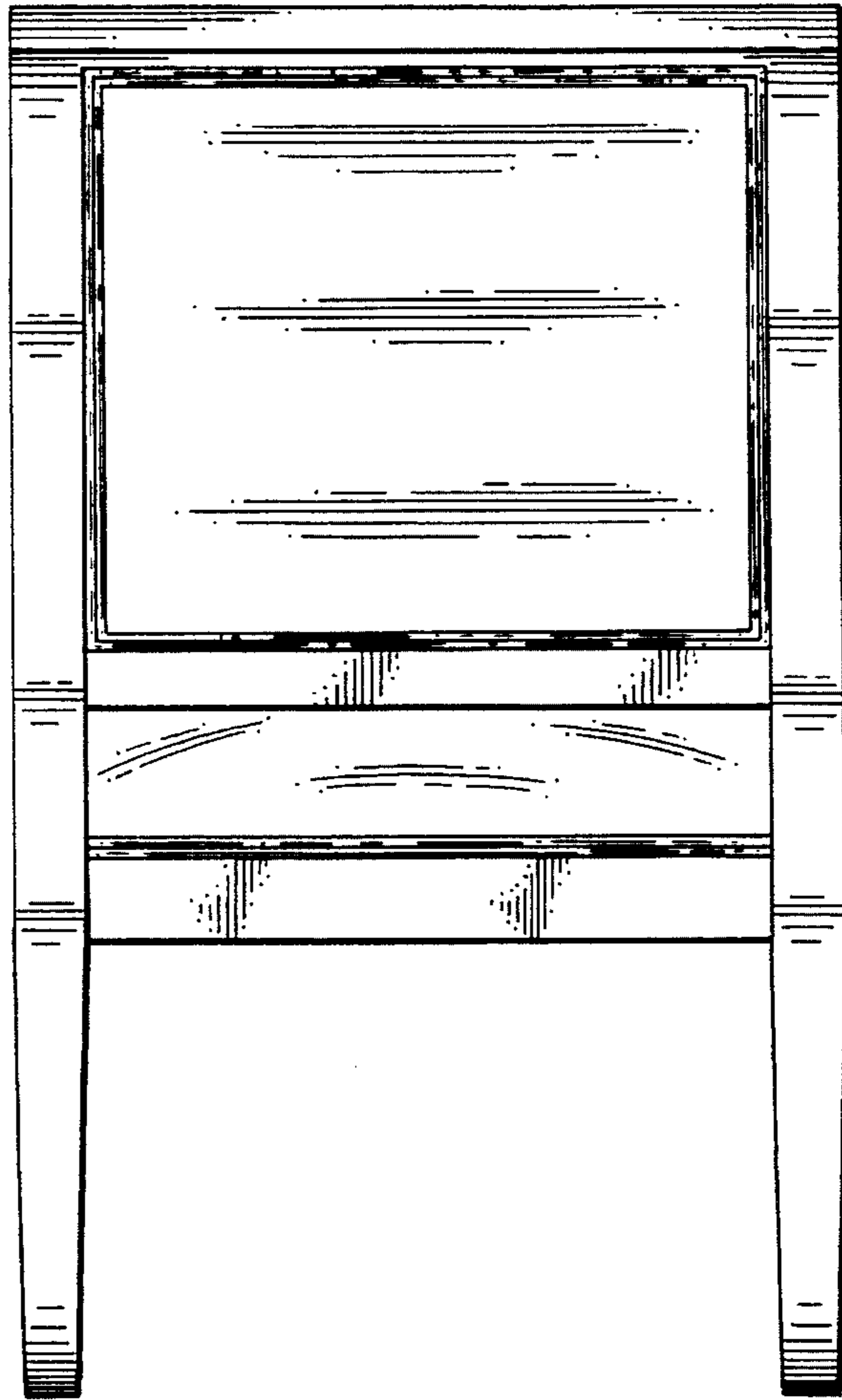

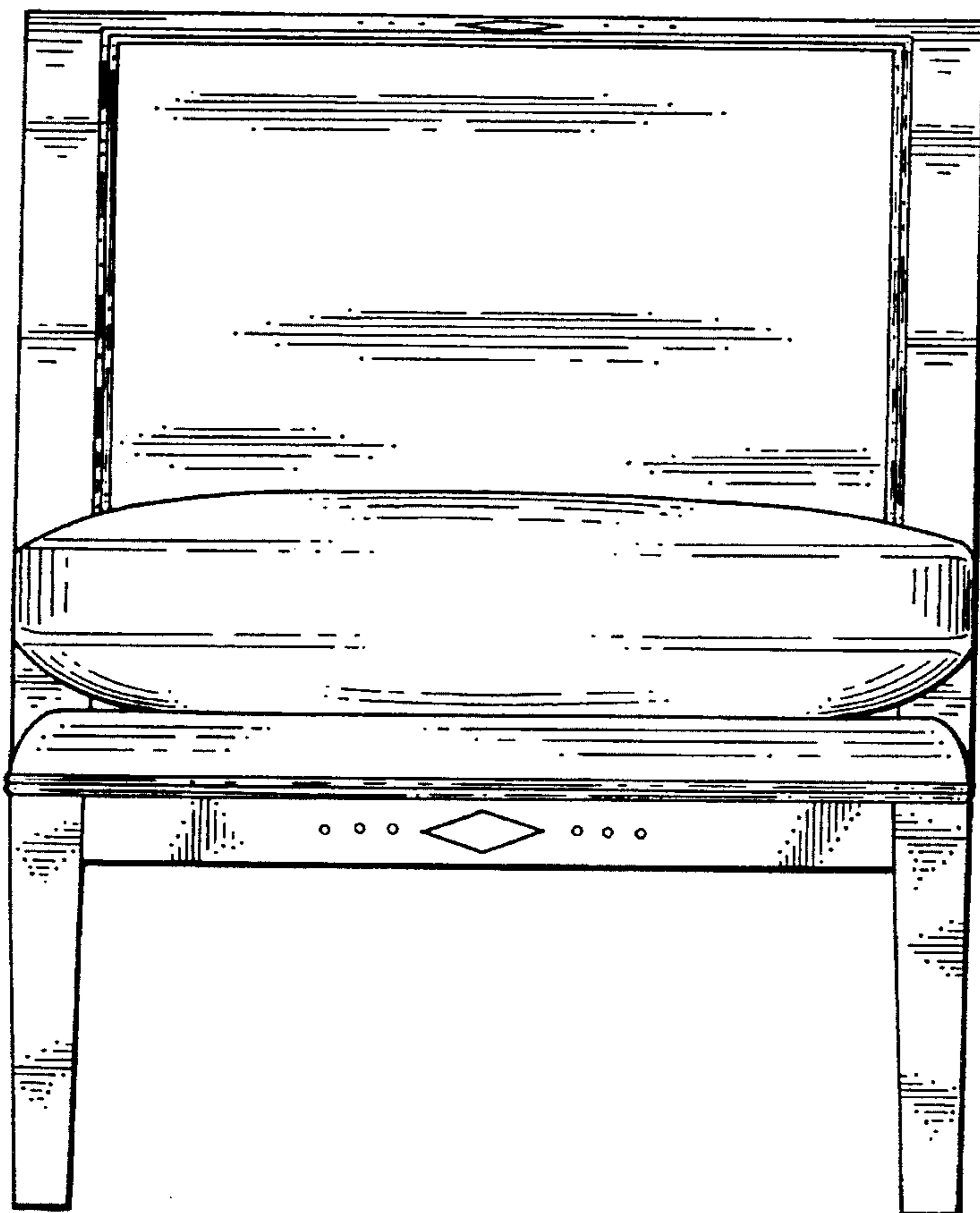
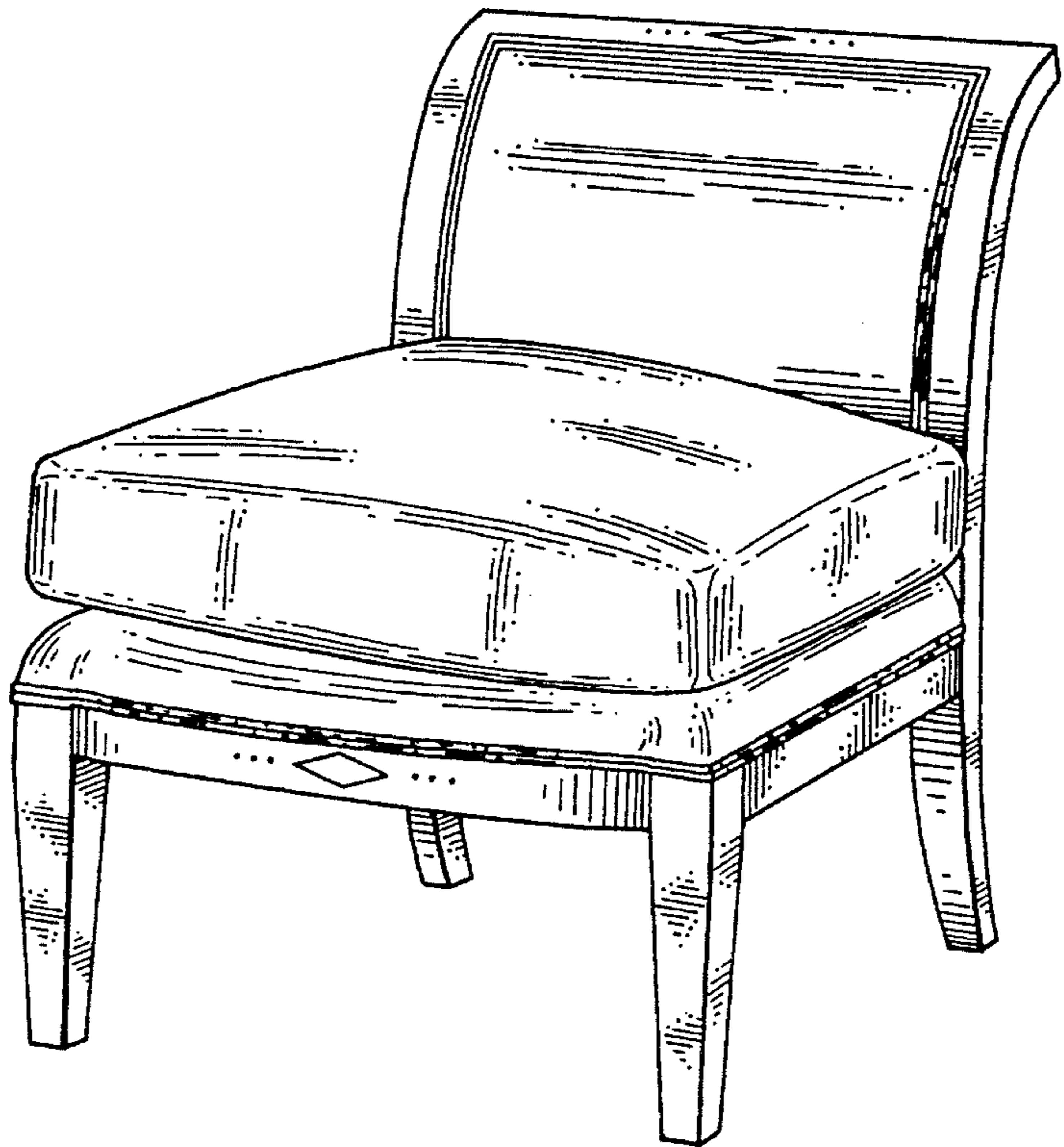

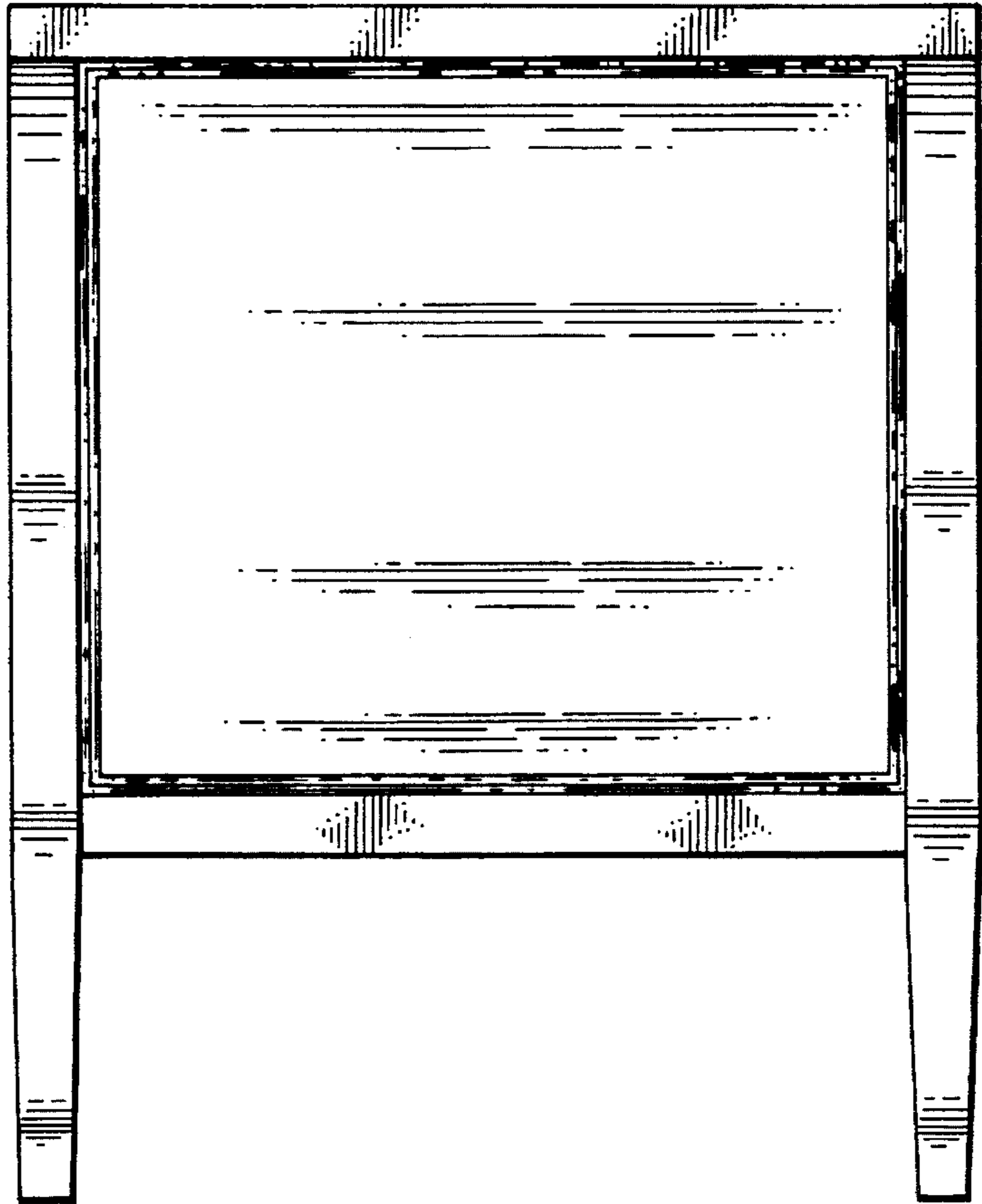
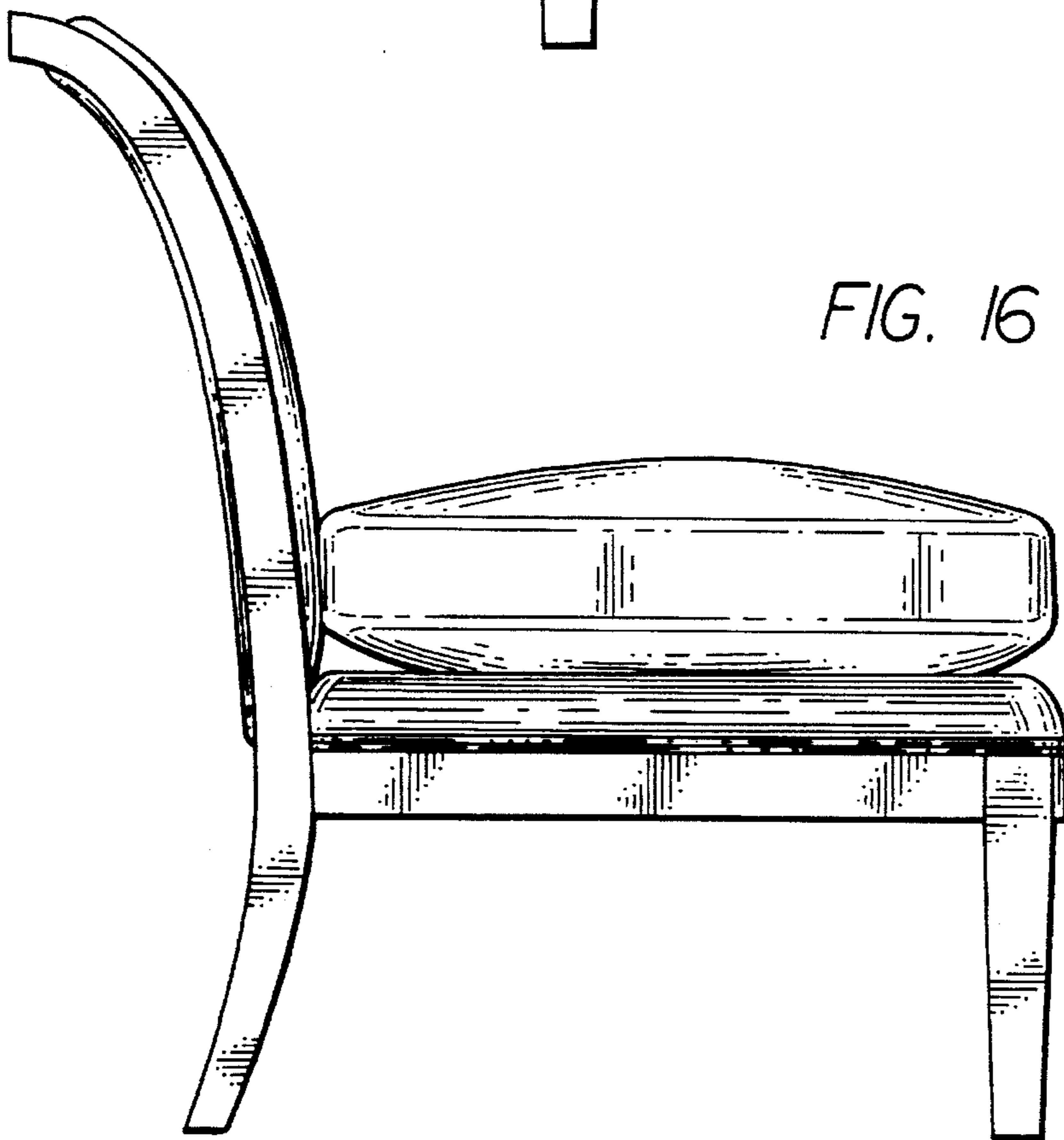

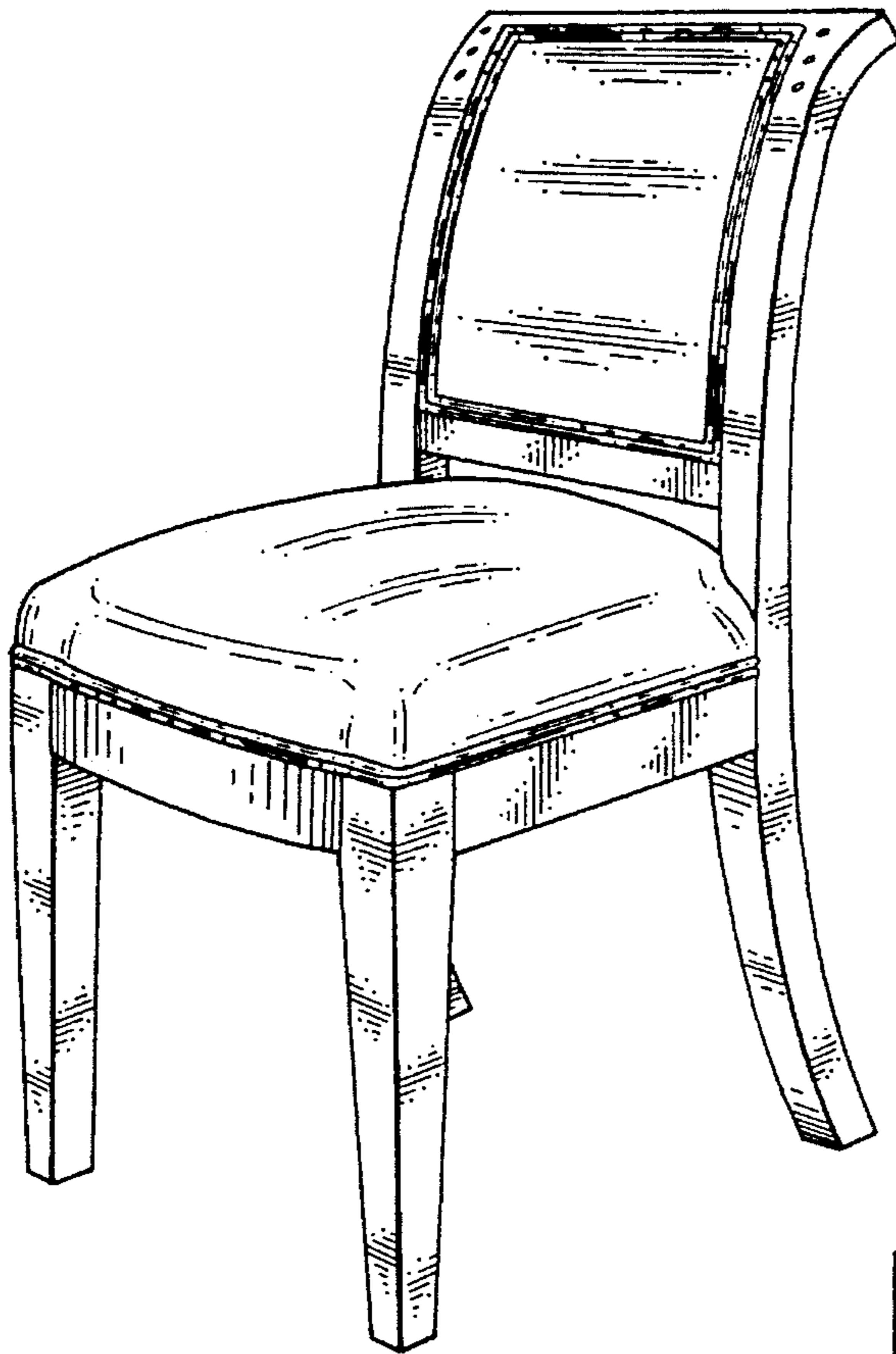

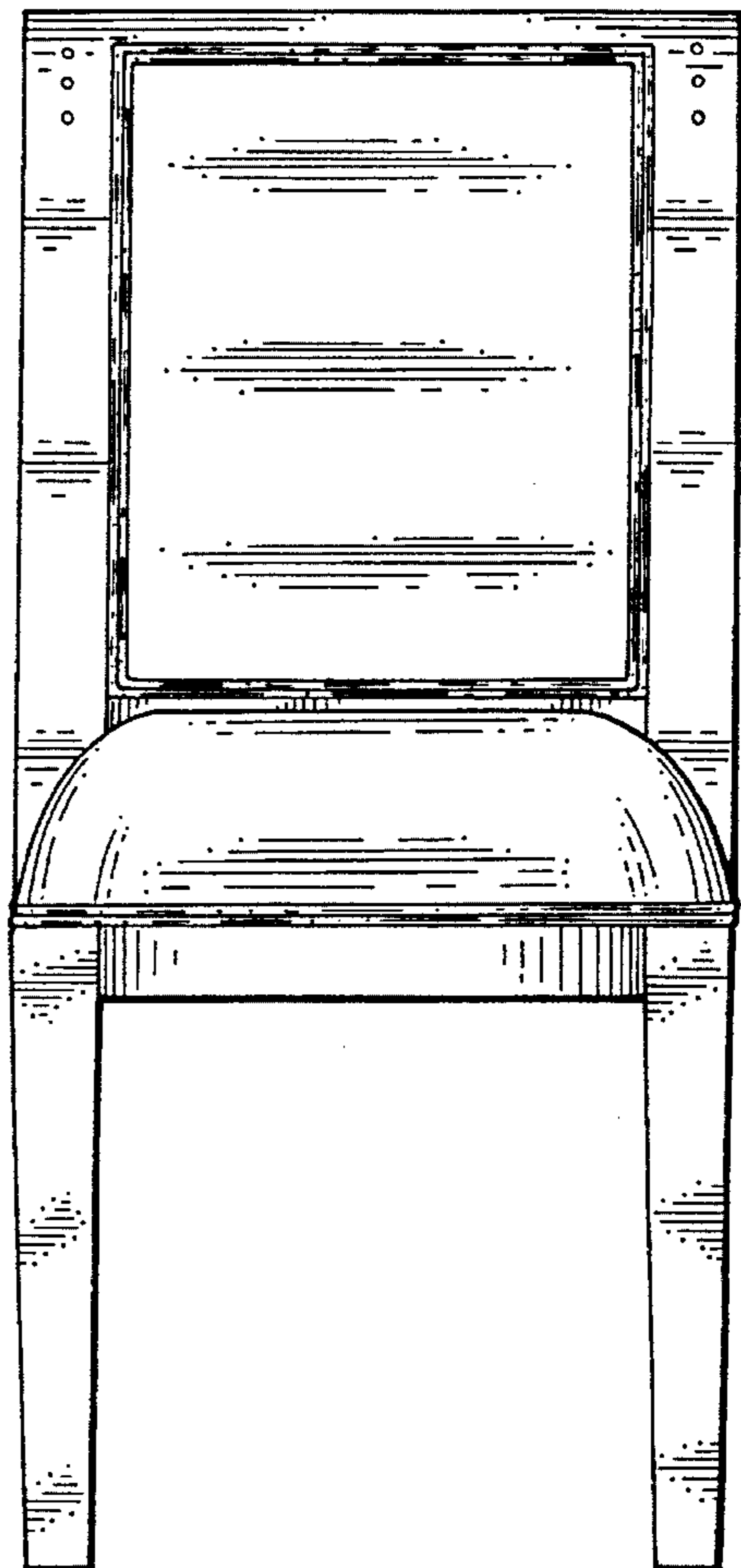

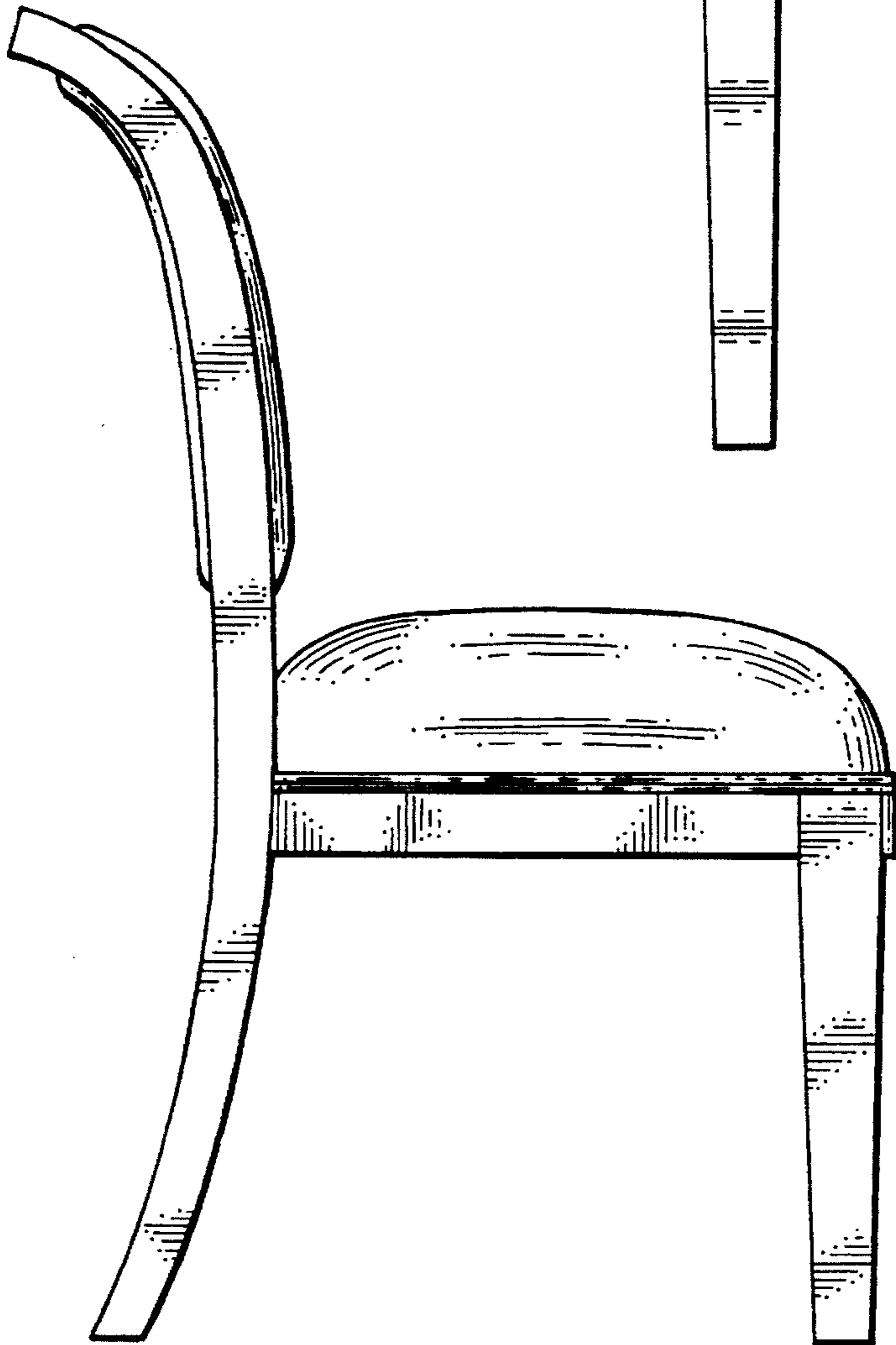
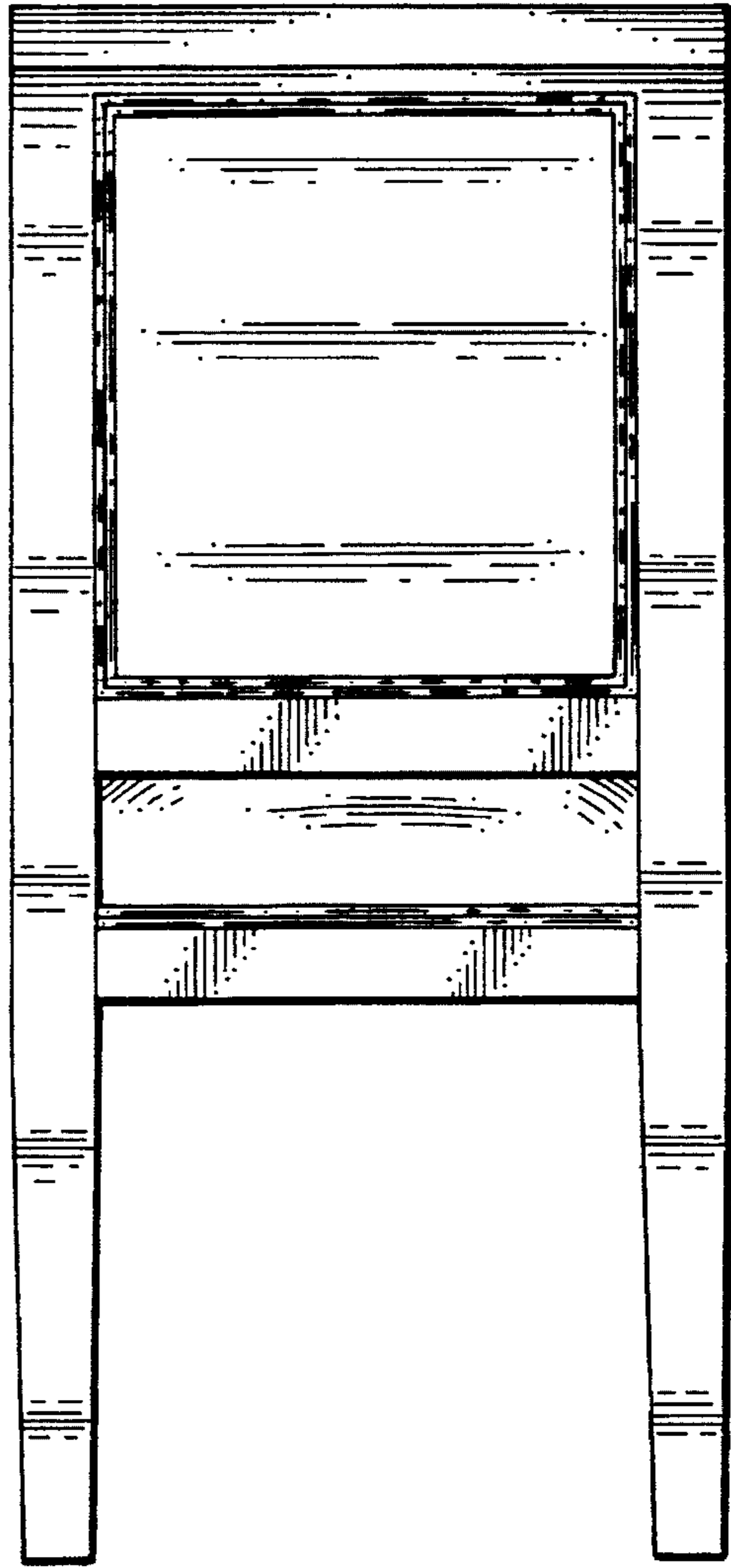
