[57] **CLAIM**

The ornament design for text telephone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front, left side of a text telephone showing the handset in place in the cradle and the cord in phantom;

FIG. 2 is a top, plan view of the text telephone of FIG. 1; FIG. 3 is a right side elevational view of the text telephone of FIG. 1;

FIG. 4 is a front elevational view of the text telephone of FIG. 1;

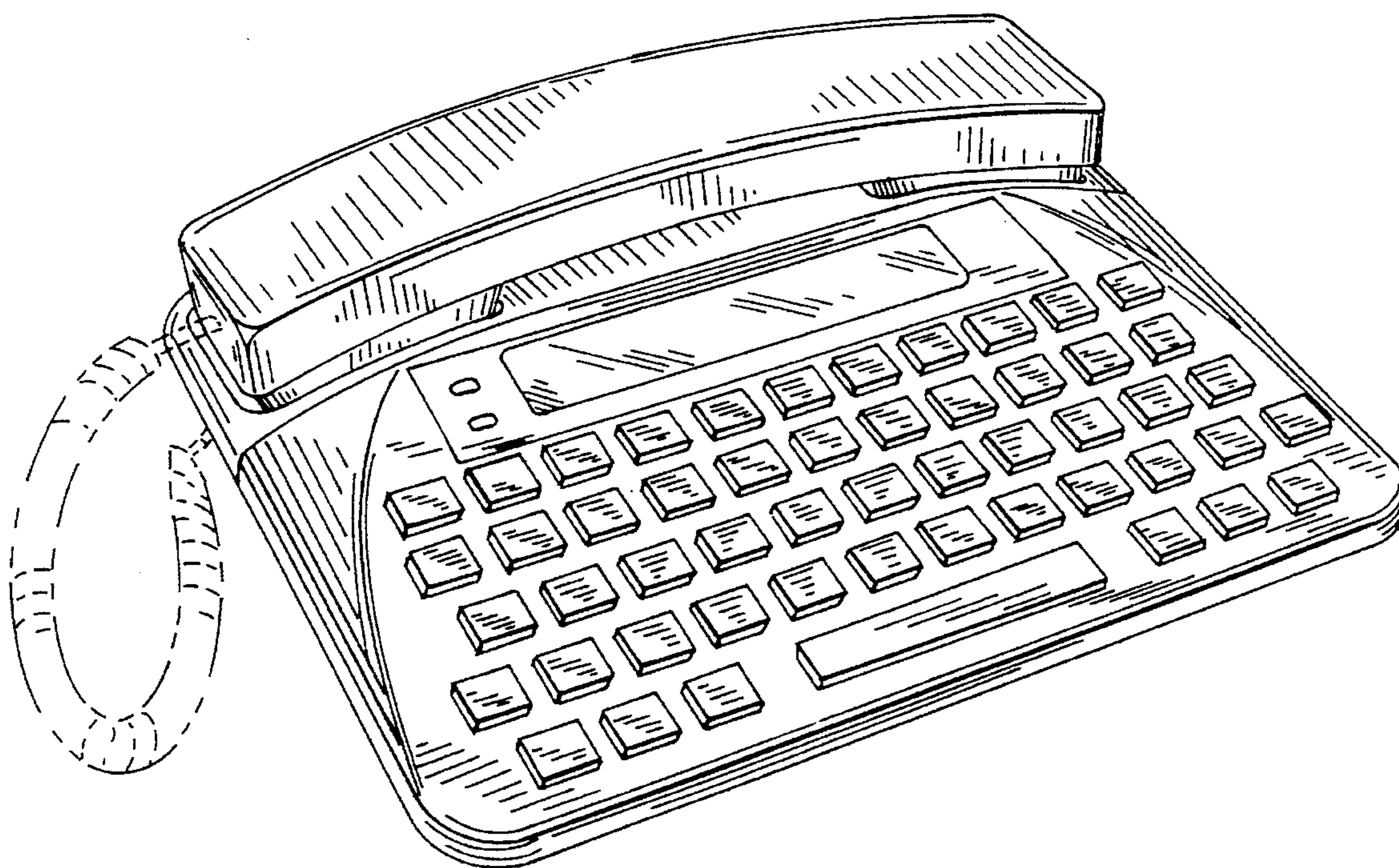
FIG. 5 is a rear elevational view of the text telephone of FIG. 1;

FIG. 6 is a perspective view taken from the top, front, left side of the text telephone of FIG. 1 with the handset and cord removed; and,

FIG. 7 is an enlarged detail plan view of the keyboard of the text telephone of FIG. 1 showing arrangement of menu and cursor keys.

The handset has been omitted from FIG. 6 for convenience of illustration. The broken line showing of a telephone cord in FIG. 1 is for illustrative purposes only and forms no part of the claim design.

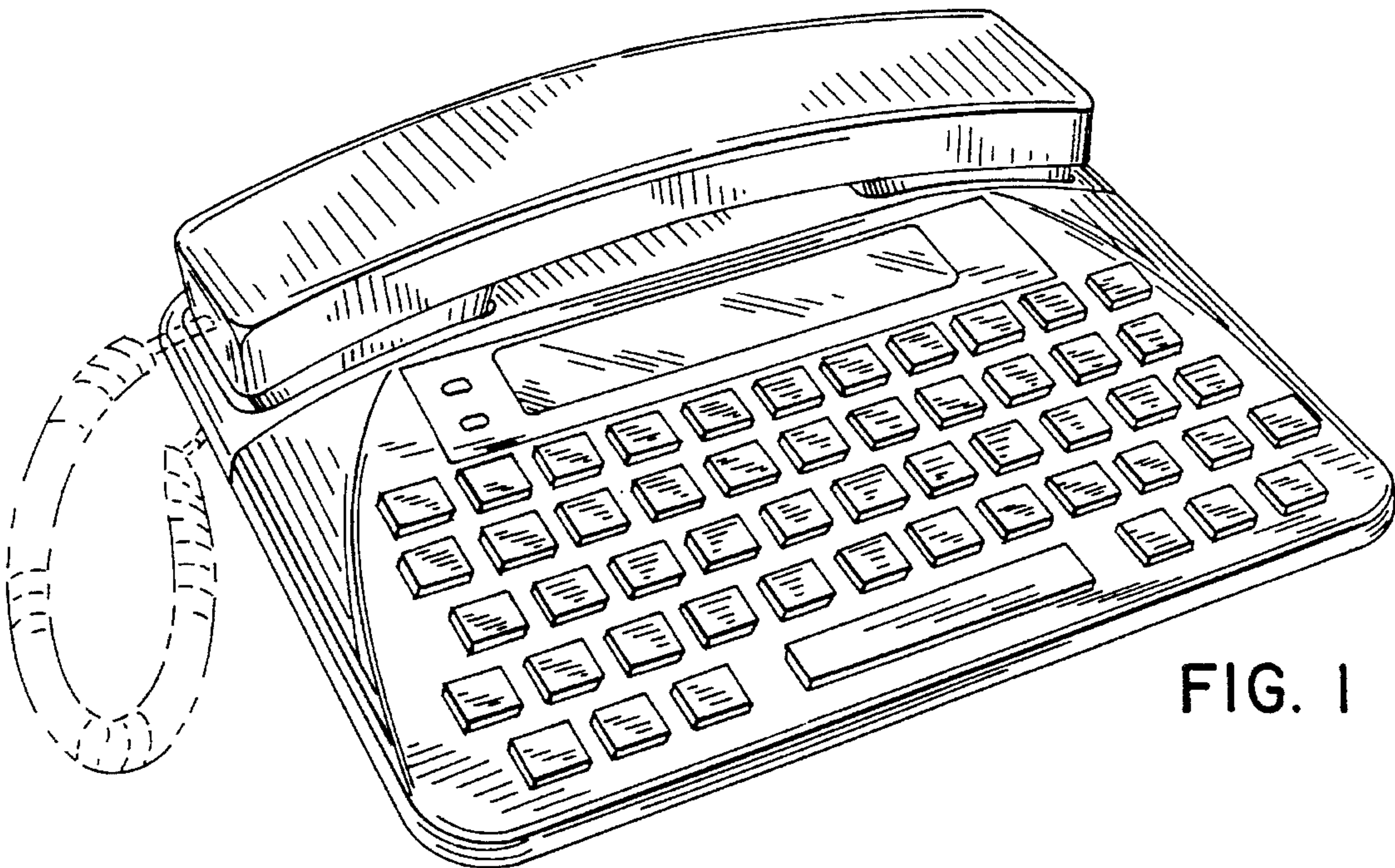

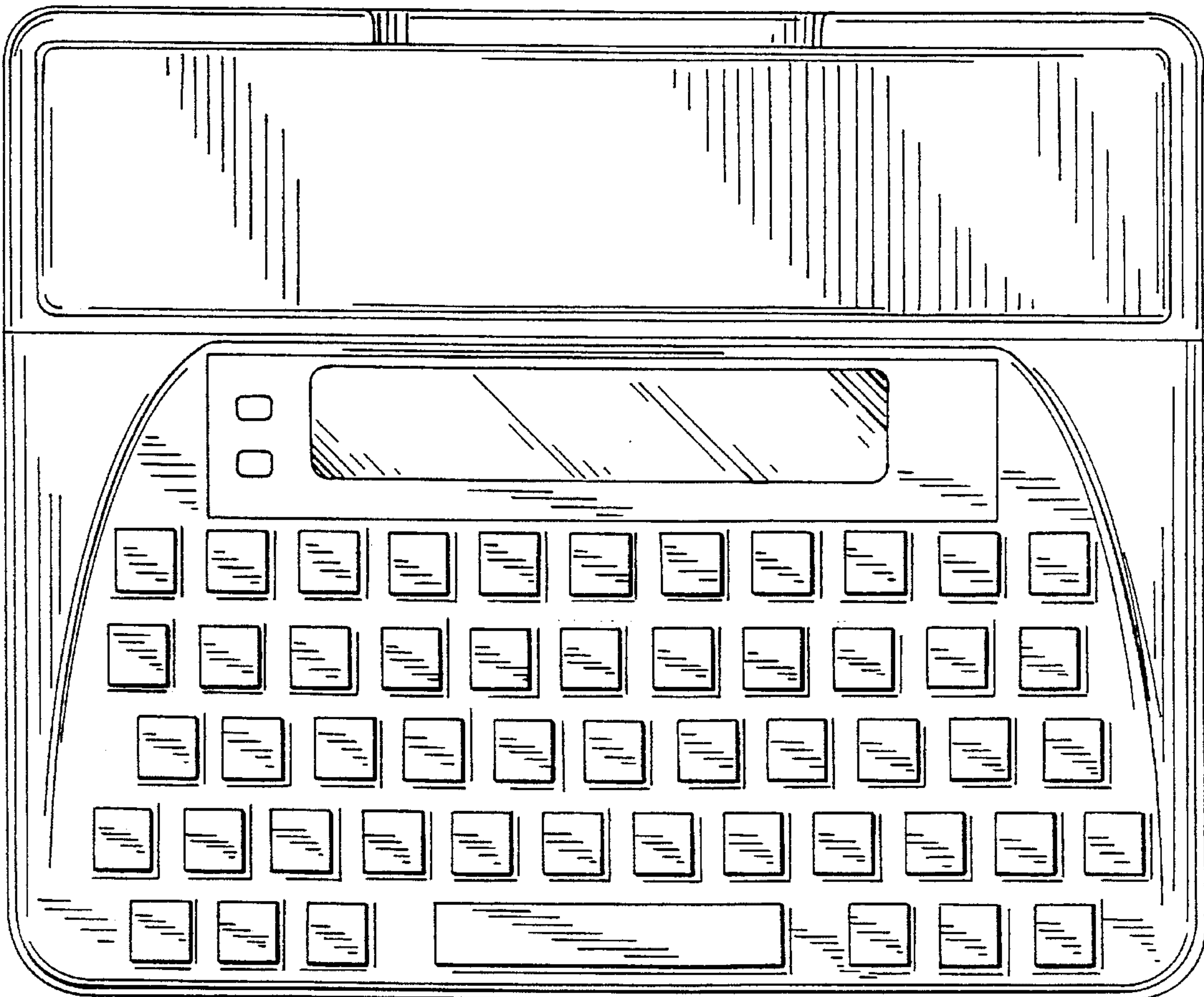

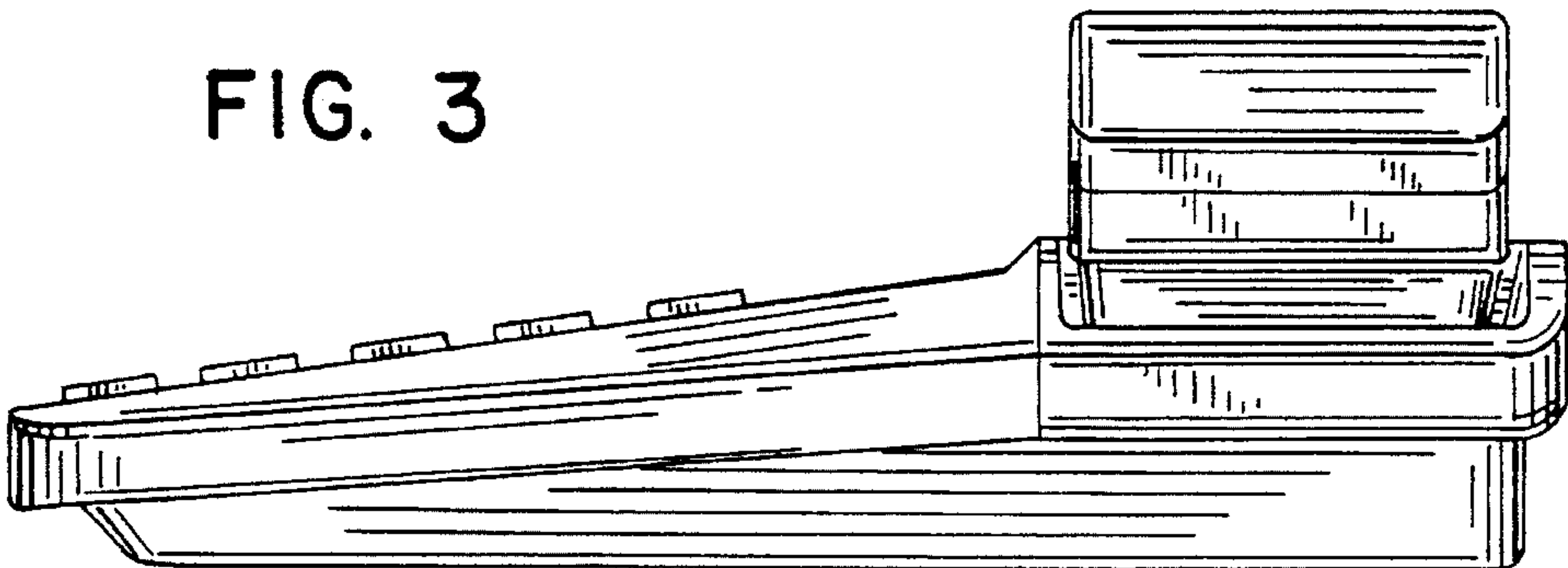

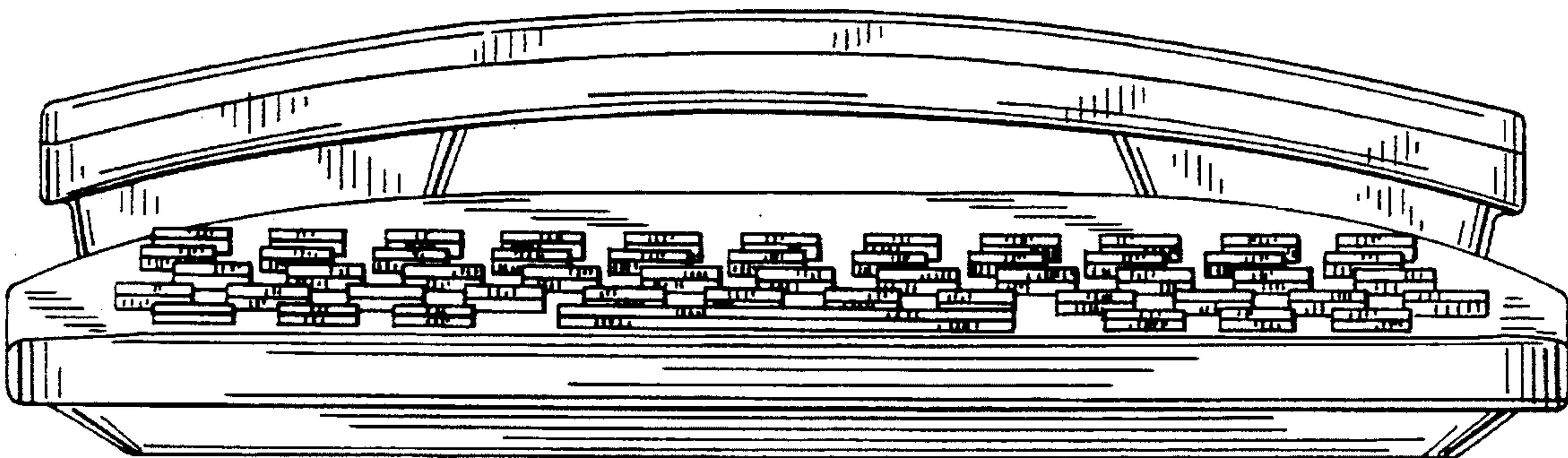
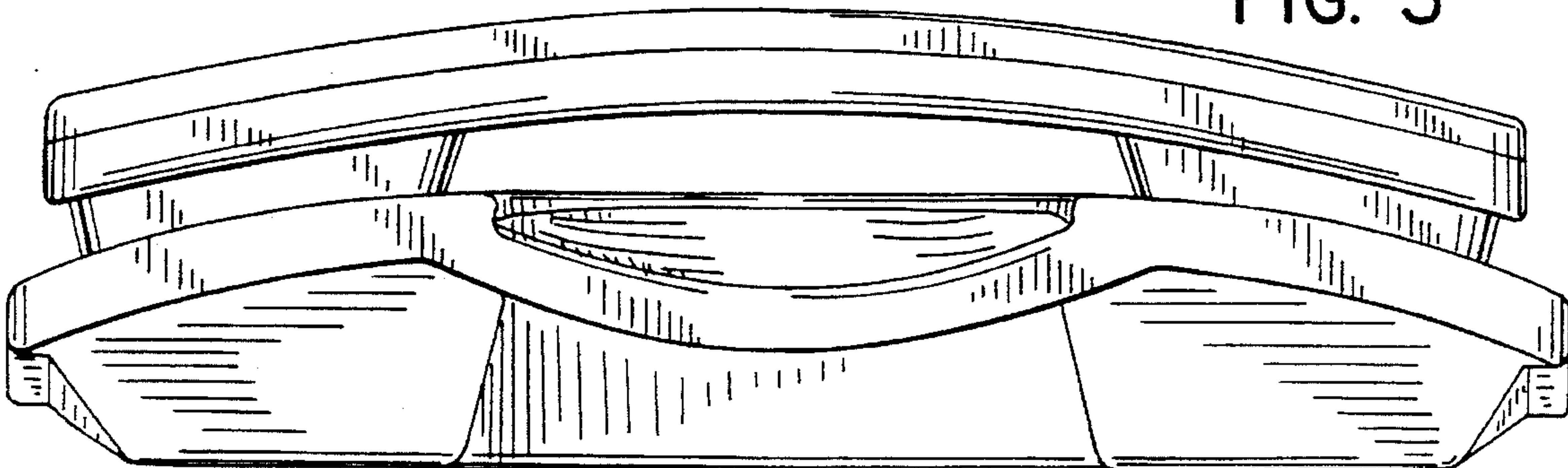

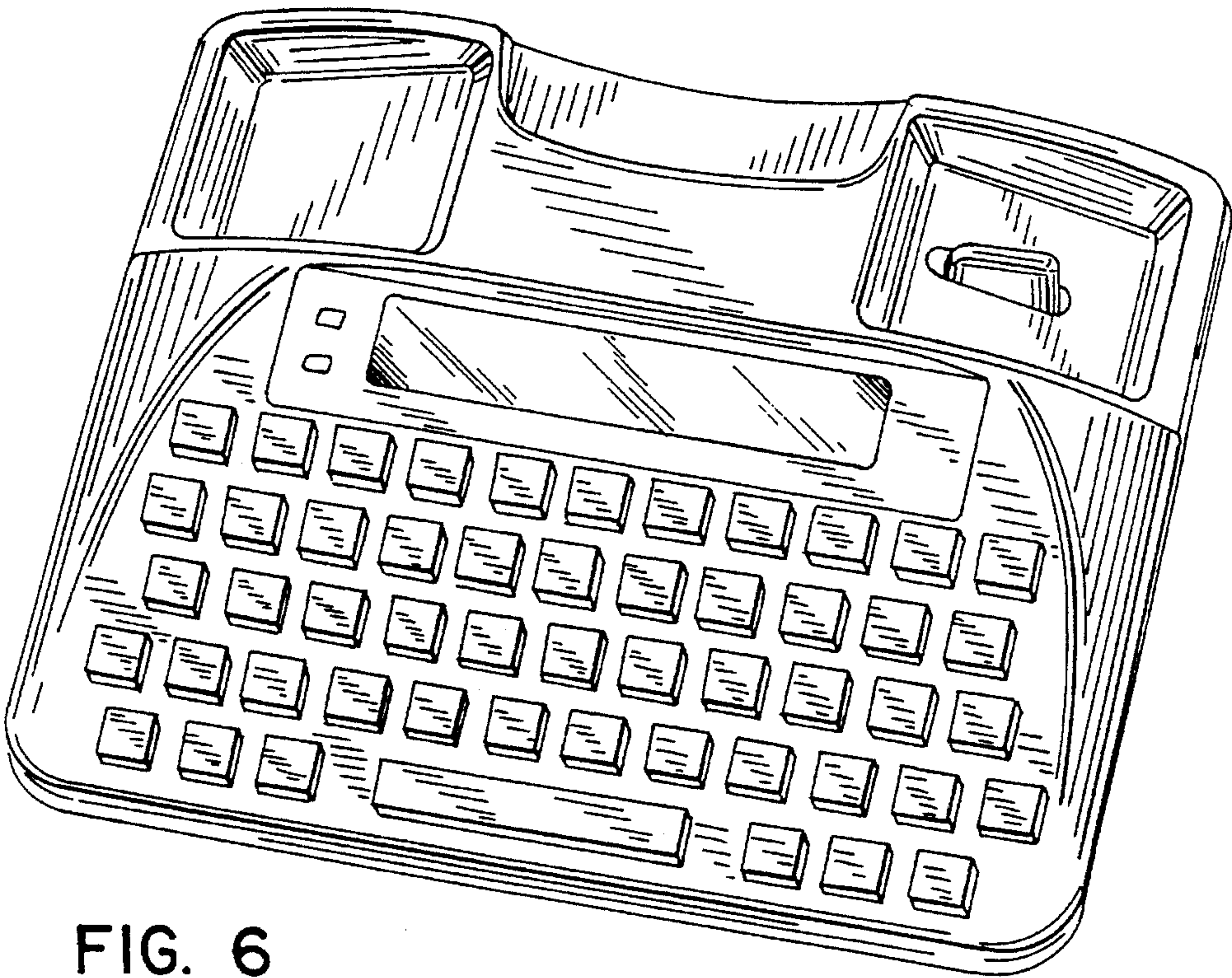
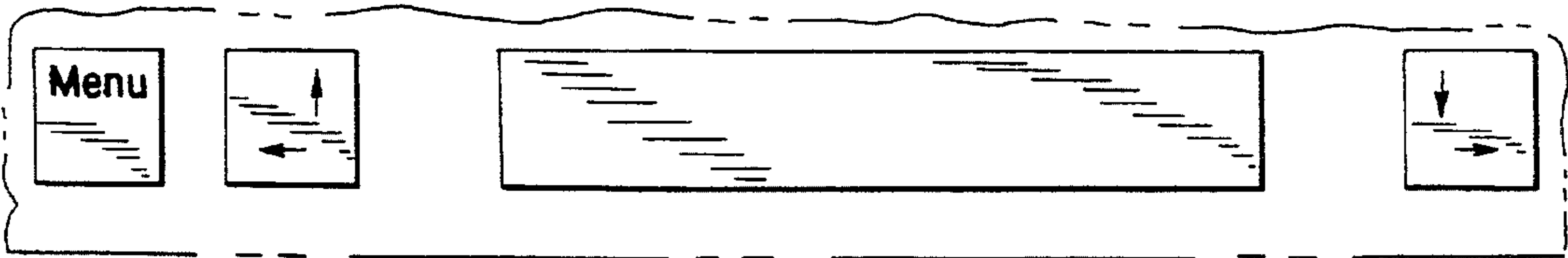
