FIG. 6 is a left side view thereof;

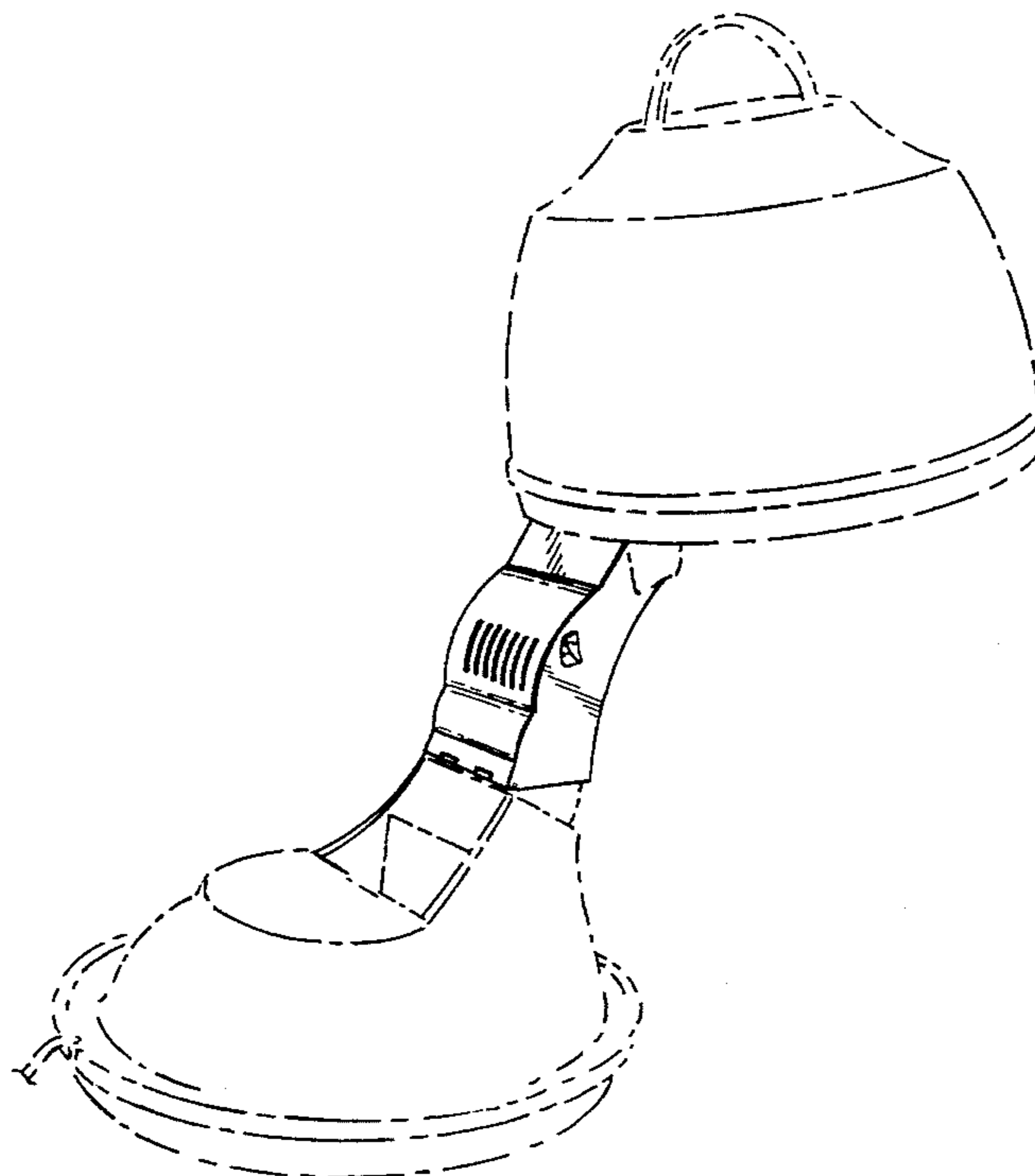
FIG. 7 is a bottom view thereof; and,

FIG. 8 is a top view thereof.

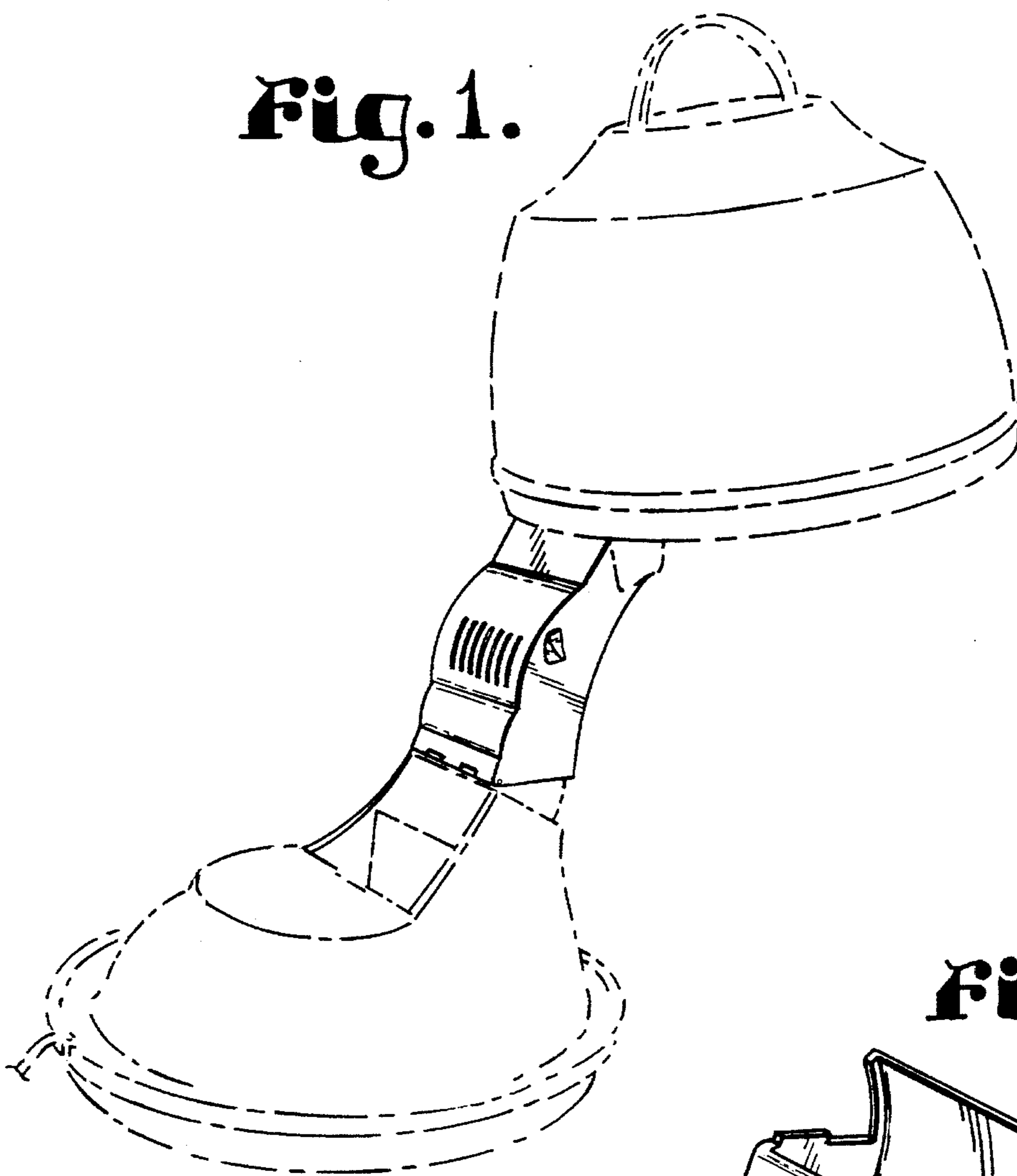

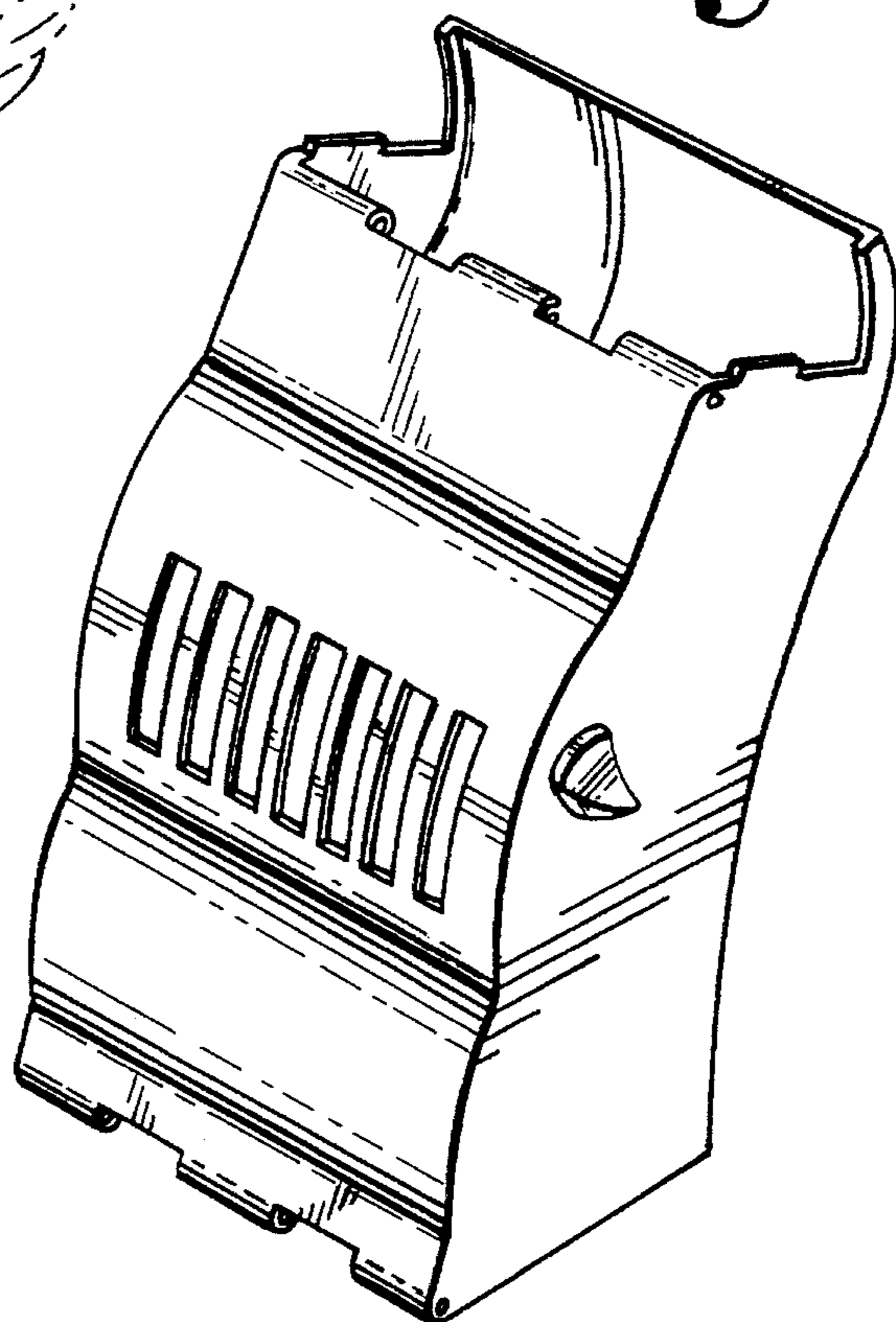

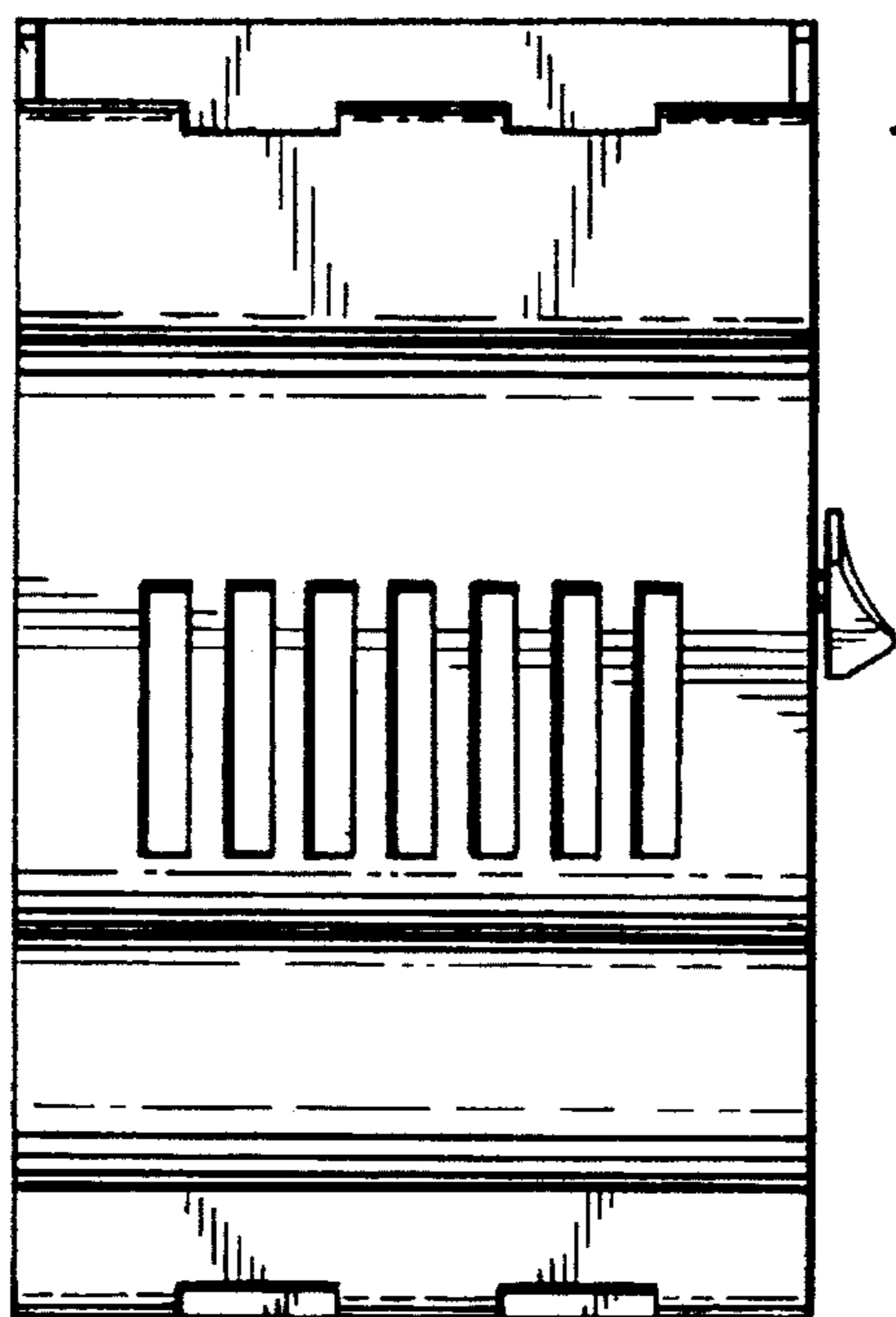

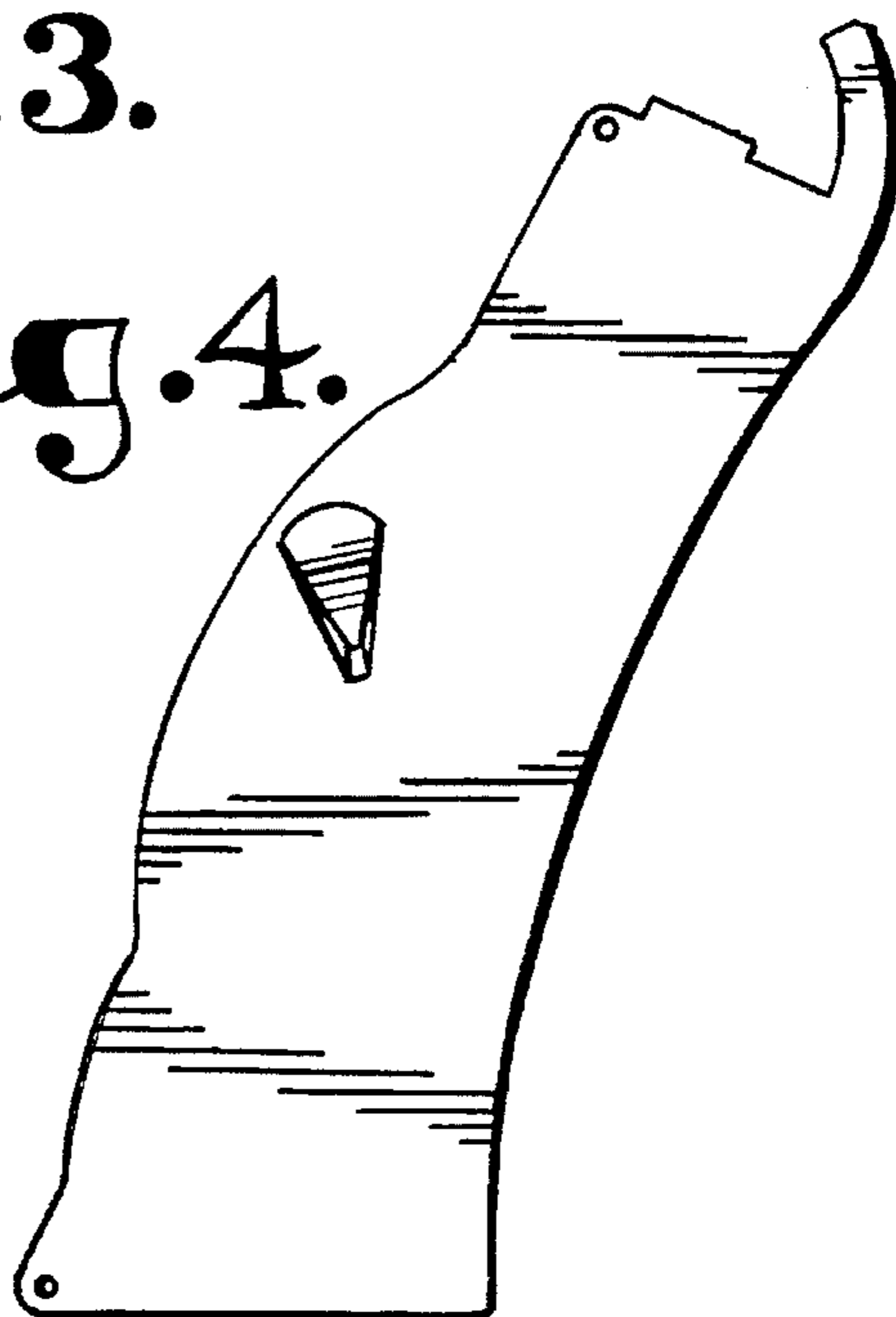

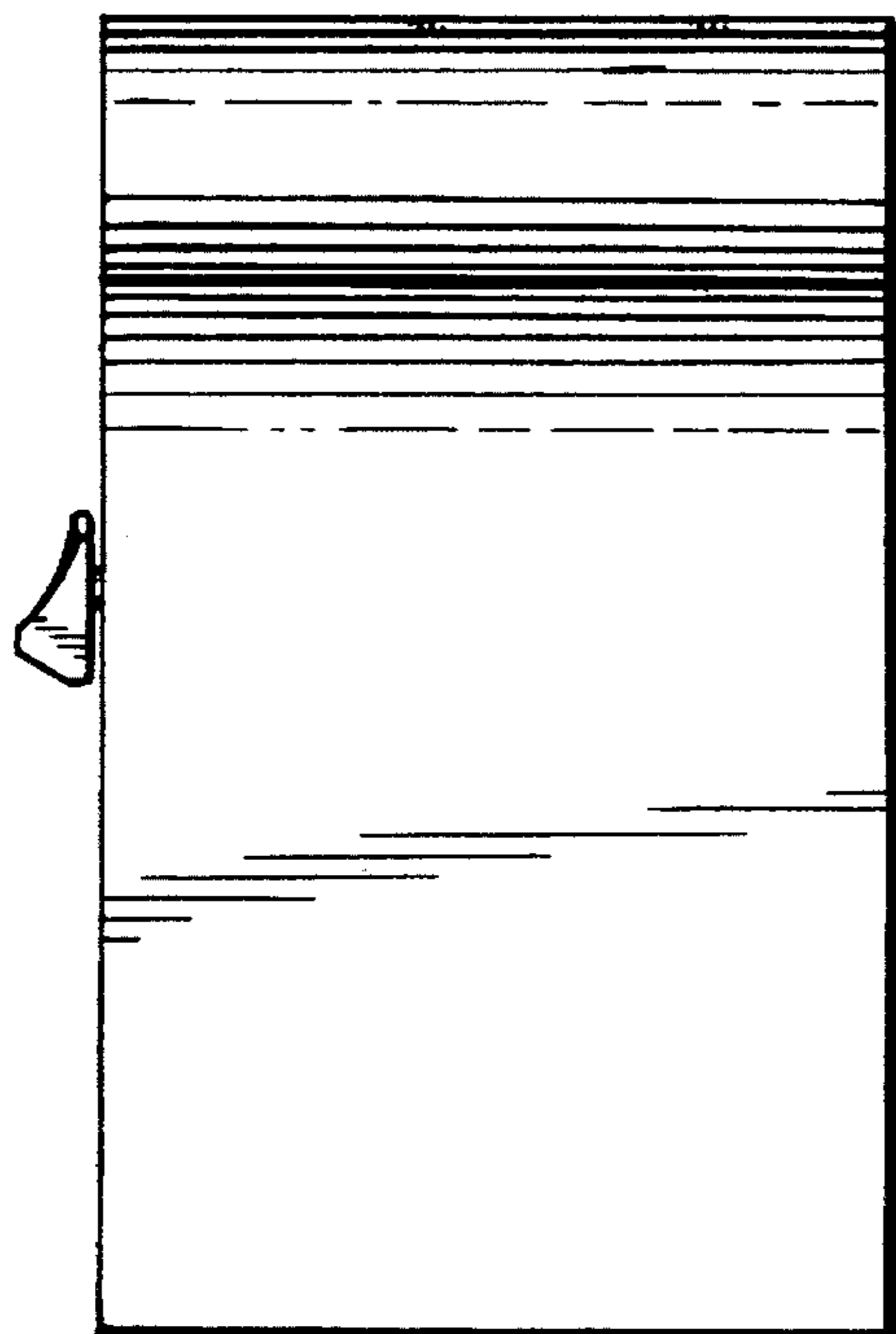

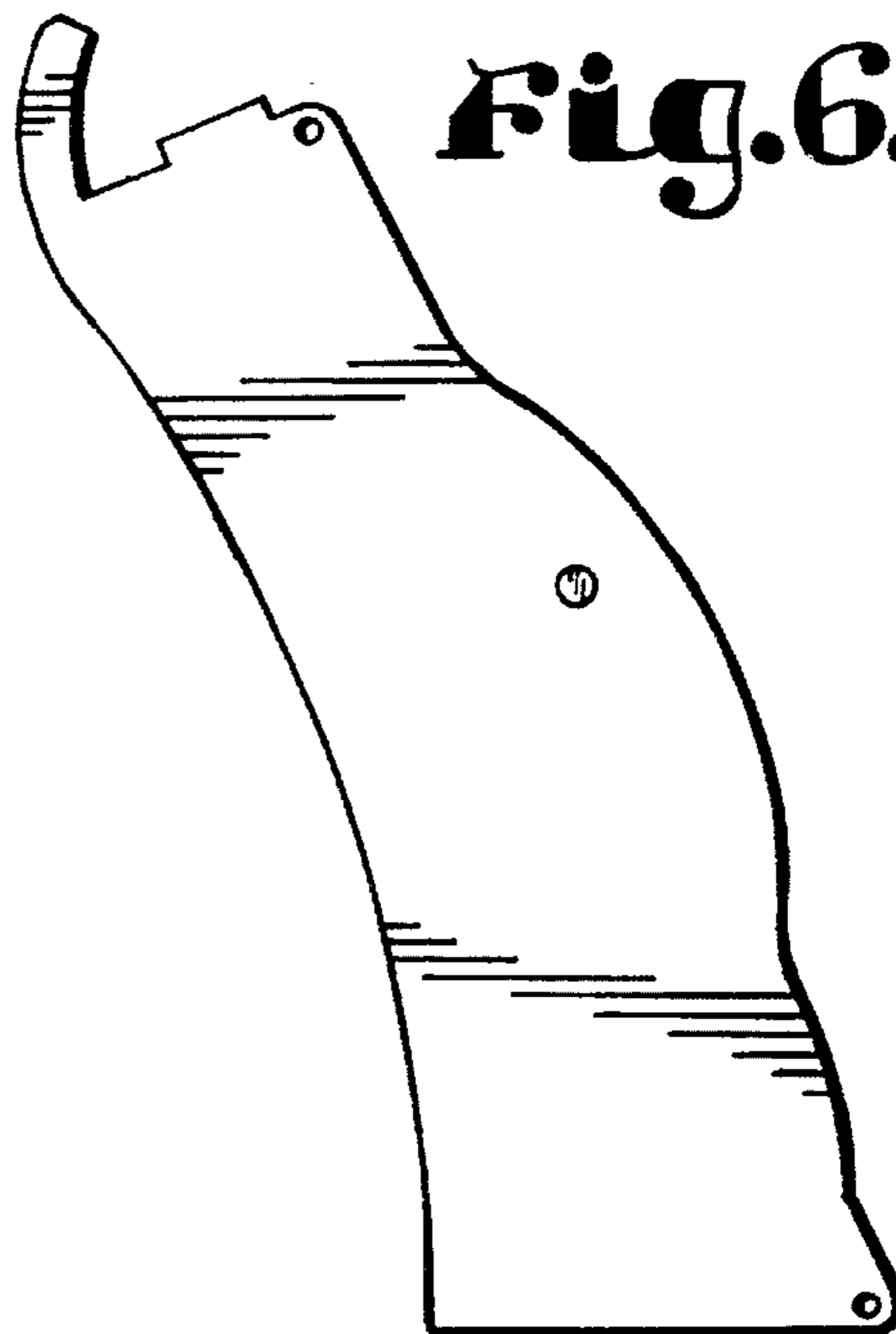

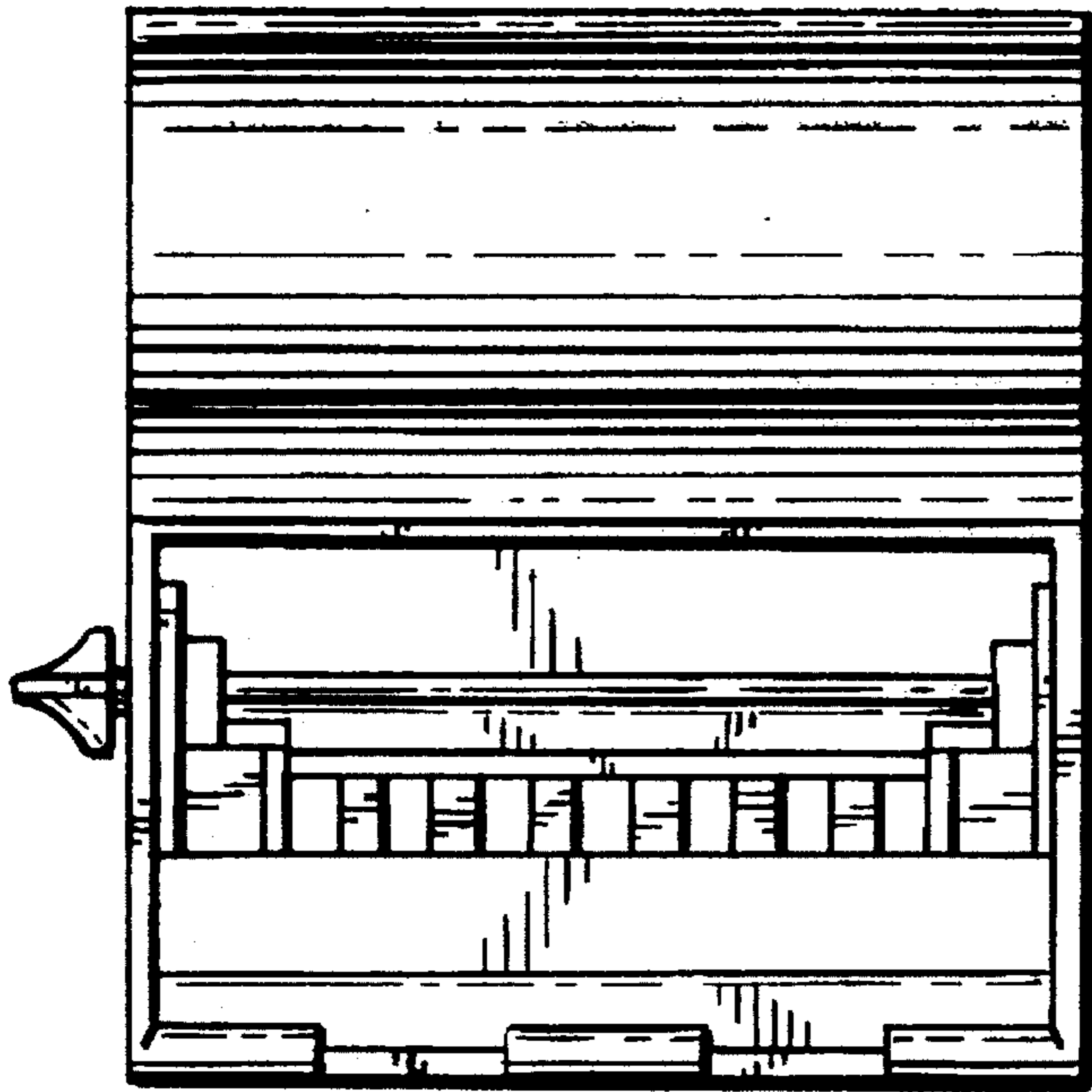

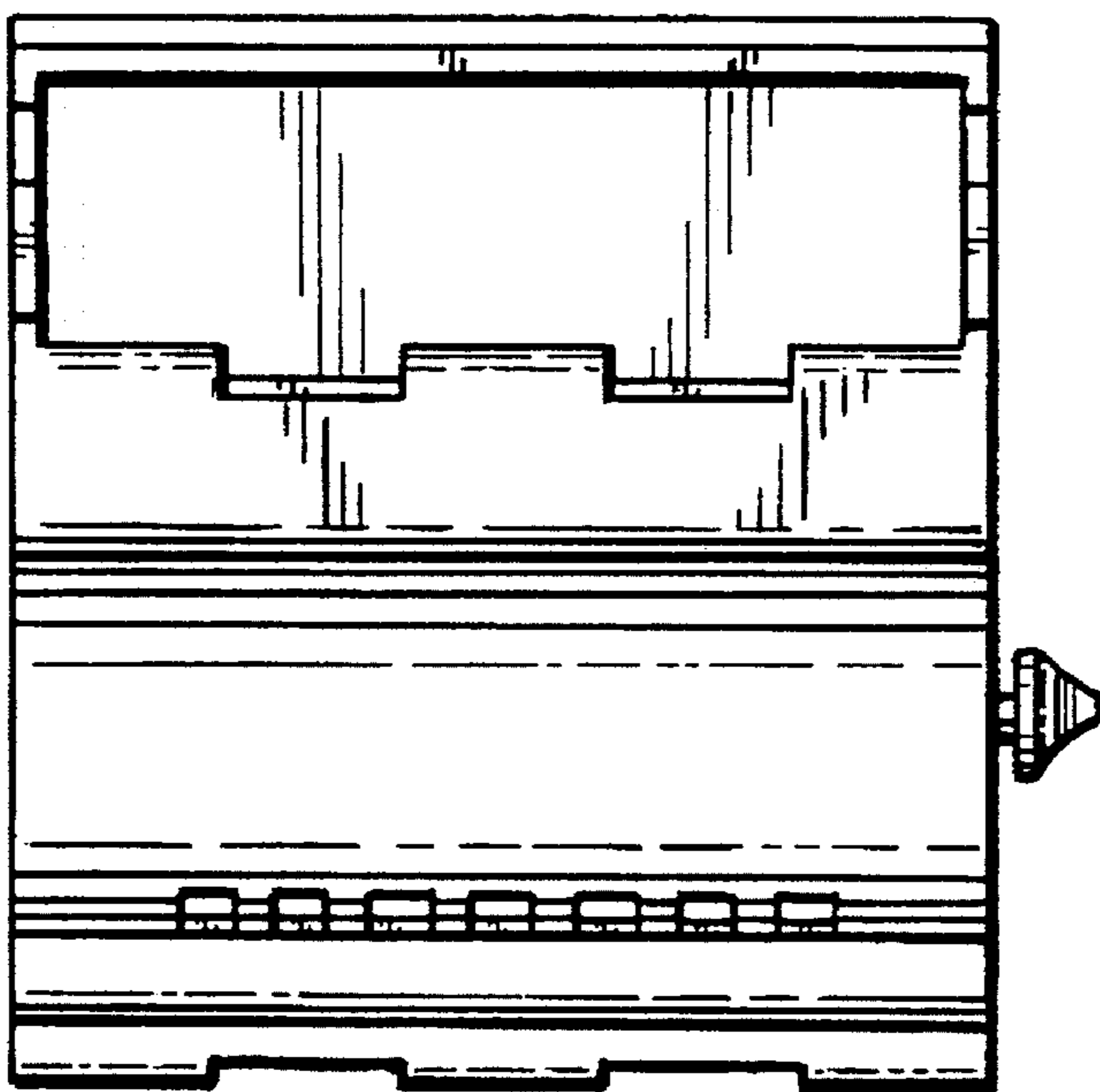
