[57] **CLAIM**

The ornamental design for a hair cutting and trimming comb, as shown.

**DESCRIPTION**

FIG. 1 is a front view of the hair cutting and trimming comb according to the present design;  
FIG. 2 is a top view of the hair cutting and trimming comb according to the present design;  
FIG. 3 is a right side view of the hair cutting and trimming comb according to the present design;  
FIG. 4 is a back view of the hair cutting and trimming comb according to the present design;  
FIG. 5 is a left side view of the hair cutting and trimming comb according to the present design;  
FIG. 6 is a bottom view of the hair cutting and trimming comb according to the present design; and,  
FIG. 7 is a cross-sectional view taken along line 7—7 of FIG. 7.

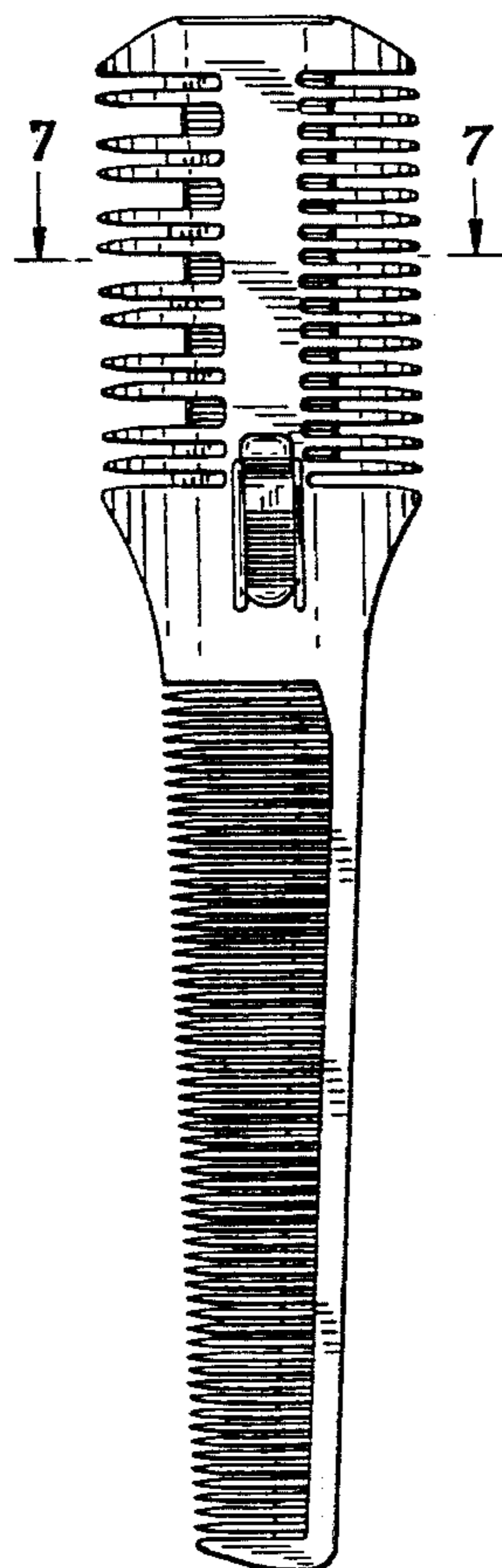

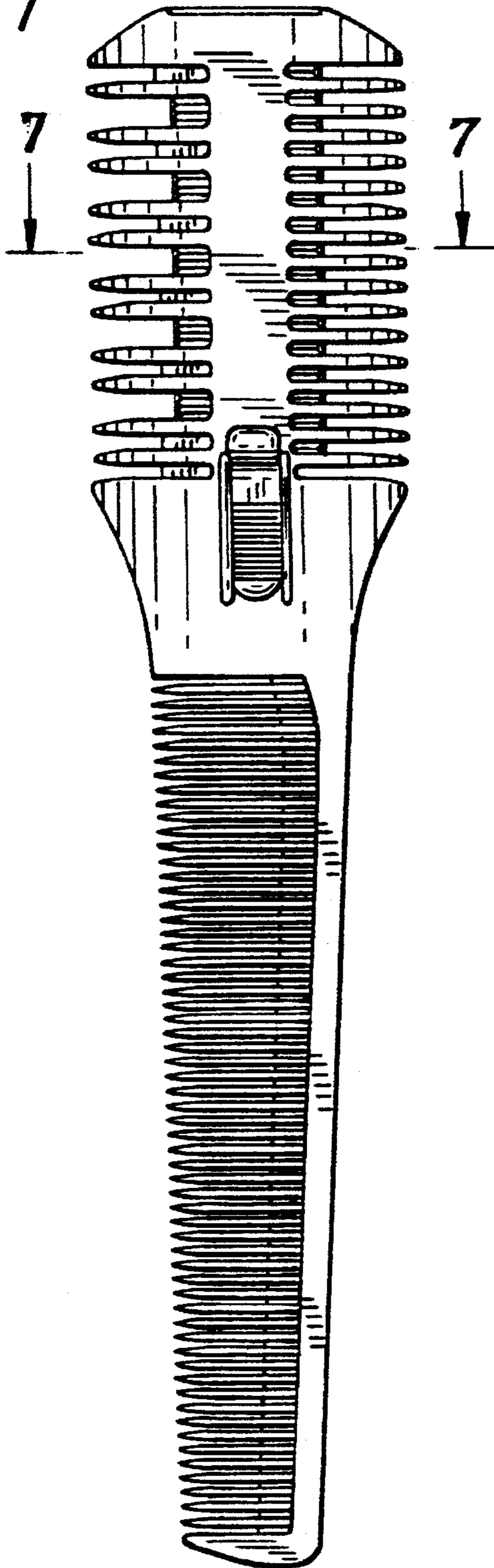

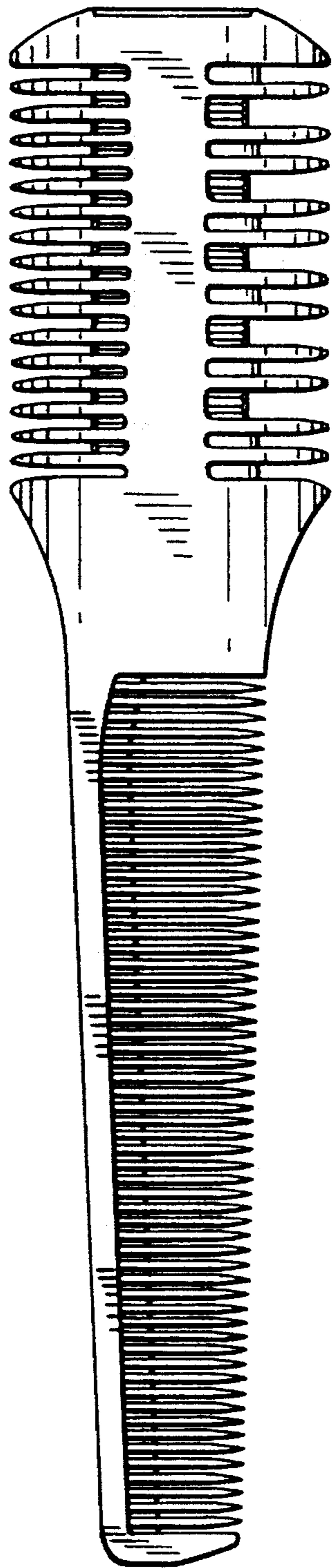
