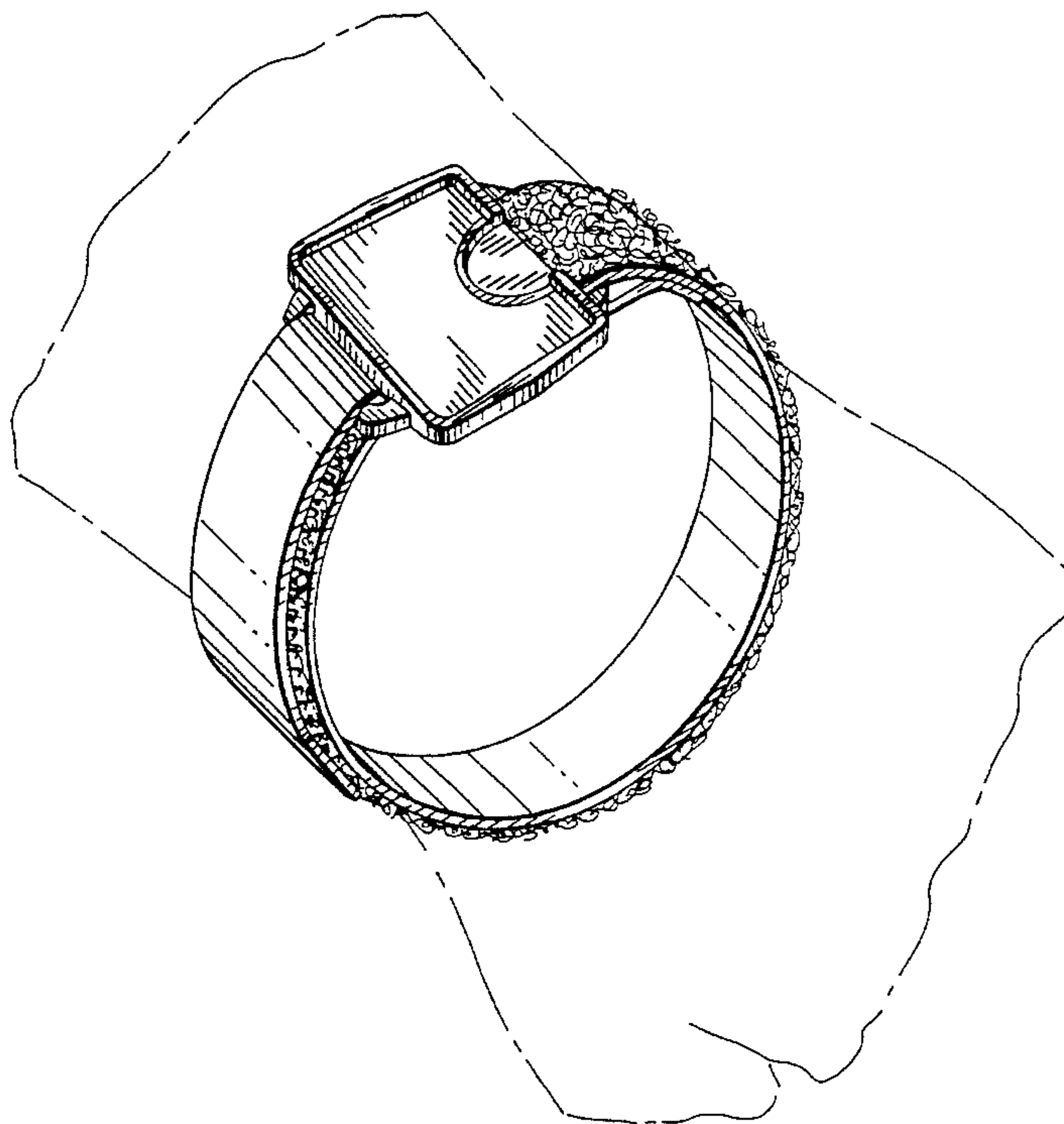
[57] **CLAIM**

The ornamental design for a tool and parts holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tool and parts holder design;
FIG. 2 is a top plan view of the tool and parts holder shown in FIG. 1;
FIG. 3 is a side view of the tool and parts holder shown in FIG. 1, the opposite side being a mirror image thereof;
FIG. 4 is a front elevation view of the tool and parts holder shown in FIG. 1, the opposite side being a mirror image thereof; and,
FIG. 5 is a bottom view of the tool and parts holder shown in FIG. 1.
The broken line showing a wrist is for illustrative purposes only and forms no part of the claimed design.

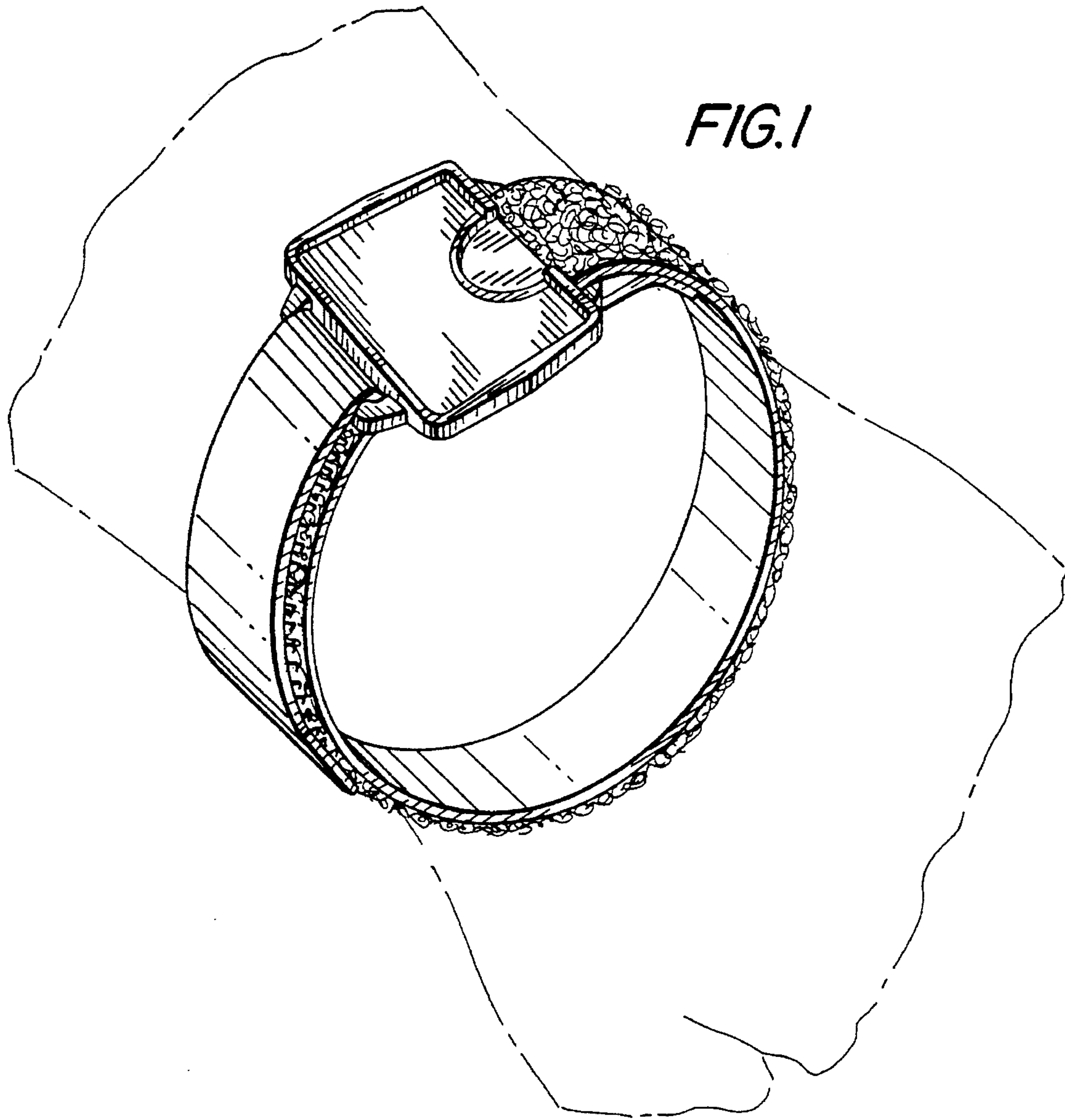

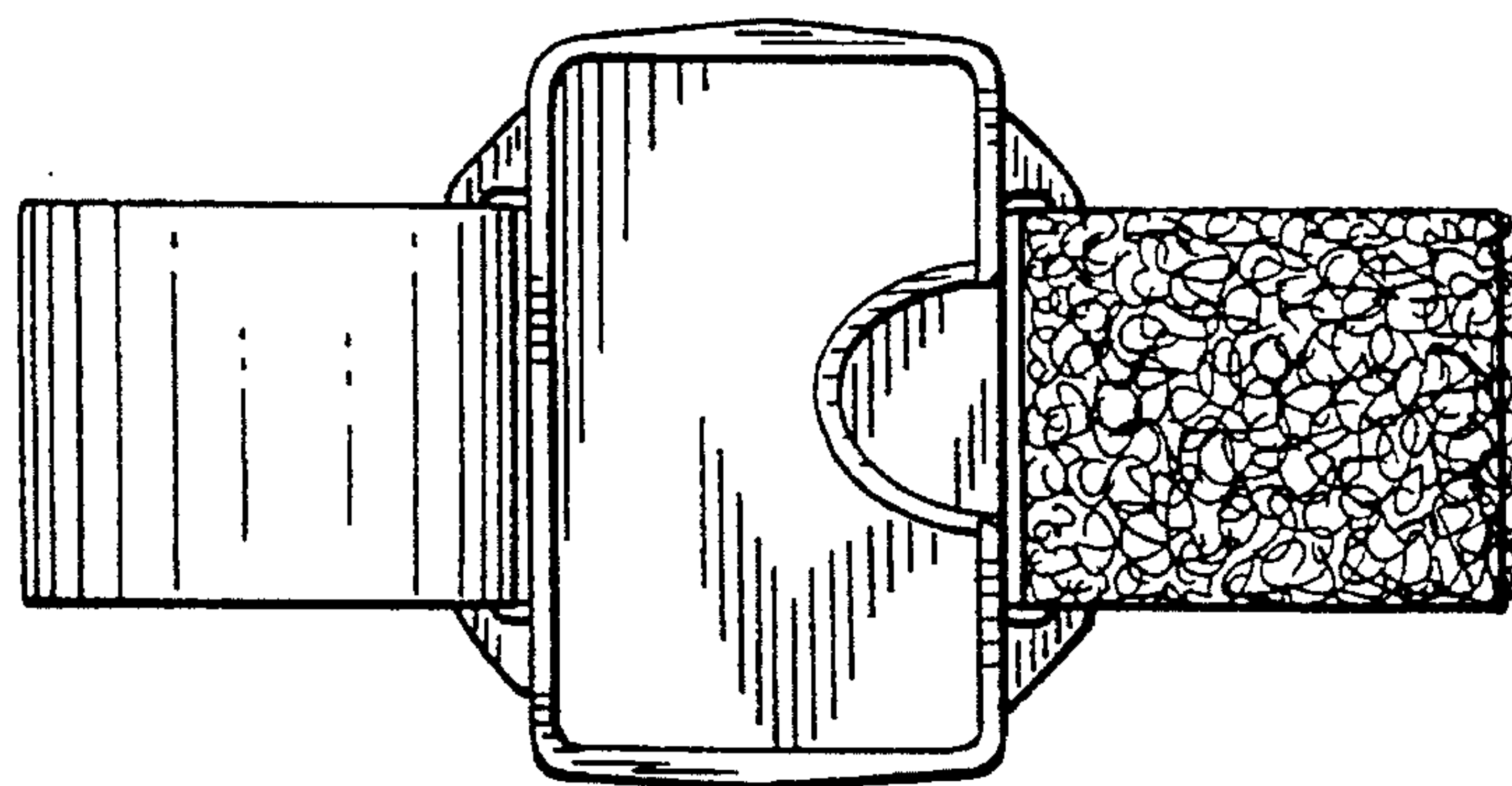

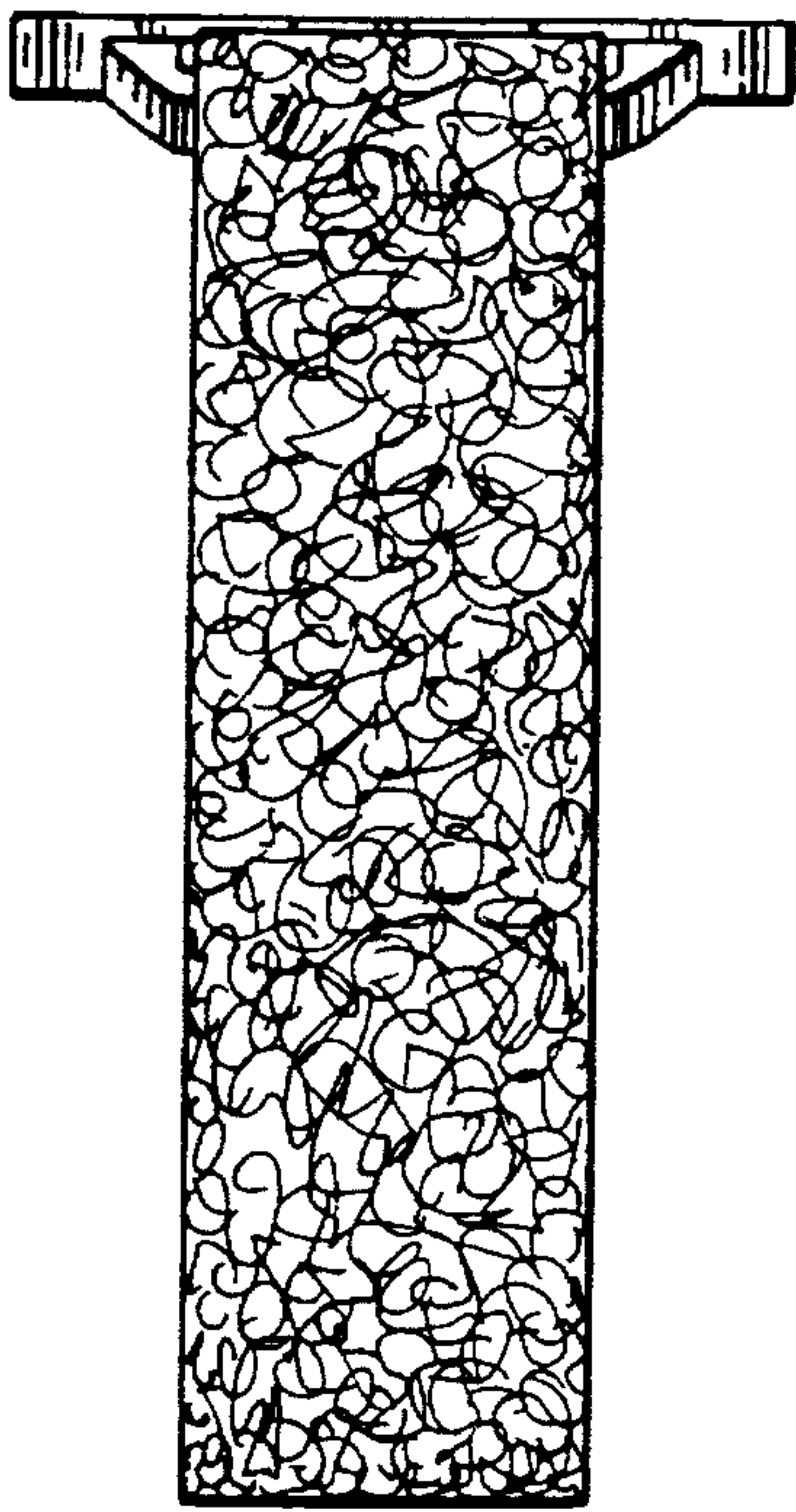

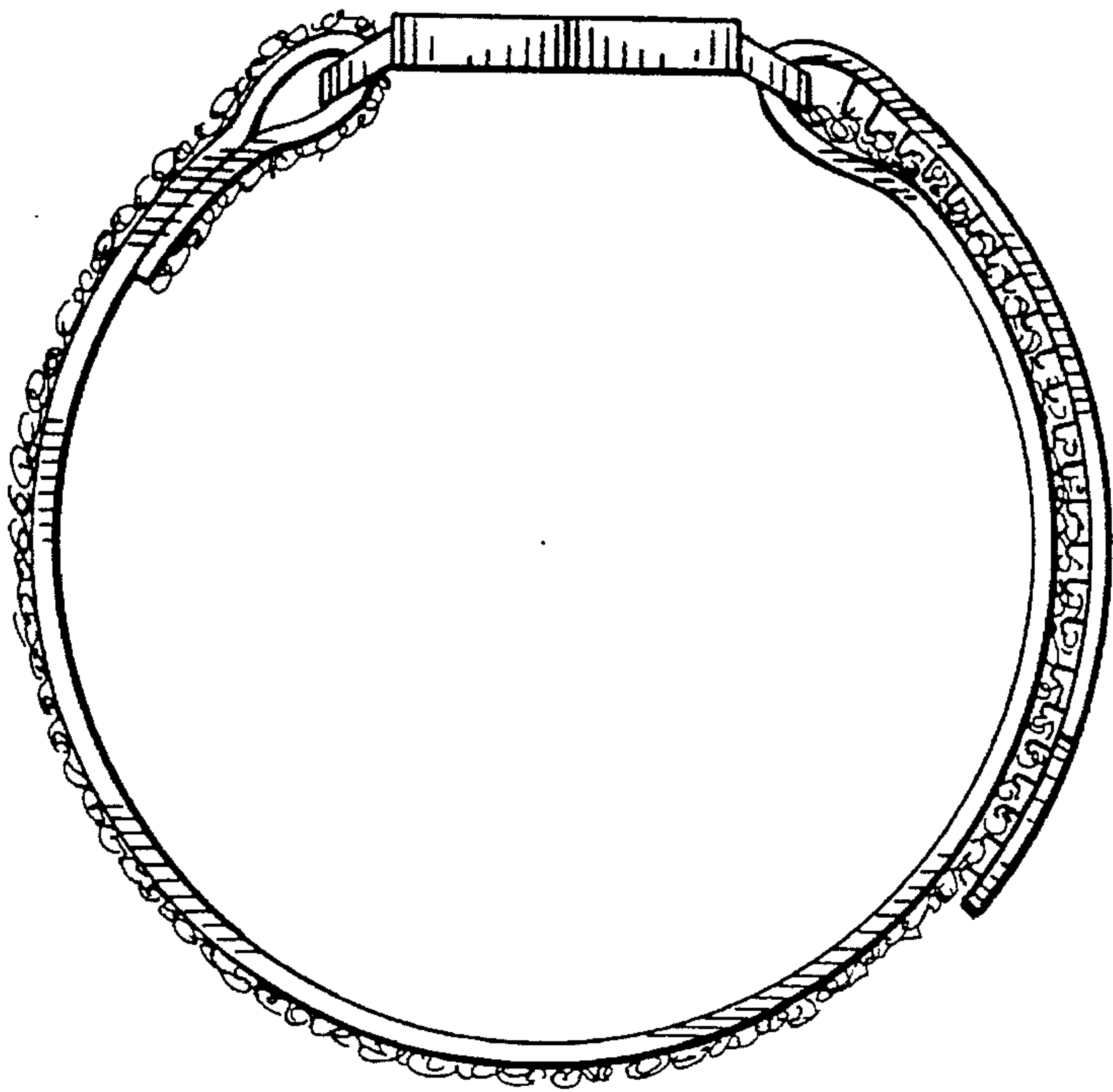
