DESCRIPTION

FIG. 1 is a top right front perspective view of an insulated pitcher showing my new design;

FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image;

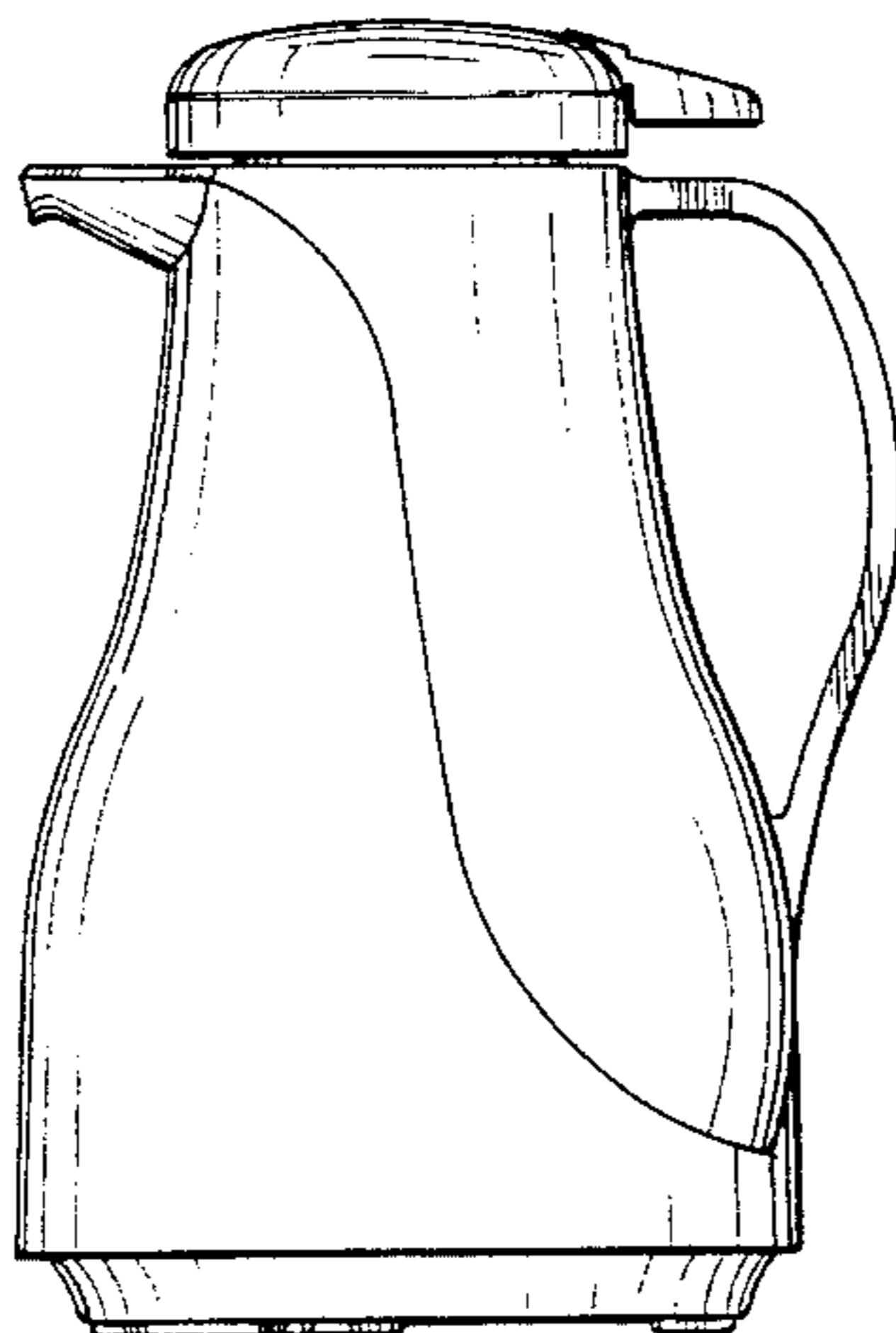
FIG. 3 is a front elevational view thereof;

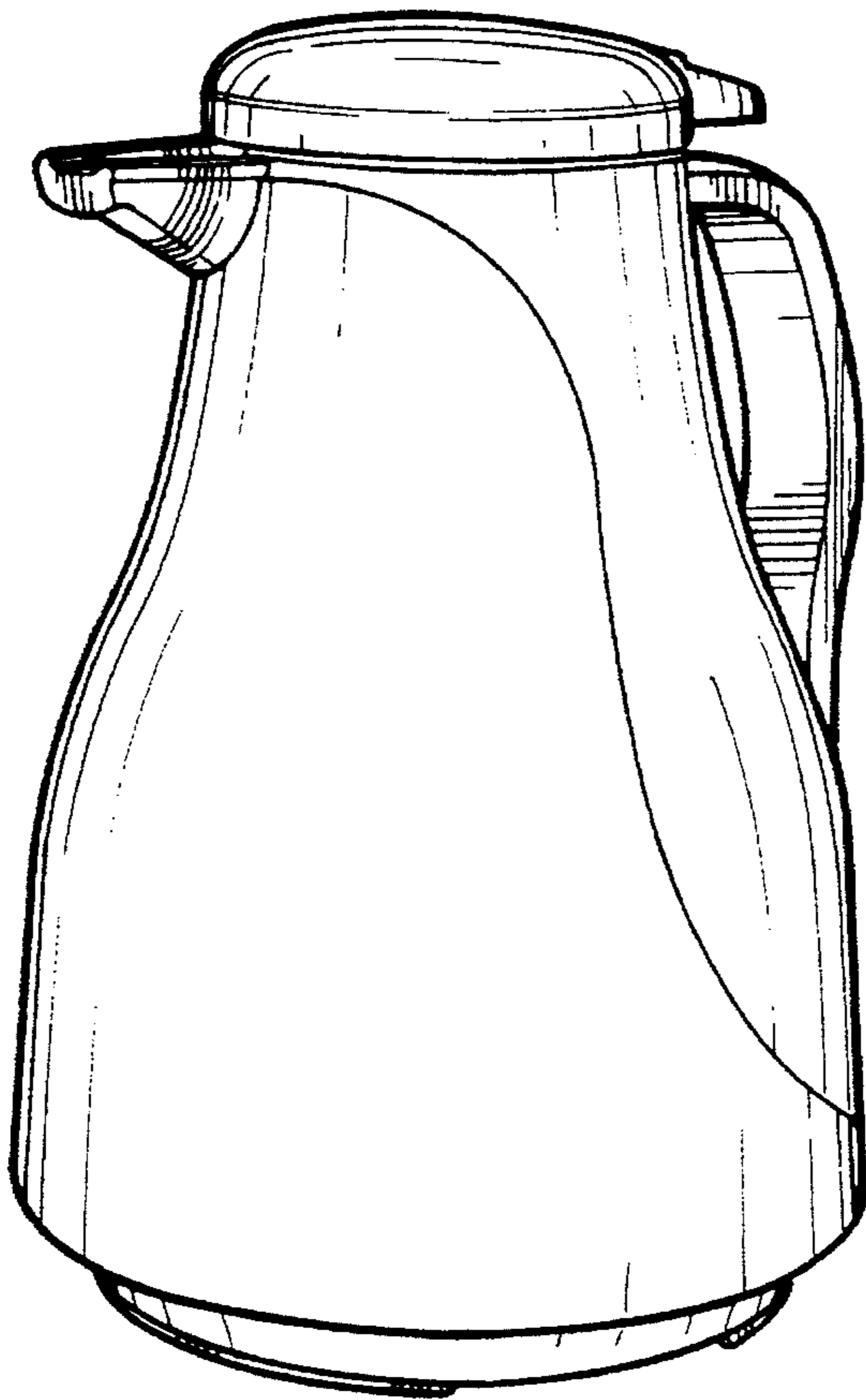

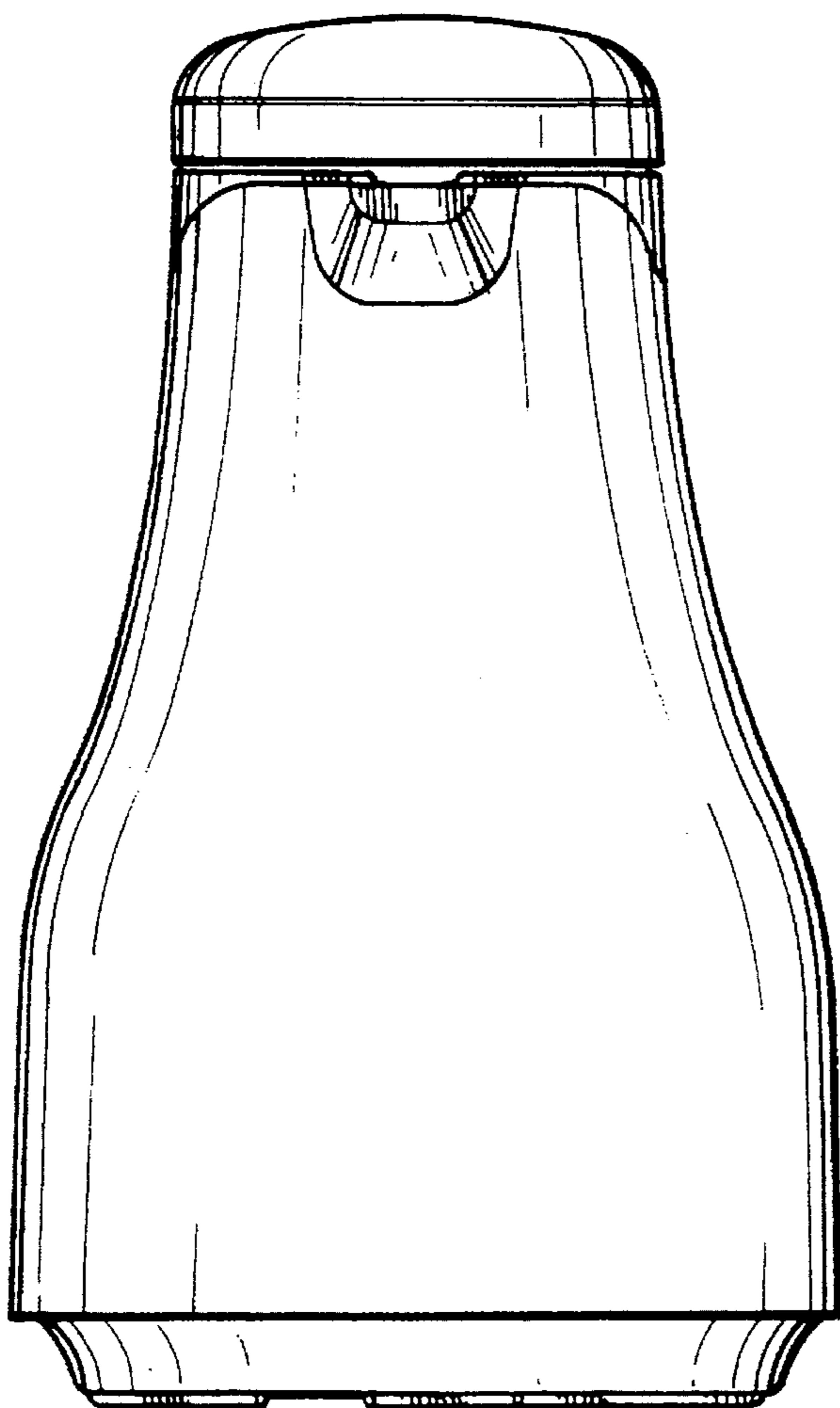

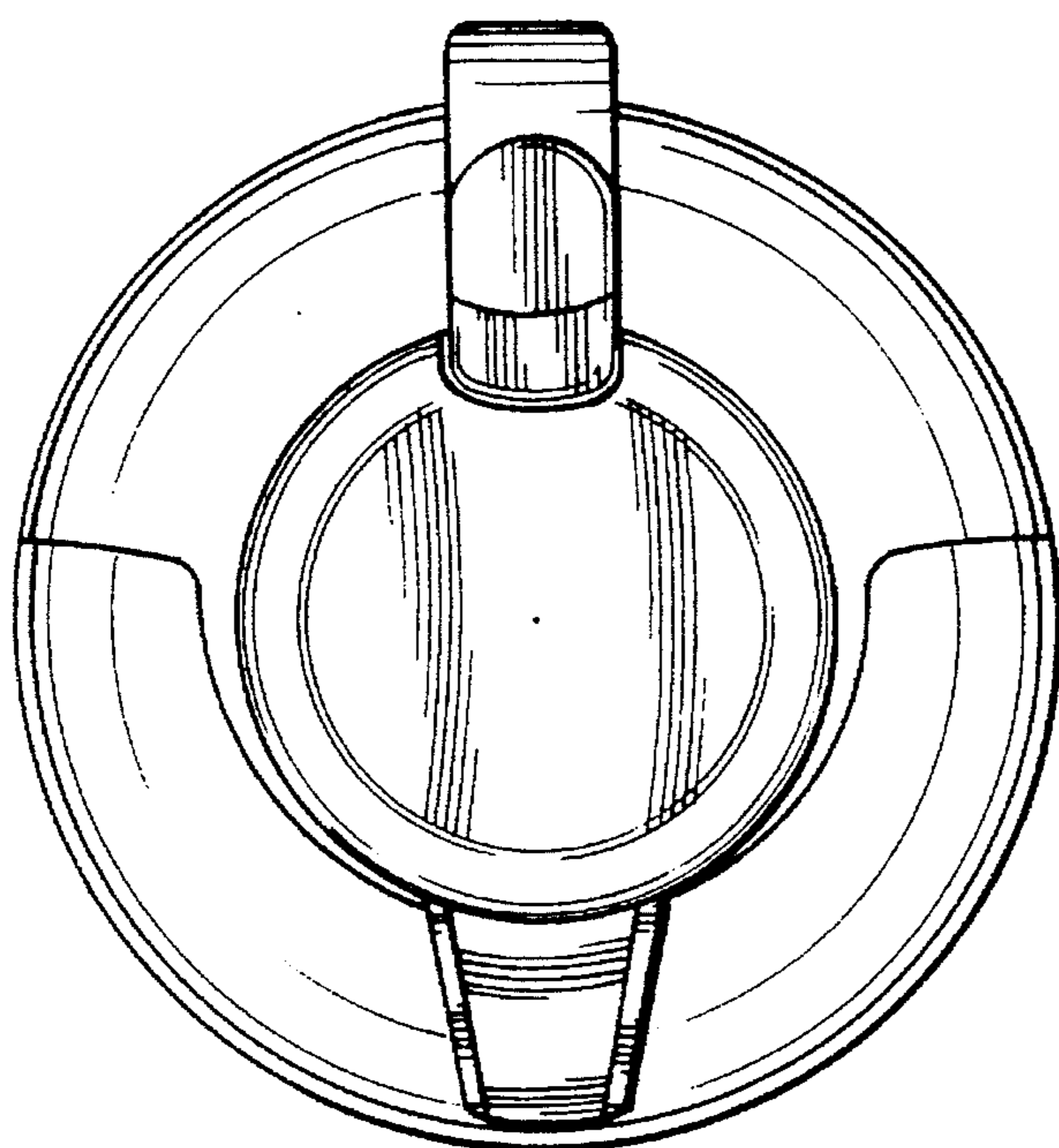

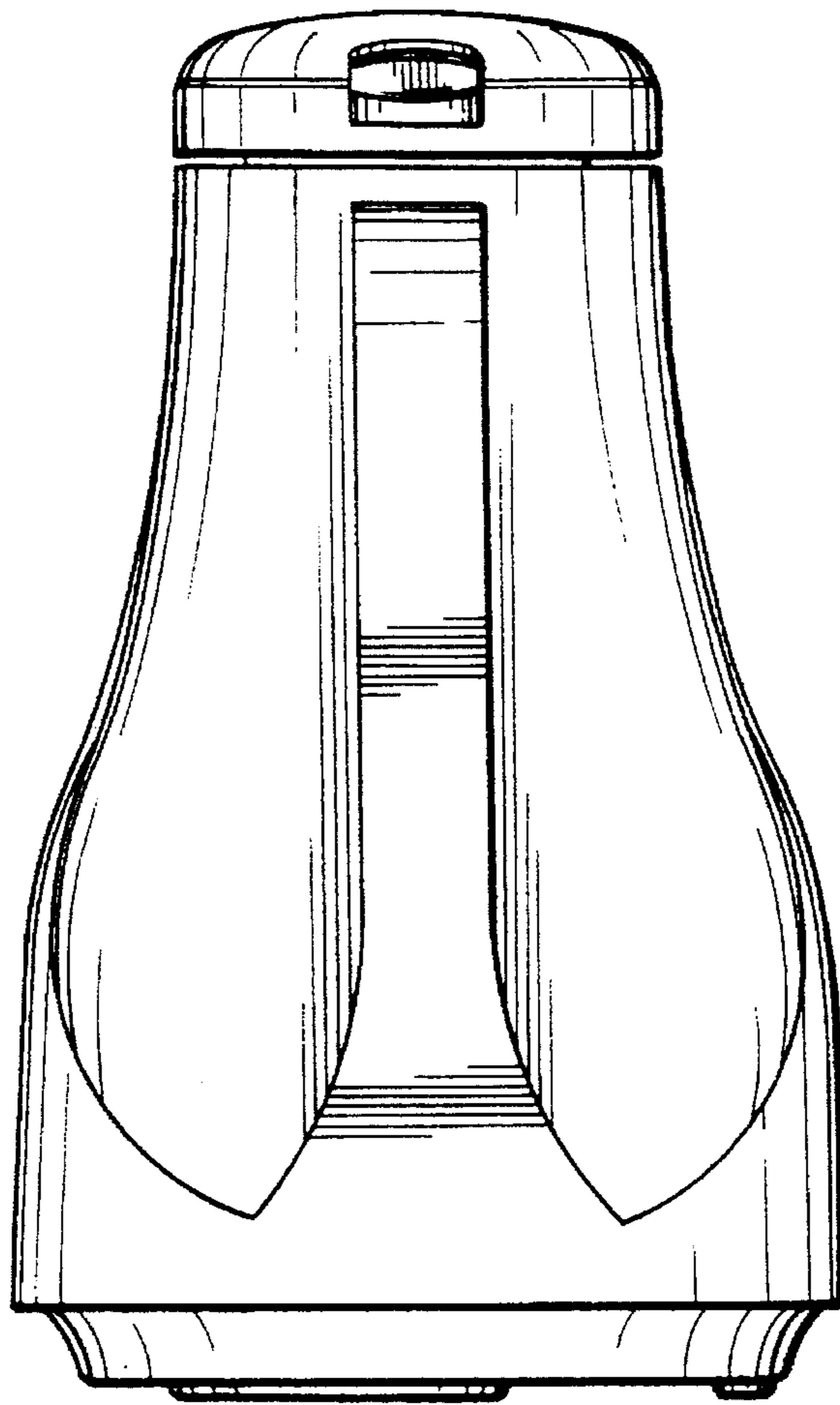

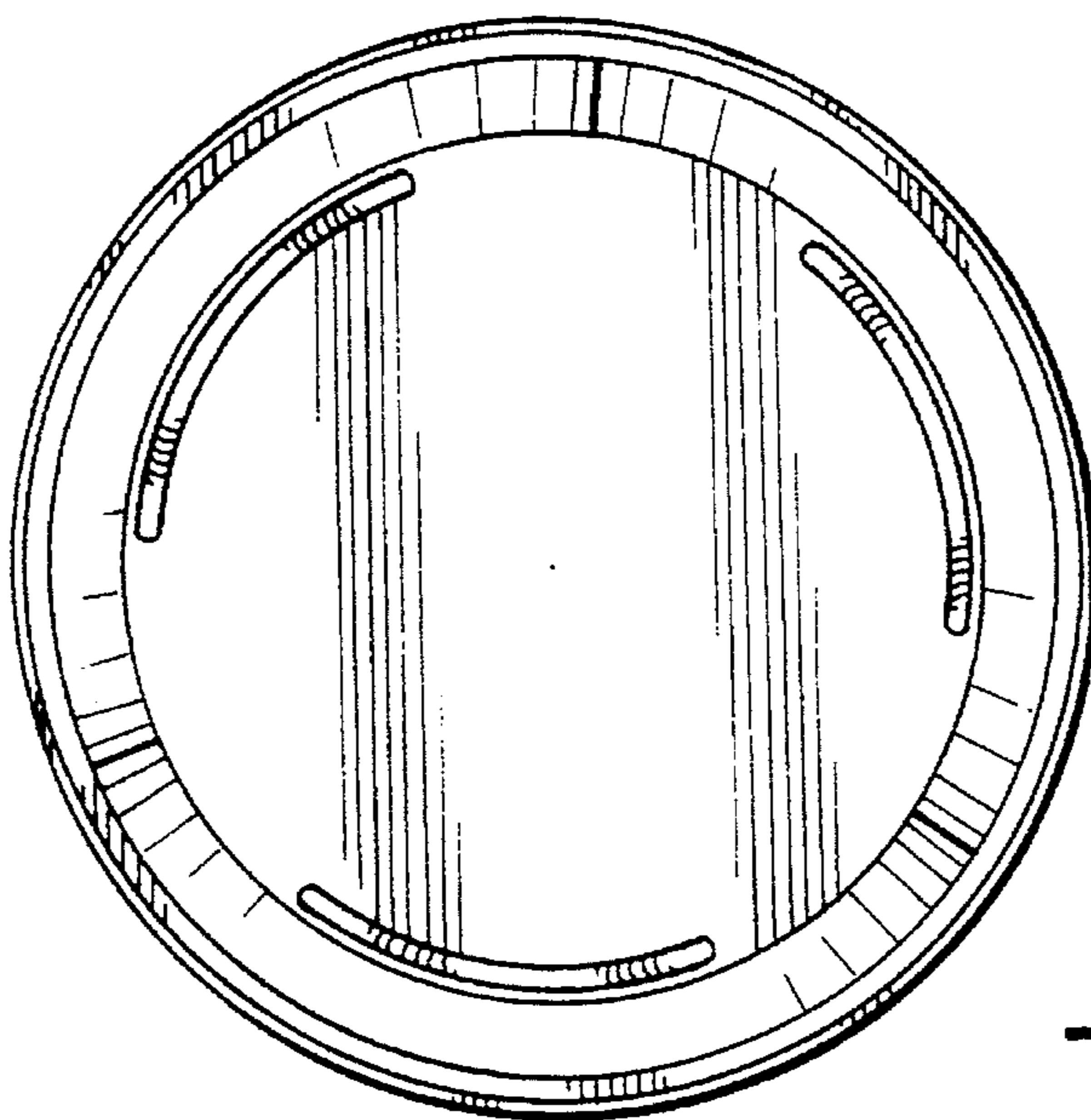
