DESCRIPTION

FIG. 1 is a front-right-top perspective view of a kettle, showing my new design;

FIG. 2 is a front elevational view thereof (the rear elevational view being a mirror image thereof);

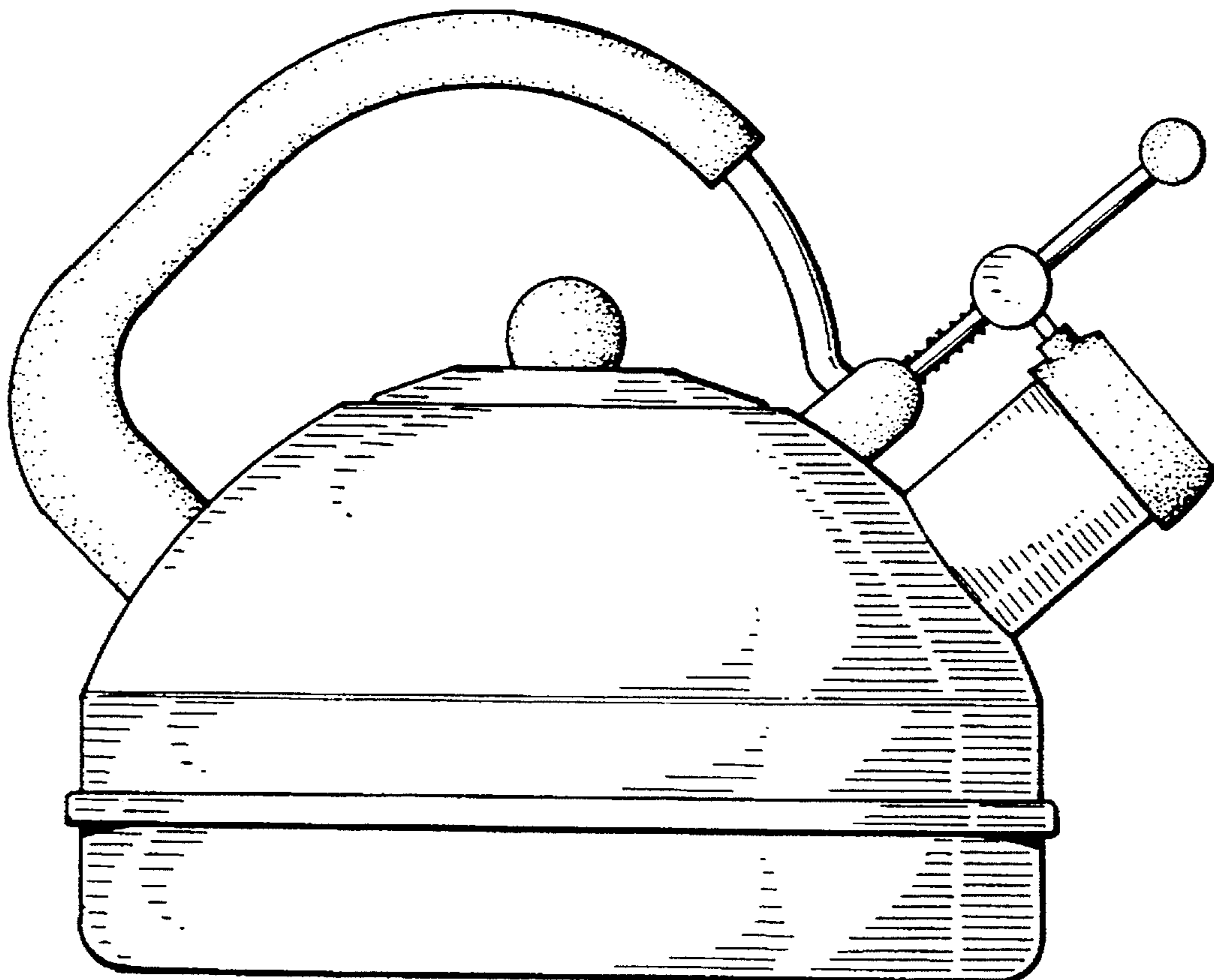
FIG. 3 is a left side elevational view thereof;

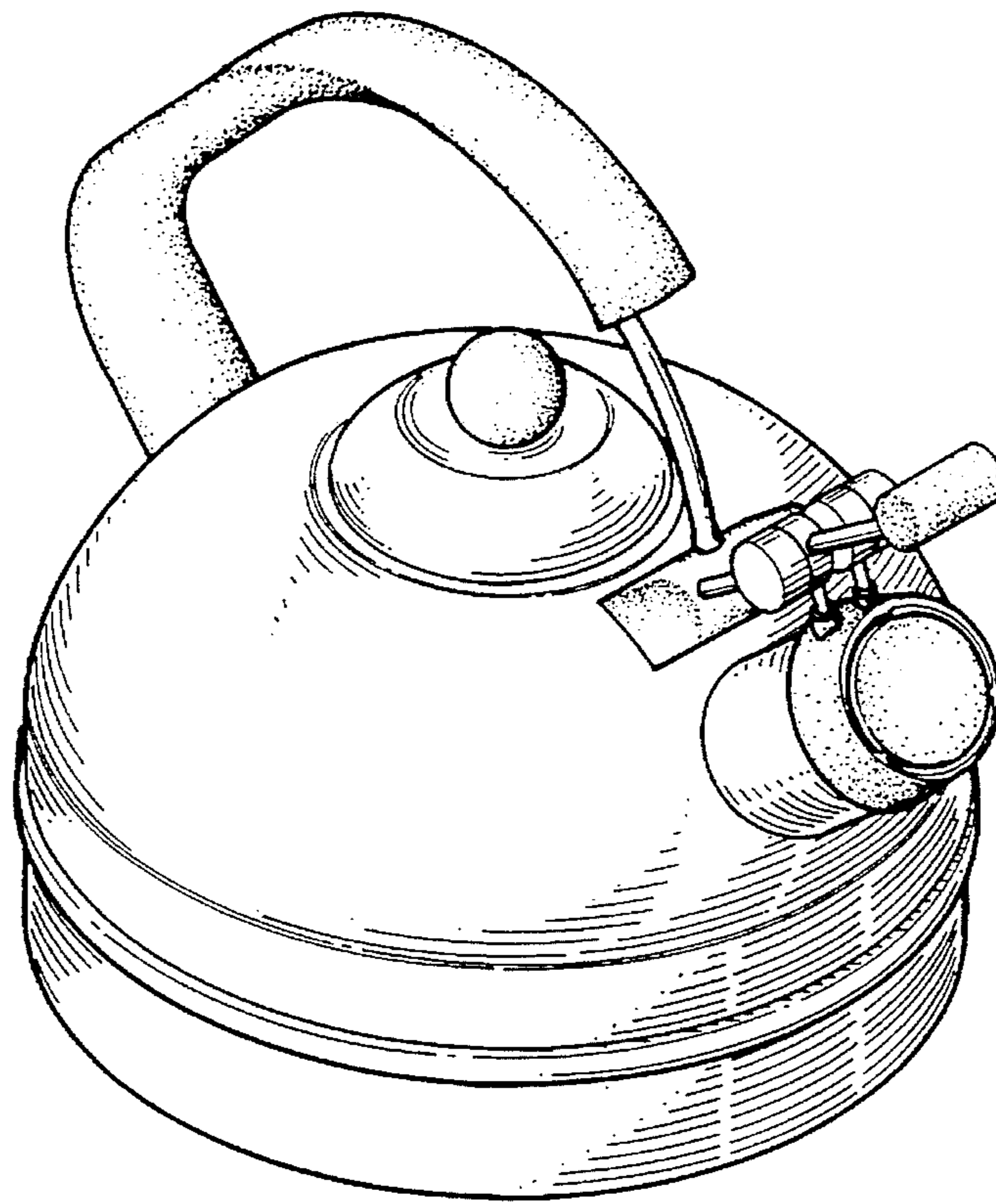

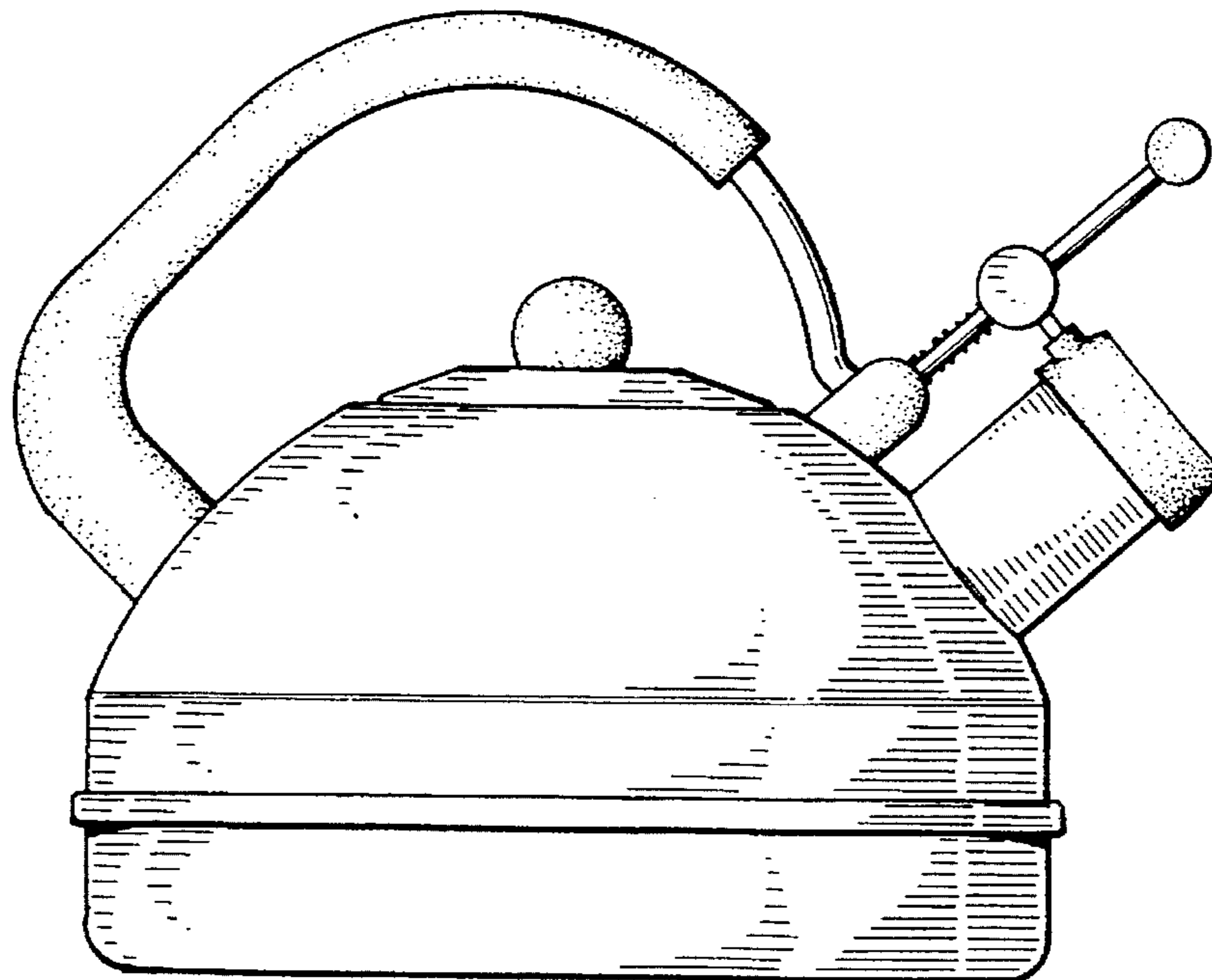

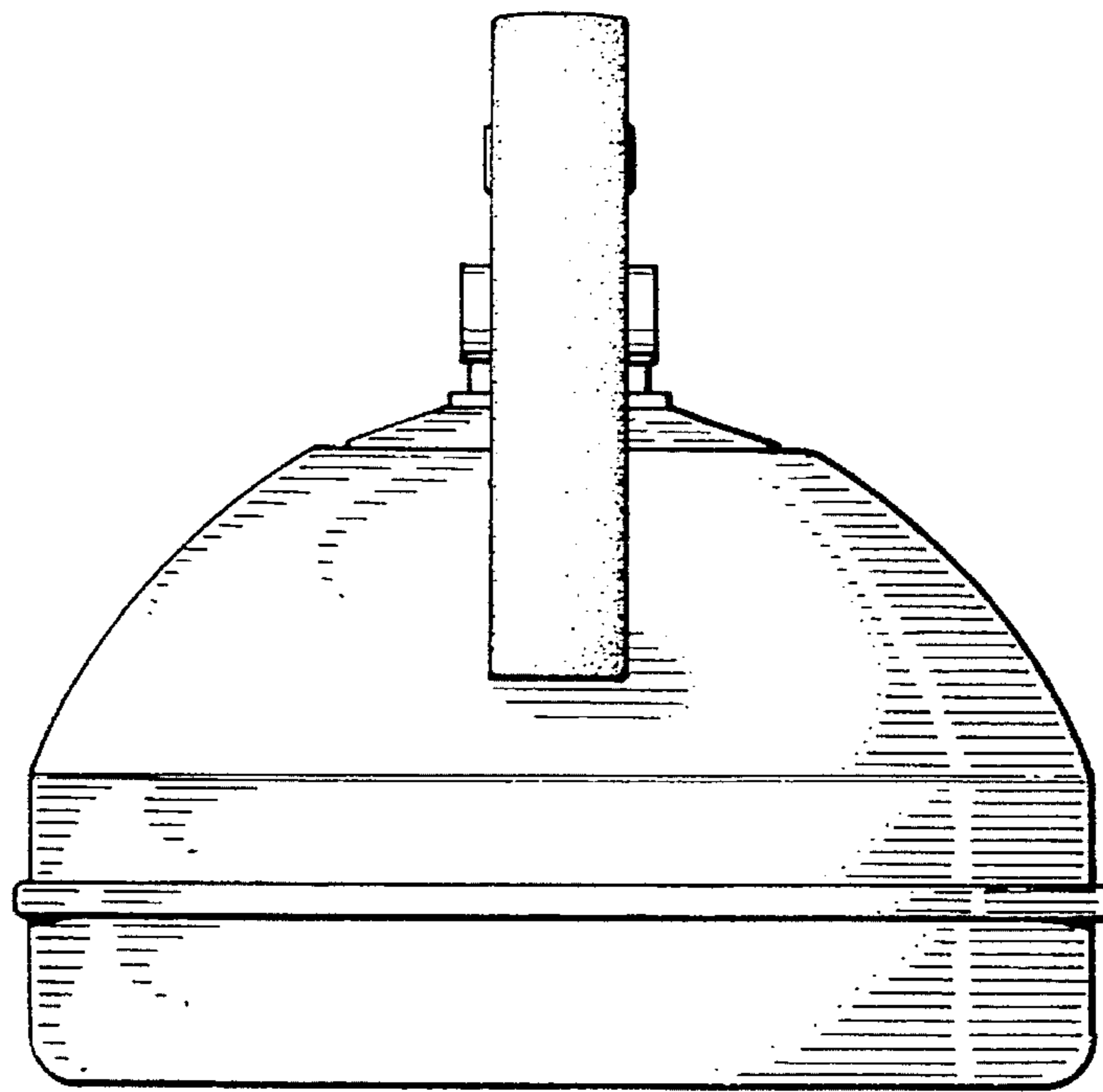

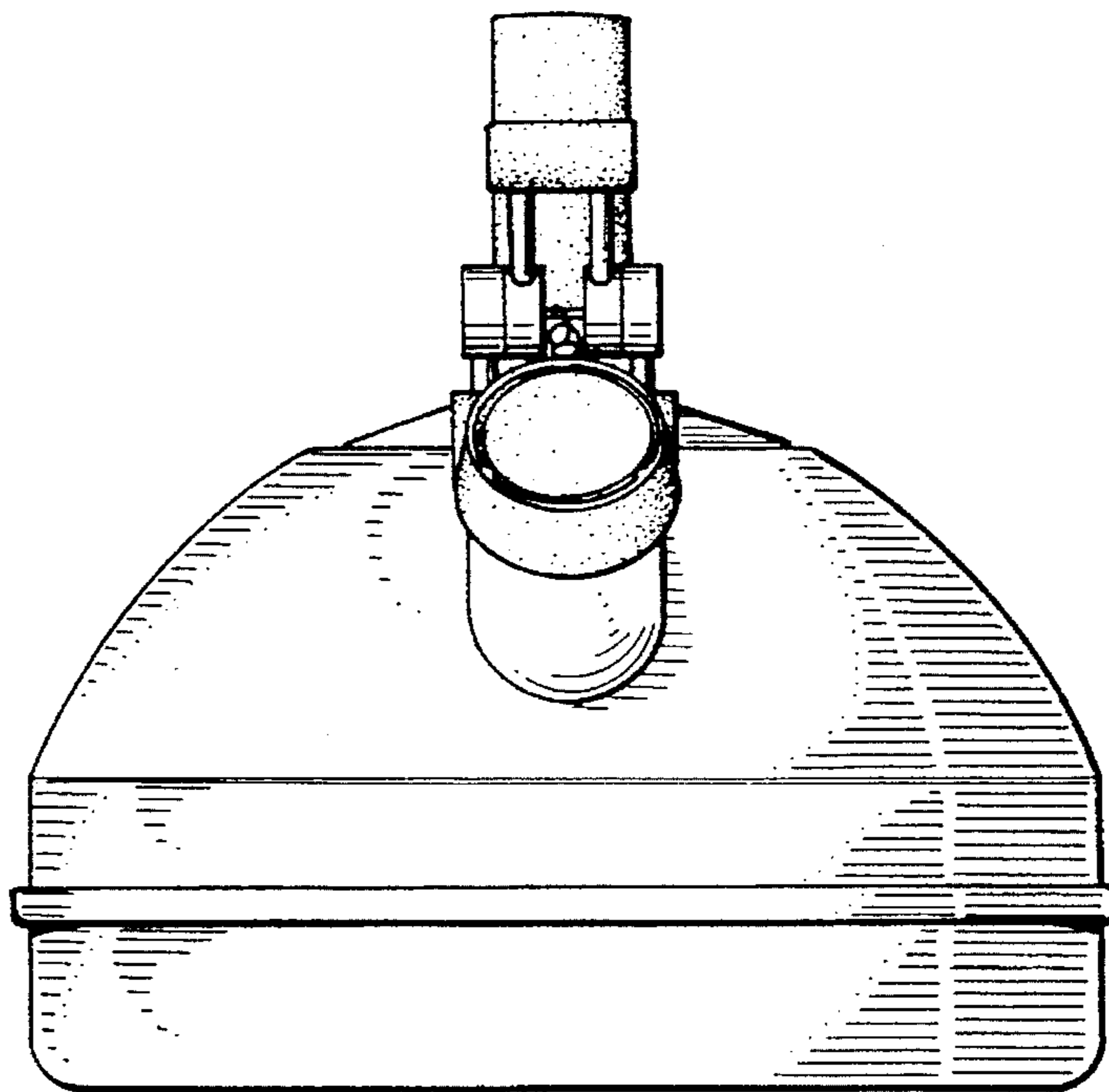

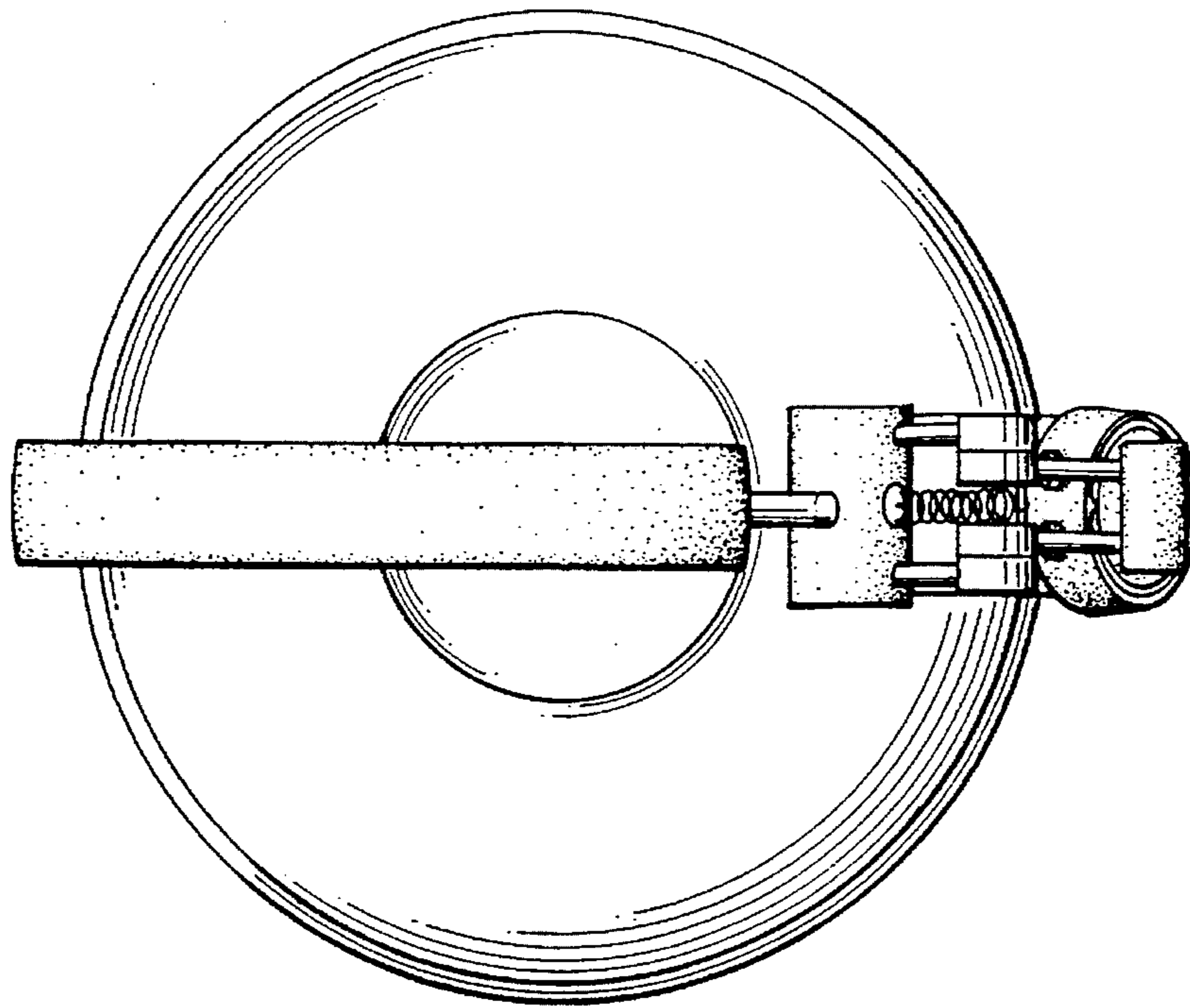

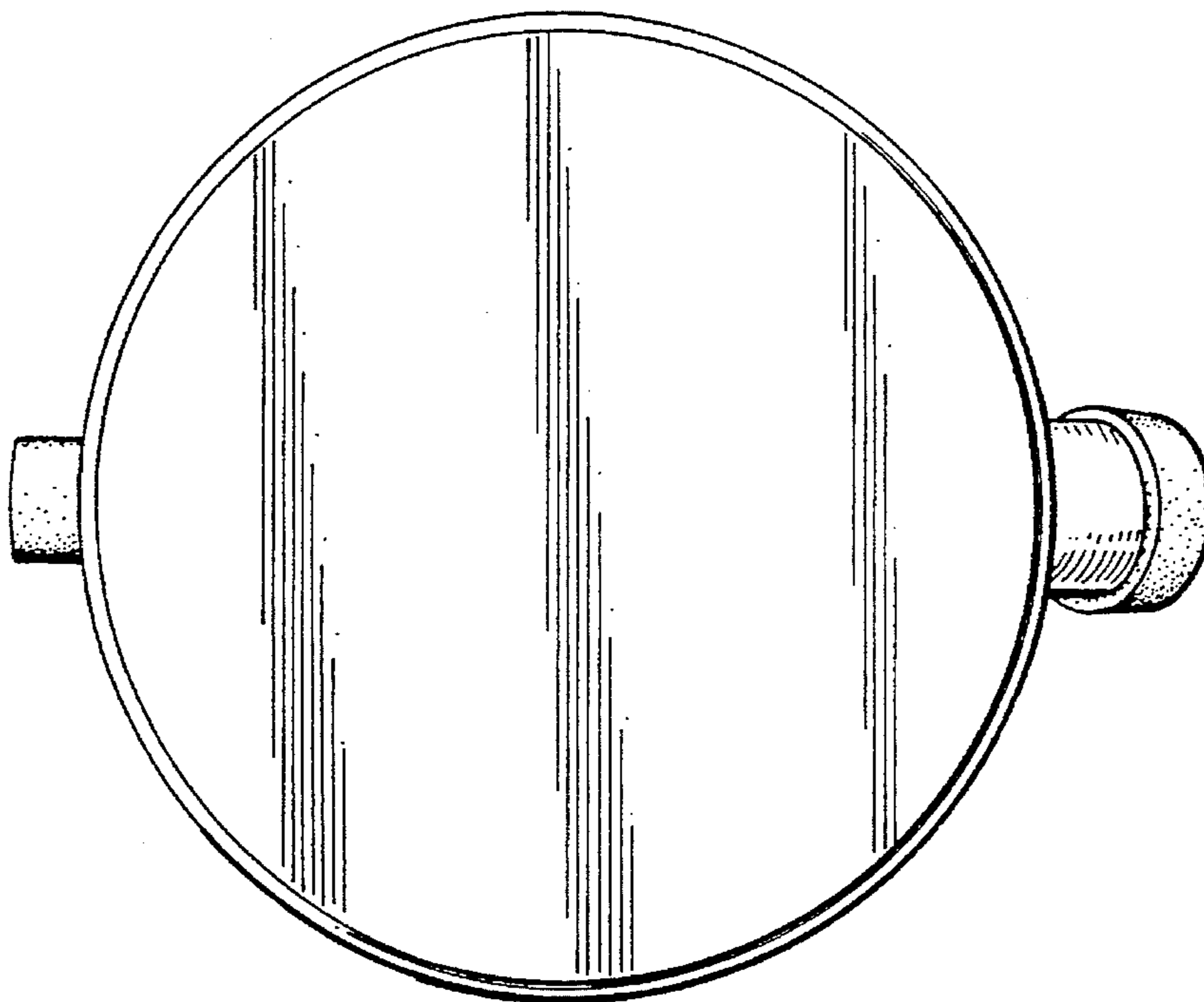
