[57] **CLAIM**

The ornamental design for a molding insert pair, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of the molding insert showing the top of the first half of a molding insert pair; FIG. 2 is a right rear perspective view thereof showing the bottom of the first half of the molding insert pair;

FIG. 3 is a top plan view thereof showing the first half of the molding insert pair;

FIG. 4 is a top plan view thereof showing the second half of the molding insert pair;

FIG. 5 is a bottom plan view thereof showing the first half of the molding insert pair;

FIG. 6 is a bottom plan view thereof showing the second half of the molding insert pair;

FIG. 7 is a front elevational view thereof showing the first half of the molding insert pair;

FIG. 8 is a right side elevational view thereof showing the first half of the molding insert pair;

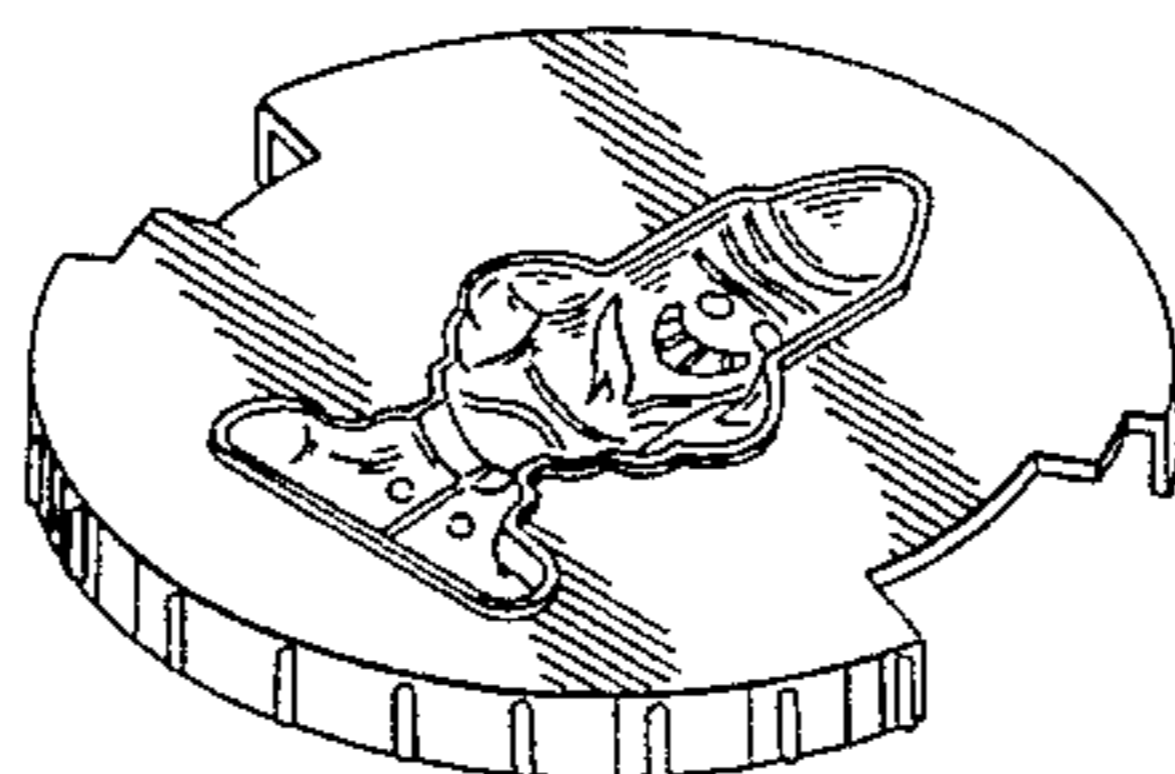
FIG. 9 is a rear elevational view thereof showing the first half of the molding insert pair;

FIG. 10 is a left side elevational view thereof showing the first half of the molding insert pair; and,

FIG. 11 is a right front perspective view of the molding insert pair showing the molding handle in broken lines.

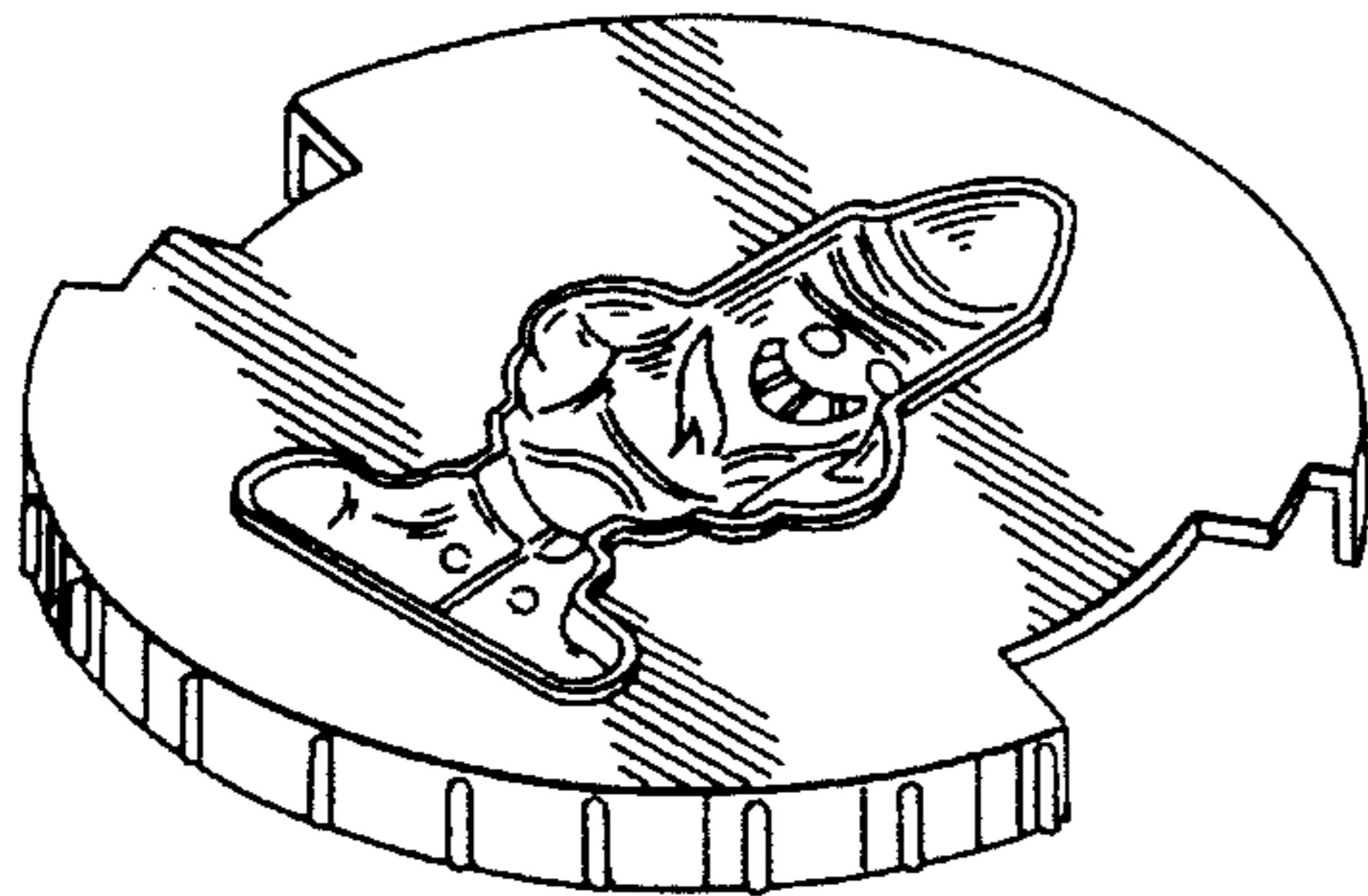

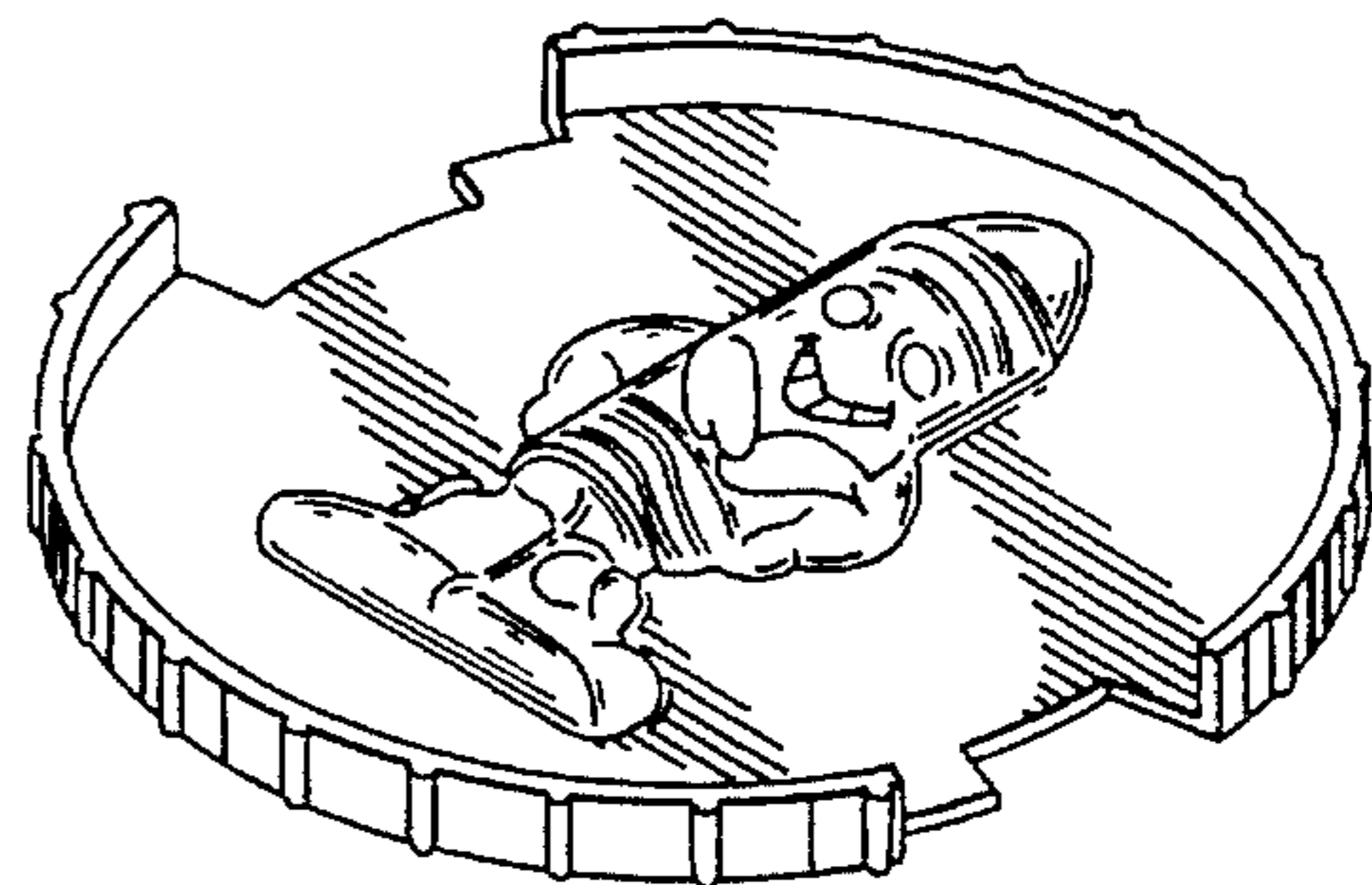

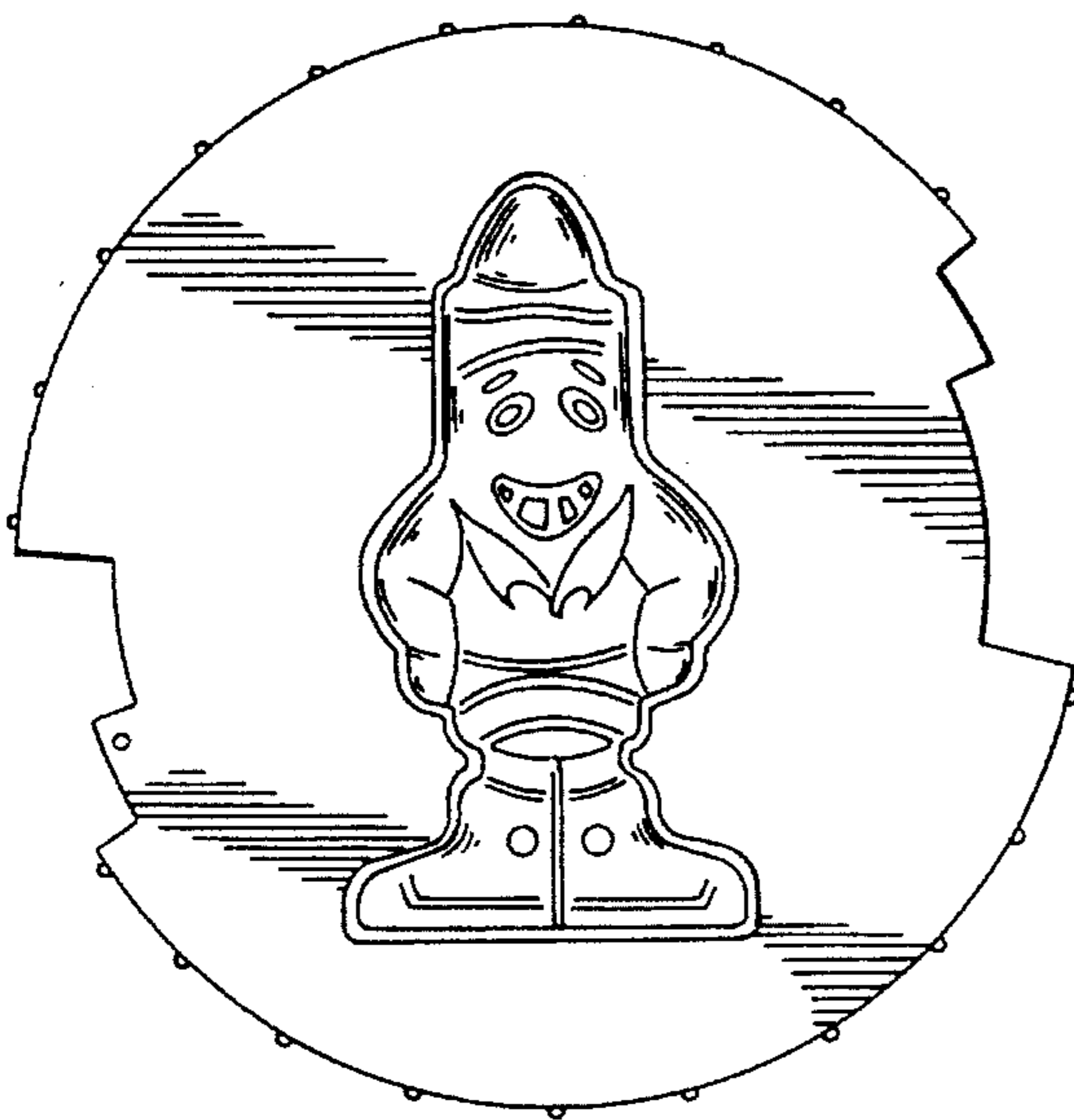

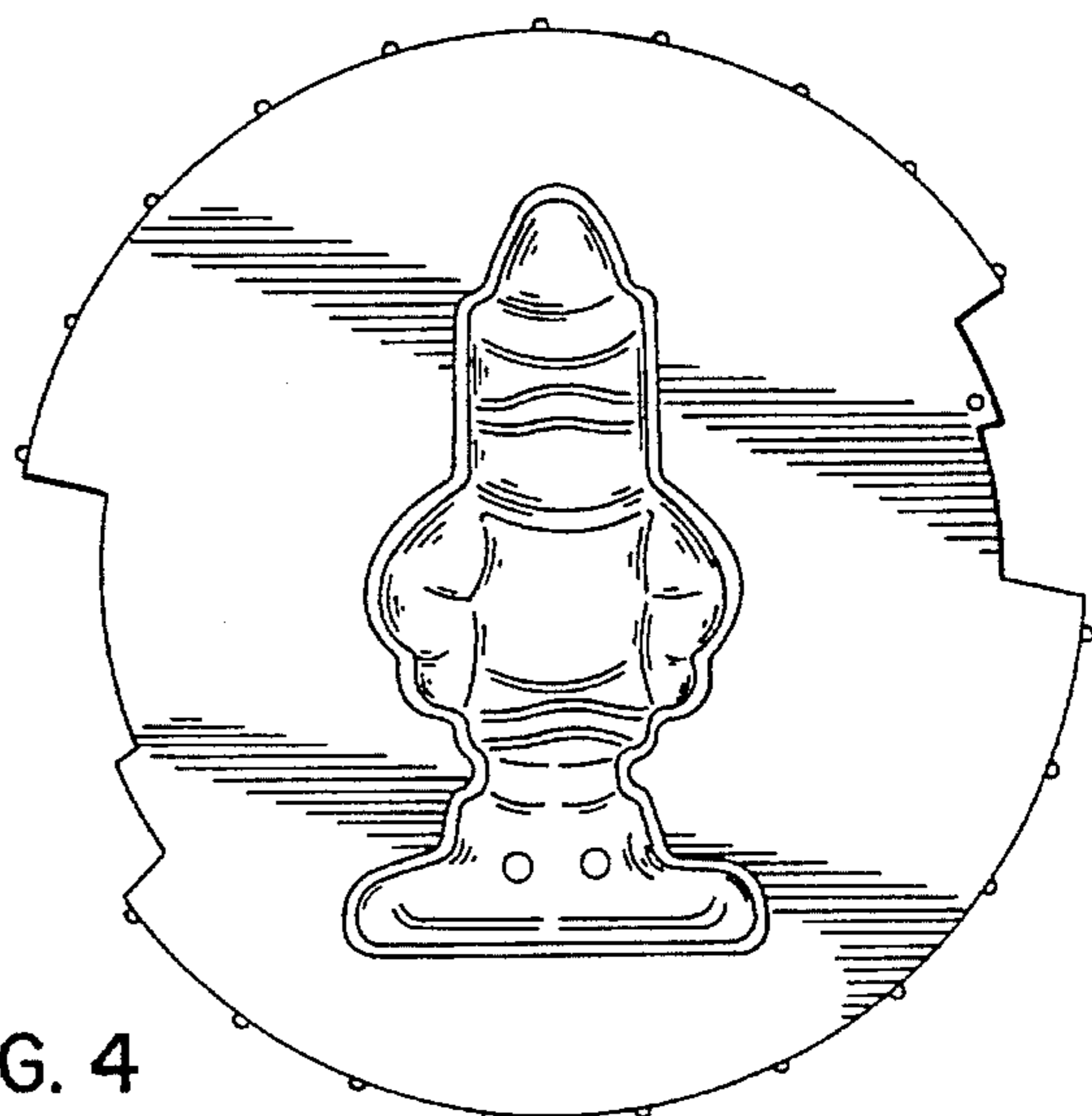

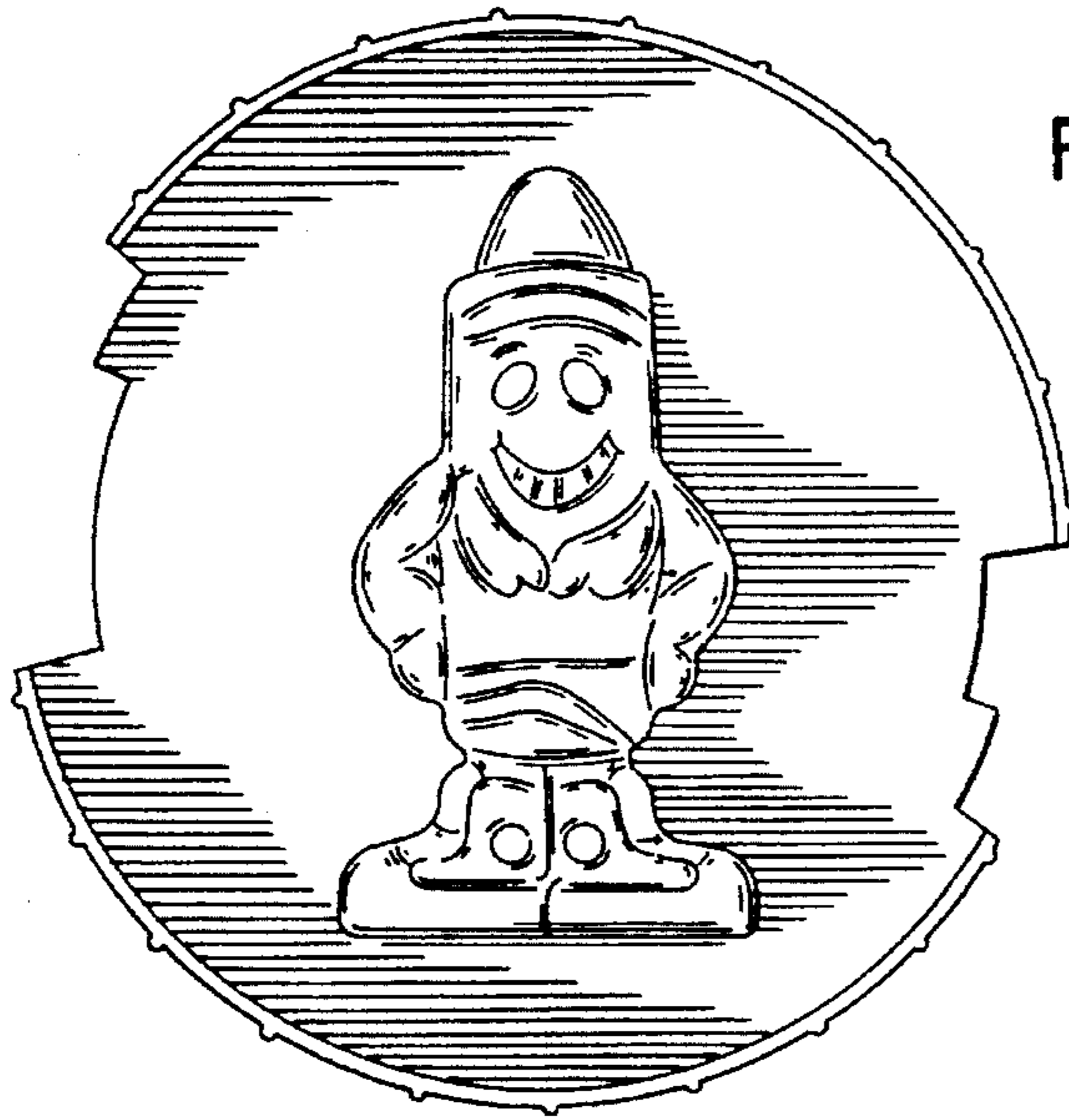

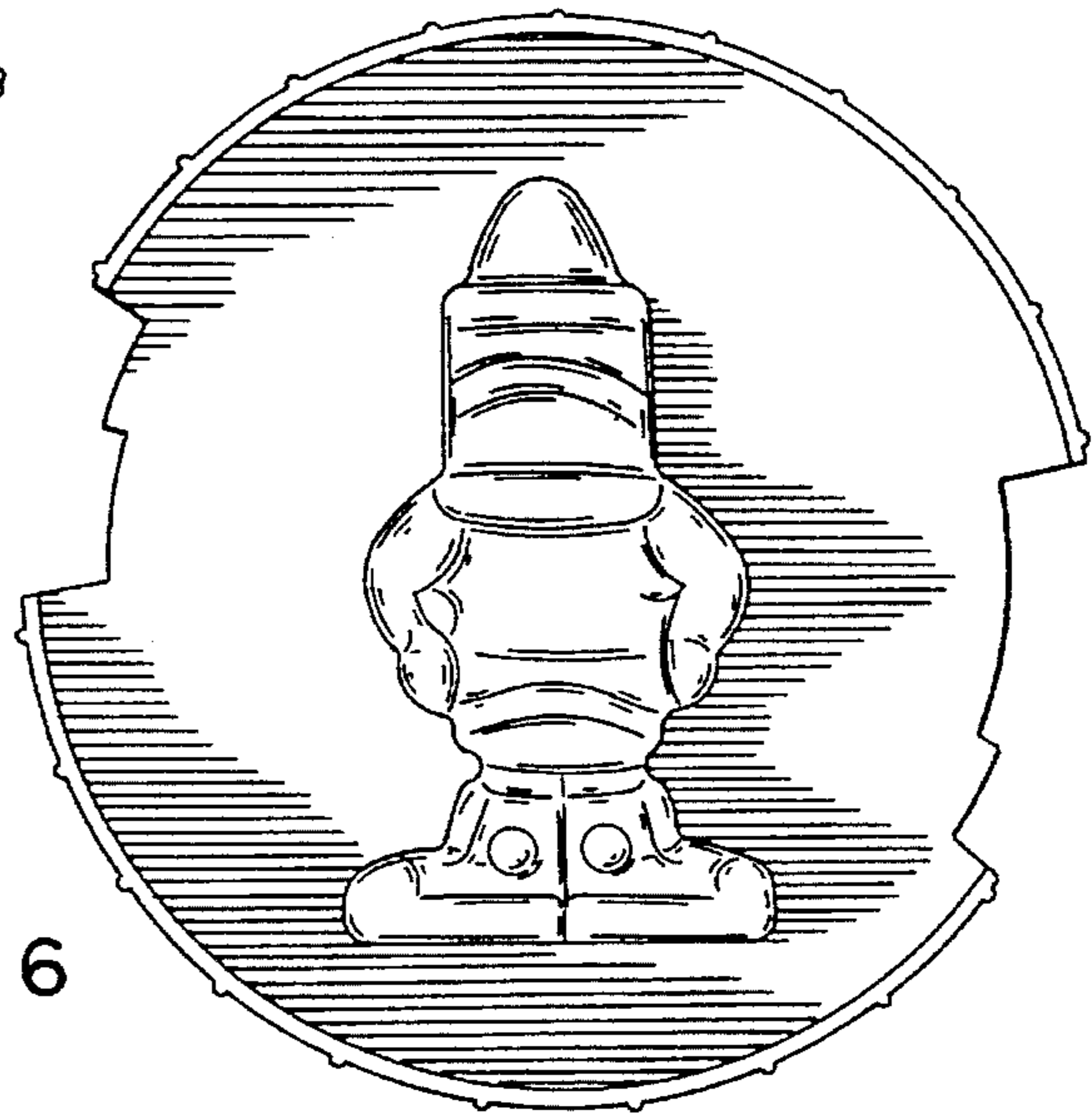

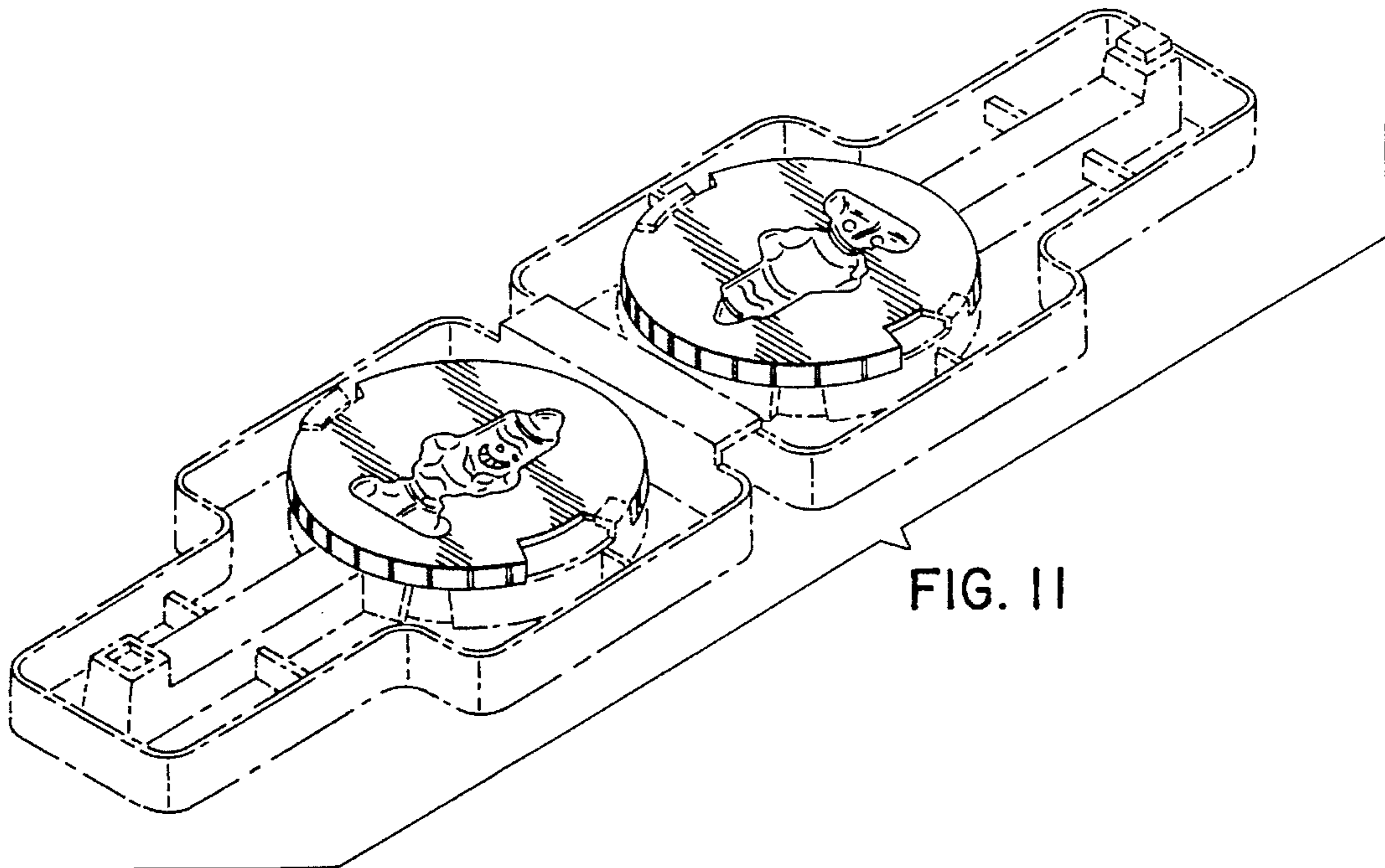
