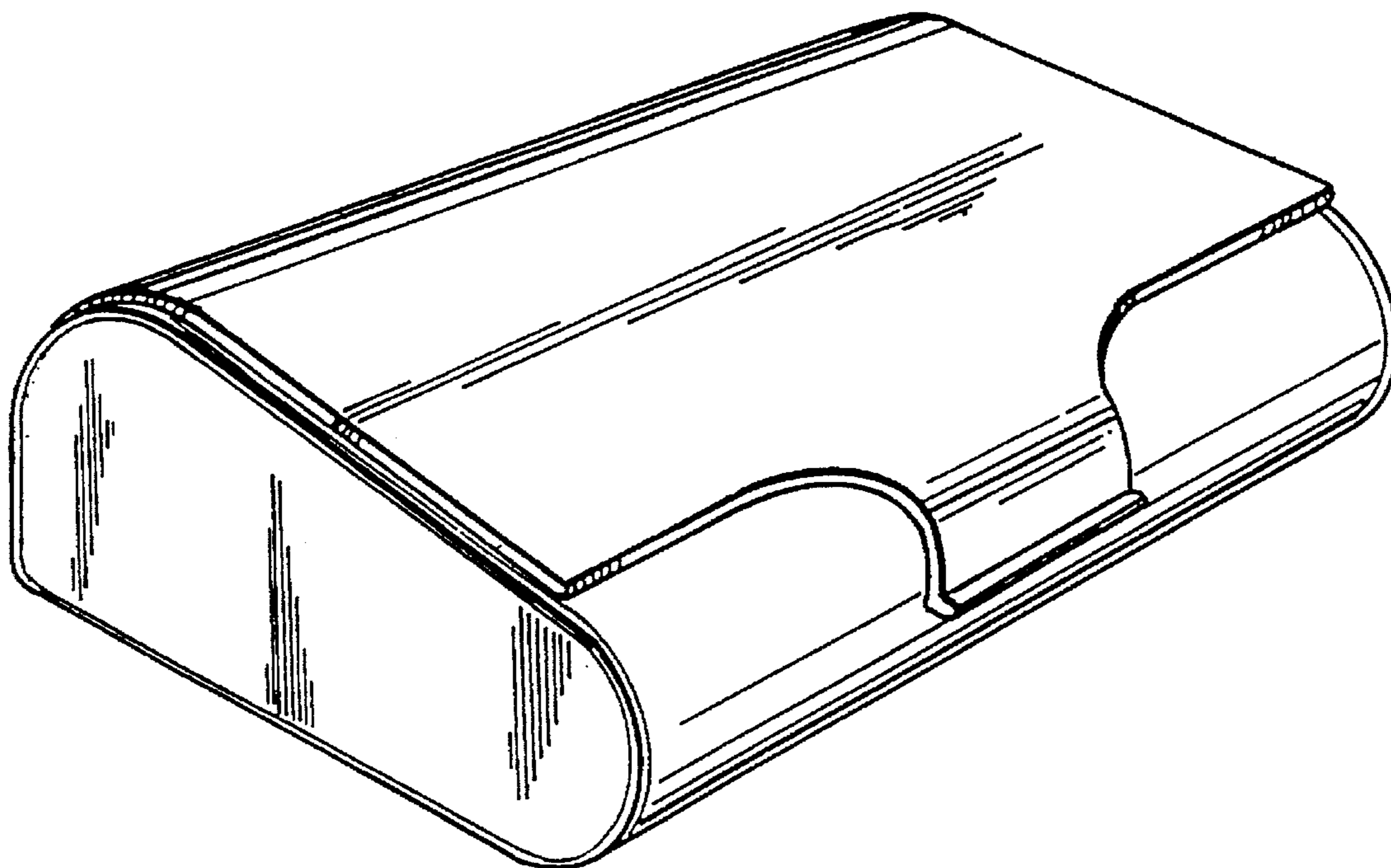
[57] **CLAIM**

The ornamental design for a case for holding consumer goods, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for holding consumer goods in accordance with my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side view thereof; the right side view being a mirror image of the left side view shown; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view of a modified embodiment of the case for holding consumer goods; FIG. 8 is a front elevational view thereof; FIG. 9 is a rear elevational view thereof; FIG. 10 is a left side view thereof; the right side view being a mirror image of the left side view shown; FIG. 11 is a top view thereof; and, FIG. 12 is a bottom view thereof.

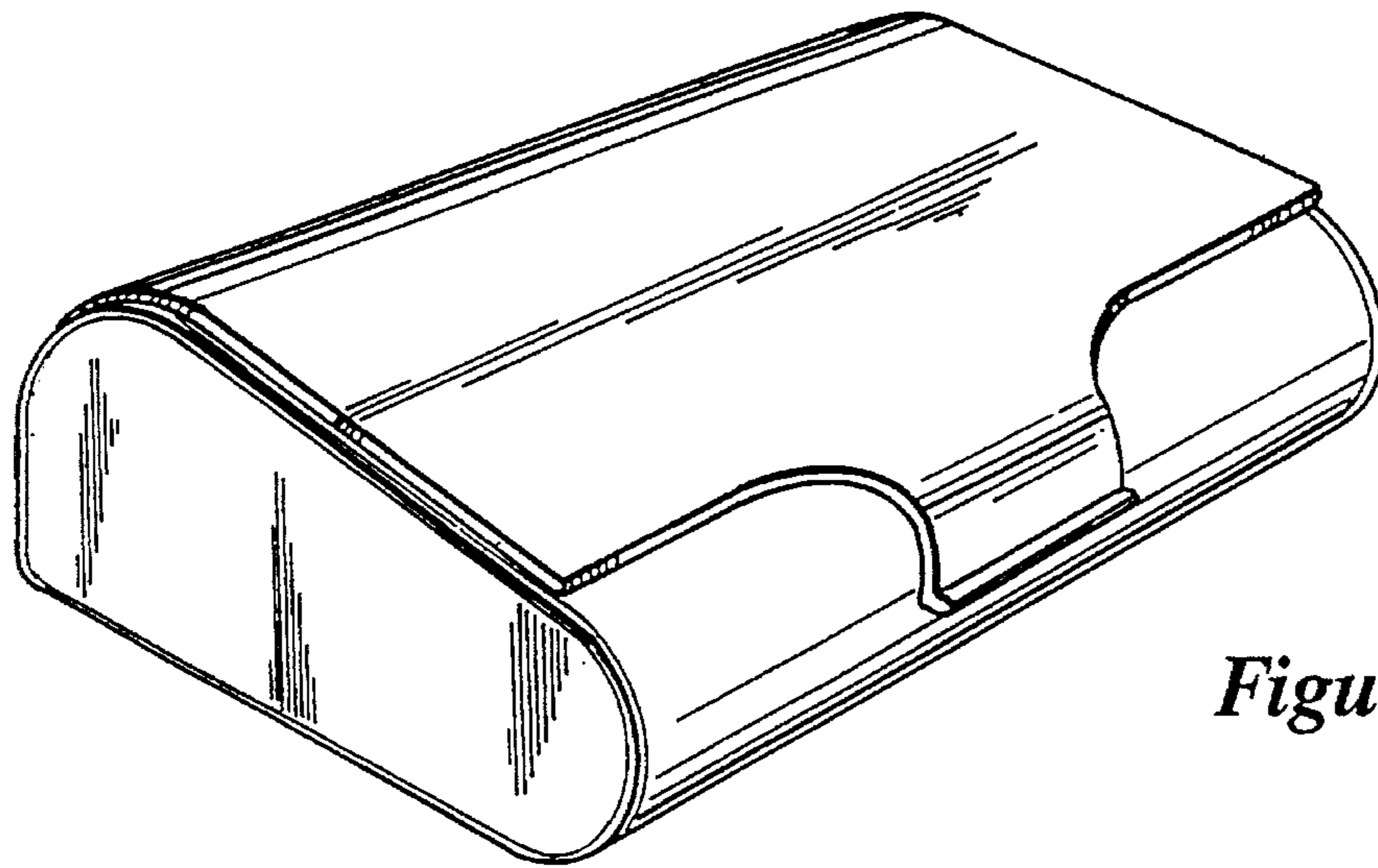

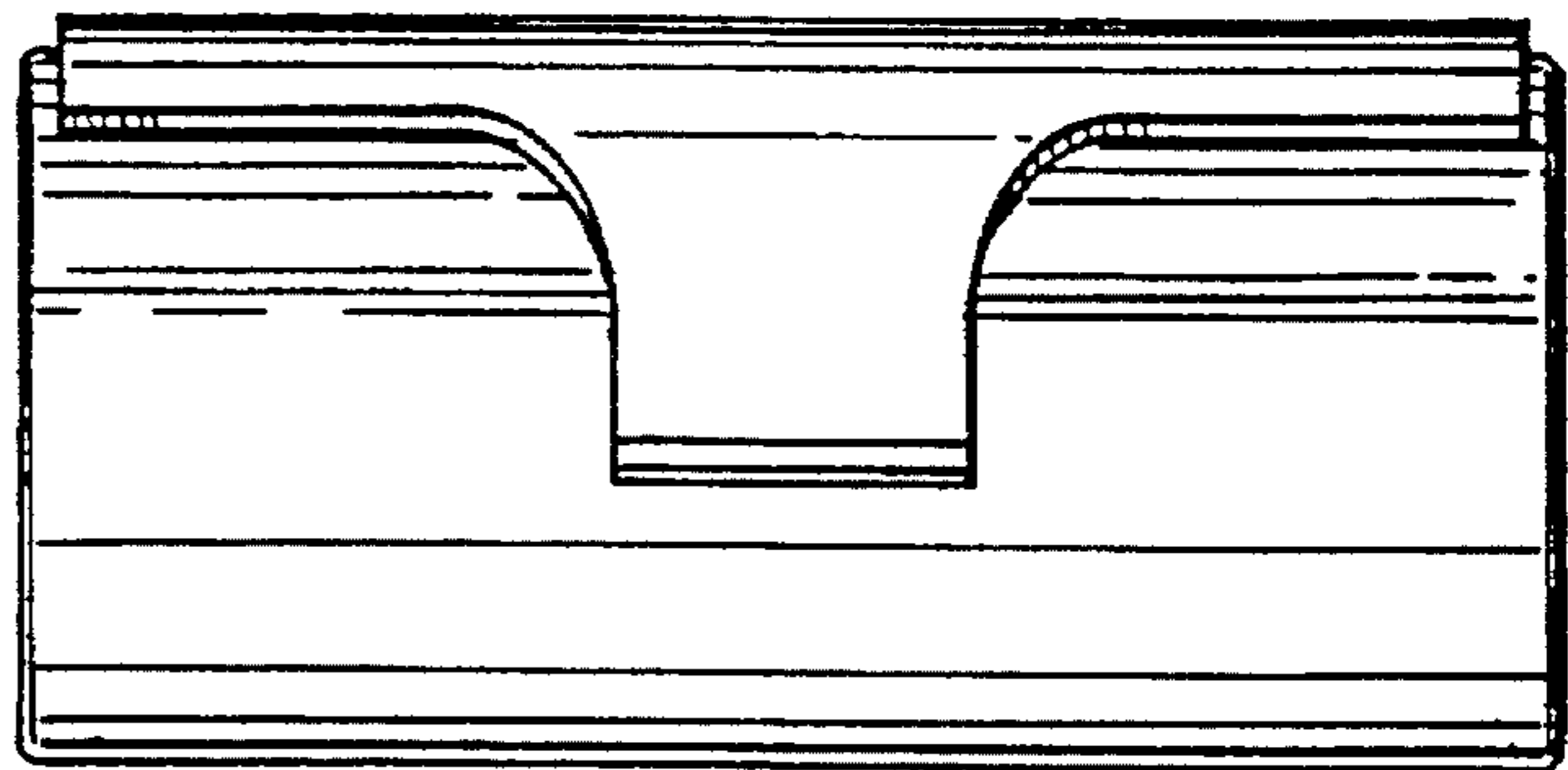

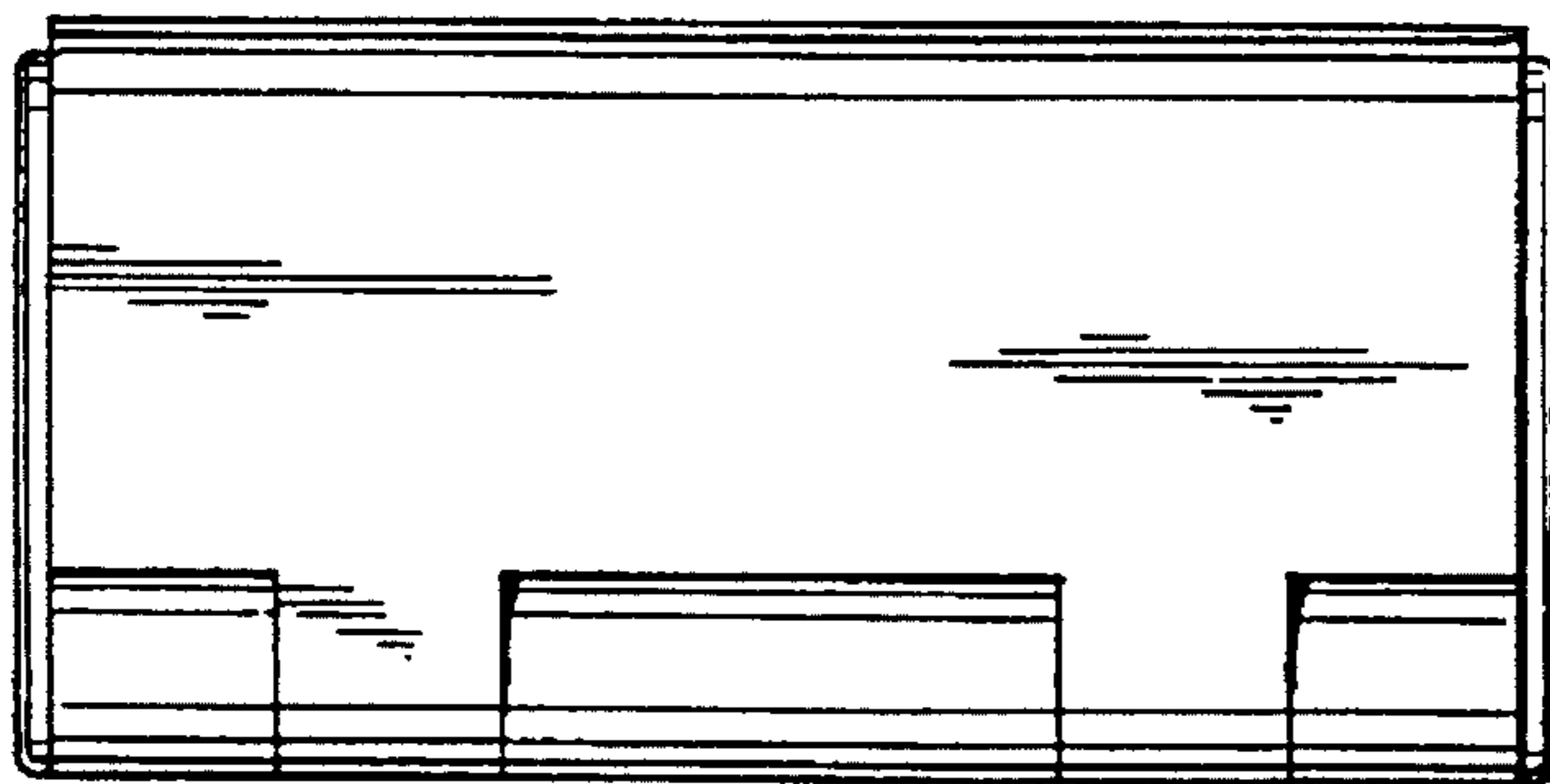

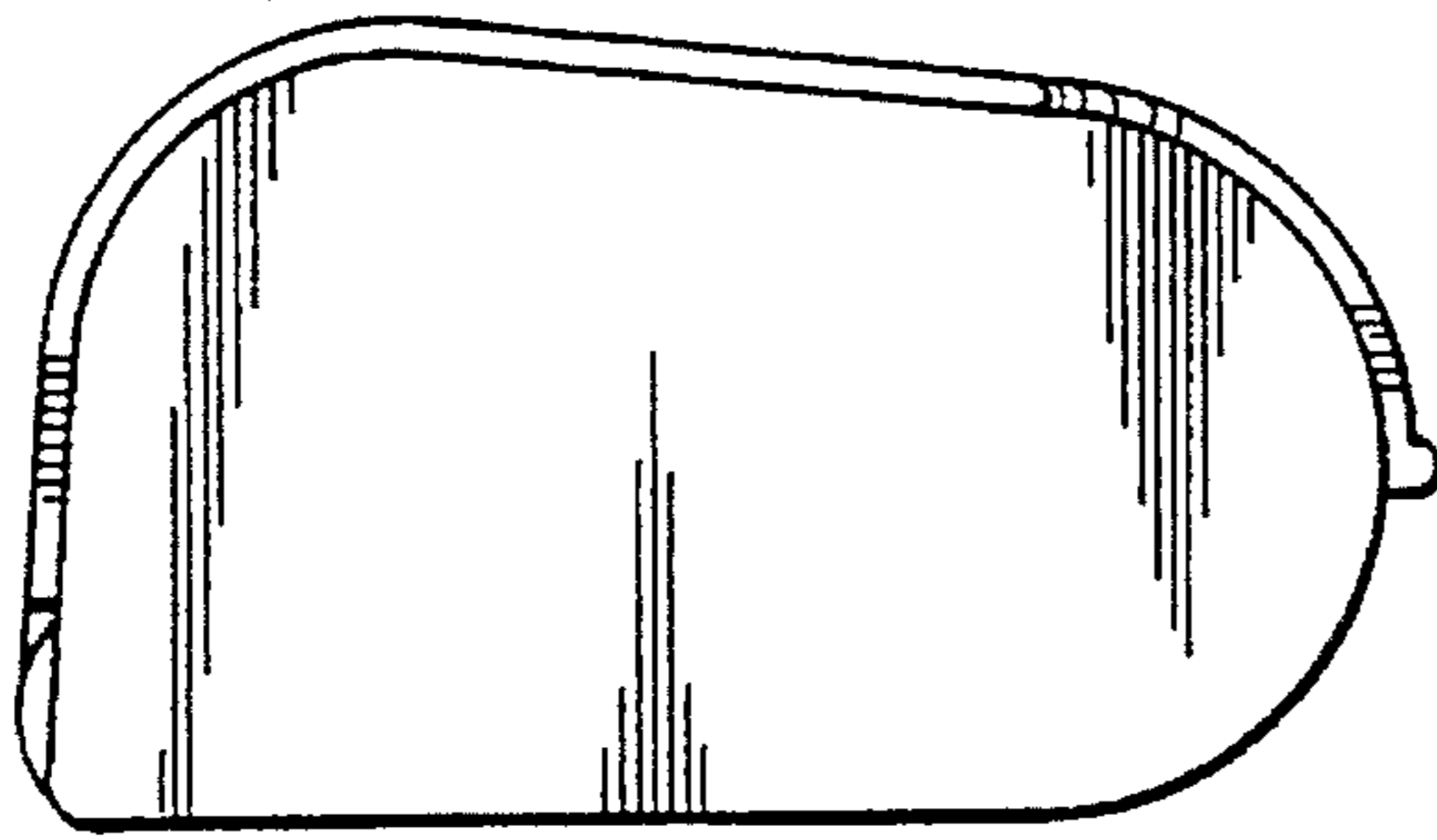

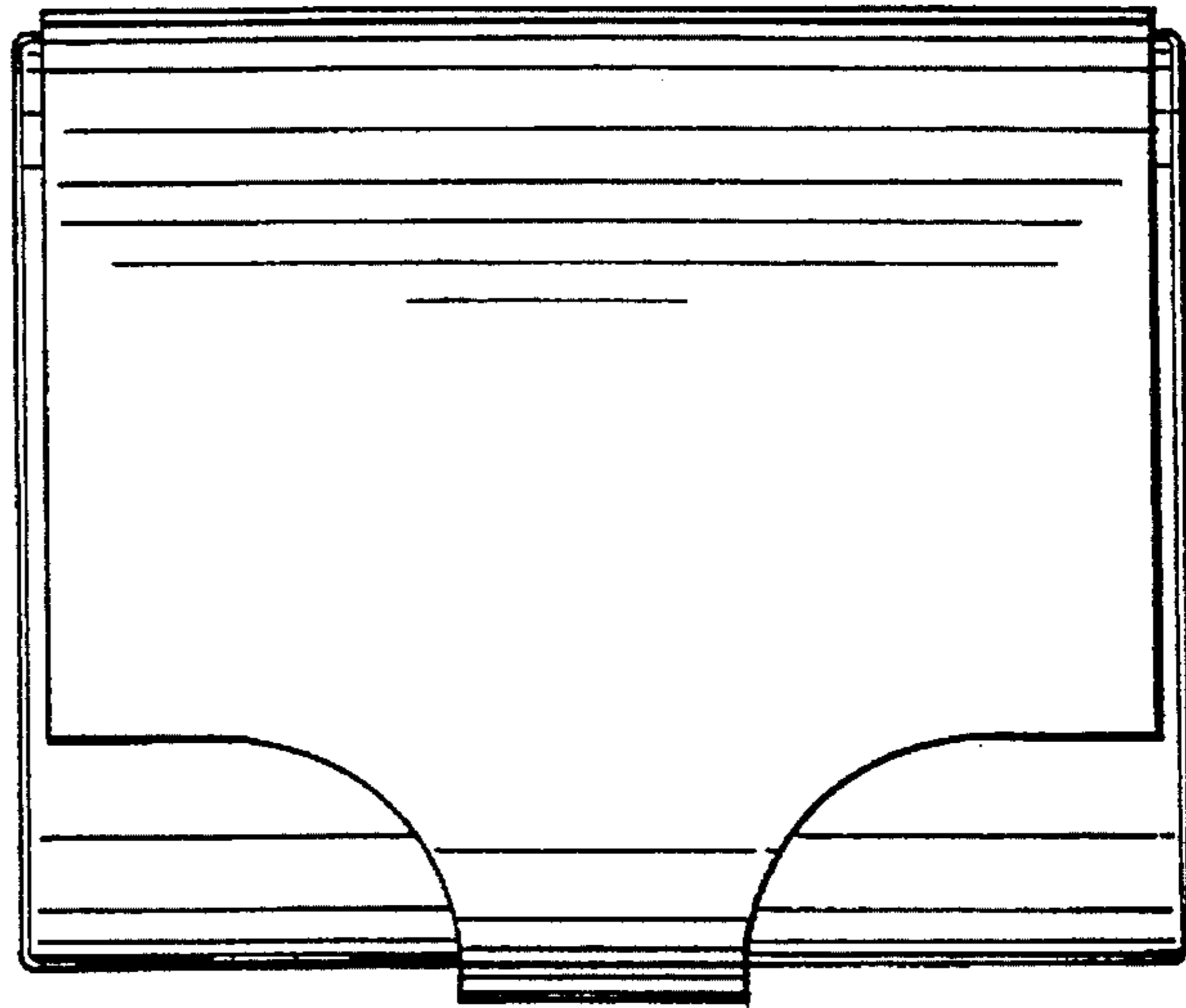

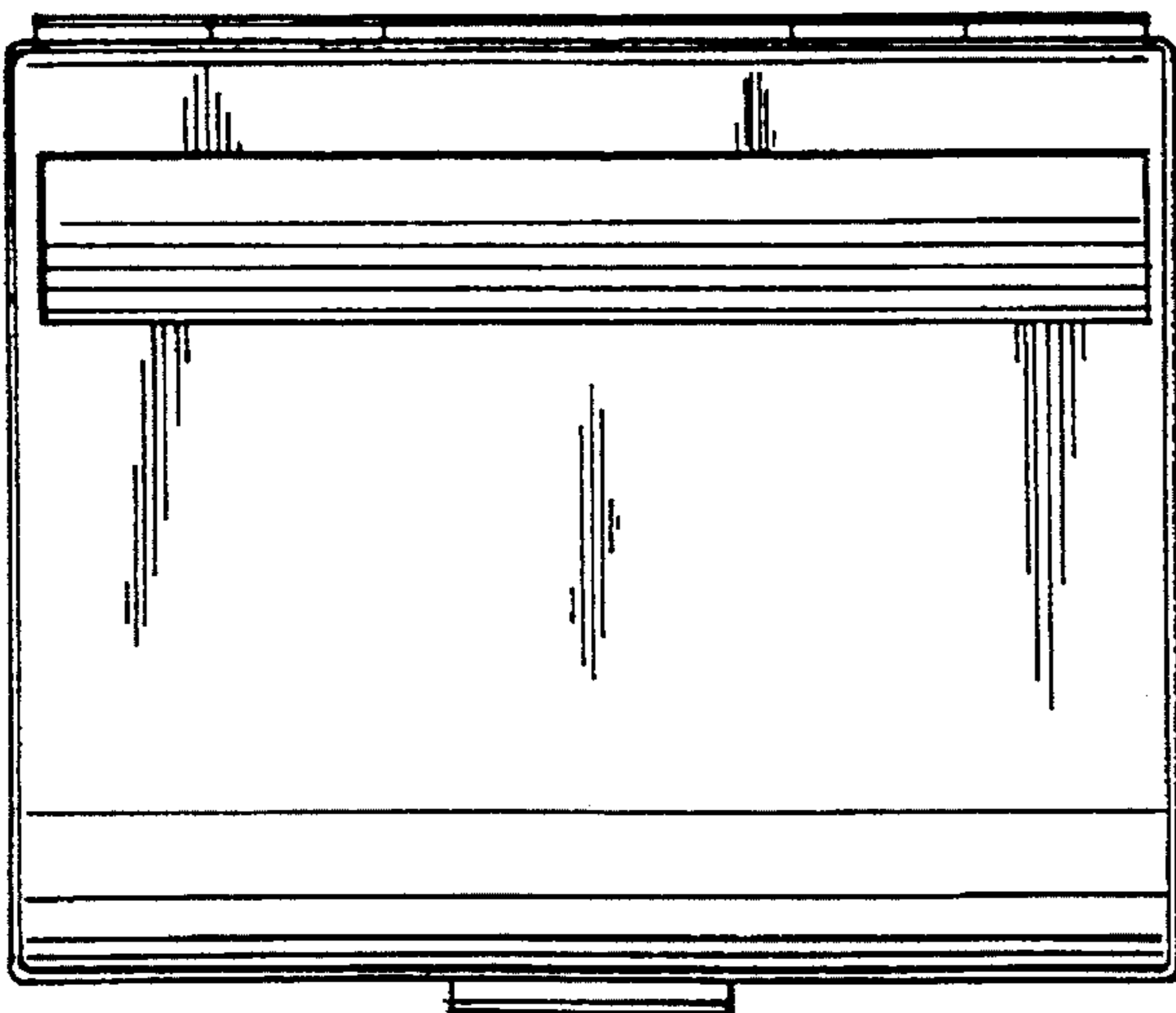

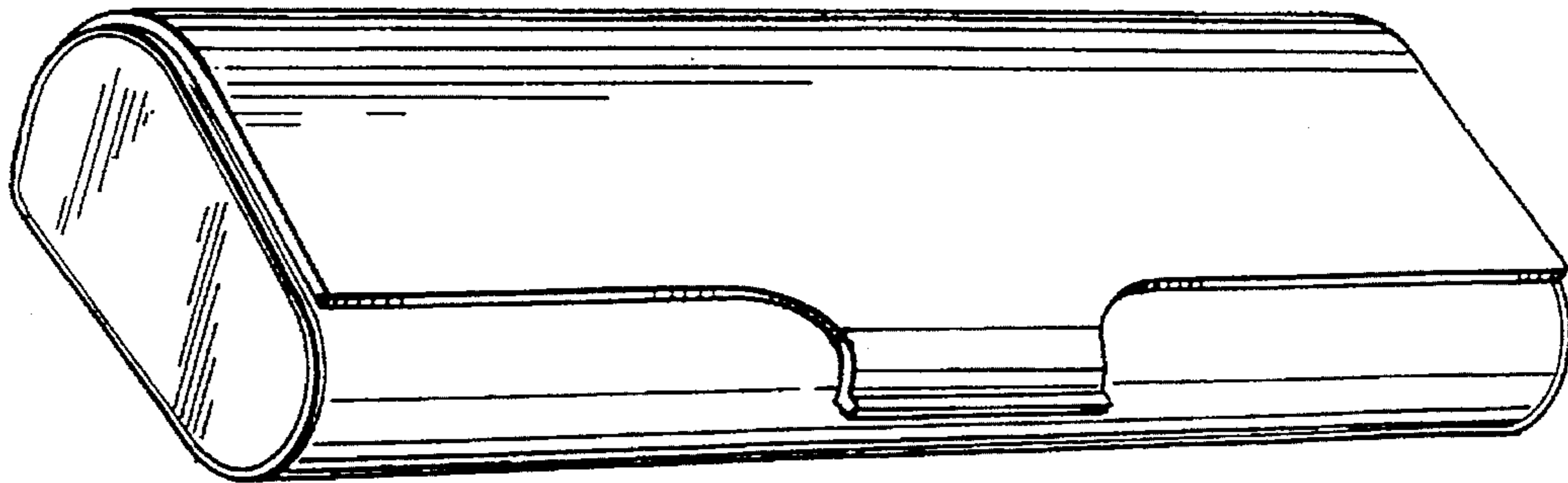

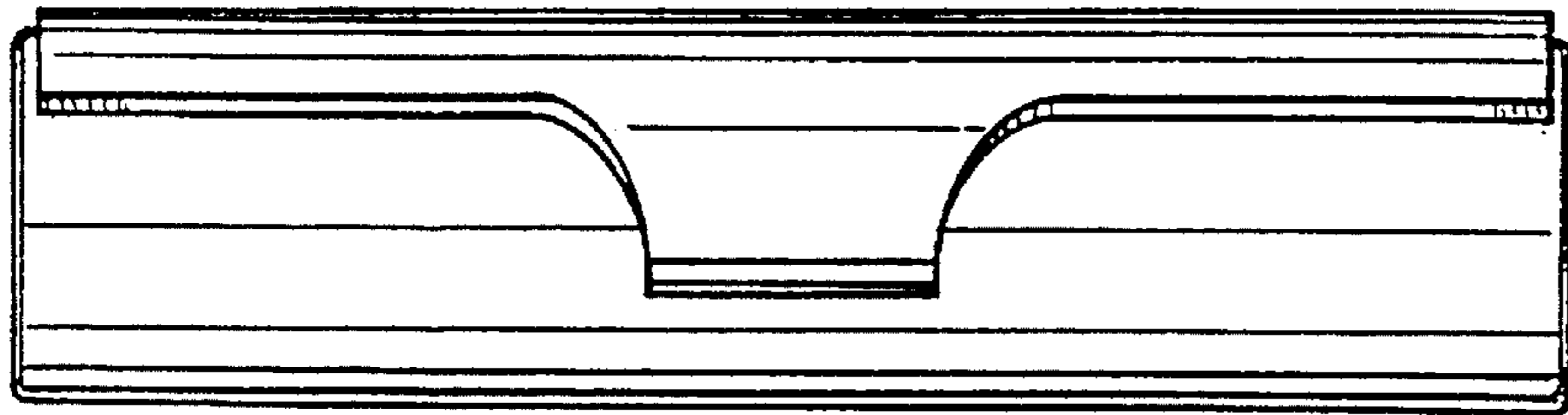

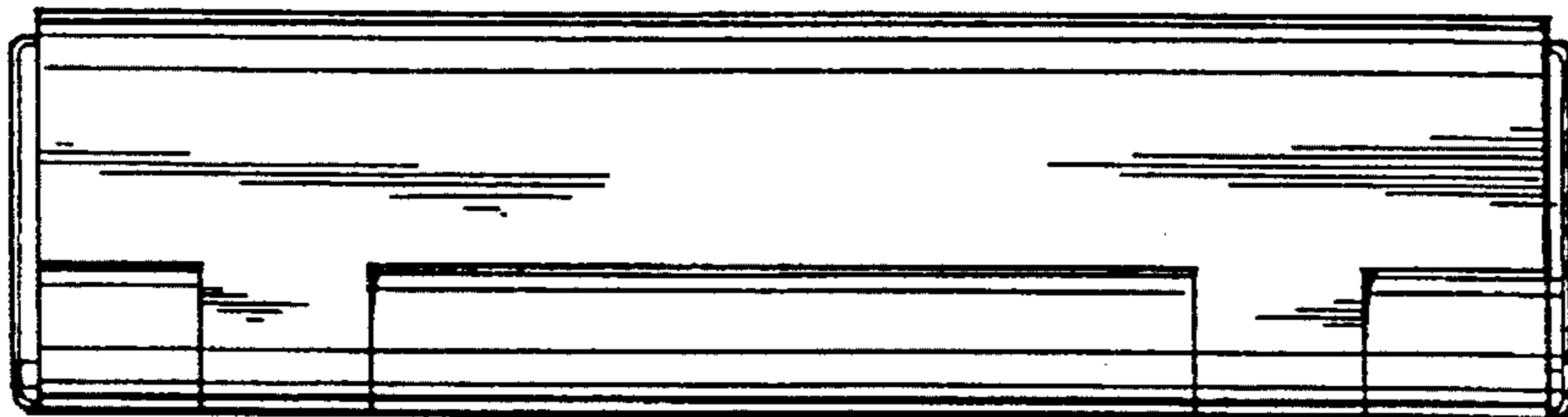
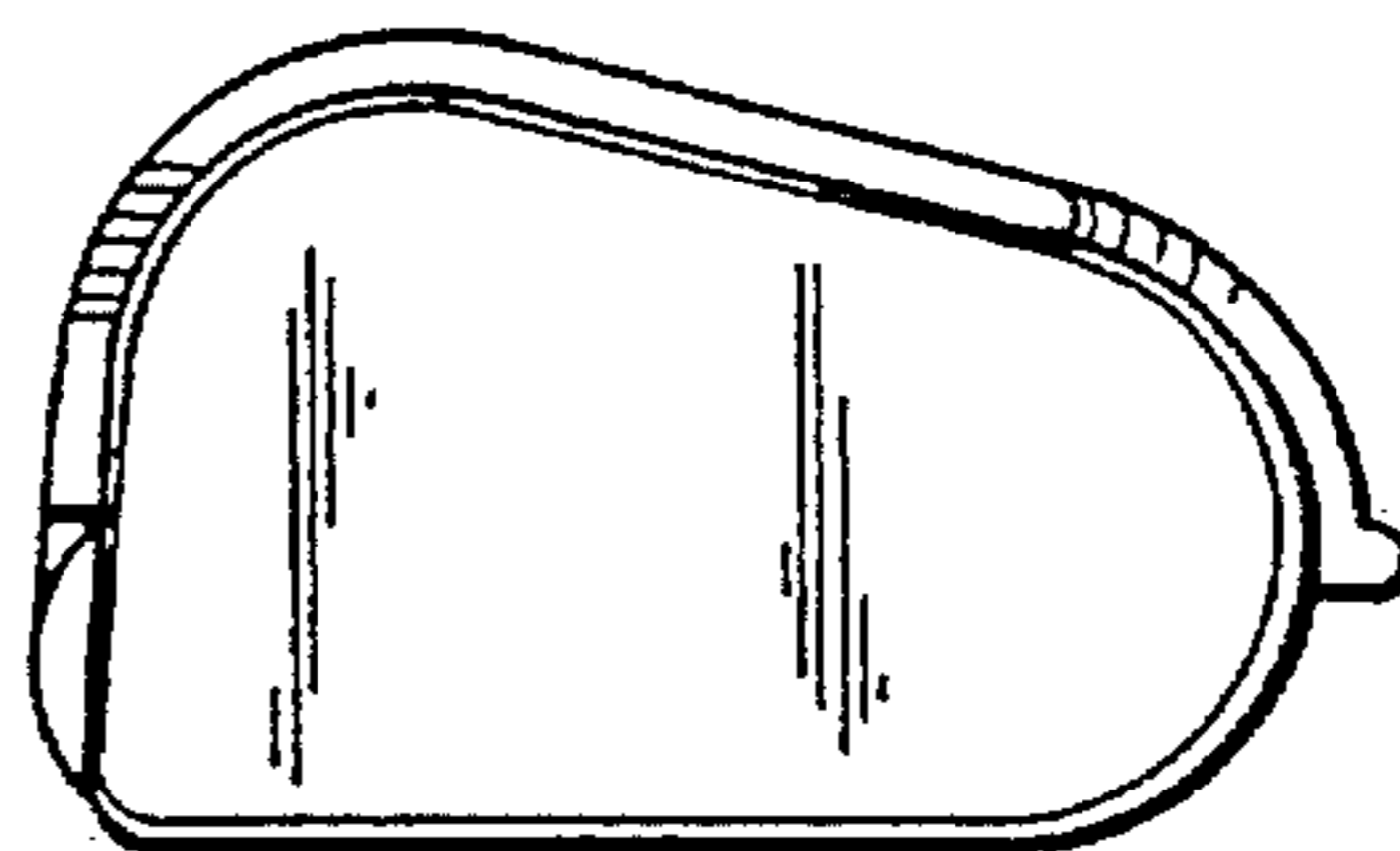

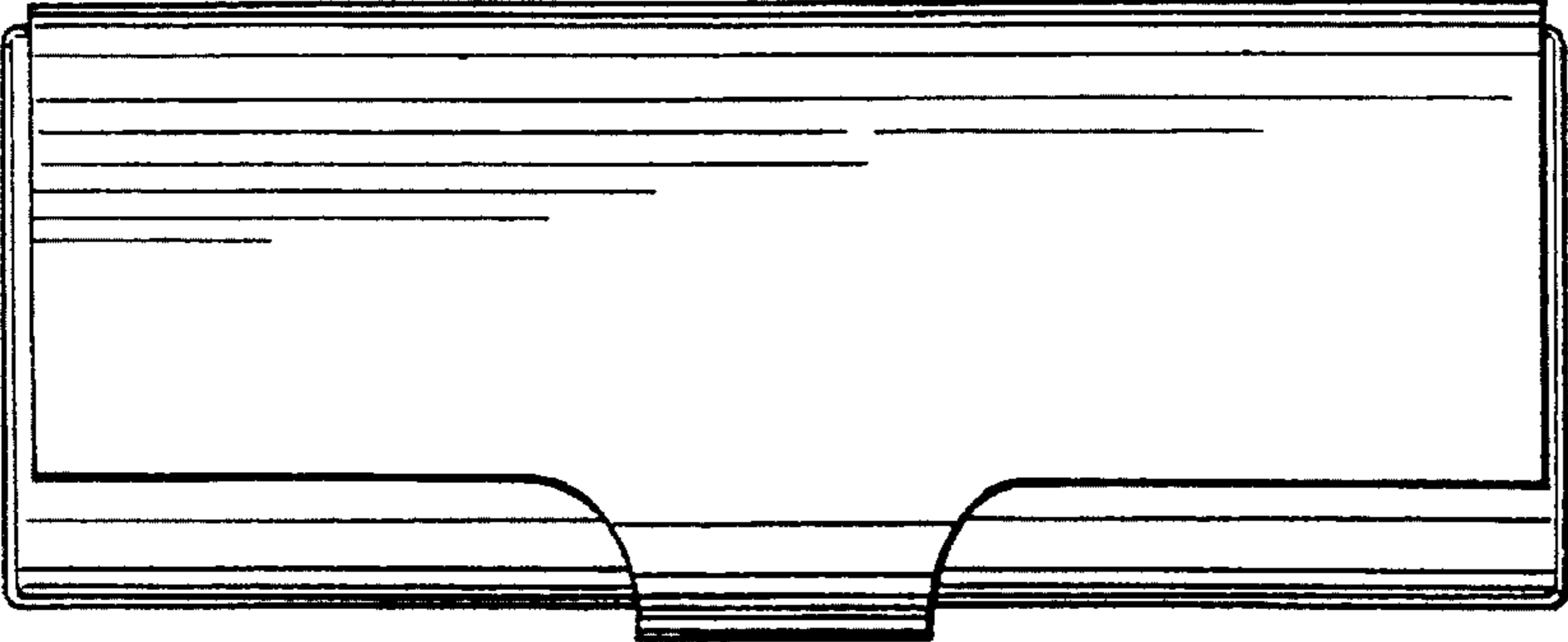

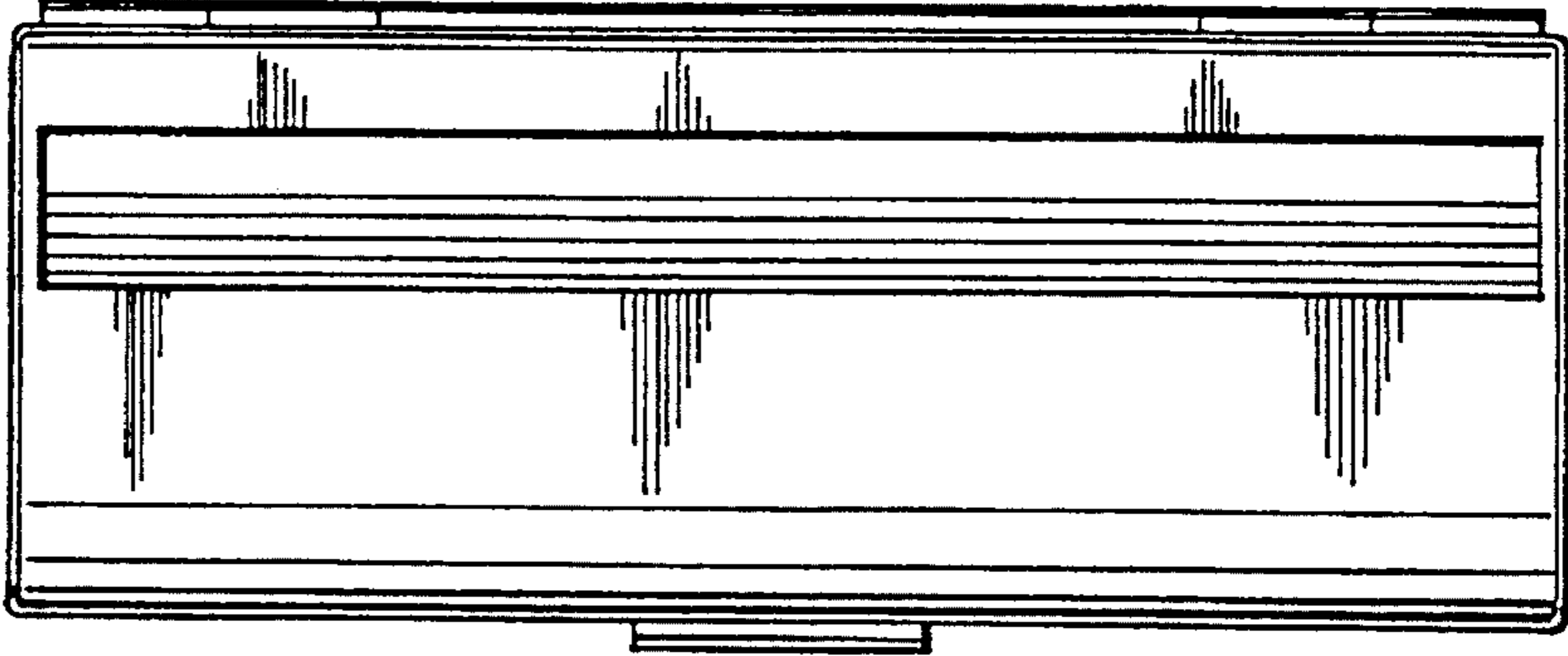
