The ornamental design for a storage organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the storage organizer showing our new ornamental design therefor;

FIG. 2 is a left side elevational view thereof, the right side being the mirror image of the right side;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof; and,

FIG. 7 is a front perspective view of the storage organizer showing one door in an open position.

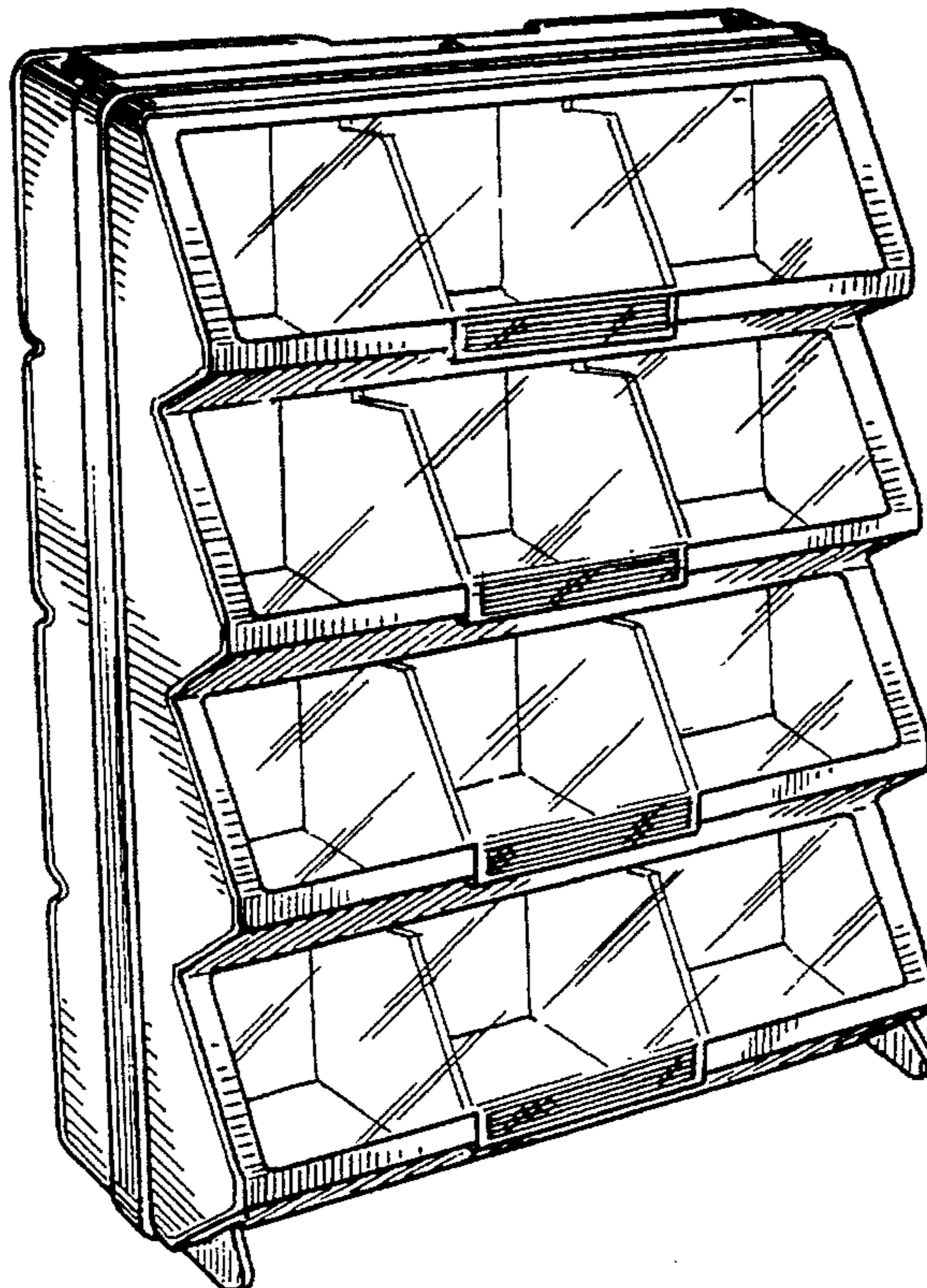

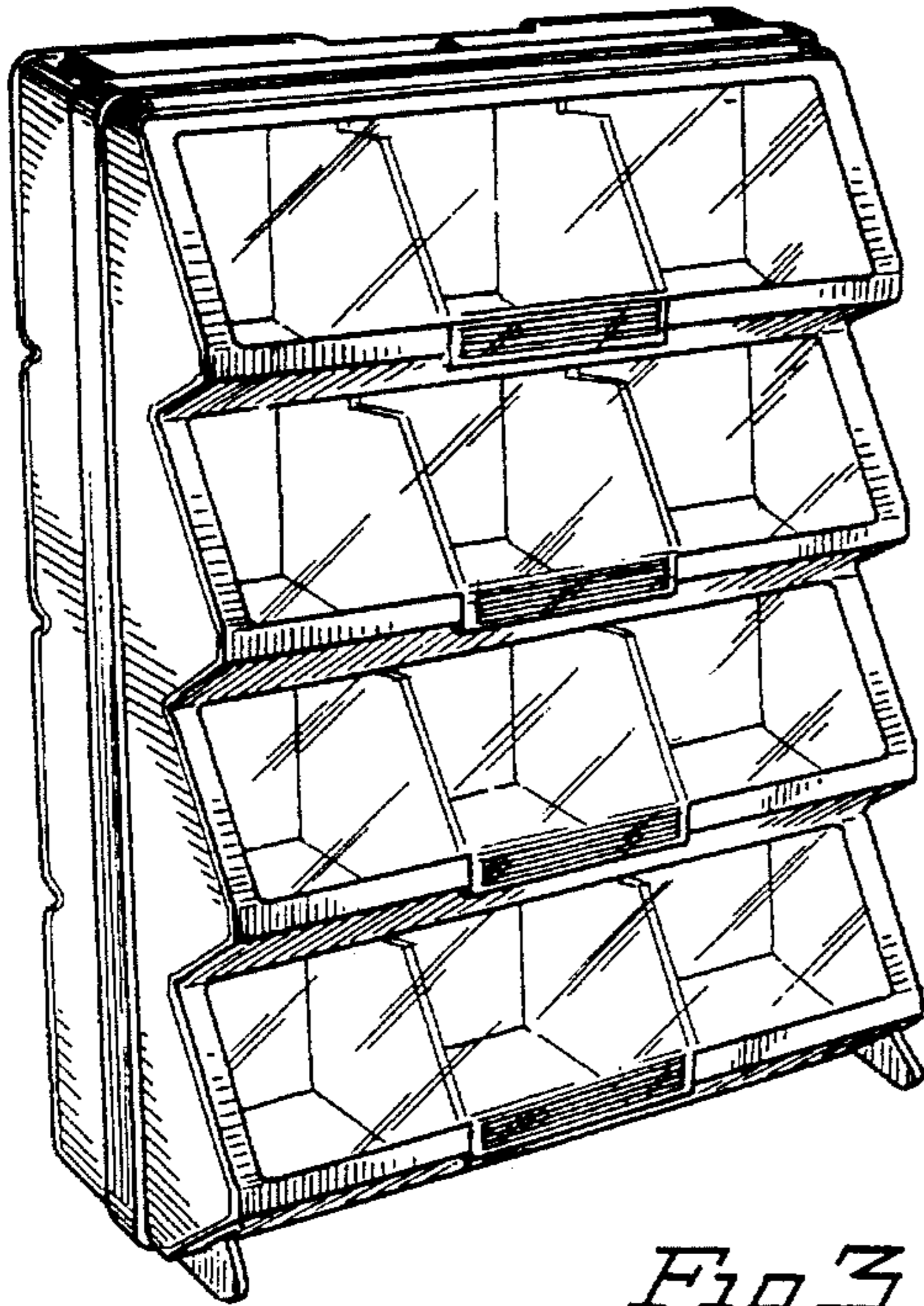

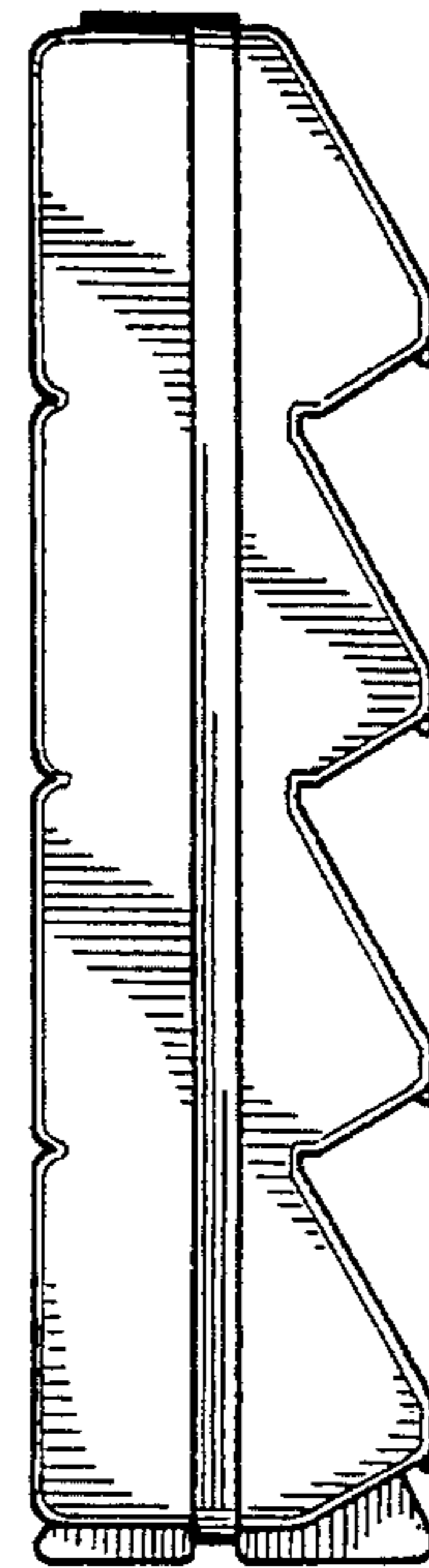

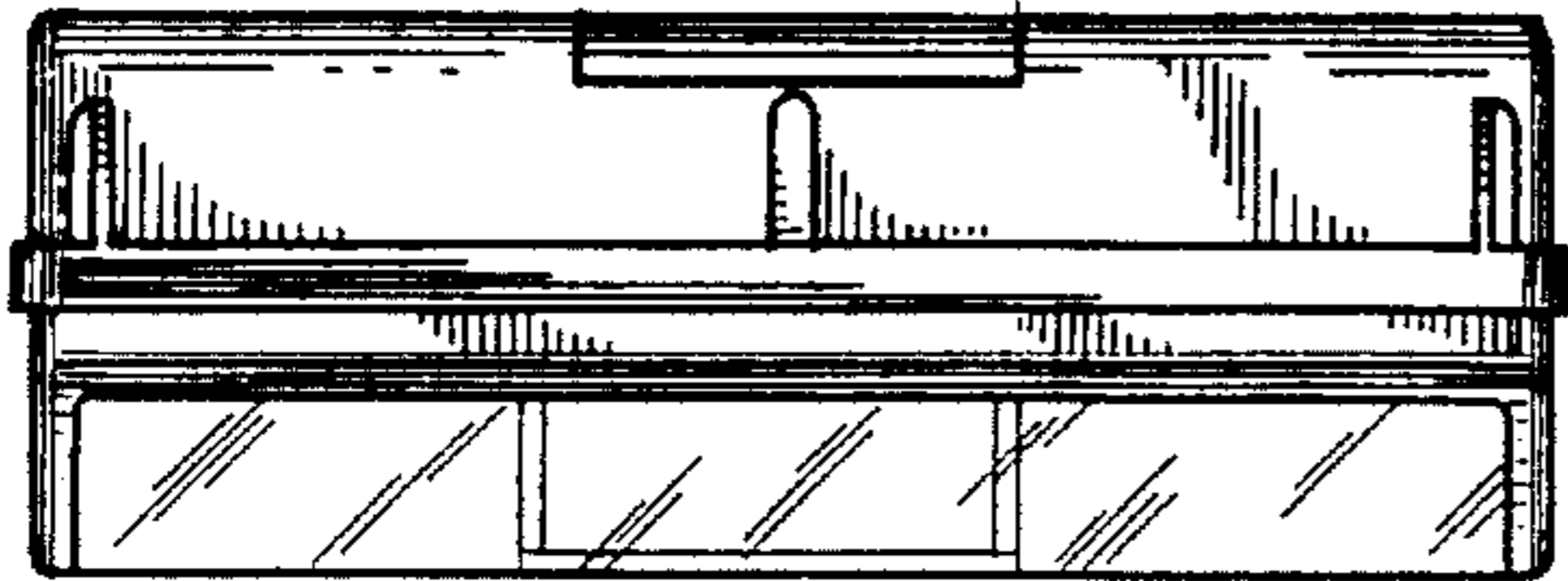

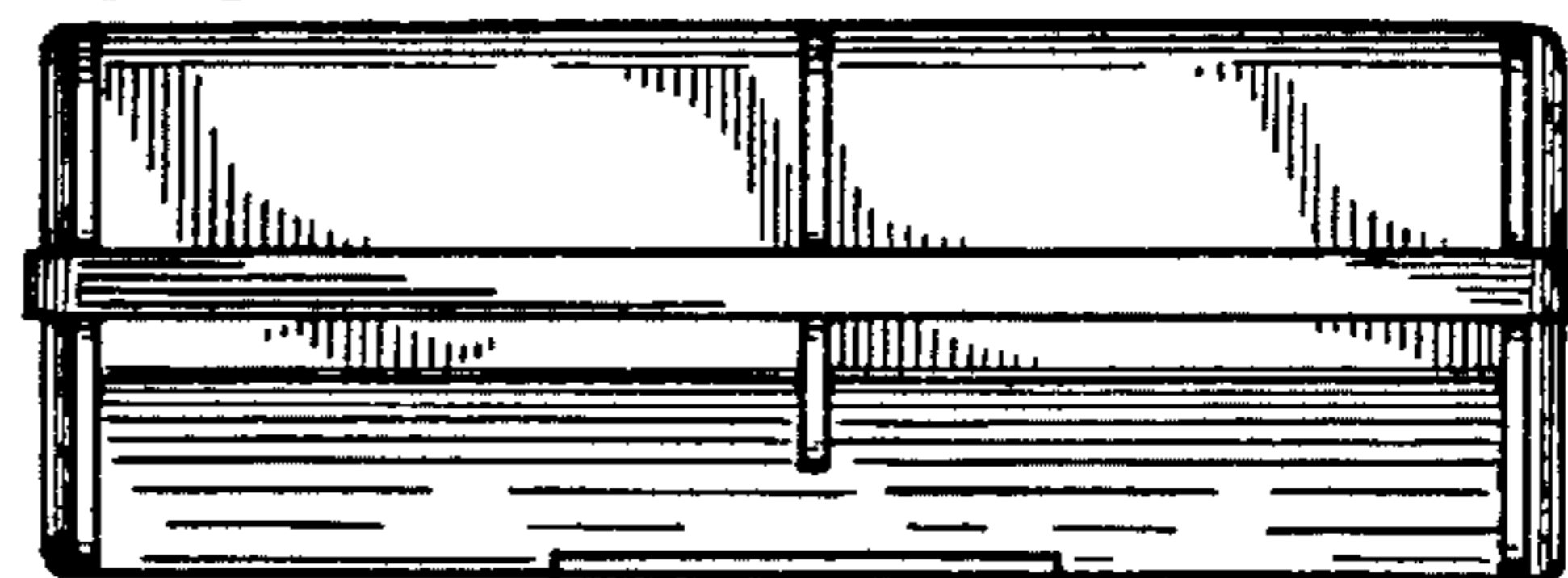

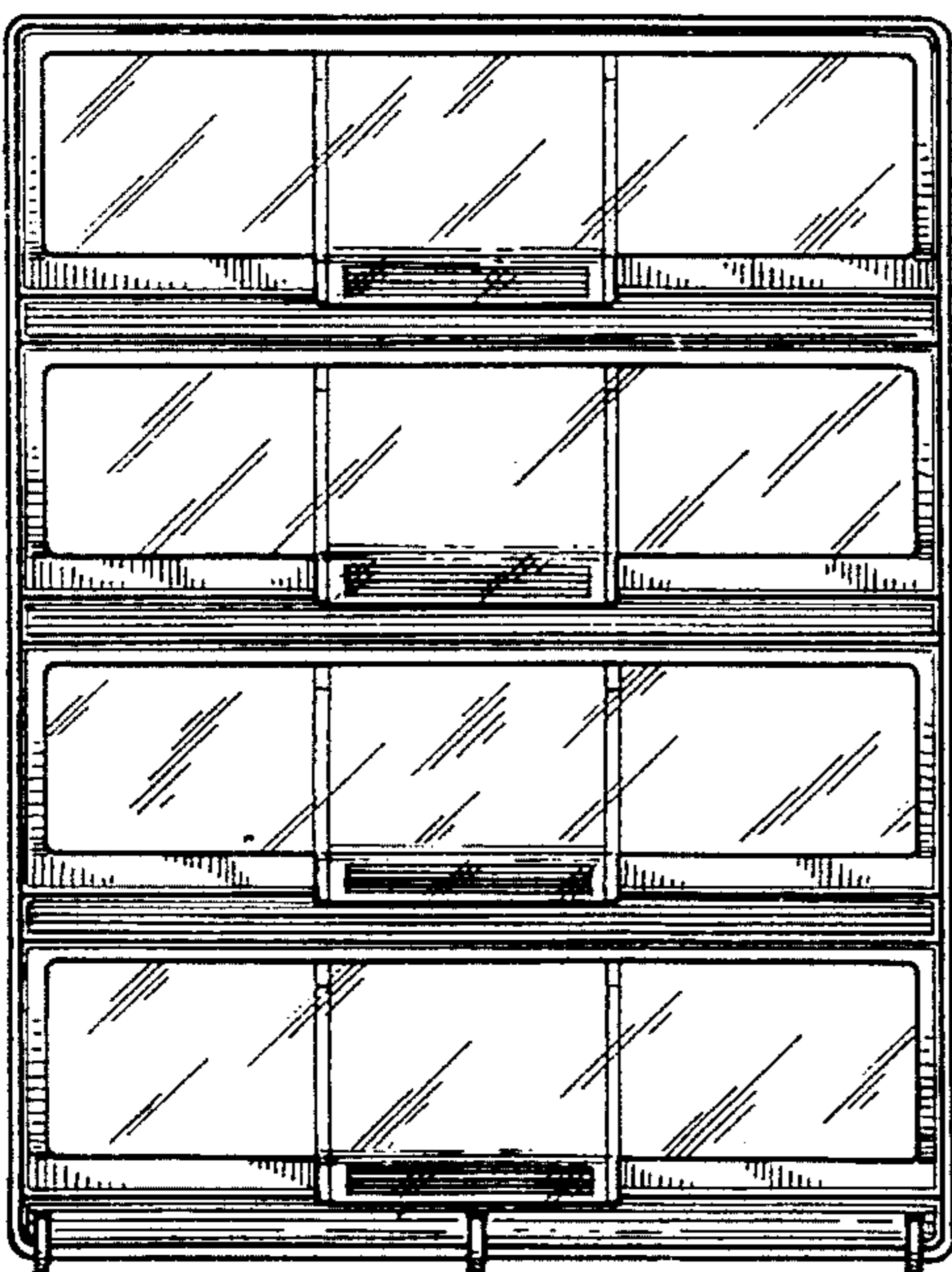

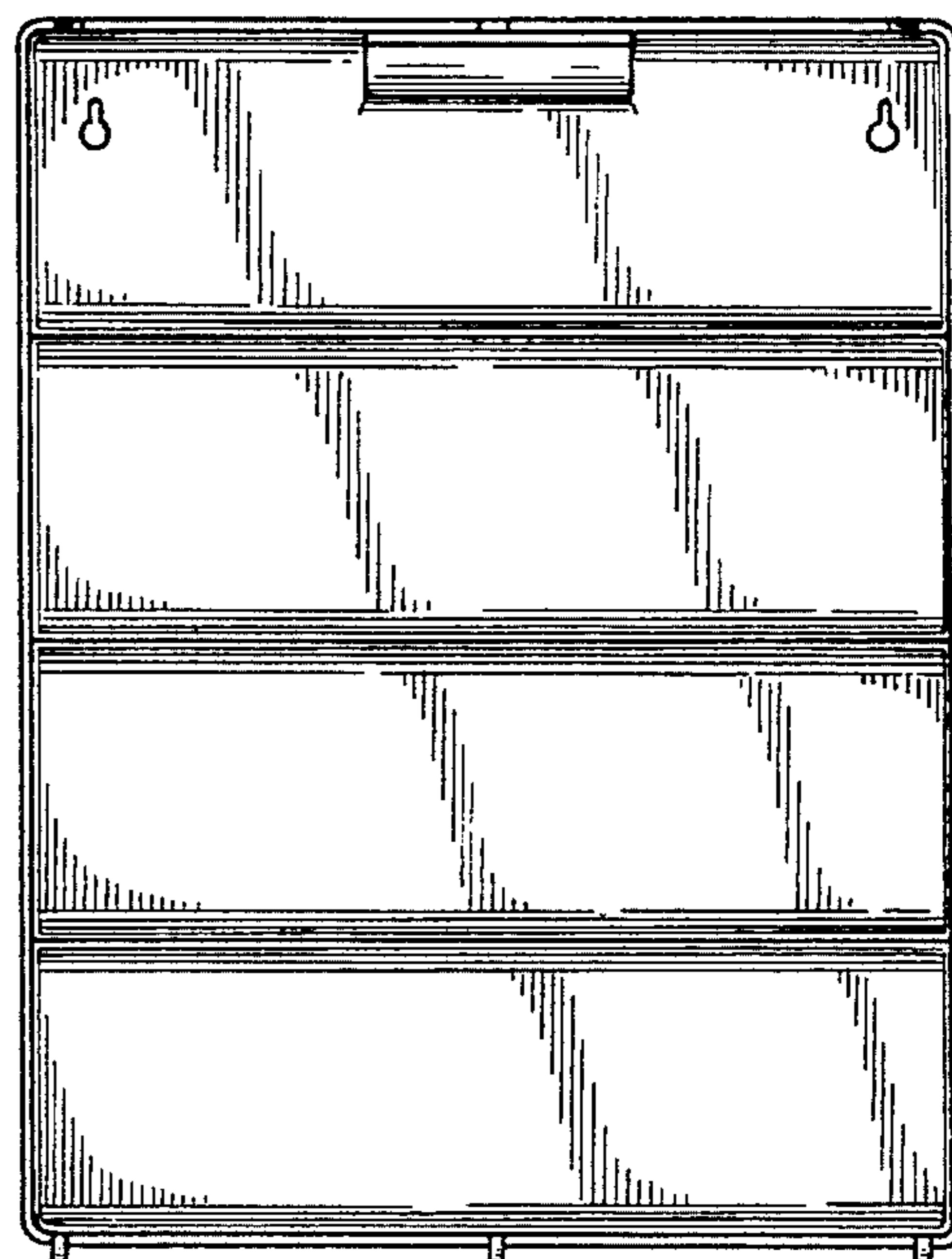
