FIG. 2 is a bottom plan view thereof;

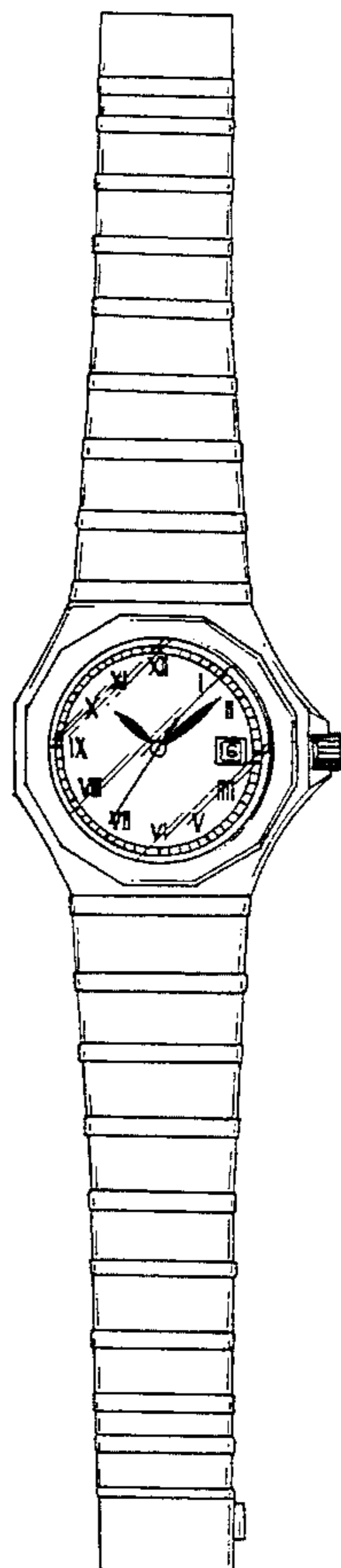
FIG. 3 is a right side view of my new watch design showing the curvature of the case and the watch crystal in the direction of the watch 6 to the watch 12;

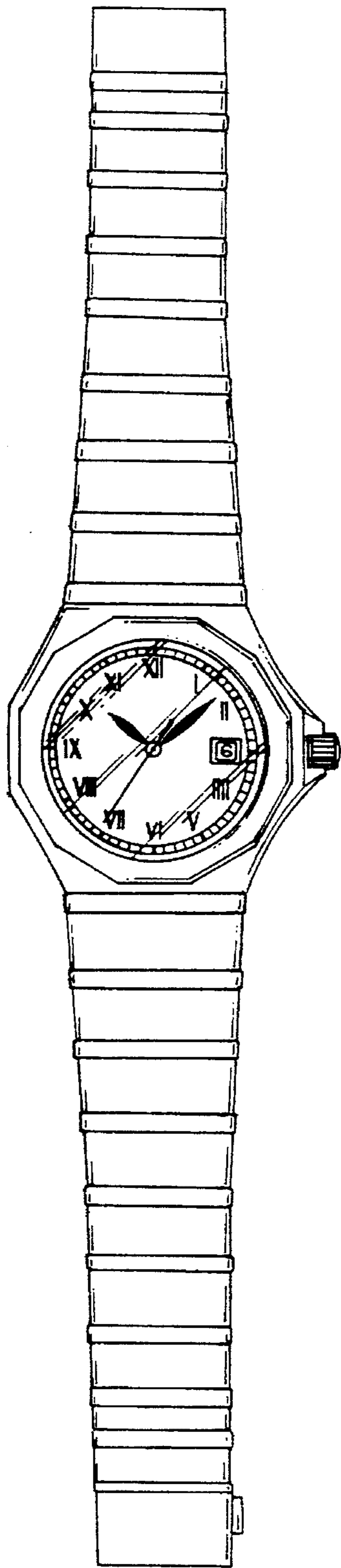

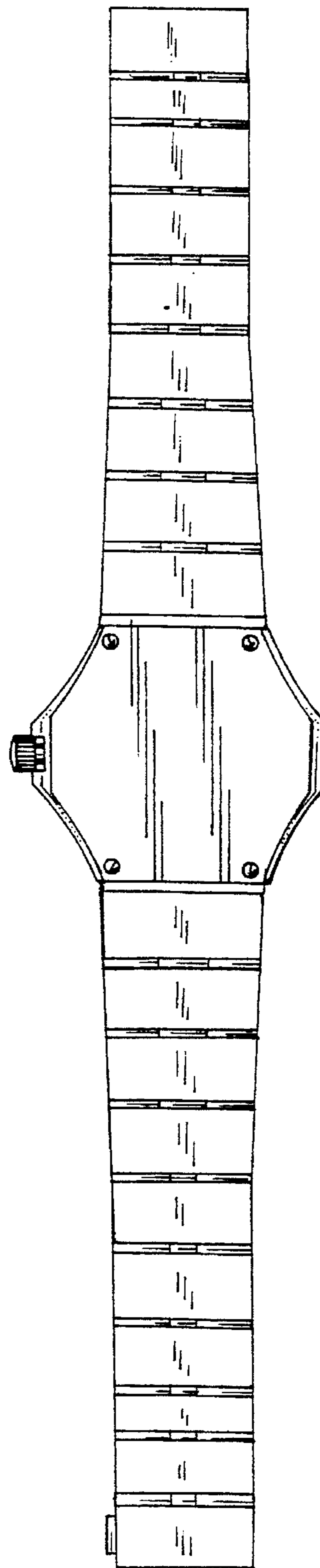

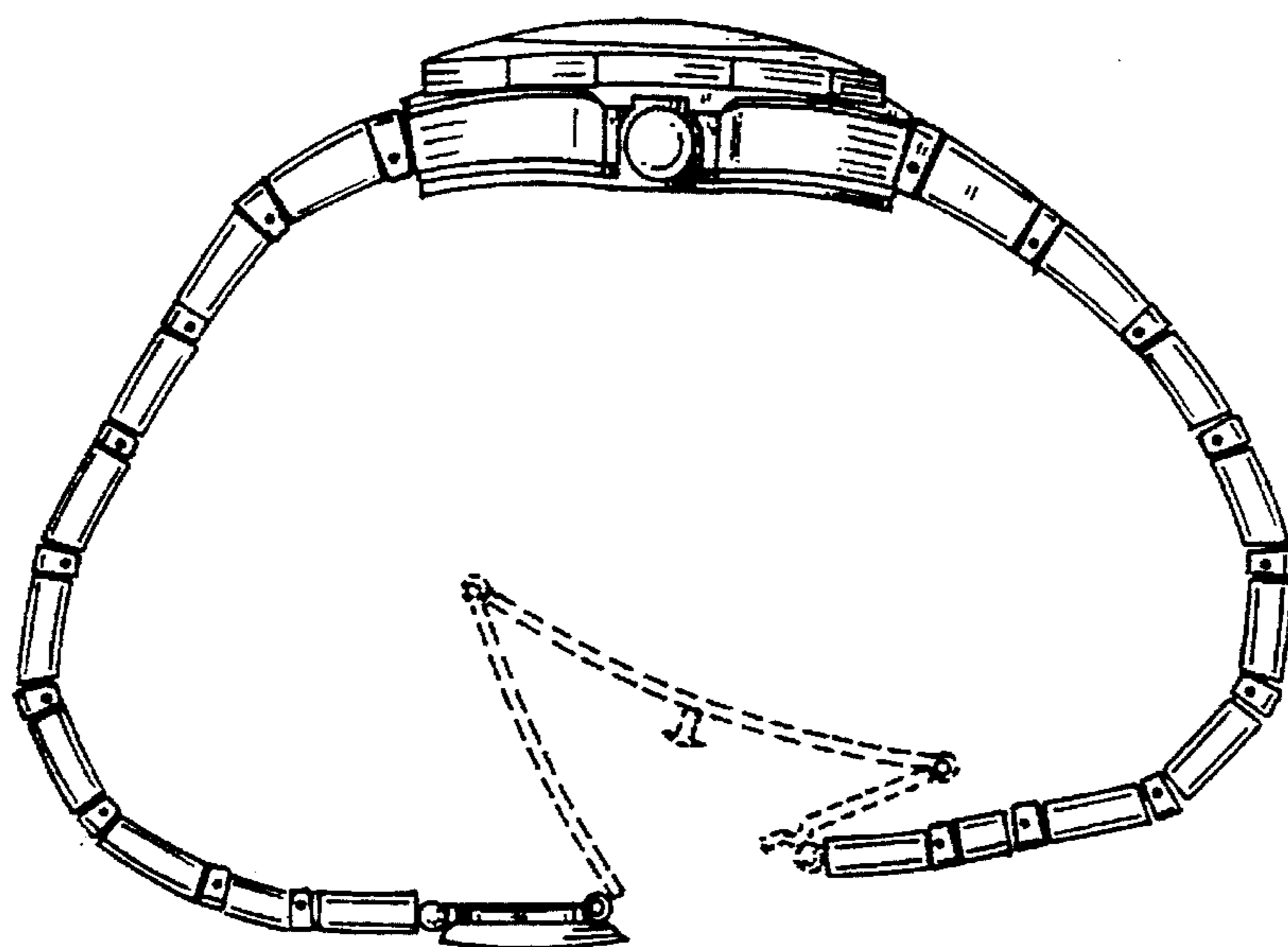

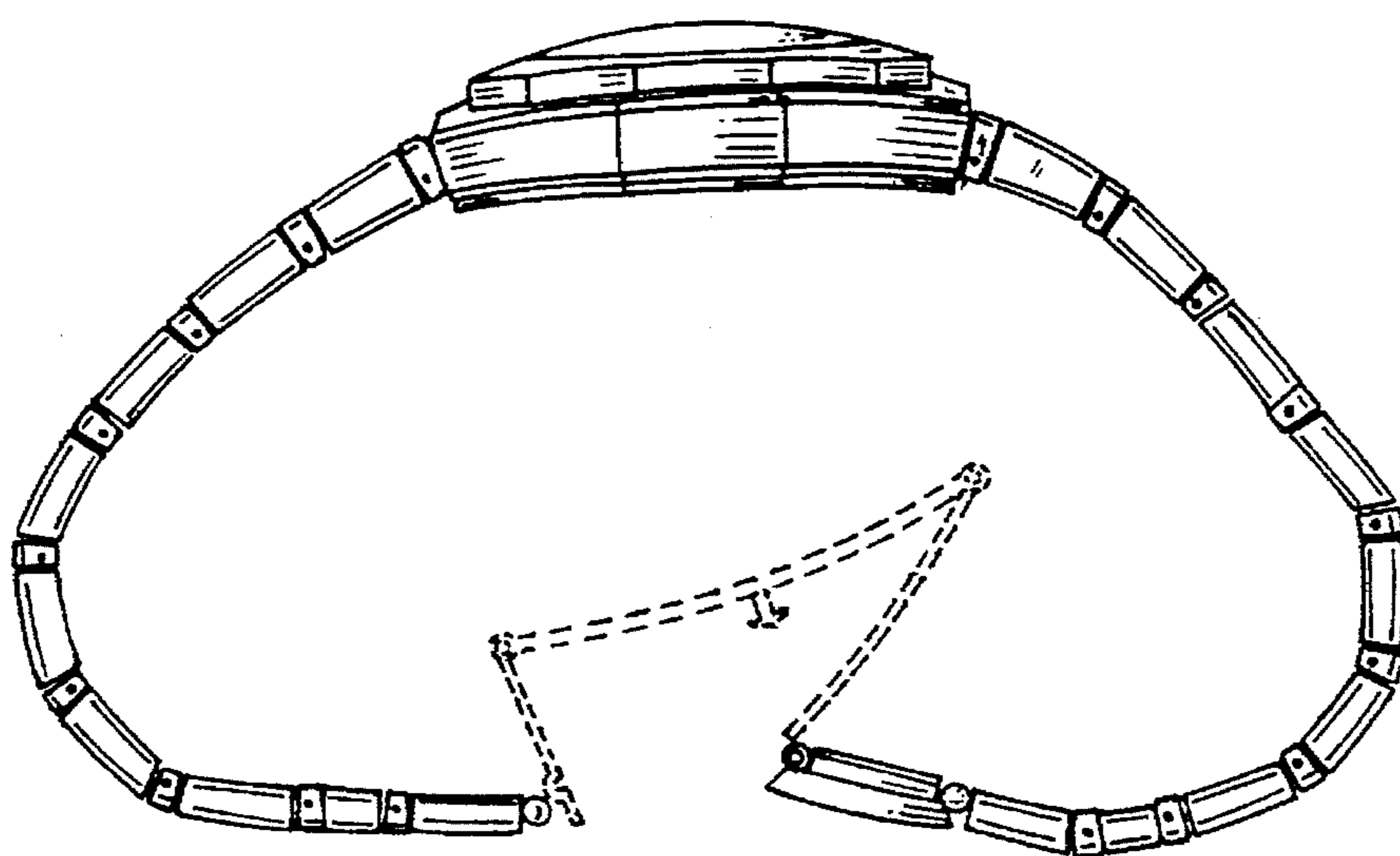

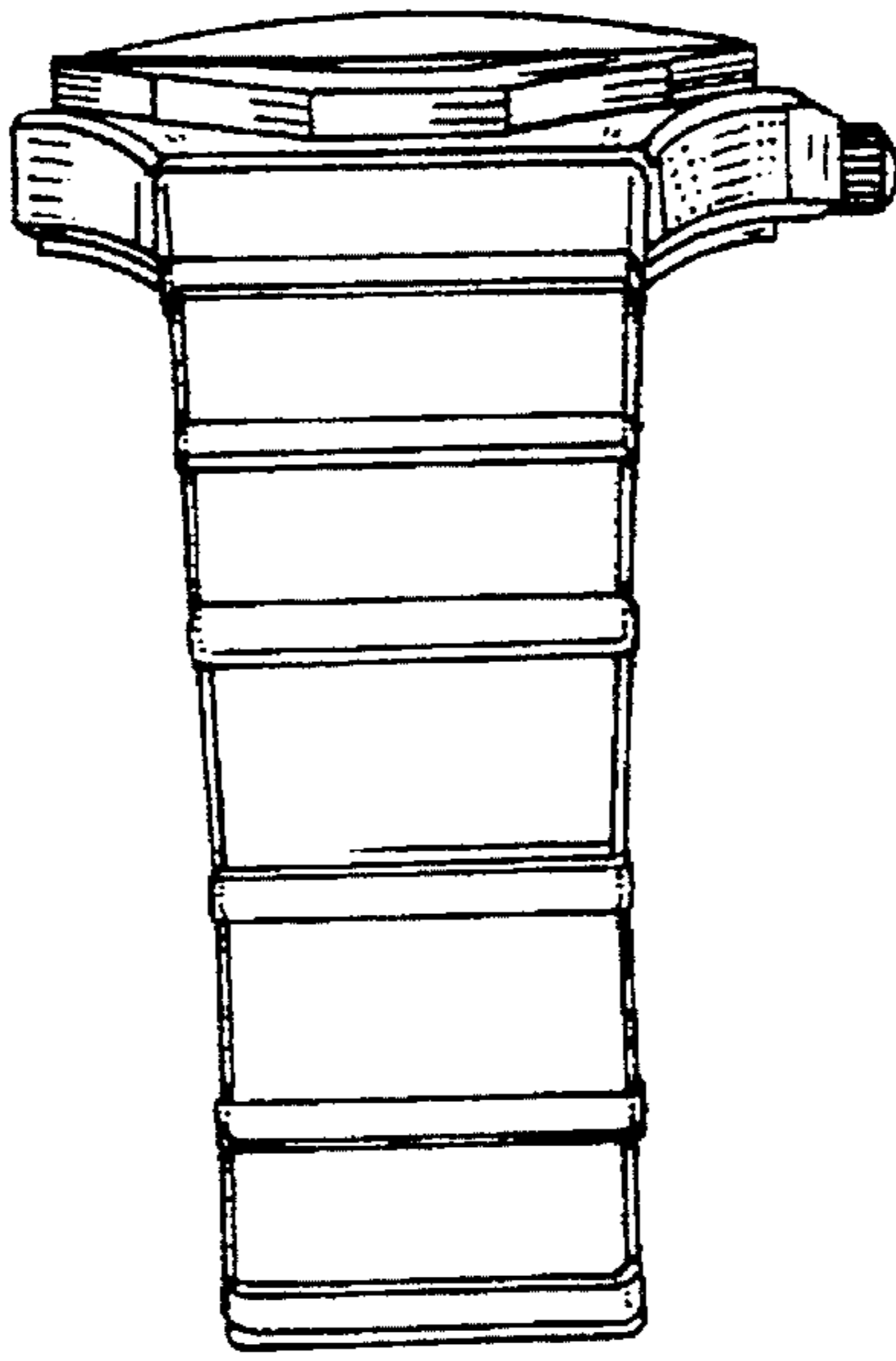

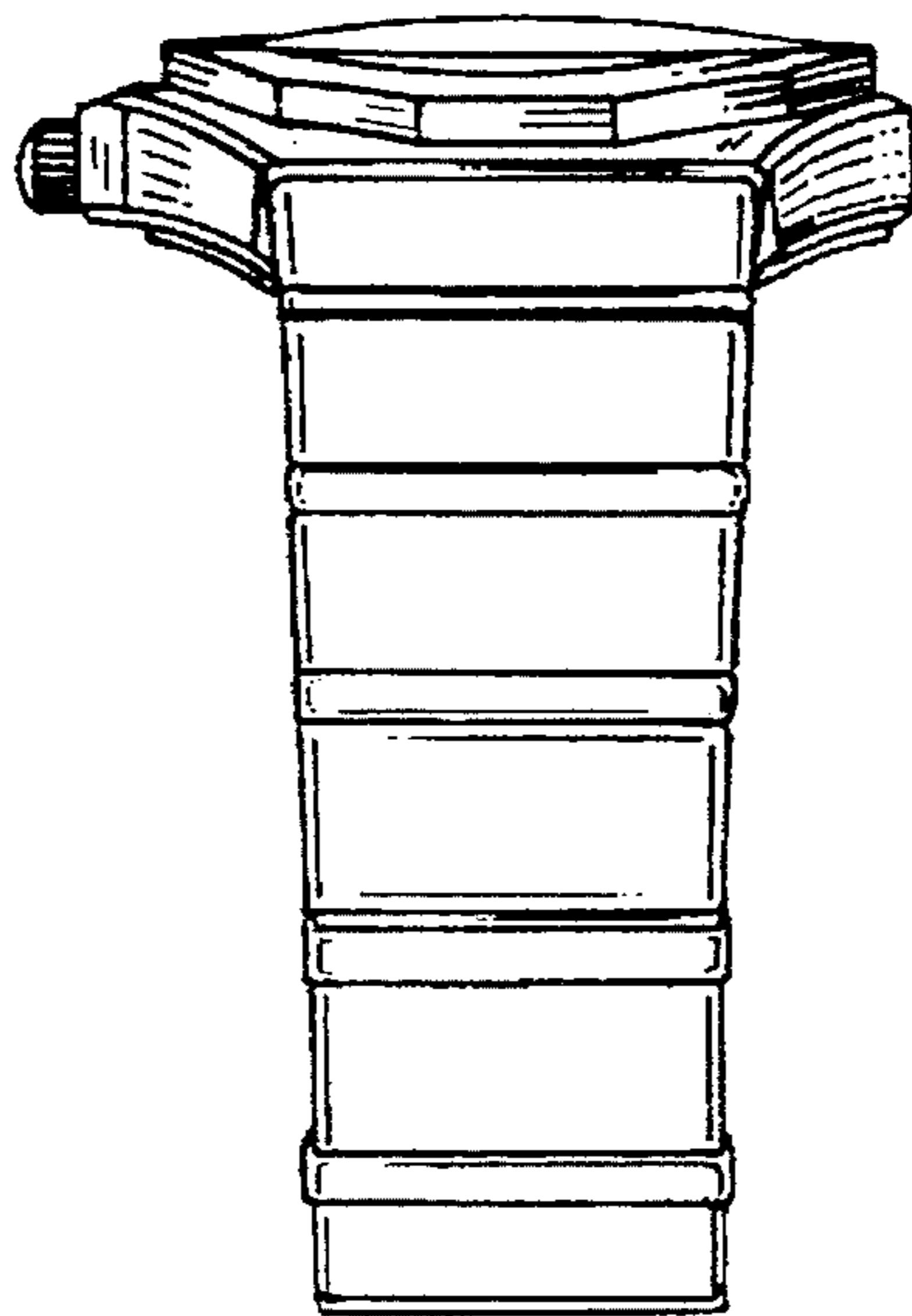
