The ornamental design for an overcap for a dispenser, as shown and described.

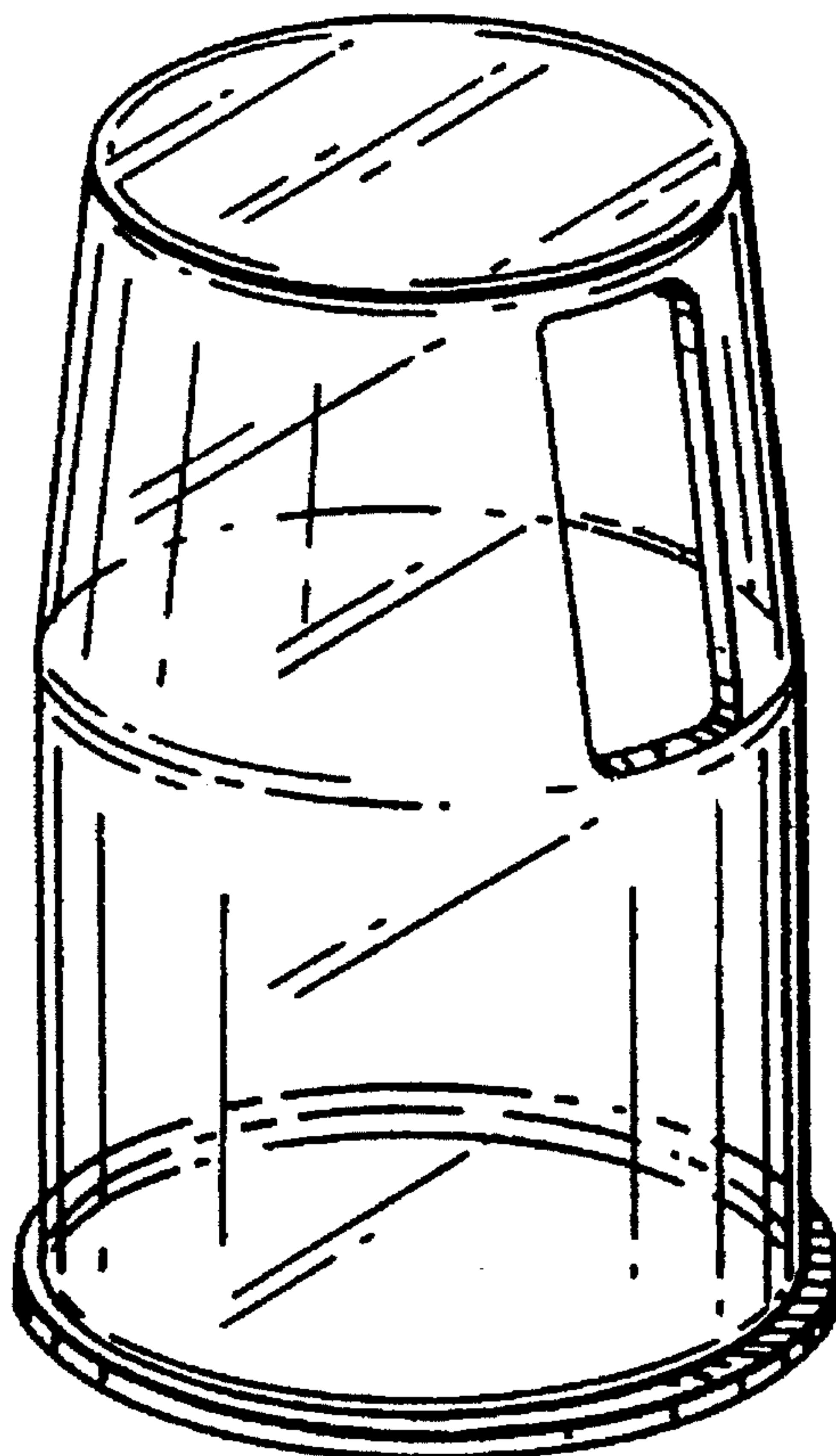
DESCRIPTION

FIG. 1 is a perspective view of an overcap for a dispenser; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a side elevational view taken from the left of FIG. 3, the right side being a mirror image thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a rear elevational view thereof.

The broken lines shown in FIG. 4 are for illustrative purposes only and form no part of the claimed design.

The broken line showing of a pump spout and bottle is for illustrative purposes only and forms no part of the claimed design.

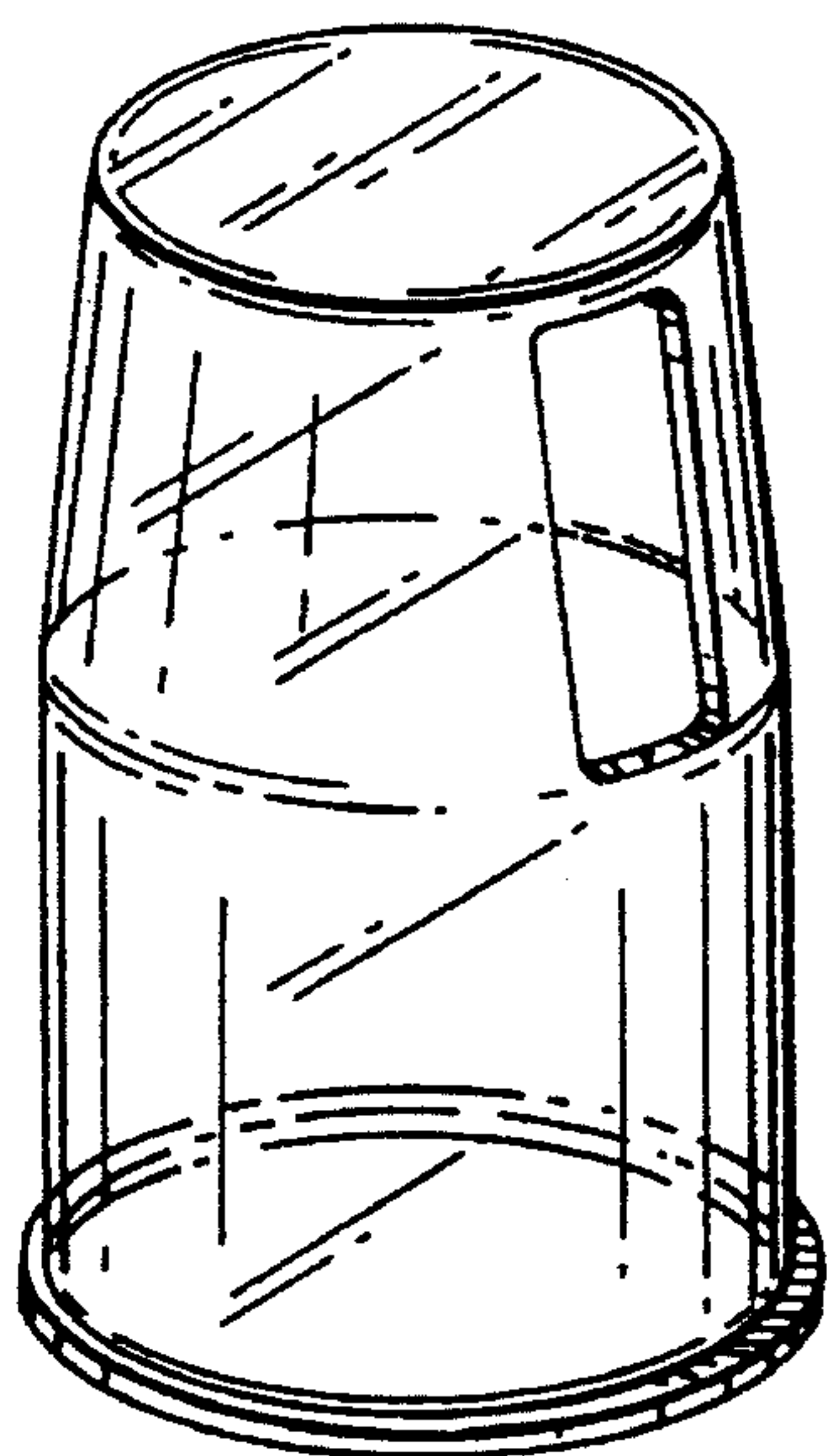

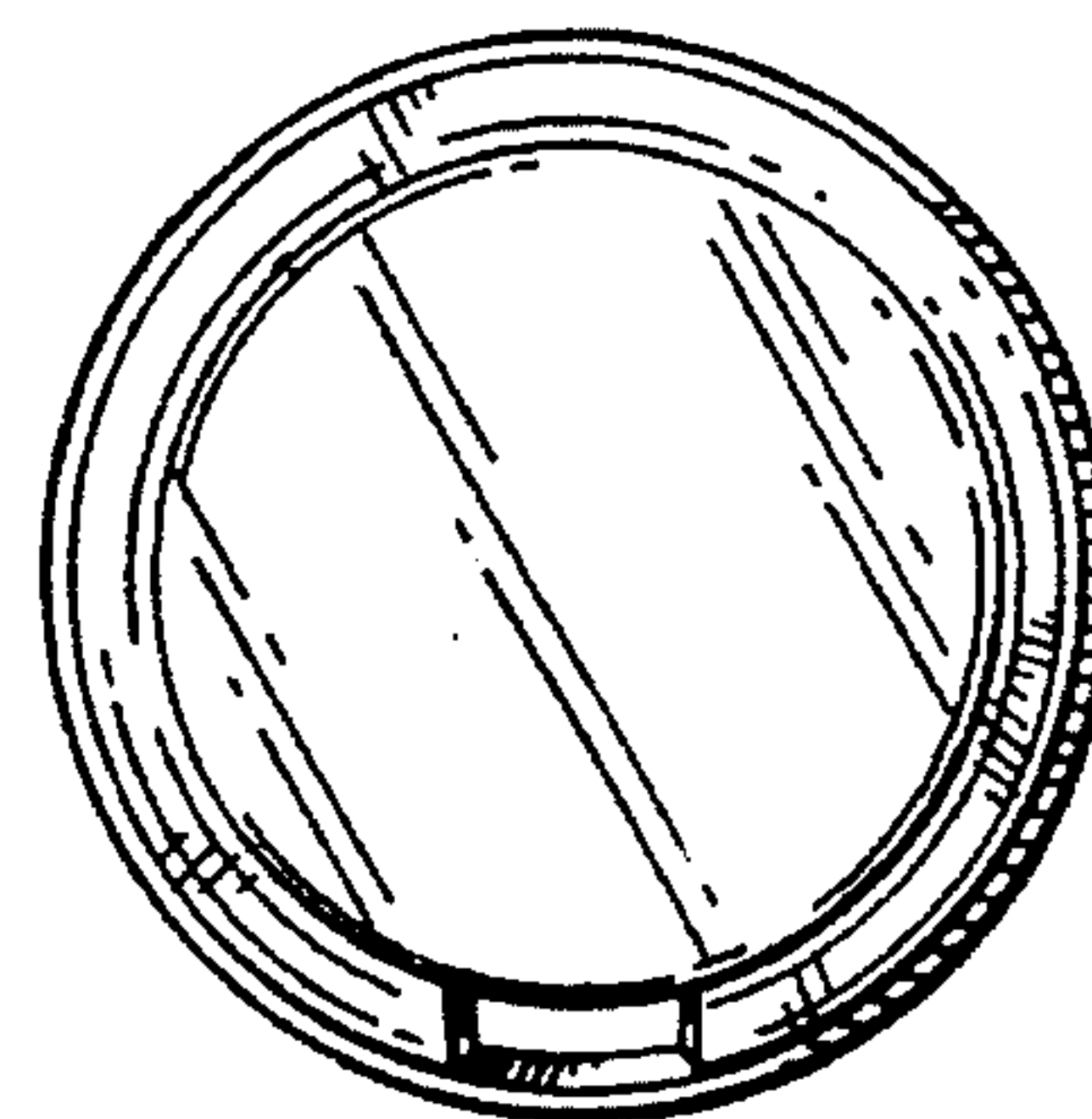

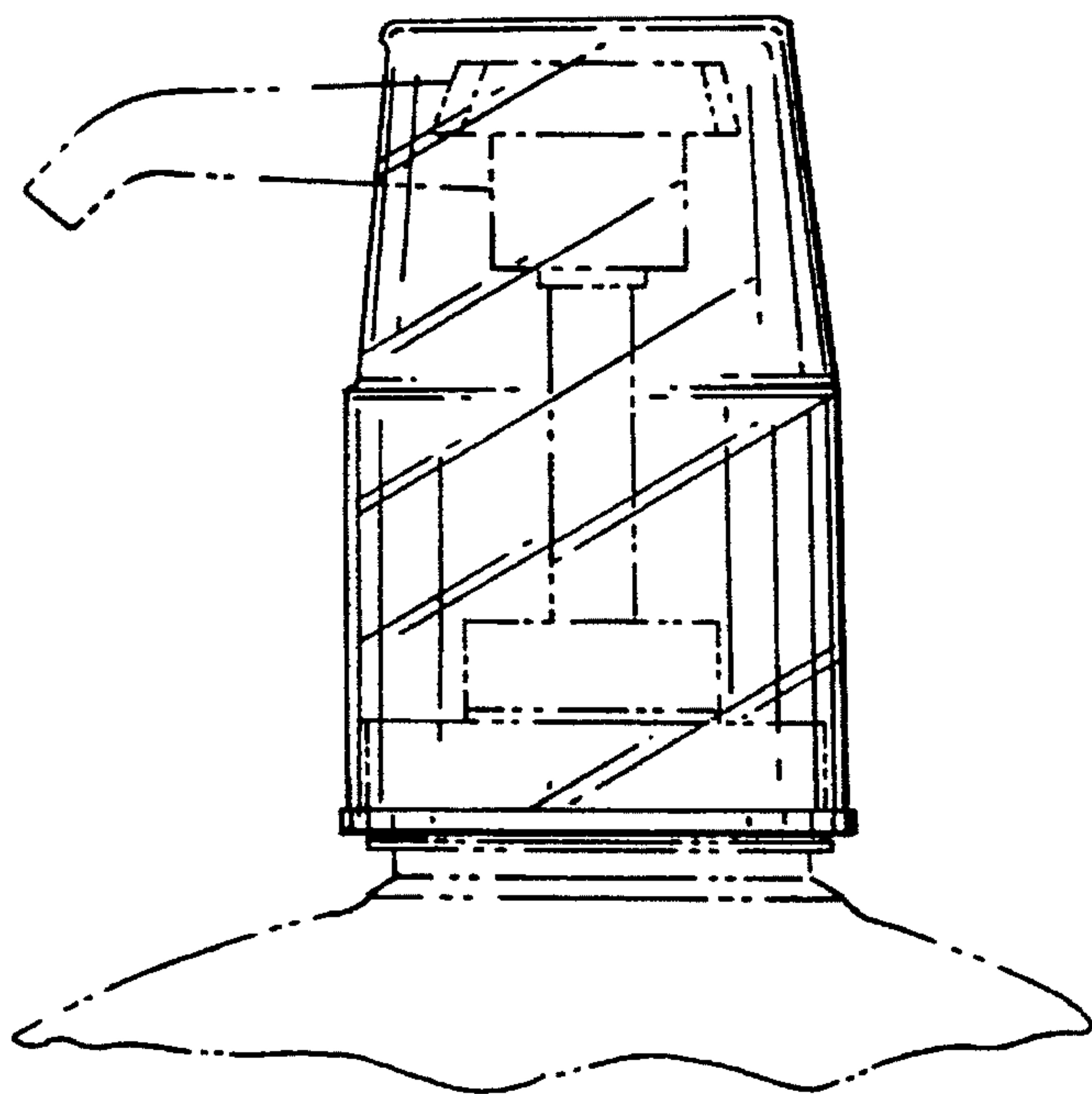

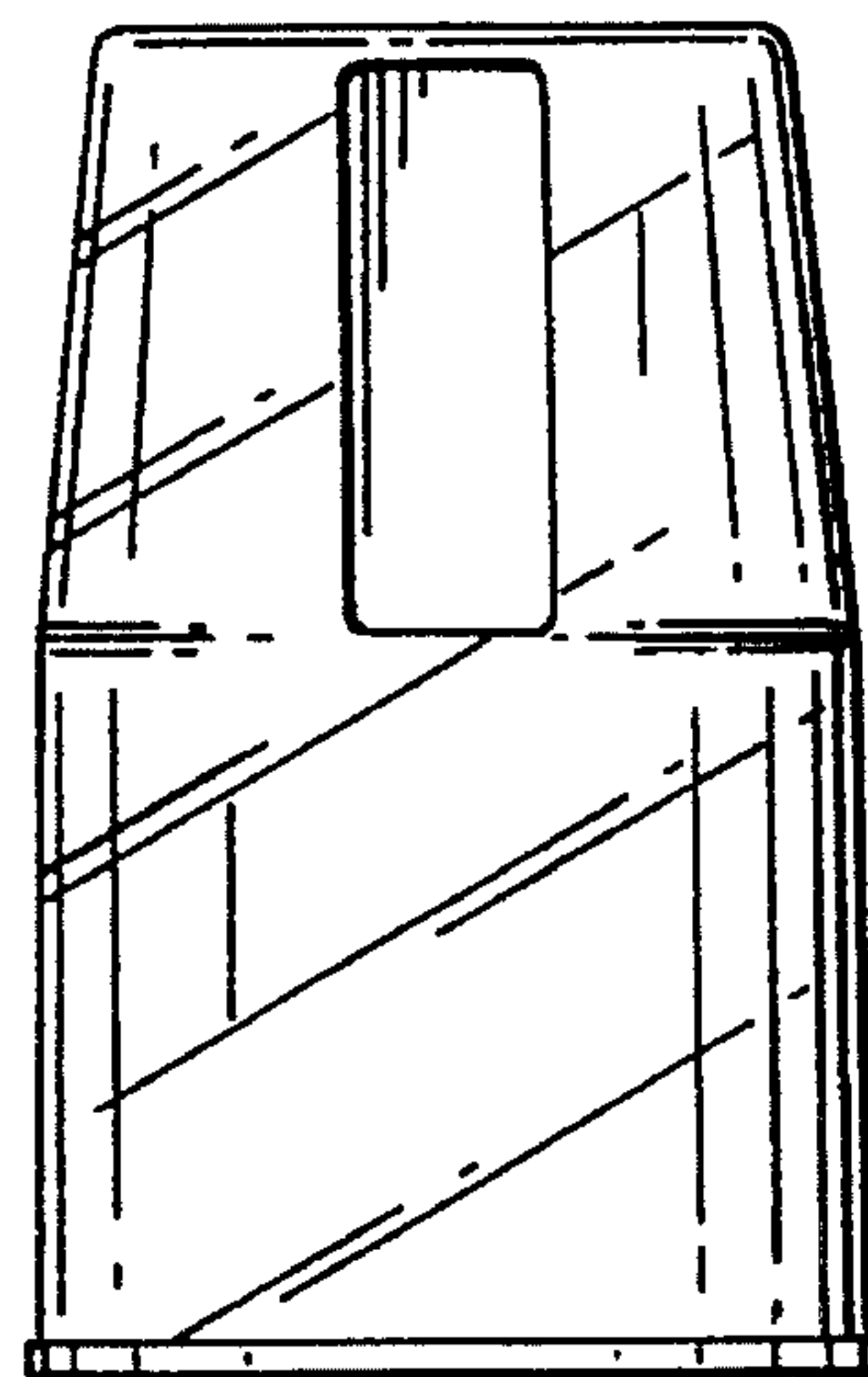

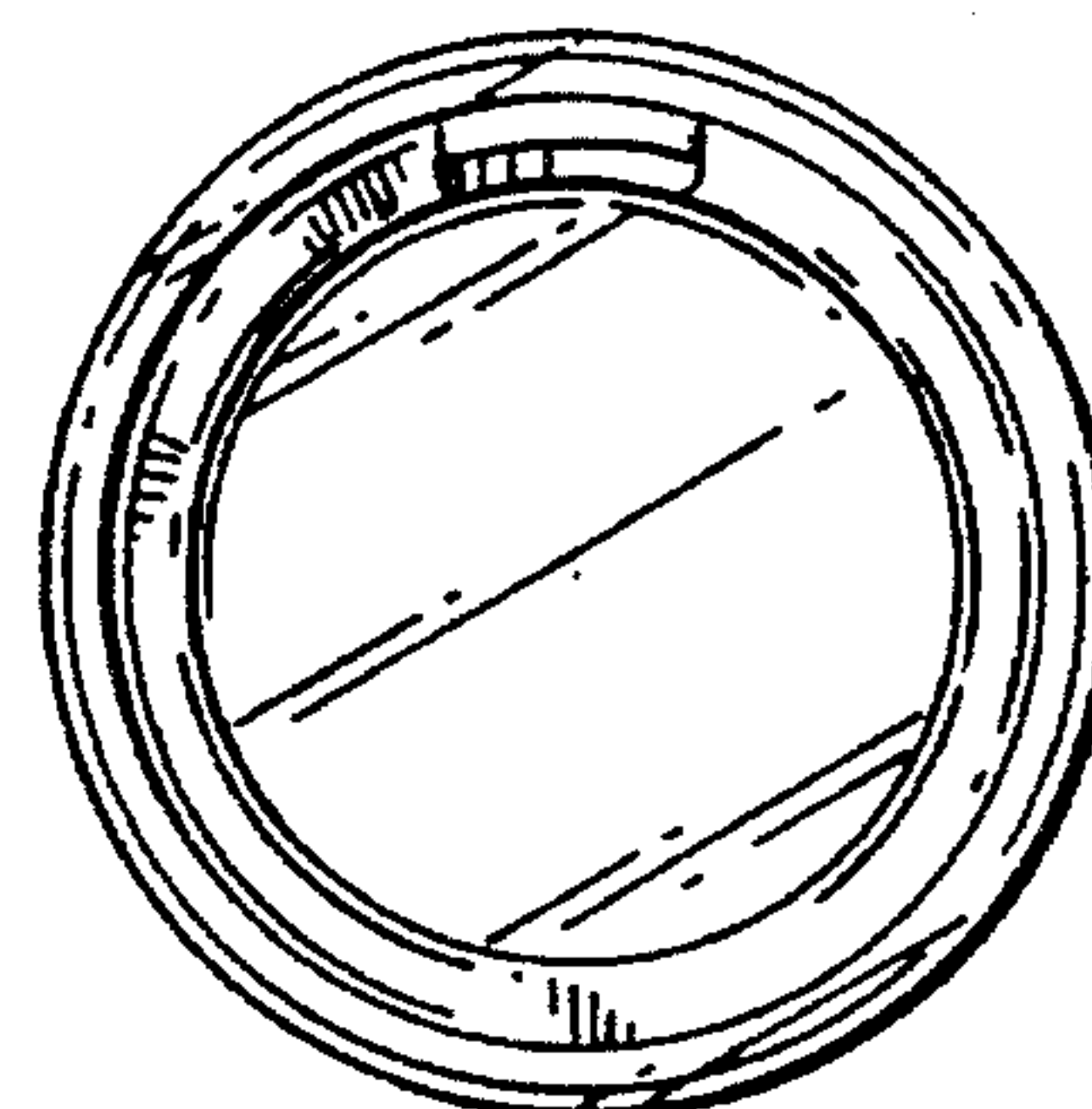

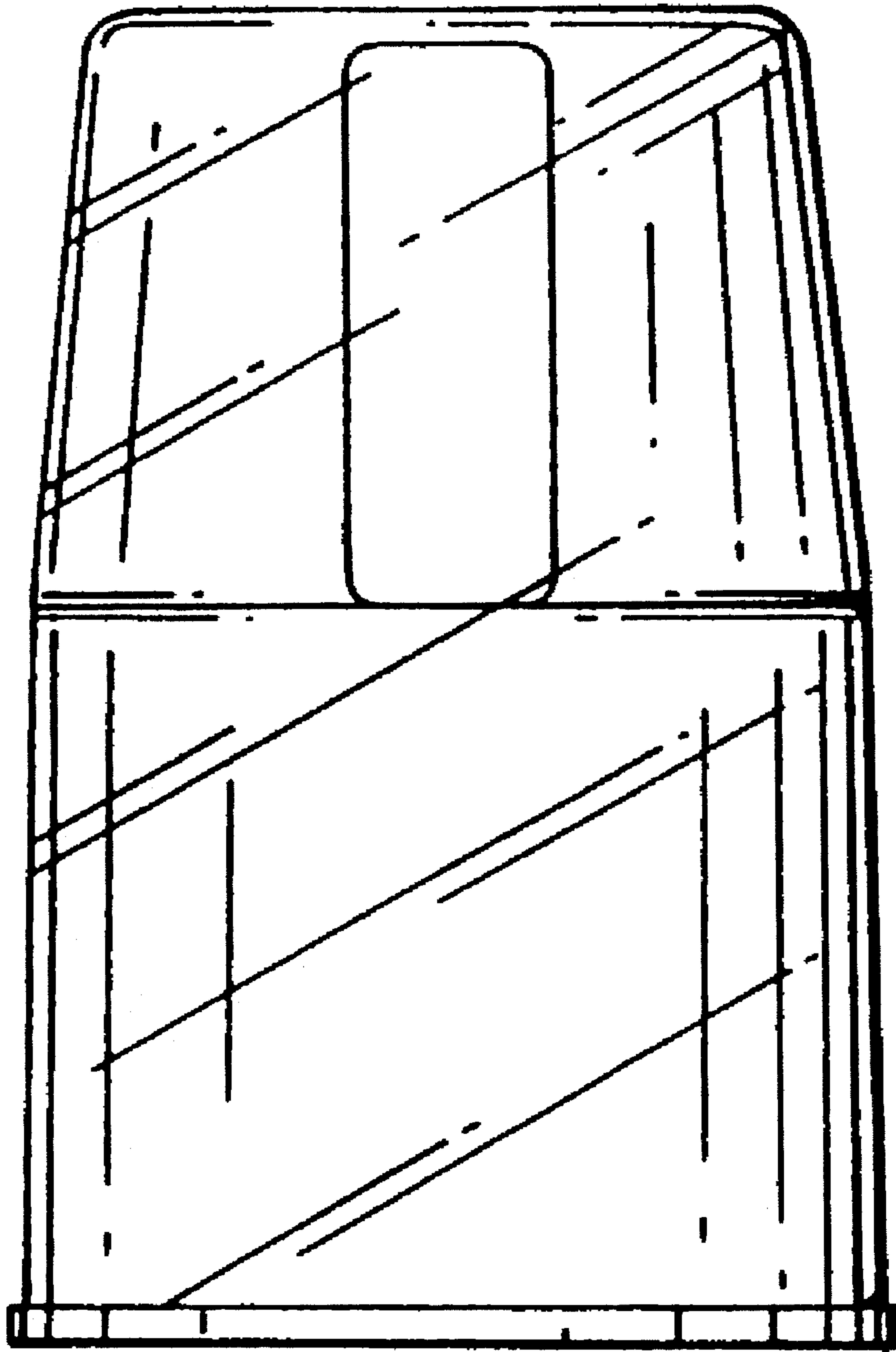
