The ornamental design for a display rack, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a display rack showing

one form of our new design;

FIG. 16 is a front elevational view of a fourth embodiment of our new design;

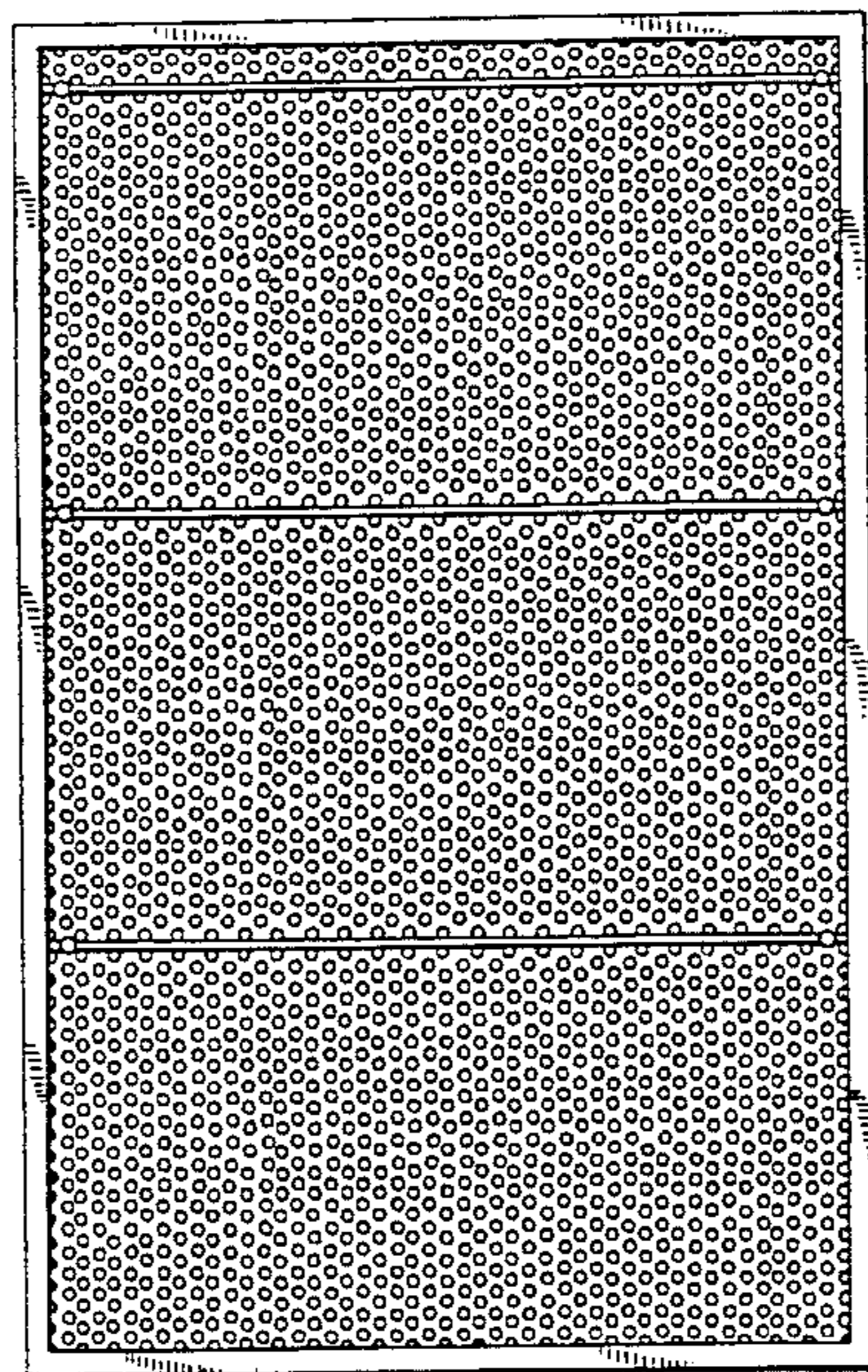
FIG. 17 is a right side elevational view thereof, the left side elevational view thereof being identical;

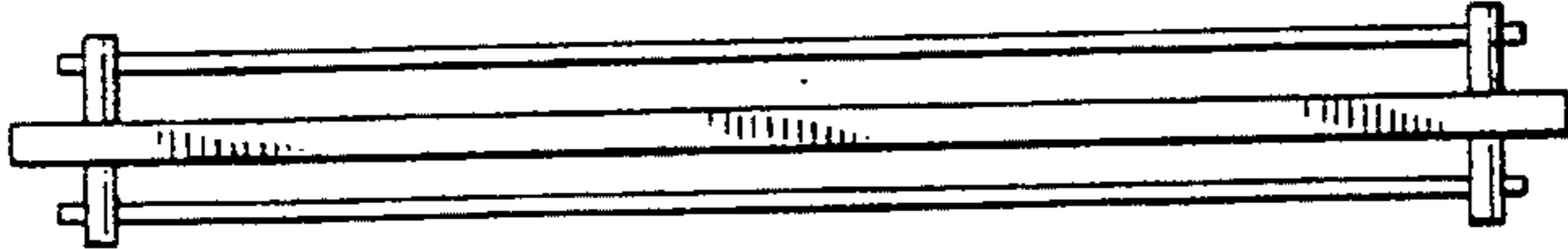

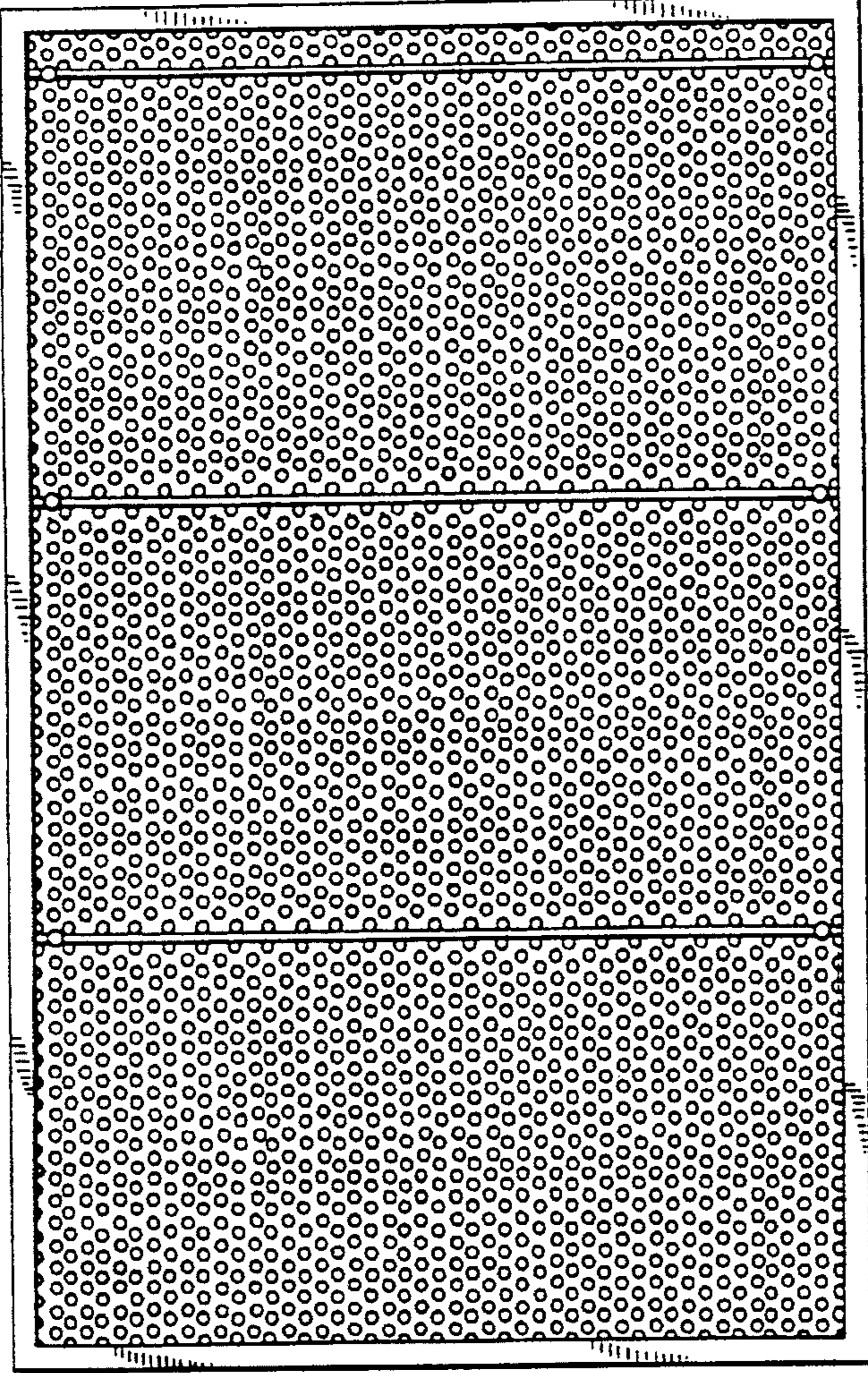

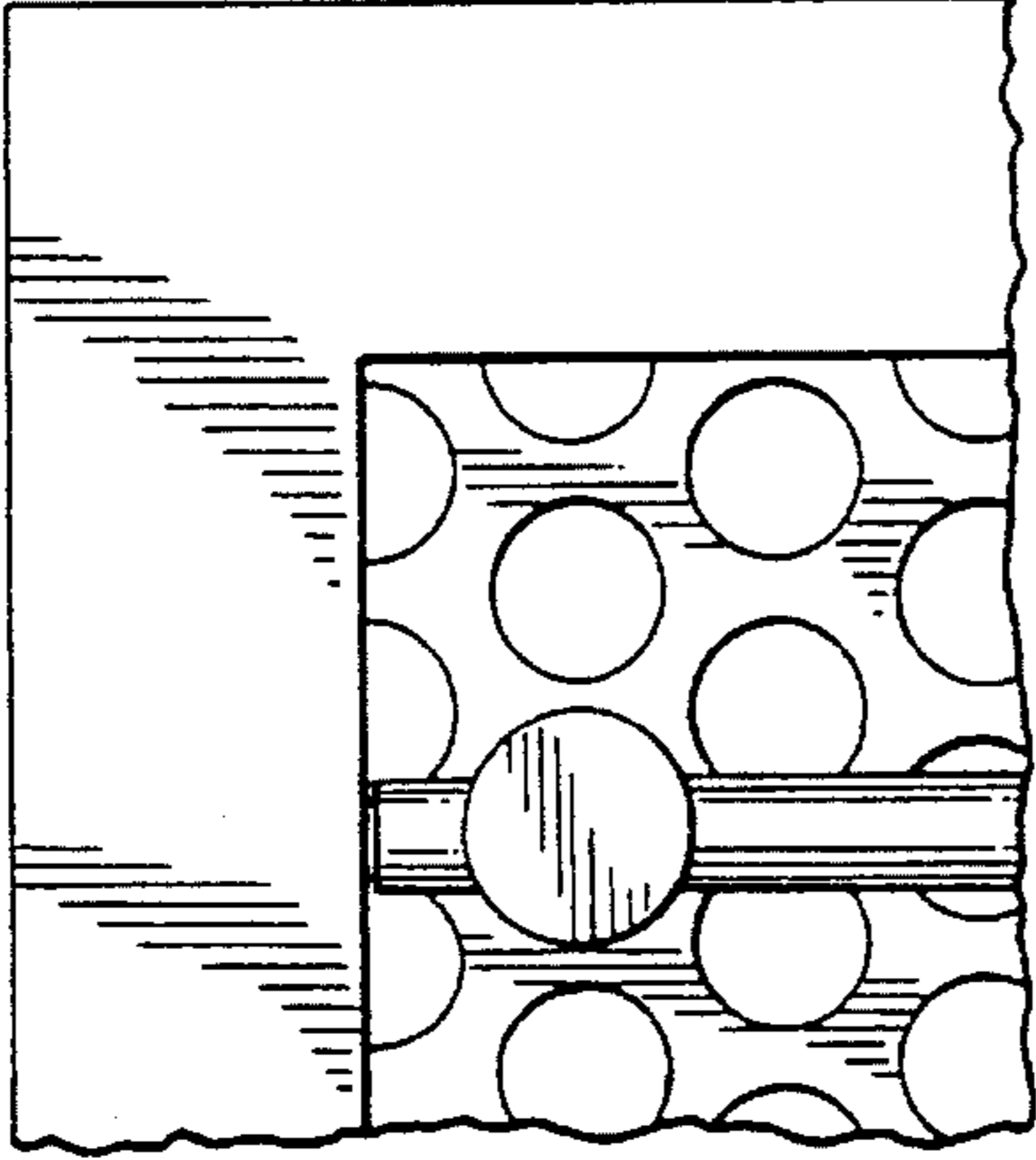
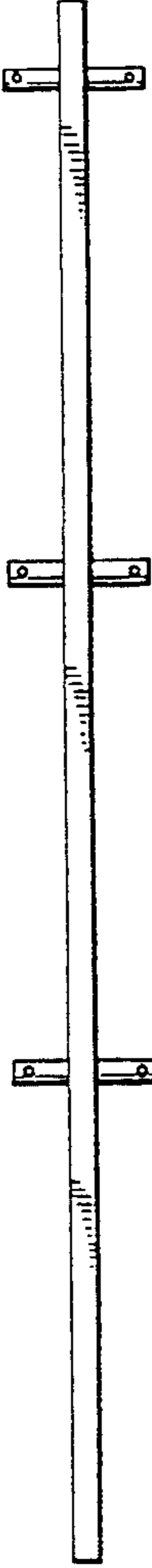
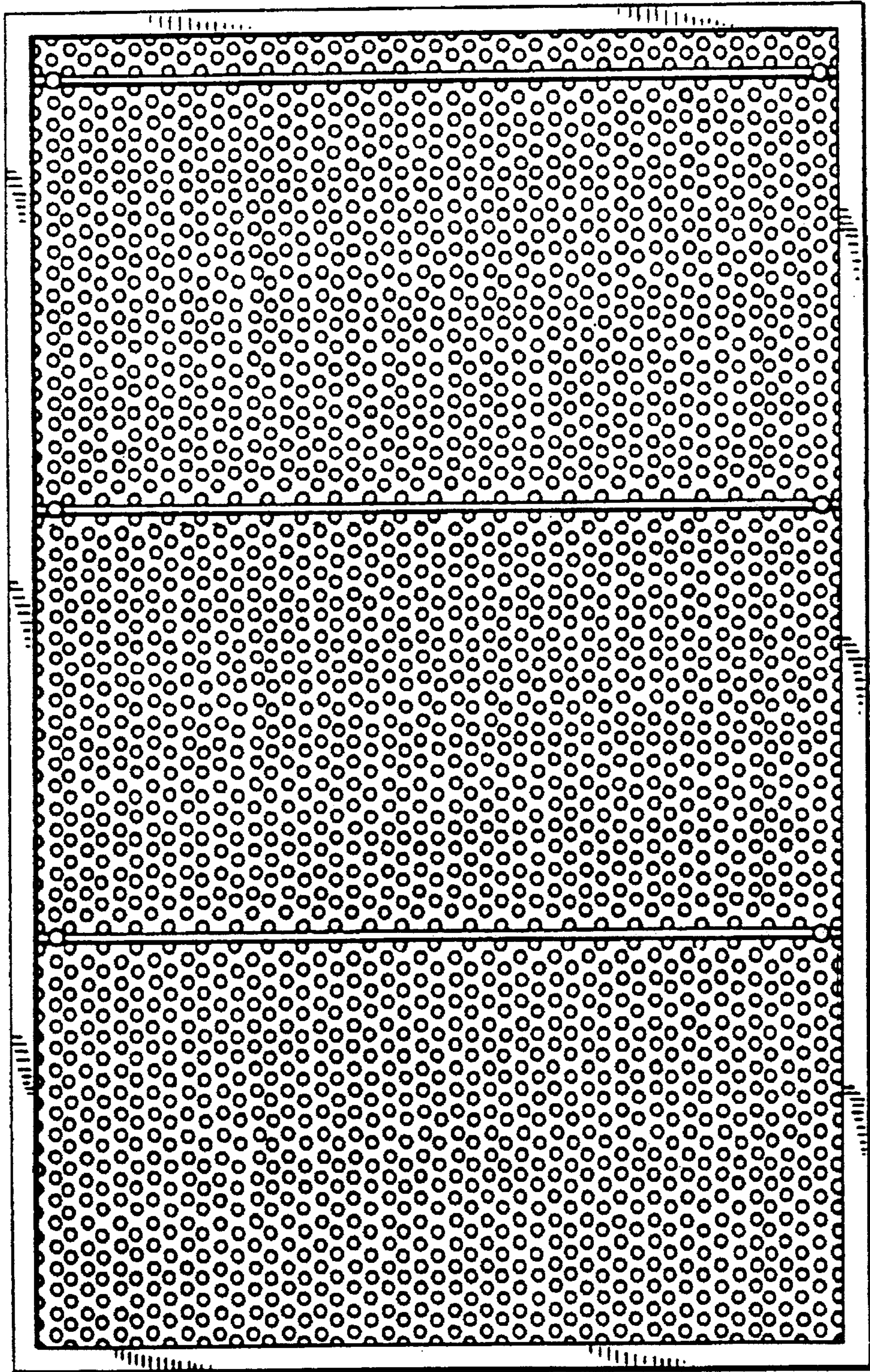

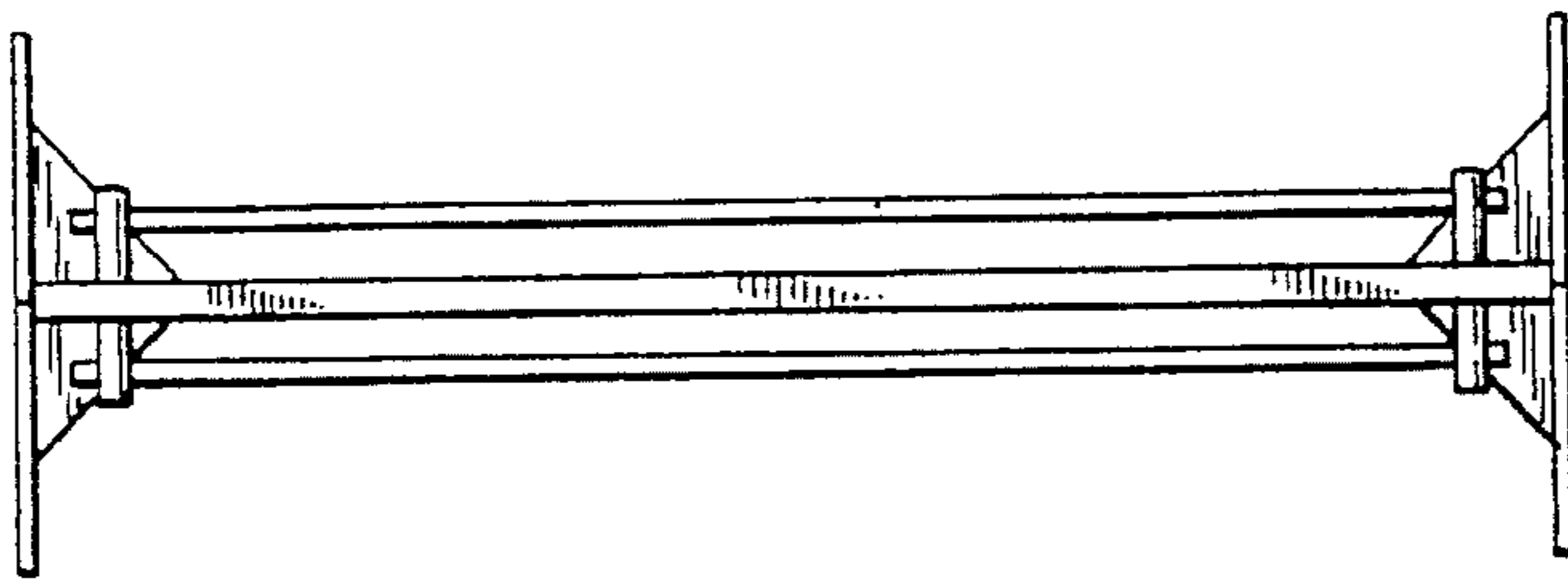

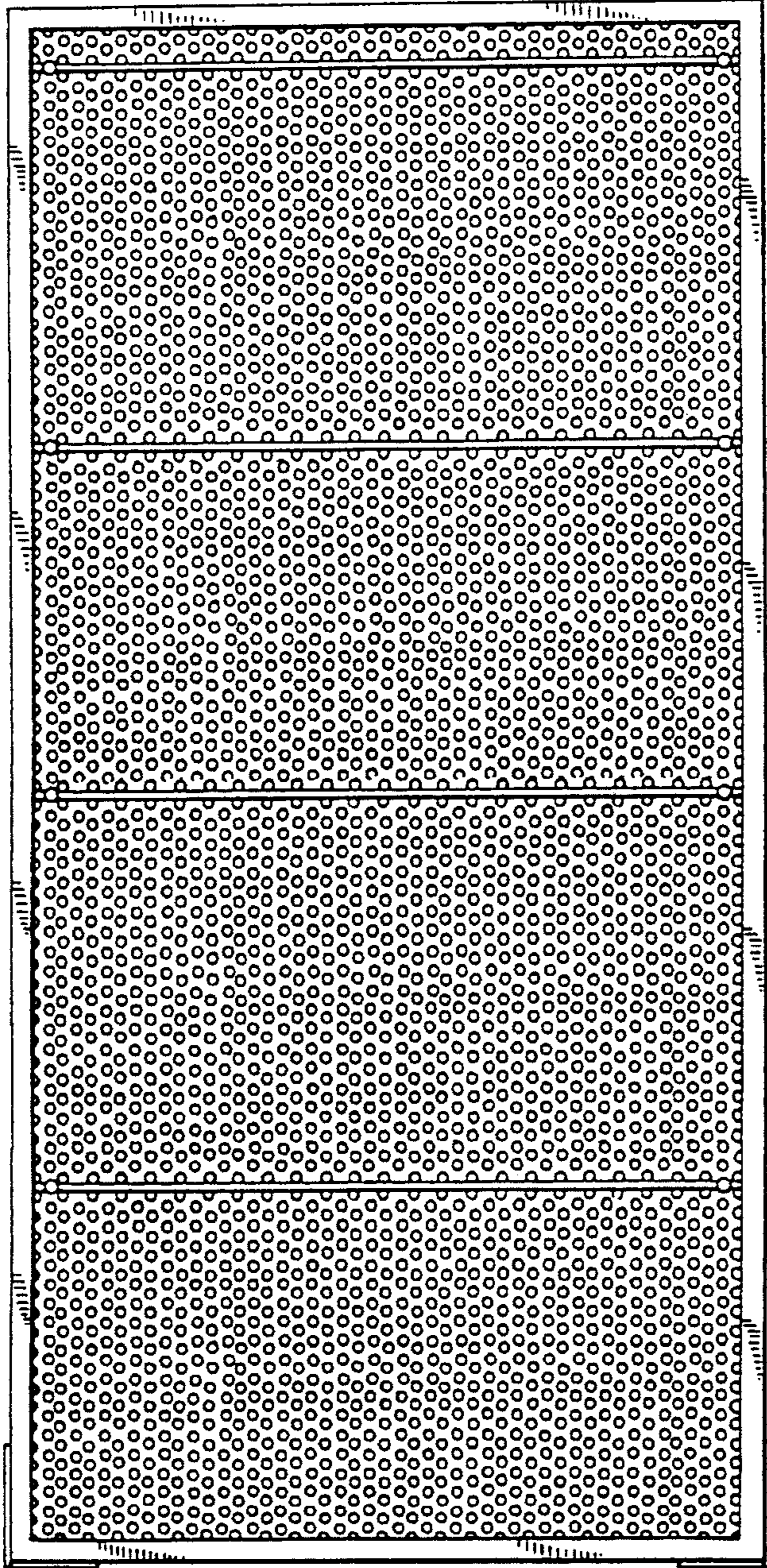

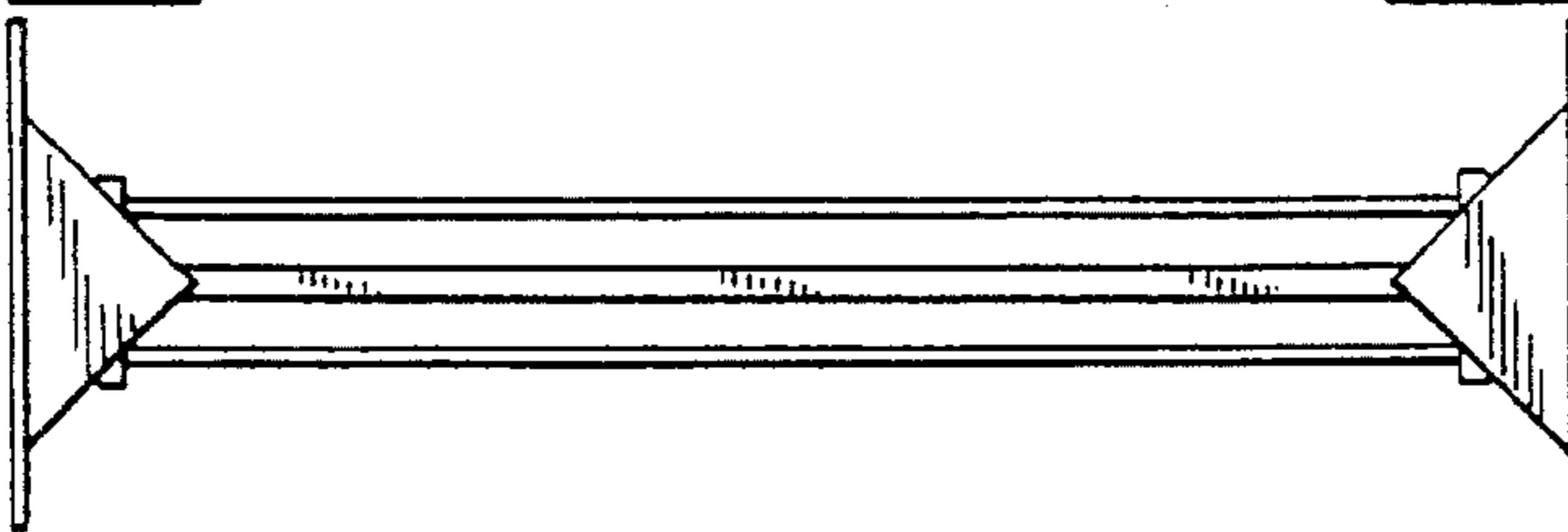

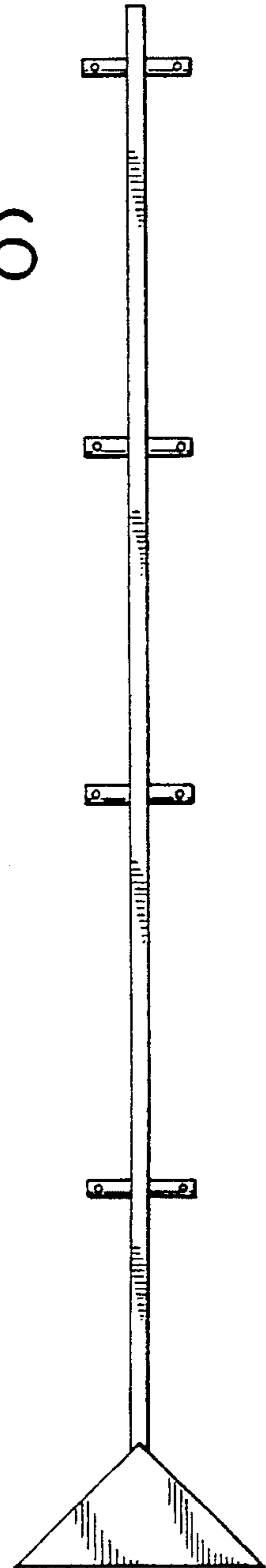
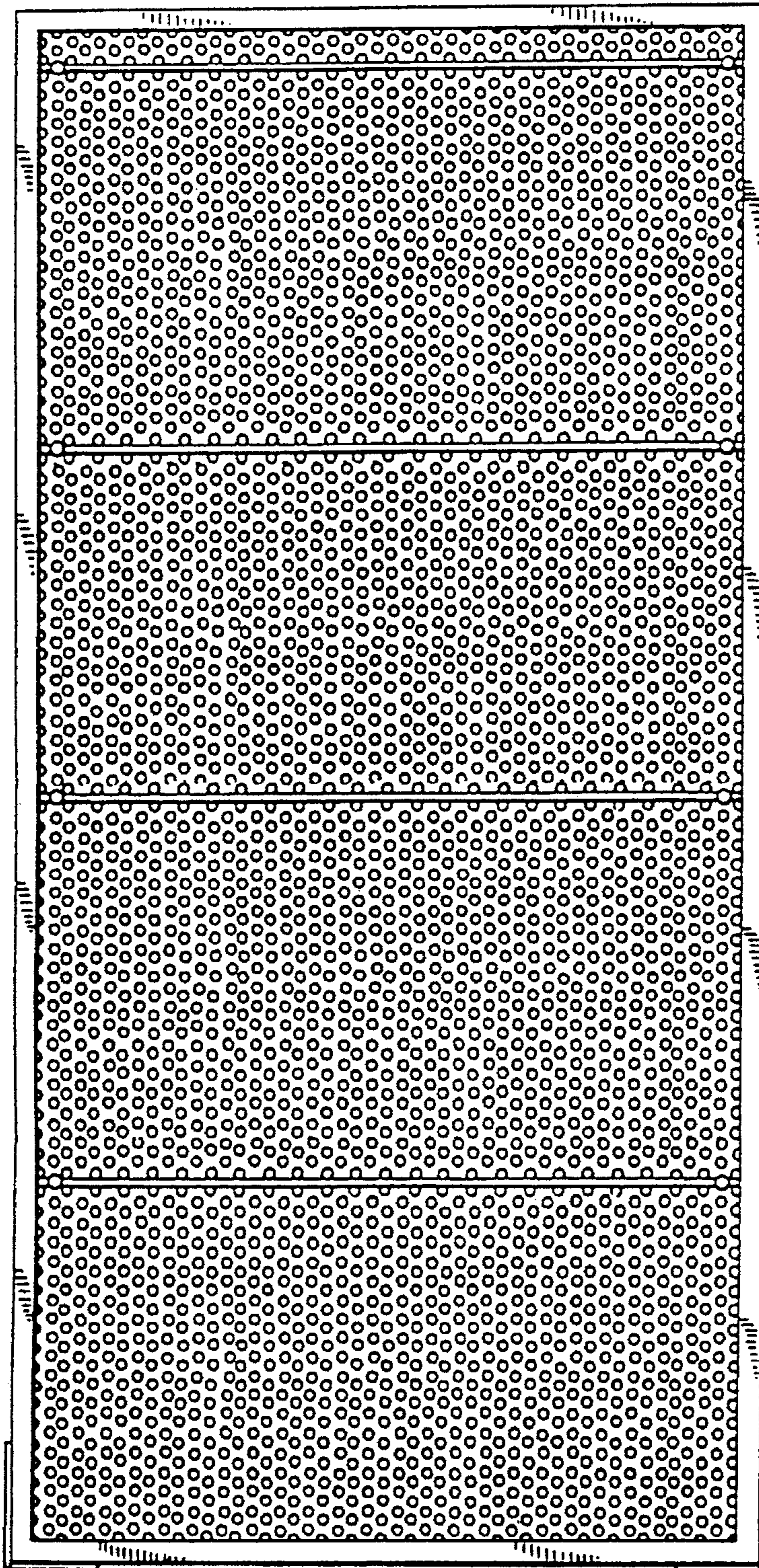

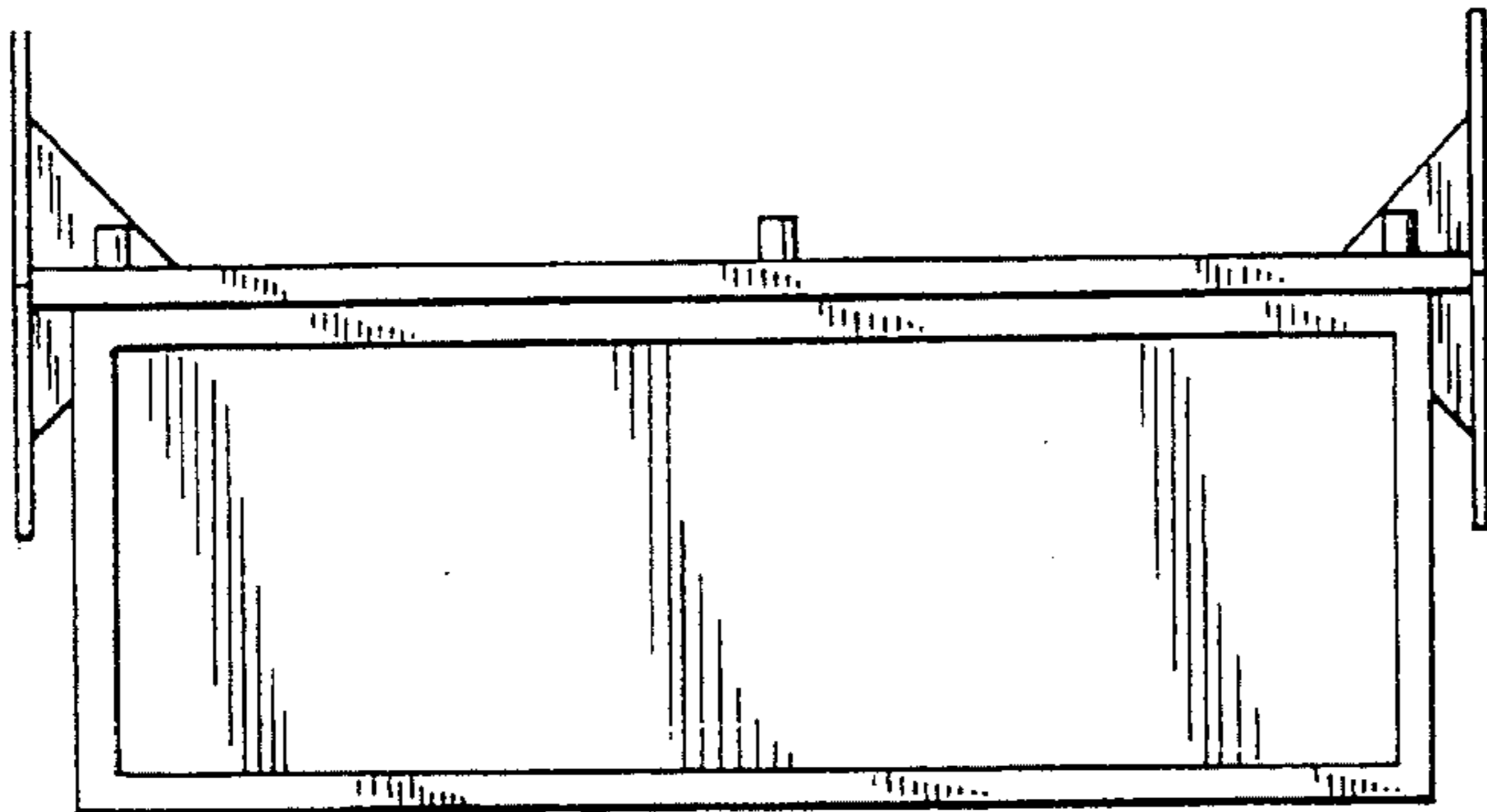

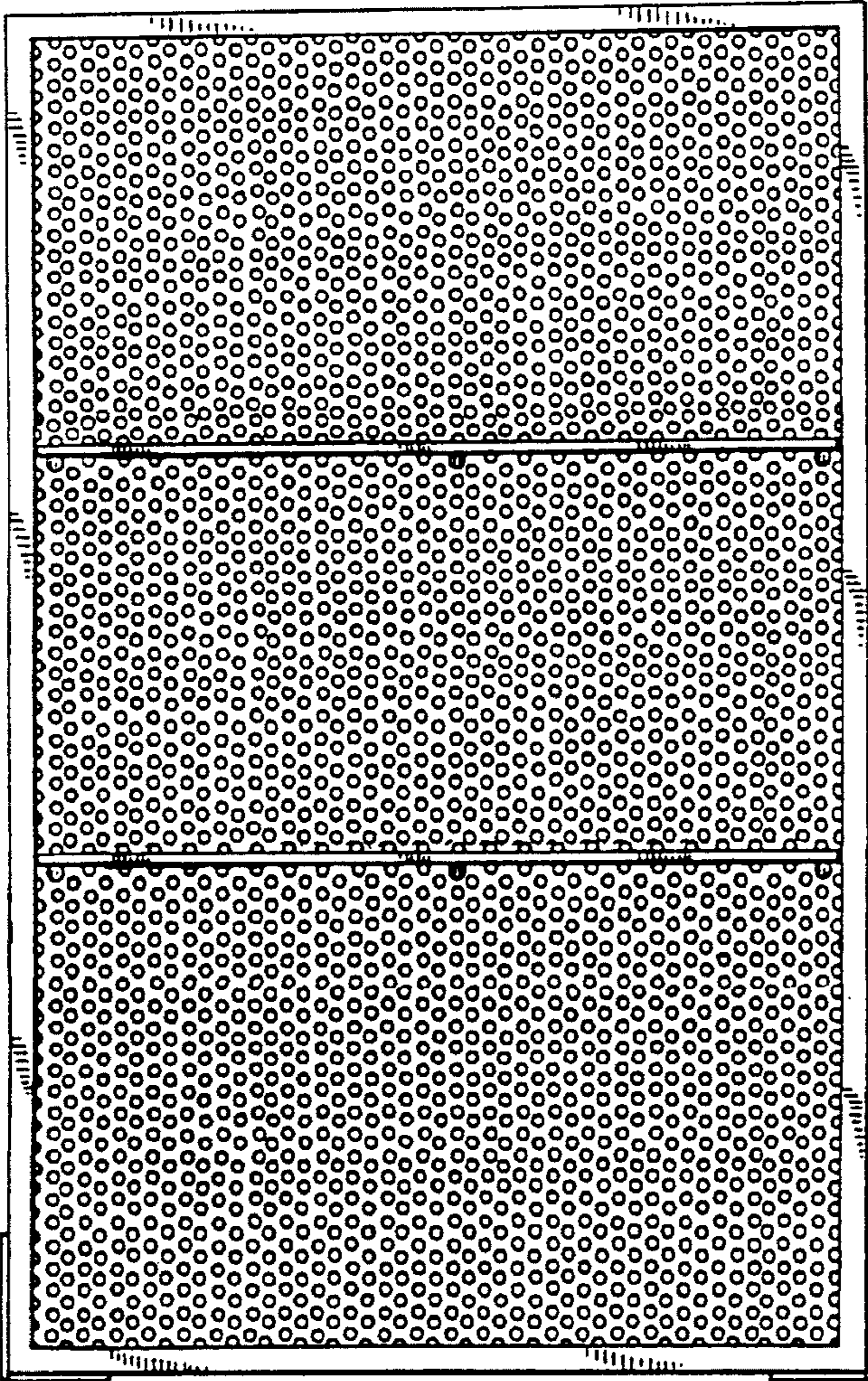

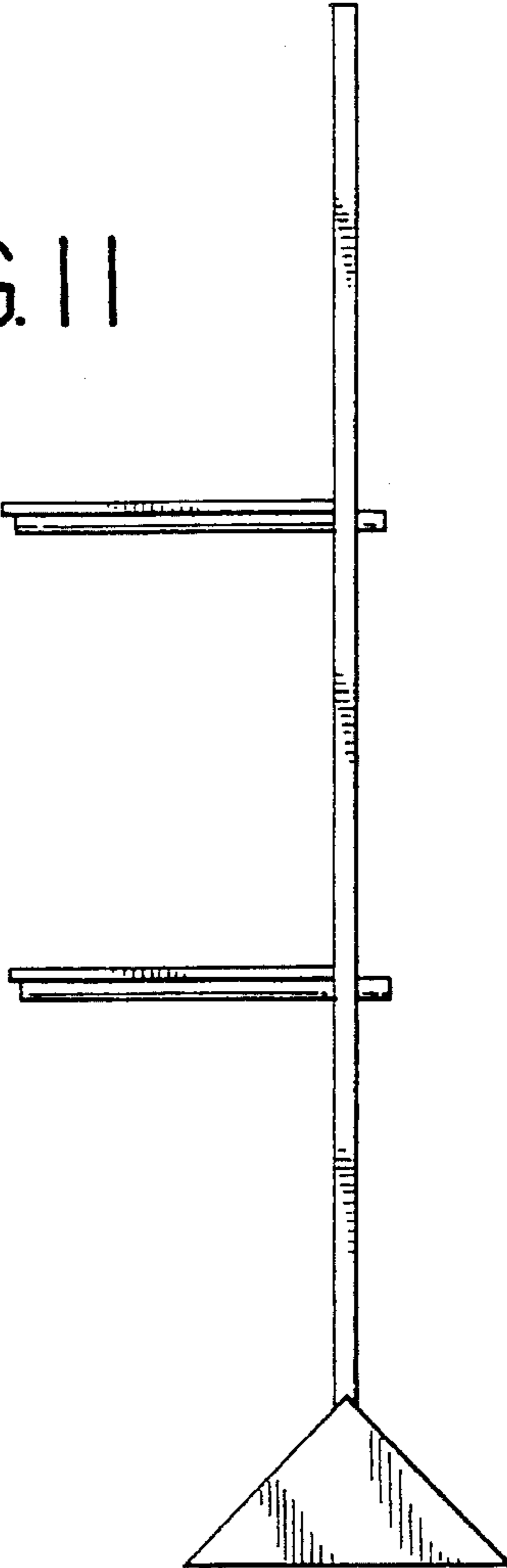

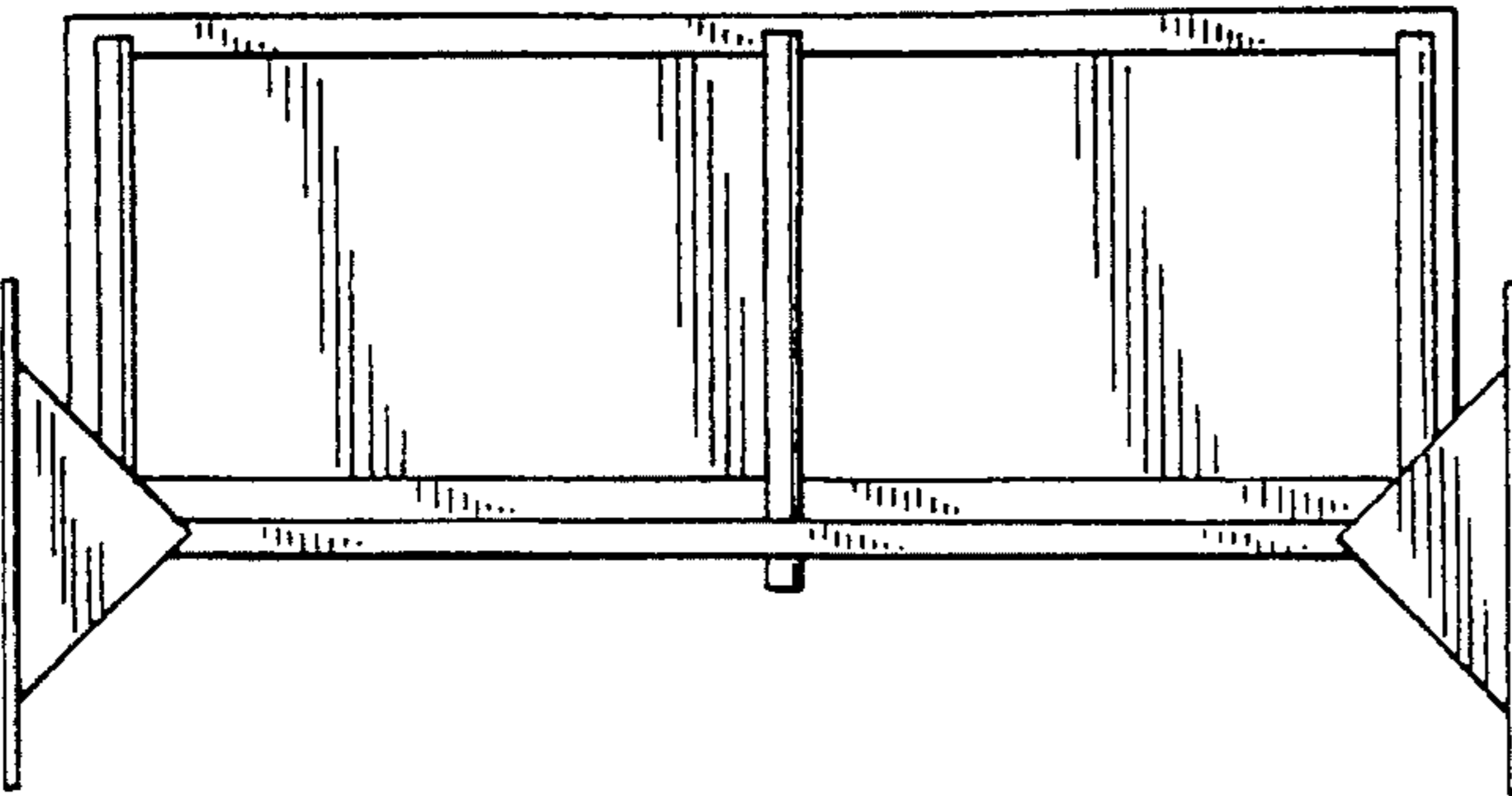
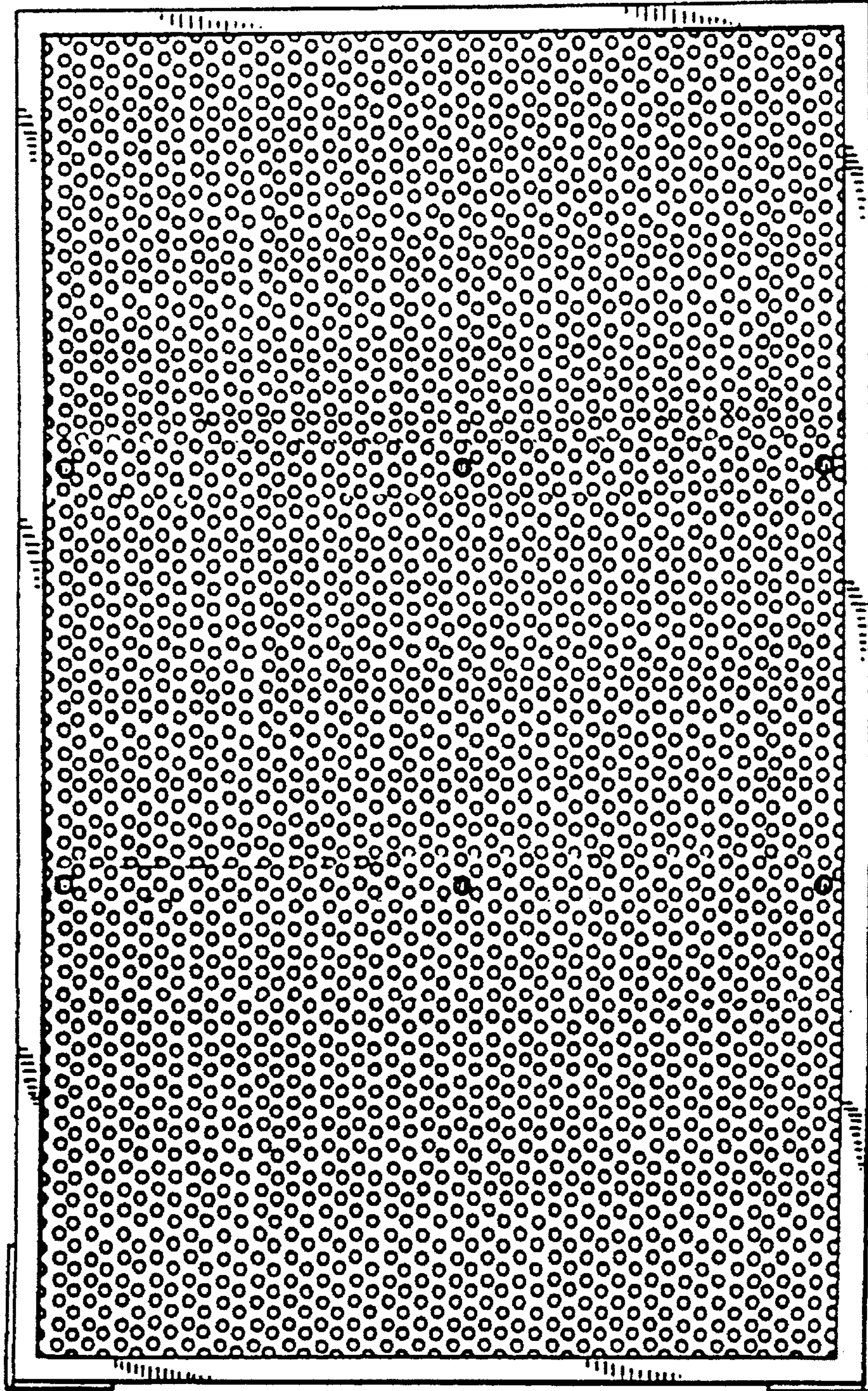

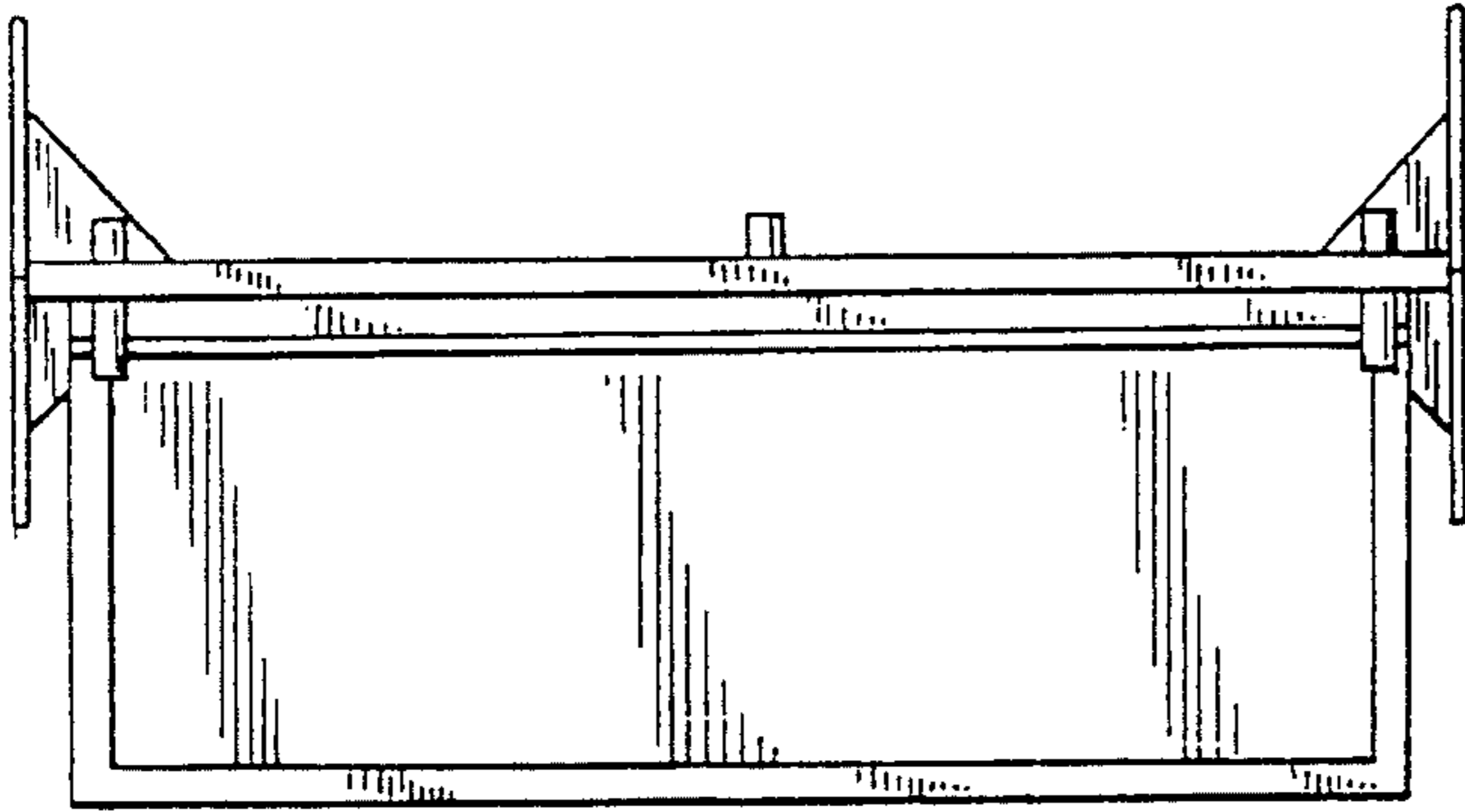

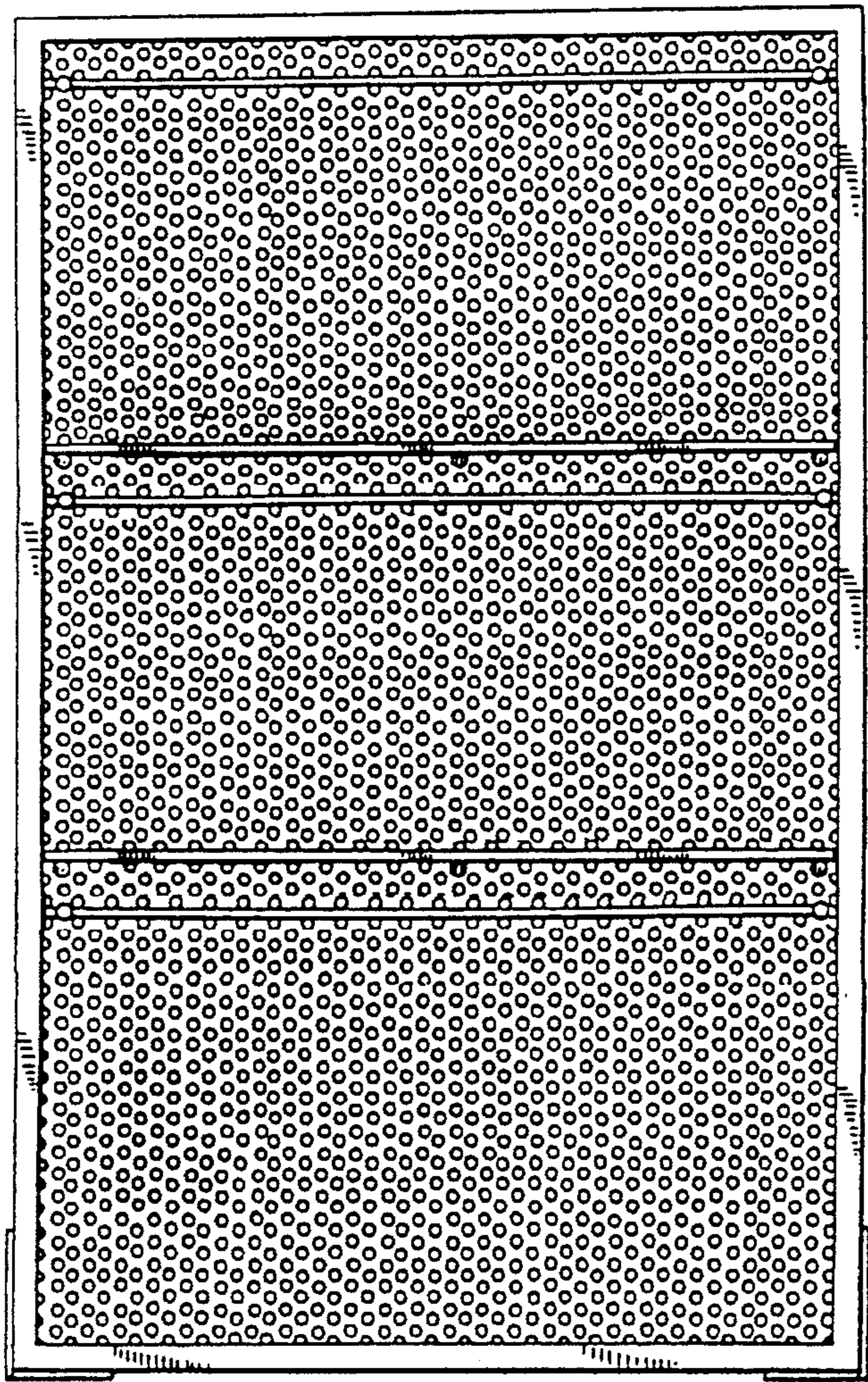

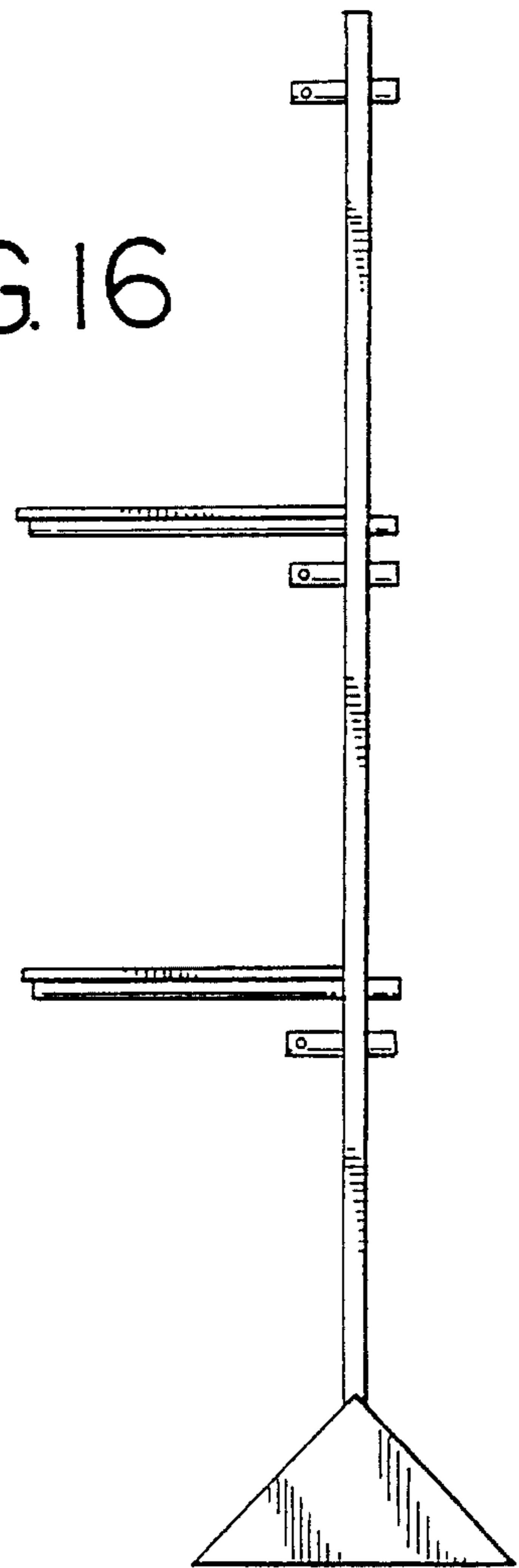

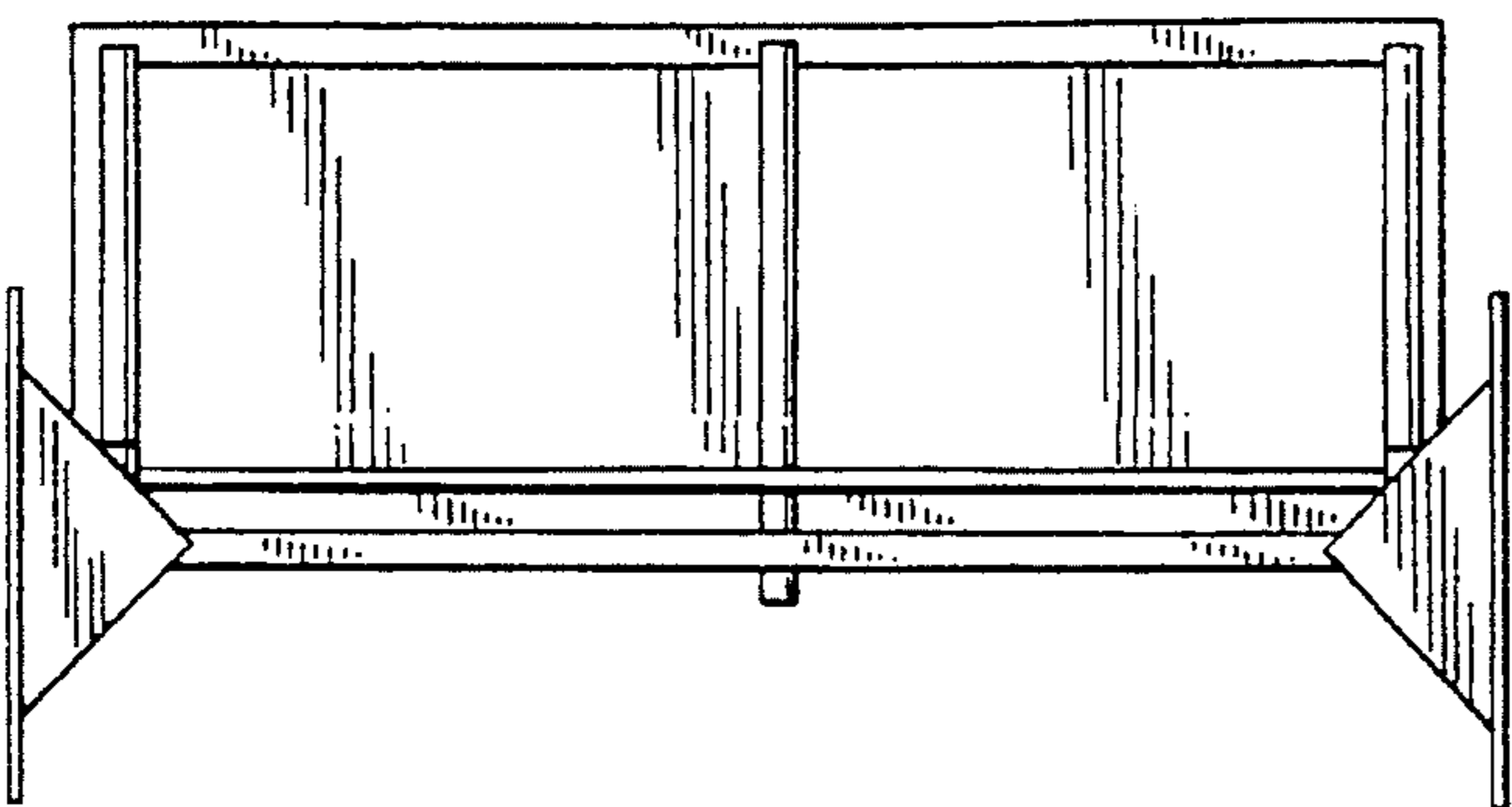
