The ornamental design for a tire tread, as shown and described.

**DESCRIPTION**

FIG. 11 is a front elevational view of a tire tread showing our new design;

FIG. 6 is a front elevational view of a tire tread showing a second embodiment of our design;

FIG. 7 is a perspective view of FIG. 6;

FIG. 8 is another perspective view of FIG. 6;

FIG. 9 is a side elevational view of FIG. 6;

FIG. 10 is another side elevational view of FIG. 6;

FIG. 11 is a front elevational view of a tire tread showing a third embodiment of our design;

FIG. 12 is a perspective view of FIG. 11;

FIG. 13 is another perspective view of FIG. 11;

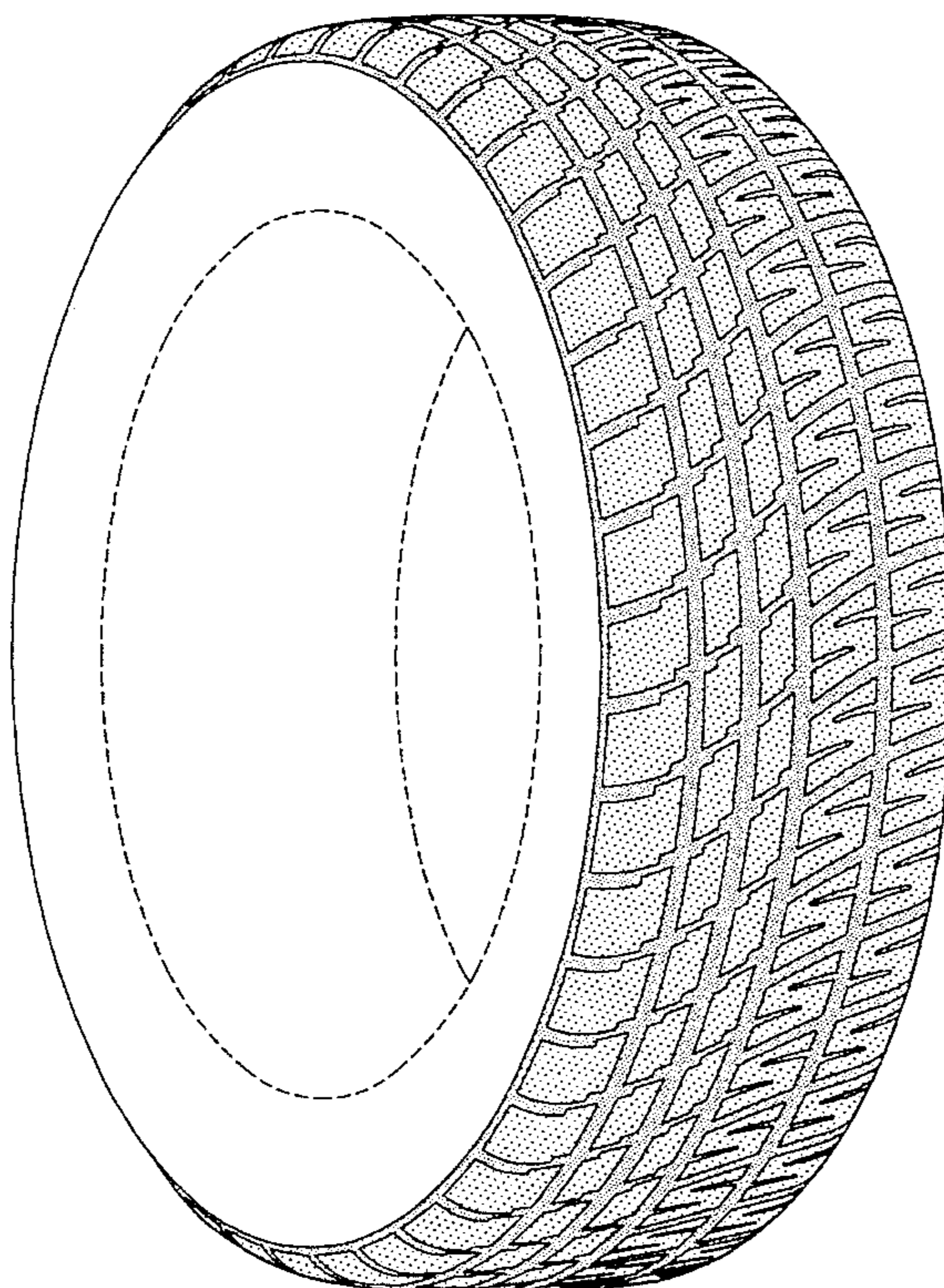
FIG. 14 is a side elevational view of FIG. 11;

The tread pattern is understood to be repeated uniformly throughout the circumference of all three embodiments of the tire tread.

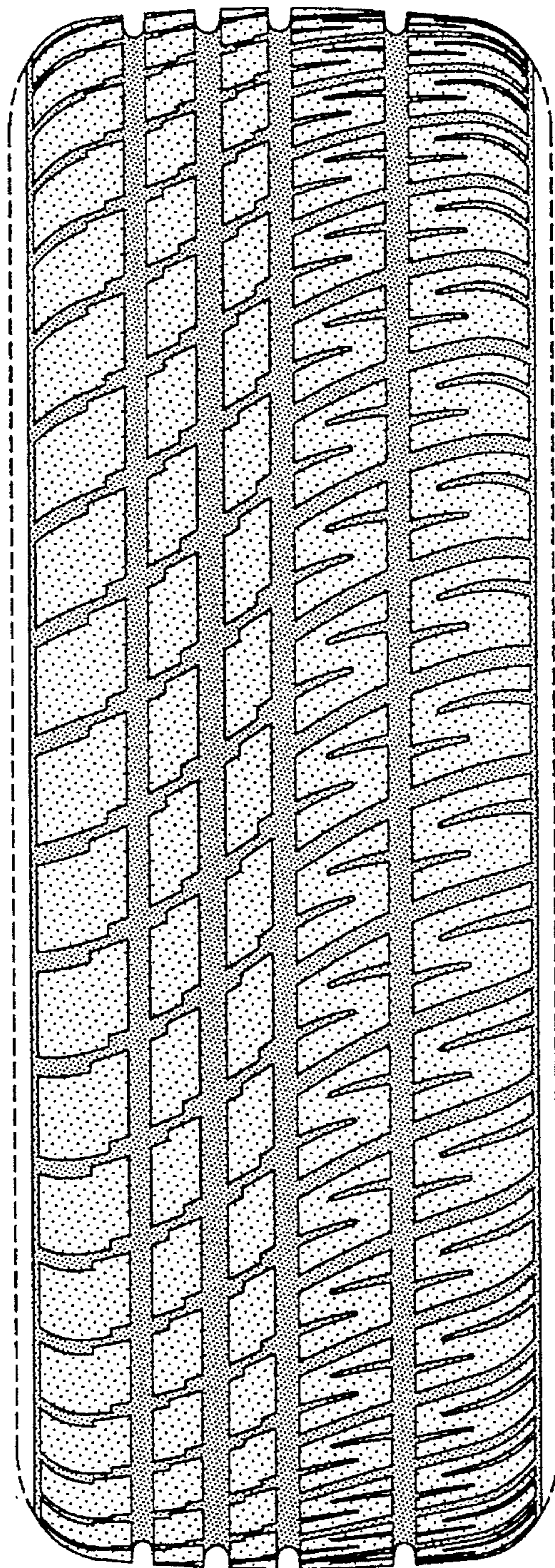

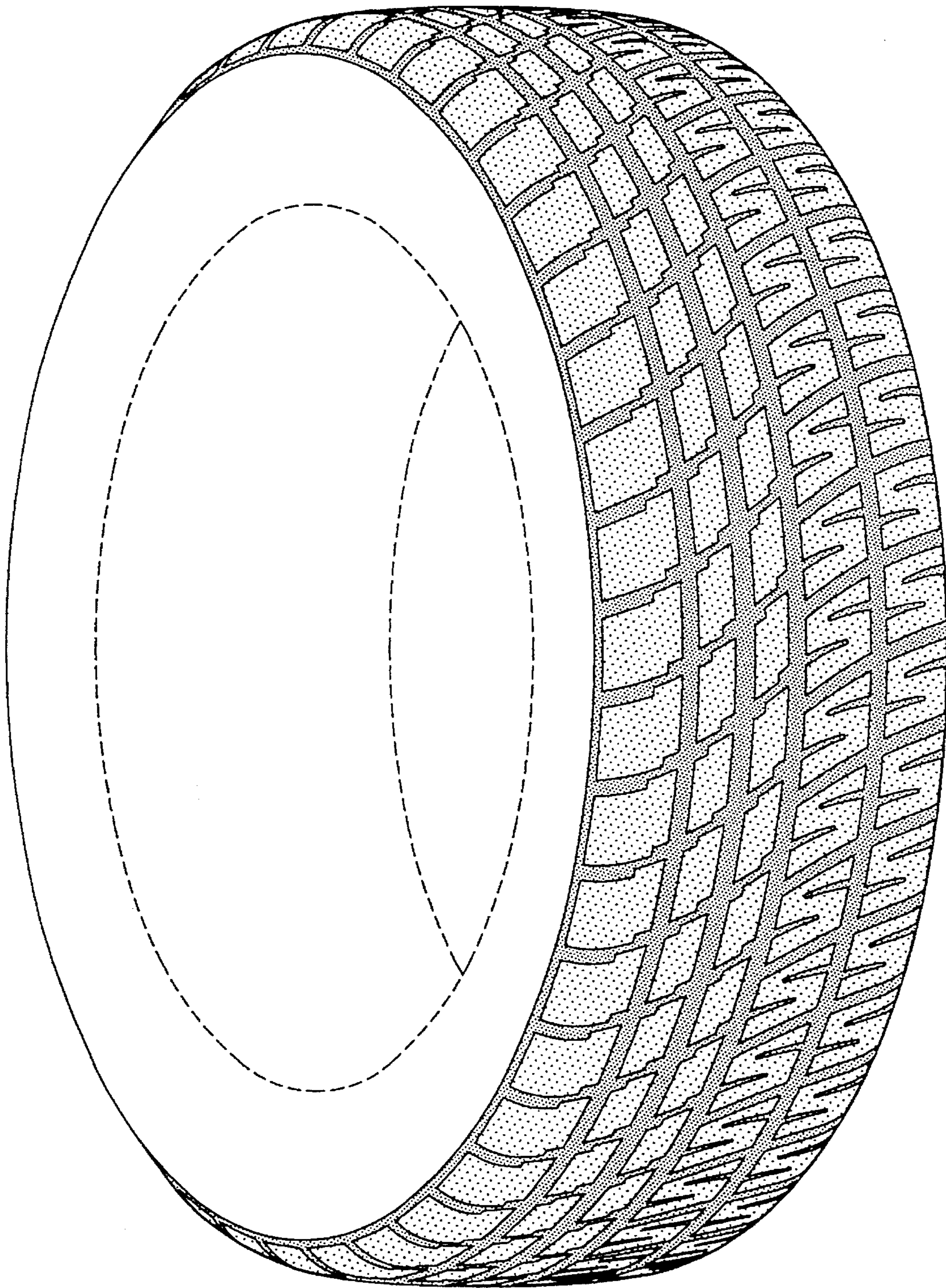

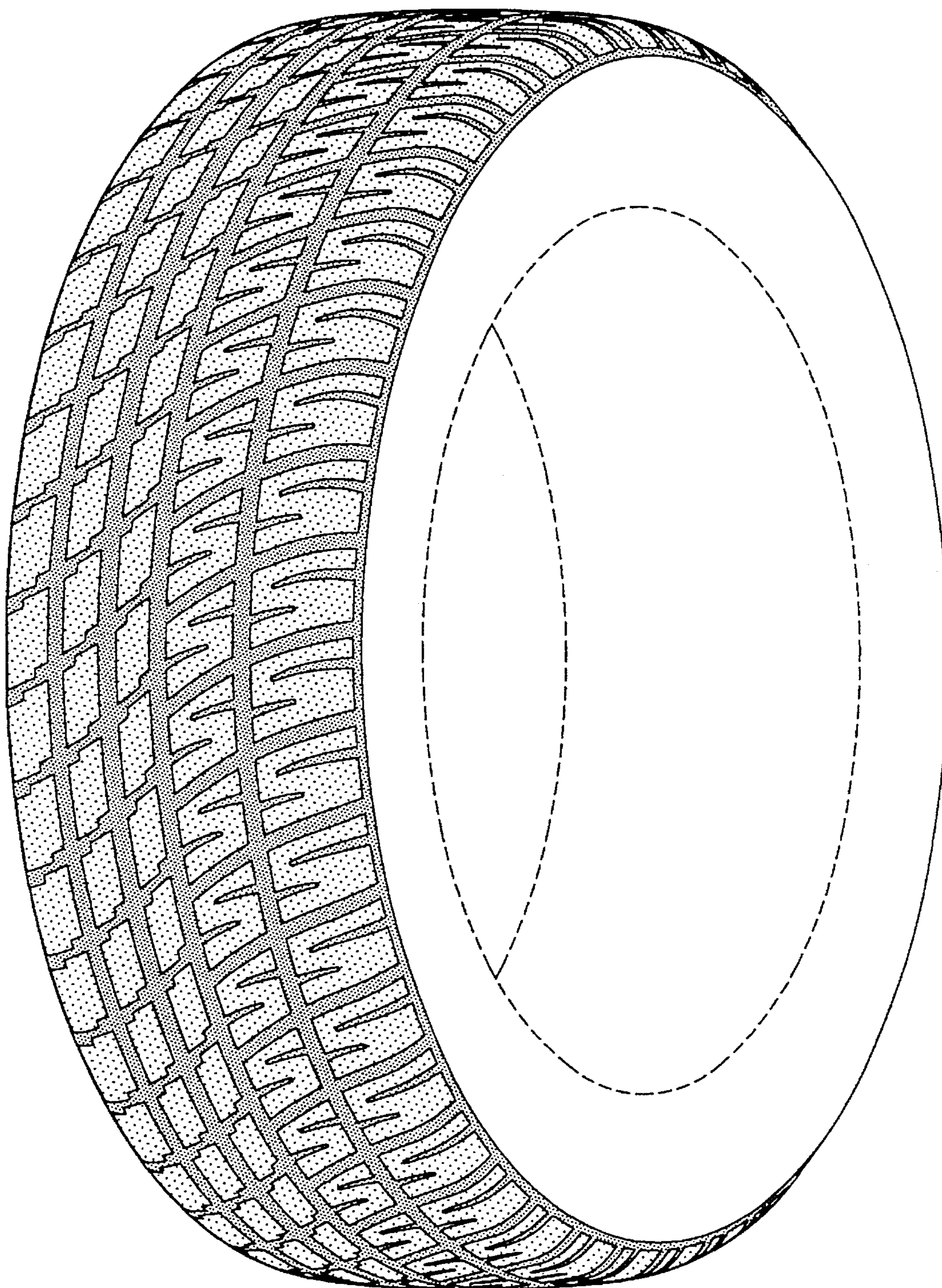

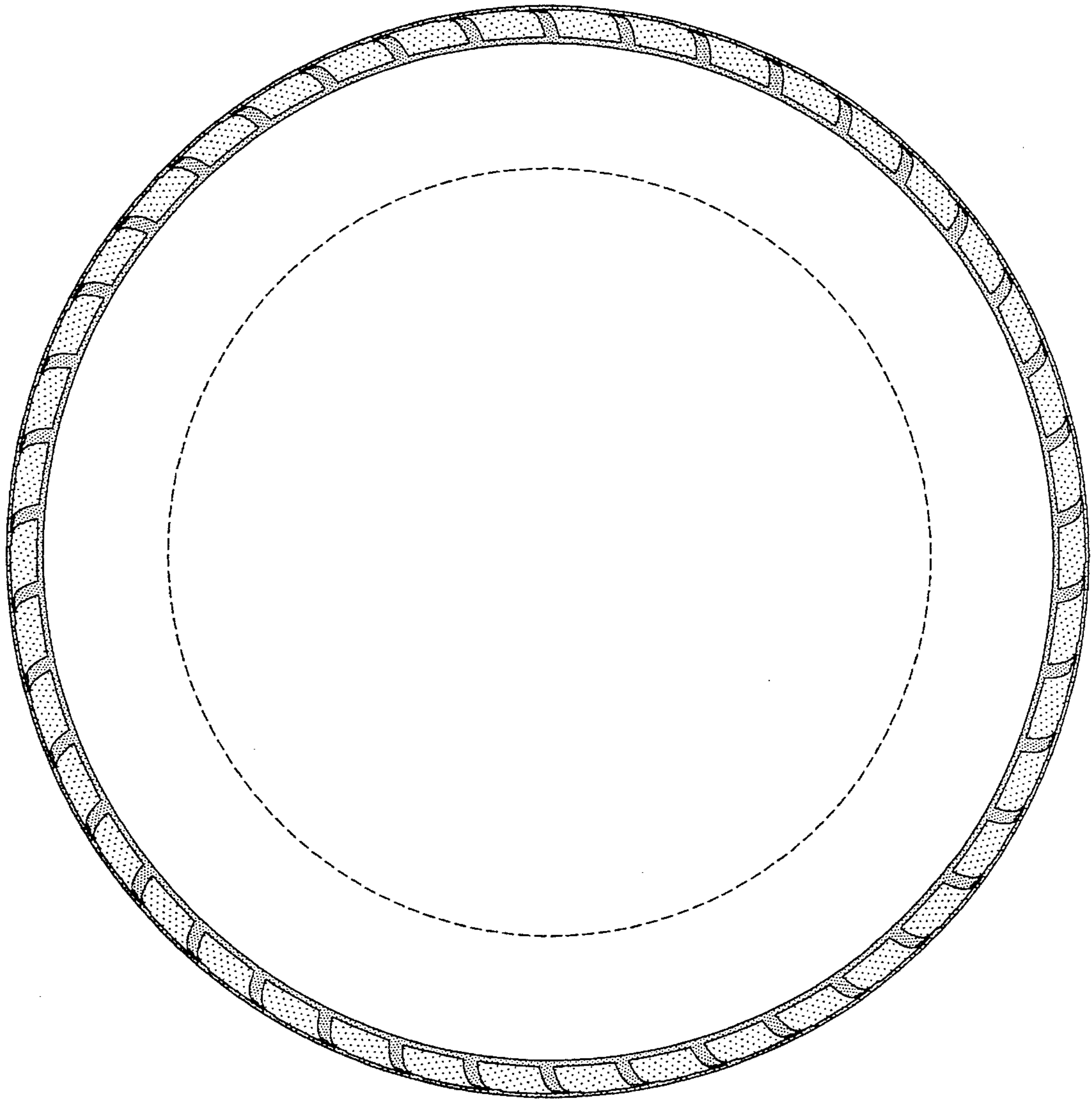

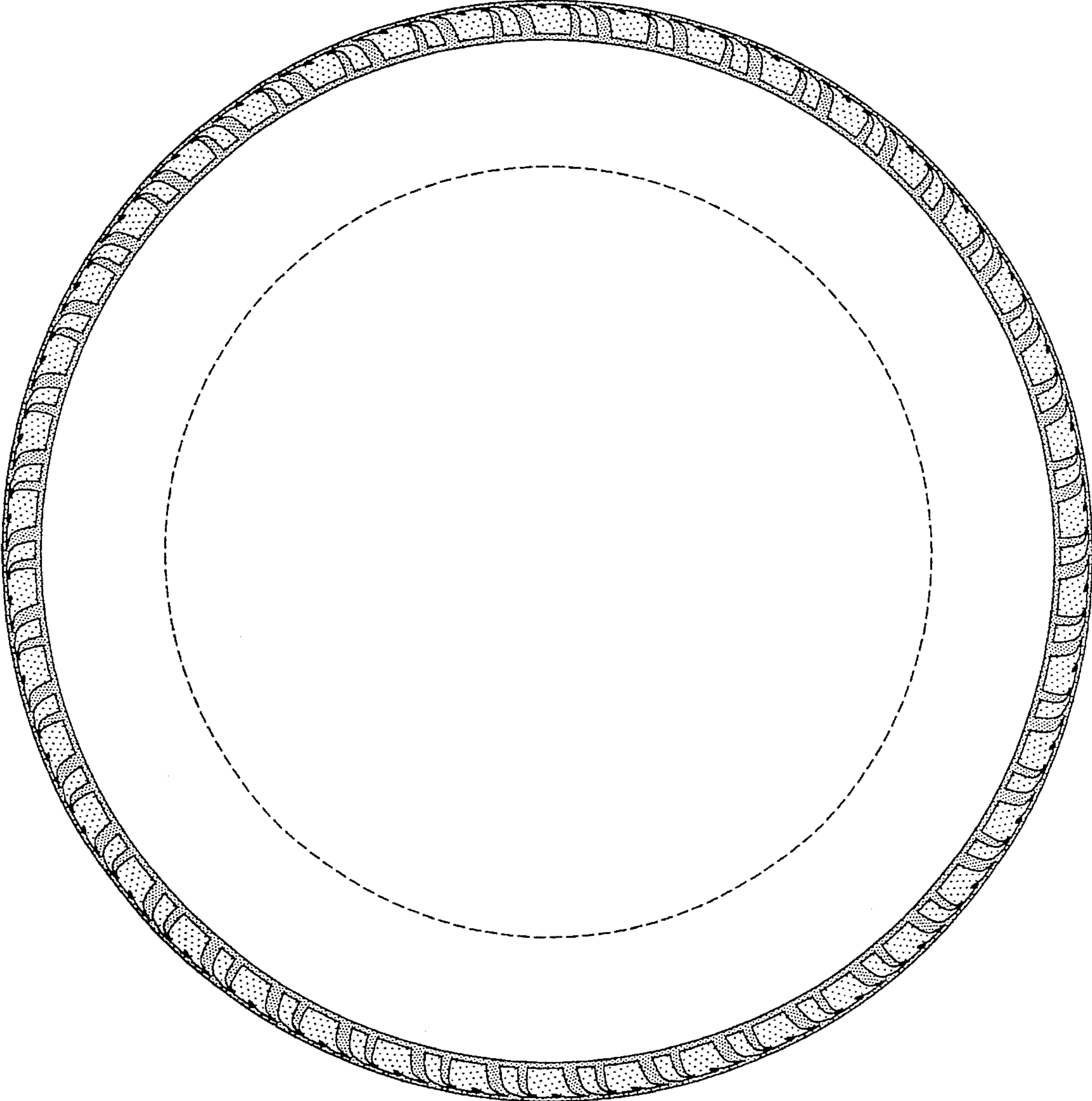

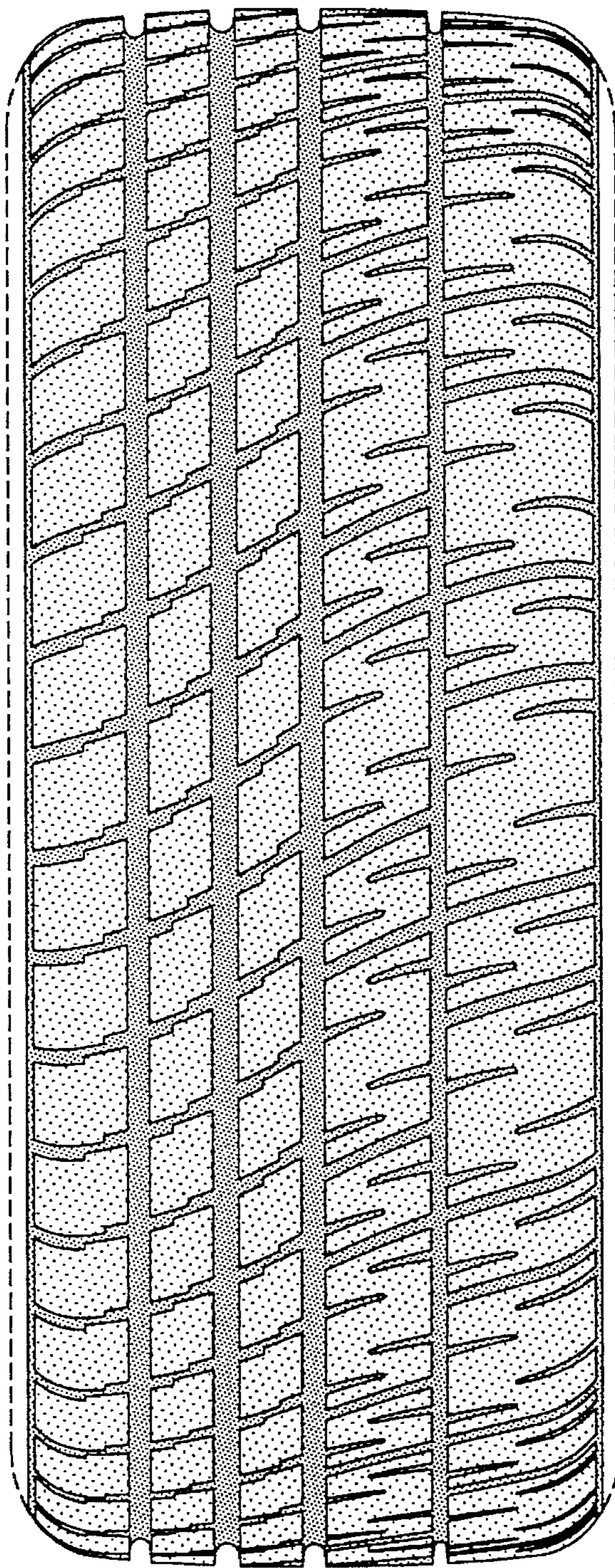

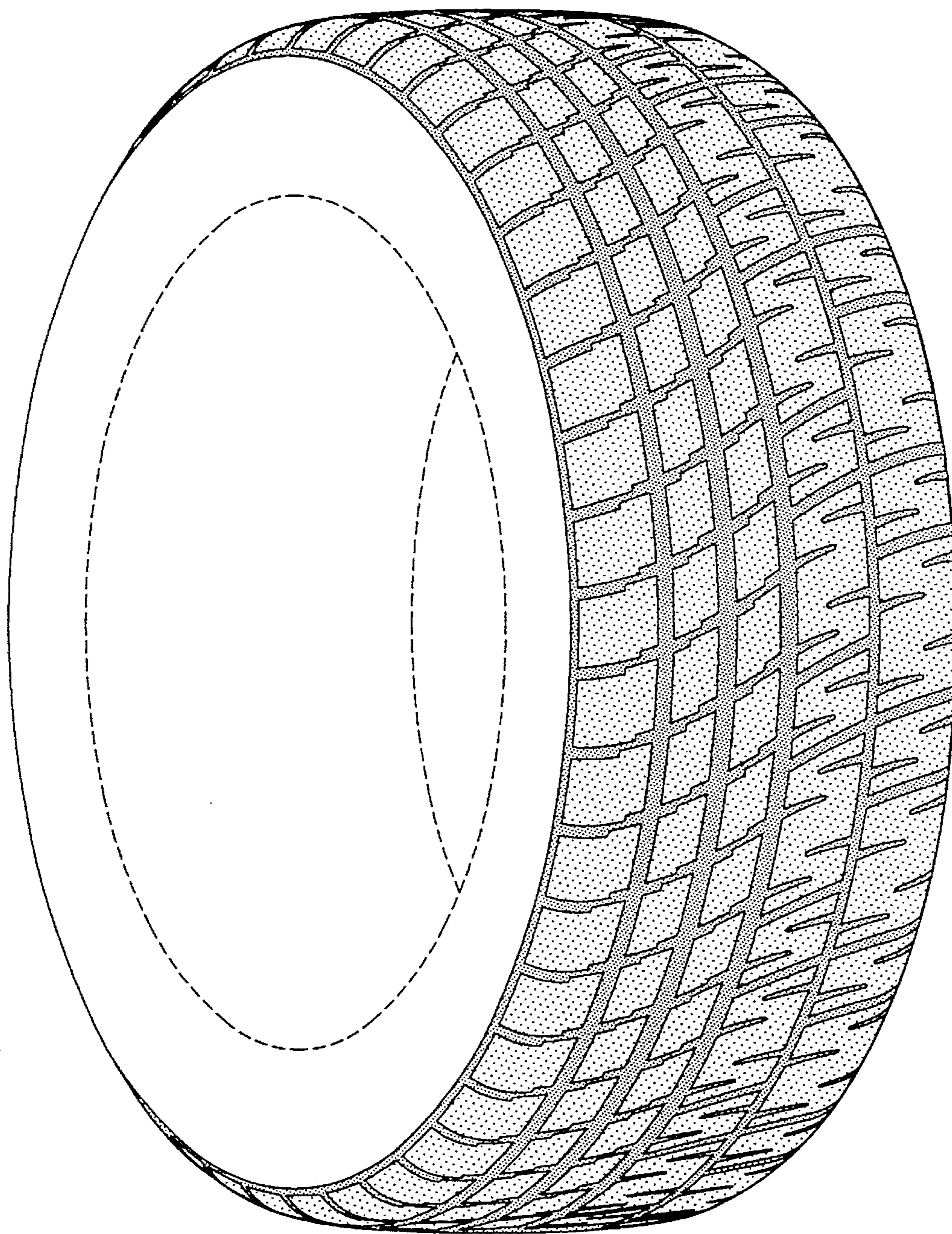

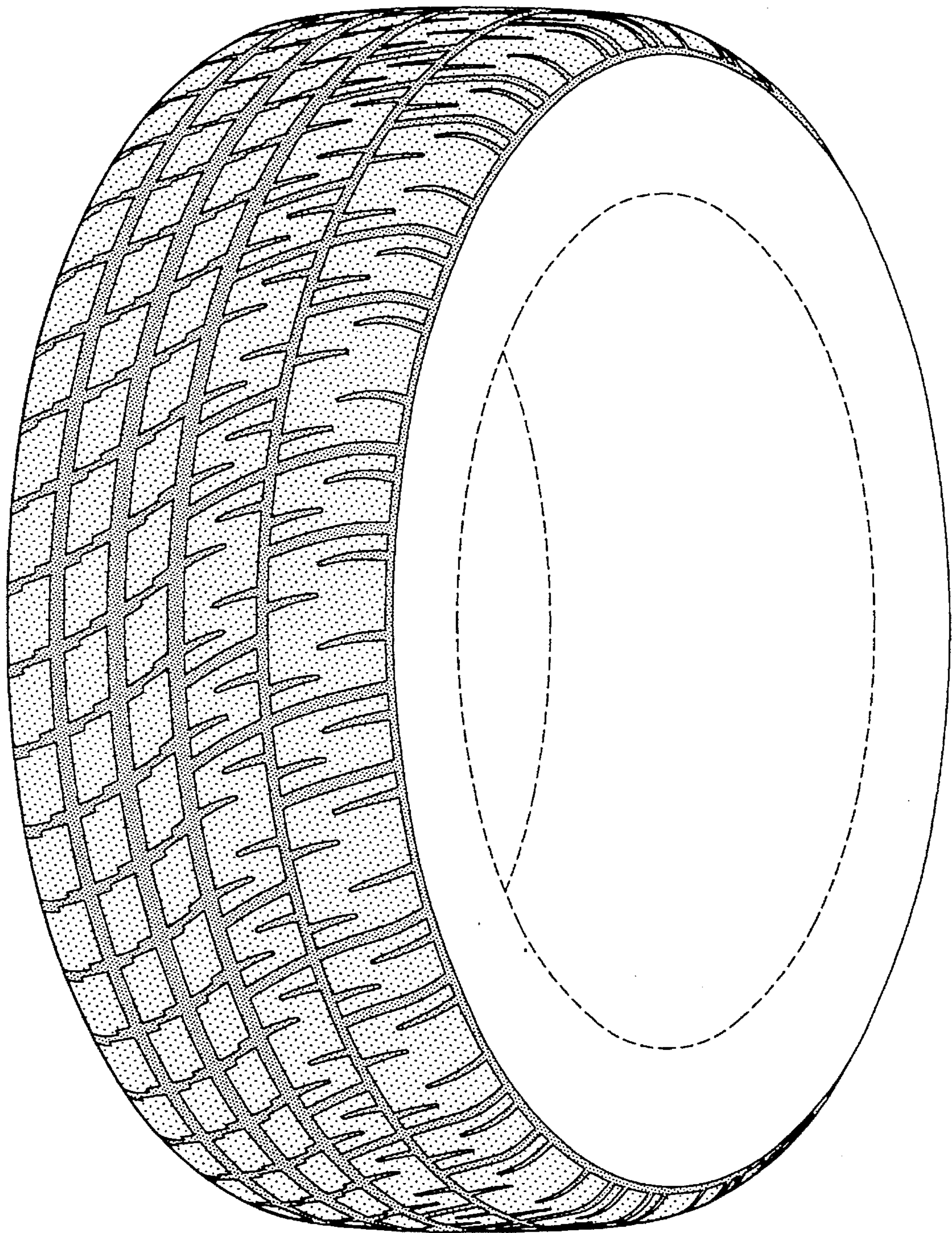

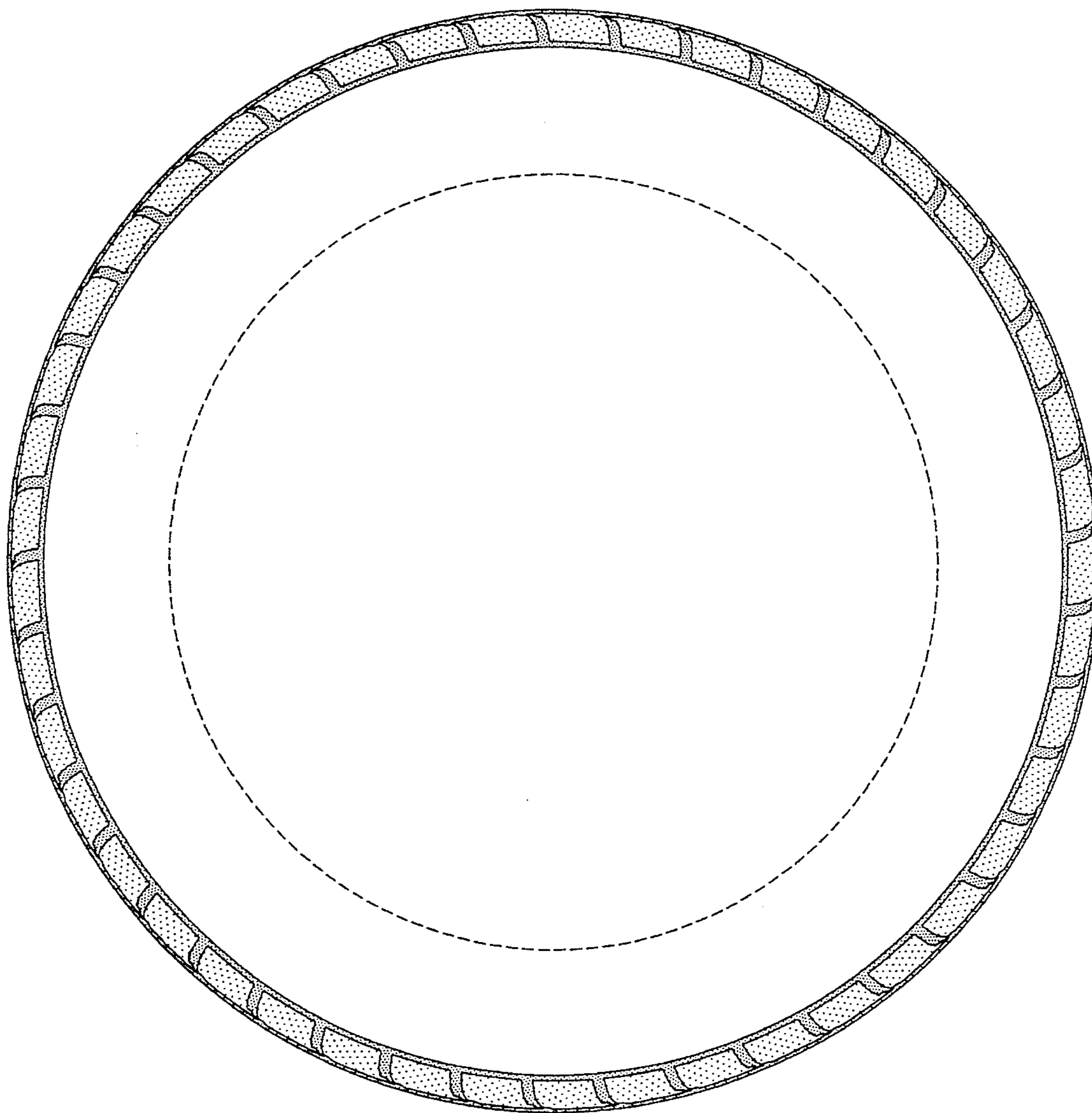

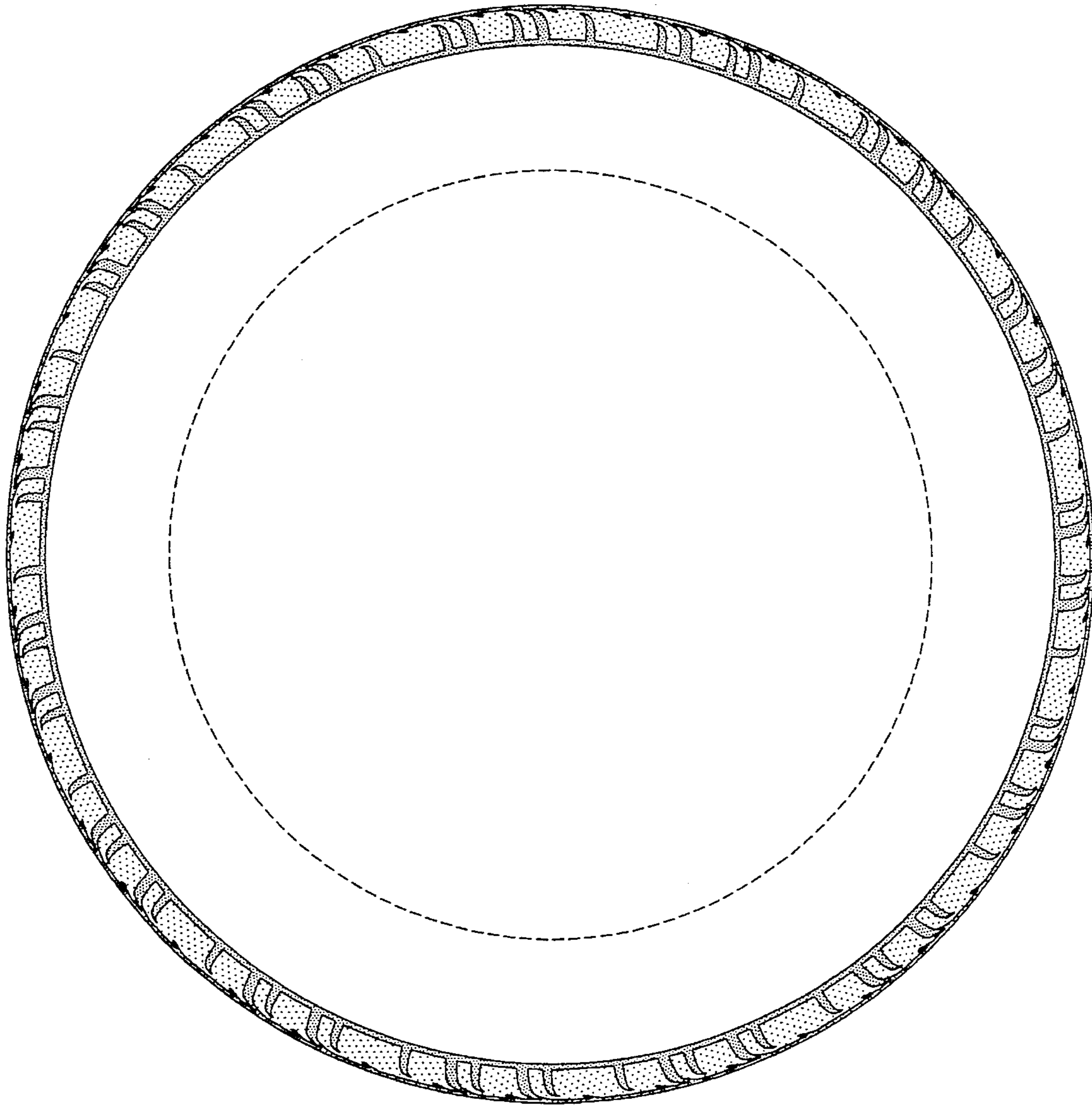

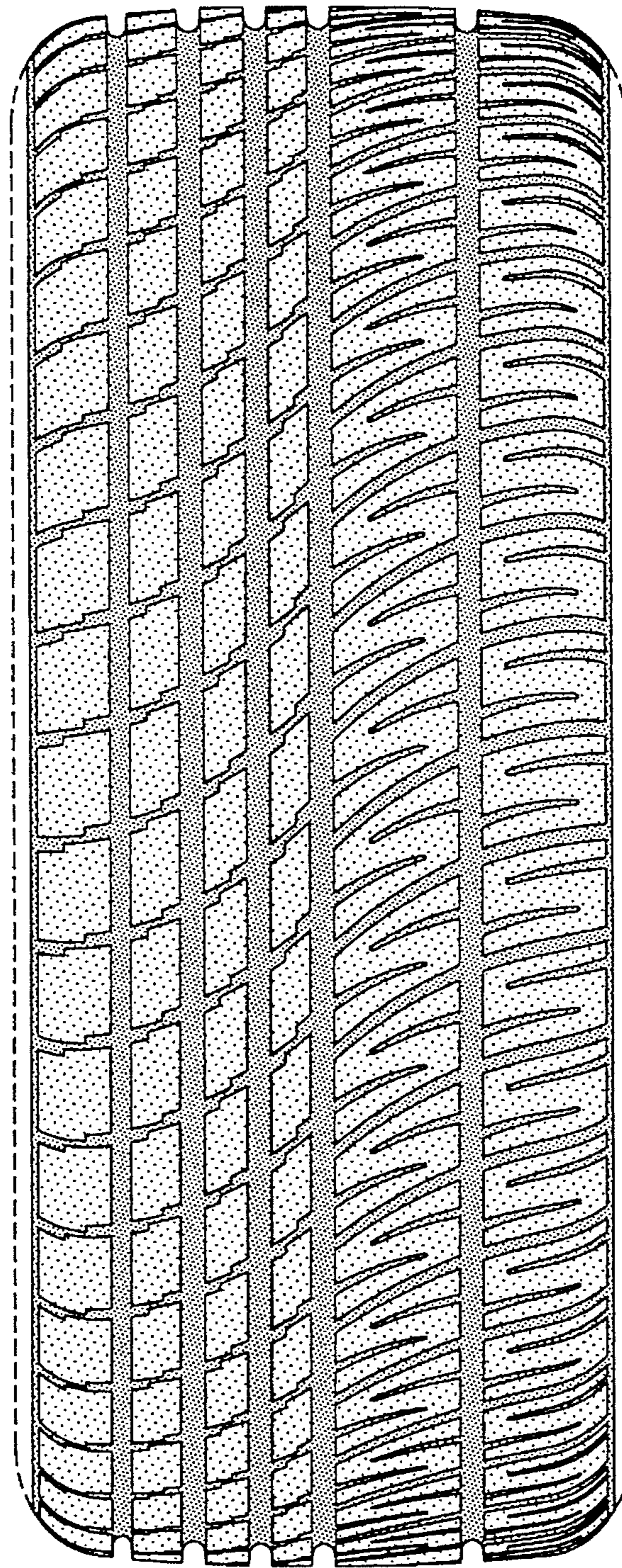

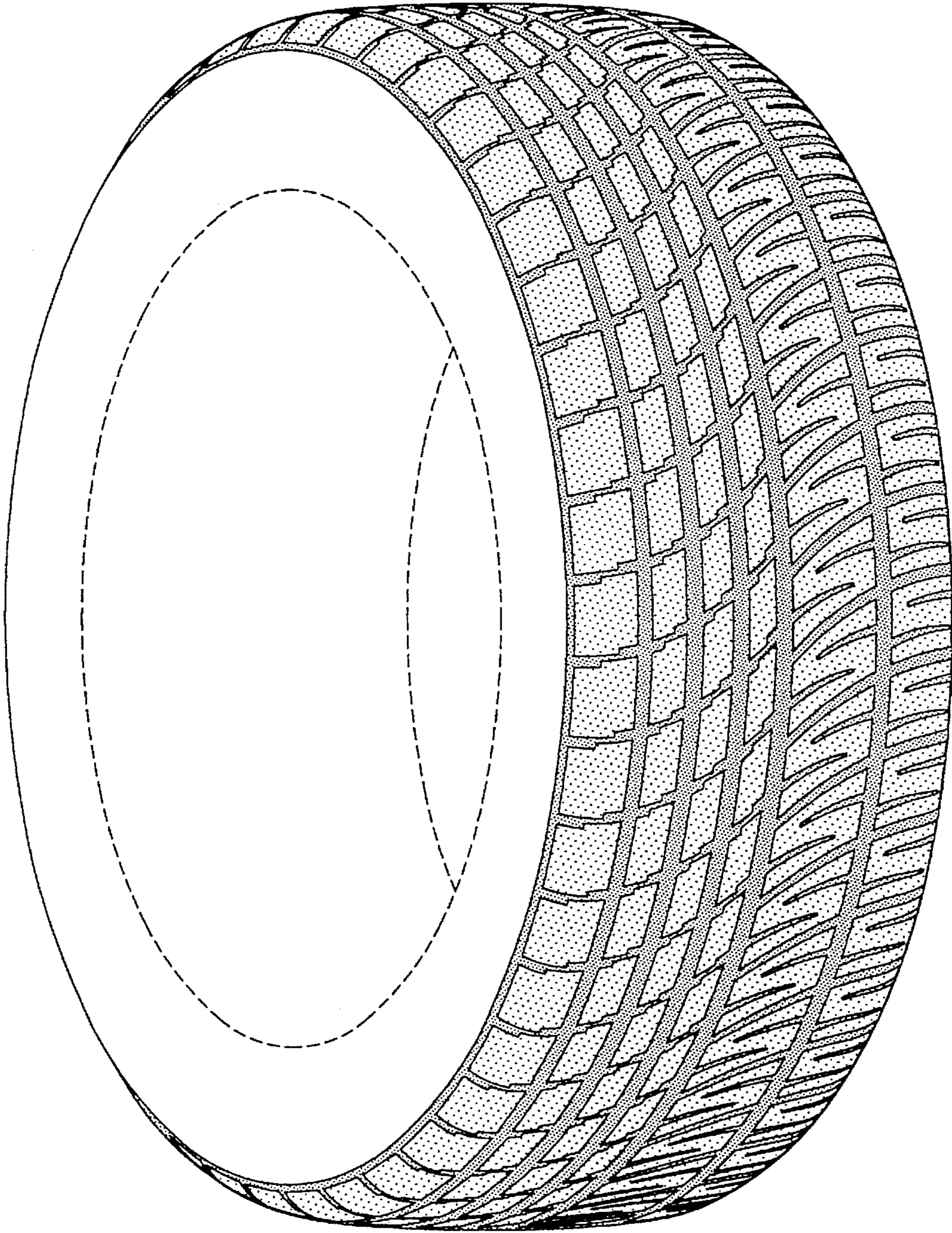

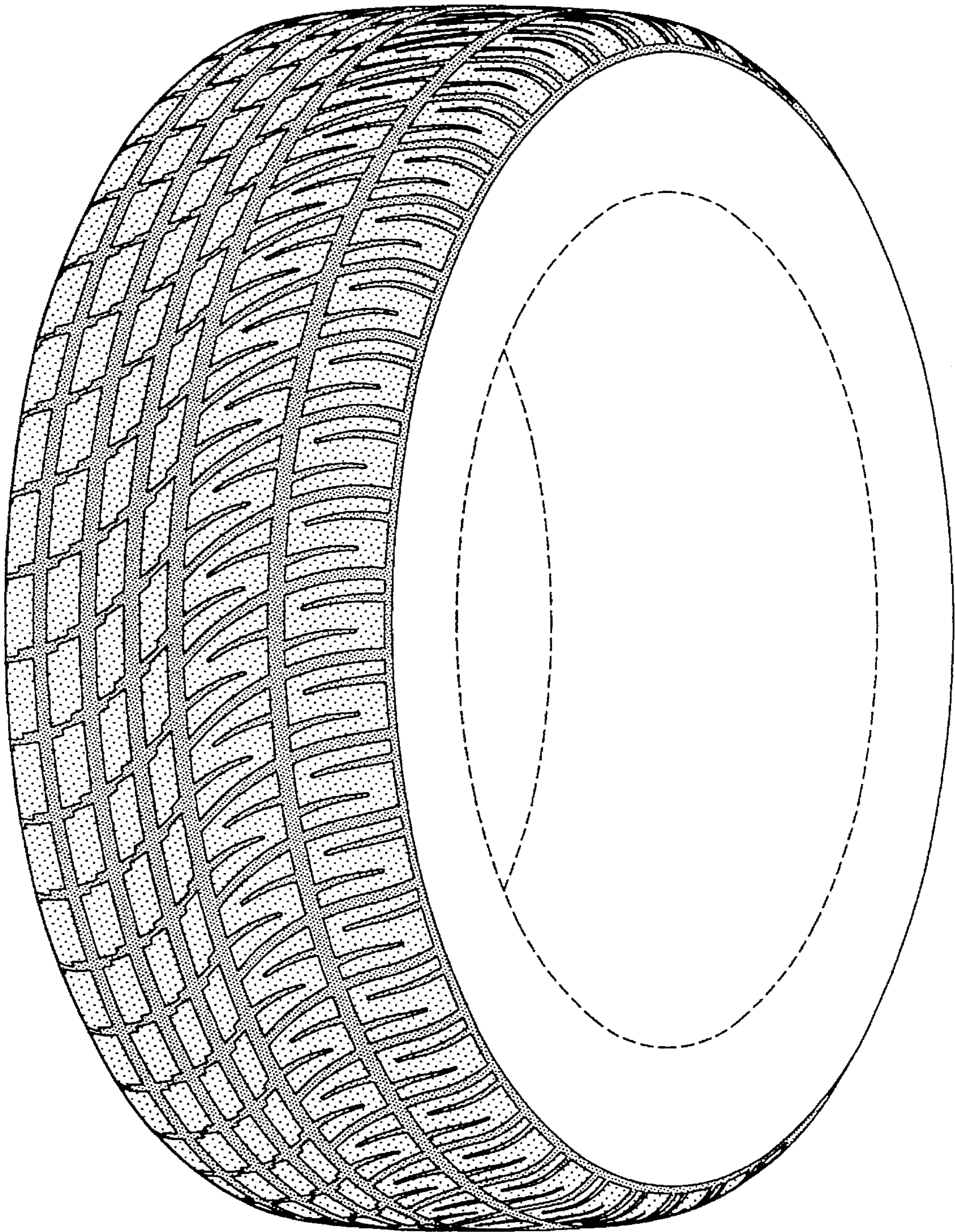

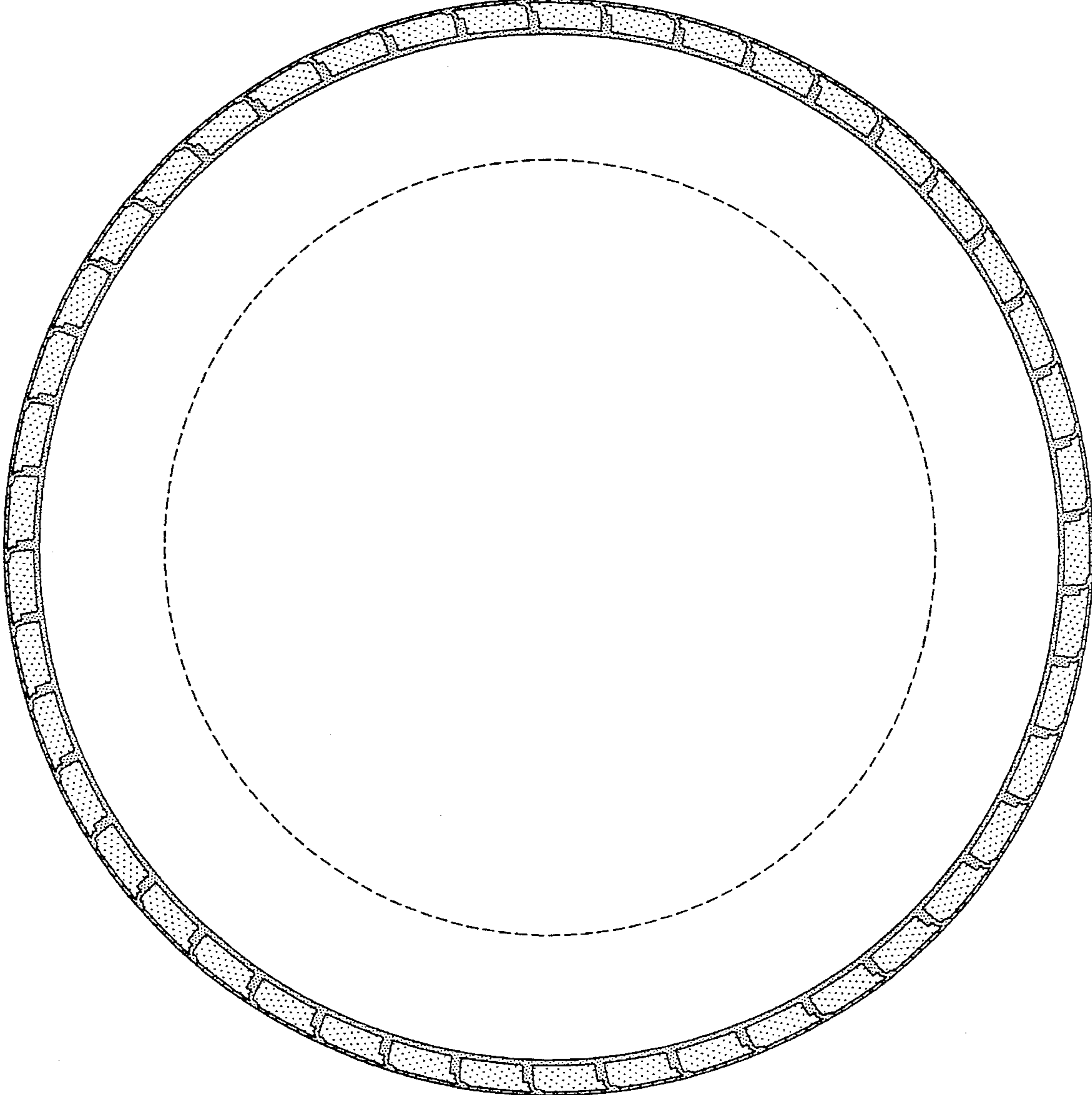

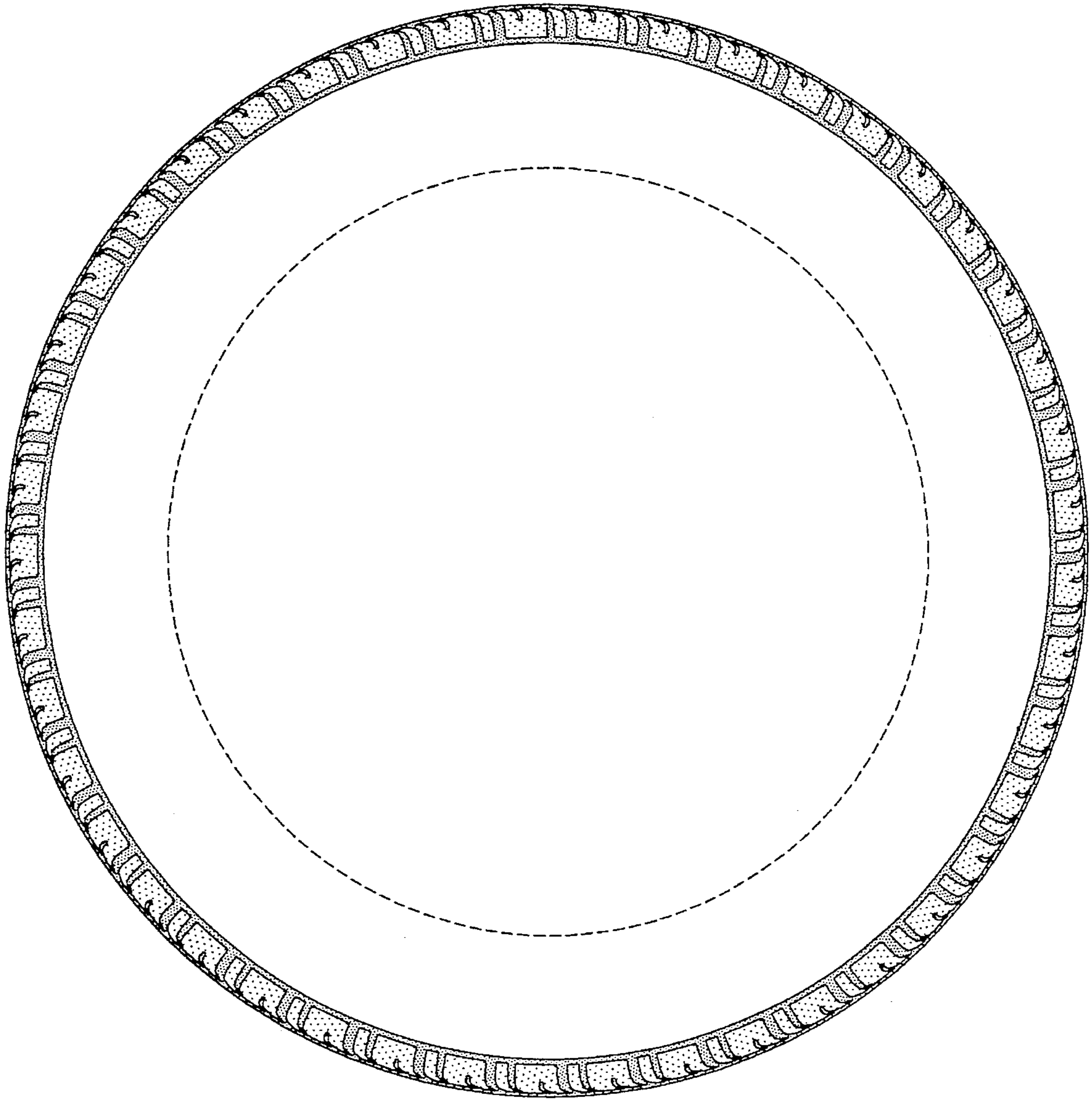
