[57] **CLAIM**

The ornamental design for a cradle for a telephone handset, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a cradle for a telephone handset showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a side elevation view thereof, the side opposite being a mirror image of the side shown.

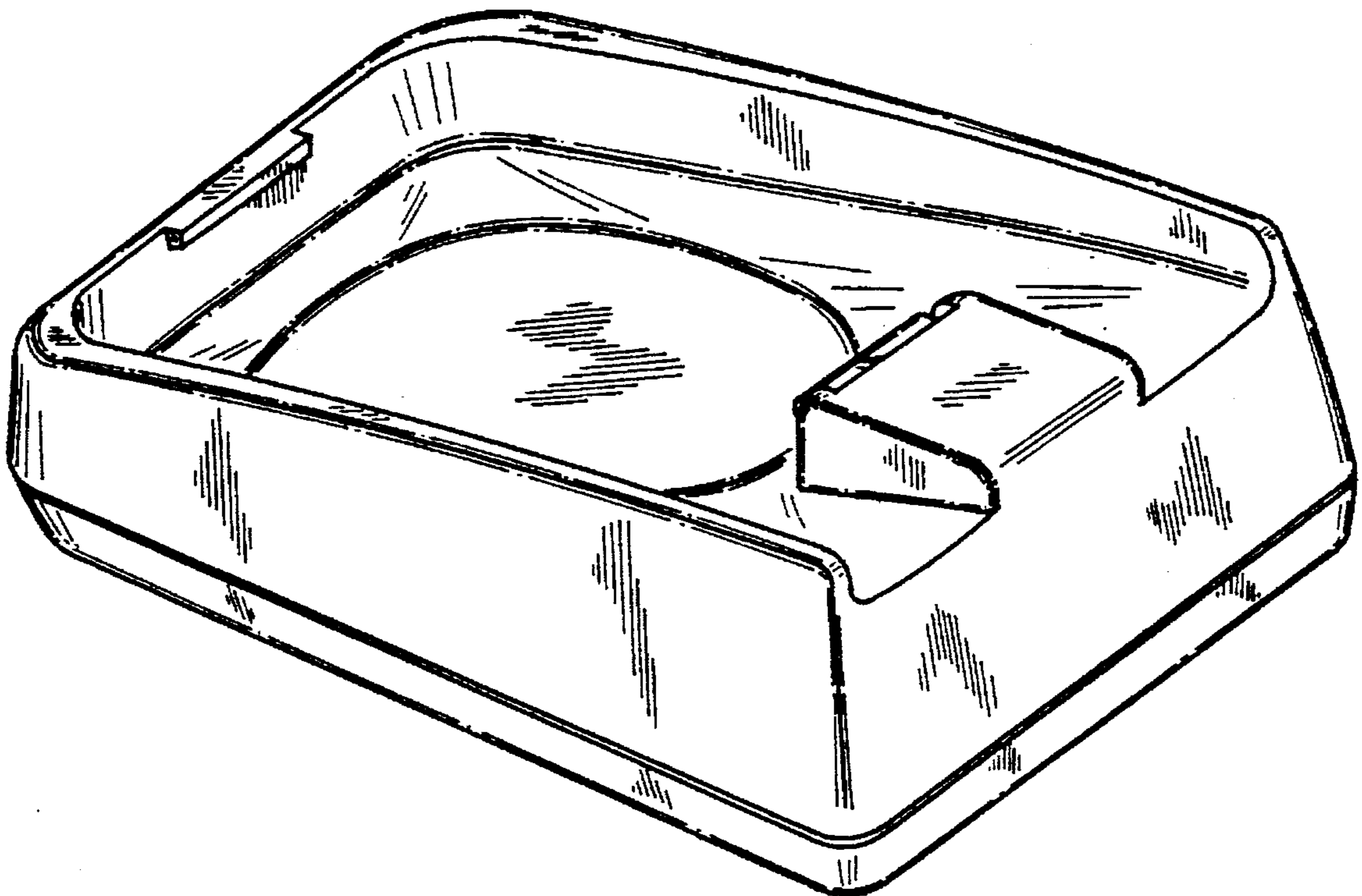

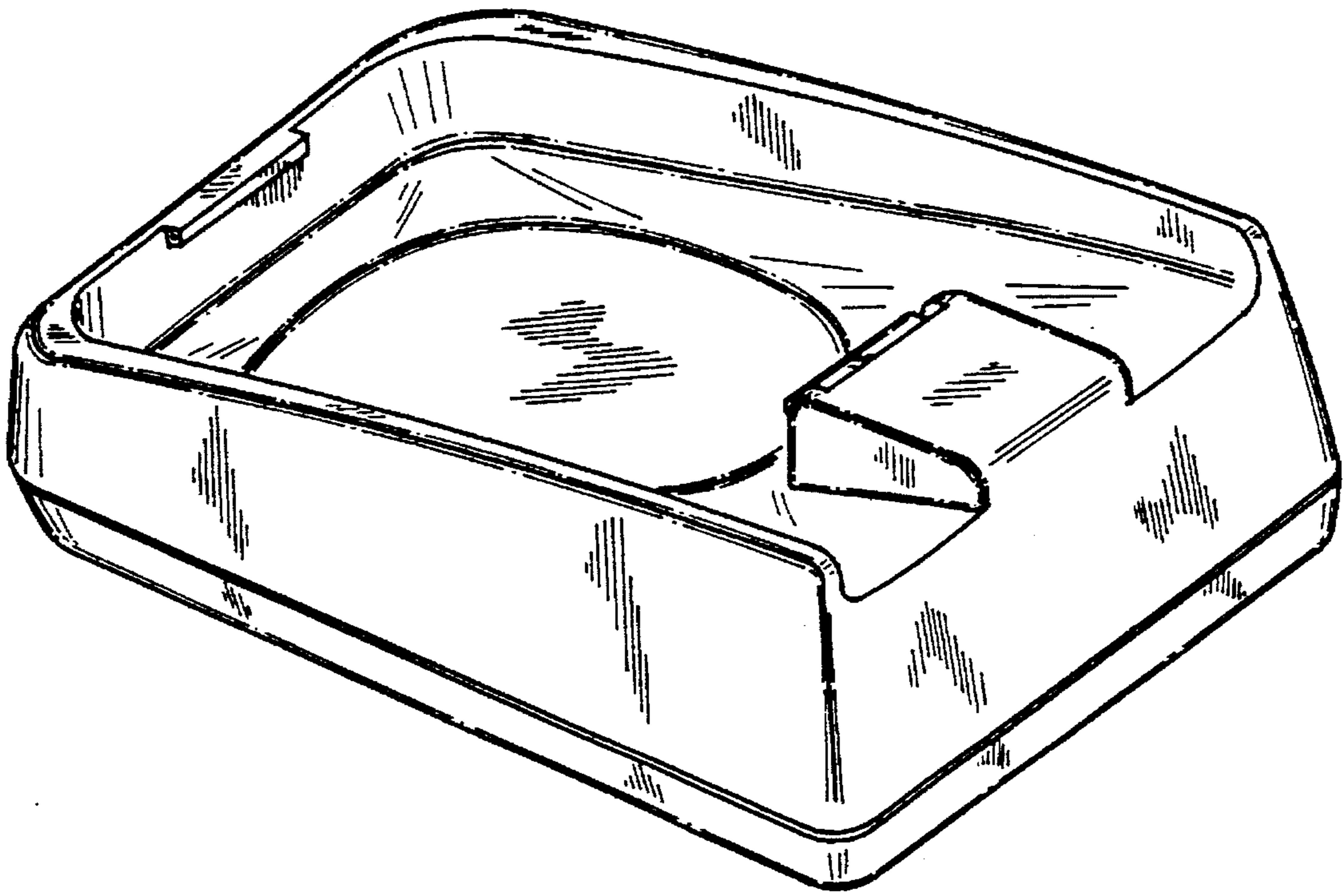

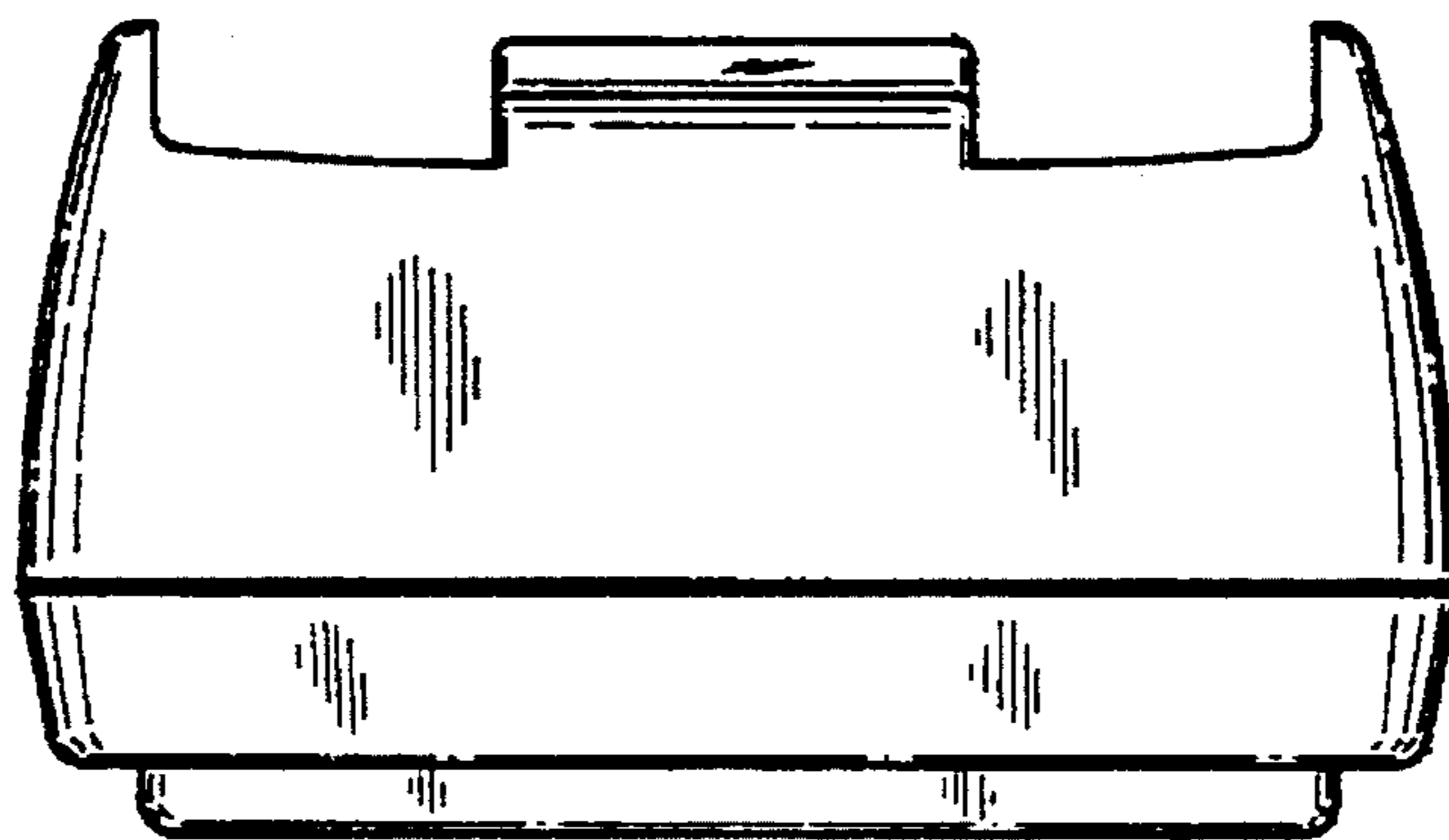

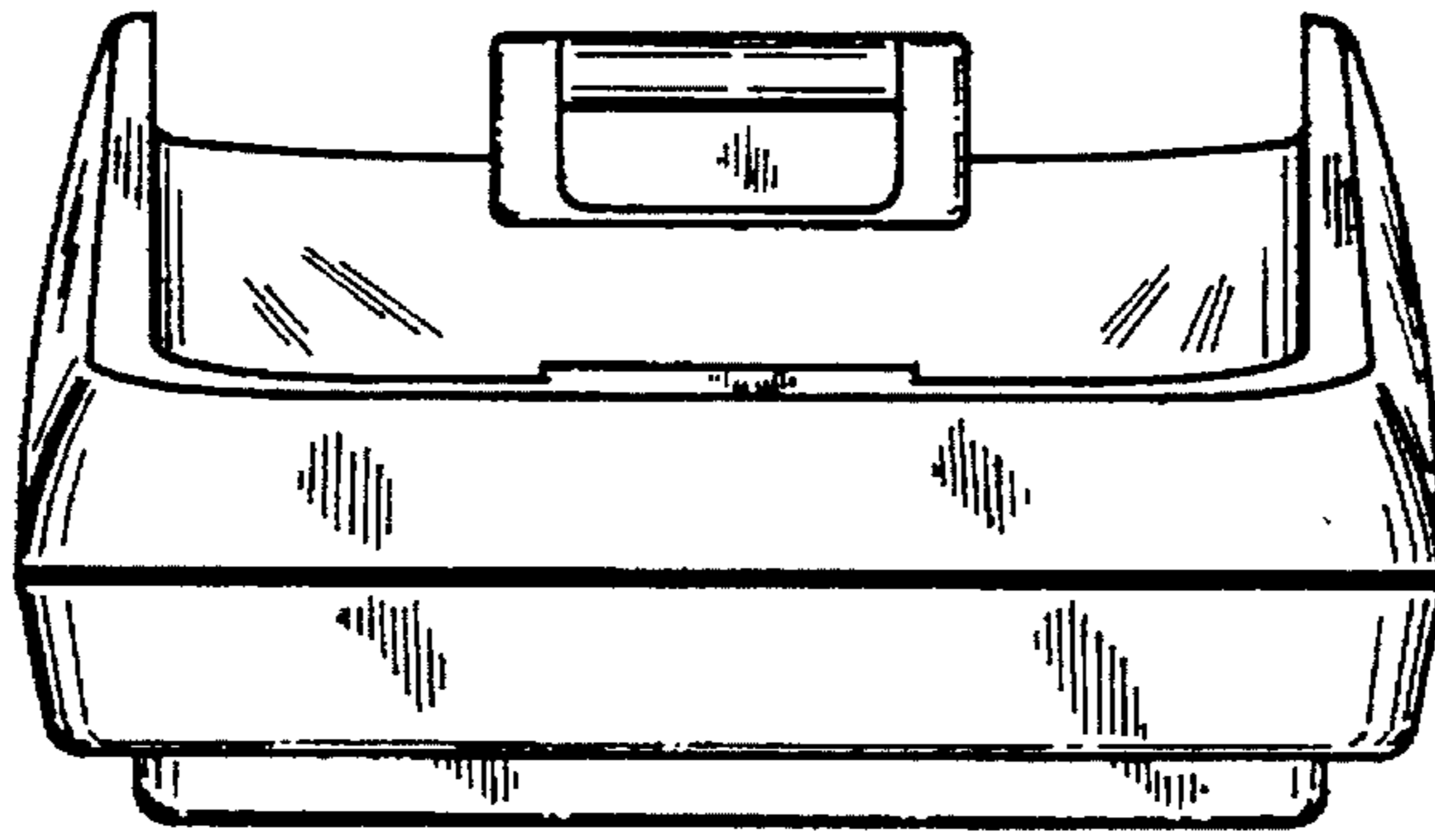

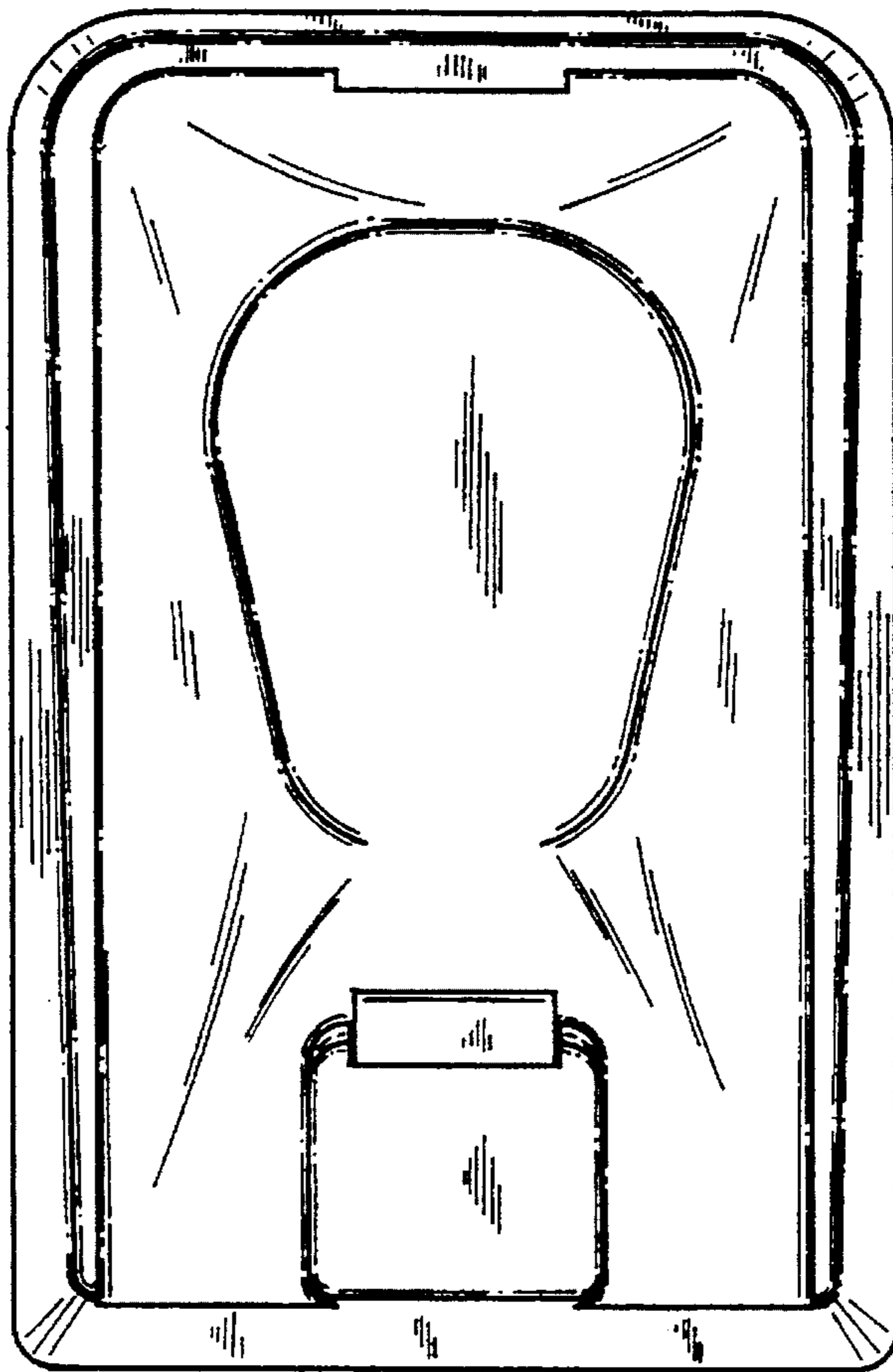

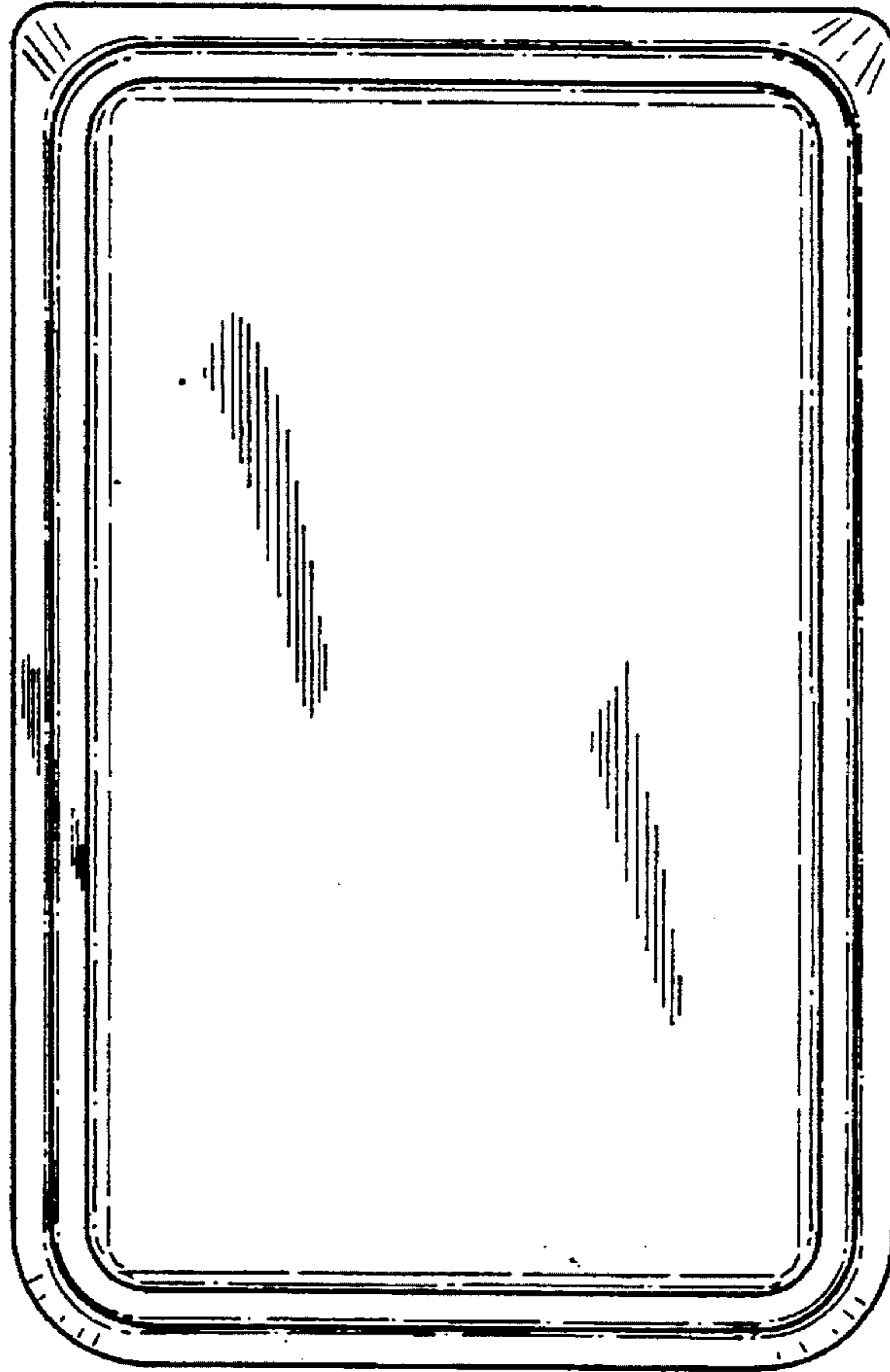
