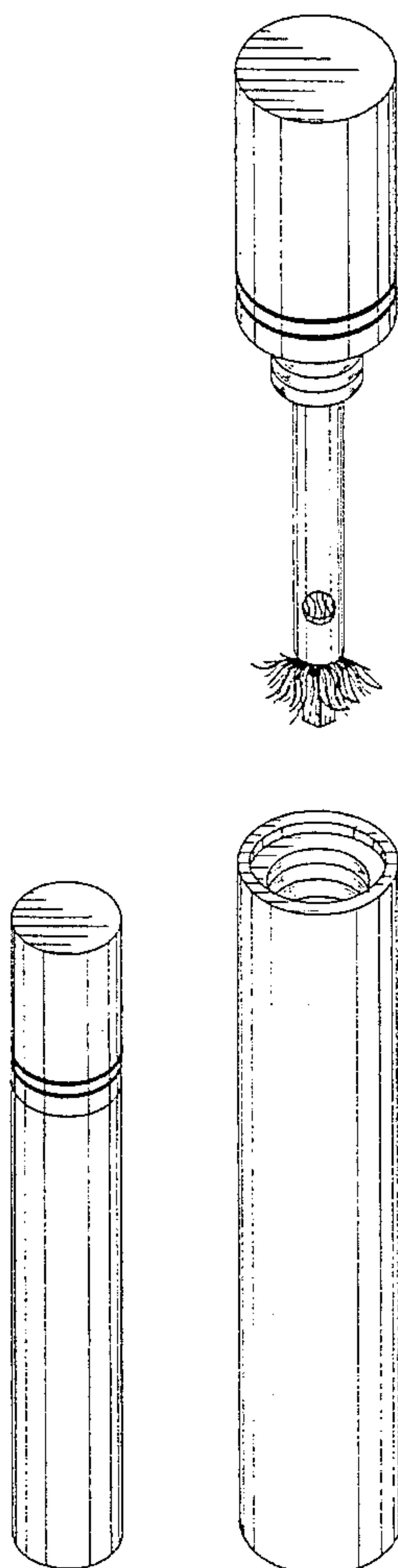
[57] **CLAIM**

The ornamental design for a cigarette lighter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cigarette lighter showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a side elevational view thereof;  
FIG. 6 is an elevational view of the opposite side from that shown in FIG. 5;  
FIG. 7 is a rear elevational view thereof; and,  
FIG. 8 is exploded perspective view showing the lighter after the lightable component thereof has been withdrawn from the lighter housing.

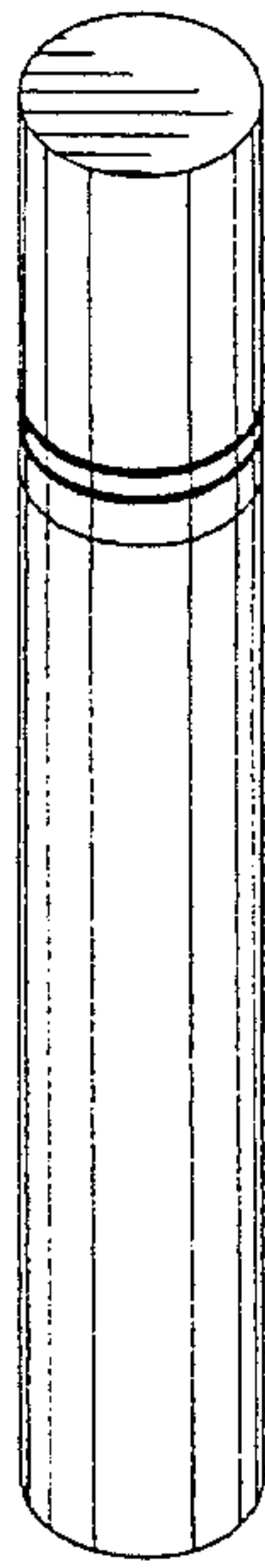

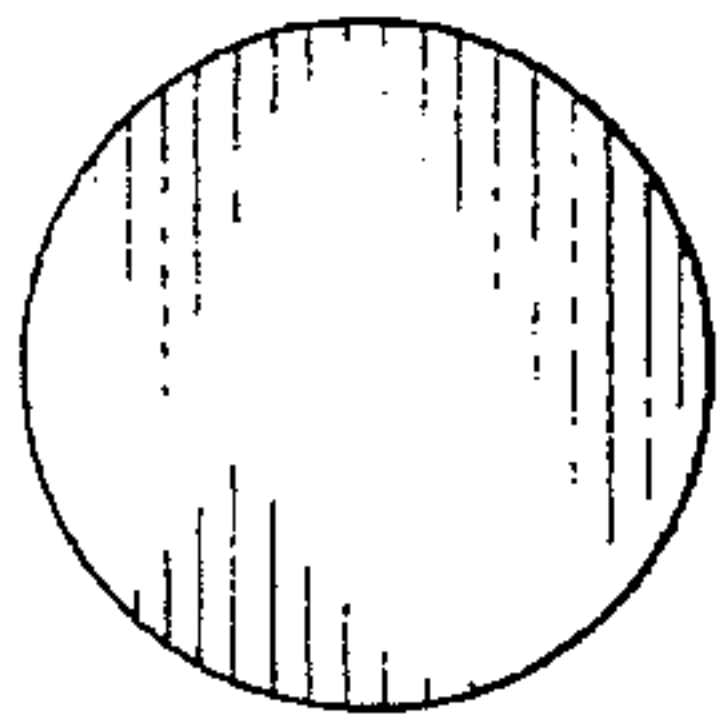

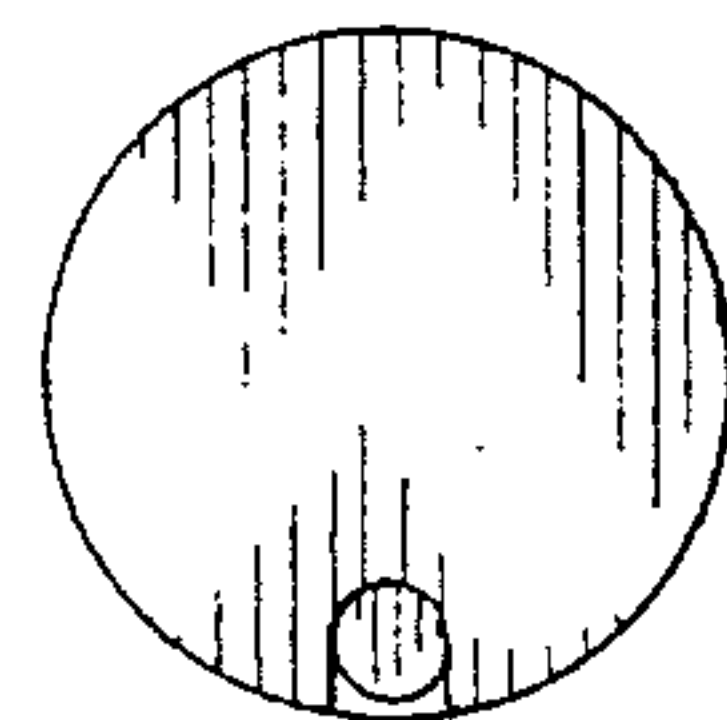

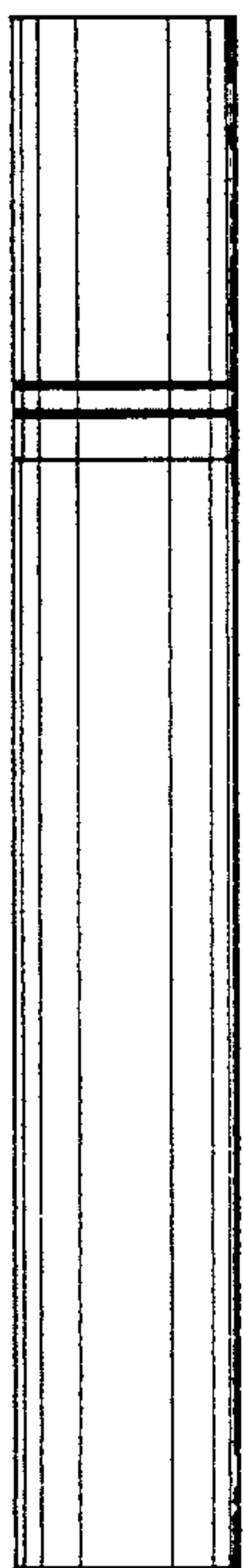

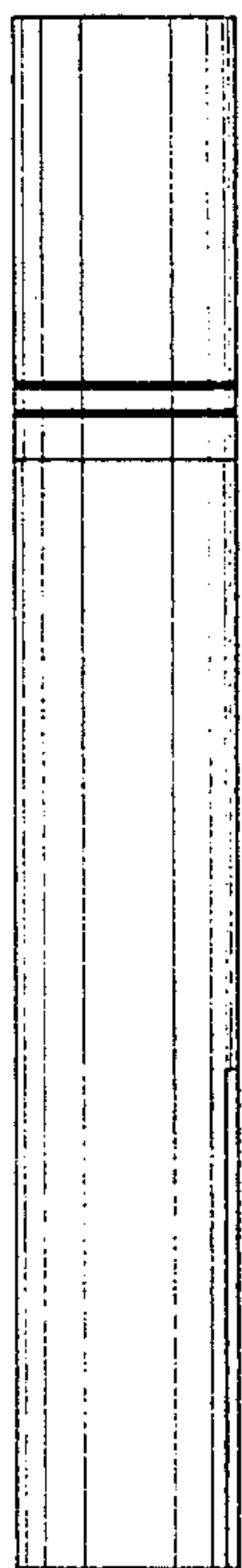

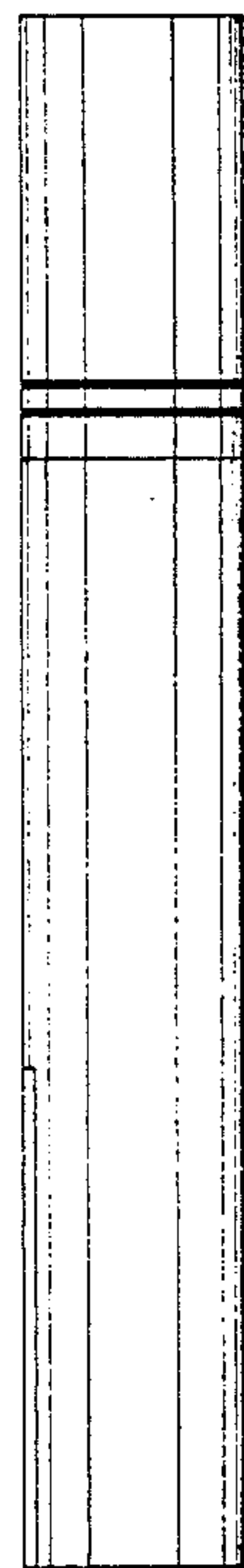

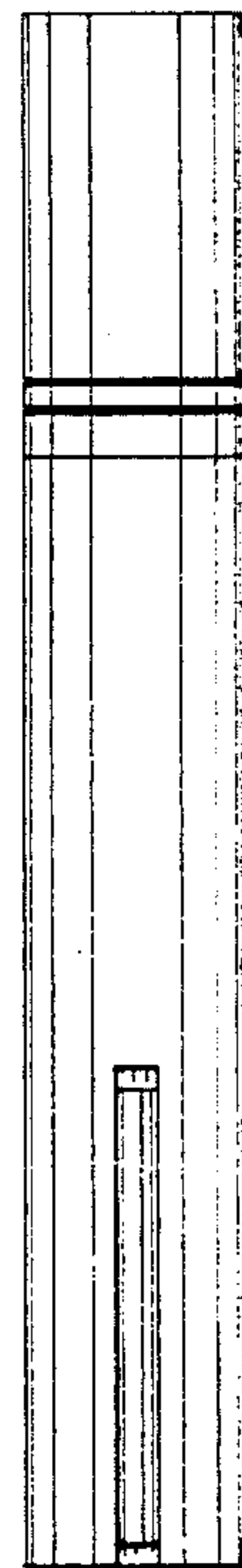

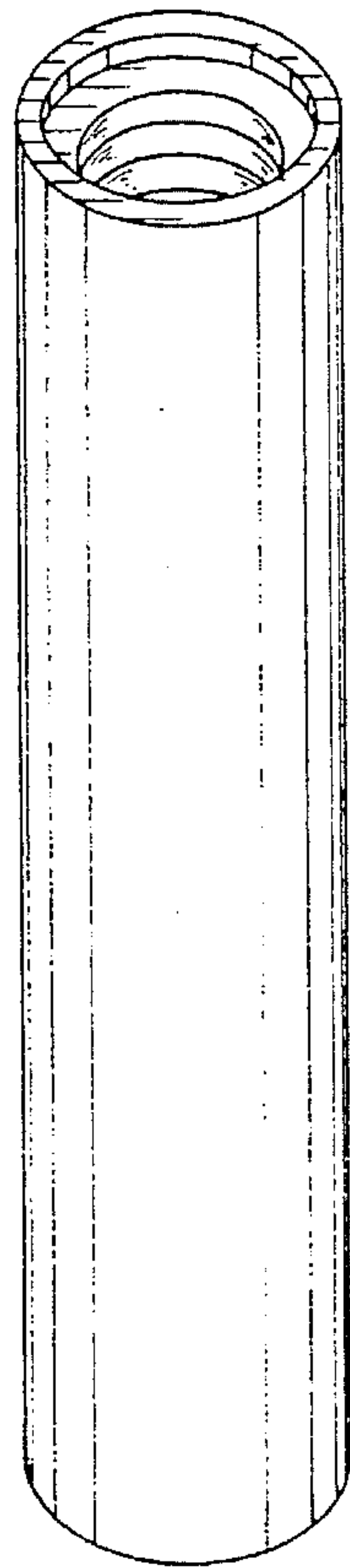
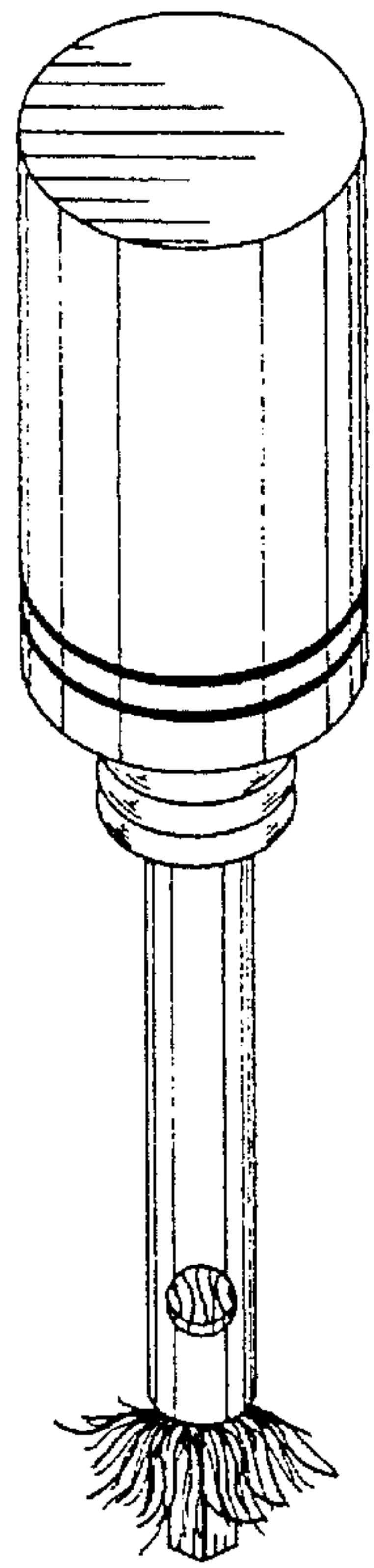
