The ornamental design for a hat for displaying sports or other cards, as shown and described.

DESCRIPTION

FIG. 1 shows a front view of a first embodiment of my new design;

FIG. 2 shows a right side elevational view thereof with the left side elevational view being a mirror image of FIG. 2;

FIG. 3 shows a top plan view thereof;

FIG. 4 shows a rear elevational view thereof;

FIG. 5 shows a bottom plan view thereof;

FIG. 6 is a front elevational view of a second embodiment the difference being the button on the top of the crown;

FIG. 7 shows a right side elevational view thereof with the left side elevational view being a mirror image of FIG. 7;

FIG. 8 shows a top plan view thereof;

FIG. 9 shows a rear elevational view thereof;

FIG. 10 shows a bottom plan view thereof;

FIG. 11 is a front elevational view of a third embodiment, the difference being the geometric shape on the front crown;

FIG. 12 shows a right side elevational view thereof with the left side elevational view being a mirror image of FIG. 12;

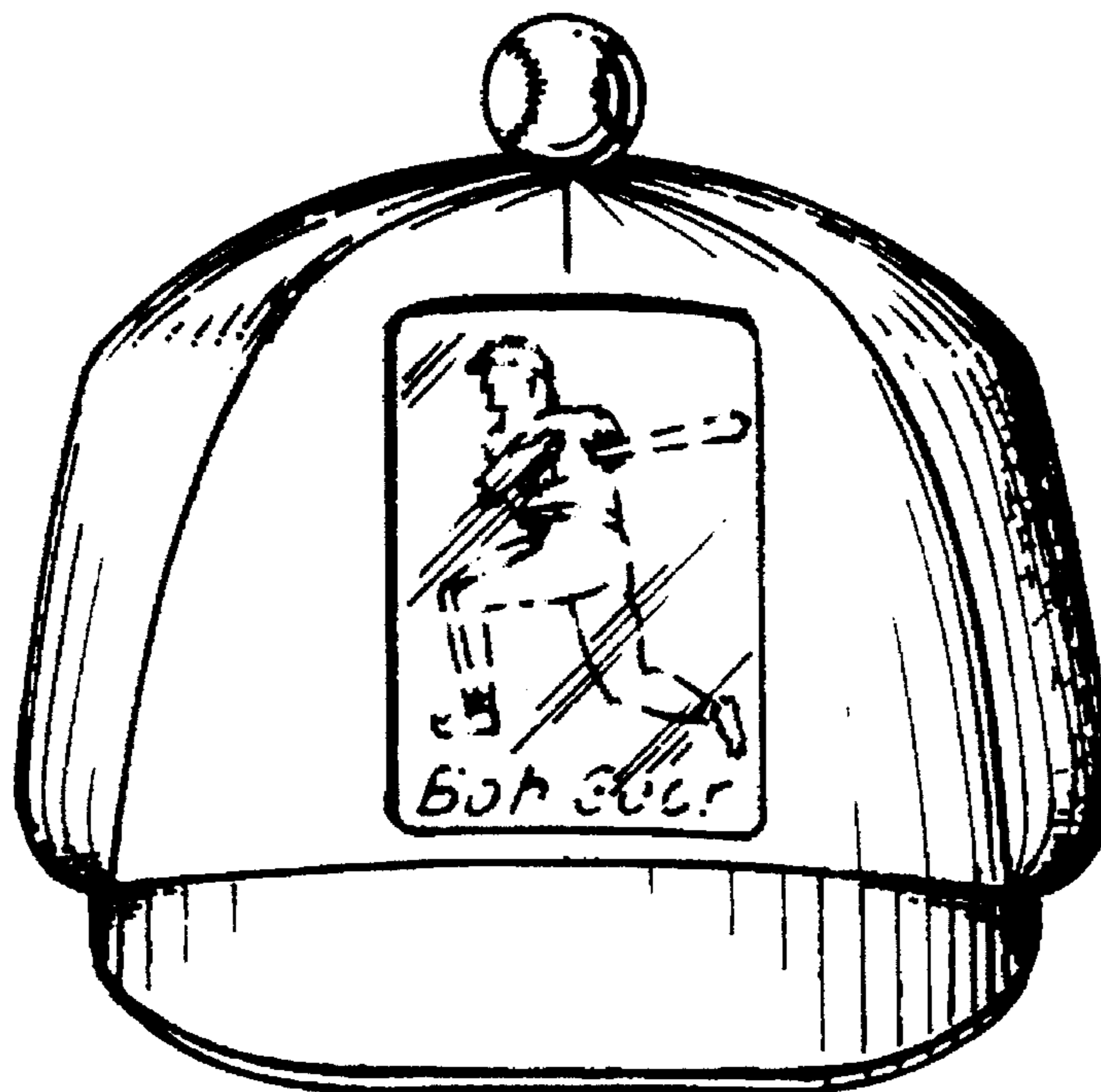
FIG. 13 shows a top plan view thereof;

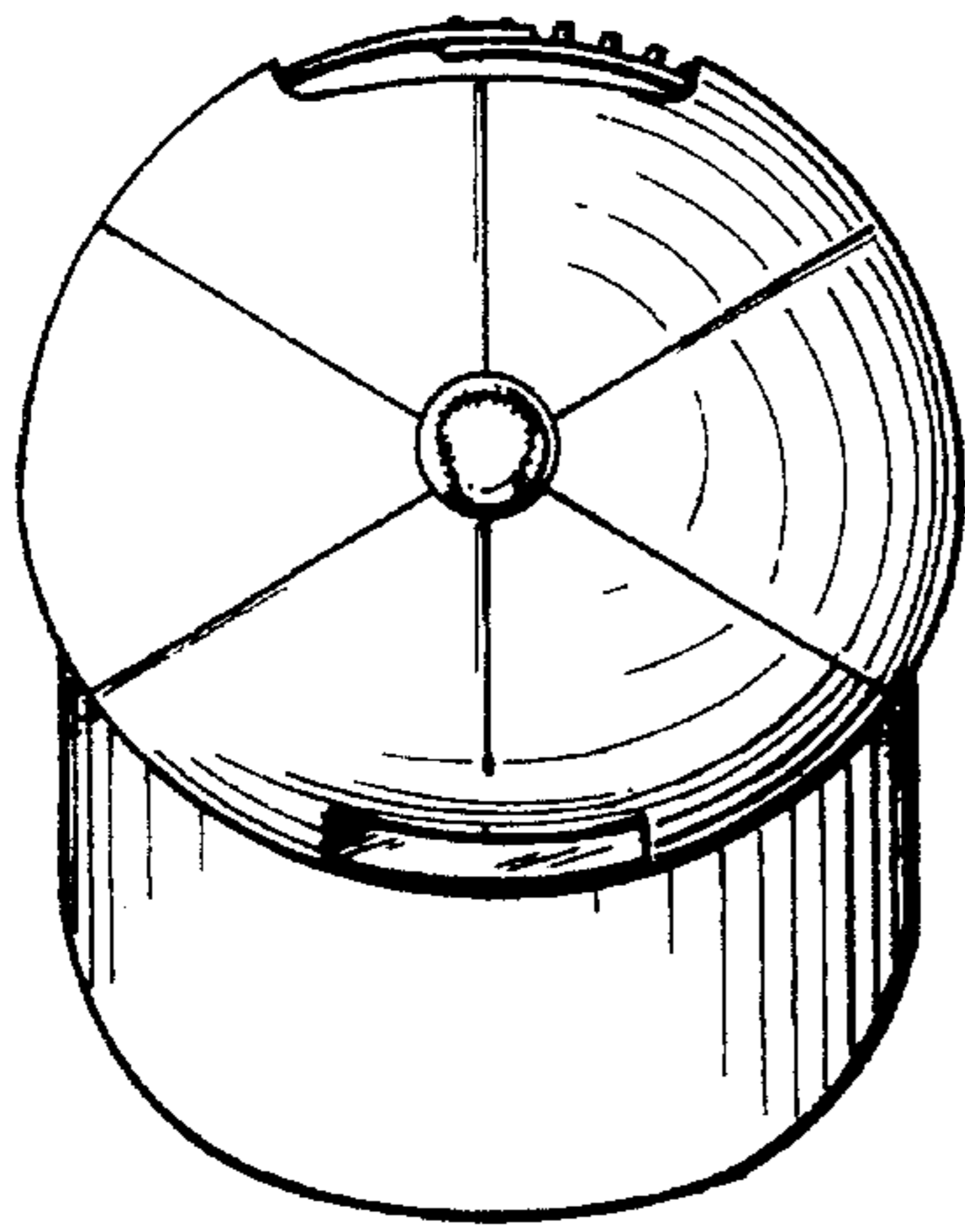

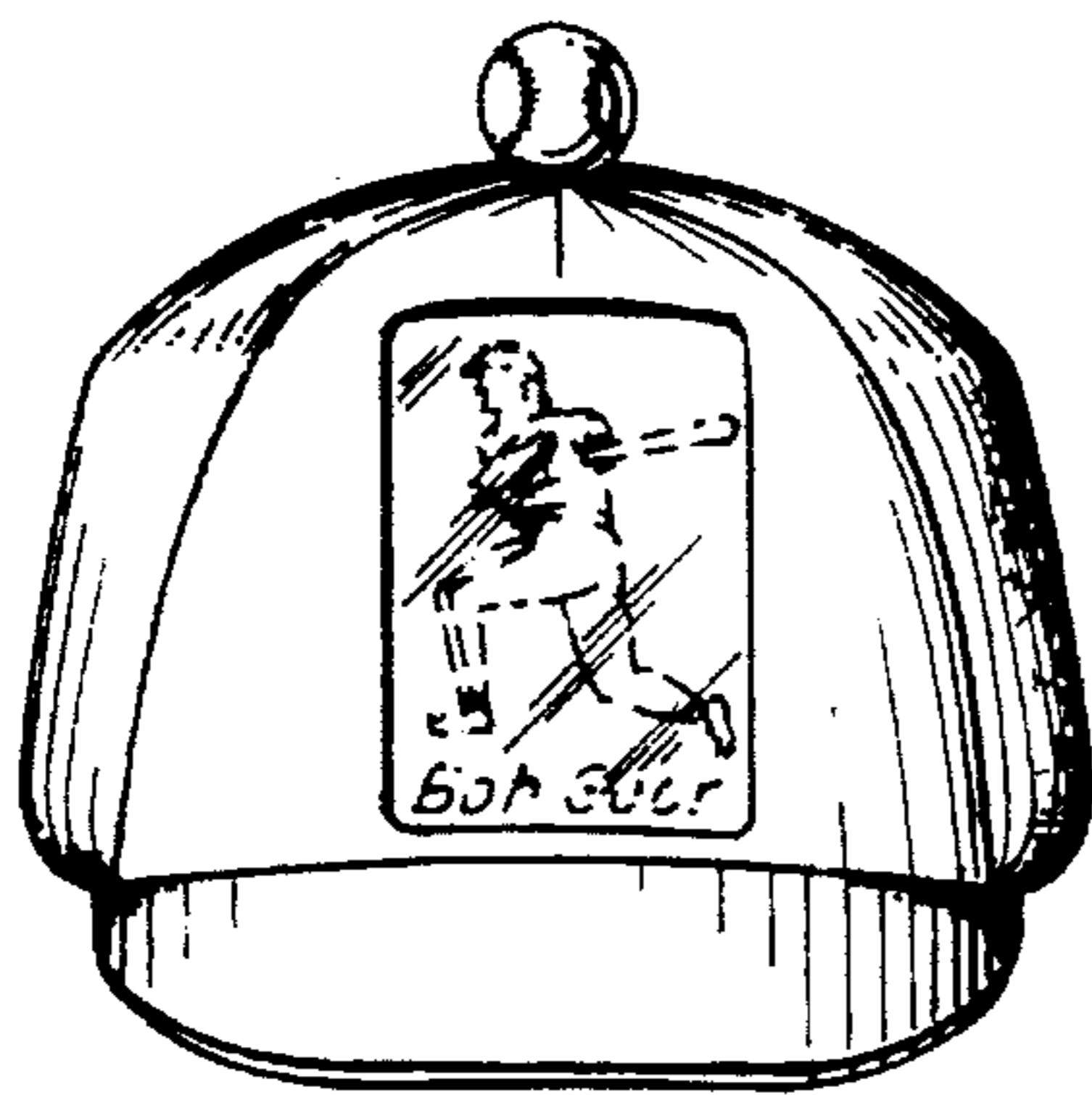

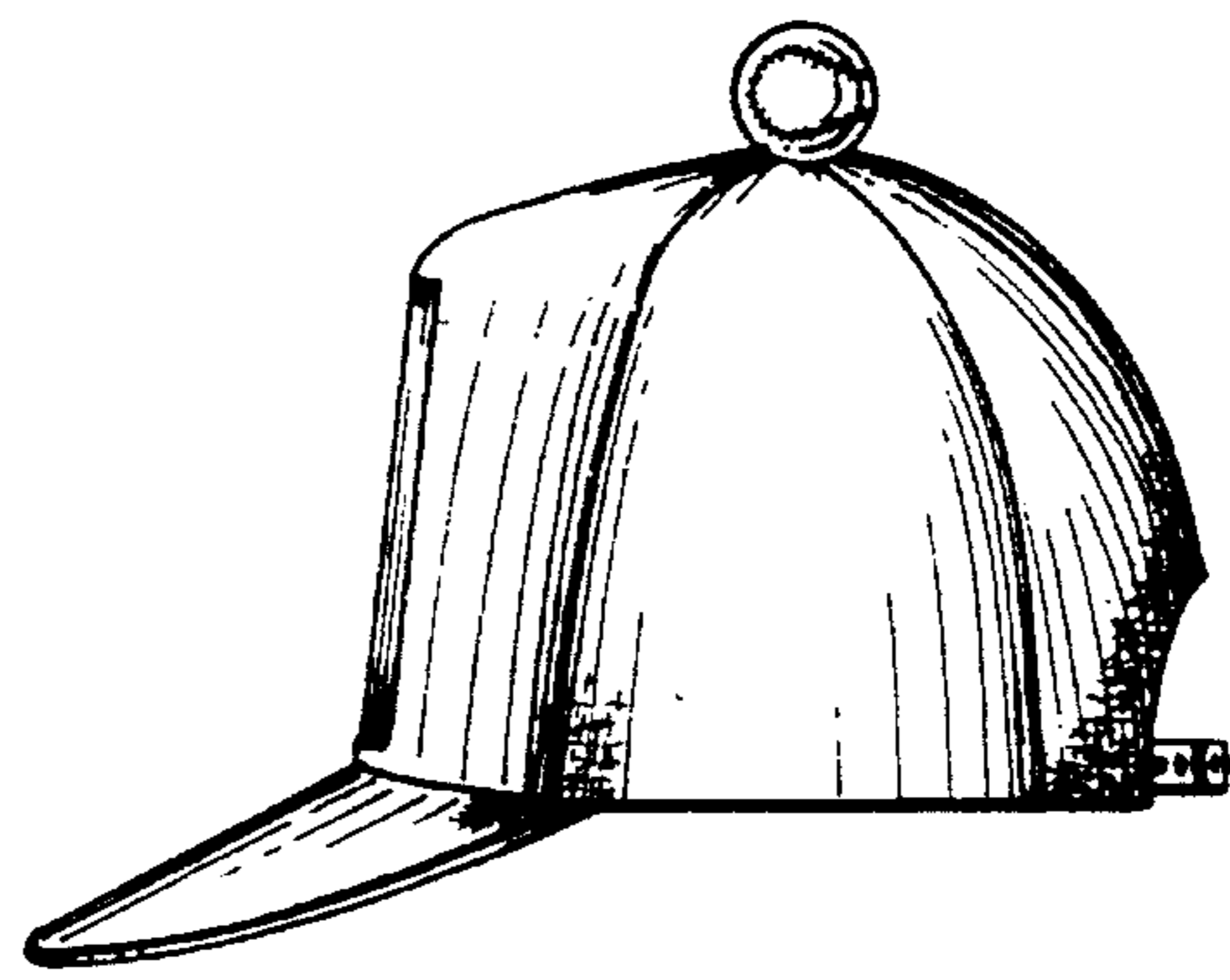

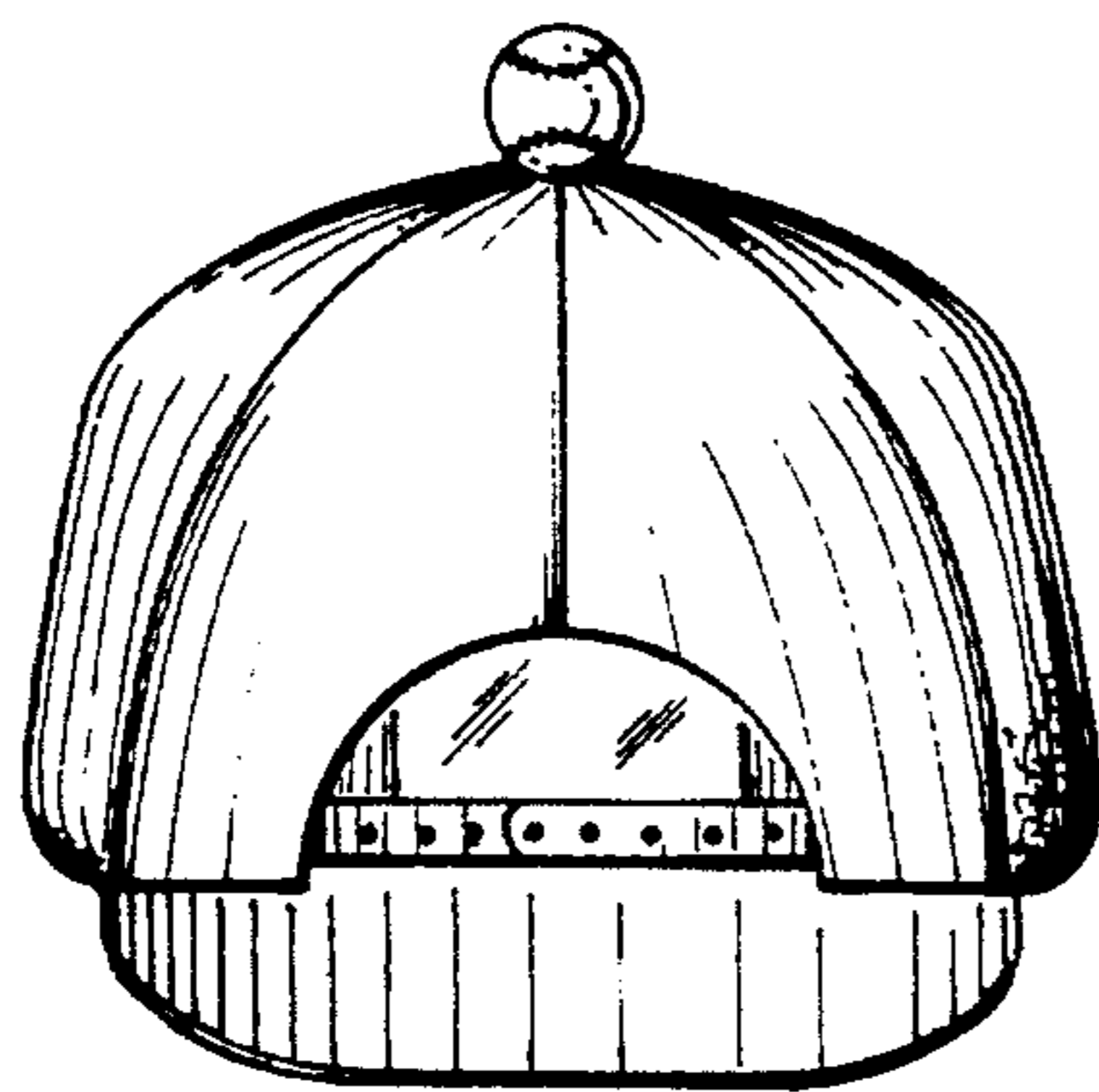

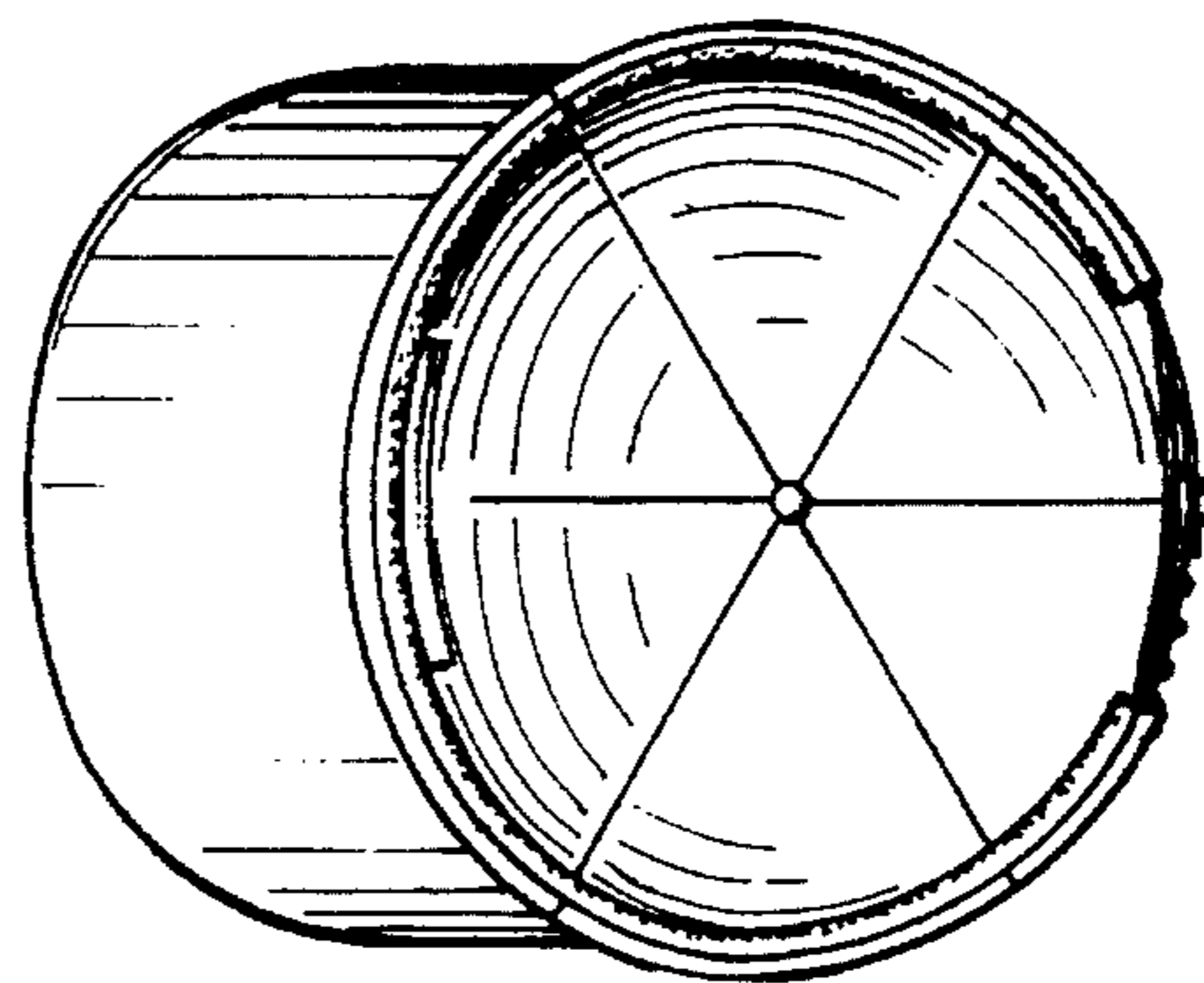

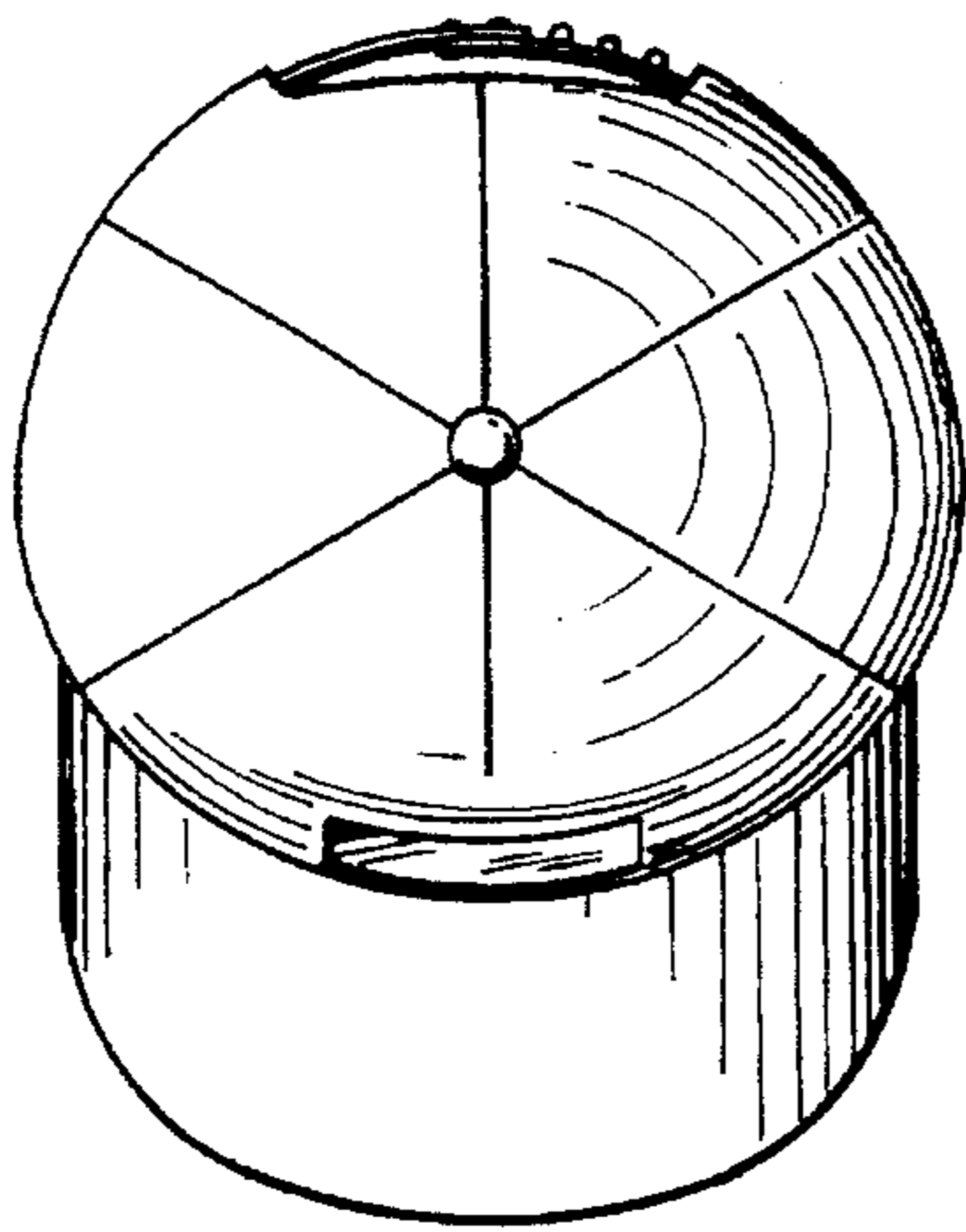

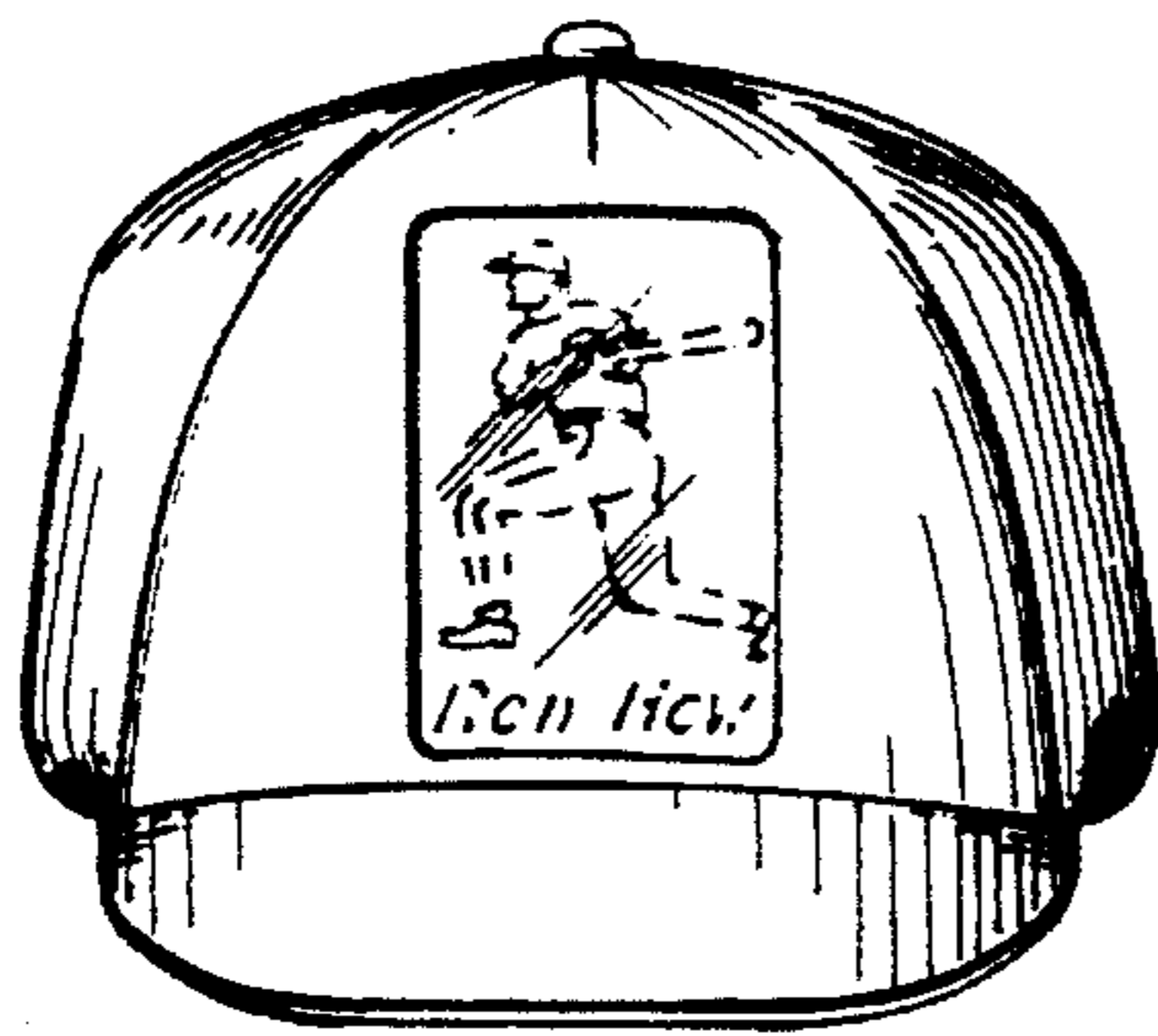

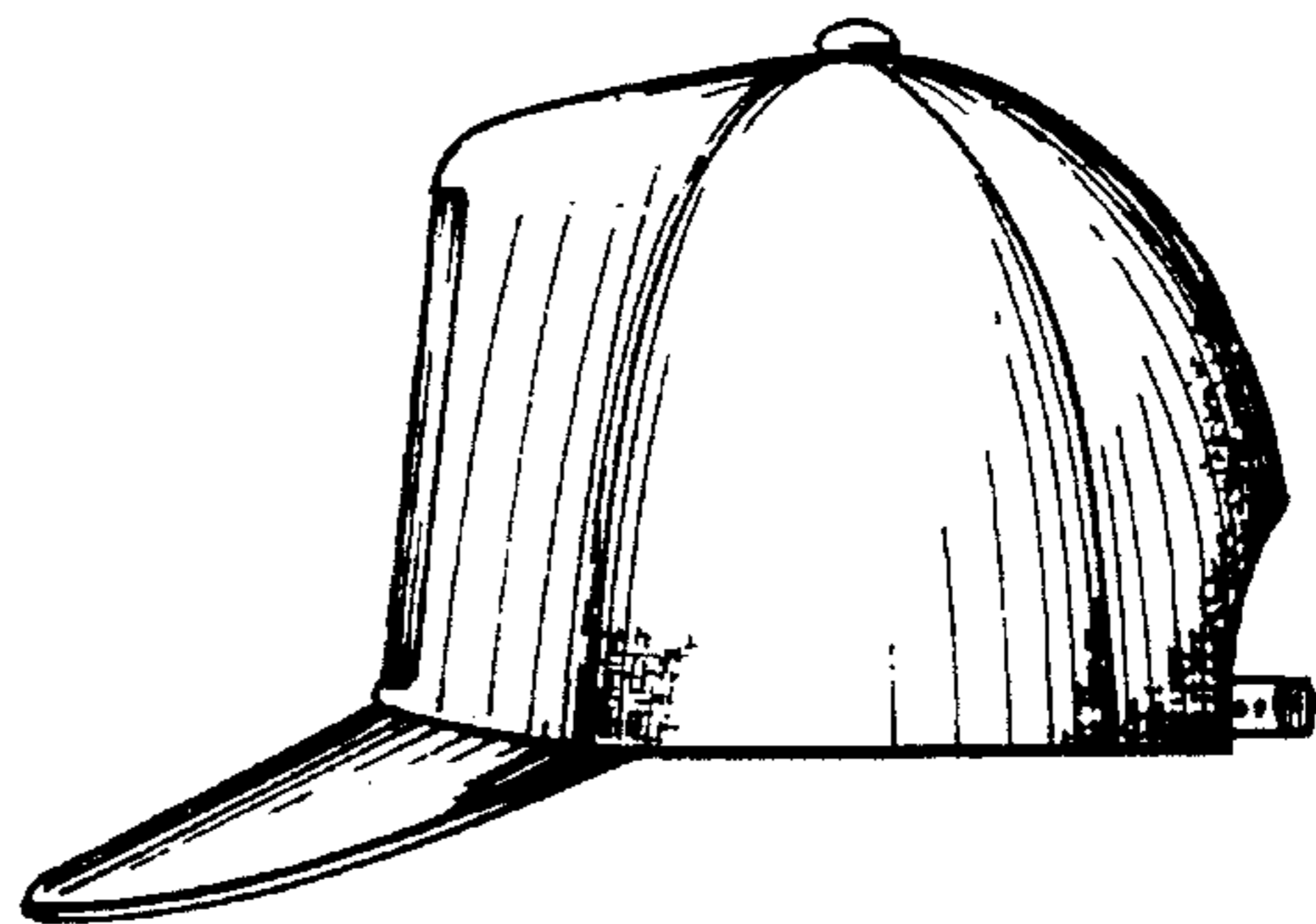

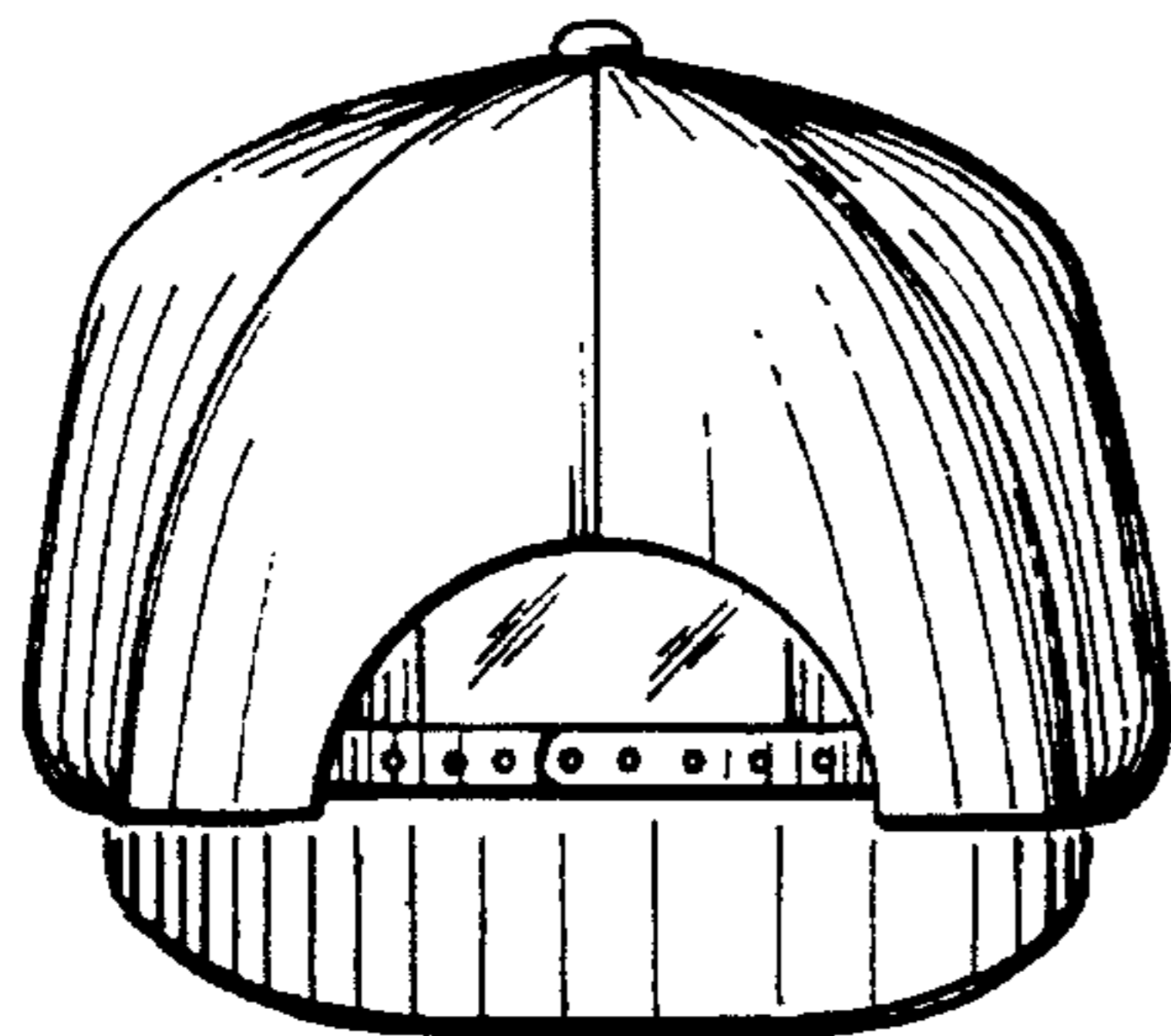

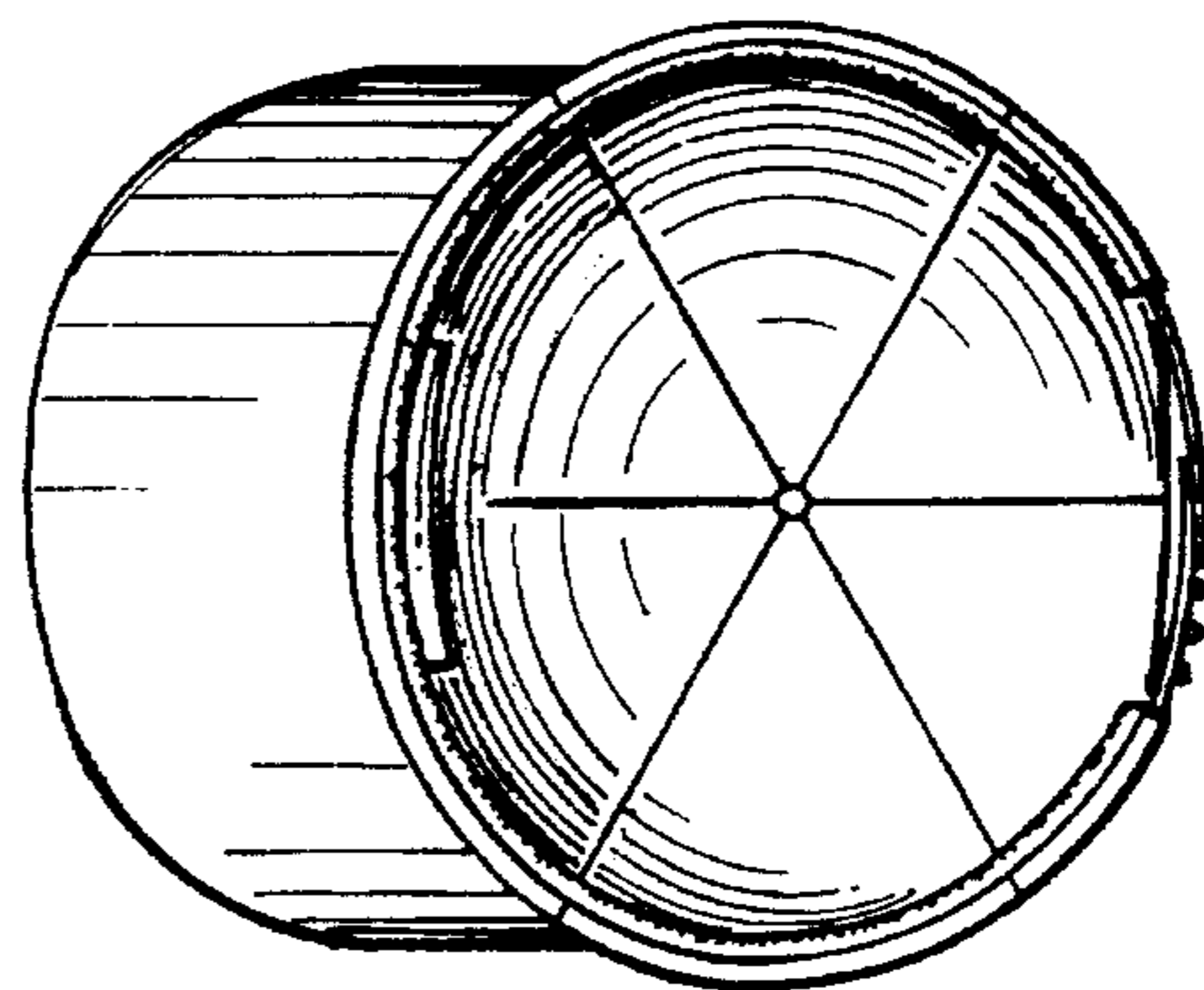

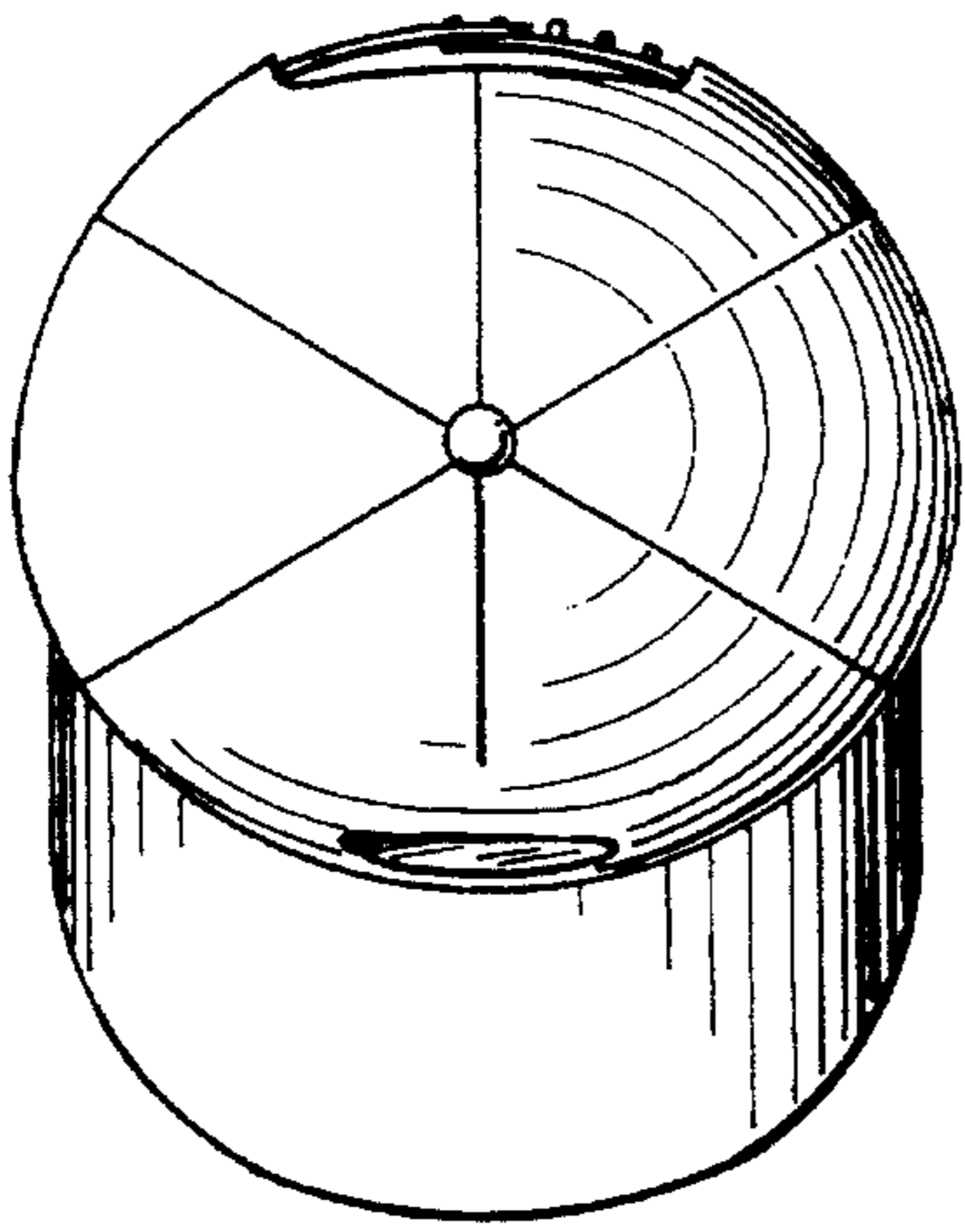

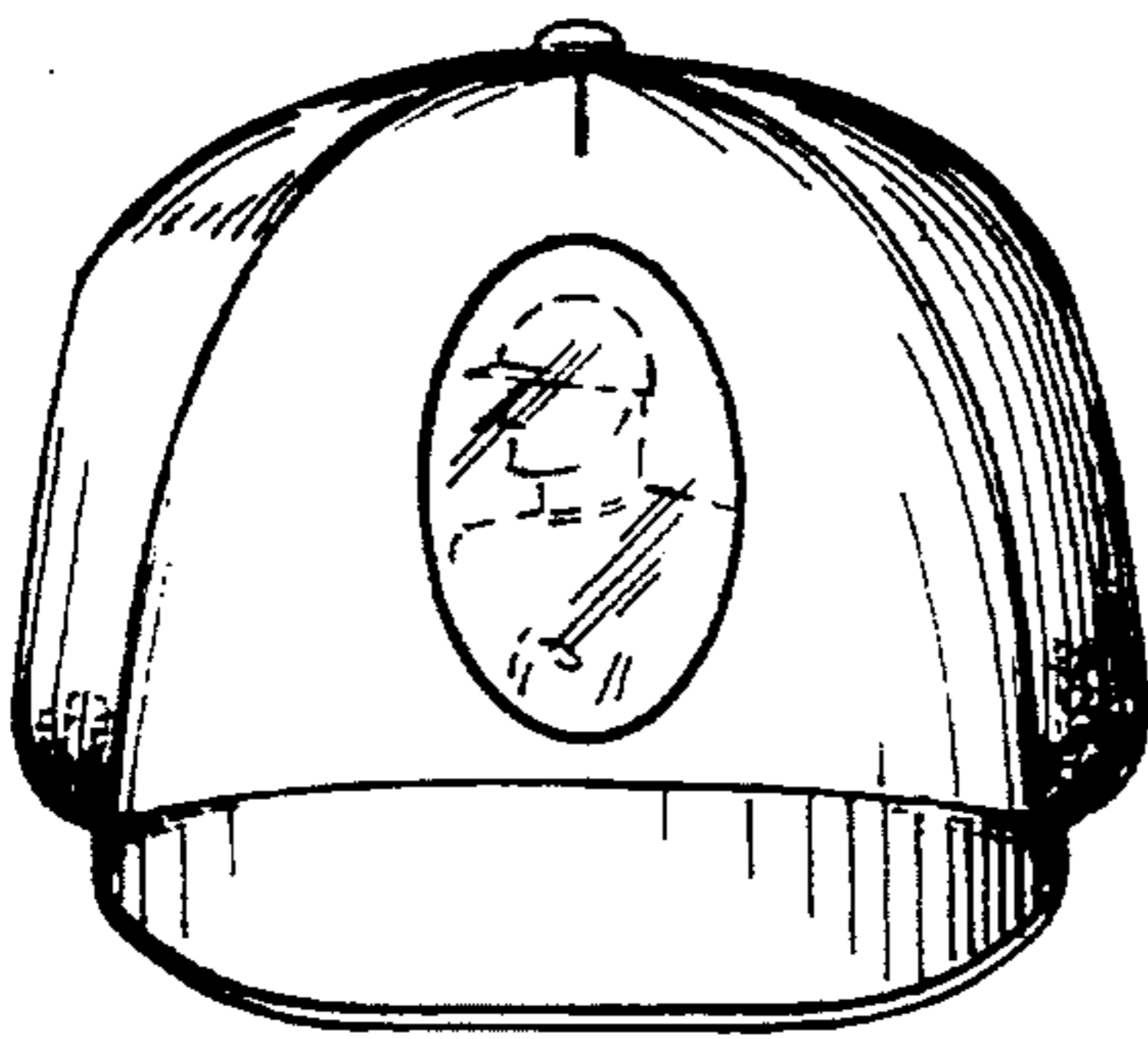

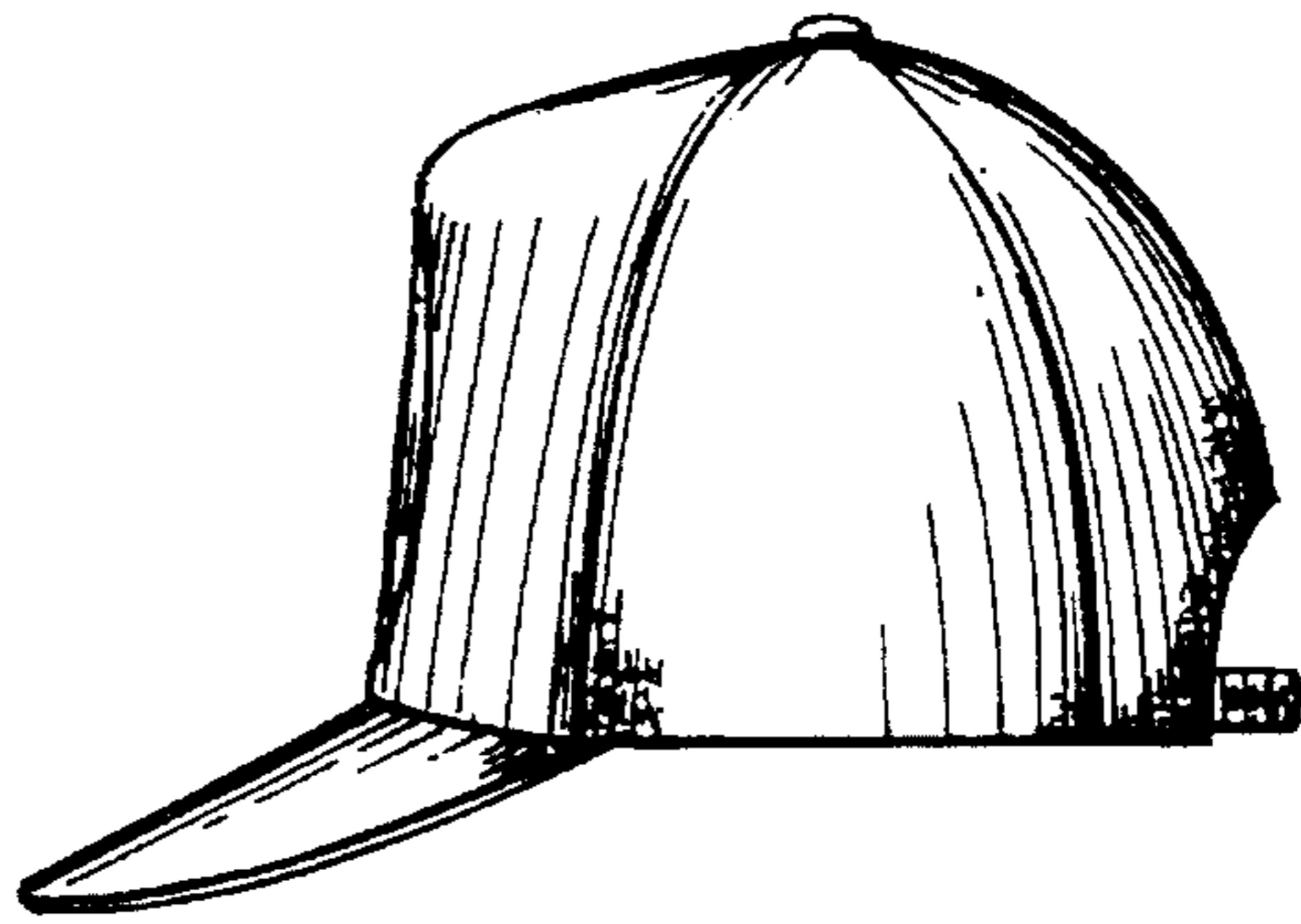

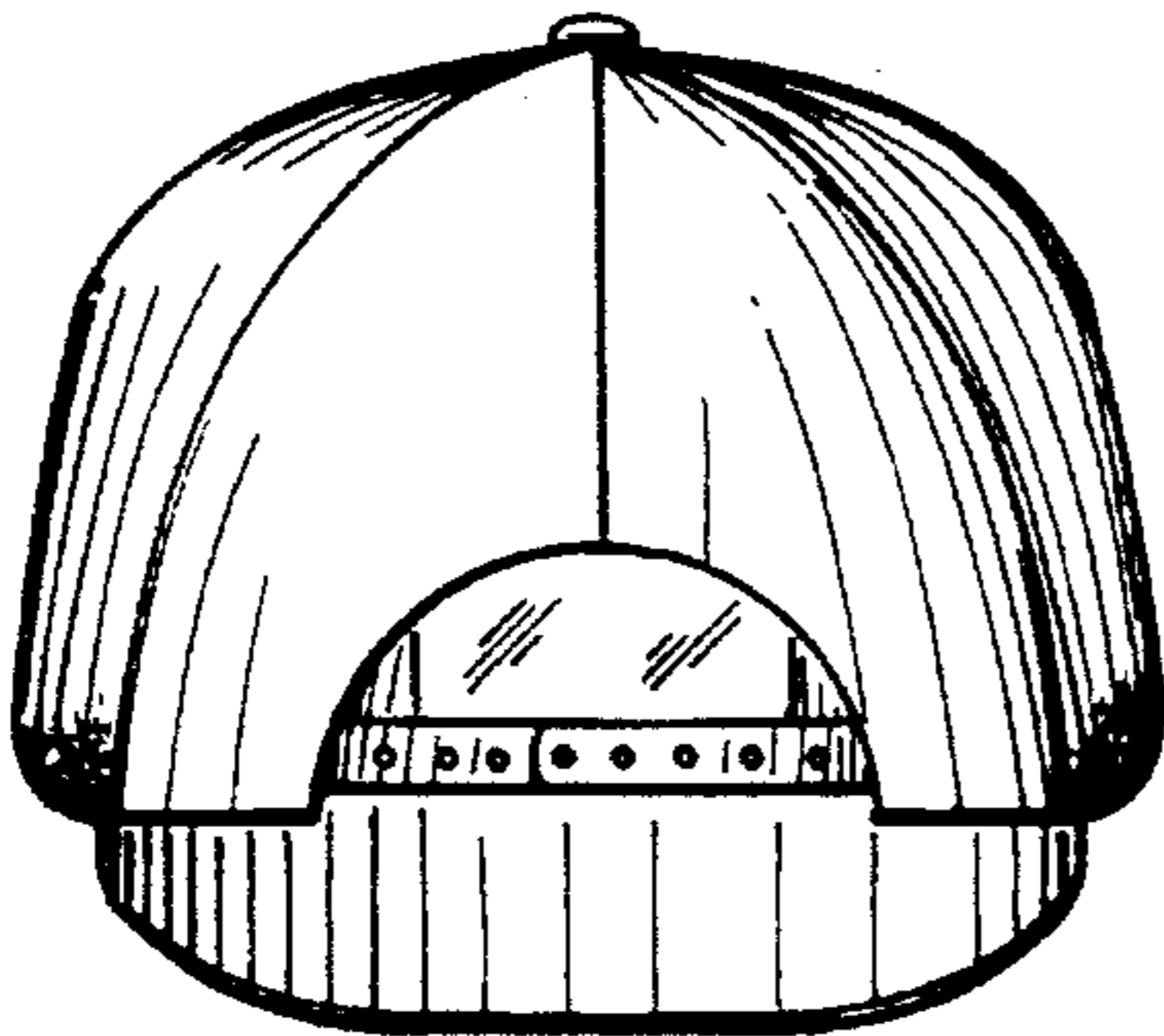

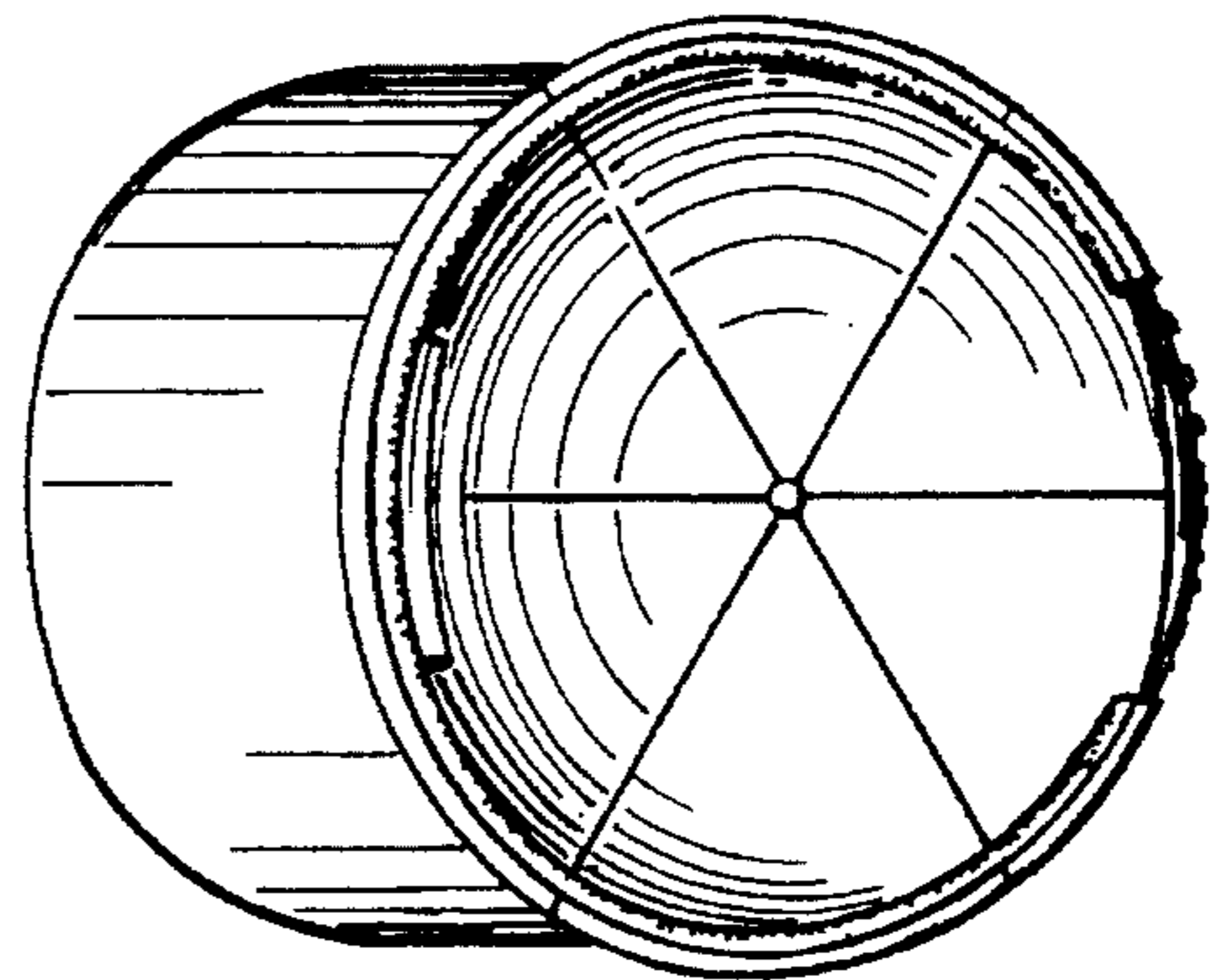
