## DESCRIPTION

FIG. 1 is a perspective view of a screen according to the present invention;

FIG. 2 is a side view of the screen of the FIG. 1;

FIG. 3 is a side view opposite the side of FIG. 2 of the screen of FIG. 1;

FIG. 4 is an end view of the screen of FIG. 1;

FIG. 5 is an end view of an end opposite the end of FIG. 4 of the screen of FIG. 1;

FIG. 6 is a top view of the screen of FIG. 1;

FIG. 7 is a perspective view of a screen according to the present invention;

FIG. 8 is a top view of the screen of FIG. 7;


FIG. 9 is a side view of one side of the screen of FIG. 7;

FIG. 10 is a side view of another side of the screen of FIG. 7;













