### DESCRIPTION

FIG. 1 is a front elevational view of the musical rocking chair showing our new design;  
FIG. 2 is a rear elevational view thereof;

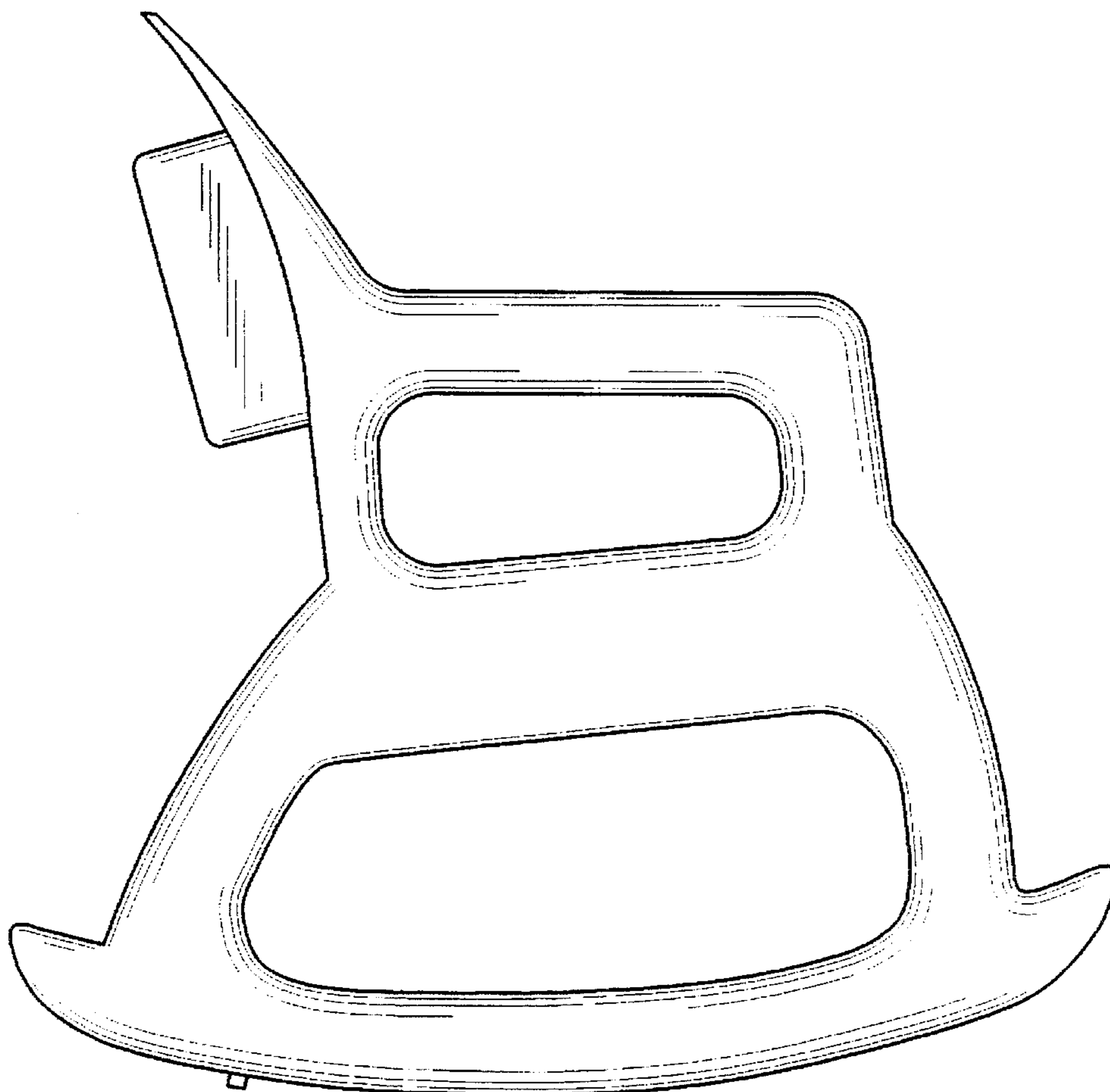

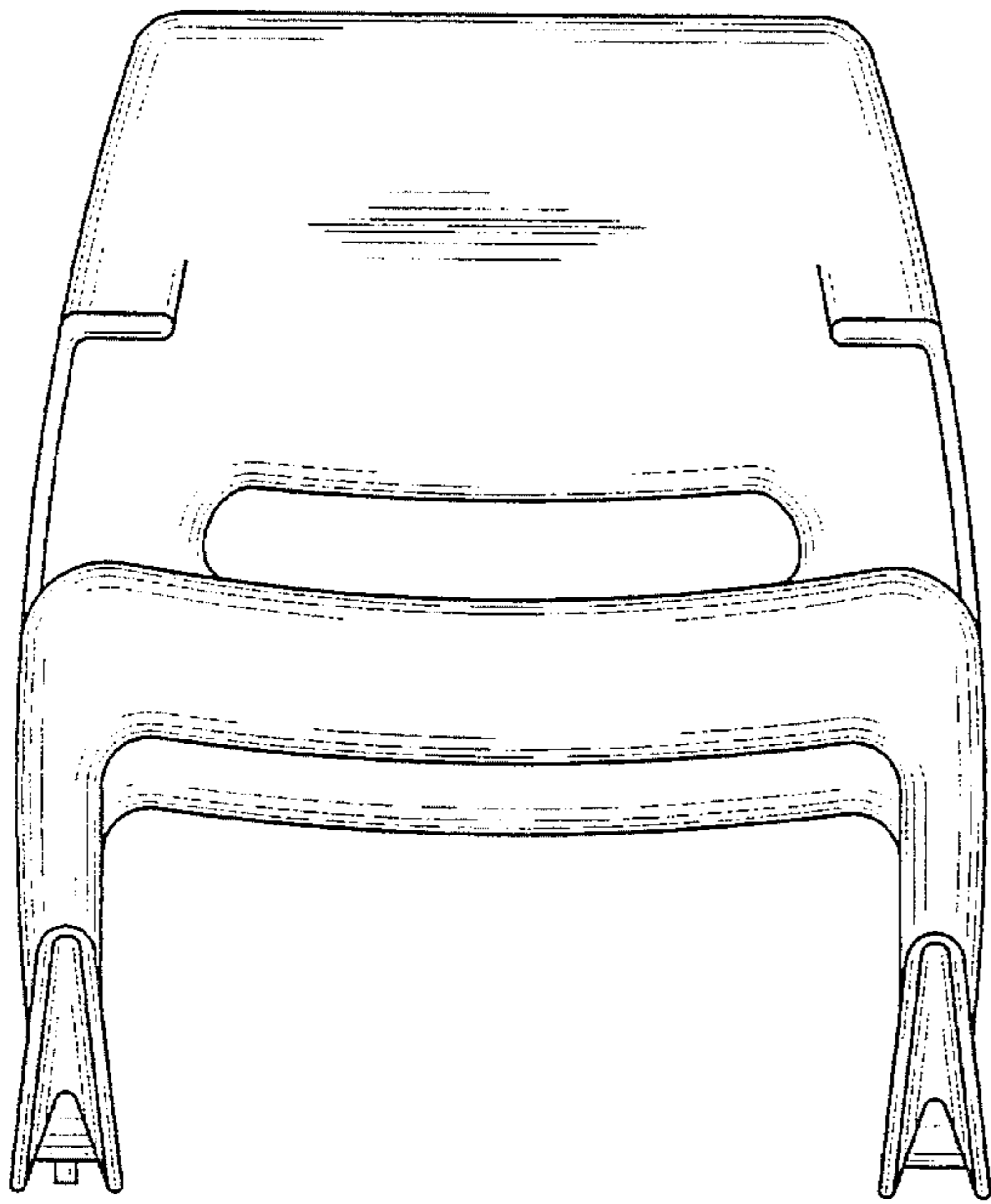

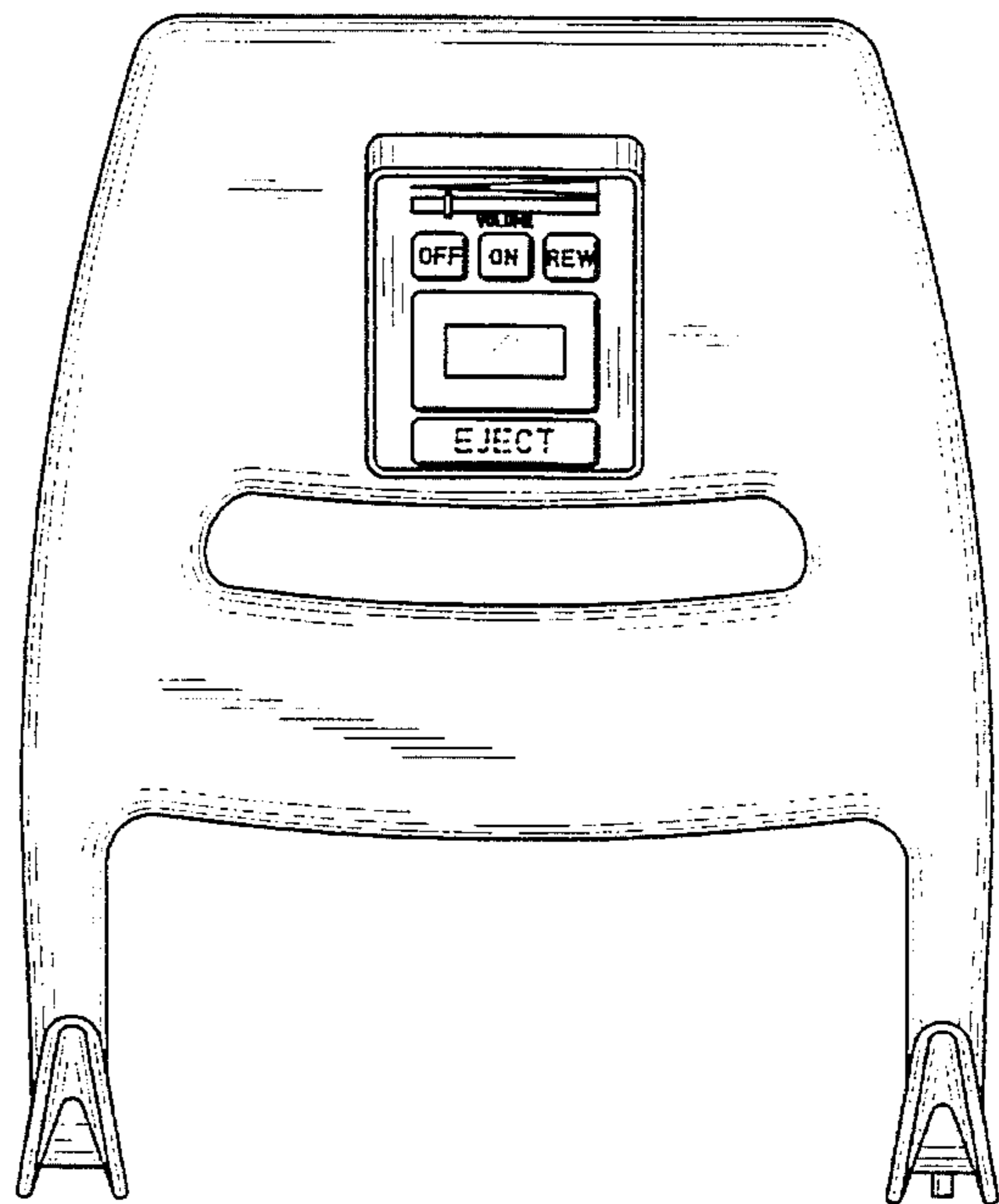

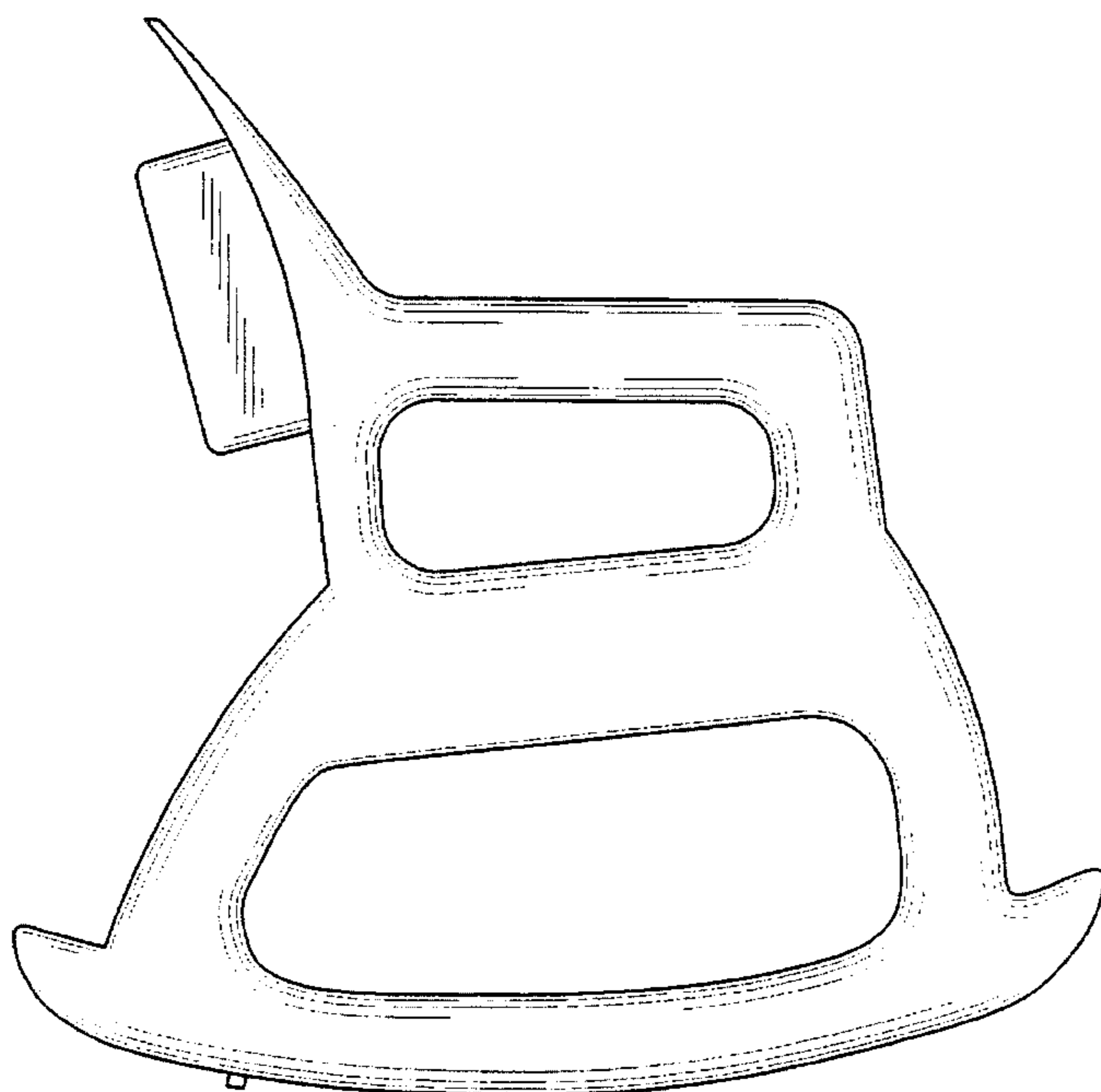

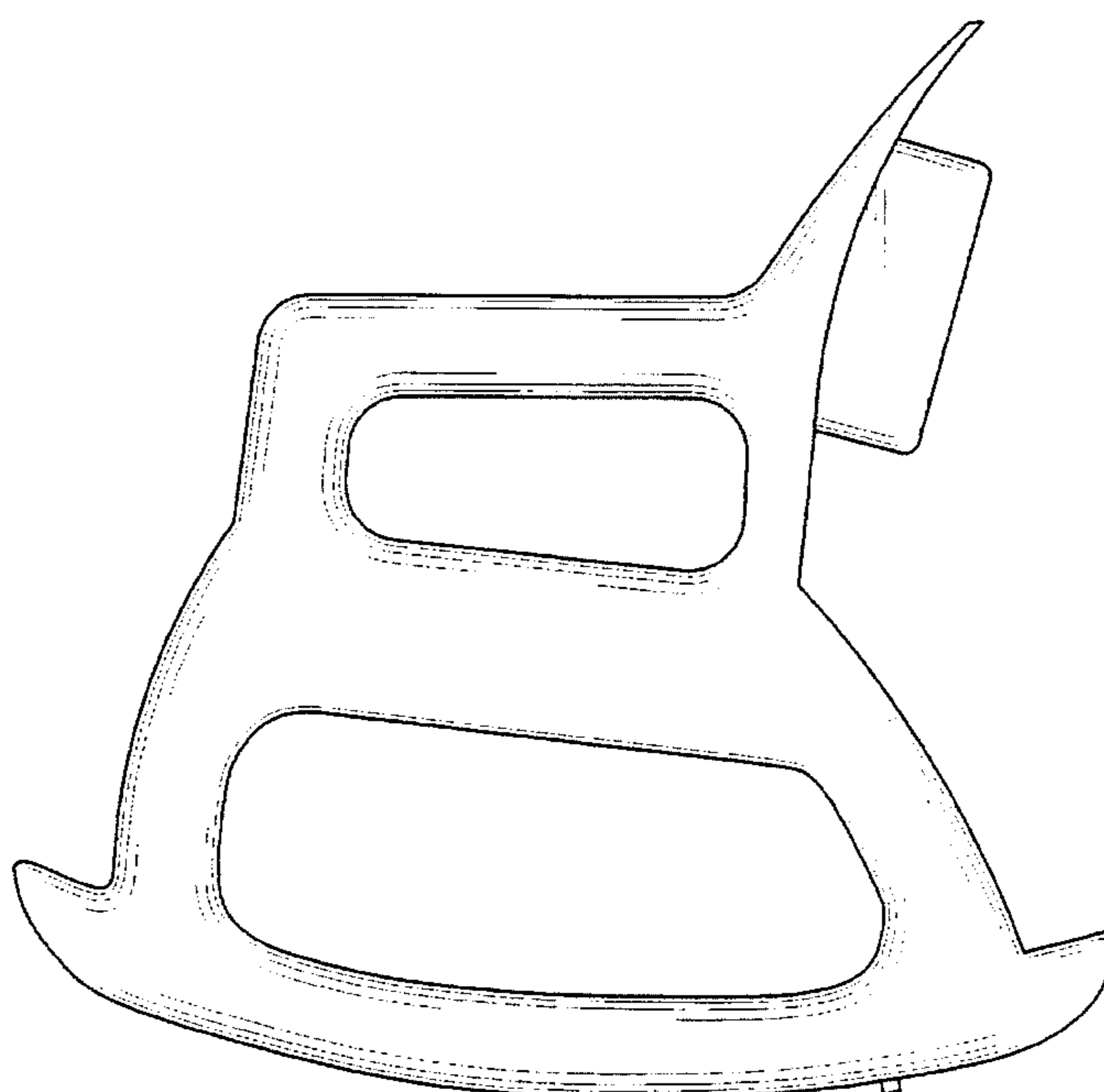

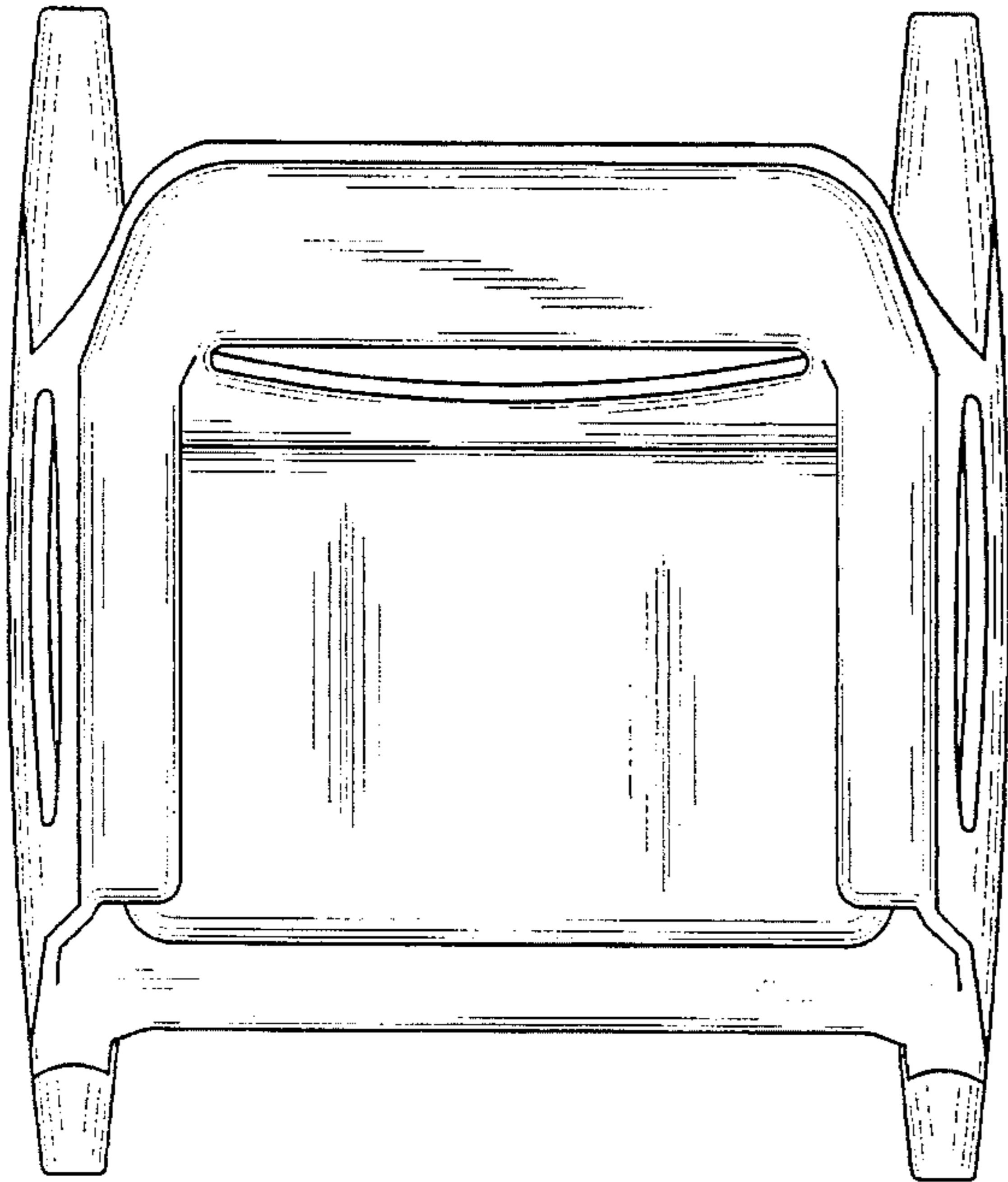
