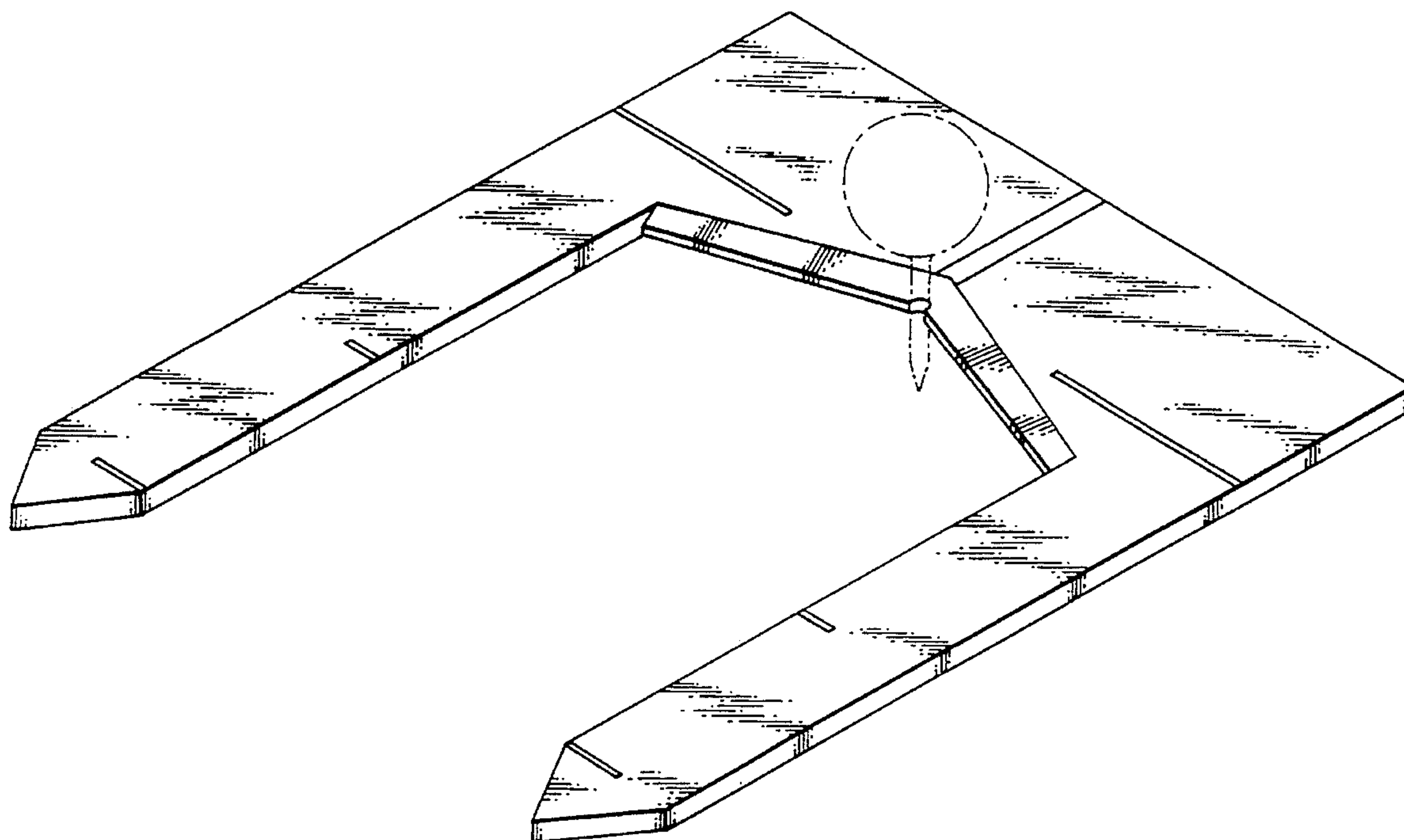

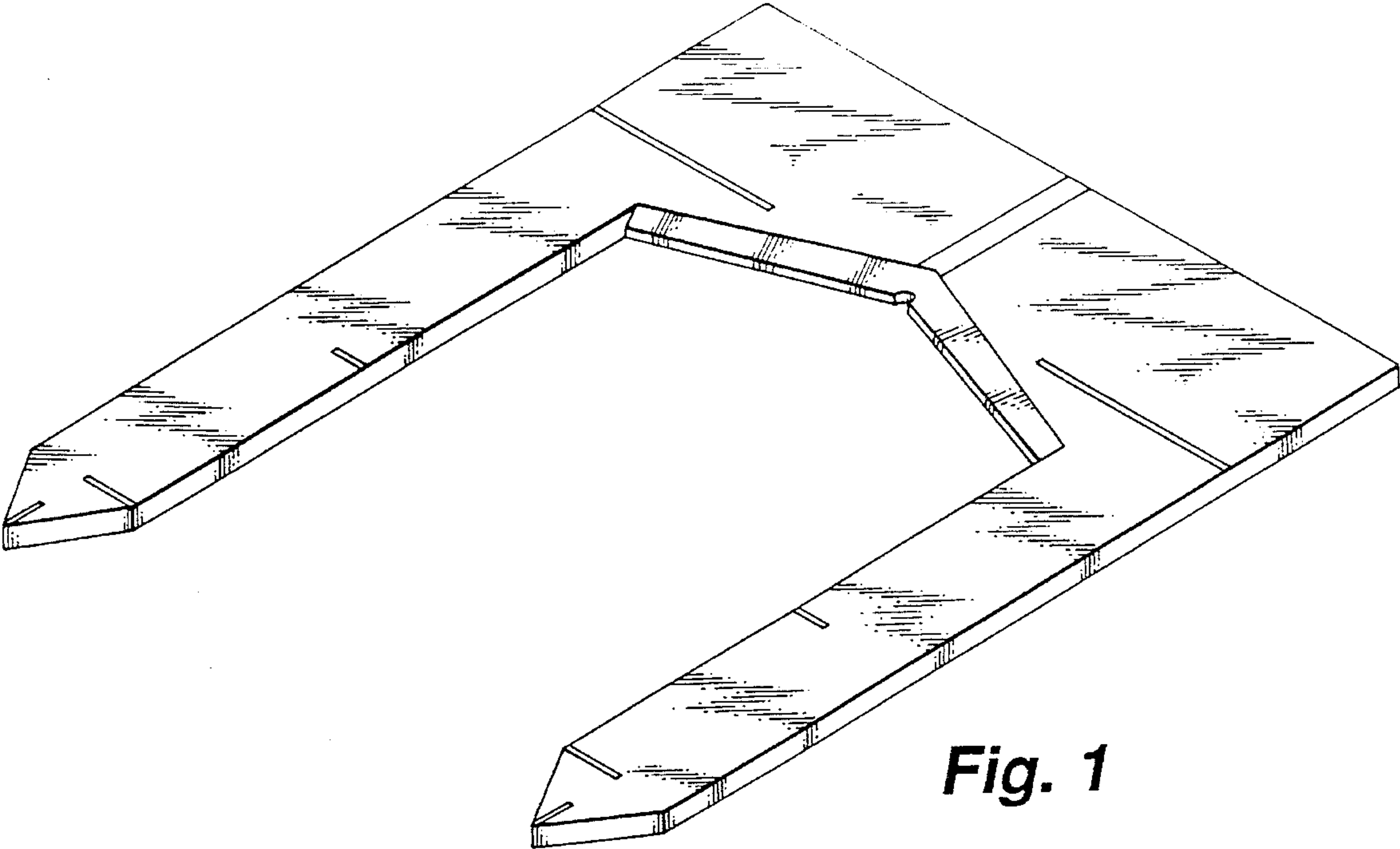
The ornamental design for a golf swing alignment mat, as shown and described.

**DESCRIPTION**

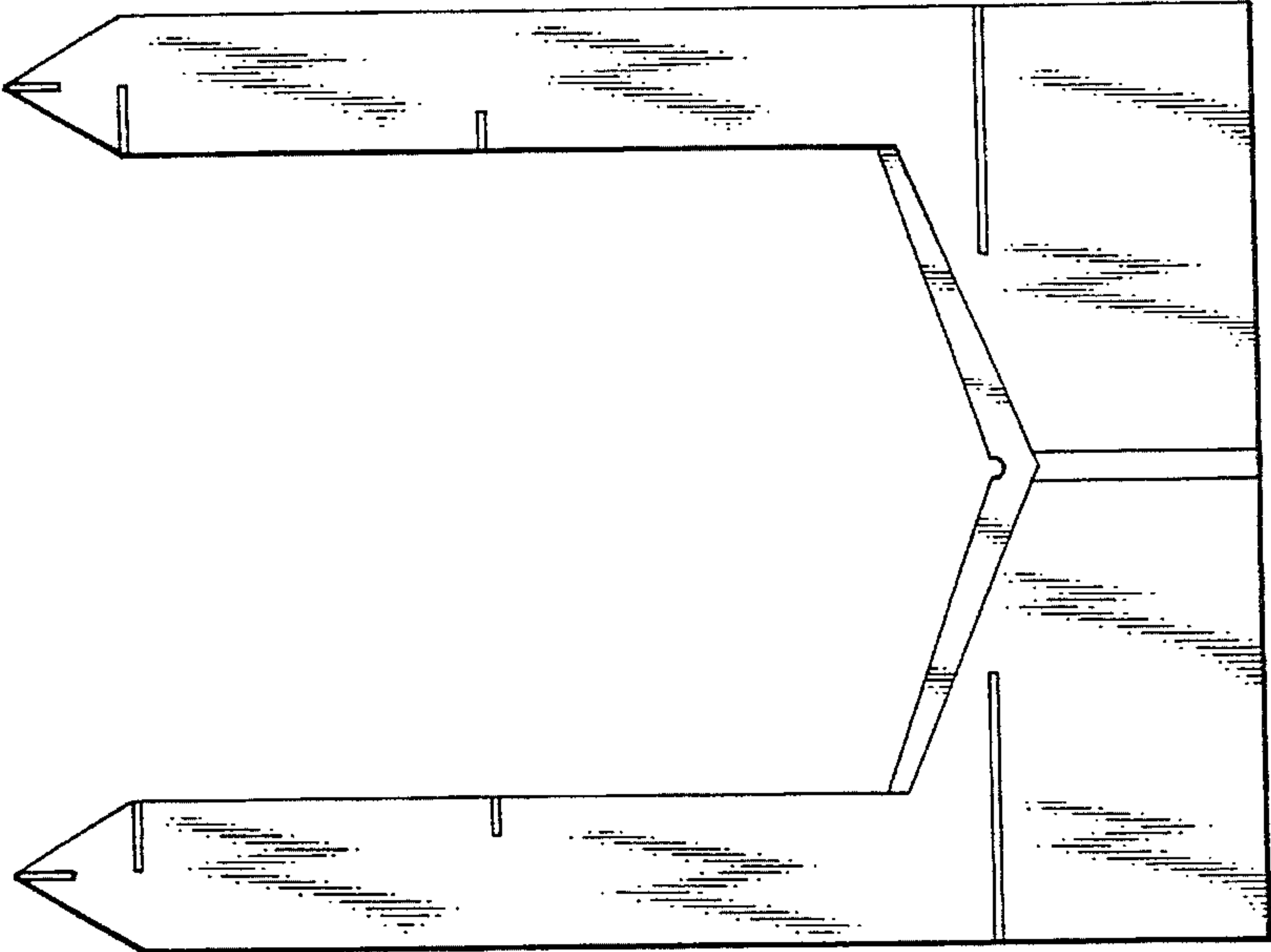
FIG. 1 is a left front perspective of a golf swing alignment mat, showing my new design;  
FIG. 2 is a top plan view, thereof;  
FIG. 3 is a side elevation view thereof, the opposite side being a mirror image;  
FIG. 4 is a front elevational view, thereof;  
FIG. 5 is a rear elevational view, thereof;  
FIG. 6 is a bottom plan view, thereof; and,  
FIG. 7 is a perspective view thereof, the broken line showing of the golf ball and tee is for illustrative purposes only and forms no part of the claimed design.

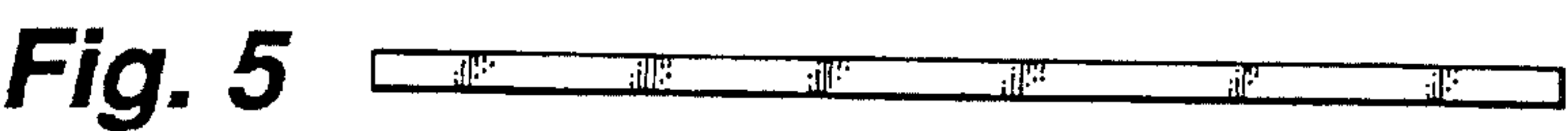

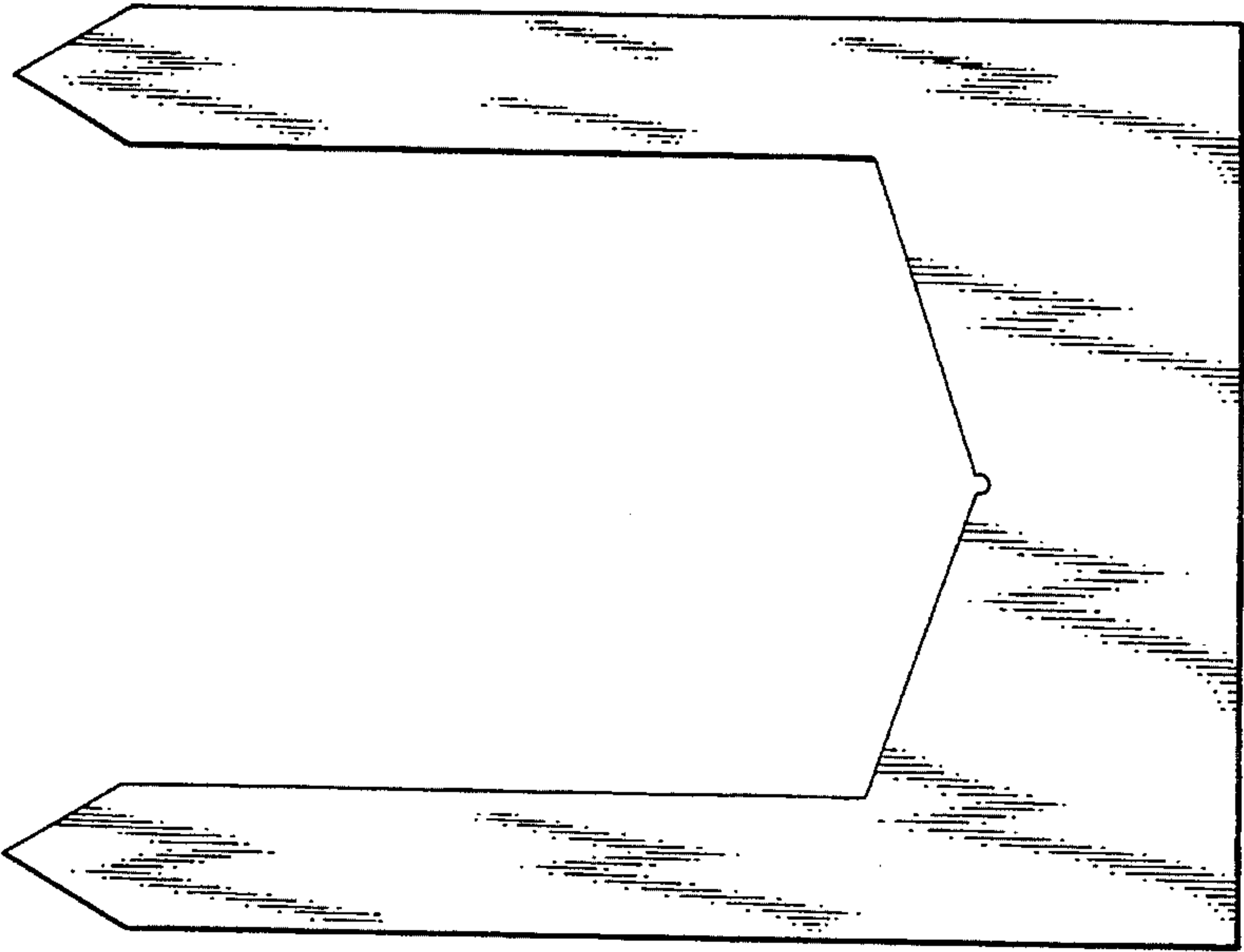

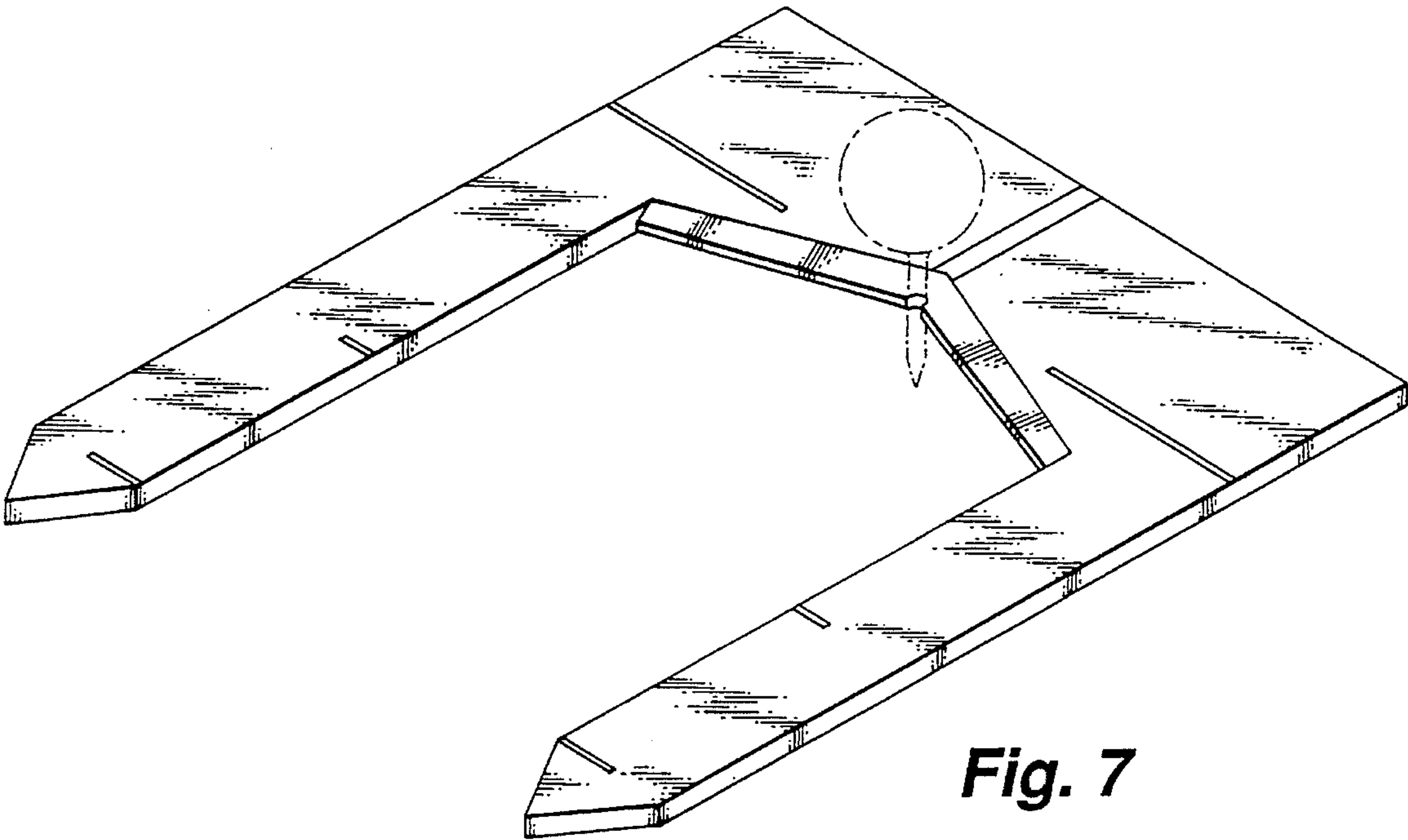
