The ornamental design for a brassiere, as shown and described.

DESCRIPTION

FIG. 1 is an environmental perspective view of a brassiere, showing my new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is an environmental perspective view of a second embodiment of the invention.

The broken line showing of a person in FIGS. 1, 2, 3, 4, and 7 is for illustrative purposes only, and forms no part of the claimed design.

The broken lines shown on the closure element throughout the views are understood to represent conventional stitching.

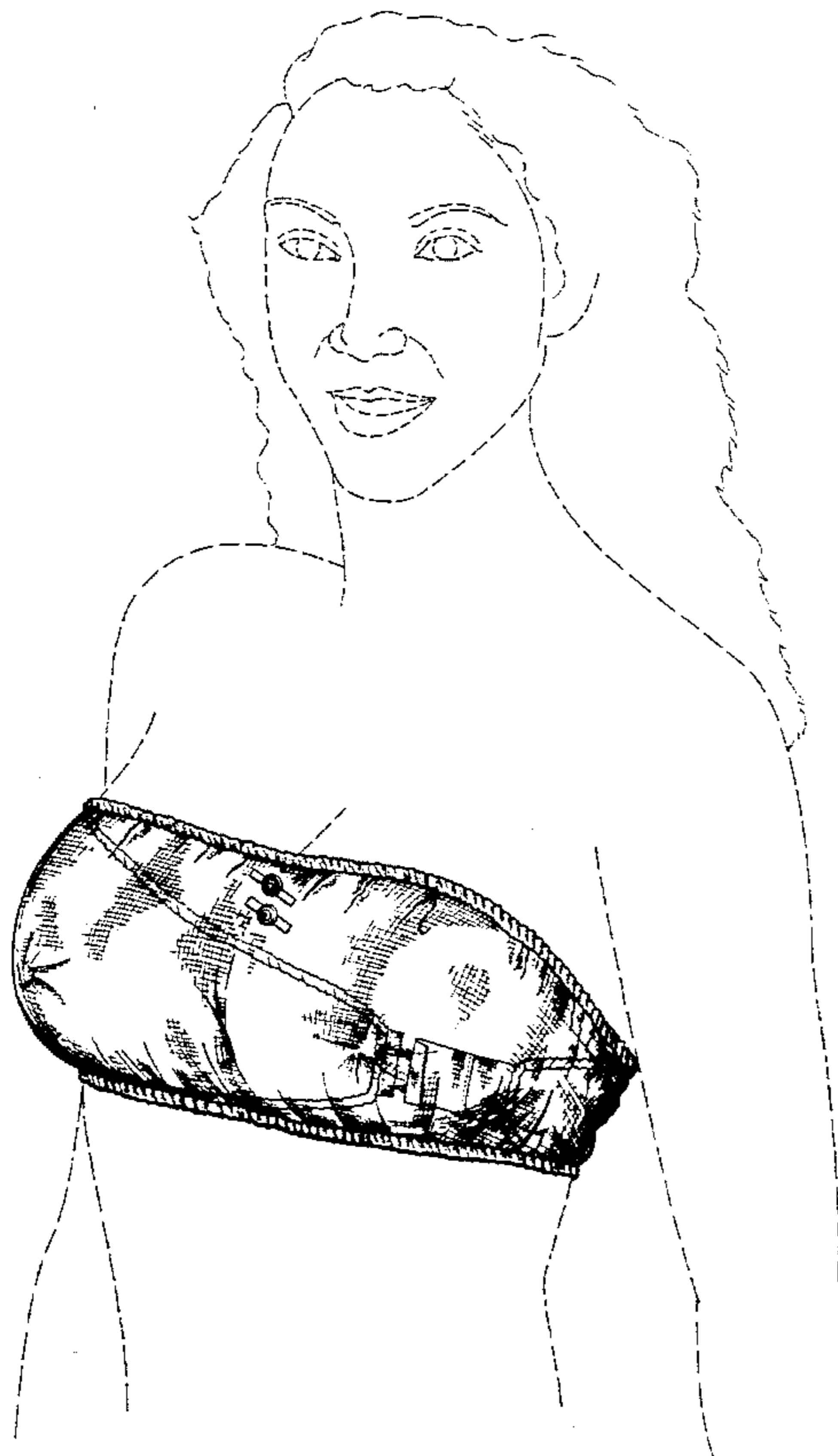

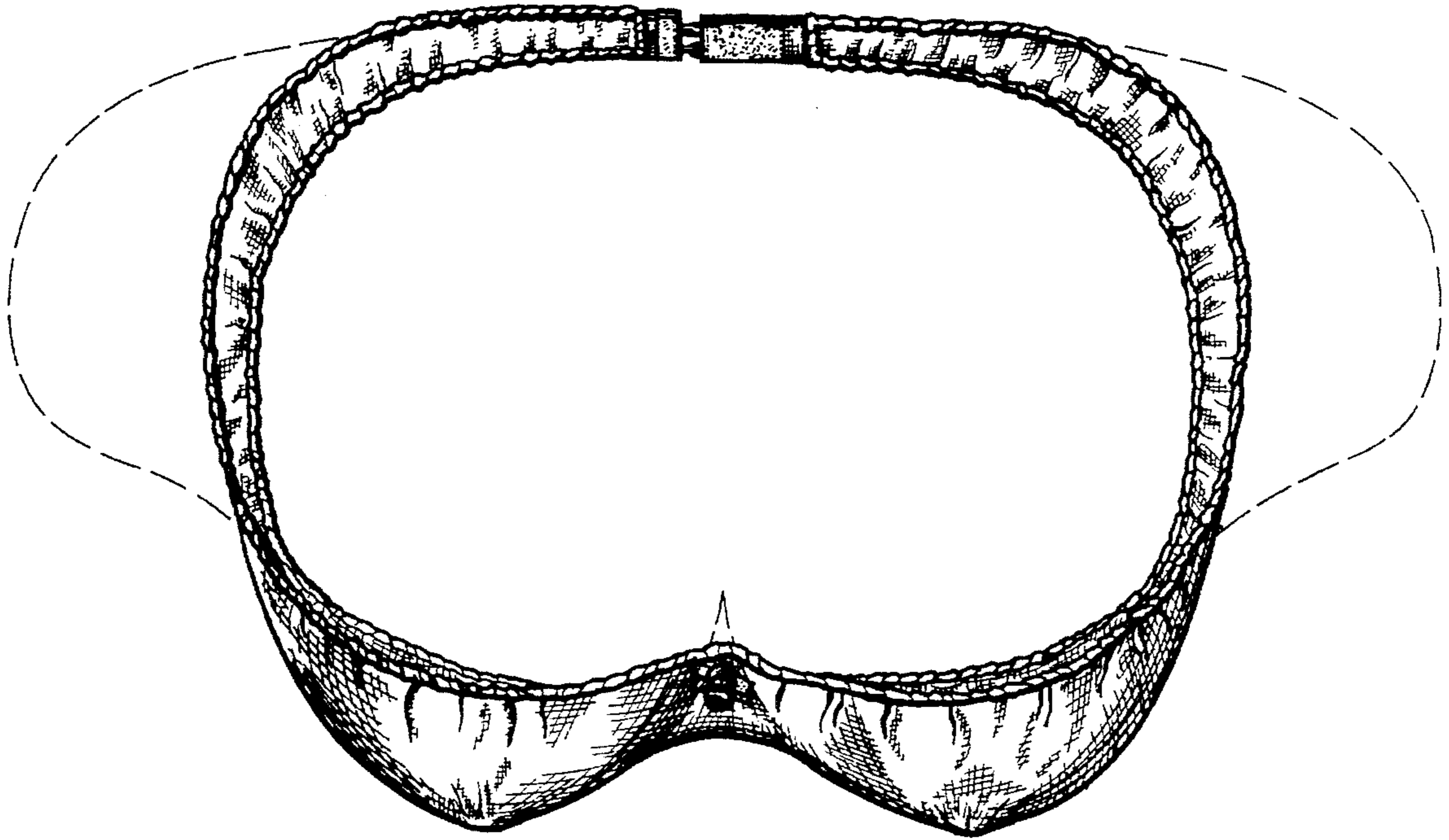

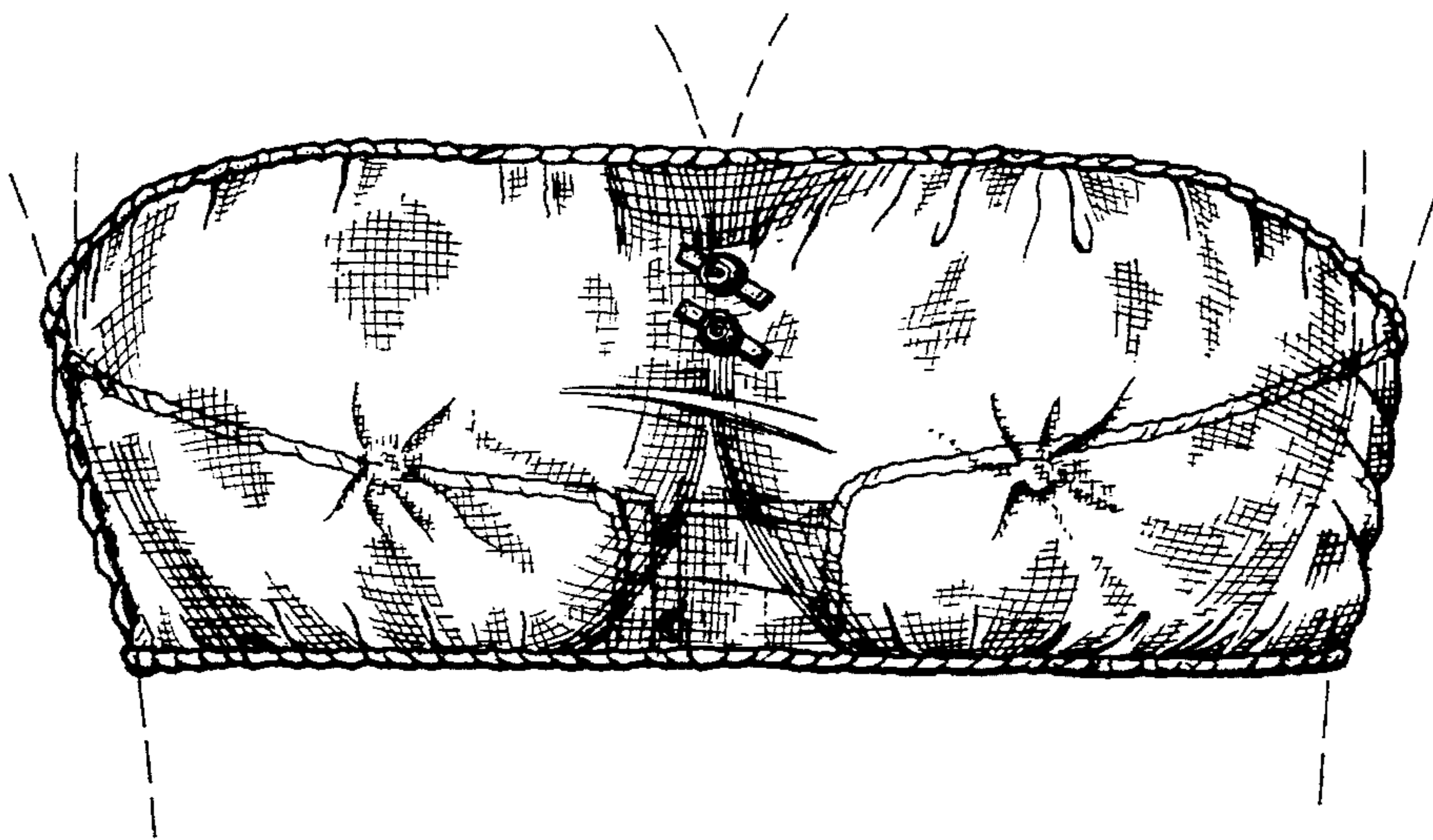

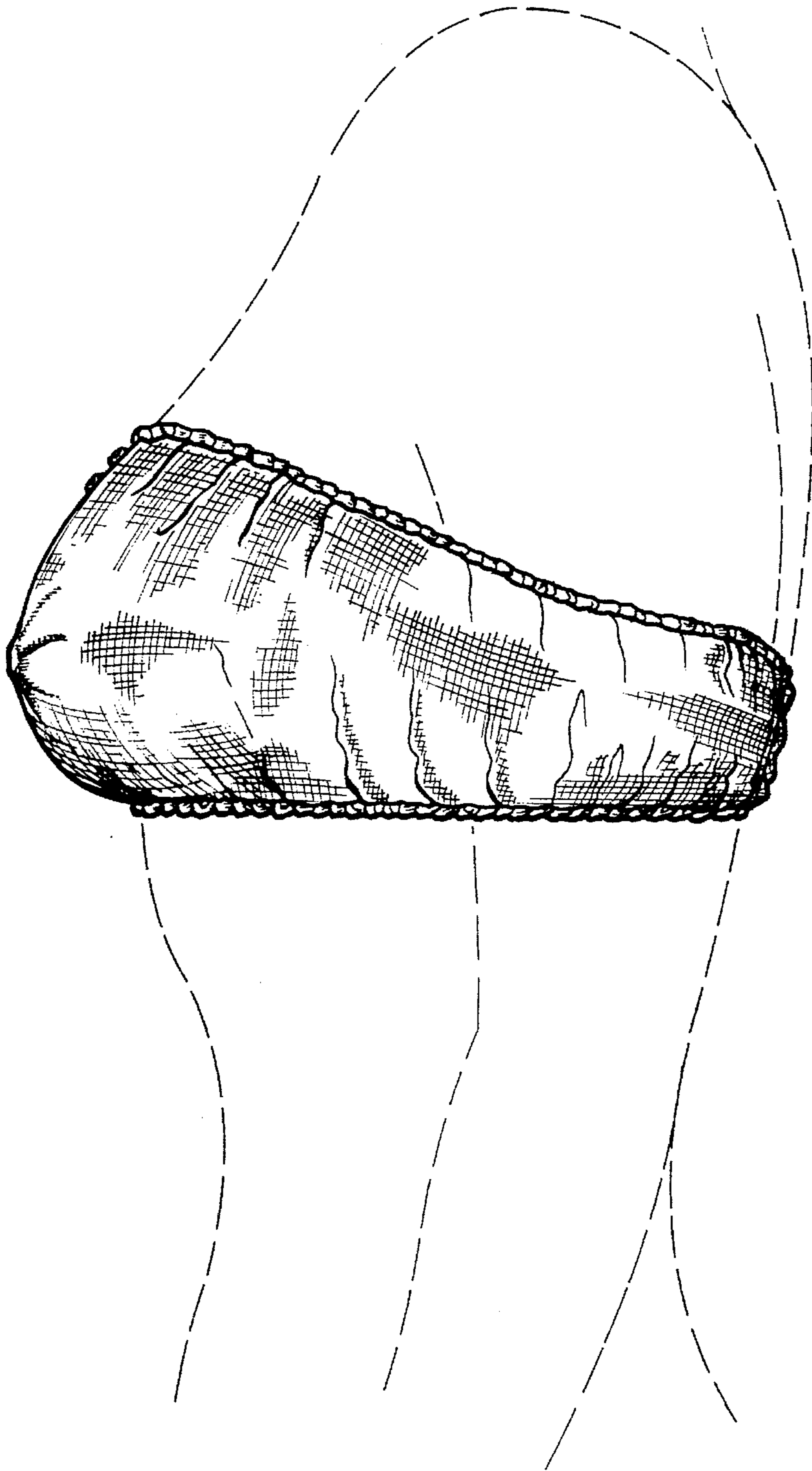

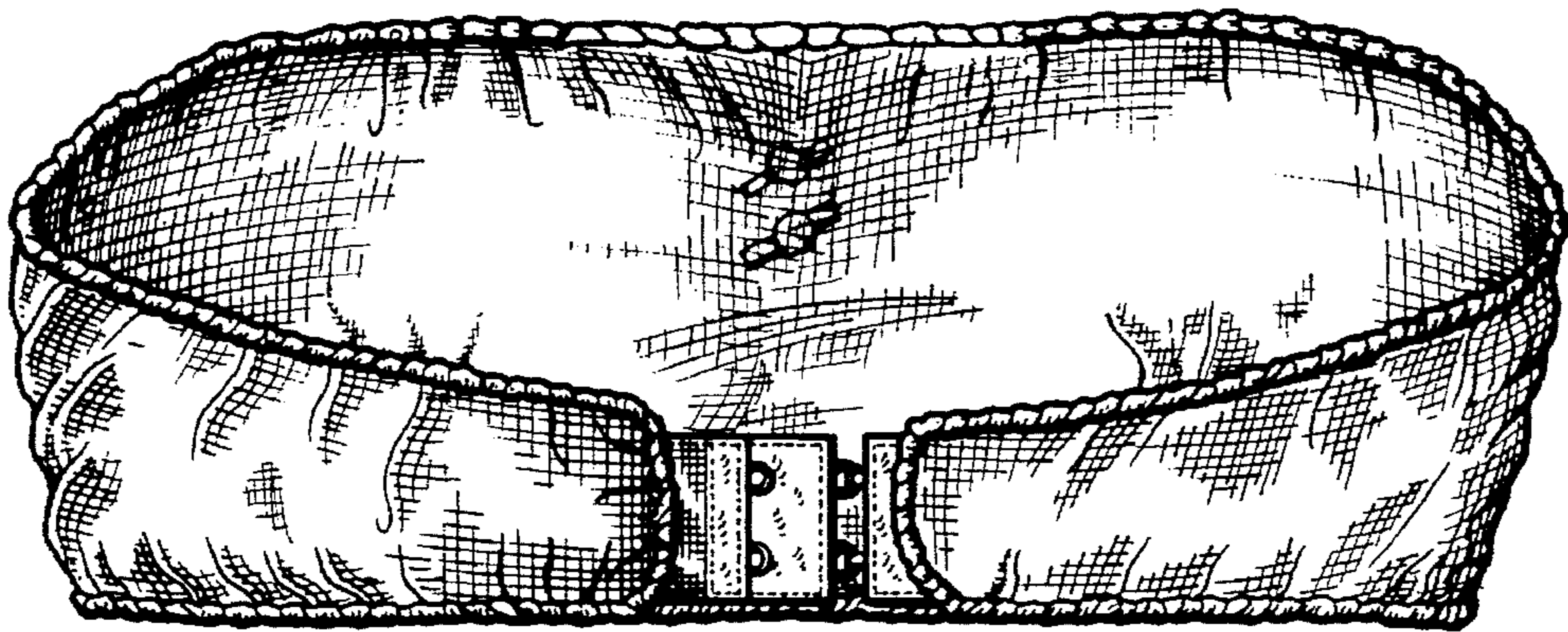

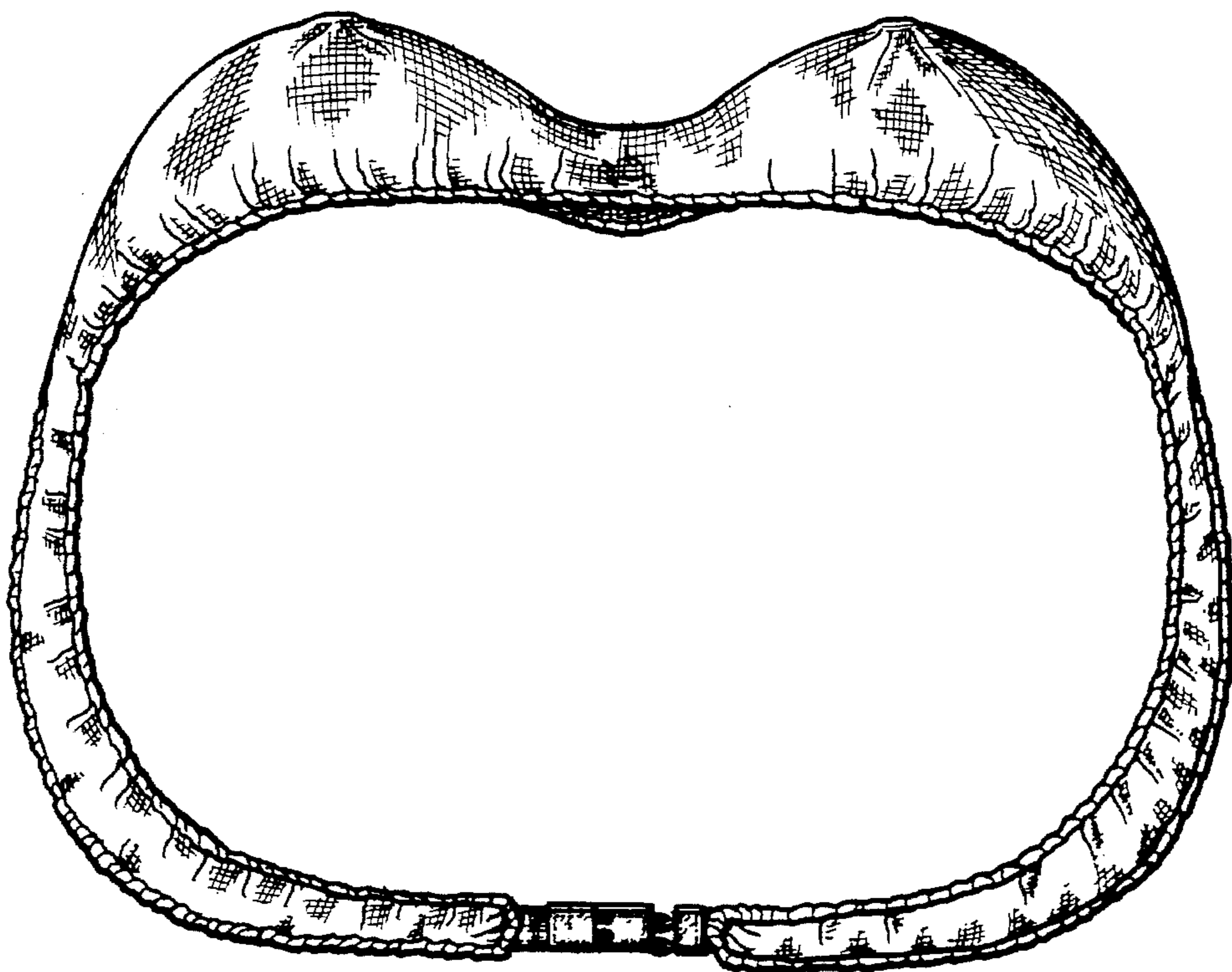
