DESCRIPTION

FIG. 1 is a bottom plan view of an inner sole showing my new design;

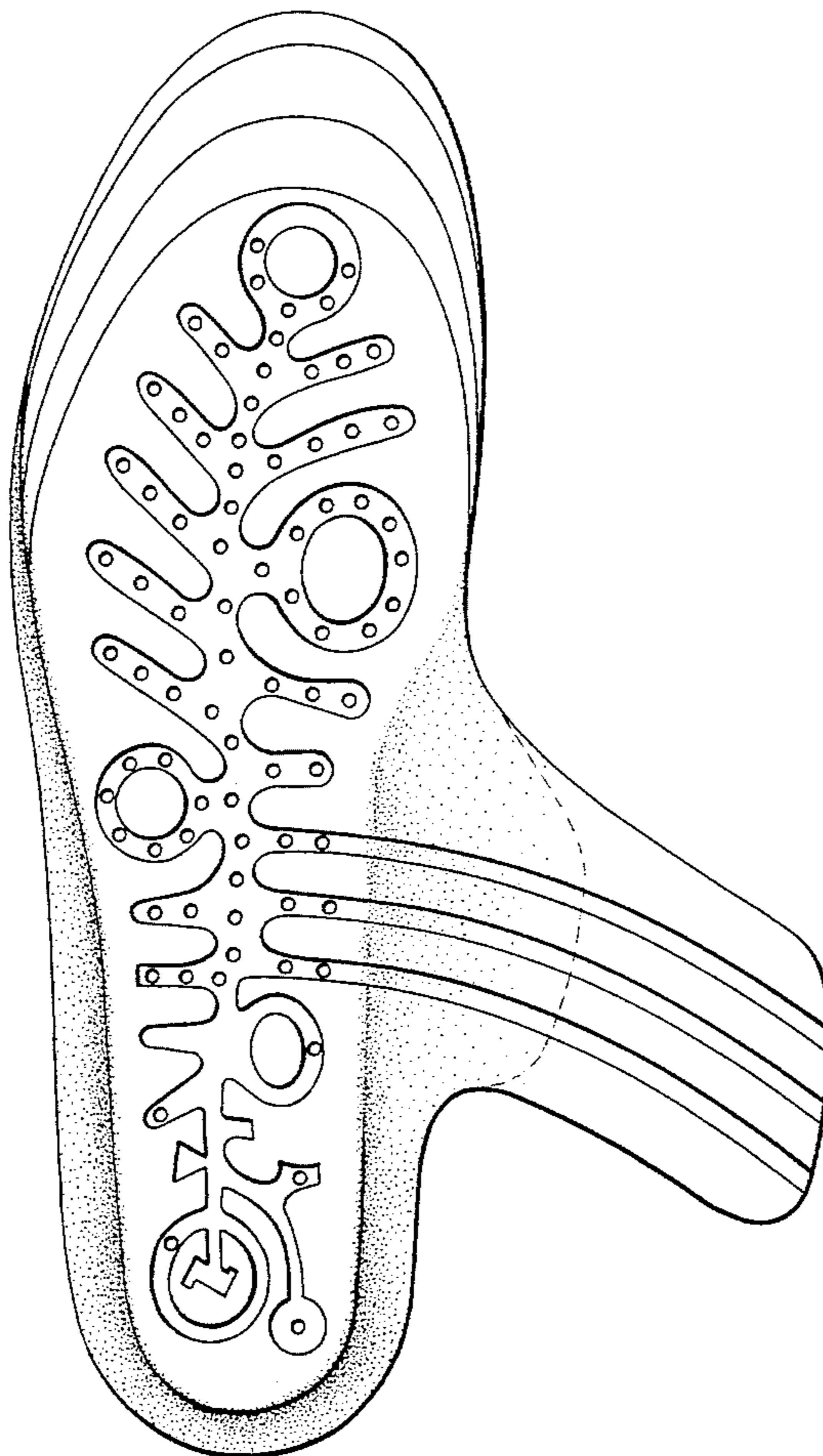

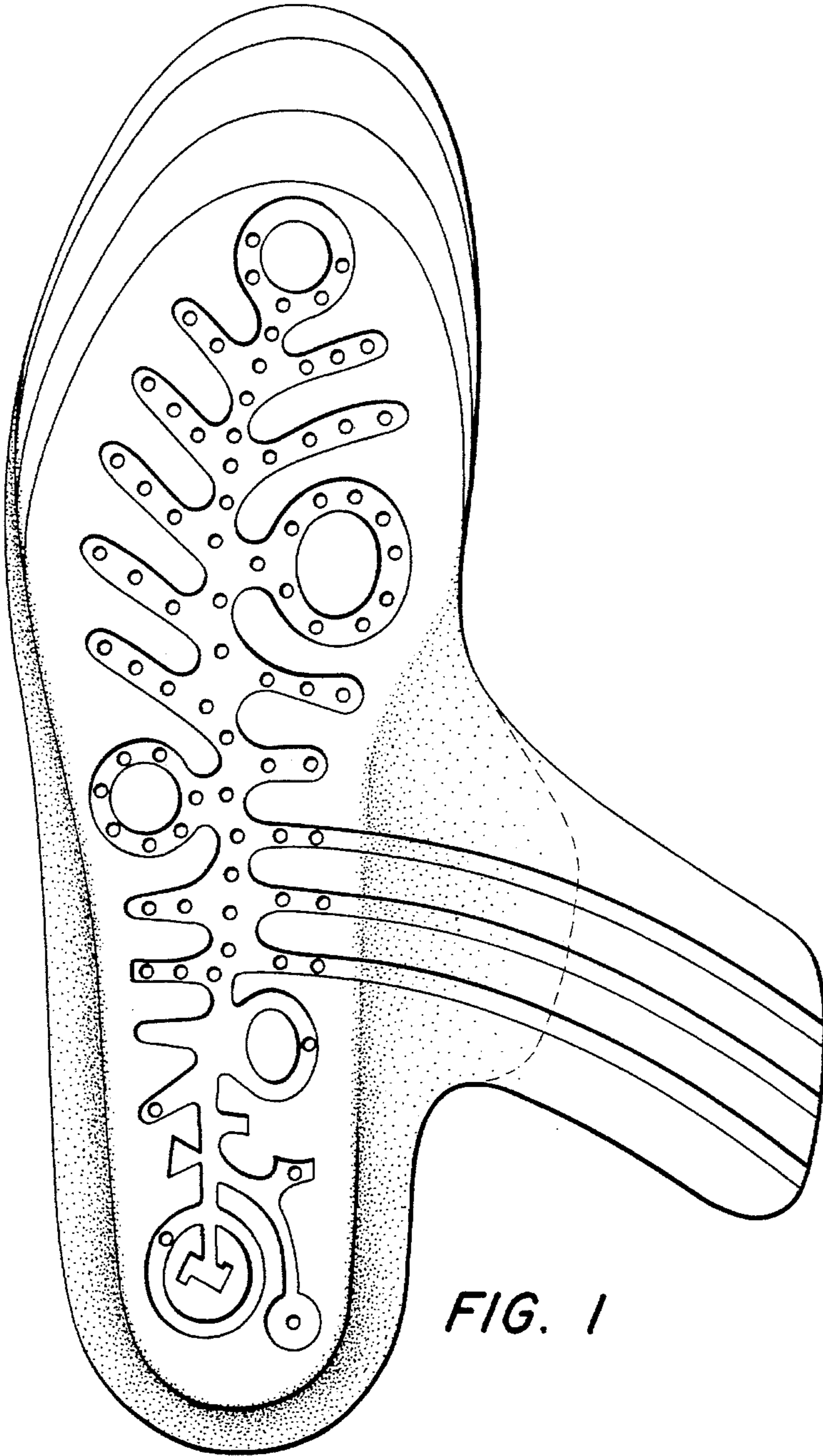

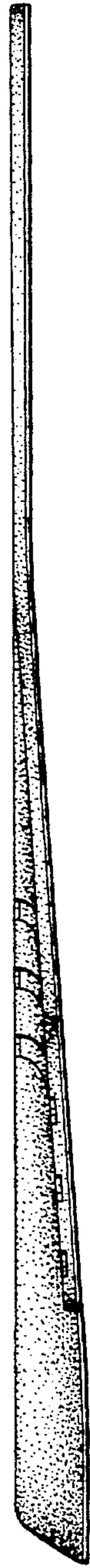

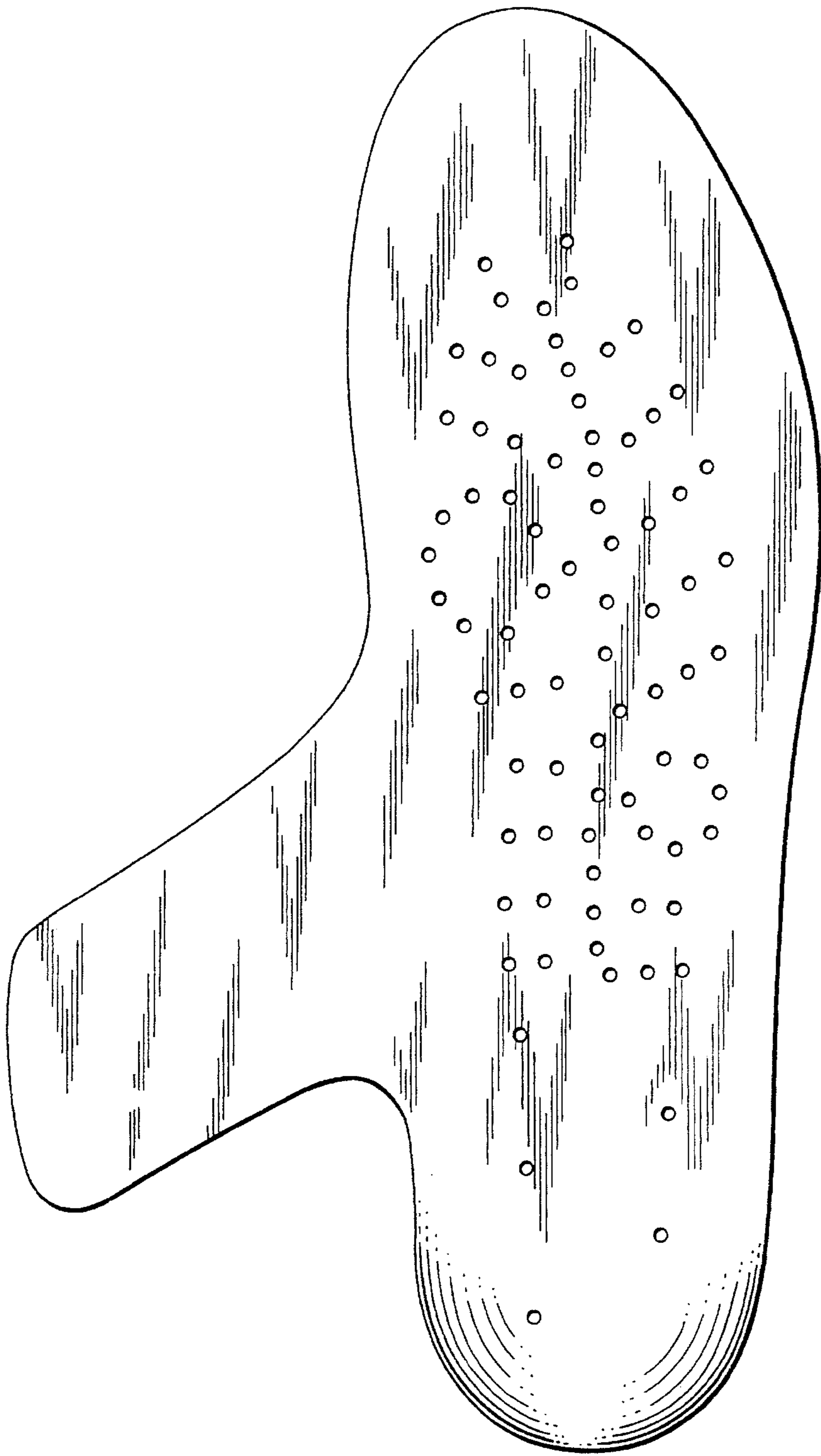

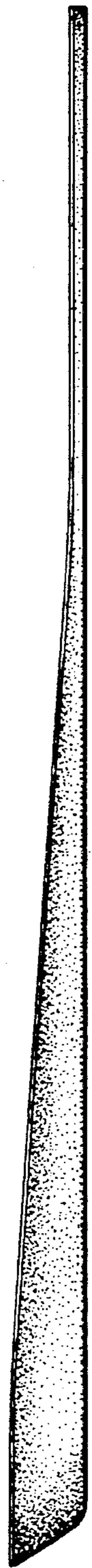
