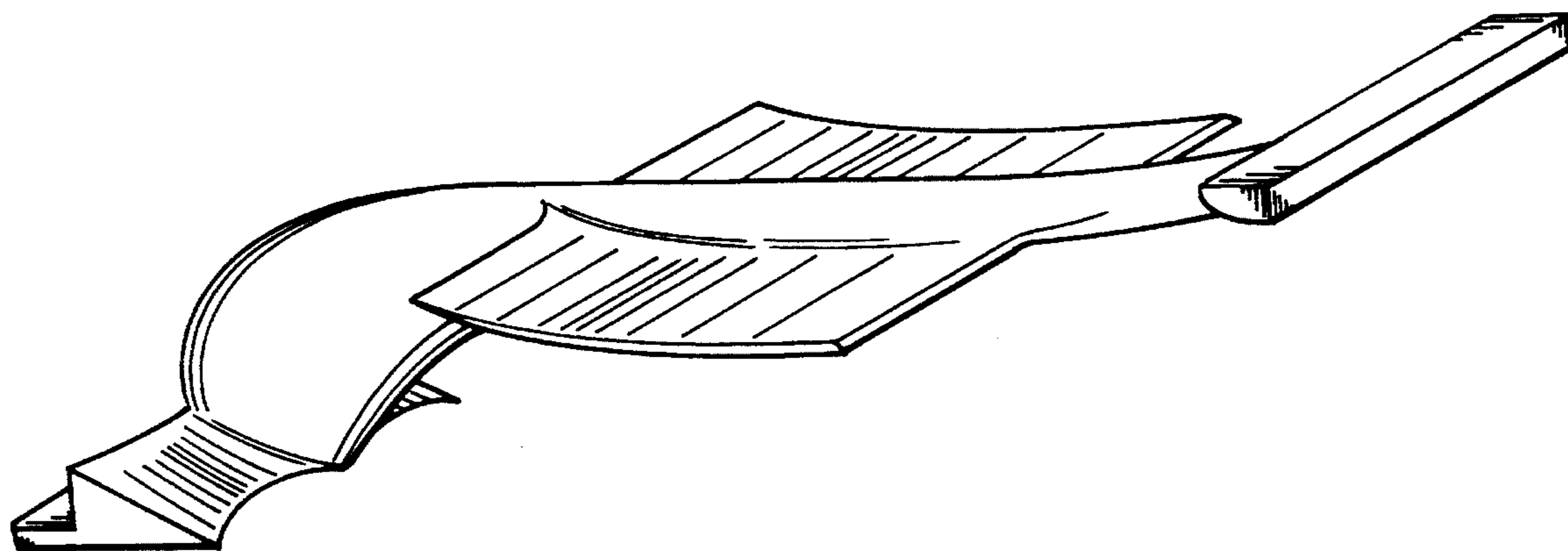

### DESCRIPTION

FIG. 1 is a side perspective view of our jet-pump watercraft intake grate design, viewed from a position toward the front of the intake grate;  
FIG. 2 is a top view of our design;  
FIG. 3 is a left side view of our design, with the right side view of our design being a mirror image of the left side view;  
FIG. 4 is a bottom view of our design;  
FIG. 5 is a front view of our design; and,  
FIG. 6 is a back view of our design.

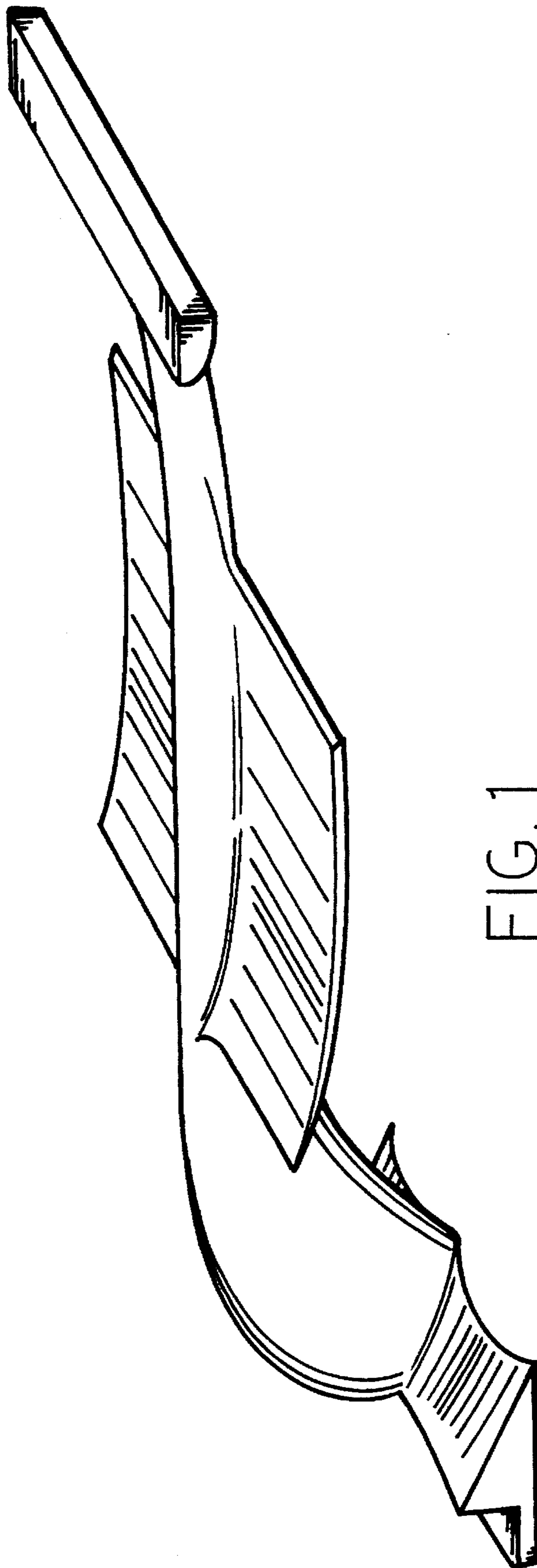

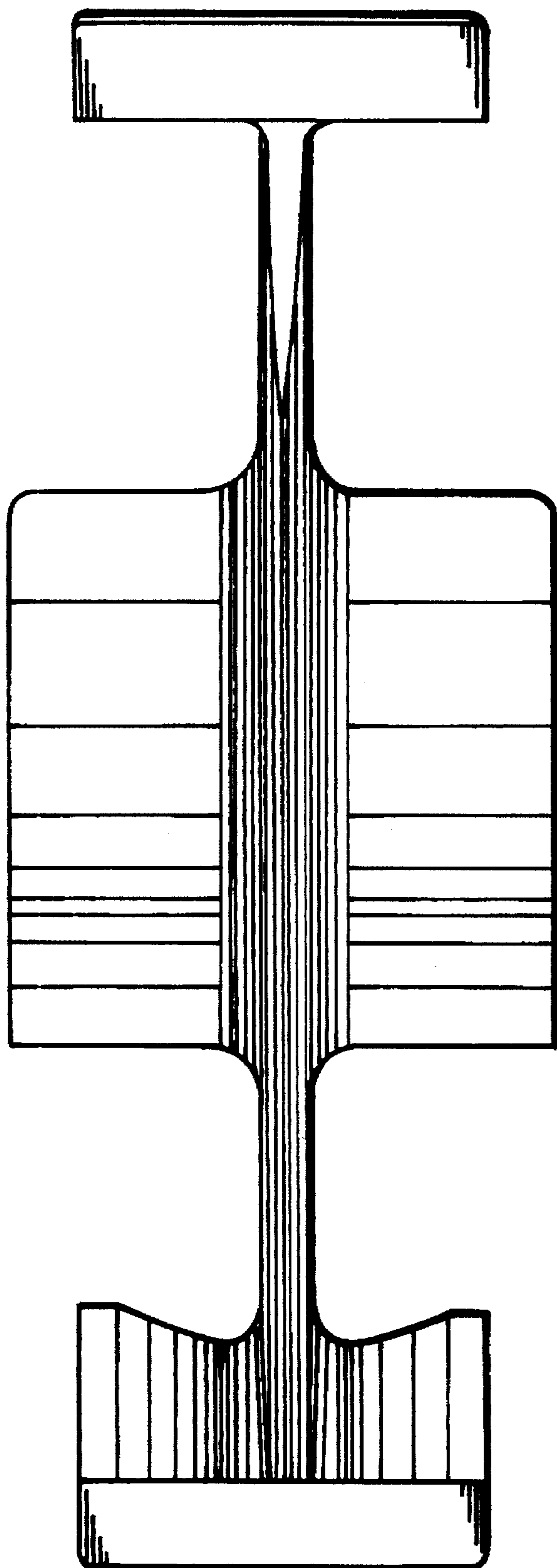

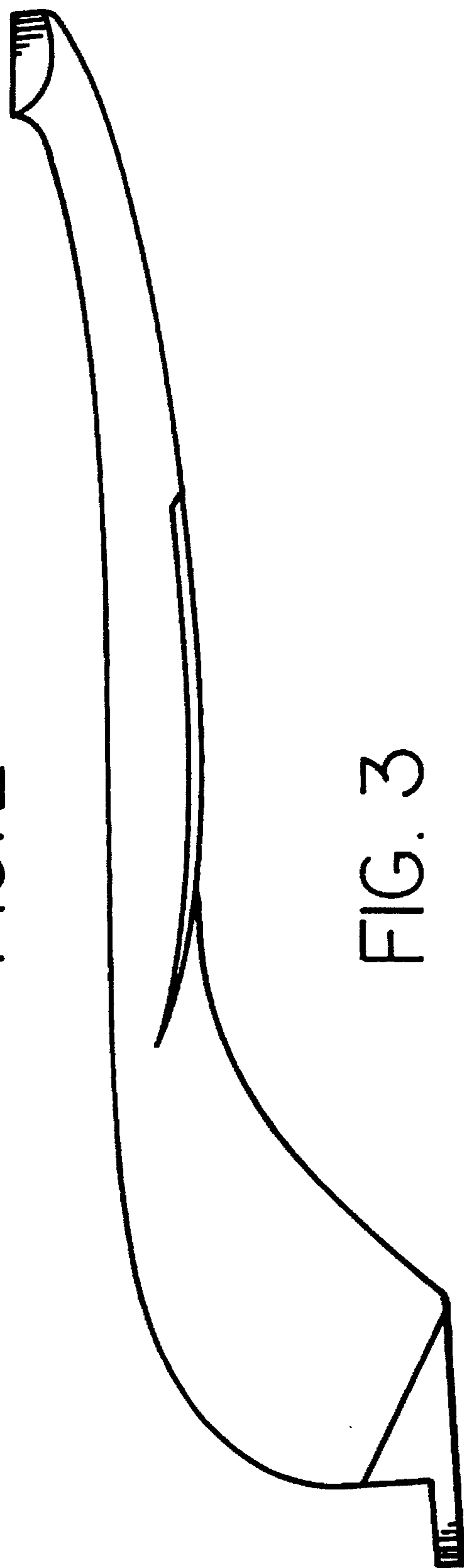

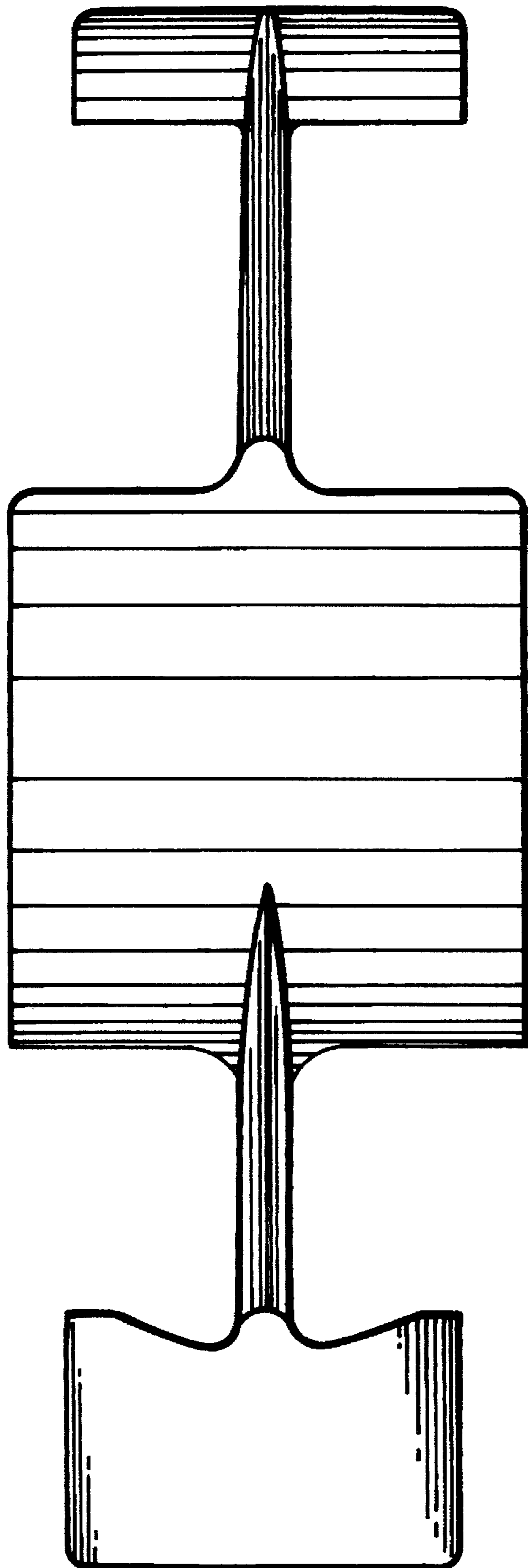

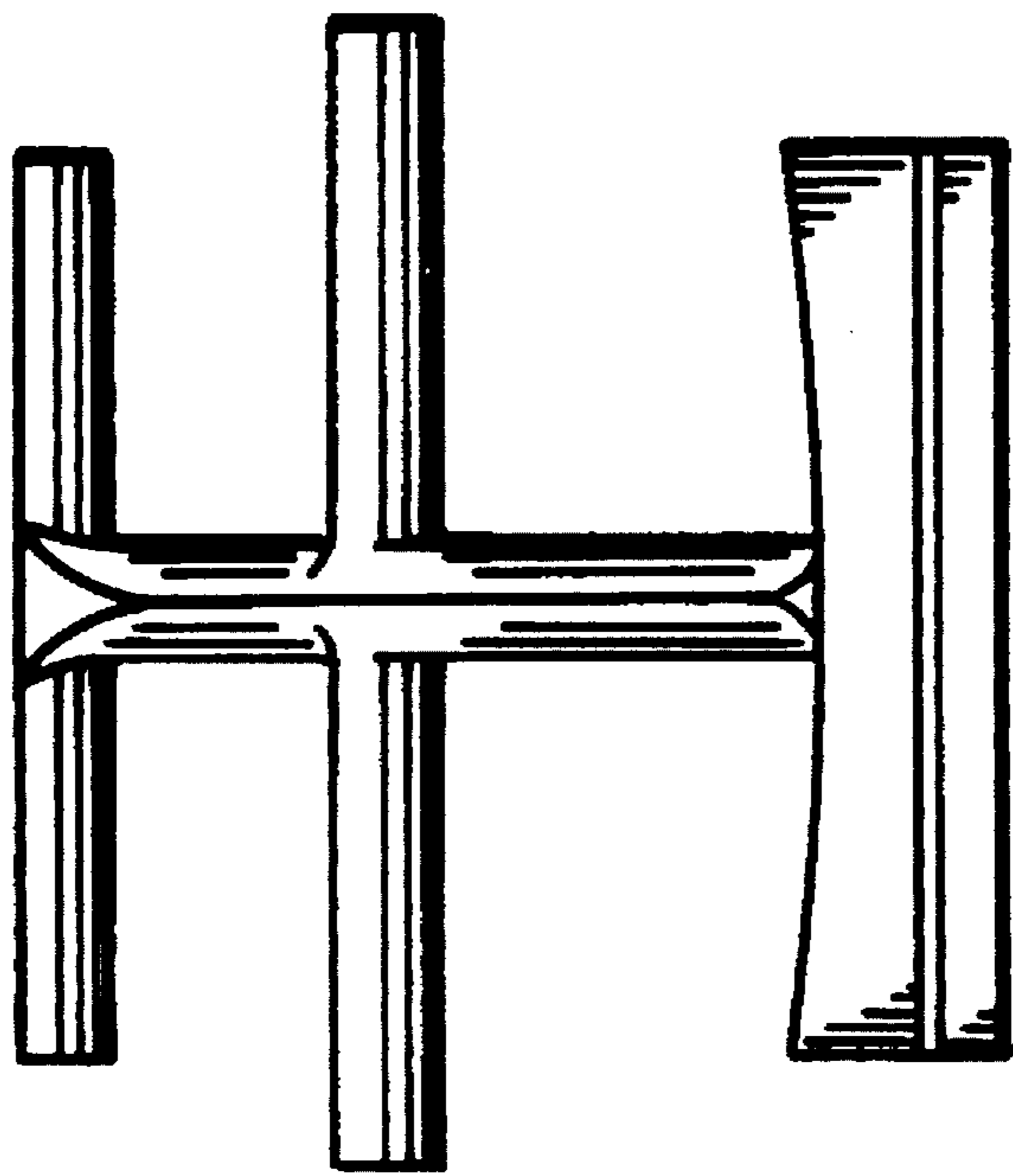

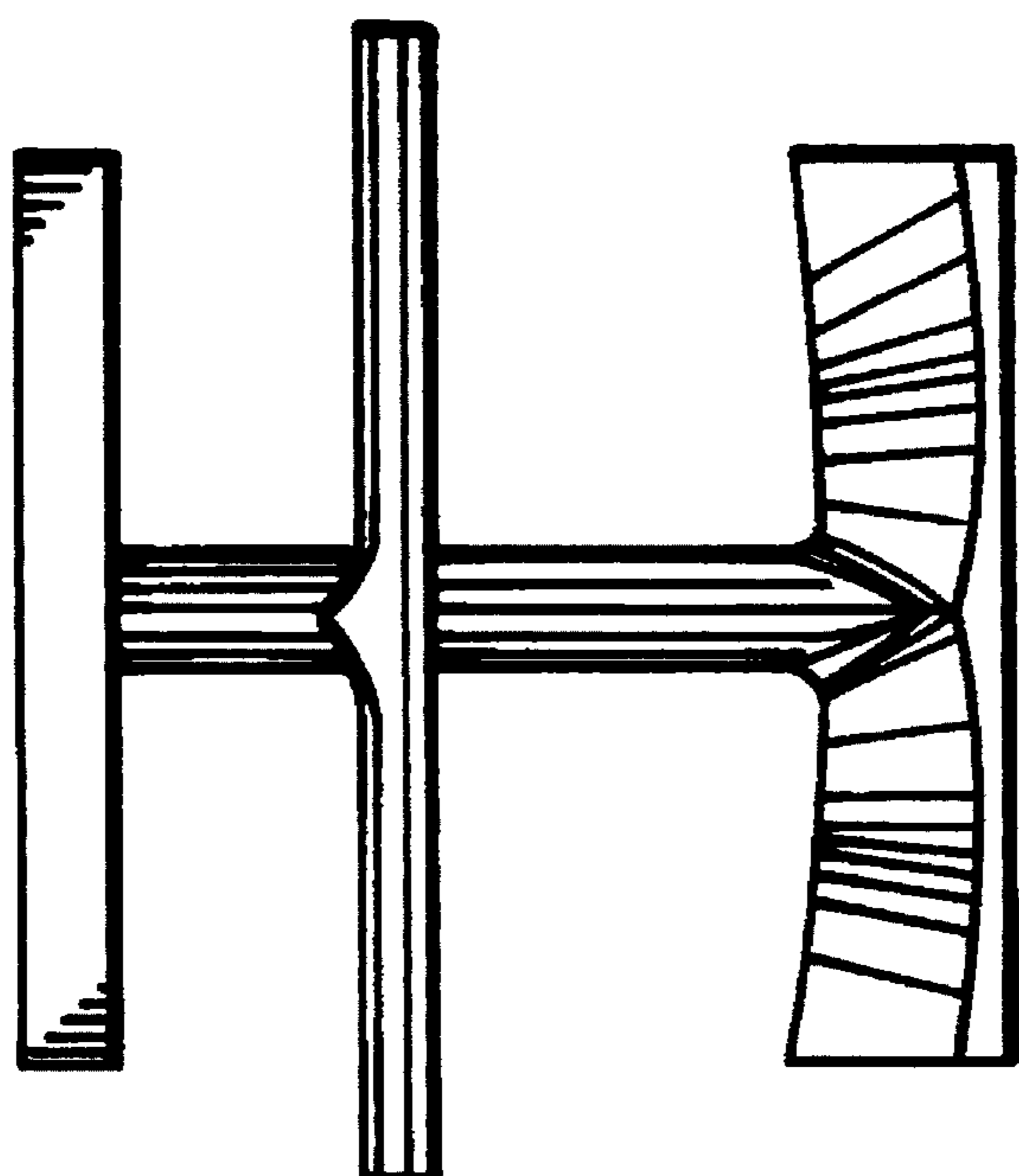
