DESCRIPTION

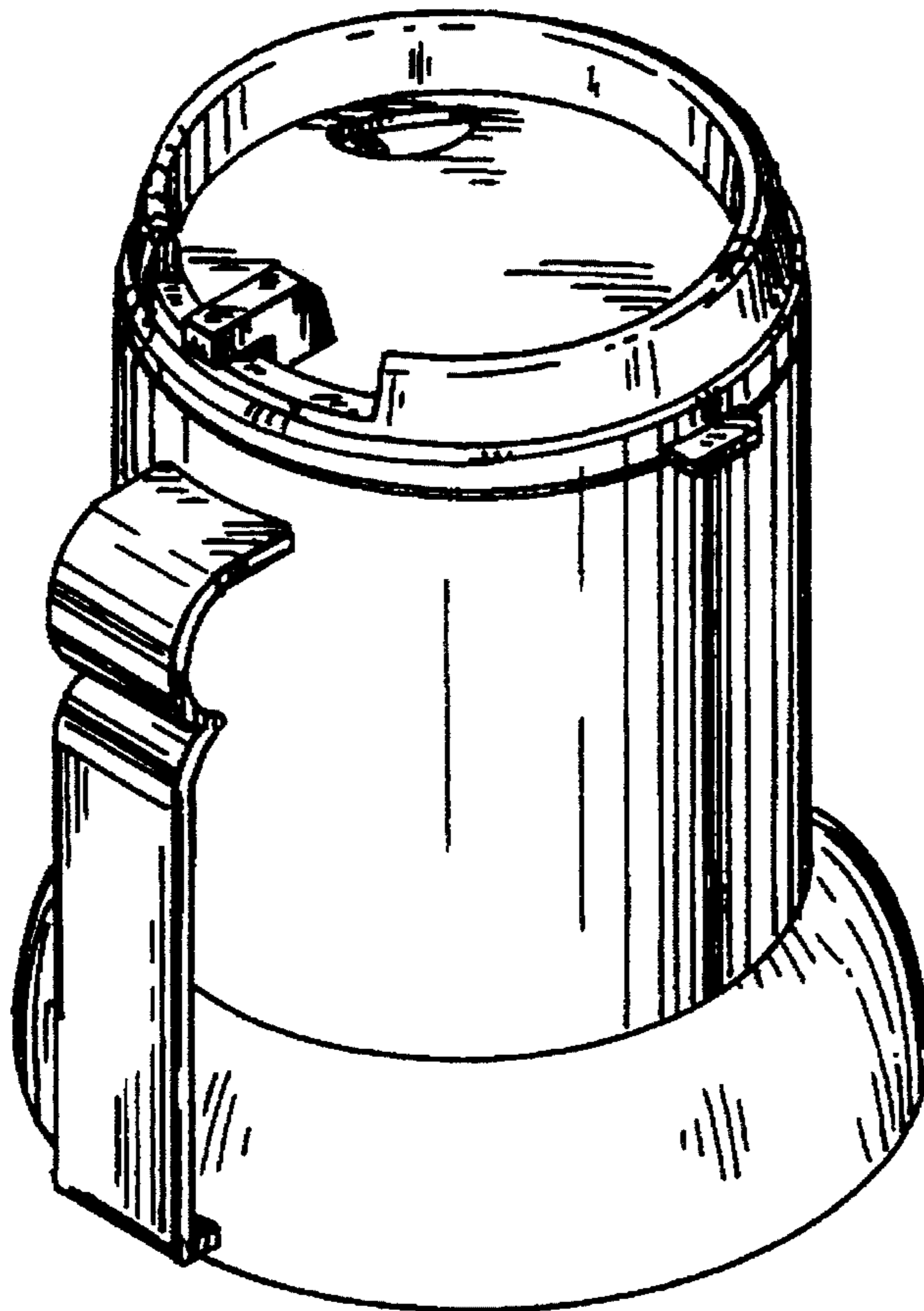
FIG. 1 is a top perspective view of a drinking mug showing our new design;

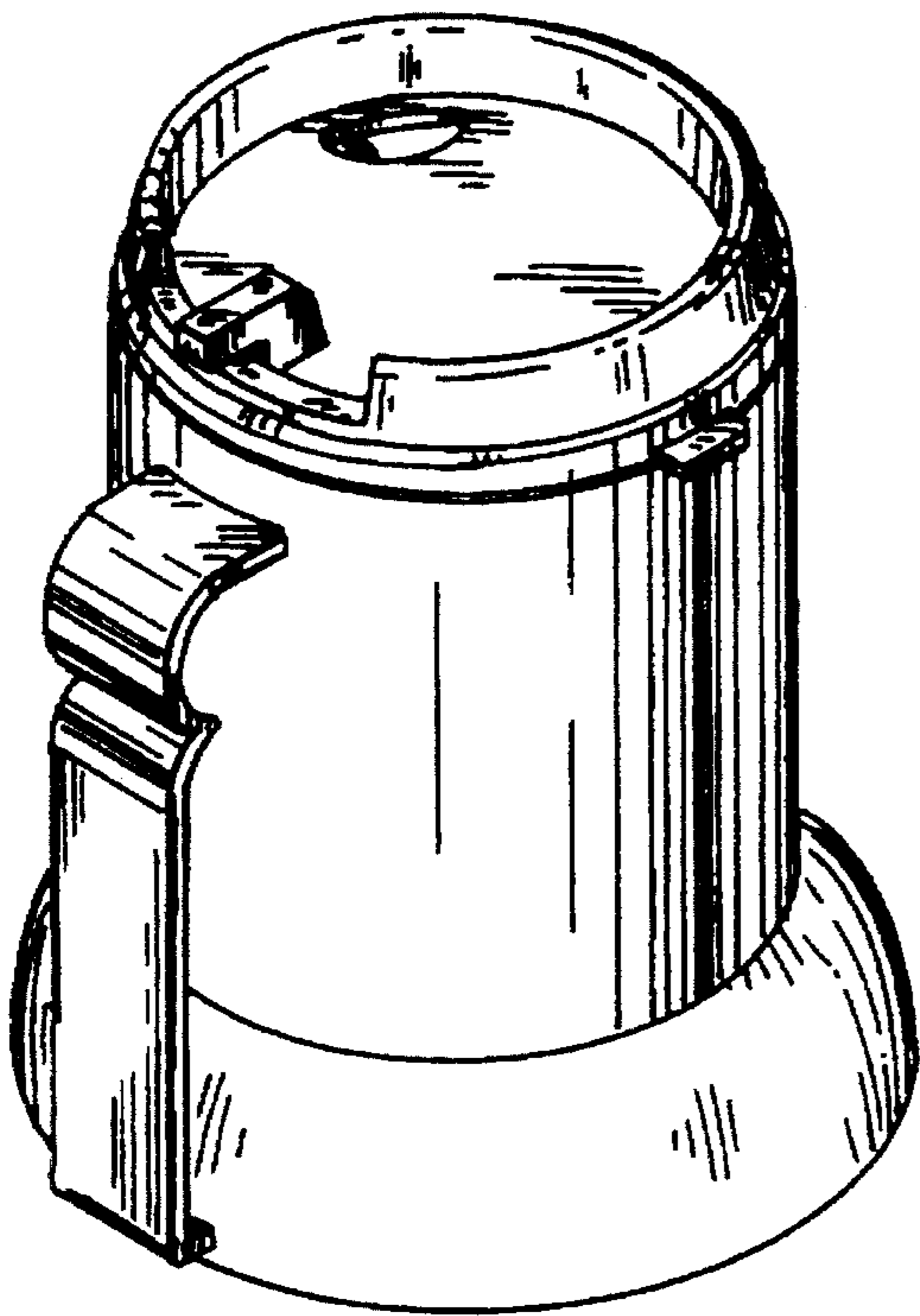

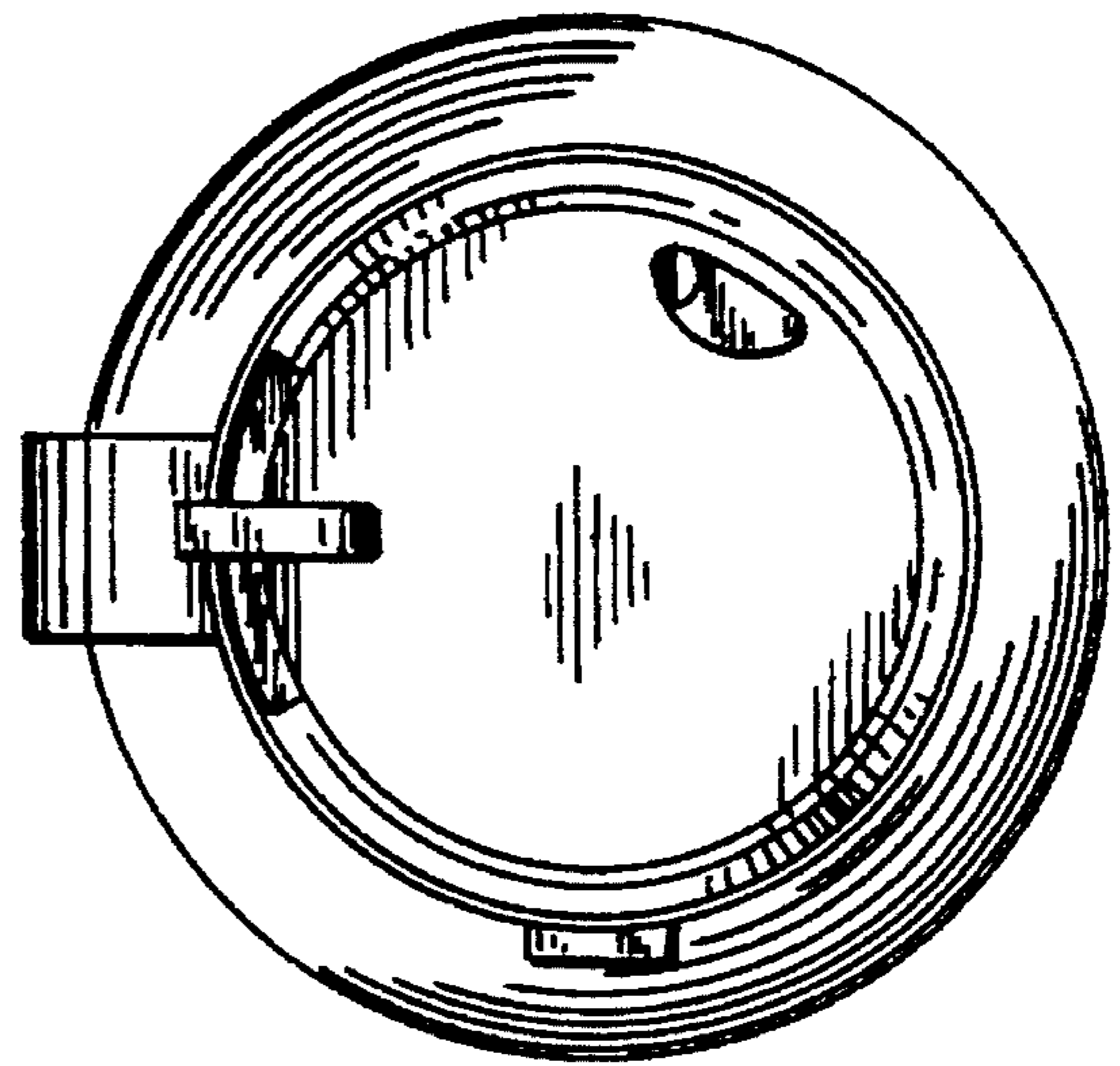

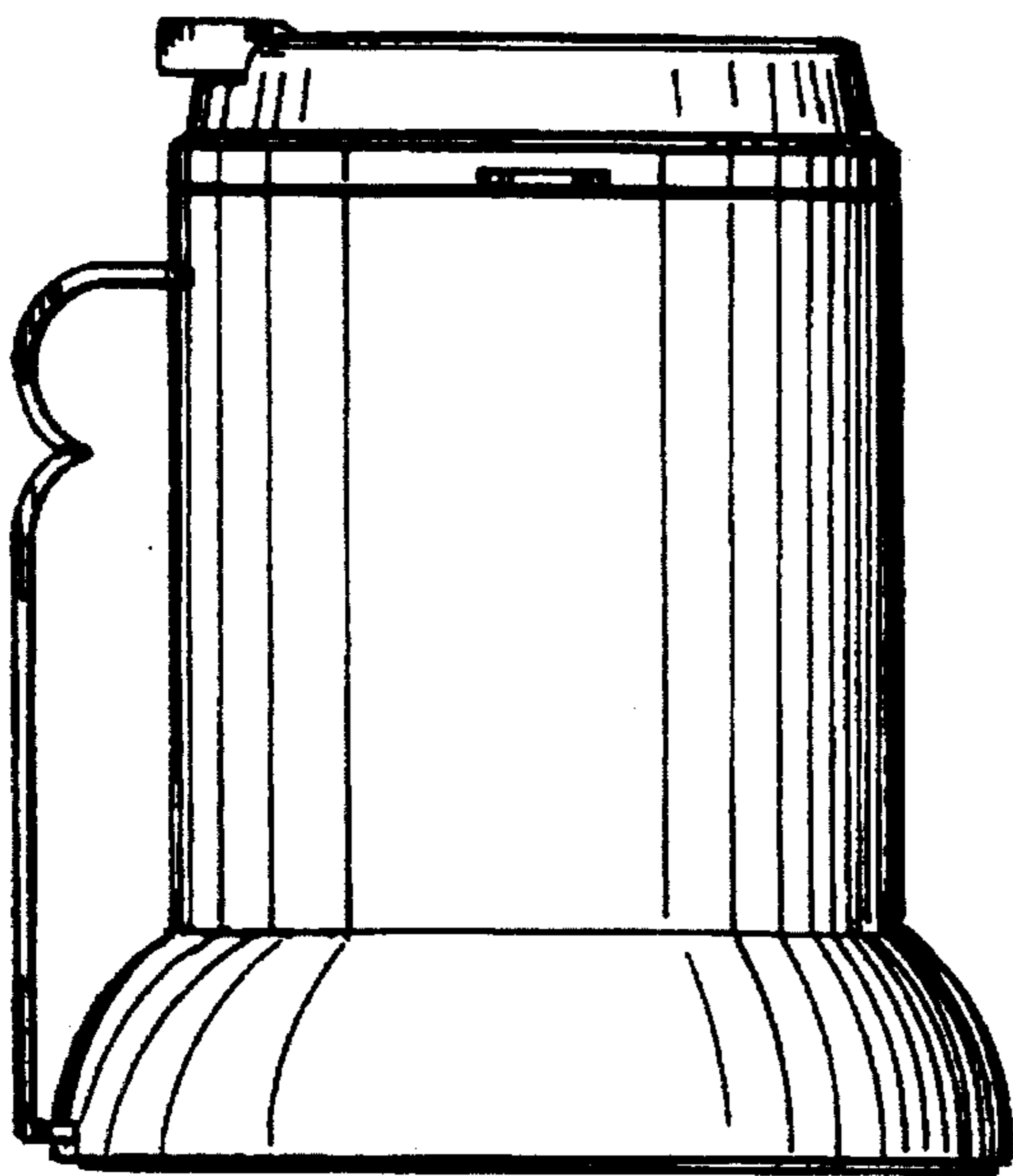

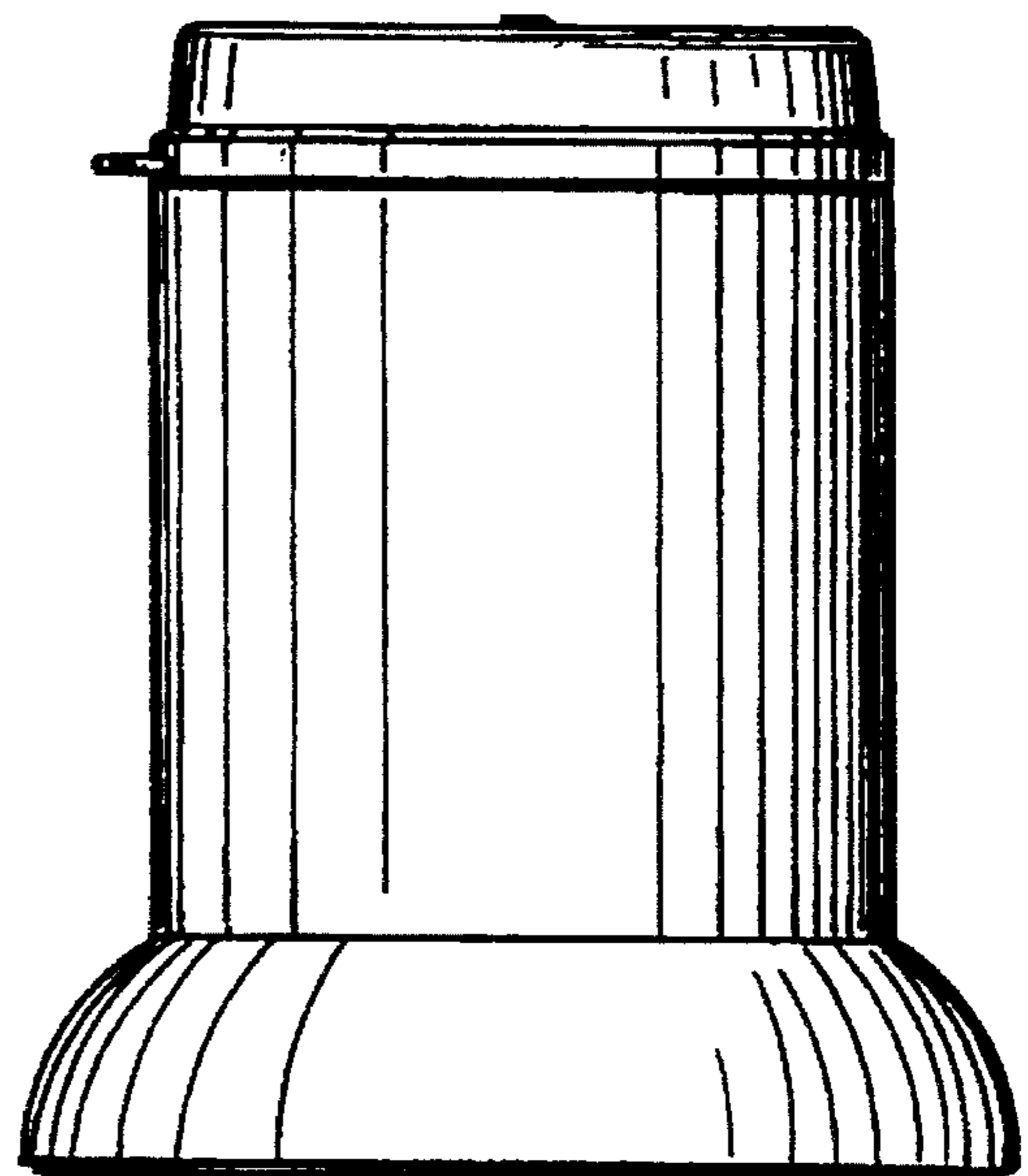

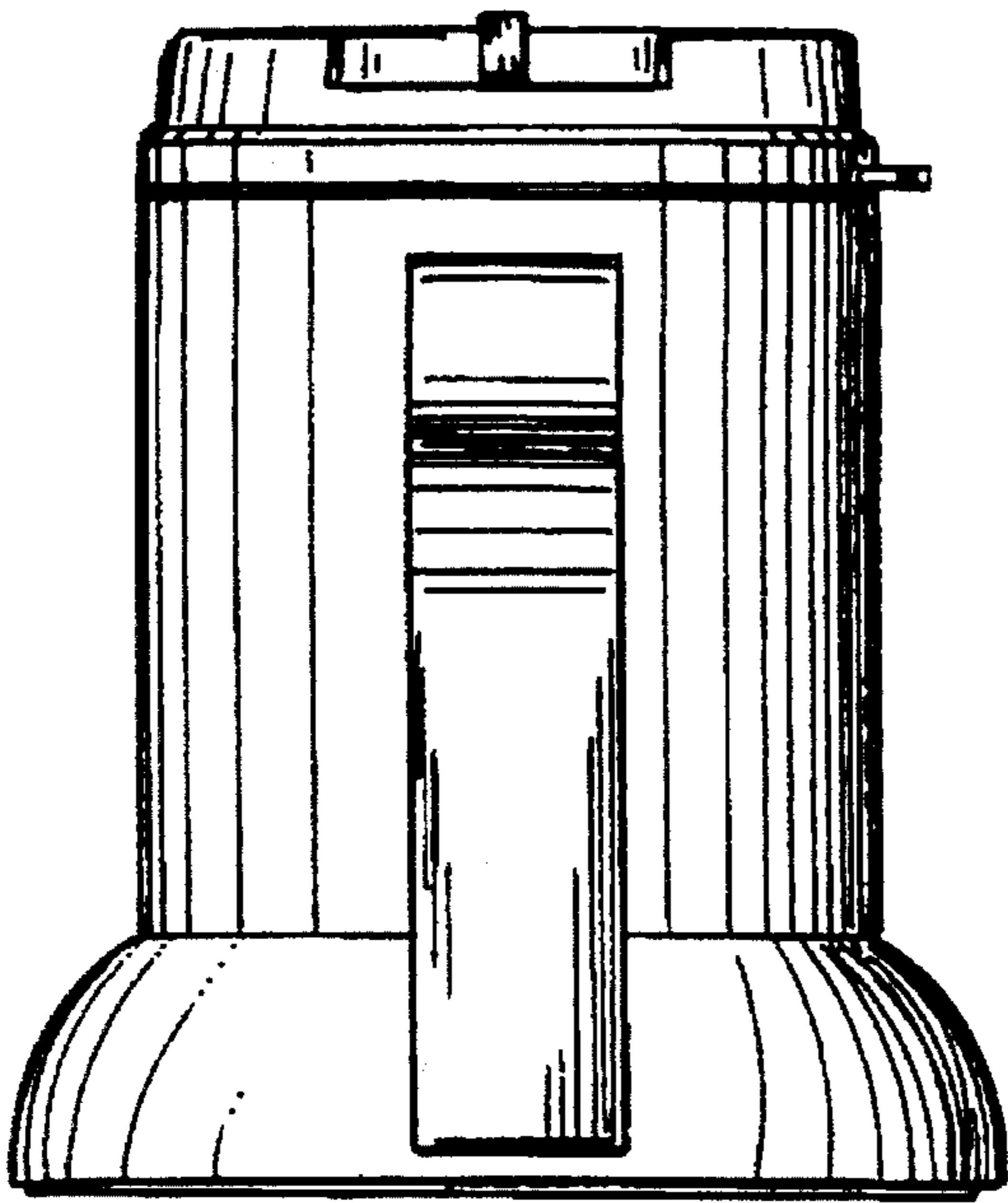

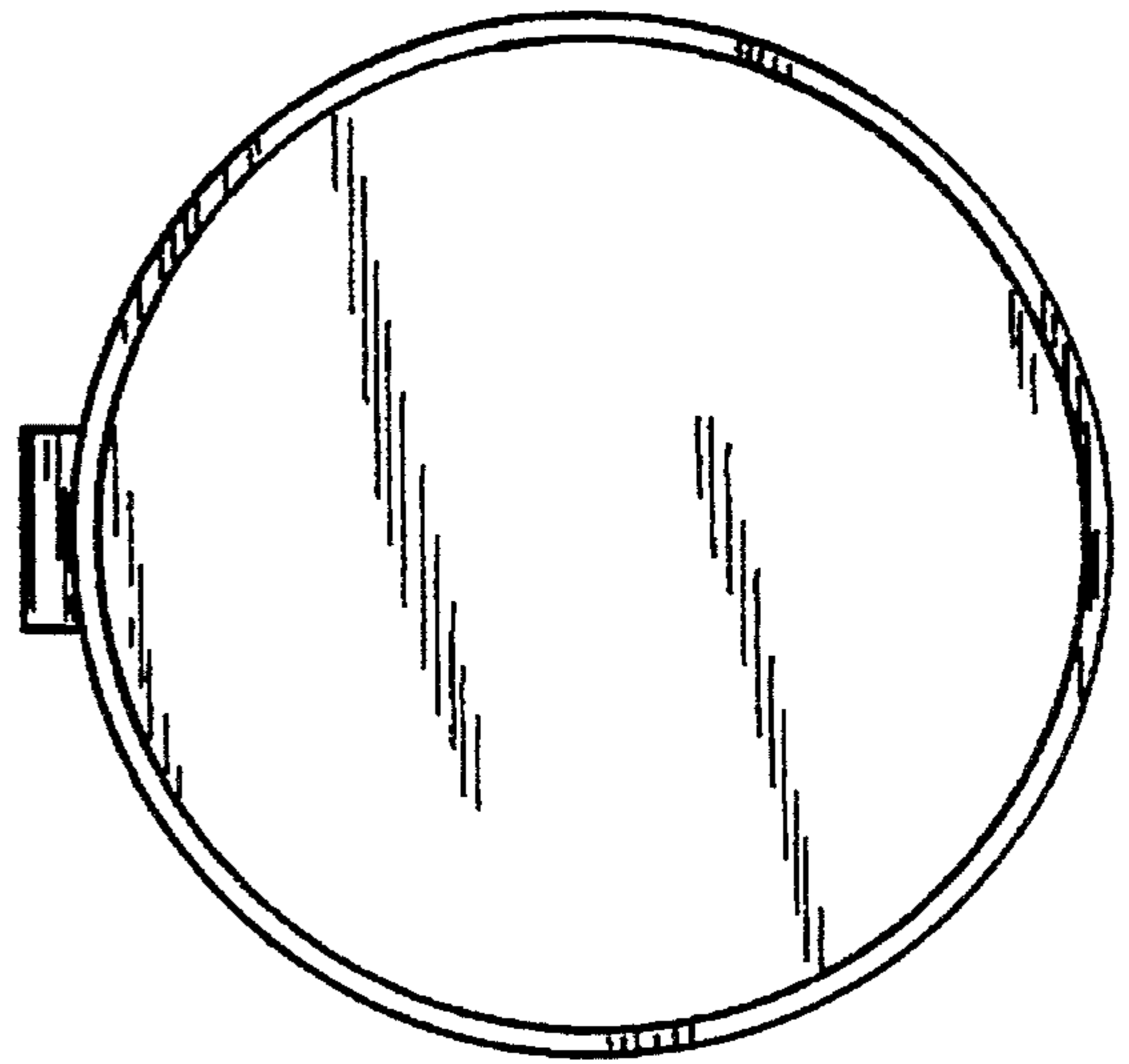

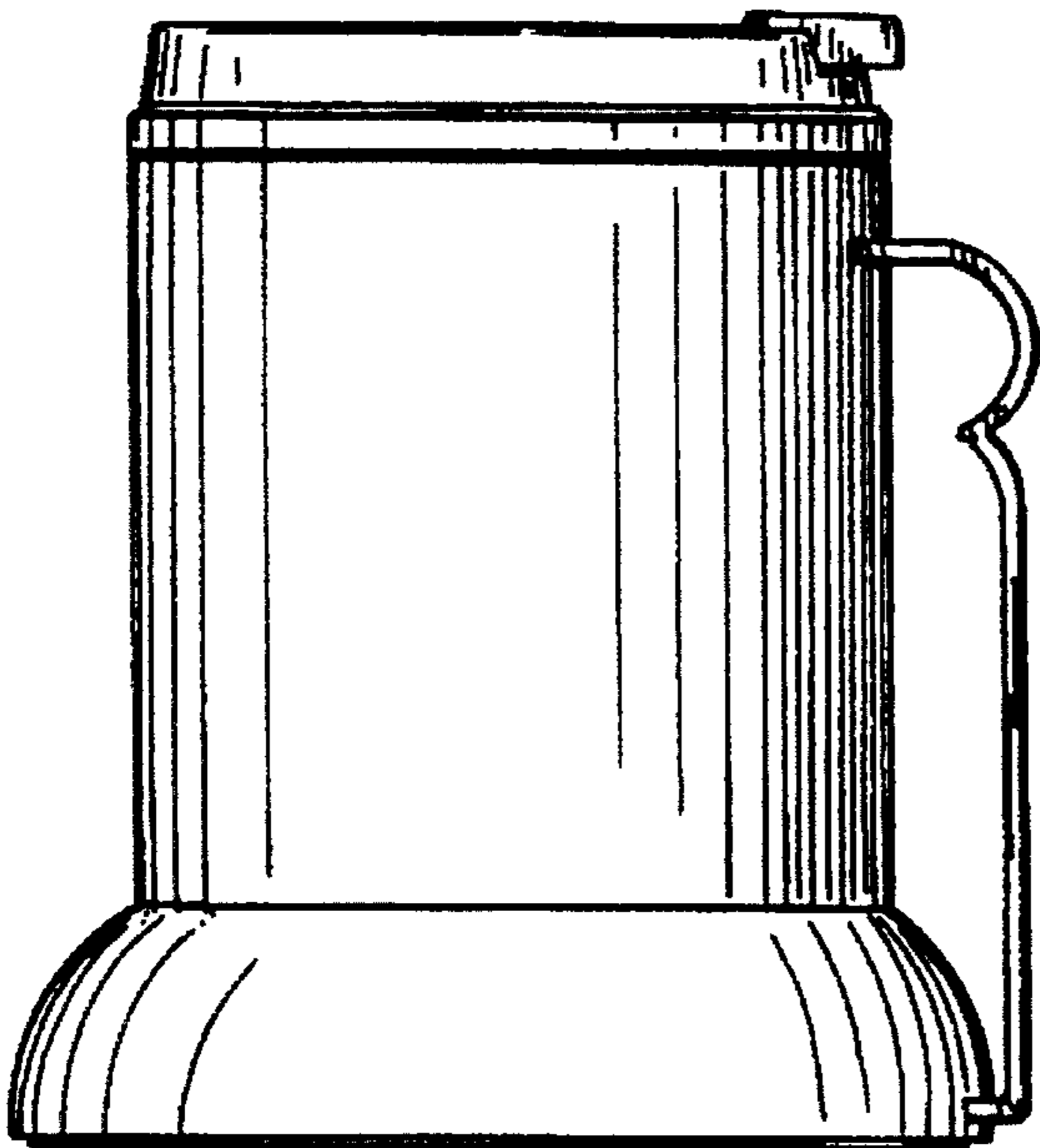
