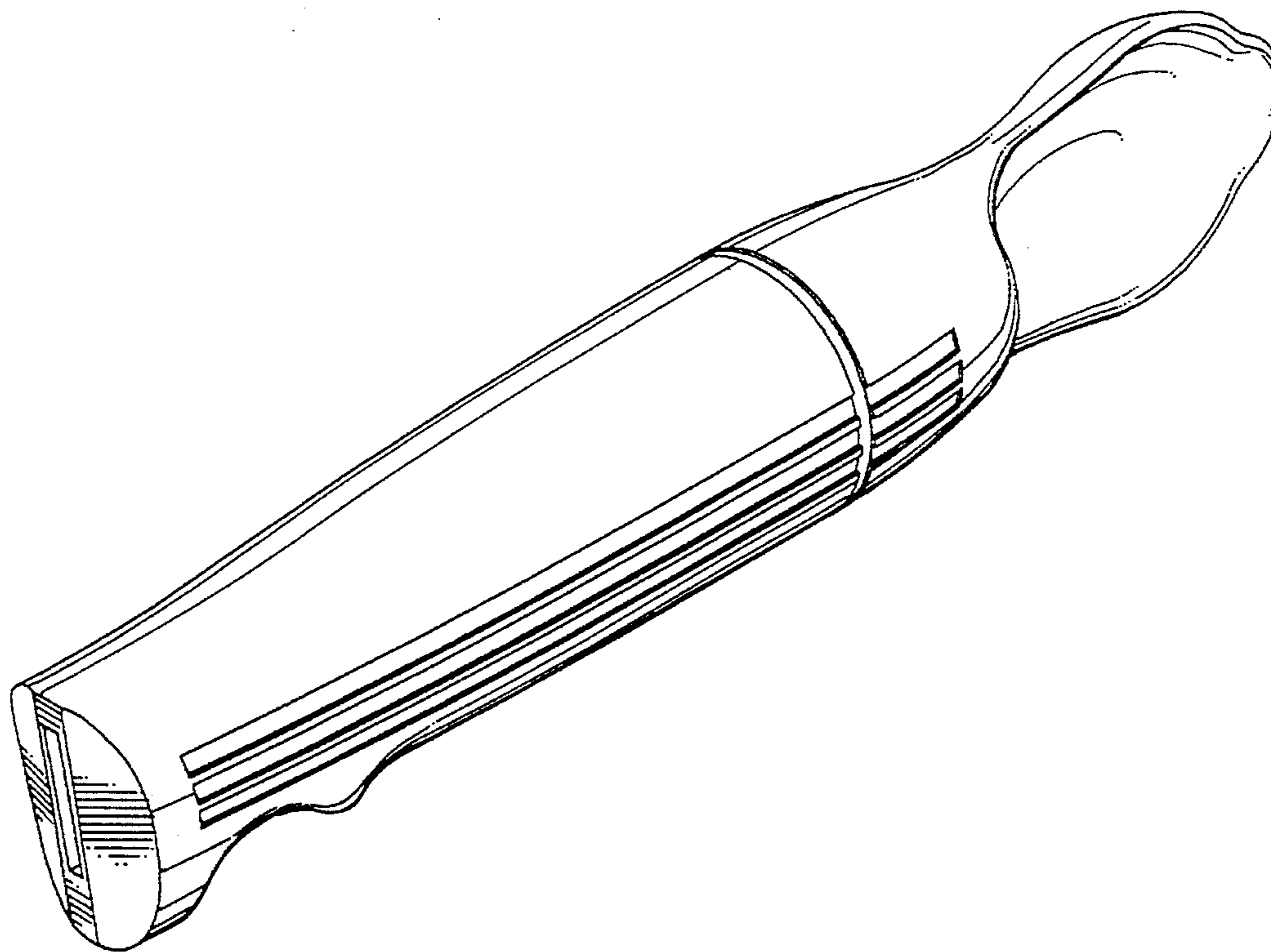
## [57] CLAIM

The ornamental design for a handle for a knife, as shown and described.

## DESCRIPTION

FIG. 1 is a top plan view of a handle for knife having ornamental design in accordance with the present design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a cross-sectional view thereof taken along line 6—6 of FIG. 1;  
FIG. 7 is a cross-sectional view thereof taken along line 7—7 of FIG. 2;  
FIG. 8 is a cross-sectional view thereof taken along line 8—8 of FIG. 1;  
FIG. 9 is an exploded view thereof;  
FIG. 10 is a reduced front elevational view thereof, wherein the broken line showing of the blade is for illustrative purposes only and forms no part of the claimed design;  
FIG. 11 is a front perspective view thereof; and,  
FIG. 12 is a rear perspective view thereof.

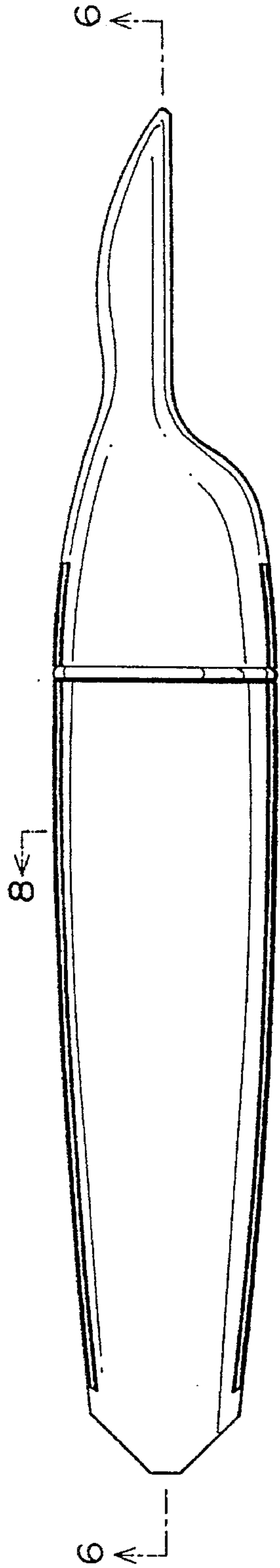

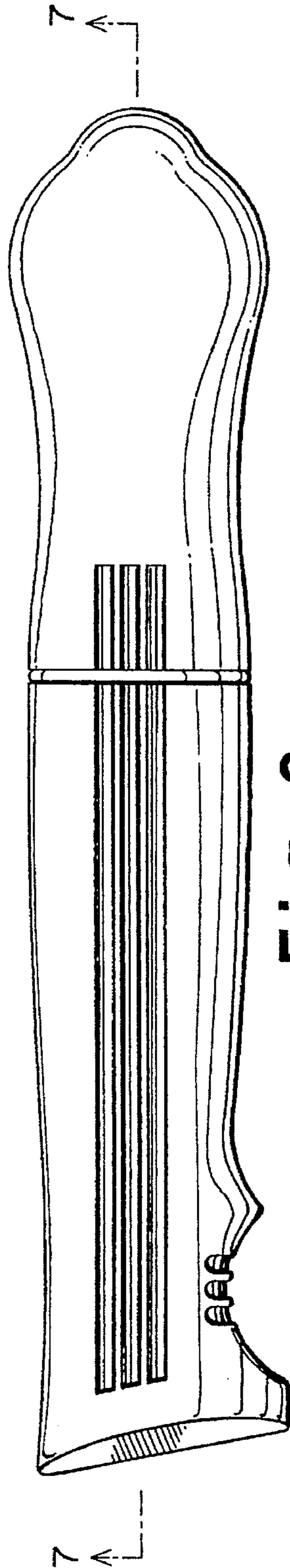

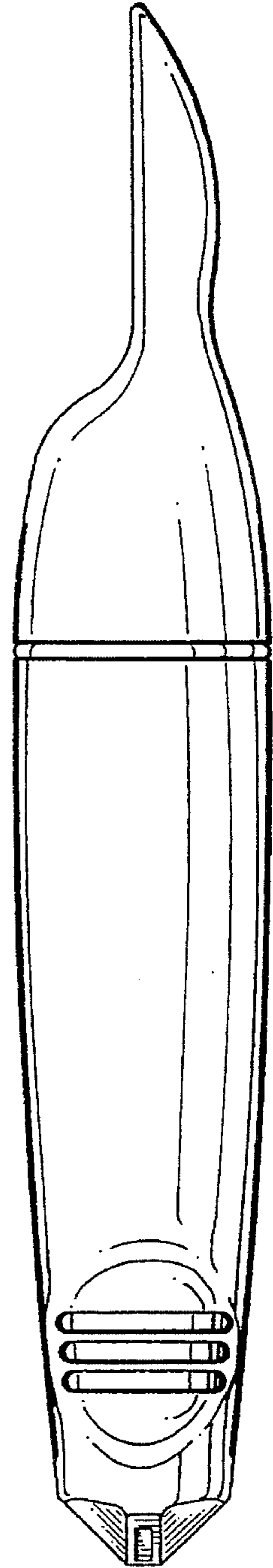
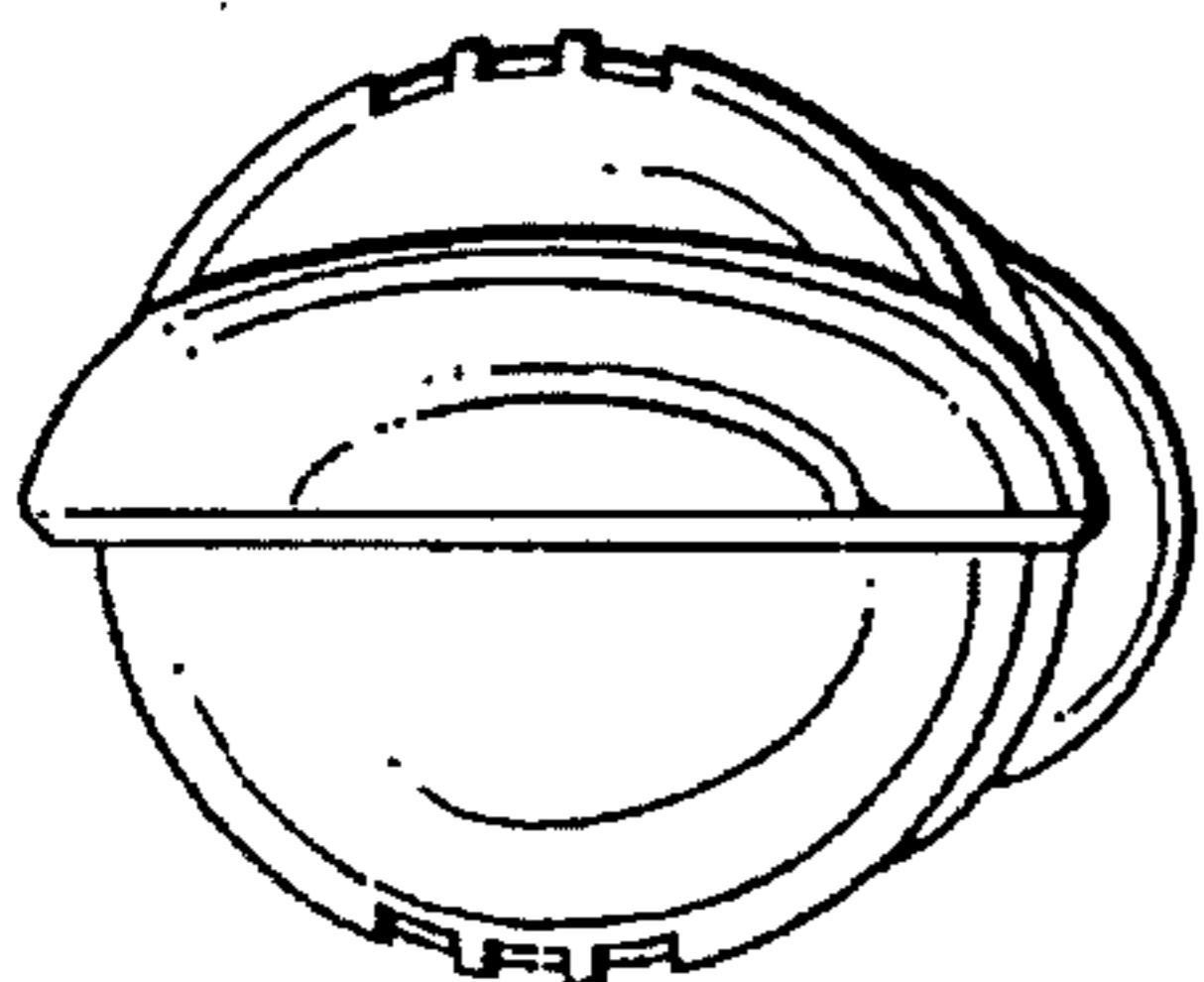
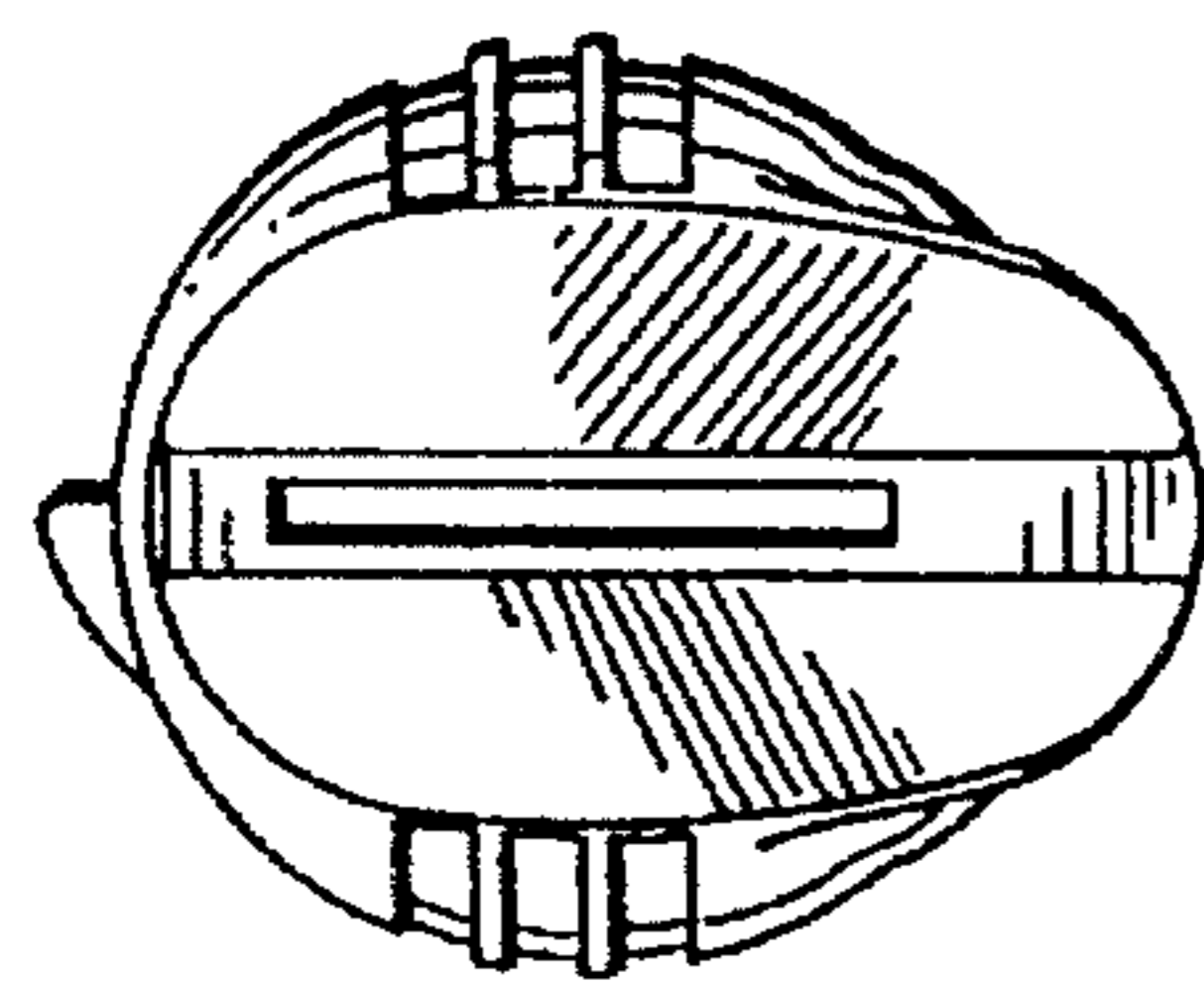


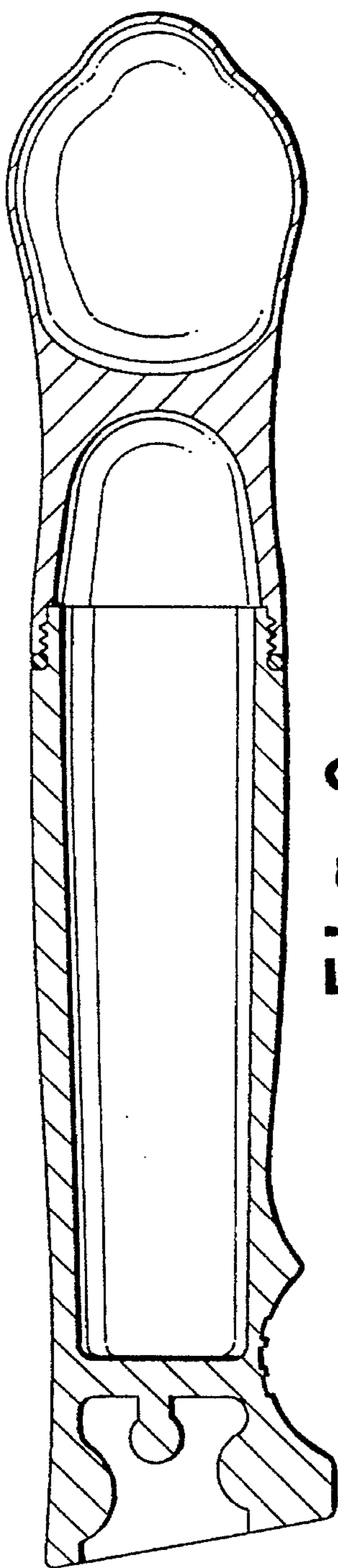

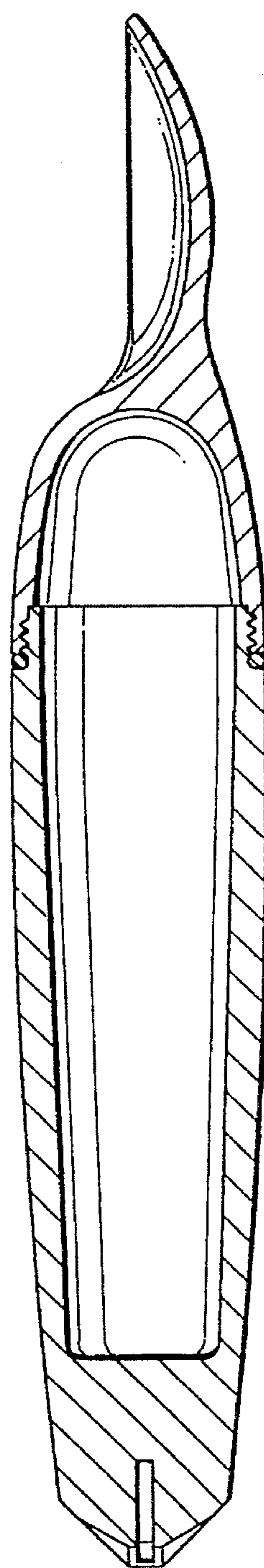

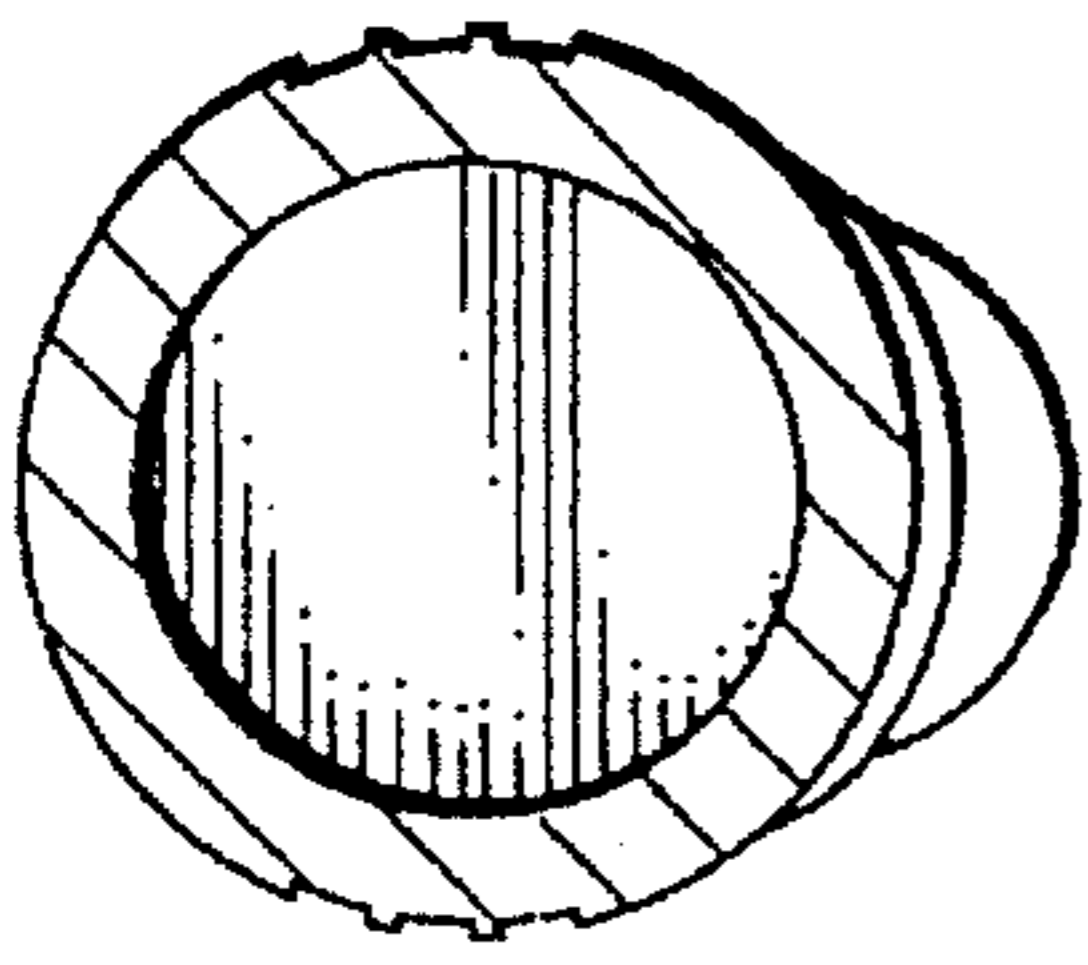

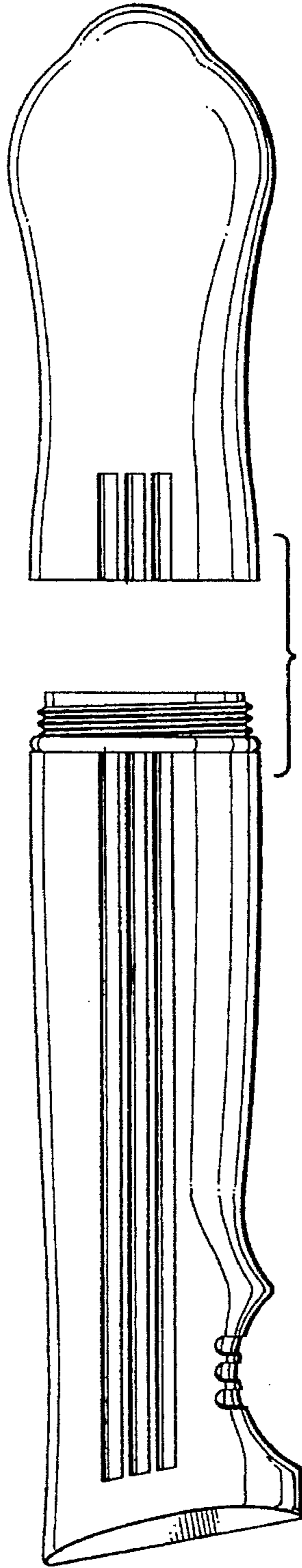

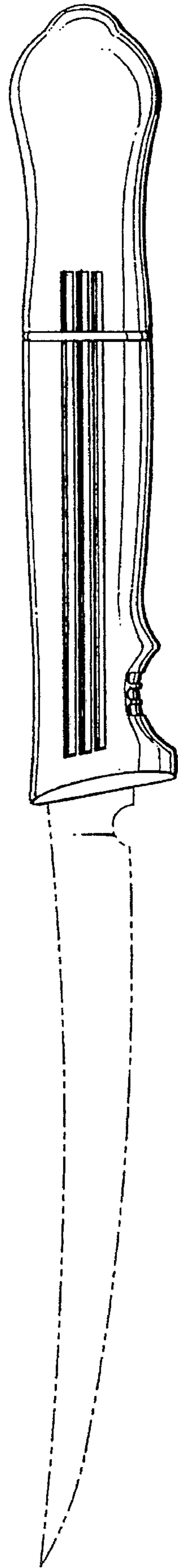

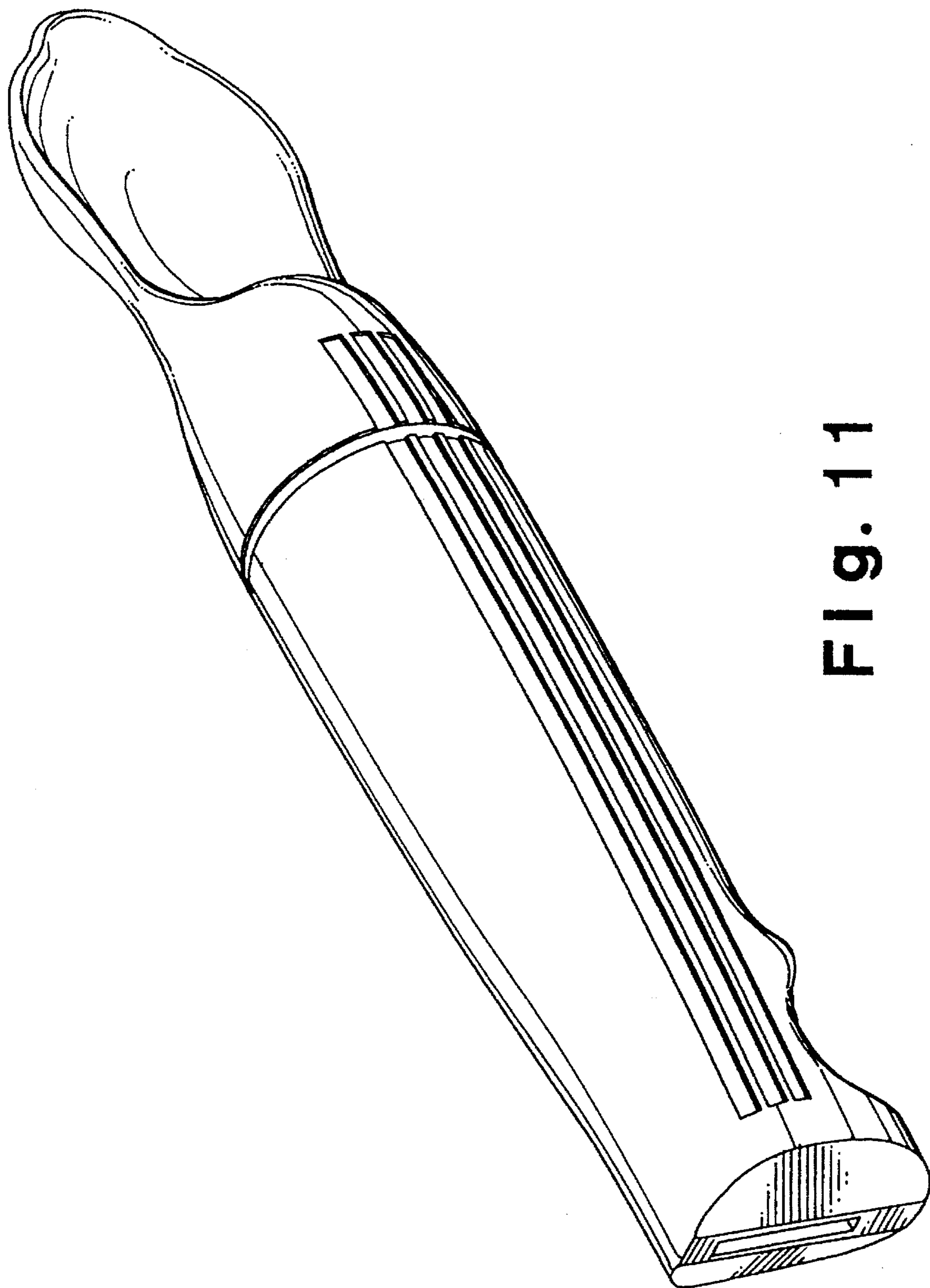
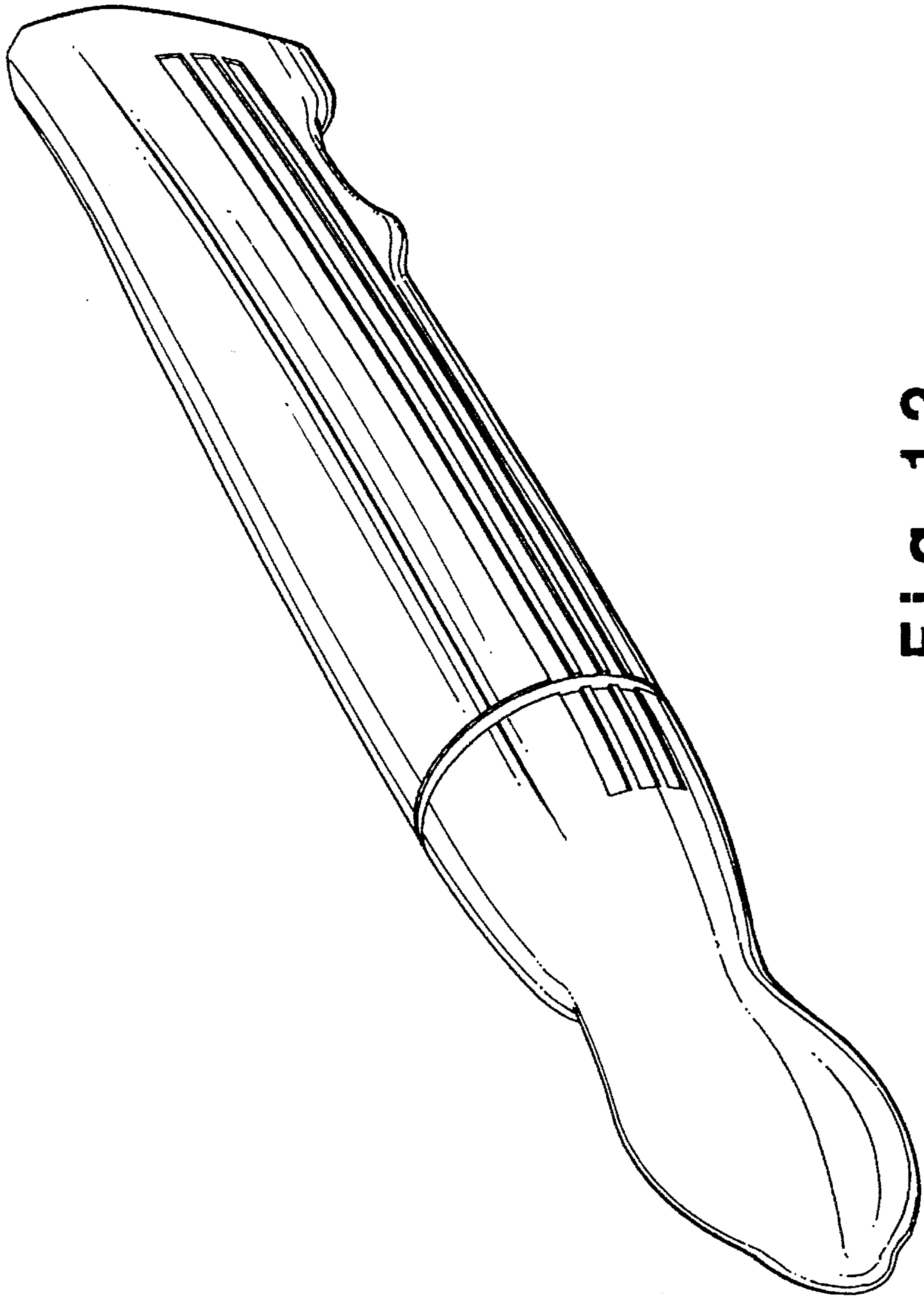
