## [57] CLAIM

The ornamental design for a combined bottle and cap, as shown and described.

## DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a combined bottle and cap showing our new design; FIG. 2 is a right side elevation thereof, the left side elevation is the same;

FIG. 3 is a front elevation thereof, the rear elevation is the same;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a top, front and right side perspective view of a second embodiment of the combined bottle and cap;

FIG. 7 is a right side elevation of FIG. 6, the left side elevation is the same;

FIG. 8 is a front elevation of FIG. 6, the rear elevation is the same;

FIG. 9 is a top plan view of the combined bottle and cap shown in FIG. 6;

FIG. 10 is a bottom plan view of the combined bottle and cap as shown in FIG. 6;

FIG. 11 is a top, front and right side perspective view of a third embodiment of the combined bottle and cap;

FIG. 12 is a right side elevation of FIG. 11, the left side elevation is the same;

FIG. 13 is a front elevation of FIG. 11, the rear elevation is the same;

FIG. 14 is a top plan view of the combined bottle and cap shown in FIG. 11;

FIG. 15 is a bottom plan view of the combined bottle and cap as shown in FIG. 11;

FIG. 16 is a top, front and right side perspective view of a fourth embodiment of the combined bottle and cap;


FIG. 17 is a right side elevation of FIG. 16, the left side elevation is a mirror image thereof;

FIG. 18 is a front elevation thereof, the rear elevation is the same except that the rear of the cap lacks the indentation on the front of the cap and has a conventional hinge which is shown in FIGS. 17 and 19;

FIG. 19 is a top plan view of the combined bottle and cap shown in FIG. 16 and,

FIG. 20 is a bottle plan view of the combined bottle and cap as shown in FIG. 16.






































