The ornamental design for a flower stem holder for flower vase, as shown and described.

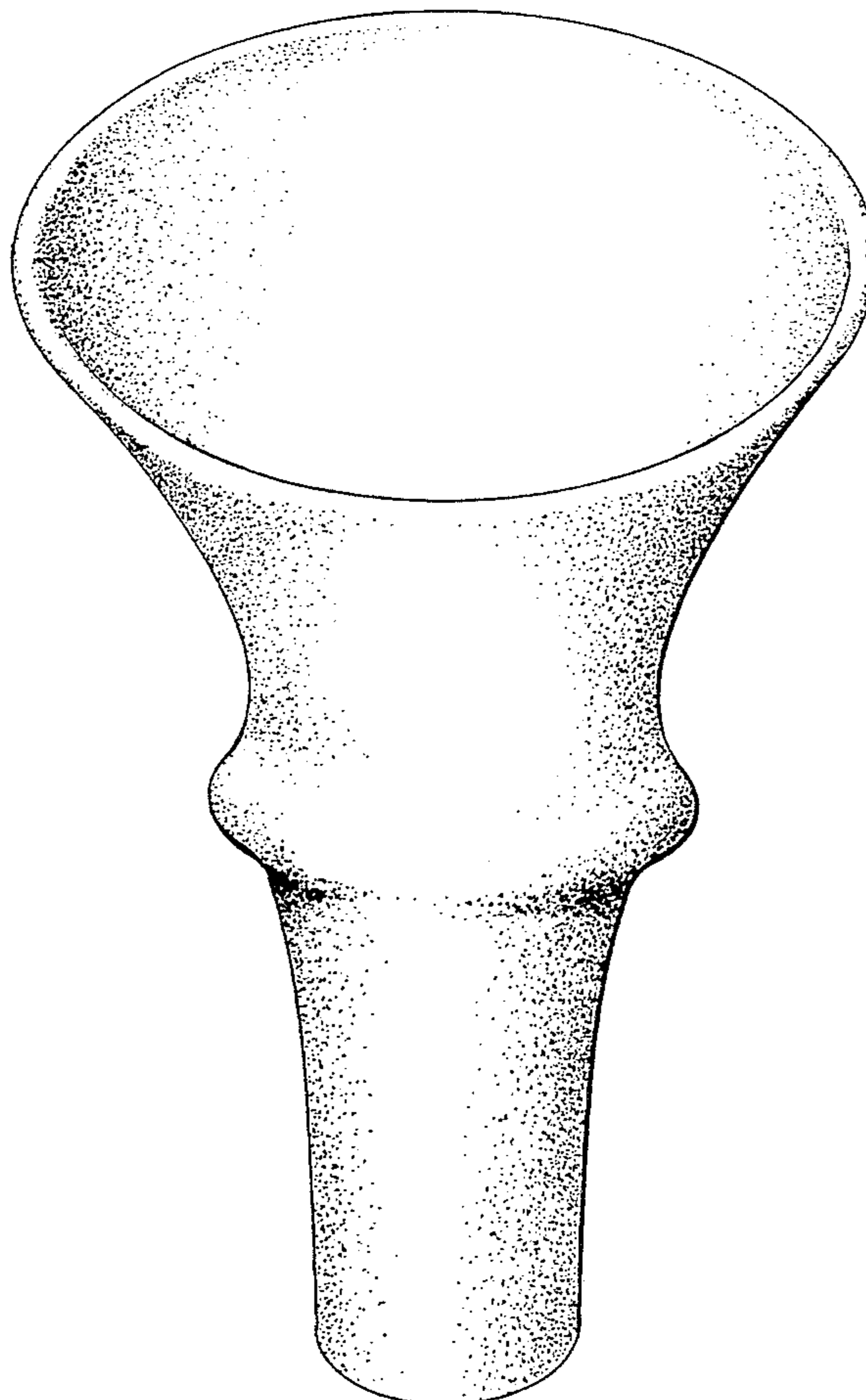
**DESCRIPTION**

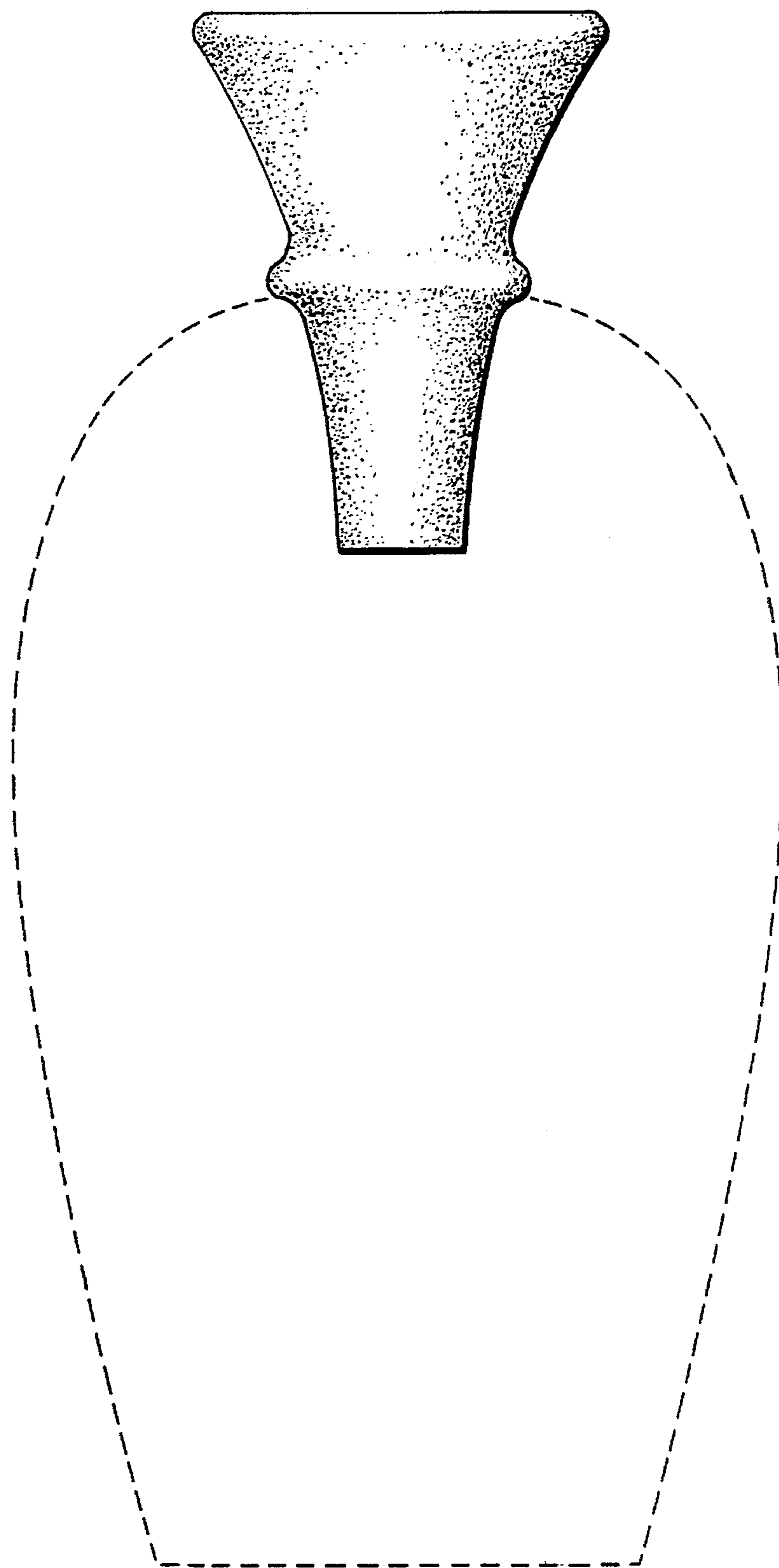
FIG. 1 is a front elevational view with the lower flower vase portion cut away to show the stem holder;

FIG. 3 is a cross-sectional view of the stemholder of FIG. 2.

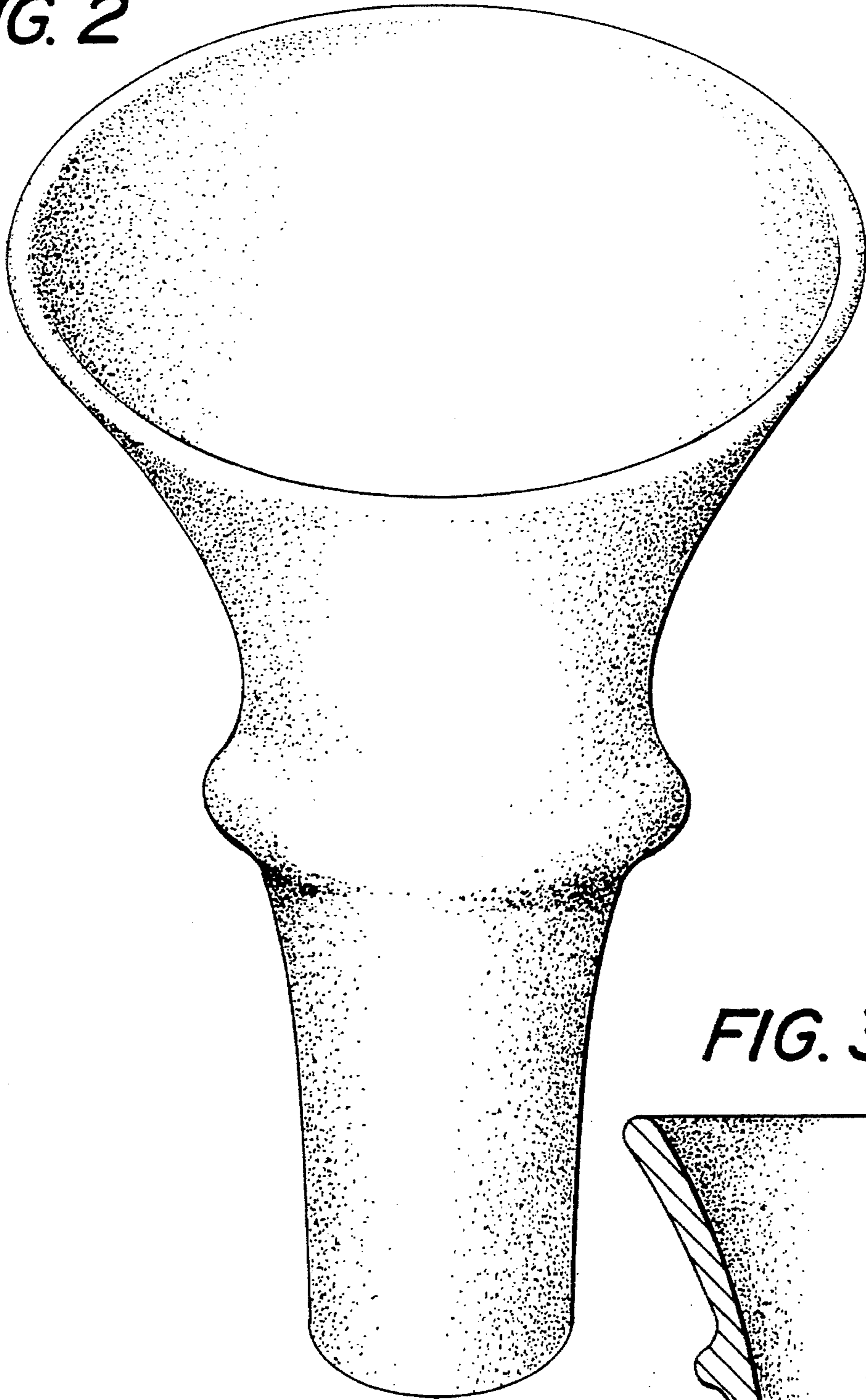
