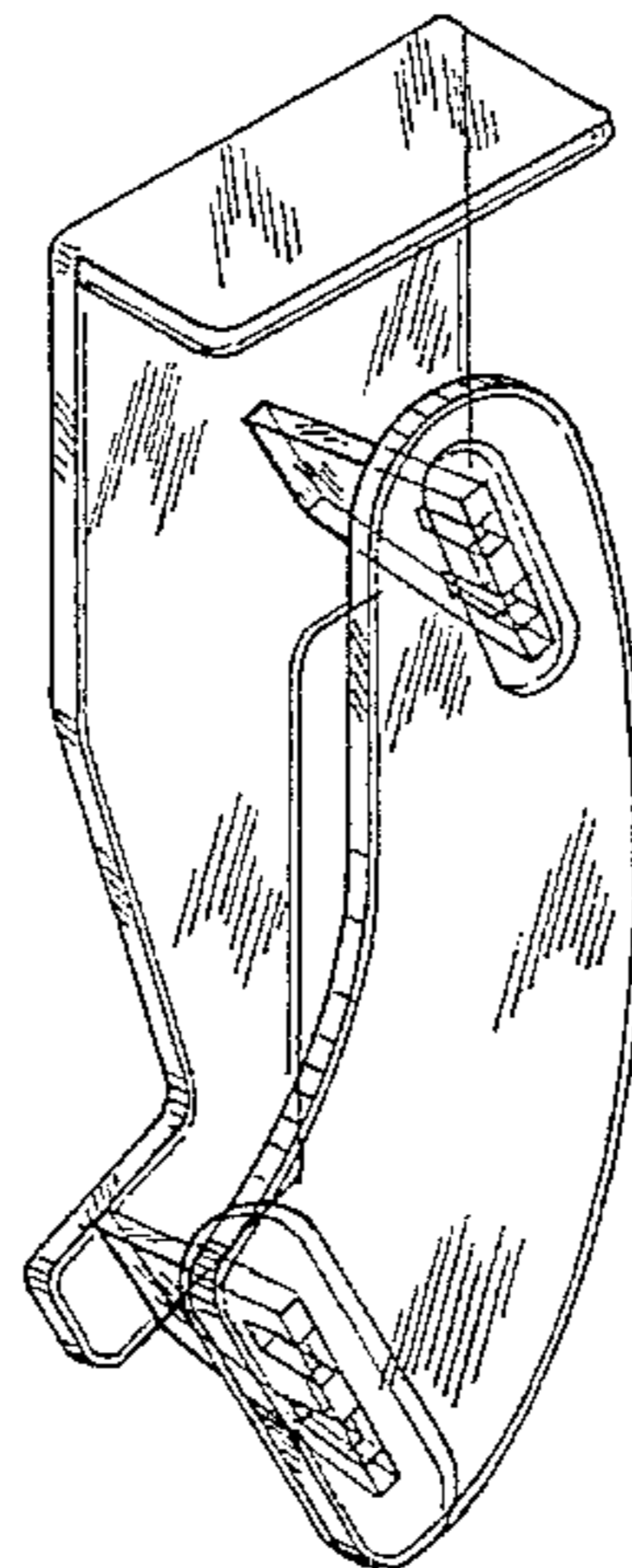
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view, taken from the top and left side of a first embodiment our design for a tool display package;

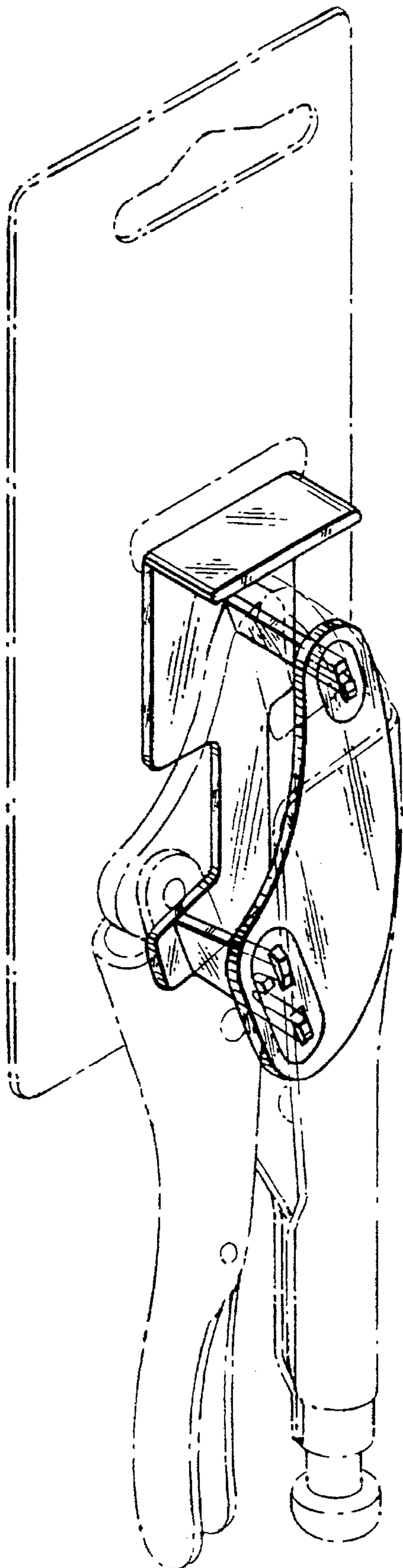

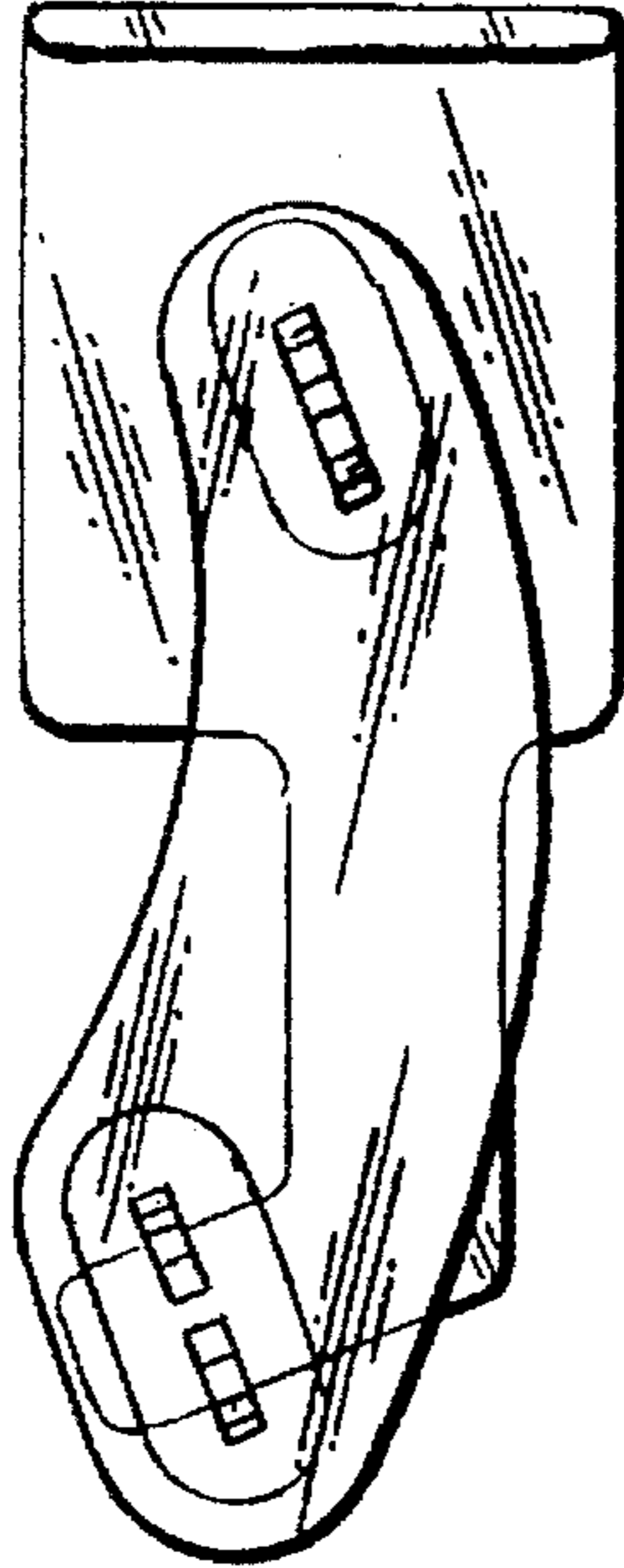

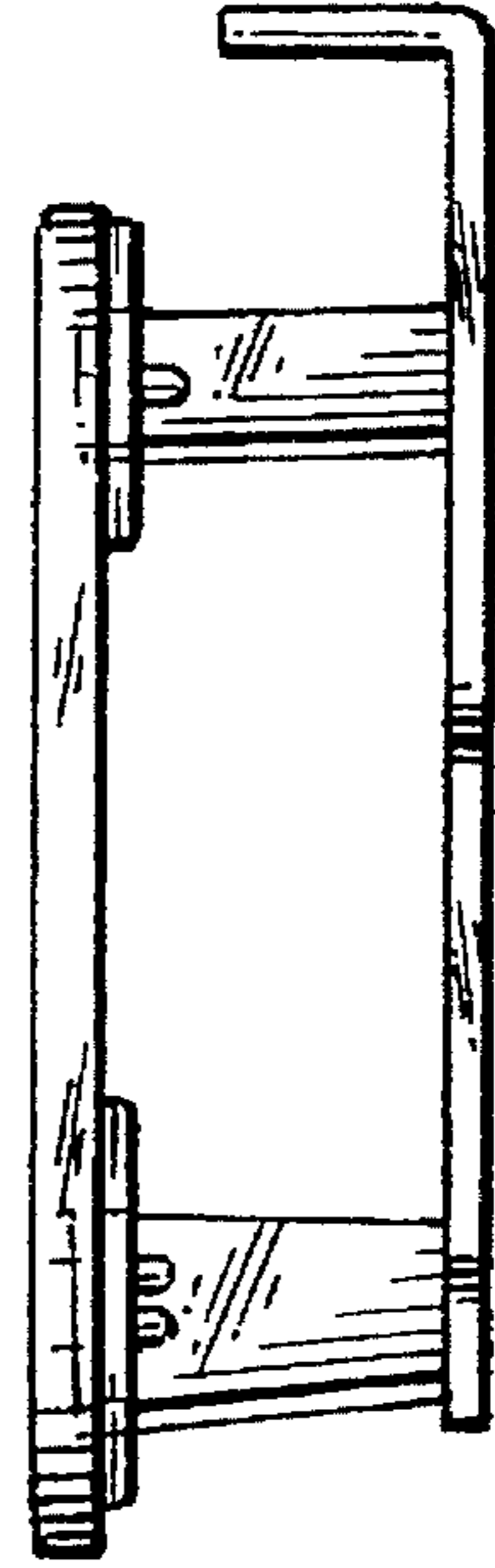

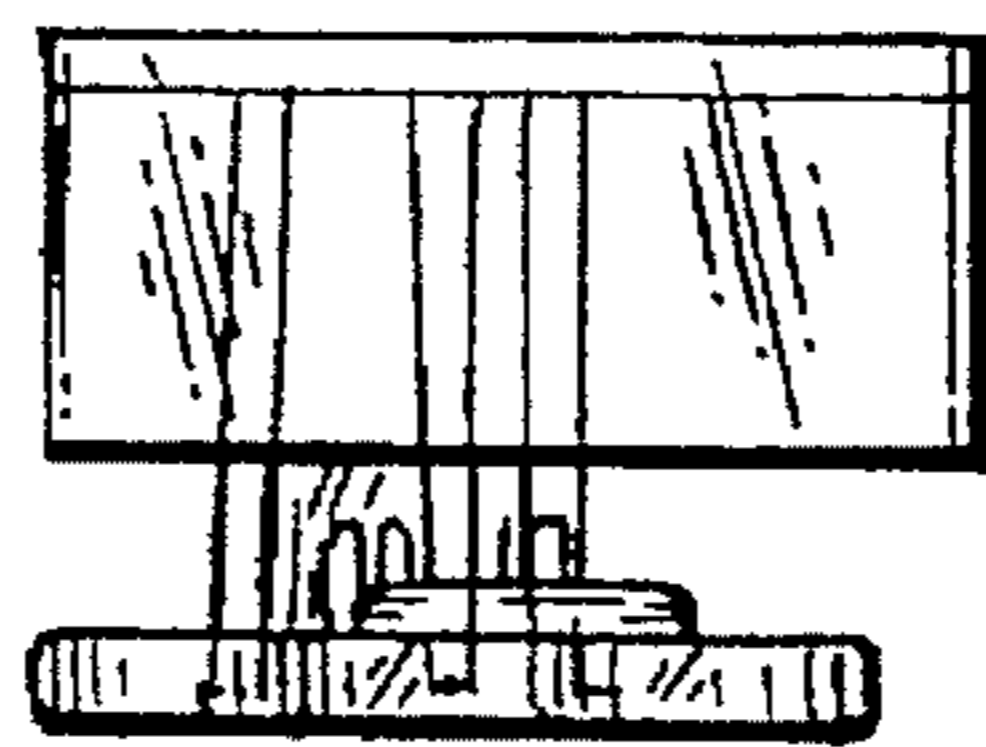

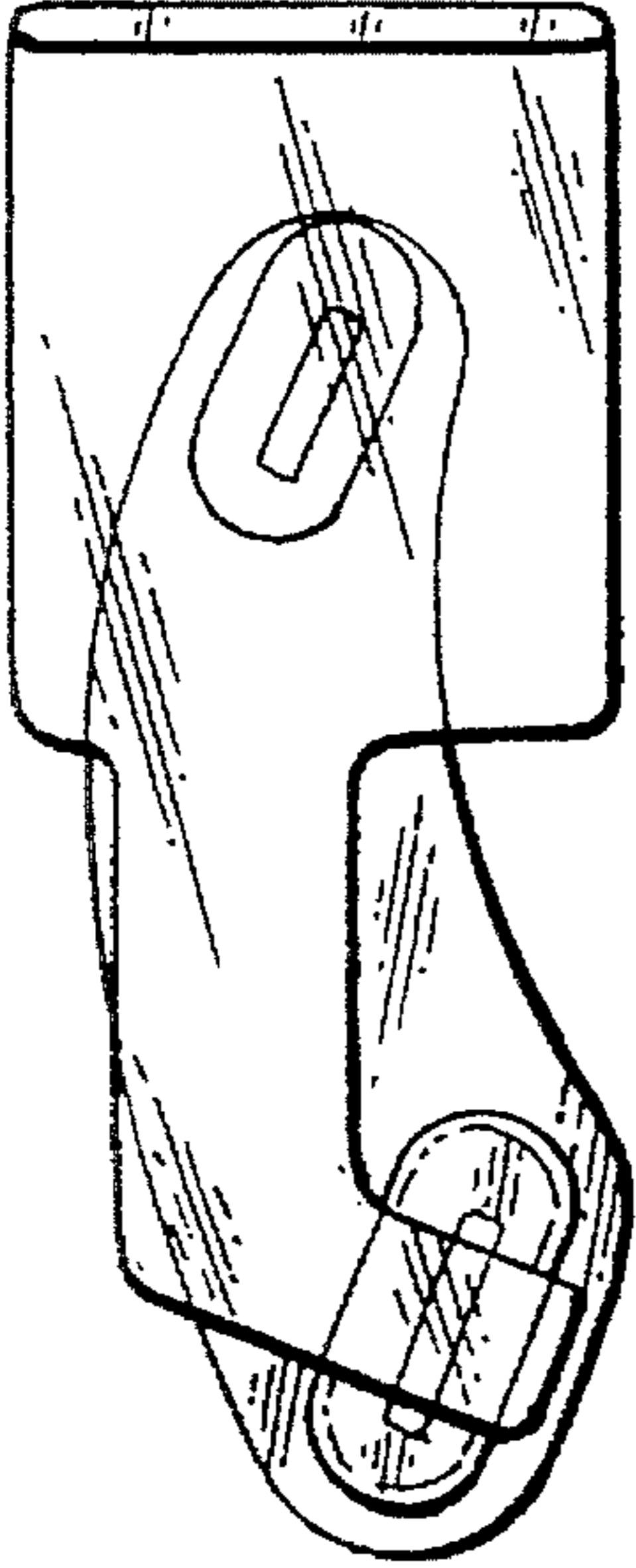

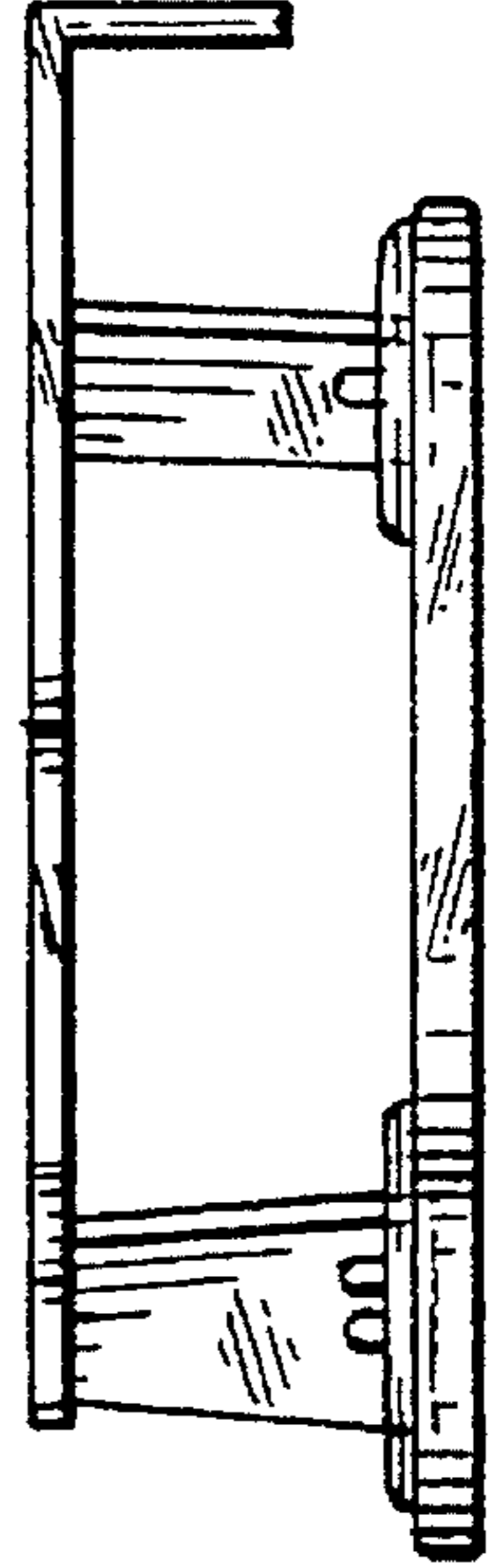

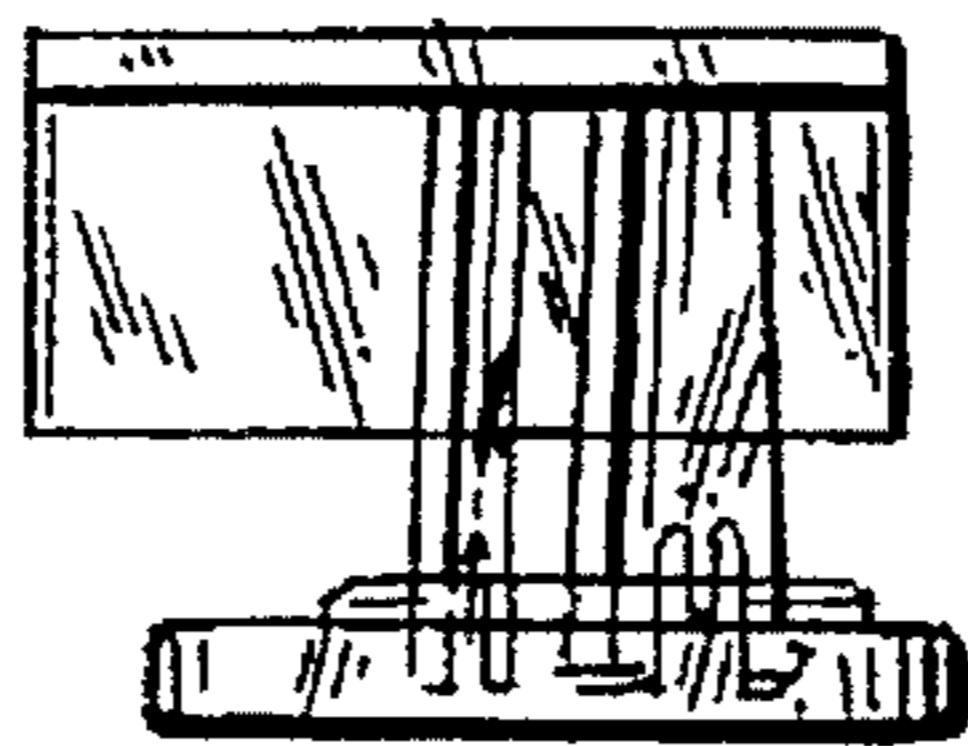

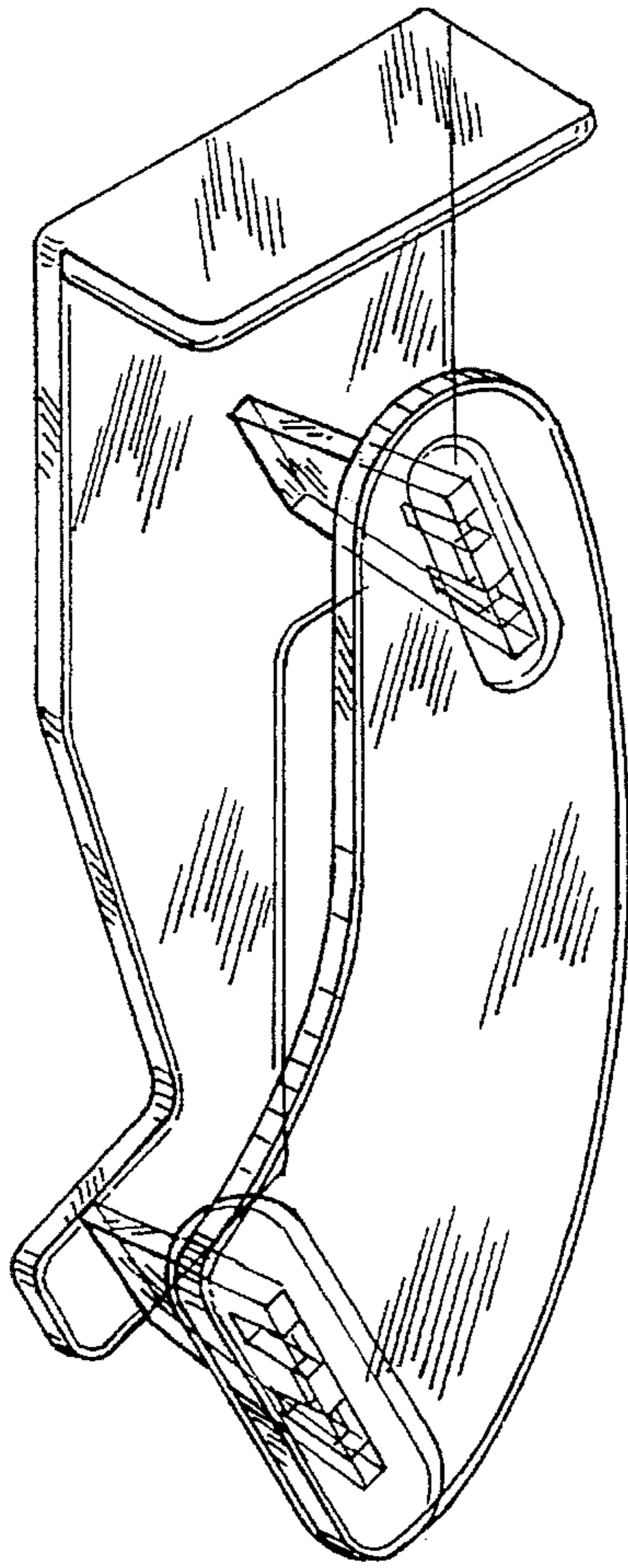

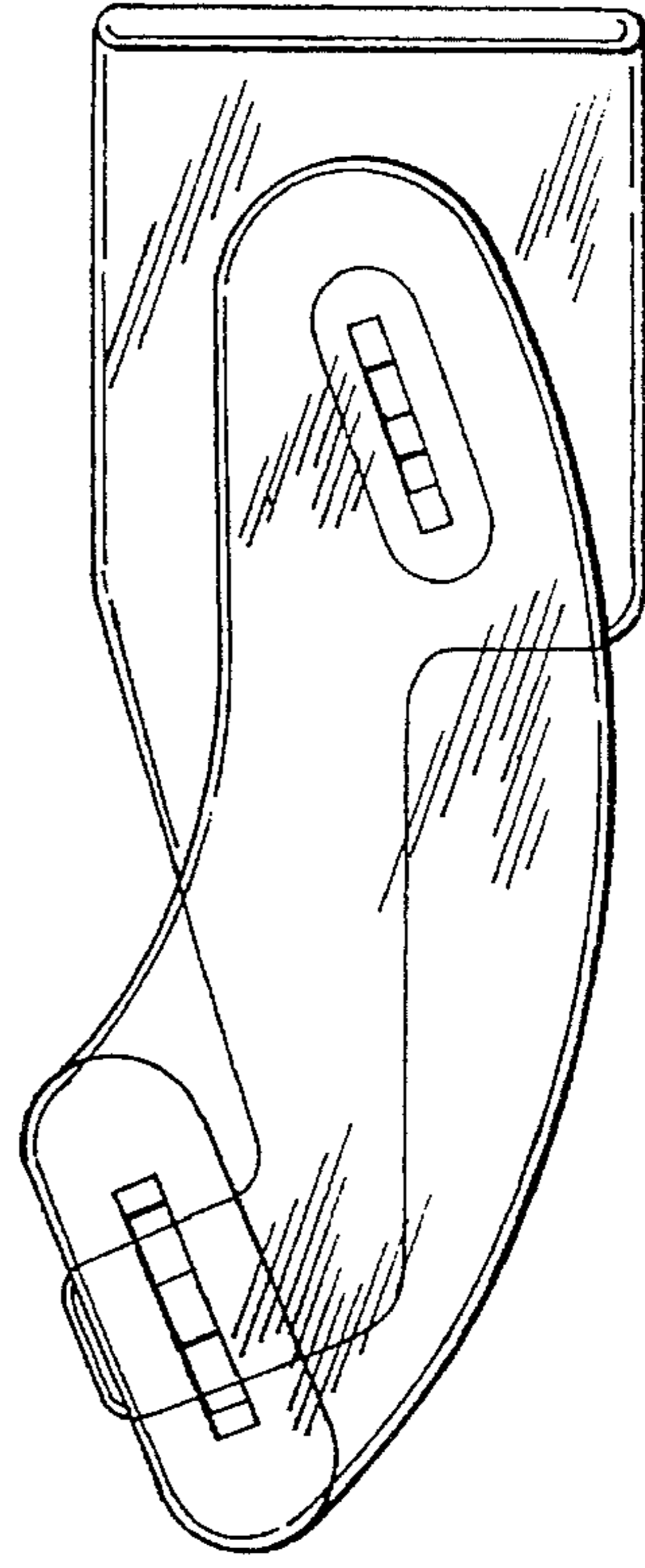

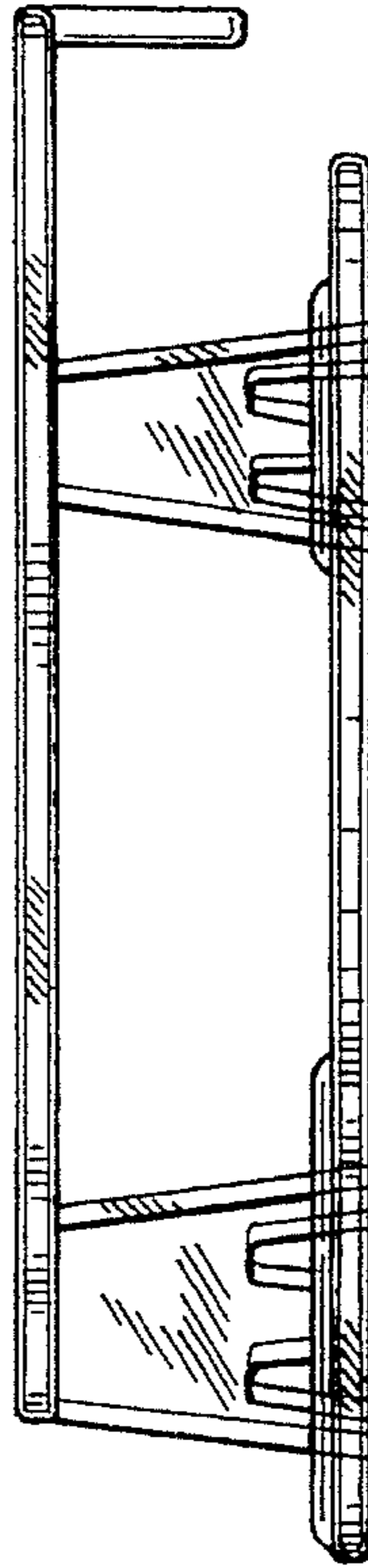

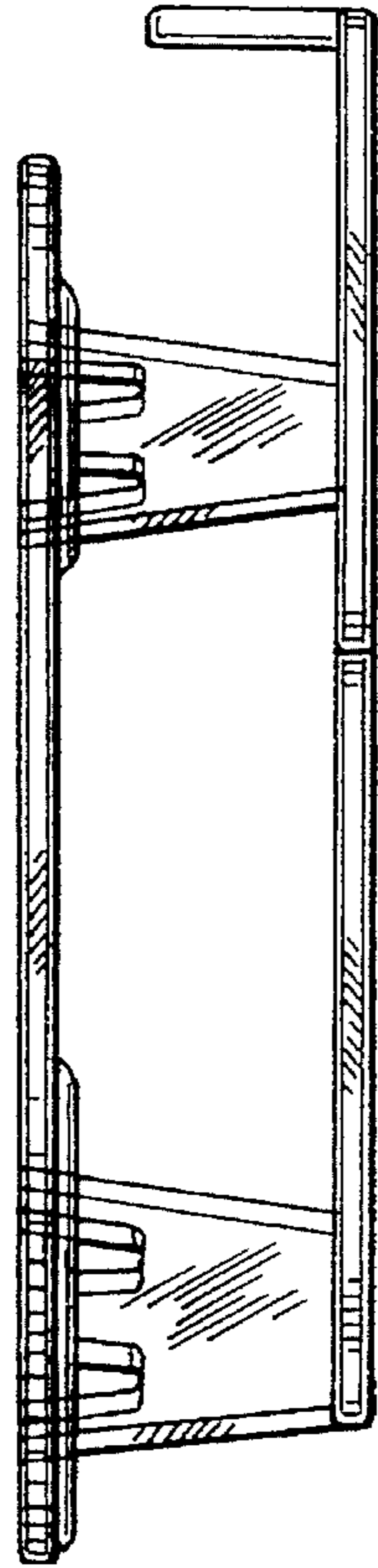

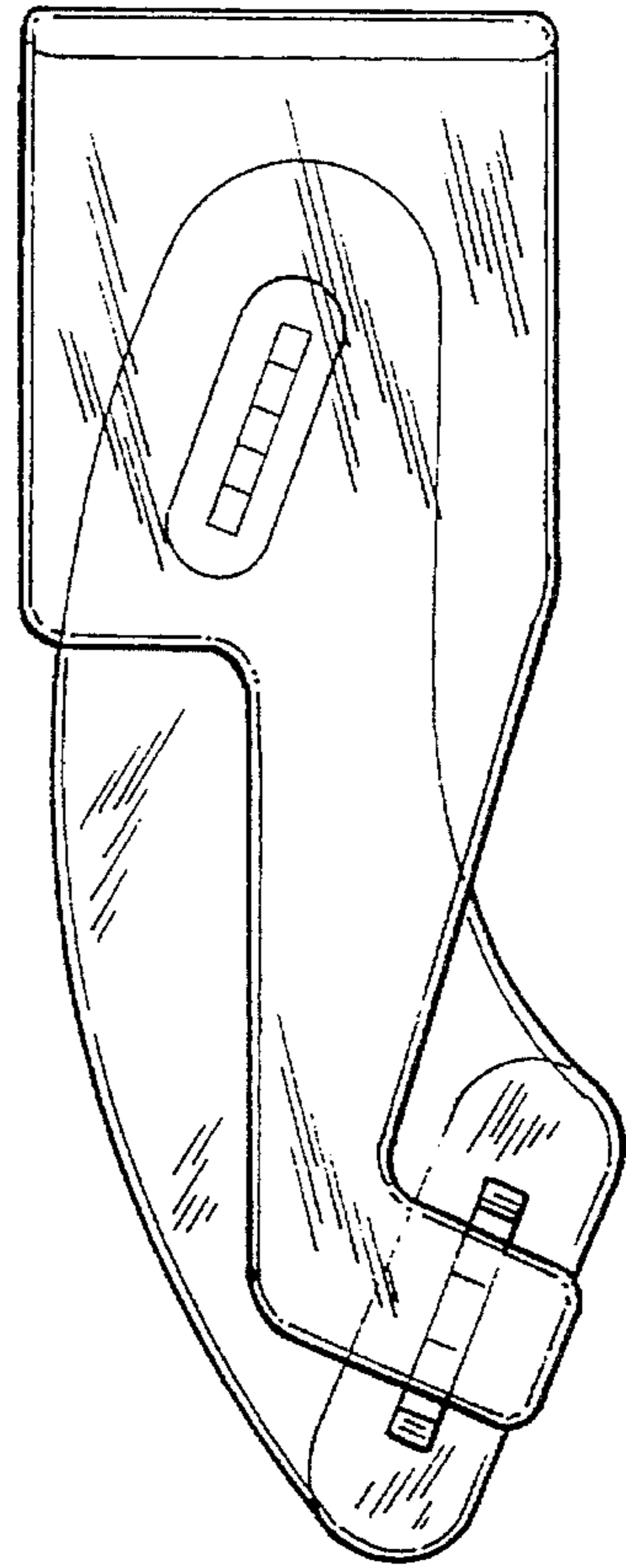

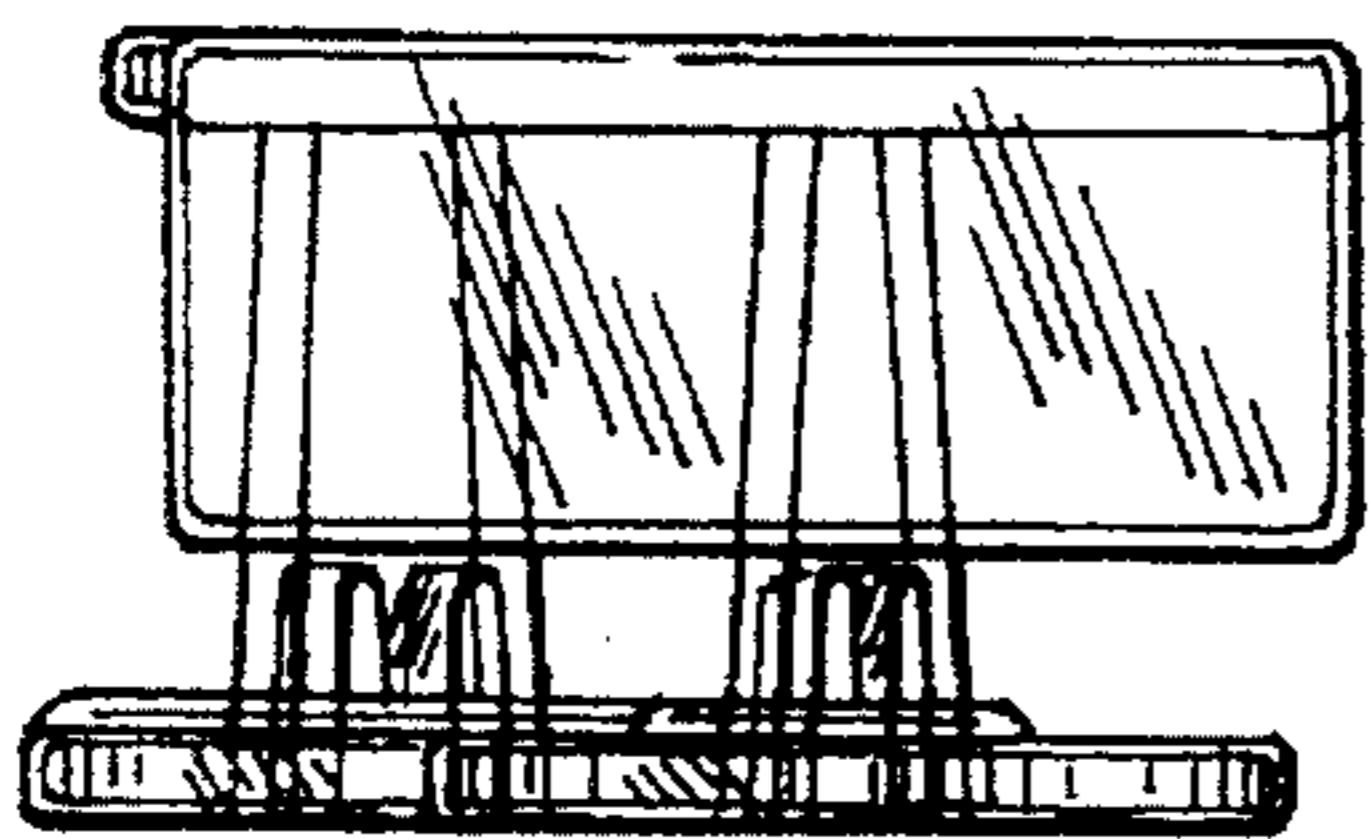

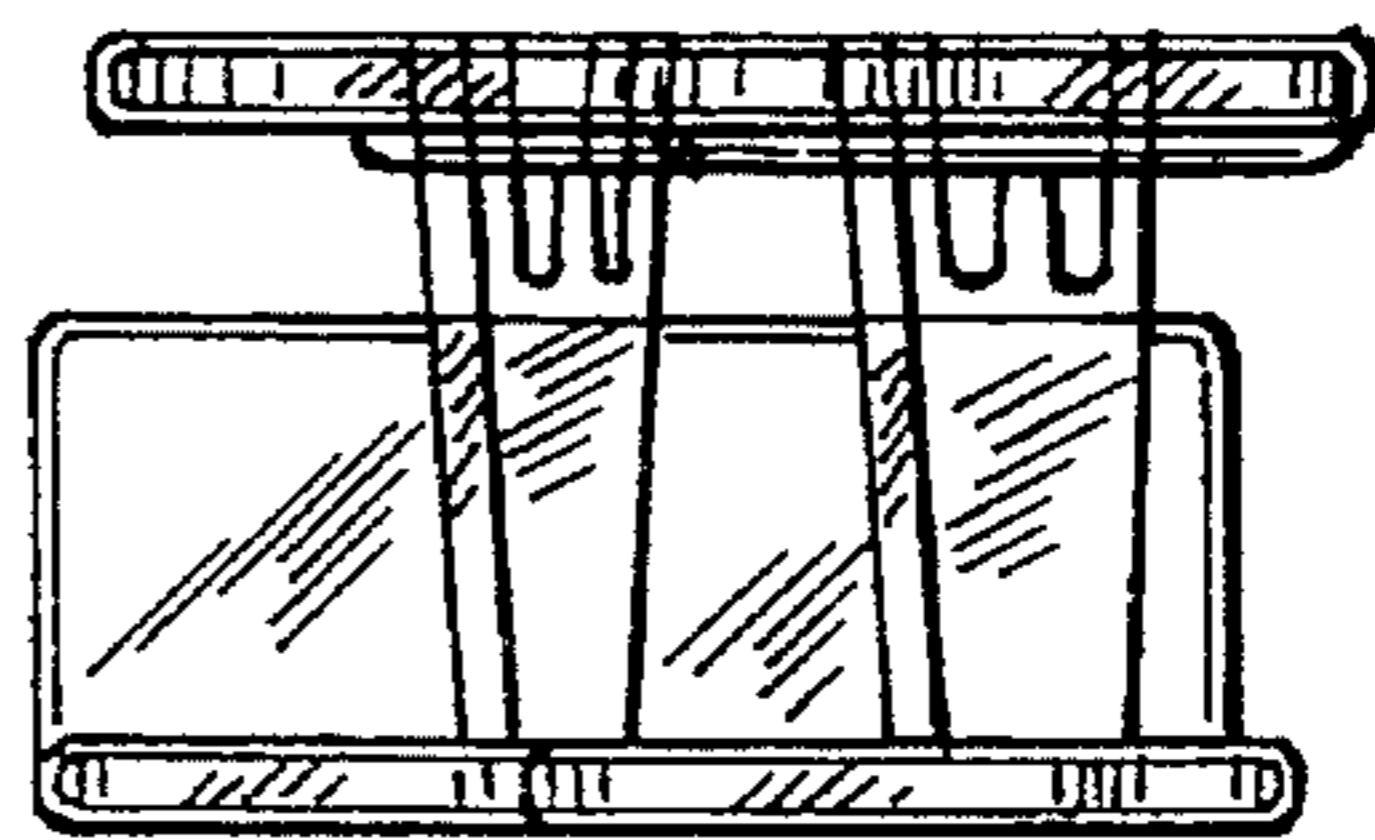

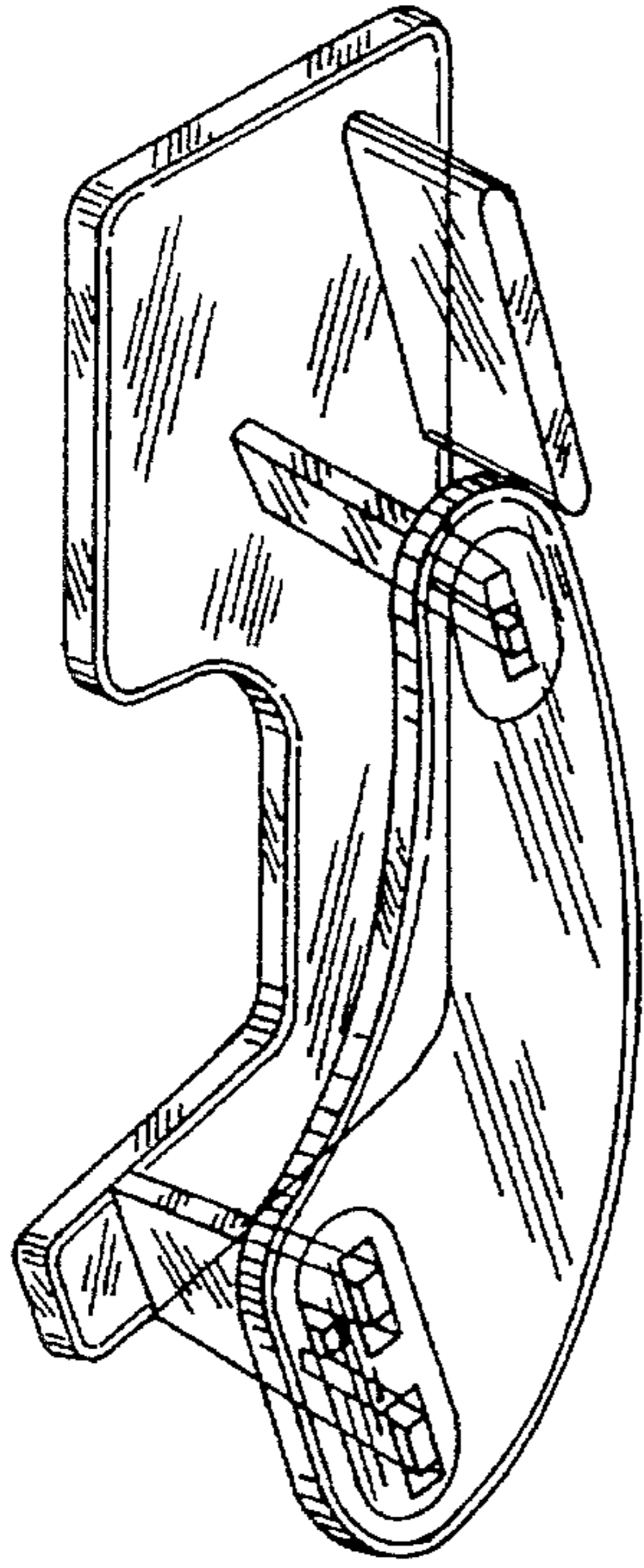

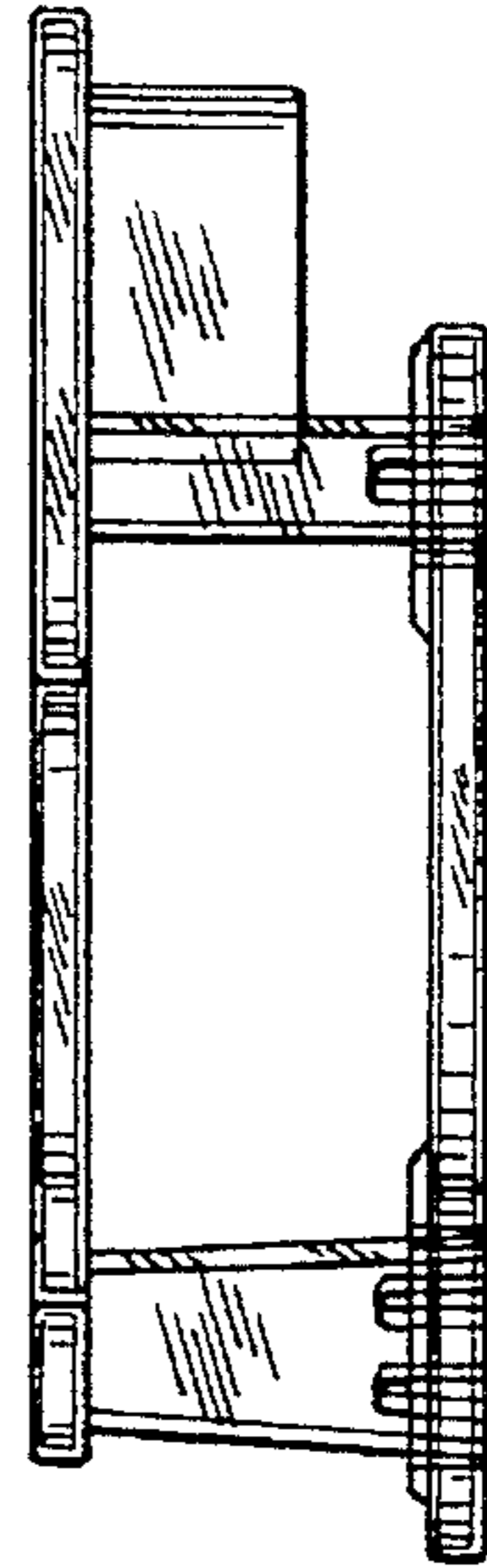

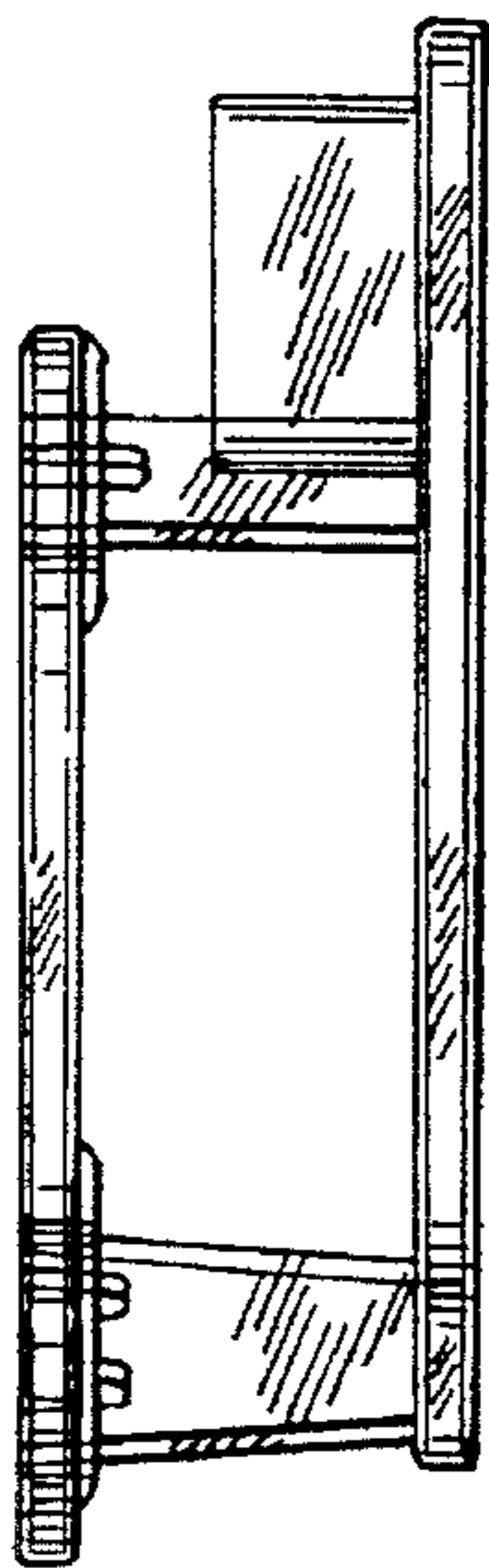

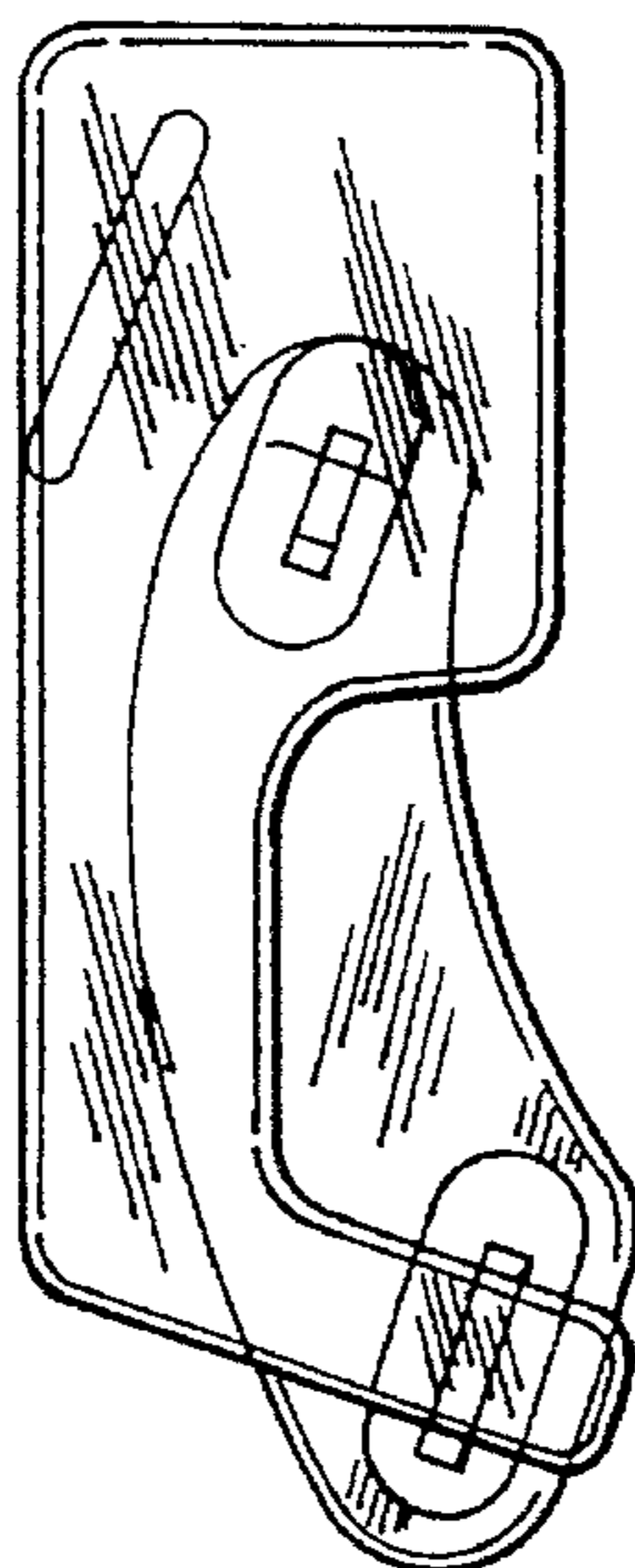

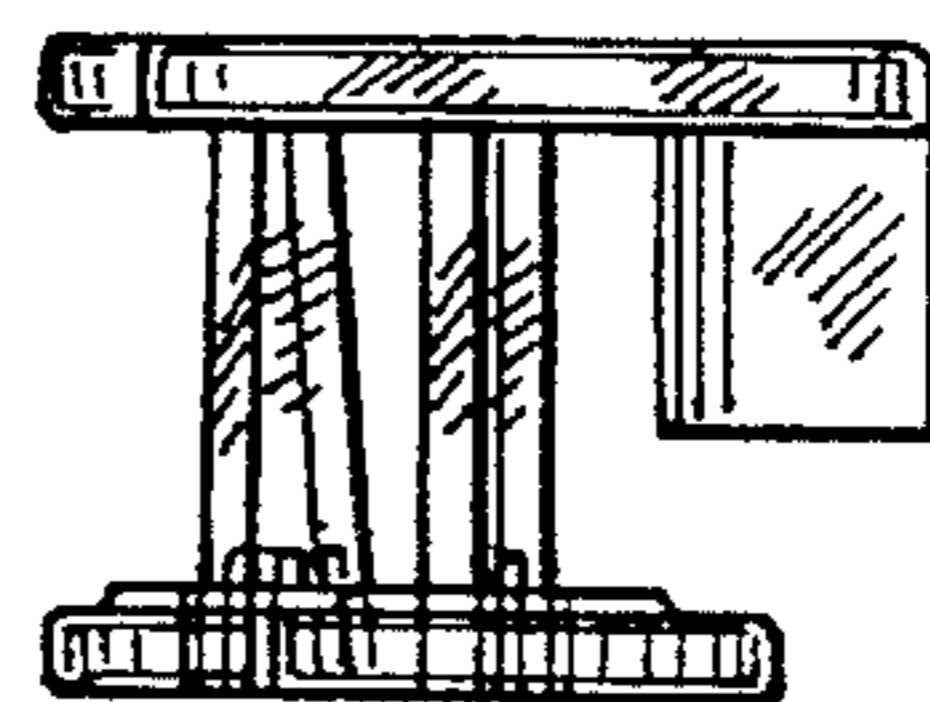

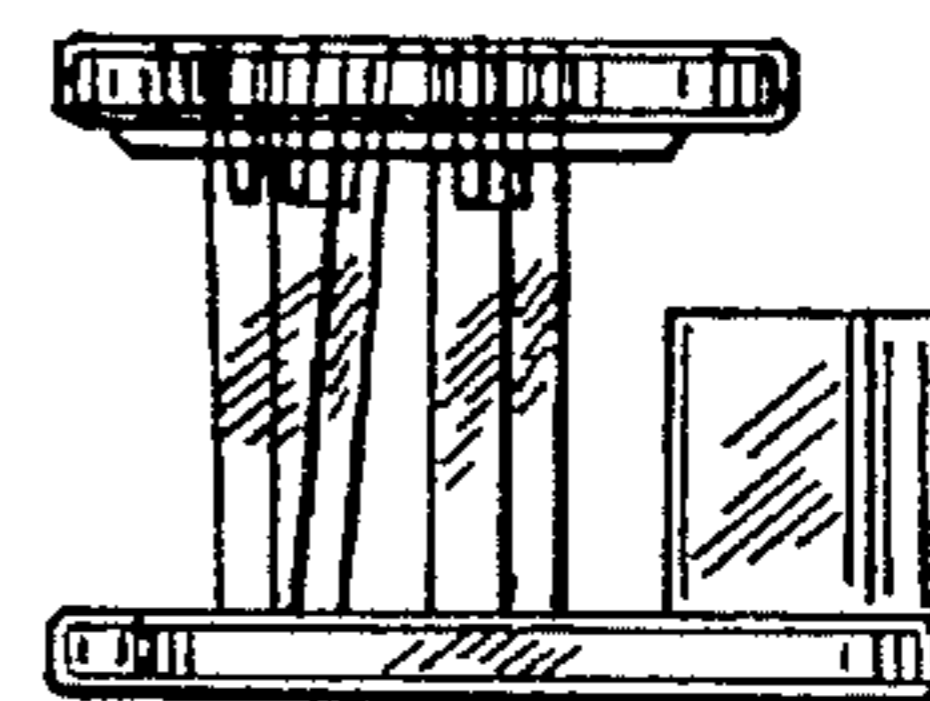

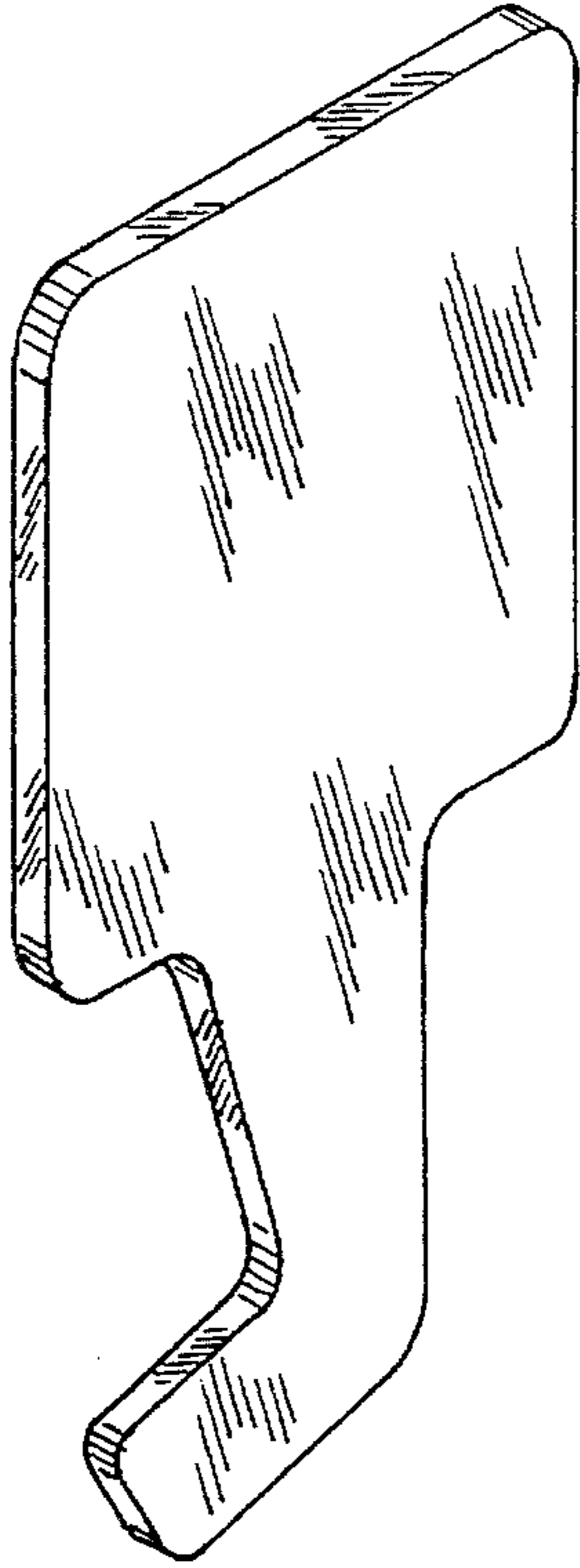

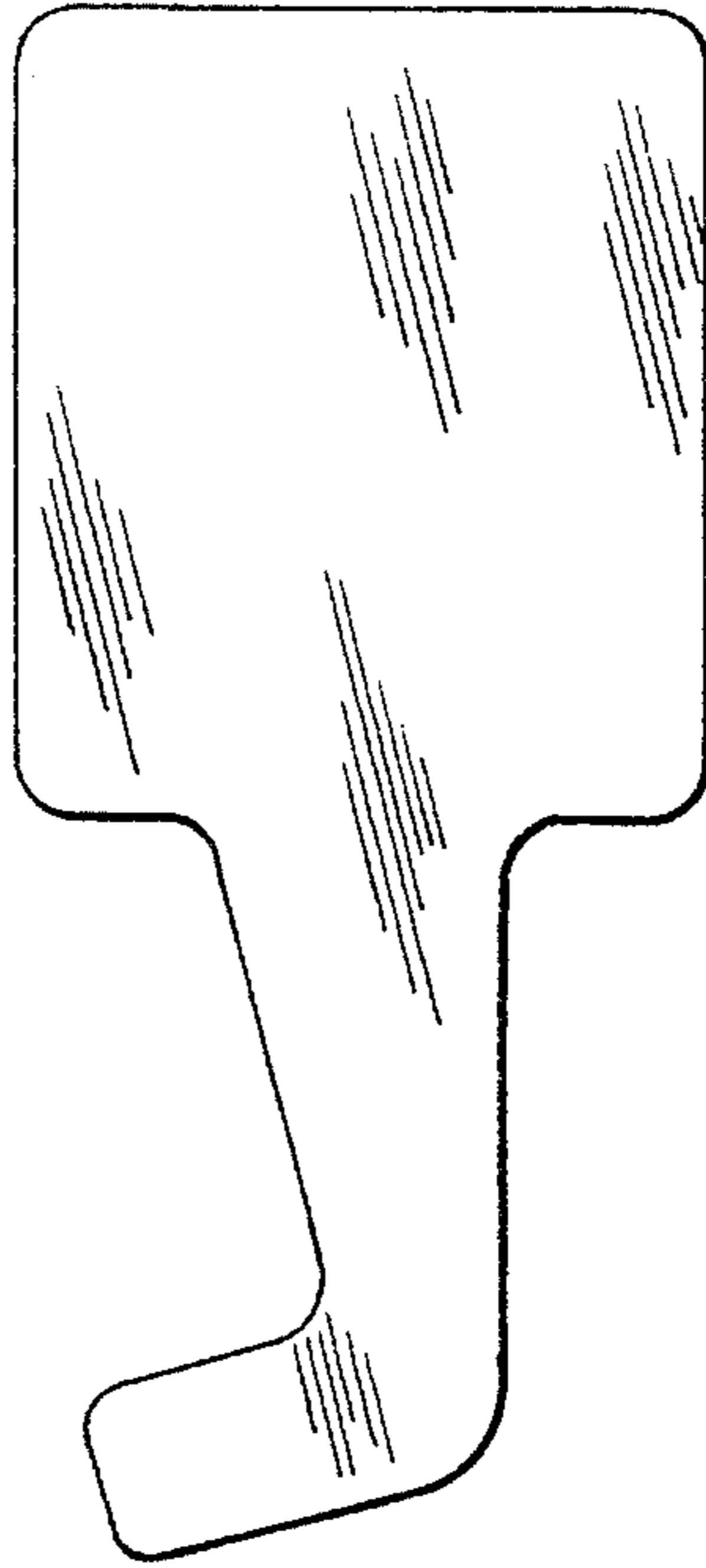

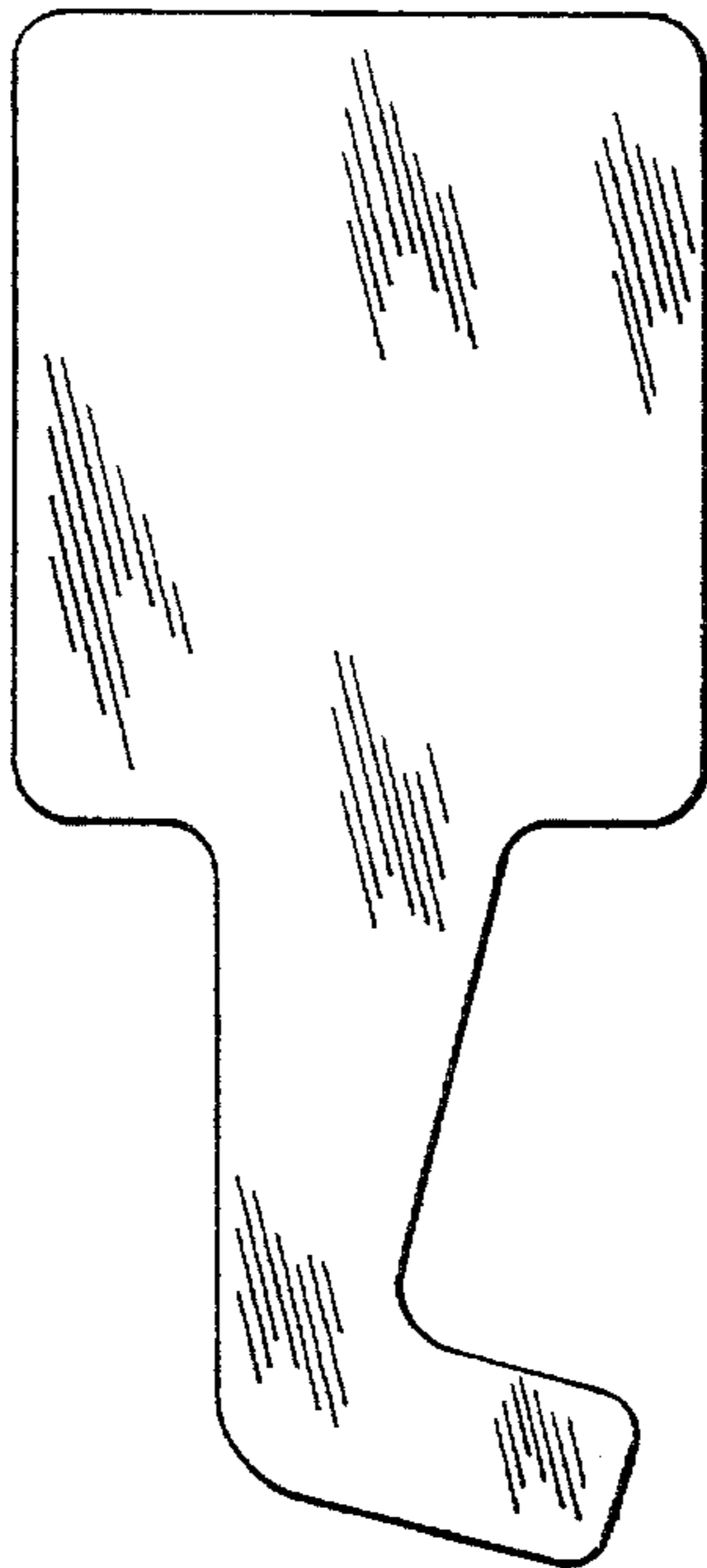
