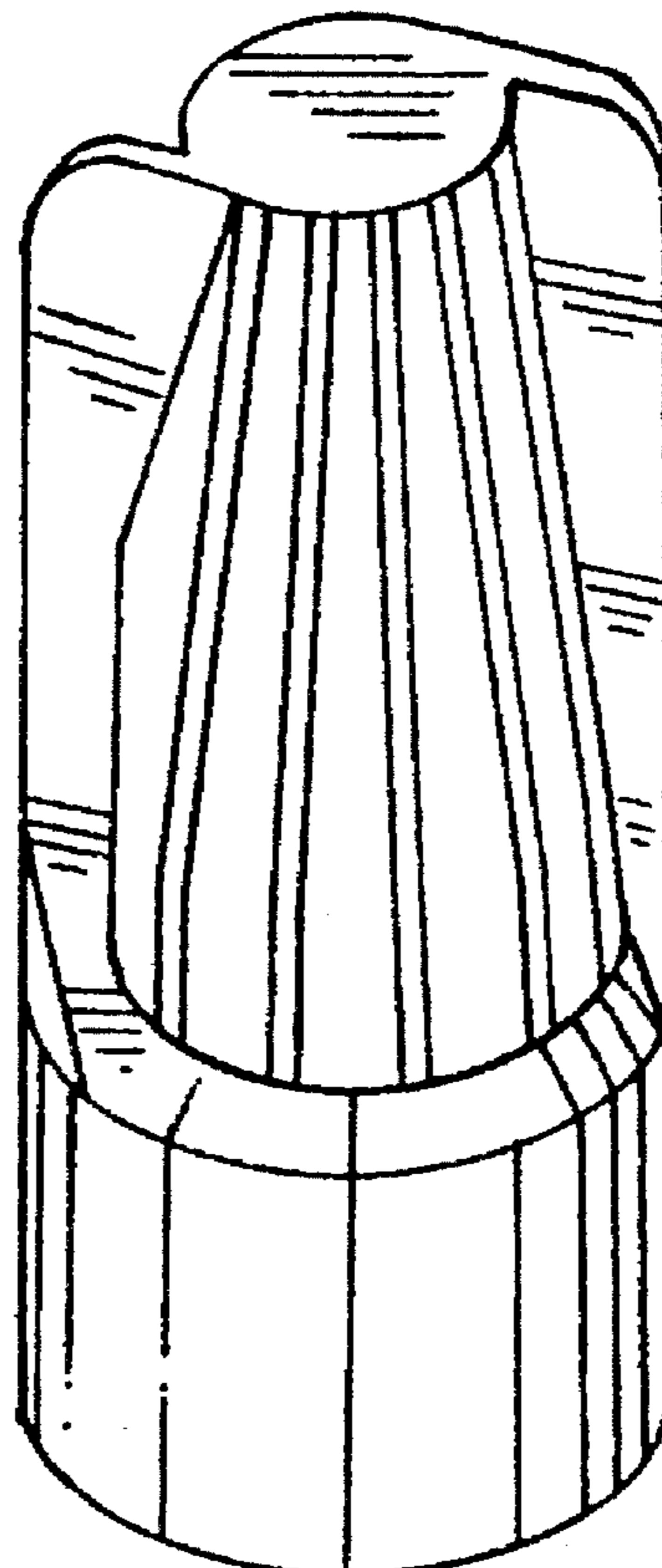
[57] **CLAIM**

The ornamental design for a twist-on electrical connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view illustrating the twist-on electrical connector of the subject invention;  
FIG. 2 is a front elevation view of the connector of FIG. 1. The rear elevation view is identical to such front elevation view;  
FIG. 3 is a right side elevation view of the connector of FIG. 1. The left side elevation view is identical to such right side elevation view;  
FIG. 4 is a top plan view of the connector of FIG. 1; and,  
FIG. 5 is a bottom plan view of the connector of FIG. 1.

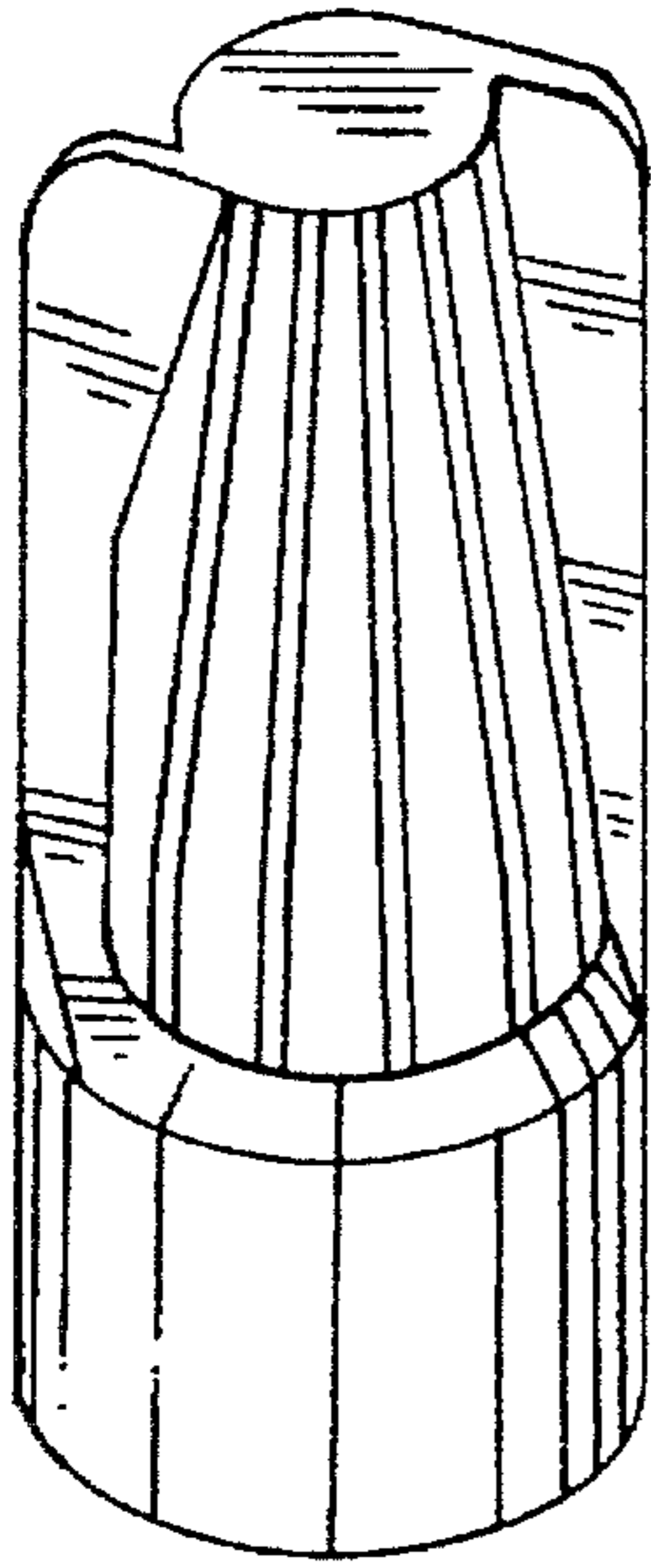

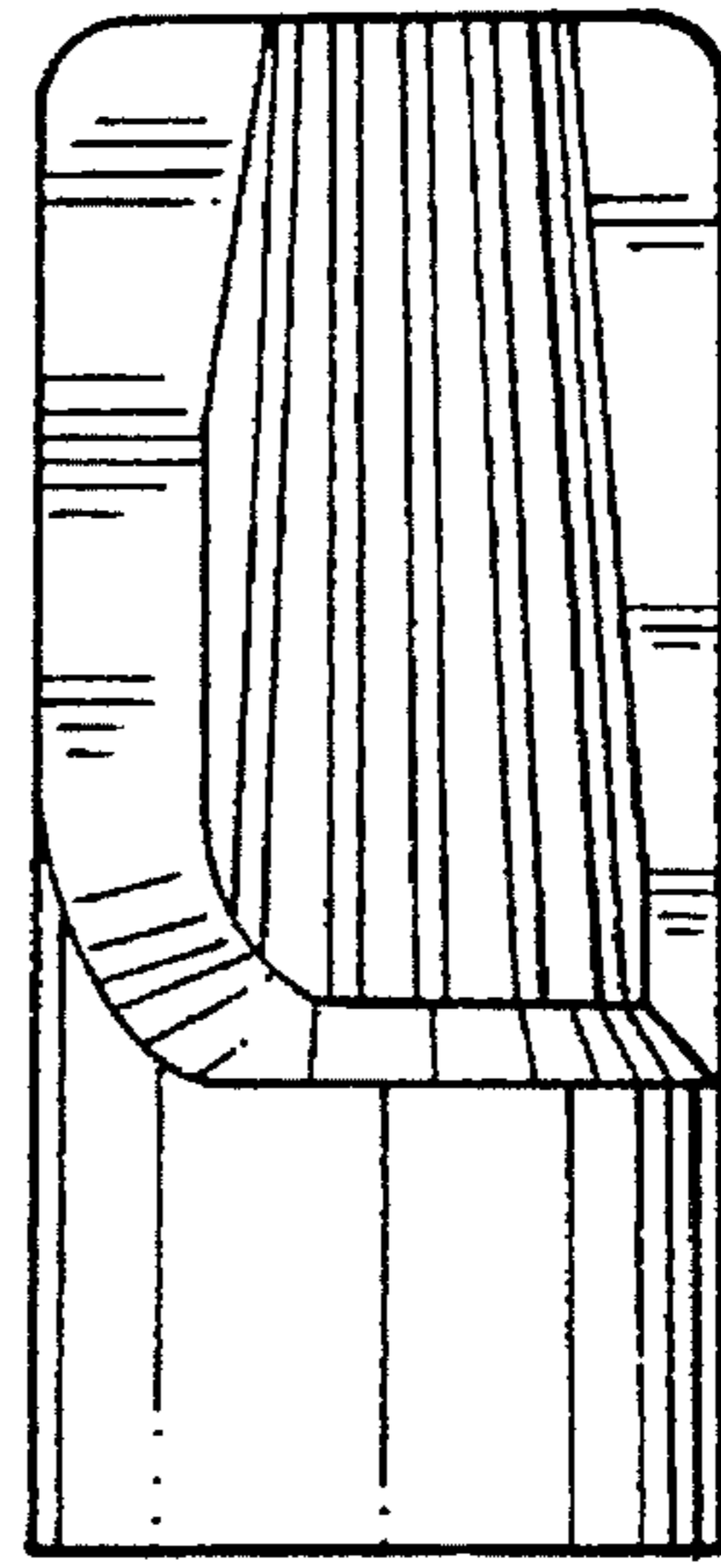

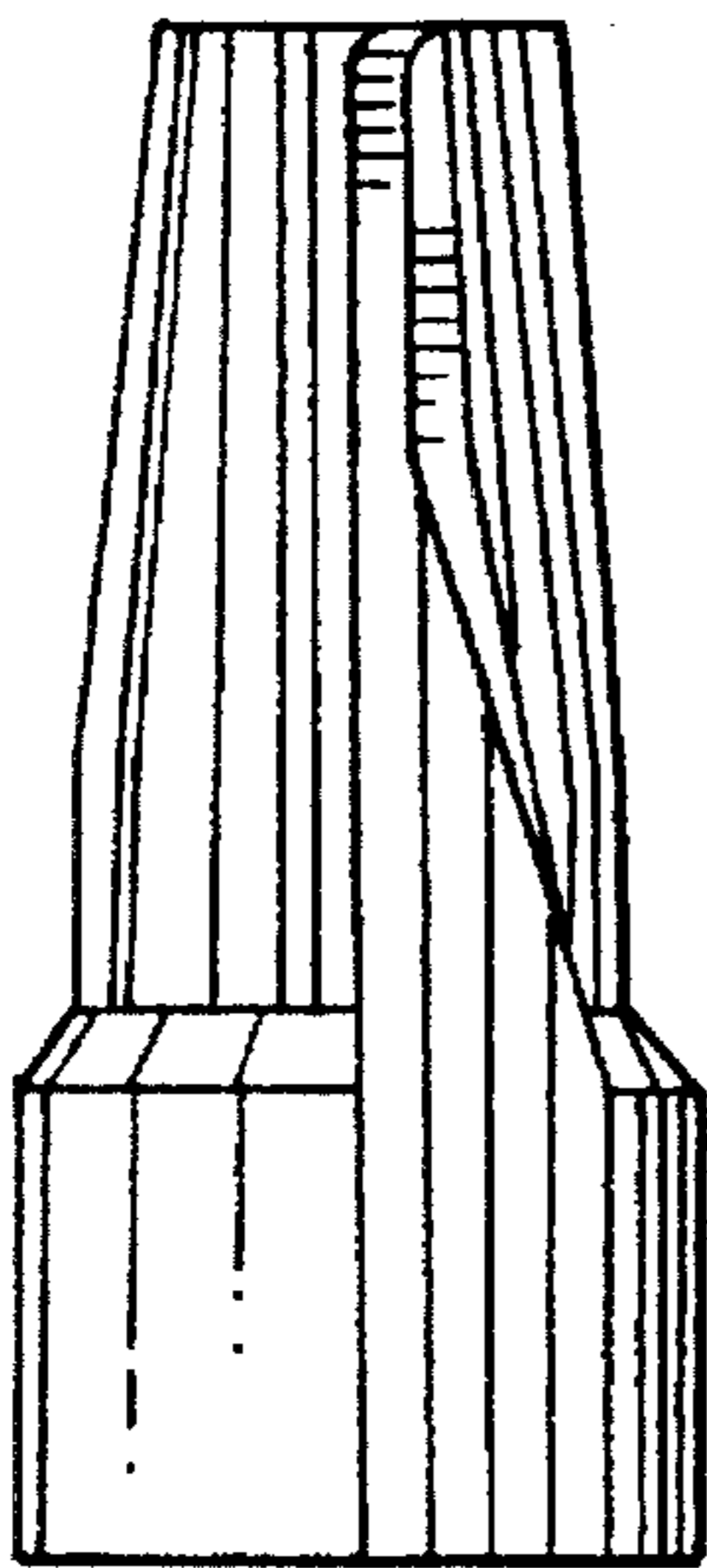

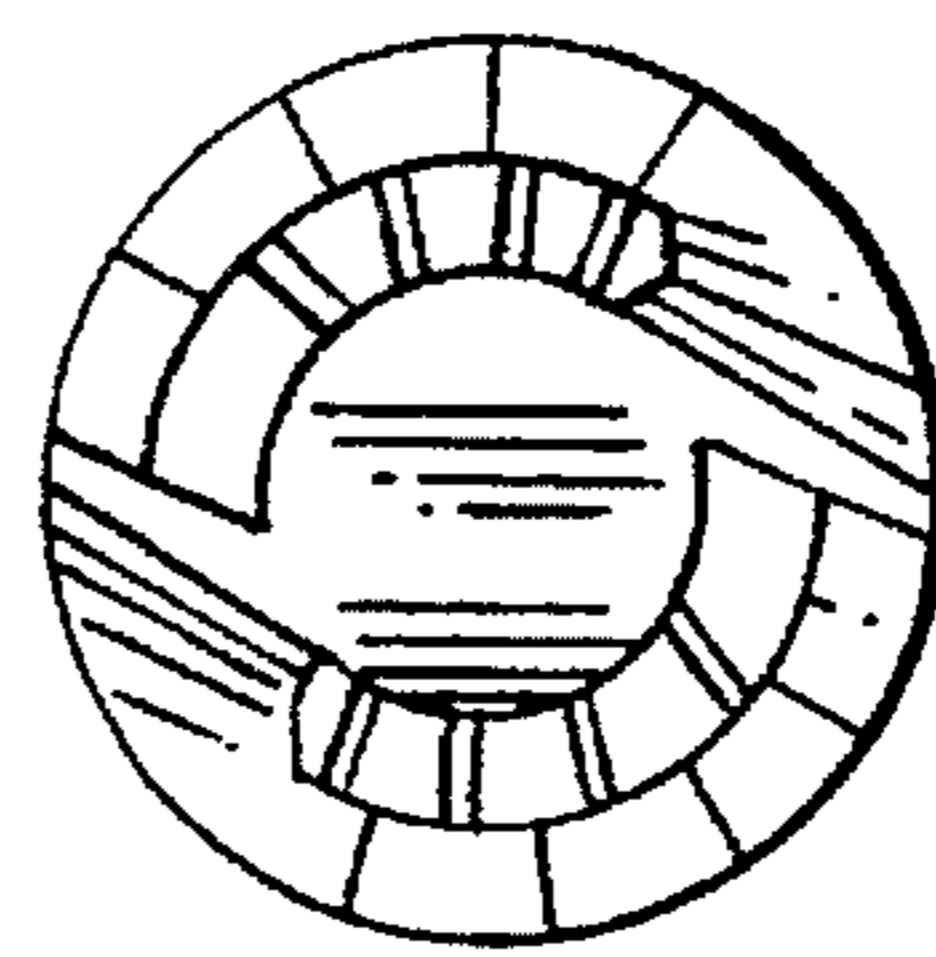

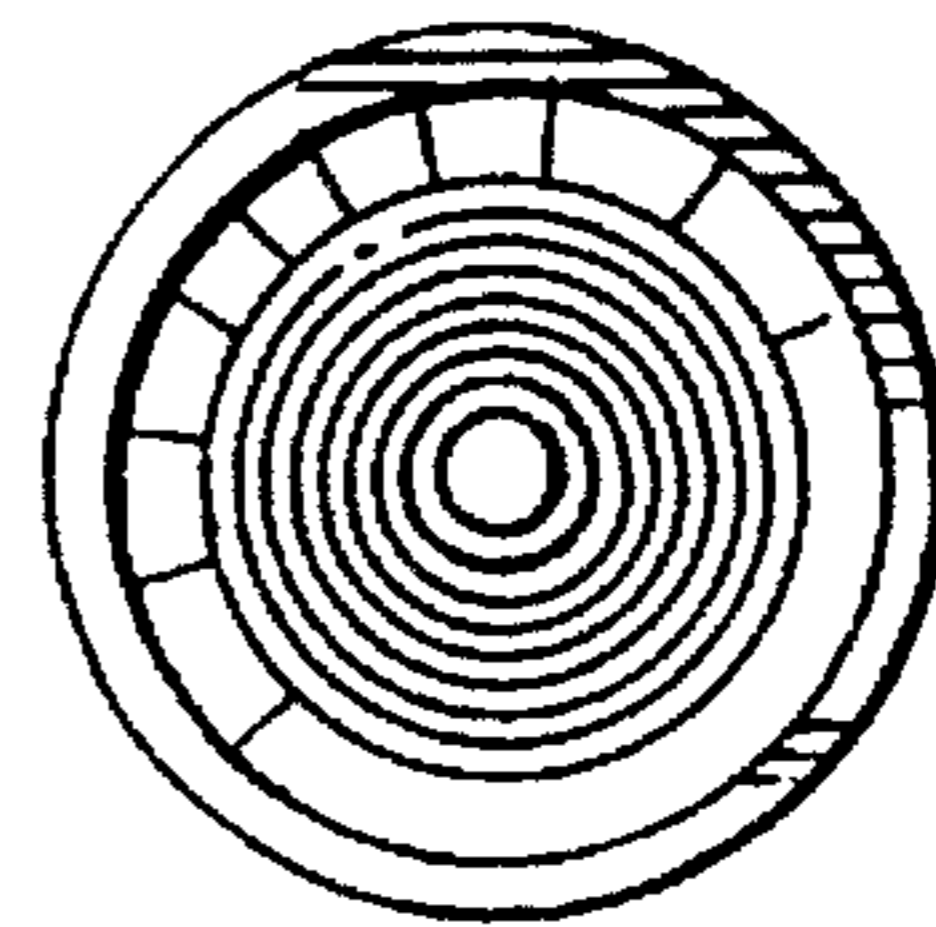
