DESCRIPTION

FIG. 1 is a front elevational view of a copying machine showing our new design;
FIG. 2 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof; and,

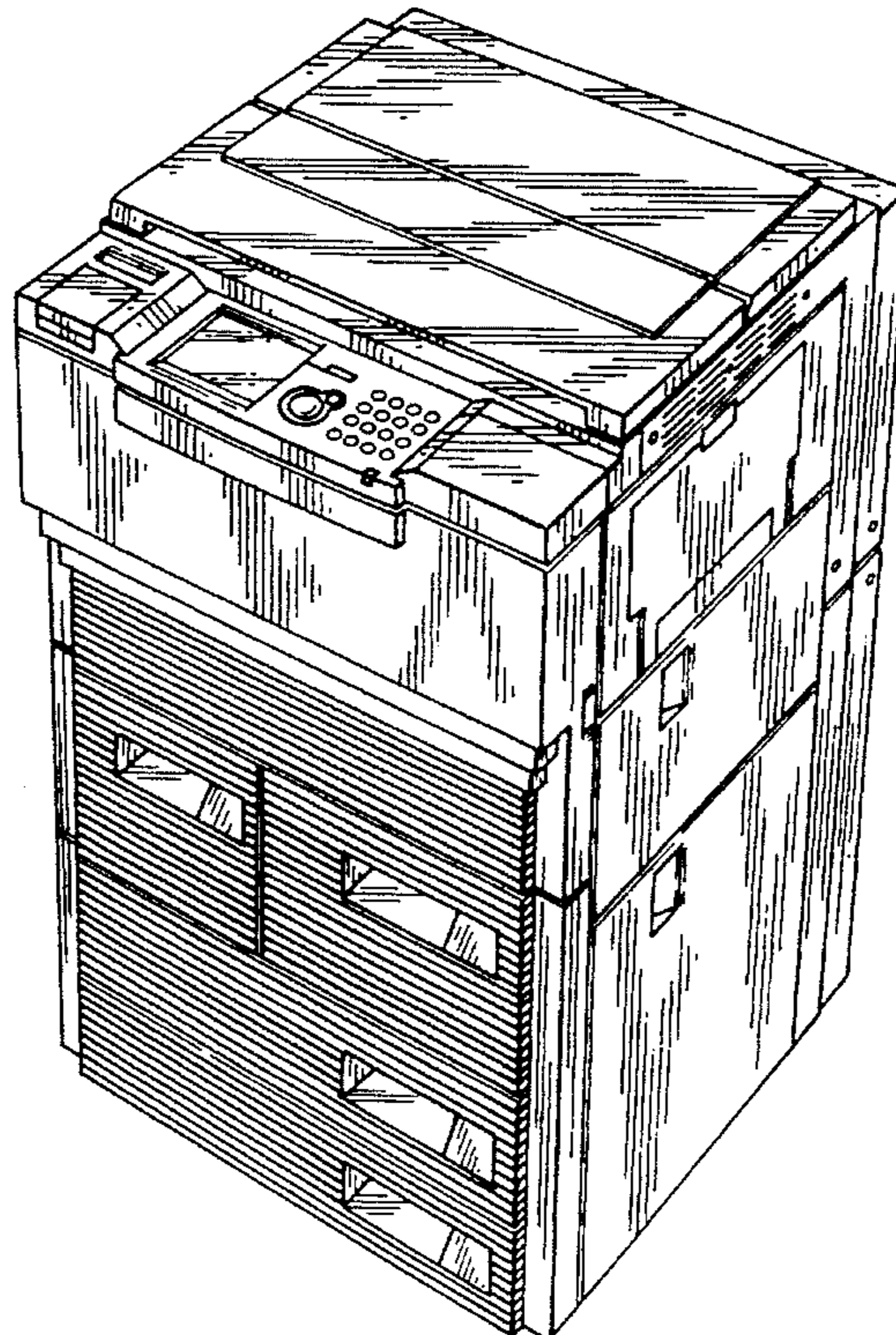

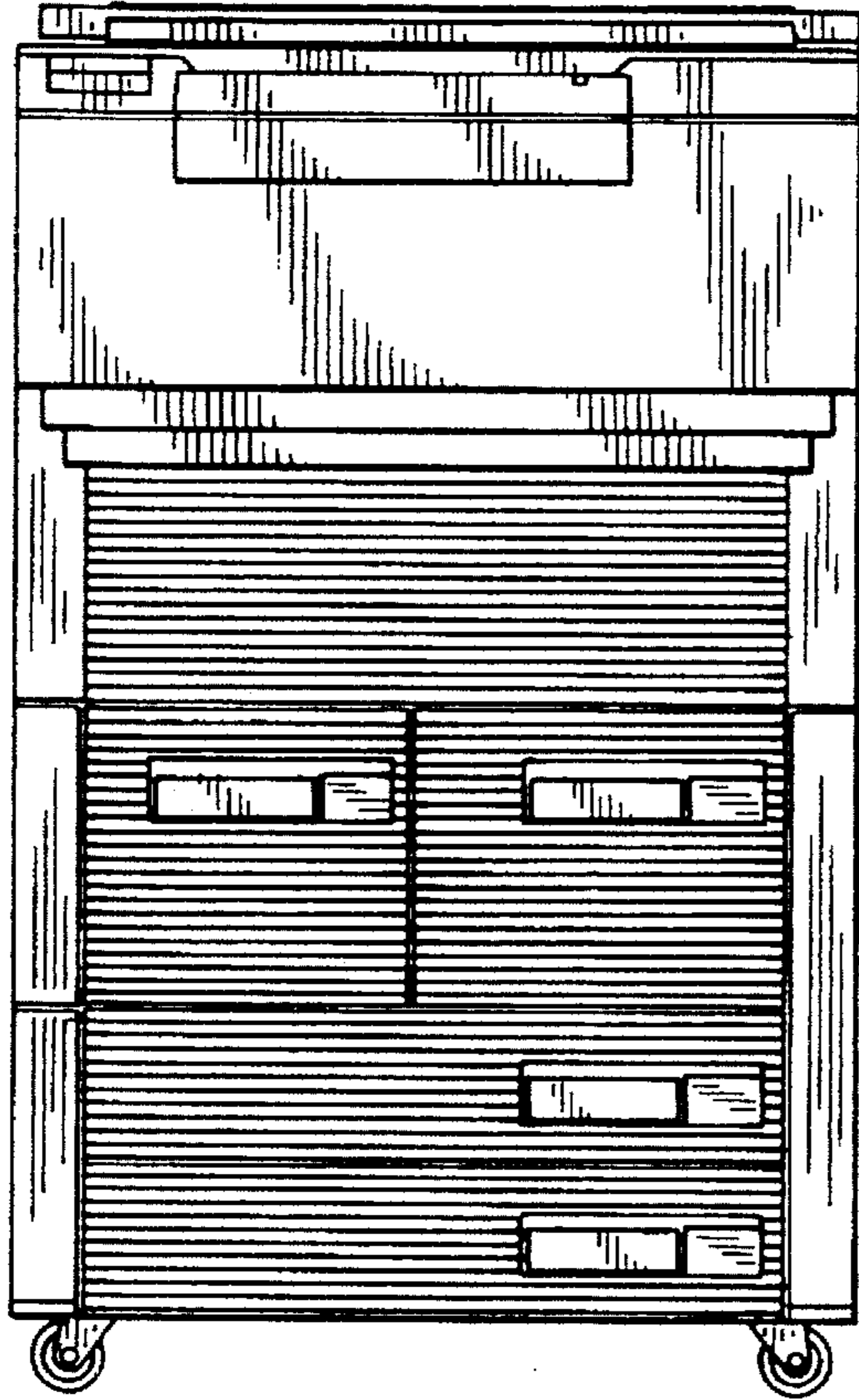

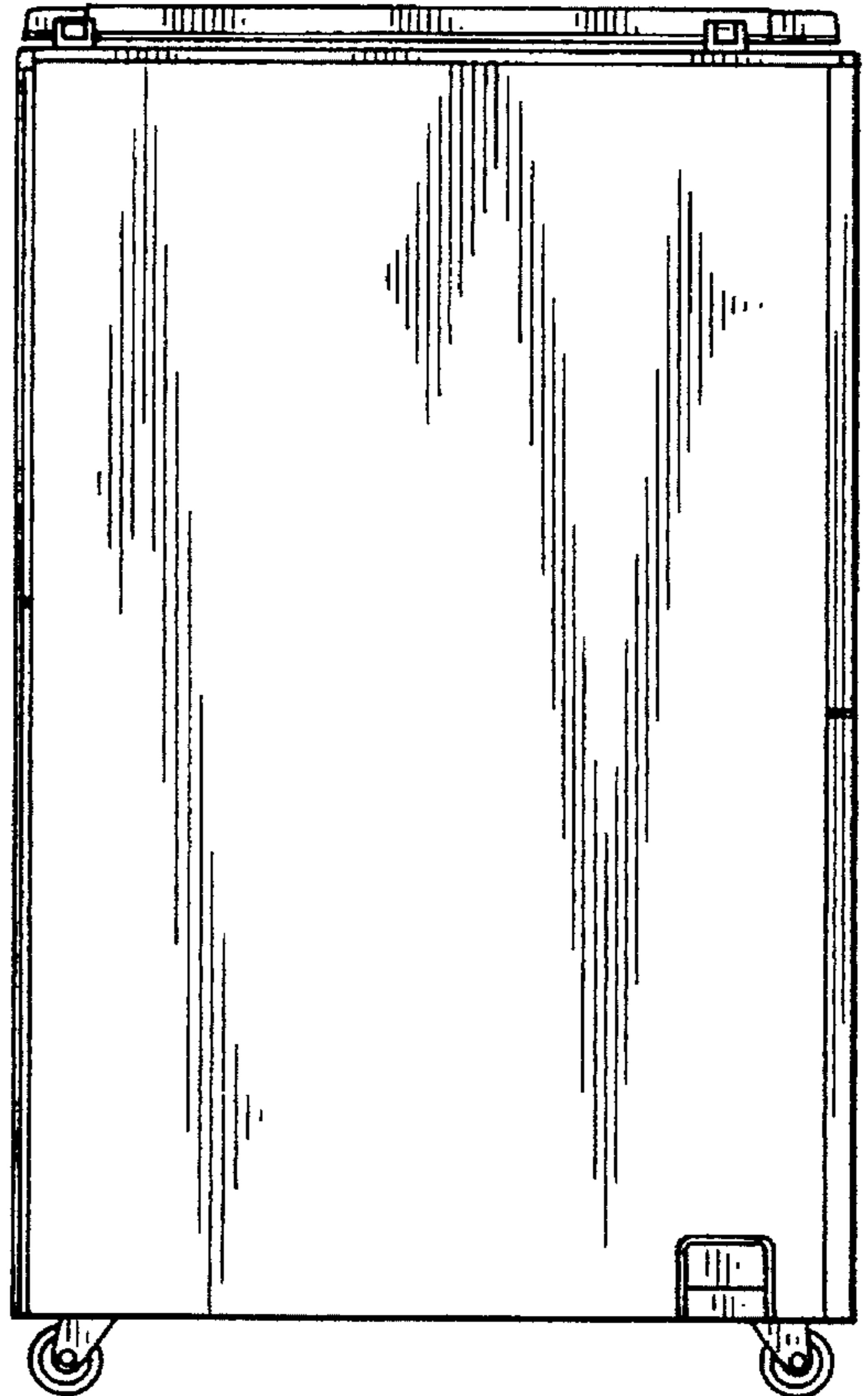

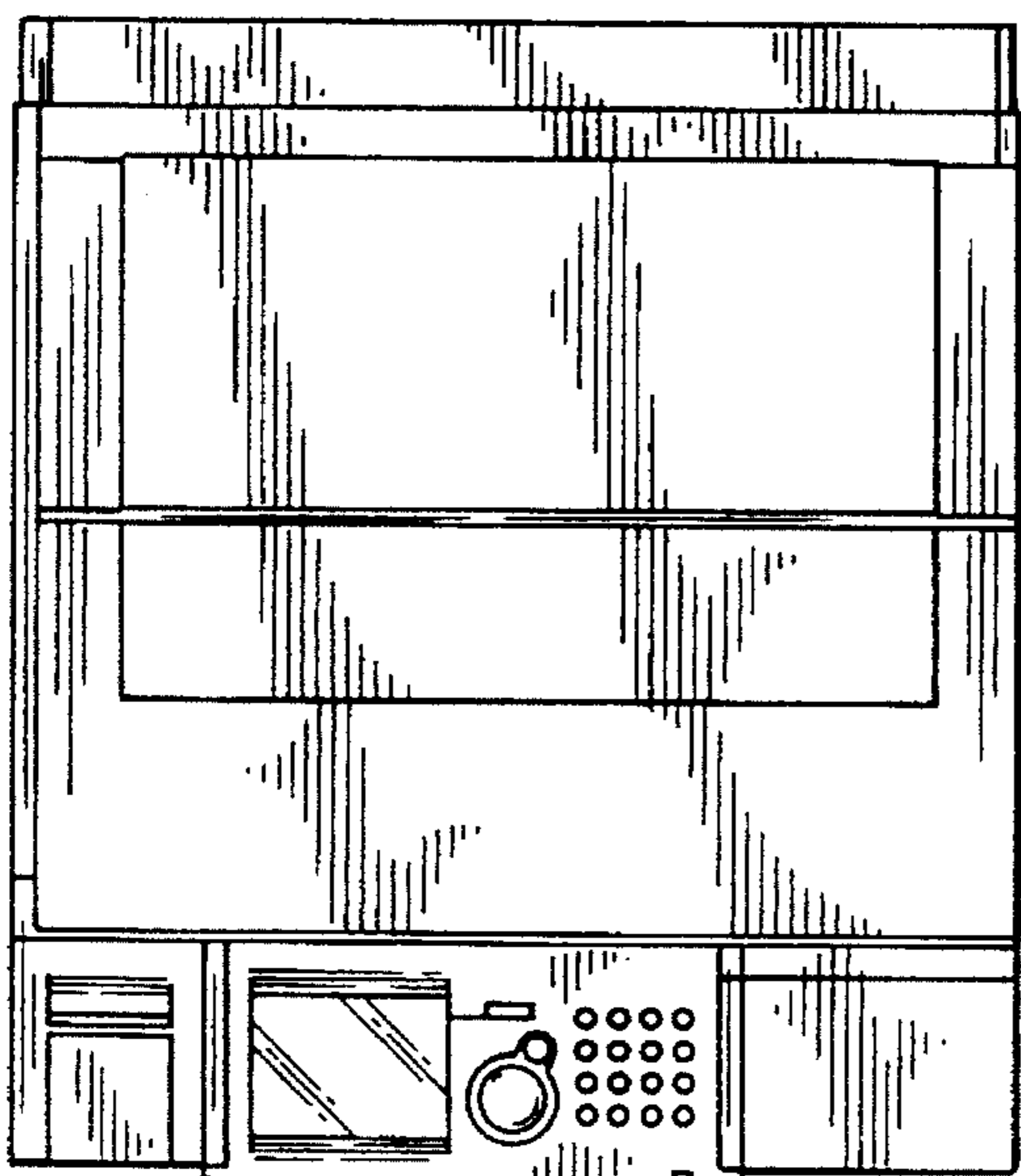

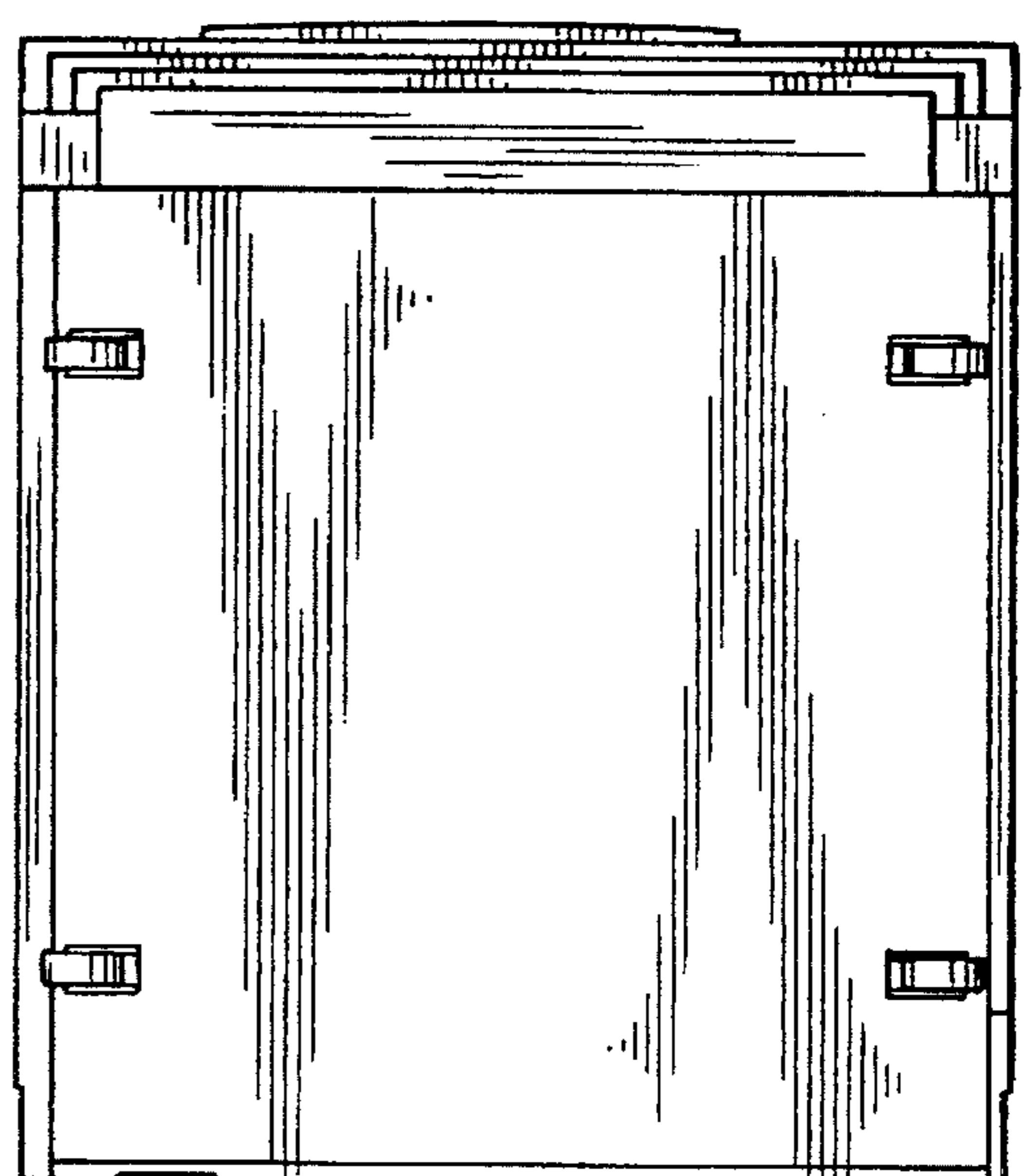

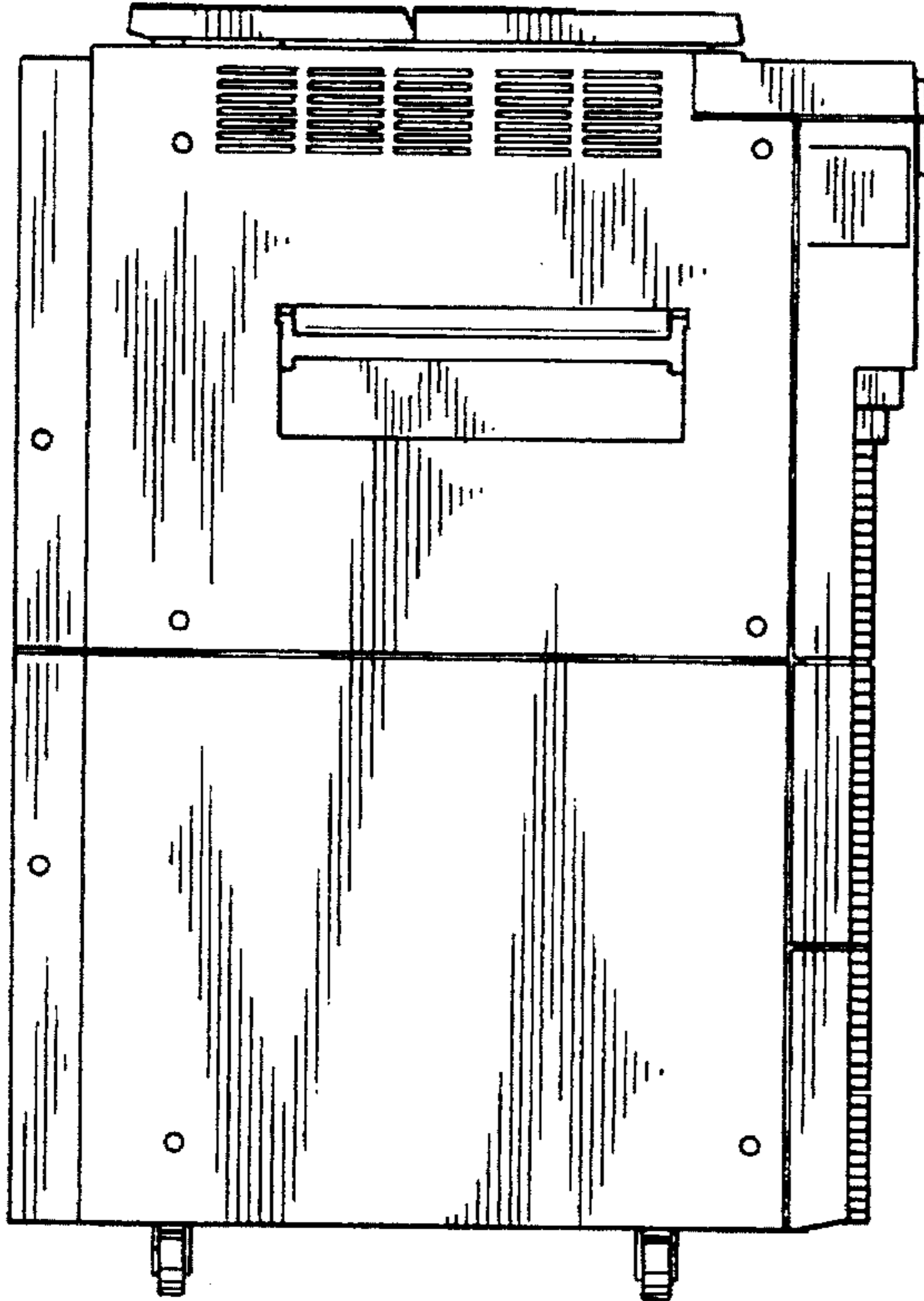

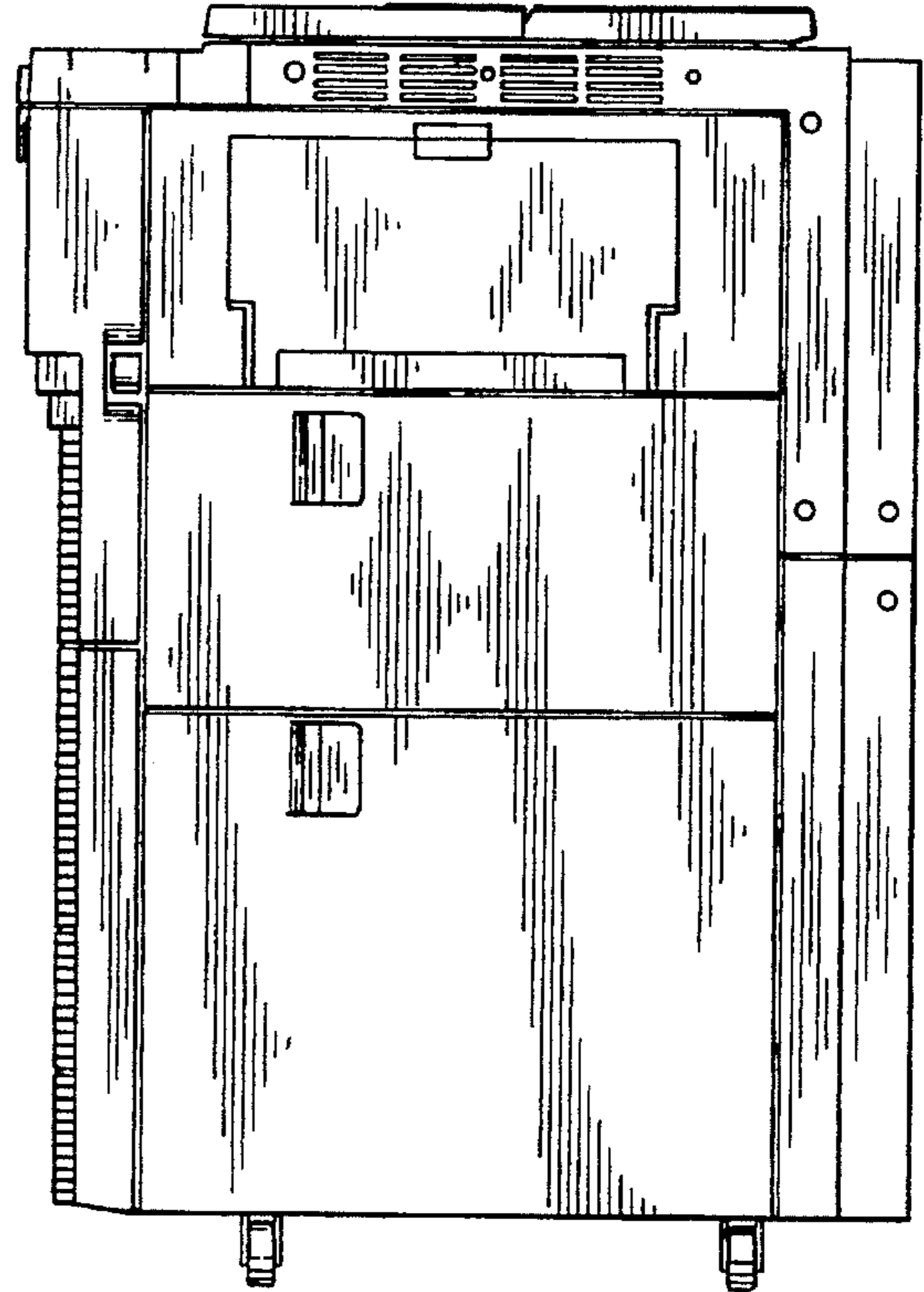
